### **Iran Rejects Europe's** "Unrealistic" JCPOA Expectations IRAN NEWS NATIONAL DESK

TEHRAN - Foreign Ministry Spokesman Seyed Abbas Mousavi says it is unrealistic to expect Iran to reverse its decision to reduce its nuclear commitments unless the European parties help Iran reap the benefits of the sanctions removal.

Mousavi made the remarks on Monday in reaction to a recent statement on JCPOA by the three European countries - France, Germany, and the UK.

"The government of the Islamic Republic of Iran closely monitors the statements and stances held by the European parties to the JCPOA in terms of their compliance with the governments' obligations under the deal and the approvals of the Joint Commission," Mousavi said.

"We emphasize that the continuation of Iran's voluntary measures - which are based on good faith and within the framework of the JCPOA - hinges on the mutuality of the rights and obligations envisaged in the deal," he added.

"Such a path should not be considered a one-way road," the spokesman noted. See Page 7

# **Forex Market Stable Despite U.S. Toughest Sanctions**

TEHRAN - Governor of Iran's Central Bank (CBI) says the bank has managed to surmount the toughest sanctions and economic pressures which have been imposed by the U.S. since last year and has passed it. Speaking in Mashhad, Abdolnaser Hemmati said despite U.S. toughest sanctions, the Central Bank has succeeded in controlling the foreign exchange market. He added that the forex market is currently stable and there is no concern.

He went on to say that the U.S. and its allies were after crippling Iran's economy, adding that the CBI will not let any rise in the forex price and it currently witnesses strengthening the value of the national currency

Hemmati reiterated that the U.S. was after destroying Iran's national currency and it used to talk about dollar to be traded at 40,000 to 50,000 tomans but it failed to materialize its goal.

He noted that Iran's power in confronting economic sanctions of enemies has now become vivid to the world and sanctions do not have any impact any longer.

He also added that at this stage, the CBI cannot eliminate forex with official rate of 4200 tomans per dollar and it is necessary for essential commodities.

The rial on the open market is now close to the Nima rate, Hemmati said.

Hemmati said that Tehran is serious to support small and medium-sized enterprises (SMEs), adding that the government will fund SMEs with more than \$2.4 billion by March 2020.

'The amount of credit paid to the manufacturing sector would increase this year while up to 300 trillion rials worth of credit would be earmarked to the SMEs," he added.

According to reports, each dollar was traded for 12,350 tomans. The dollar rate has nose-dived in ecent weeks and there is no sign of attraction among people to rush to the forex market for investing

TEHRAN - Foreign Minister Mohammad Javad Zarif says the Europeans do not seem ready yet to put investment into saving the 2015 nuclear agreement with Iran, despite their claim to be willing to retain it.

"The Europeans claim they were willing to maintain the JCPOA, but we have not seen Europe yet to be ready for an investment," he told reporters upon arrival in New York, where he is going to attend a high-level UN meeting.

Expressing one's interest and preparedness to save an international agreement "is totally different from being ready to make the investments required to save that deal and the Europeans have not done that yet," Zarif said.

Britain, France, and Germany in January announced the establishment of a mechanism aimed at enabling non-dollar trade between the 28-nation bloc and Iran, officially called the Instrument in Support of Trade Exchanges (INSTEX). See Page 7

# **Pre-JCPOA Conditions**

TEHRAN (PressTV) - The spokesman for the Atomic Energy Organization of Iran (AEOI) says Tehran is planning to go back to the conditions preceding the landmark 2015 nuclear deal unless European signatories fulfill their obligations.

Behrouz Kamalvandi said on Monday that Tehran's retaliatory decision to reduce some of its commitments under the Joint Comprehensive Plan of Action (JCPOA) is within the framework of the accord which says if one side fails to deliver its commitments, the right is reserved for the other party to reconsider its obligations.

"If the Europeans and the United States do not fulfill their commitments, we will balance out their actions under the deal by reducing commitments and taking the conditions back to how they were four years ago," he said.

He said the JCPOA was supposed to be an "exchange deal" but "what we were giving [within its framework] was way more than what we were getting in return."

The JCPOA was originally signed between Iran and six world powers - namely the US, the UK, France, Russia, China and Germany. Washington, however, unilaterally withdrew in May 2018. See Page 7

# **Iran Responsible for Over** 70% Drugs Busts in World

TEHRAN (MNA) - Head of Iranian Anti-Narcotics Police said Sunday that Iran is responsible for over 70 percent of illicit drug busts in the world.

Speaking at a regional working group meeting on prevention of industrial drug precursors, Head of Iranian Anti-Narcotics Police, Brigadier General Masoud Zahedian said that "despite unjust sanctions, the Islamic Republic of Iran has managed to take remarkable measures in countering drug trafficking, the results of which are enjoyed by all countries in the world."

He went on to add that "Iran is responsible for over 70 percent of illicit drug busts in the world. In the past seven months, the Iranian police has busted 364 tons of various types of narcotics during operations that left 3,814 of its forces martyred and 12,000 wounded."

"Production of crystal in Afghanistan is a serious threat," said Zahedian, adding "since its revenues are in the hands of smuggling networks which then inject a part of these revenues into the countries' economies."

He further maintained that the discovery of tens of tons of drug precursors by Iran's counter-drug units reveal the extensive scope of the product's trafficking.

# **No Fresh Payments From Iran To India's Basmati Exporters**

NEW DELHI (Dispatches) - In some relief for consumers, basmati rice has become cheaper 12 per cent during the past one month due to an increase in the area under cultivation and cessation of fresh payments from U.S. sanction-hit Iran, the largest buyer of India's aromatic rice.

The fair average quality (FAQ) variety is currently quoting at Rs 72 a kg in the benchmark physical Delhi wholesale market, as compared to Rs 82 about a month ago. With satisfactory progress of monsoon rainfalls prompting farmers to bring in additional area under basmati sowing, prices are set to fall lower going forward.

The ongoing payment stoppage by Iranian importers may pare India's basmati exports to that country, which is facing economic sanctions from the United States.

"Indian exporters are currently executing old orders. Hence, there is no export problem as of now. But, importers in Iran have stopped fresh payments for the past one month, bringing new orders to a complete halt. As long as advance payments to their accounts continue, exporters would face no issues. See Page 7

# S. Korea Imports No Oil From Iran in June

SEOUL (Reuters) - South Korea imported no crude oil from Iran for a second month in June following the end of a U.S. sanctions wavier, with Iranian imports for the first half dropping 36.9% from a year earlier, customs data showed on Monday.

South Korea, the world's fifth-largest crude oil importer and one of Iran's major oil customers, stopped importing Iranian crude from May after waivers on U.S. sanctions against Iran ended at the start of that month. South Korean oil buyers mainly imported condensate, an ultra-light oil, from Iran.

Shipments of Iranian oil in the first six months of the year were nearly 3.9 million tons, or 156,155 barrels per day (bpd), down 36.9% from 6.13 million tons during the same period a year earlier, according to customs data. In total, South Korea's crude oil imports fell 12.6% in June to 11.49 million tons, or about 2.8 million bpd. Oil shipments from Saudi Arabia, South Korea's top oil supplier, were 3.67 million tons in June, or 893,806 bpd, down 16.2% from 4.38 million tons last year.

Reflecting South Korea's efforts to replace Iranian oil and diversify its crude sources, imports from the United States nearly tripled to 1.09 million tons in June, or 264,745 bpd. It also imported 265,403 tons of crude oil from Kazakhstan in June, up 96.2% from 135,254 tons a year earlier, the data showed.

In the first half of the year, South Korea's crude oil imports dipped 2% to 72.7 million tons, or 2.93 million bpd. With South Korea increasing its U.S. oil intake, the United States ranked as South Korea's No.4 crude oil supplier in the first half of the year, supplying 7.8 million tons, or 313,387 bpd. This was more than quadruple the intake of 1.81 million tons a year earlier. South Korea is expected to keep purchasing U.S. oil amid ongoing OPEC-led supply cuts and higher U.S. crude oil production.

State-run Korea National Oil Corp (KNOC) will release the country's final crude oil imports data later this month.

### Saudi Forces Suffer Heavy Losses in Yemeni Retaliation

SANAA (Dispatches) - Yemeni army and popular committees have killed or injured 10 Saudi-paid militiamen in Saudi Arabia's southwestern region of Jizan.

The army's sniper unit, supported by fighters from allied Popular Committees, killed and injured 10 mercenaries east of al-Doud Mountain in Jizan on Sunday, Yemen's Arabic-language al-Masirah news website cited an unnamed Yemeni military source as saying.

On Thursday, Yemeni forces took control of several military positions east of the mountain. Also on Sunday, Yemeni forces targeted with artillery shells gatherings of Saudi soldiers in Arar position in Jizan. In the nearby province of Najran, Houthi fighters and their allies in the army killed and injured a number of militiamen in an artillery attack in Ajasher desert. They also fired a Zelzal-1 (Earthquake-1) missile at gatherings of Saudi mercenaries in Soh, which lies between Najran and Yemen's northwestern province of Sa'ada. A number of the mercenaries lost their lives in the attack. Separately, Yemeni troops inflicted heavy casualties

on militiamen in several operations in Saudi Arabia's province of Asir.

Sanctions Lifted

TEHRAN – President Hassan Rouhani says Tehran is ready for negotiations with the US if its sanctions against the country are lifted.

President Rouhani made the comment while reiterating that Iran lived up to its commitments under the Iran nuclear deal known as the Joint Comprehensive Plan of Action (JCPOA) unlike Washington which withdrew from the agreement unilaterally.

"We did not breach our commitments under the JCPOA. In the Shanghai meeting, two of world leaders said Iran had secured a great political and ethical victory in history. The Americans failed to do anything and have been defeated in all international, political and legal circles. We, the Iranian nation, have managed to display our power," said Rouhani.

He said Israel prompted the U.S. to pull out of the JCPOA.

"It was wicked Israel that caused the U.S. to withdraw from the JCPOA," he said.

"Some reactionaries in the region also acknowledged that the US was under pressure to pull out of the JCPOA. Washington's breach of commitments coupled with the animosity of some of our enemies was the reason behind Washington's pullout from the JCPOA," said the president.

He then touched upon Iran's stance following the U.S. withdrawal from the JCPOA. "We have given the P5+1 countries time. Some of them have taken some steps. The Europeans either didn't want to, or couldn't take any steps. And the US is left alone as far as the JCPOA is concerned," President Rouhani said.

"The world stood up to the U.S., and this is because of Iran's strategic patience," he noted, highlighting the importance of people's resistance to tackle sanctions.

### Leader Assigns **Clerics to Guardian Council**



TEHRAN (Tasnim) - Leader of the Islamic Revolution Ayatollah Seyed Ali Khamenei appointed a new member to the Guardian Council's board of Fuqaha (Islamic jurists) and extended the tenure of two other members.

In a decree on Monday, Ayatollah Khamenei appointed Hojjatoleslam Alireza A'rafi as a new member of the Guardian Council's board of Fuqaha. A'rafi is replacing Ayatollah Mohammad Mo'men, who died in February.

In separate decrees, Ayatollah Khamenei also extended the terms of two other members of the board. According to the Leader's decree, Ayatollah Mohammad Yazdi and Ayatollah Sadeq Amoli Larijani will remain in the council for six more years. The Guardian Council is a constitutionally mandated 12-member council in Iran that, among other things, is tasked with ensuring the compatibility of the legislation passed by the parliament with the criteria of Islam and the Constitution.

### **Tehran Criticizes U.S. Limitations On Zarif Movement in New York**

NEW YORK (IRNA) - Iranian Foreign Ministry spokesman protested to US over setting limitations on movement of Foreign Minister Mohammad Javad Zarif to some districts of New York, saying it has no effect of Zarif's agenda. Abbas Mousavi said that as Pompeo confessed in his recent interview, they are worried about the political implications of the Iranian foreign minister's current tour to the United Nations enlightening the New York-based diplomatic corps.

Definitely, putting limitation on Zarif's movement to some districts of New York will have no effect on his agenda, he said.

Zarif usually stays in the UN and also the residence of the Iranian envoy to New York and all interviews and speeches will be held there, he added.

Earlier in a telephone interview with Washington Post, Pomeo said that he granted visa to Zarif, adding that Iranian foreign minister's movement to some districts of New York will be sharply curtailed.

He added: "It's absolutely appropriate that we provide Foreign Minister Zarif and his delegation with all the rights that they are due under the U.N. headquarters agreement, and nothing more than that."

### Iranian Delegation Due in Pakistan

TEHRAN (Tasnim) – Pakistan's ambassador to Tehran said an Iranian delegation is slated to visit her country to address problems that have prevented the two neighboring nations from signing a free trade agreement (FTA).

Riffat Masood pointed to a recent visit to Tehran by Pakistani Prime Minister Imran

Khan and said since the visit, she has been seeking to provide grounds for the implementation of agreements reached between the two countries.

No Forex for **Importing Cigarettes** 

ISNA\* - Deputy Health Minister Alireza Raisi says the Iranian government has allocated \$170 million at subsidized rate to importing tobacco and another \$16 million to cigarette paper.

According to Raisi the subsidized rate foreign currency was meant to be spent on importing essential medical supply.

The deputy health minister made the remarks at a ceremony marking the "No Tobacco national Day." Raisi said that "the current output of Iranian tobacco factories is around 35 to 40 billion cigarettes, but they aim to increase their output to 80 billion."

Unlike many countries, Iran still allows advertisement for flavored tobacco products, although the Iranian Judiciary has officially declared a ban on such advertisements. According to Raisi, most Iranian smokers live in the Central Province and the provinces of West Azarbaijan, Qazvin and Alborz.

There are many rules and legislations against tobacco use but they are not observed by retailers or government authorities. Meanwhile, "Hookah is used the most in the provinces of Bushehr, Hormozgan, Sistan-Baluchestan and Fars. In southern provinces, hookah use is more widespread among women than men," the Deputy Health Minister said.

### Iran to Try **ISIL Terrorists, Spies Soon**

FARS\* - Head of Tehran's Revolutionary Court Moussa Qazanfarabadi announced that a number of ISIL terrorists and environmental activists charged with spying for foreign states will be tried in the near future.

"These people (ISIL terrorists) intended to carry out operations inside the country and at the borders, and thanks God, they failed and were arrested thanks to the vigilance of intelligence forces, and some of them were tried and a number of others are waiting for trial," Qazanfarabadi said. He noted that they had been supported and sent by a number of countries which are infamous for sponsoring the ISIL.

Asked about the case of environmental activists who are charged with espionage for foreign states, Qazanfarabadi said that their cases are being studied and they will be tried soon. He added that they are 8 to 9 people, noting that some of the defendants have been charged with "corruption on Earth", a charge that can carry the death sentence in Iran.

Amir Kabir University of Technology has grown to be one of the main spots to study engineering in Iran. As a public institution, it is mostly funded by the state.

"We have had good cooperation with the Iraqi universities and some universities in the Iraqi Kurdistan Region in the past, but it can increase," he said. In line with this memorandum, we can have collaborative courses and collaborative projects in common between the two universities. The head of the Amir Kabir University of Technology added that at the present time, this university holds joint courses with reputable European and Asian universities that we can allocate part of these courses to the needs of Zakho University.

### Students Rally in Support of Zakzaky

TEHRAN (FNA)- Iranian university students gathered in front of the foreign ministry to urge accelerated diplomatic efforts to free Muslim cleric Sheikh Ibrahim al-Zakzaky who is jailed by the Nigerian government. The students carried placards reading "We are all Zakzaky" and "Free Zakzaky" to criticize the international community's silence on the dire situation of Sheikh Zakzaky who needs urgent medical treatment. The rallies are due to be held in different parts of Tehran for four days.

A statement issued at the end of the Monday rallies warned of attempts to kill Zakzaky despite his suffering from different diseases for years, and called on the Iranian government, specially the foreign ministry, the parliament and the judiciary to double efforts to free and treat the Muslim leader.

Sheikh Zakzaky, who is in his mid-sixties, lost his left evesight in a 2015 raid by security forces that left more than 300 of his followers and three of his sons dead. His wife also sustained serious wounds.

### Spain Vows to Join INSTEX to Ease Trading With Iran

LONDON (IRNA) - Spain's Foreign Minister Josep Borrell said on Monday that Iran's nuclear deal is of prime importance and voiced his country's readiness to join INSTEX to facilitate trade exchange between Iran and Europe. The three European signatories pledged to compensate the losses inflicted on Iran through devising the financial channel, officially known as the Instrument in Support of Trade Exchanges (INSTEX). The instrument has not become operational yet.

Speaking to reporters at the Foreign Affairs Council in Brussels, the Spanish foreign minister said that Madrid strongly disagrees with the US extraterritorial sanctions against Iran.-Borrel, who is likely to succeed Federica gas condensate, by participation if people's investment.

### **MP Escapes** Assassination, **Bodyguard Shot**

Salek's car in Tehran on Sunday evening.

The 73-year-old cleric who represents the city of Isfahan in the Iranian Parliament has said that he was in downtown Tehran at around 8:30 pm local time for a television program when he heard "suspicious" gunshots from the nearby streets. Salek said when recording of the program was

over, he once again heard gunshots near the building, and found out later that his bodyguard has been shot in the leg.

Eyewitnesses say two motorcycles, each carrying two riders, fled the scene after the shooting, he added, noting that his bodyguard has been taken to the hospital and is in good health.

Salek said there is no evidence about the motive behind the attack and it is not clear whether it was an assassination attempt. Salek has been elected to the Iranian Parliament for five terms.

Accordingly, 60 percent of parts needed for manufacturing Peugeot 301 will be provided through domestic production, expandable to 80 percent in upcoming programs, VP Sattari said, adding, "some 300 Iranian parts suppliers have been employed for manufacturing parts of this passenger car."

He went on to say that Peugeot 301 sedan fully observes requirements of international standards.

Peugeot 301 is manufactured in IKCO while France's Peugeot Company left Iran in the wake of U.S. sanctions, he said, adding, "earlier, it was supposed that all parts and equipment needed for manufacturing this passenger car would have been provided by French companies."

After France's Peugeot left Iran, this giant project was handed over to domestic manufacturers, the vice president added.

According to the scheduled program, Peugeot 301 passenger car will hit the domestic car market by the yearend. Some 2,123 parts are required for manufacturing this passenger car, 565 of which have been indigenized by Iranian manufacturers, Vice President for Science and Technology added.

# Non-Oil Exports Rise Up

BANDAR ABBAS (Dispatches) - Export of oil and non-oil products from southern port of Shahid Rajaei rose up in the past three months of the Iranian year (started on March 21, 2019) compared with the preceding year.

Director general of port and maritime organization of Hormuzgan province Allah Morad Afifipour made the remarks speaking to reporters in south of the country on Monday.

Oil and non-oil exports witnessed three and 10 percent growth respectively during the period, the official said.

Shahid Rajaei port is the biggest and the most equipped port of its kind that covers 80 percent of container operations in Iran. As Afifipour said, about 19.9 million tons of oil and non-oil products have been loaded onto and offloaded from Shahid Rajaei Port during the past three months.

Meanwhile, some 1,047 vessels have operated to ship the merchandises from the port.

EHRAN (MNA) - Some 1.8 quadrillion rials (about \$13.8 billion) of investments have been made on tourism sector. Ali Asghar Mounesan, the head of Iran's Cultural Heritage, Handcrafts and Tourism Organization announced on Monday.

Making the remarks in his visit to Qazvin province, he added that via reducing bureaucratic procedures, investment attraction can be improved in this sector.

As reported, Iran's travel and tourism sector grew at 1.9% to contribute 1.158 trillion rials (\$8.83 billion) or 6.5% of overall GDP and 1,334 jobs (5.4% of total employment) to the economy in 2018. This is according to the World Travel and Tourism Council's annual research into the economic impact and social importance of the sector. The WTTC report also shows international visitors spent 168,954 billion rials (\$1.28 billion) in Iran in 2018. The council expects the number of international arrivals to stand at 6.5 million in 2019. Lately, Iranian authorities have redoubled efforts to boost the tourism sector for increasing foreign currency revenues and creating jobs under the declining economic conditions. The decline in national currency last year meant that travelling to and shopping in Iran became cheaper for foreign nationals.

# **Yemen Sides Meet On Hodeida**

HODEIDAH (AFP) - Representatives from Yemen's government and Huthi rebels tasked with pulling forces out of the key port city of Hodeida met Sunday for the first time in five months.

The redeployment from Hodeida is a critical part of a ceasefire deal reached in December in Sweden that calls on the government and the Huthis to move forces away from ports and parts of city.

"The joint meeting of the redeployment coordination (committee) meeting started earlier this afternoon," a UN official present at the meeting told AFP.



### **Trump Can Waive** Sanctions on Turkey

ISTANBUL (Reuters) - U.S. President Donald Trump has the authority to waive sanctions on Turkey for its purchase of Russian air defence systems and should find a "middle ground" in the dispute, President Tayyip Erdogan said on Sunday.

Erdogan's comments came two days after NATO member Turkey took delivery of the first consignment of advanced Russian S-400 missile defence system parts, despite warnings from Washington that the move would trigger U.S. sanctions.



# Bastille Day Parade Marred by Clash etween Protesters and Police

PARIS (Dispatches) - French police fired tear gas to disperse protesters from Paris's Champs Elysees avenue on Sunday, a few hours after President Emmanuel Macron had reviewed the traditional Bastille Day military parade alongside other European leaders.

The famous boulevard was reopened to traffic as soon as the parade finished, but a few hundred protesters from the grassroots 'yellow vests' movement tried to occupy it. Macron and his guests had already left for the Elysees

presidential palace for lunch. Police fired tear gas to disperse the protesters, some hooded, who were trying to block the road with metal barricades, dustbins and other debris.

Several loud bangs were heard. Protesters hurled objects at the police, booed and set bins on fire. Police drove some of the demonstrators to adjacent streets where they regrouped and set up new barricades, drawing more tear gas fire.

A video obtained by Reuters showed a man kicking a policeman to the ground from behind and punching him after the policeman had used pepper spray to push back a couple. The policeman and his colleagues fought back with truncheons.

The Police Prefecture said on Twitter it had ordered the protesters to leave the area, or be forcibly removed. Paris Police chief Didier Lallement told journalists during

a Sunday evening patrol of the boulevard that order had been restored. He said some 200 rioters had tried to occupy the Champs Elysees but had been pushed out.

More trouble could be expected on Sunday night when the traditional Bastille Day fireworks is held, Lallement said, while seeking to reassure tourists they would be safe.



Authorities are also bracing for rowdy soccer fans to flood the avenue after Algeria's African Cup of Nations semi-final match against Nigeria. On Thursday, some fans looted shops there after Algeria beat Ivory Coast in the quarter-final.

Paris authorities had banned 'yellow vest' demonstrations near the parade but several groups linked to the movement had called for gatherings around the Champs Elysees on Bastille Day, a national holiday in France.

Earlier a French police source and a court source said 152 people -- whom they linked to the 'yellow vests' -- had been detained near the Champs Elysees as they tried to stage a protest.

The number of 'yellow vest' protesters has dwindled to a few hundred recently from a high of around 300,000 nationwide in November when demonstrations started against fuel price hikes and later morphed into a general discontent against Macron's policies and government.

### **Rockets Kill 6 Civilians** In Syria's Aleppo

DAMASCUS (AFP) - Rockets fired by jihadists Sunday killed six civilians and wounded eight others in the government-held northern city of Aleppo, state news agency SANA reported.

It said two neighborhoods were struck in the "terrorist rocket attack" and that one rocket hit the municipal building in the city, which the regime retook full control of at the end of 2016.

The Britain-based Syrian Observatory for Human Rights war monitor confirmed the toll, with its head Rami Abdel Rahman saying the number of dead could rise because some of the wounded were in serious condition. "Jihadists west of Aleppo have been targeting the city

since the morning," Abdel Rahman said. Pro-government newspaper Al-Watan said on its

Telegram messaging app that the "army has been responding to terrorist attacks ... with salvos of rockets". It was not immediately clear who fired the rockets that hit Aleppo.

Fighters of Syria's former Al-Qaeda affiliate Hayat Tahrir al-Sham (HTS) are deployed in the neighbouring province of Idlib and nearby regions including the western Aleppo countryside. Smaller jihadist and Islamist groups are also deployed in those areas.

Russian and regime aircraft have ramped up strikes on Idlib since the end of April, killing nearly 600 civilians.

HTS fighters and other combatants have responded with attacks on Syrian government troops in the region, including in the northern sliver of Hama province, which also neighbours Aleppo.

Since Russia intervened on the government's side in 2015 the regime has notched up a series of victories against opposition fighters and jihadists who overran large parts of Syrian in the first years of the war.

### Indonesia President Pledges More Infrastructure, Investment in Second Term

BOGOR (Reuters) Indonesia's recently re-elected President Joko Widodo on Sunday outlined his vision for a second term, pledging faster infrastructure development and more investment opportunities to create jobs and growth in Southeast Asia's biggest economy.

Hampered by soft prices,

NEW DELHI (Dispatches) - The death toll in Nepal from flash floods and landslides in the past three days rose to 55 on Sunday, with dozens missing and injured, the government said.

Ten thousand people have been displaced from their homes as incessant monsoon rains pounded many areas in mostly mountainous Nepal since Thursday, submerging large swathes of land, inundating homes, and destroying bridges and roads across the country.

A Home Ministry statement said 55 people had been confirmed dead and 33 injured. There are 30 missing. India's northeastern state of Assam has also been hard hit by the floods brought by the monsoon, with at least 1.5 million people displaced and 10 dead. And in the Chittagong division of Bangladesh there have been 10 deaths and about 500,000 displaced as 200 villages have been flooded. In Nepal, cabinet spokesman Gokul Banskota told reporters that "the disaster has caused a big loss to the economy". The government will make an assessment soon, he added. Nepal Red Cross spokesman Dibya Raj Poudel said the displaced had been sheltered in schools and other public buildings. Television channels showed roofs of houses submerged in flood waters in the southern plains and people wading through chest-deep water with their belongings on their heads. Officials said in some areas rains had eased but some rivers in the eastern part of the country were still above flood level. Authorities asked residents to remain alert. The Kosi River, which flows into the eastern Indian state of Bihar, was among those that had risen above the flood level. Nepal police official Ishwari Dahal said all 56 sluice gates of the Kosi barrage on the Nepal-India border had been opened last night for six hours to drain out 371,000 cusecs of water, the highest accumulation in 15 years. A cusec is a measurement of flow, equivalent to one cubic foot per second. "Its water level has gone down now," Dahal told Reuters from the barrage site in southeast Nepal.




# **India Calls off Moon Mission Launch**

NEW DELHI (Dispatches) - India on Monday dramatically scrapped the launch of a rocket that was aiming to land a probe on the Moon less than one hour before blast-off because of a "technical" problem.

India wants the Chandrayaan-2 -- or Moon Chariot 2 -- mission to make it only the fourth country after Russia, the United States and China to land a craft on the lunar surface. Countdown at the Satish Dhawan Space Centre was halted 56 minutes and 24 seconds before the planned liftoff at 2:51 am (2121 GMT Sunday).

"A technical snag was observed in launch vehicle system at T-56 minute," the India Space Research Organisation (ISRO) said on Twitter.

"As a measure of abundant precaution, #Chandrayaan2 launch has been called off for today. Revised launch date will be announced later." Officials at the space centre on an island off the coast of Andhra Pradesh state said the problem was in the launch vehicle system.



# Huawei Plans Extensive Layoffs at Its U.S. Operations

NEW YORK (Reuters) - Huawei Technologies Co Ltd is planning extensive layoffs in the United States as the Chinese telecoms equipment company grapples with its U.S. blacklisting, the Wall Street Journal reported, citing people familiar with the matter.



The layoffs are expected to affect jobs at Huawei's U.S.-based research and development subsidiary Futurewei Technologies, which employs about 850 people in research labs across the United States, the Journal said.

# Iraq, Jordan Seek to Further Boost Economic Ties

LONDON (Dispatches) - Addressing the Sulaimani Forum earlier this year, Iraqi President Barham Salih touted Iraq's capacity to help bring about a new regional order built on cooperation. Iraq, he said, could "be a bridge to the economies of the region by linking the infrastructure between Iraq and the Gulf and Turkey between Iran and the Arab region and the Mediterranean."

Under the leadership of Salih and Prime Minister Adel Abdul-Mahdi, the Iraqi government has been expanding efforts to deepen economic relations with neighbouring countries. To the chagrin of the United States, this has included the signing of several economic agreements with Iran, seen as the most influential outside actor in Iraq.

Another country Baghdad has been forging closer ties with is Jordan. In June, a Jordanian business delegation visited Iraq to talk about investment opportunities and the flow of Jordanian products into the Iraqi market. Jordanian and Iraqi entrepreneurs and government officials recently met in Amman regarding digital transformation in the financial sector.


The developments come after months of high-level diplomacy between the two countries. The prime ministers of Jordan and Iraq met at the border in February and agreed on a deal involving oil and other goods.

Iraq would sell 10,000 barrels of oil per day to Jordan at a special price. In exchange, Iraqi goods imported through Jordan's Aqaba port would get preferential tariffs. The office of Jordanian Prime Minister Omar Razzaz said Jordan would export electricity to Iraq within two years.

"The opening of the border will break the isolation that existed," Abdul-Mahdi said in February. "Iraq and Jordan are the lungs of each other and as one breathes, the other will."

Before the border meeting, Jordanian King Abdullah II made a rare trip to Baghdad, the first in more than a decade, during which he stressed the strong ties between the two countries. Salih had travelled to Jordan shortly after his election in 2018. Both visits were billed as part of a shift in relations.

Ties between the two countries have undergone a large transformation in recent decades. Under the reign of Saddam Hussein, Iraq provided Jordan with cheap oil, while Jordan's Aqaba port became a lifeline for imports as international sanctions hit Iraq after the invasion of Kuwait in 1990. The 2003 toppling of Saddam's regime and the rising influence of Iran led to a deterioration in relations in the economic and political realm, especially under former Iraqi Prime Minister Nuri a-Maliki.



As they work to expand trade between them, Jordan and Iraq face significant, albeit different, economic challenges. "Jordan is facing one of its worst economic crises in decades," said Suha Ma'ayeh, a journalist in Amman. "The economy has been hit hard by regional instability and border closures." Other problems, she said, include declining remittances and foreign aid, low levels of productivity and the large influx of Syrian refugees.

The World Bank measured the Jordanian unemployment rate at 18.6% in 2018, a slight increase in comparison to the year before. While noting "renewed momentum" in the economy, the World Bank said more work was needed to improve the investment climate and ease of doing business. It urged the kingdom to diversify its energy supply. In 2018, protests against planned austerity measures backed by the International Monetary Fund spread across Jordan, leading to the resignation of Prime Minister Hani Mulki.

The Iraqi GDP is more than five times the size of Jordan's. Iraq has the fifth-largest crude oil reserves in the world but the country's economy, highly dependent on oil revenues, took a hit when the Islamic State destroyed large parts of Iraq.

### **Japan Sees Decline** In Value-Added Trade **Surplus With Korea**

TOKYO (Dispatches) - Japan's trade surplus in value-added goods and services (TiVA) with South Korea took a downturn during the 2005-2015 period, reflecting the diversifying structure of logistics and trade, statistics showed Sunday.

In light of the interconnection of the global value chain, the country's recent curbs on hi-tech exports to Korea are likely to affect not only the two countries but also the regional and global economy in general, Seoul's government officials noted.

According to the Organization of Economic Cooperation and Development, Japan logged \$135.2 billion in aggregated TiVA from 2005 to 2015. Its total trade surplus during the same period stood at \$303.2 billion.

TiVA, in international trade is equivalent to operating profits of corporate business transactions, figuring out the value added by each country in the production and distribution process.

The OECD indicator was developed to address the dilemma that conventional measures of international trade can no longer precisely reflect the flow of goods and services in the complex global production chains. For instance, when a Korean customer purchases a

Japanese television for 1 million won (\$848), the OECD would exclude the display panel price when assessing Japan's TiVA in the given deal.

With an increasing number of countries participating in the global value chain, Japan's TiVA surplus with Korea has been declining over



LONDON (Guardian) - Britain is facing the highest risk of a recession since the financial crisis and needs urgent plans to combat the next downturn, according to an

alarming assessment of the nation's economic health. Preparations need to be made to reduce the impact, the study by the Resolution Foundation thinktank warns. It states that both uncertainty around Brexit and the global economic slowdown have led to the highest recession risk since 2007. It raises the alarm over the potential impact on living standards, warning that the five previous recessions have produced an economic shock equating to a £2,500 loss for each household in the UK. They have also increased unemployment by one million. It comes after a series of warnings over the health of the economy amid continuing uncertainty around Britain's EU membership. Earlier this month the governor of the Bank of England, Mark Carney, warned that there had been a "sea change" in the world's financial markets, driven by pessimism

about the economic outlook.

### **German Investments** In Russia Set to Smash 10-Year Record

BERLIN (Dispatches) - German businesses poured more than  $\in 1.7$  billion into the Russian economy in the first three months of 2019, already exceeding half of last year's highest-in-decade figures, the Russian-German Chamber of Commerce has revealed.

The volume of German companies' investment in Russia is up by 33 percent –or €400 million– compared to the same period last year, the German trade lobby said. Results of the first quarter show that German investments in Russia may well, by the end of this year, break a more-than-ten-year record.

"Despite a weakening economic situation, German companies continue to trust in the Russian market and even invest against the trend," chairman of the chamber Matthias Schepp said in a statement.

Last year's total investments reached their highest since the 2008 financial crisis, exceeding earlier forecasts and standing at €3.2 billion. However, it was still short of the all-time high of the €7.8 billion reached in 2007.

Investments continued despite anti-Russian sanctions imposed by Washington and its allies although the restrictions cause much trouble for German firms doing business with Russia. More than 140 companies polled by the chamber said that their total sanctions-related losses had exceed  $\in 1$  billion, the equivalent to what would amount to multi-billion damages for all German enterprises registered in Russia.

### We Need a Radical Shift in Thinking

On 24 and 25 September 2019, Heads of State and Government will gather at the United Nations in New York for the first global summit on the Sustainable Development Goals since the adoption of the 2030 Agenda in 2015.

Our world is at a decisive moment. After decades of relative stability, we are navigating uncertain and even unstable times. Global cooperation is in decline; economic growth rates are down. Some countries and regions are responding by looking inwards, emphasizing division and exclusion; but such short-term thinking will only deepen the global challenges we face.

Many of these challenges are rooted in the economic and social frameworks that we have built over centuries and even millennia, based on exclusion and discrimination. From colonialism to the climate crisis, we are living the consequences of exclusion, intolerance, and a lack of respect for difference and it's killing us.

Inequality is high and rising. By 2030, the richest one percent of people could control two-thirds of the planet's wealth. The rights of minorities and marginalized people, particularly refugees and migrants, are routinely disregarded. Violence is used to enforce patriarchy and millions of women and girls face insecurity and violations of their human rights every day. Military spending is rising even as societies fail to provide basic services for their people.

Climate change is wreaking havoc on some of the most vulnerable countries and regions, while others continue to increase greenhouse gas emissions. Deforestation, overfishing and pollution are causing unprecedented damage. Short-term profits for a few are prioritized over the rights and interests of all.

We have lost sight of our shared humanity and interdependence on each other, and on the planet that gives us life. These principles are shared across all major faiths and traditions, but we have lost touch with them.

Four years ago, all countries came together and agreed unanimously on the 2030 Agenda for Sustainable Development, our transformational roadmap for people, planet, prosperity, peace and partnerships. The Agenda is centered on inclusion, pluralism and the rights of all. It is rooted in evidence that greater diversity and inclusion, particularly of women, is correlated with sustainable economic growth and better prospects for peace and stability. It calls for a fundamental reorganization of our economic, political and social systems so that we can reap the benefits of inclusion, through stronger and more resilient communities and societies based on human rights and human dignity for all.

Such ambitious efforts can work, when they are backed by political will. Thanks to multilateral action, today life expectancy is higher, extreme poverty is declining, literacy is at historically high levels and we are mending the hole in the ozone layer. The Millennium Development Goals, precursors to the 2030 Agenda, helped to lift more than a billion people out of extreme poverty, to make inroads against hunger, and to get more girls into school than ever before. But multilateralism may be a victim of its own success. We have started taking it for granted, rather than treating it as an evolving challenge to be nurtured, promoted and reinvigorated. Without multilateral support for inclusive solutions, we are doomed to lose-lose economics, widening inequality and climate catastrophe. The solutions we need to meet the ambitions of the 2030 Agenda are centered on dignity, well-being and opportunity for all, without discrimination. While these qualities are not measured under Gross Domestic Product, they are critical measures of successful governance. We all have a part to play. Inclusion starts everywhere people connect: businesses, schools, medical clinics, the media and civil society. We need a radical shift towards solutions based on mutual gains rather than zero-sum thinking; towards security based on resilient, inclusive and more equal societies rather than weapons and stronger borders, and towards economic systems that incentivize the sustainability of our planet over profits made from exploitation and destruction.

The National Institute of Economic and Social Research, one of the UK's leading economic forecasters, said last week that the UK would only "narrowly avoid a technical recession", with growth of 0.2% in the third quarter following a decline of 0.1% in the second quarter. A technical recession occurs with two consecutive quarters in which the economy shrinks. Meanwhile there have been warning signs in the

construction industry. The Chartered Institute of Procurement and Supply has warned the political paralysis gripping Westminster has left the industry trapped in "quicksand", with house buying and new orders dropping "like a stone". There are also concerns that the government and Bank

of England have already used many of the tools in their armoury that could curb a future recession. Cutting interest rates to stimulate the economy is hard, as they are already at historically low levels, while quantitative easing (QE), in which more money is pumped into the economy, is likely to have less effect than in the past. Had those weapons not been deployed during the last recession, in which interest rates were cut from 5.75 per to 0.5 per cent, QE amounted to £375bn and VAT was cut to 15%, the downturn would have been 12%. That is the equivalent to £8,000 for every UK household. The Resolution Foundation also warns that it would be dangerous to assume that the next recession will be the same as the last, when major job losses were avoided. It states that it may not be the case that the big unemployment increases that characterised the 1980s and early 1990s recessions have been consigned to history.

However, Western economic pressure has not stopped the growth of Russia-Germany trade turnover, which increased 8.4 percent and reached nearly €62 billion last year.

Moscow and Berlin are also involved in a large construction project, the Nord Stream 2 natural gas pipeline, set to be finished by the end of the year. The project has come under fierce criticism from Washington, which lobbies continuously for the sales of its own liquefied natural gas (LNG) to Europe.

The US also threatened to sanction anyone involved in the Nord Stream 2 project, but Russia's partners on the project – and Germany in particular – have repeatedly defended the pipeline as a way to meet Europe's growing energy demand.

# **Turkey Will Deport Syrian Refugees Who Commit Crimes**

ERBIL (Dispatches) - Turkish President Recep Tayyip Erdogan has threatened to deport Syrians found to have broken the law amid a worrying spike in public hostility toward the 3.6 million Syrian refugees sheltering in Turkey.

"We will encourage Syrians to return to their countries," Erdogan said Saturday during a meeting of his Justice and Development Party (AKP)'s Central Decision and Management Board (MKYK).

"We will definitely deport the criminals" and take "new steps" to alleviate growing concerns among Turkey's citizens about Syrian refugees, he added.

Turkey's Immigration Office, which falls under the Interior Ministry, says there are currently 3,644,342 Syrian refugees in Turkey who fled Syria's protracted civil war.

"We had to open our doors to the Syrians. We couldn't ignore it. We took care of them," Erdogan said. However, he is now calling for a mechanism to encourage the voluntarily return of refugees to Syria.

Under strict new measures, Erdogan will abolish free health services for Syrians, forcing them to pay as Turks do, a move that will increase the financial burden on refugees.

Syrian refugees in Turkey face numerous challenges, including poverty, which worsened last year with Ankara's economic woes. Children, in particular, are vulnerable to discrimination and a lack of educational opportunities, according to the UN

Polling agencies close to the AKP say the party may have lost Ankara, Istanbul, Izmir, and Antalya in this year's municipal election partly because of Erdogan's lenient policies towards Syrian refugees. Since the Turkish military launched the Euphrates Shield and the Olive Branch operations in Syria, around 330,000 Syrians have returned home.

"After the resolution of Manbij and East of Euphrates issues, this figure will reach millions," Erdogan told an AKP parliamentary meeting in early July, referring to Ankara's quarrel with Kurdish-led forces in northern Syria.

More than half of all Syrians have been displaced at least once during the eight-year conflict, many fleeing to Turkey, Lebanon, Jordan, and Iraq. But with neighboring countries creaking under the strain of these massive refugee populations, there are growing calls to send these families back. In the first six months of 2019 alone, some 79,886 Syrians used the Cilvegozu Border Crossing in southern Hatay province to return to Syria, according to Turkish state media agency Anadolu.



A violent attack on Syrian businesses in Istanbul in early July shed light on the divisions in Turkish society over the continued presence of refugees.

Syrian refugees come under similar pressure to leave in Jordan and Lebanon, according to rights groups. Human Rights Watch in early June condemned Lebanon's order for Syrian refugees to demolish their hard shelters, branding it as tantamount to "illegitimate pressure" to return to their war-torn country.

At least 1.5 million Syrians have fled to Lebanon since 2011, many of them living in informal settlements in the country's east. Nearly a million are registered by the United Nations High Commissioner for Refugees.

"This crackdown on housing code violations should be seen for what it is, which is illegitimate pressure on Syrian refugees to leave Lebanon," HRW refugee rights director Bill Frelick said. "Many of those affected have real reasons to fear returning to Syria, including arrests, torture and ill-treatment by Syrian intelligence branches.'

'Iran expects the European parties to the JCPOA to take practical, effective, and responsible decisions and steps regarding the process of implementing the 2015 nuclear deal," he added.

"It would be unrealistic and in violation of the goals, logic, and contents of the JCPOA to expect Iran to return to the situation before May 8, 2019 unless it is proved that the European parties have a serious political will and the practical ability to create a balance in implementing the JCPOA commitments and helping Iran reap the benefits of the sanctions removal as enshrined in the JCPOA.'

"We reiterate that as long as the other parties remain committed [to the deal], we will remain committed to the same extent," he added.

Mousavi's comments came as the European Union's Foreign Affairs Council is holding a meeting with a key focus on the issue of saving the Iran nuclear deal. Upon arrival at the Foreign Affairs Council on Monday, EU Foreign Policy Chief Federica Mogherini said the EU officials are going to "see how we can together with all the Member States and with the rest of our international partners preserve the nuclear deal [Joint Comprehensive Plan of Action] with Iran."

"We will start with a point on Iran. We will see how we can together with all the Member States and with the rest of our international partners preserve the nuclear deal [Joint Comprehensive Plan of Action] with Iran," Mogherini added.

But, fresh exports would be difficult. Indian markets have already started responding to Iran's payment stoppage, and basmati prices shed Rs 10 a kg or 12 per cent the past one month," said Sushil Jain, Vice President, All India Rice Exporters' Association (AIREA).

Informed sources said advance amounts of Rs 1,800 crore received from Iranian importers are lying in various banks accounts held by the Iranians in India. India's basmati rice exporters would continue till payments from these accounts are exhausted.

"Basmati prices have declined in the last one month. But, future price movement would depend upon the progress of this year's monsoon rain and farmers' interest in sowing of basmati paddy," said Anand Goyal, Owner, Akash Rice Mills, a Delhi-based basmati rice miller, trader and exporter. Meanwhile, India's two commodity exchanges, National Commodity & Derivatives Exchange (NCDEX) and Indian Commodity Exchange (ICEX) have started futures trading in 1,121 varieties of basmati. The ongoing uncertainty and price volatility offer immense opportunities for traders, exporters and rice mills to hedge their price risk in futures.

Being a compulsory delivery contract with small trading unit of 10 tonnes and basic delivery centres in Karnal and Haryana, basmati paddy is trading at about Rs 42 a kg in the futures market. "Apart from the Iran issue, Indian basmati rice exporters are also facing phytosanitary issues with the European Union, which poses a threat to ongoing exports. While there arr negotiations with the European Union on pesticide residue issues, overall basmati exports may decline this year," said Gurnam Arora, Joint Managing Director, Kohinoor Foods Ltd, the producer of Kohinoor brand basmati rice.

Basmati prices have been volatile the past few months. Prices fell when the US withdrew the waiver on India's

### German FM Calls for **Qatar Opens Biggest Coast Guard Base**




BERLIN (Dispatches) - Germany's foreign minister says willing EU countries should redistribute migrants saved in the Mediterranean Sea. Some EU countries have vehemently opposed any form of redistribution in recent years.

Germany should promote a "coalition of the willing" among European Union countries that are prepared to accept refugees saved in the Mediterranean Sea, Foreign Minister Heiko Maas said Saturday.

"We must now move forward with those member states that are ready to receive refugees - all others remain invited to participate," he told the RND media group. Germany would be willing to make a substantial contribution to the alliance and accept a set share of refugees as part of a "binding" redistribution system, he added. Maas said Germany would make a substantial contribution

Maas, a Social Democrat, said that disputes between EU countries about redistributing refugees "must no longer" impede an agreement on saving migrants from drowning in the Mediterranean. "This blockade must finally come to an end," he said. EU ministers are scheduled to discuss efforts to save migrants at a meeting next week. Maas said he expected "a decisive step" forward in the discussion. Maas's proposal was immediately rejected by Austria's former chancellor, Sebastian Kurz. Kurz, whose conservative People's Party is the frontrunner to win Austria's parliamentary vote in September, dubbed the common refugee policy a failure, adding that all Mediterranean migrants should be sent back to their home countries. 'The distribution of migrants in Europe has failed," Kurz said on Saturday. "We are once again discussing ideas from 2015 that have long proved impractical." "The order of the day is rather to remove the business case for unscrupulous smugglers and return people after sea rescues to their home or transit countries, as well as creating initiatives for stability and economic development in Africa," he said. Rescue missions in the Mediterranean have sparked tensions particularly between Italy and other EU countries in recent months. Hard-line Italian Interior Minister Matteo Salvini has repeatedly refused to allow charity ships that have rescued migrants from docking at Italian ports. Other EU countries, such as Poland and Hungary, have in recent years refused German-led efforts to introduce an EU-wide system for redistributing refugees who have entered the EU's borders. More than 420 migrants have died trying to enter Europe from North Africa since the beginning of 2019, according to the International Organization for Migration (IOM).

Tehran has said it would potentially scrap the deal if the remaining signatories -- mainly the UK, France and Germany -- fail to deliver on pledges to protect bilateral trade from US sanctions against Iran.

In May, a year after the U.S. President Donald Trump's decision to abandon the deal, Iran suspended some of its commitments under Articles 26 and 36 of the JCPOA, giving the other signatories a first 60-day deadline to turn their verbal support for the accord into concrete action. "Iran's decision to reduce its JCPOA commitments was not out of intransigence and rather aims to give diplomacy a chance and make the other party come to its senses and act upon its obligations," Kamalvandi said Monday.

He added that Iran's uranium stockpile surpassed 300 kilograms after the 60-day ultimatum to Europeans and Tehran was no longer obliged to export the surplus heavy water anymore as it was required under the deal.

"The Europeans have to stay united on this issue," Le Drian told reporters in Brussels on Monday. Iran has made it clear that it would only reverse the decision once the other parties deliver their end of the bargain.

# Hamilton Wins Record Sixth British GP

 $L^{\text{ONDON}}$  (Dispatches) - Lewis Hamilton made the most of a favourable safety car intervention on Sunday to claim a record sixth British Grand Prix victory at a packed Silverstone.

The defending five-time world champion clocking fastest lap on his final lap to finish 25 seconds clear of Mercedes team-mate and nearest title rival Valtteri Bottas after an action-packed contest. The Briton moved 39 points clear of the Finn behind in the title race, but Bottas was unlucky with the timing of the safety car which effectively gave Hamilton a free pit stop.

Charles Leclerc of Ferrari was third.

Pierre Gasly finished fourth ahead of his Red Bull team-mate Max Verstappen, whose race was compromised by a late collision when Sebastian Vettel of Ferrari drove into him, and Carlos Sainz of McLaren. It was Hamilton's seventh win in 10 races this year and the 80th win of his career. He had shared the British Grand Prix record of wins, on five, with fellow-Briton Jim Clark and Frenchman Alain Prost. Daniel Ricciardo was seventh for Renault ahead of Kimi Raikkonen of Alfa Romeo, Daniil Kvvat and his Toro Rosso team-mate Alex Albon.

"What a day," said Hamilton. "To all the crowd, thank-you so much for coming out."

Hamilton, who stopped on his slow-down lap to collect a British 'Union Jack' flag, added: "I love you Silverstone. I appreciate everything and the opportunity to be a part of this. "I couldn't have done this without these guys or without my team." A glum Bottas said: "Congrats to Lewis... It wasn't my day."

A much happier Leclerc said: "It's probably the race I've enjoyed the most in my career.'

The safety car was deployed when Antonio Giovinazzi spun into a gravel trap in his Alfa Romeo ? gifting Hamilton a 'free' first, and only, pit stop. The luckless Bottas, on a two stop strategy, had already pitted before the incident.

On an overcast and cool afternoon, Justin Whiting, the 12-year-old son of the late Charlie Whiting, the official Race Director who died suddenly in Melbourne in March, started the race. before a crowd of 141,000 at Silverstone. As the lights went out, the Mercedes pair pulled clear, Hamilton chasing Bottas throughout the first lap ahead of Leclerc and Verstappen with Vettel fifth.

By lap 10, the lead was three-tenths, Hamilton oozing confidence could not pass Bottas slithering to protect his lead. Behind them, Leclerc blocked attacks from Verstappen. But on lap 17, Bottas came in for a new set of mediums and Hamilton inherited the lead ahead of Vettel, the pair delaying their stops as long as possible. Then Giovinazzi beached his Alfa Romeo at Club

# **Djokovic Claims Fifth Wimbledon Title in Record-Breaking Final**

ONDON (Dispatches) - Novak Djokovic saved two match points to clinch a fifth Wimbledon title and 16th major on Sunday, shattering Roger Federer's bid to become the oldest Grand Slam champion in the longest final ever played at the tournament.

Despite being outplayed by the 37-year-old Swiss for large parts of the knife-edge encounter, the world number one triumphed 7-6 (7/5), 1-6, 7-6 (7/4), 4-6, 13-12 (7/3). At 4 hours and 57 minutes, it was the longest Wimbledon final ever played and settled by a final set tiebreak for the first time.

Djokovic is the first man in 71 years to win the title from match points down. He is now level with Bjorn Borg as a five-time Wimbledon winner.

"I think that if this is not the most exciting final then definitely it's in the top two or three of my career against one of the greatest players of all time, Roger, who I respect," said Djokovic.

"Unfortunately in this type of match someone has to lose. It is quite unreal to be two match points down to come back and strange to play a tie-break at 12-12."

Djokovic is just four Grand Slam titles shy of the alltime record held by Federer who is more than five years older. It was incredibly tough on Federer, chasing a ninth Wimbledon crown, who didn't face a break point until the eighth game of the fourth set.

Djokovic's win meant that the 'Big Three' of men's tennis -- himself, Federer and Rafael Nadal -- have won the last 11 Slams.

He has now won nine of his last 11 clashes against Federer and three of their four Wimbledon meetings.

With William and Catherine, the Duke and Duchess of Cambridge looking on from the Royal Box, Federer carved out the only break point of the opening set. But Djokovic saved it and with serve dominating,

the set was decided by the tiebreak.

The top seed was 3-1 up, then Federer inched to 5-3 before Djokovic swept the next four points.

At 58 minutes, it was two minutes longer than the women's final on Saturday. Djokovic, however, then went completely off the boil, losing his footing as he was broken in the first game of the second set.

Federer broke twice again and after just 25 more minutes the final was all-square with Djokovic managing just two winners in the set.

Federer was comfortably on top in the third set, flashing winners from all parts of the court but was unable to convert a set point in the 10th game.

Djokovic then carved out his first break points of the match in the eighth game.

The first was saved after a breathtaking 35-shot rally before the Serb finally broke for the first time.

It was too little, too late, however, as Federer deservedly levelled the final. Into a tense finale, Federer saved three break points in the fourth game but a drilled, backhand passing shot gave Djokovic the break in the sixth game for a 4-2 lead.

The world number one couldn't back it up and Federer had Centre Court on their feet when he restored parity in the next game. Despite twice being just two points from defeat, Federer broke for 8-7 but was unable to serve out for the match.

### **Barcelona Agree Deal** To Sign Japan's Abe

BARCELONA (Reuters) Barcelona have agreed a deal to sign emerging Japanese talent Hiroki Abe from Kashima Antlers, the J-League club said.

The 20-year-old attacker, named the league's best young player of 2018, was set to undergo a medical with the Spanish side and would join up with their 'B' side.

### Mochizuki Makes **Grand Slam History**

ONDON (AFP) LShintaro Mochizuki made history on Sunday becoming the first Japanese player to win a boy's Grand Slam title, beating Carlos Gimeno Valero of Spain 6-3, 6-2 in the Wimbledon final. The 16-year-old, who



follows 1969 girls singles title winner Kazuko Sawamatsu in triumphing at the grass court Grand Slam.

Mochizuki said he had learned a lot from his compatriot, 2014 US Open finalist Kei Nishikori.

"He's really nice," said Mochizuki. "He gives me a lot of advice.

"Like sometimes I practice with him. I learn from him a lot. Yeah, he's smart." Nishikori, nine times a Grand Slam quarter-finalist, took to Twitter almost immediately to fete his compatriot. "Huge congrats to @ShintaroMOCHIZU! Such an amazing tournament," tweeted the Japanese star, adding a thumbs up icon, a flexed bicep icon and several Japanese flags.

However, it is not 29-year-old Nishikori who is his idol.

# **England Win Cricket** World Cup

LONDON (Dispatches) - England won the World Cup for the first time as they beat New Zealand in a dramatic Super Over after a nerve-shredding final ended in a tie at Lord's on Sunday.

After Eoin Morgan's side finished on 241 all out in pursuit of New Zealand's 241-8, the final came down to a six-ball shootout for each team. England's Ben Stokes and Jos Buttler took 15 off Trent Boult's over. Jofra Archer bowled England's over against Martin Guptill and Jimmy Neesham, who smashed a six off the second ball.



With two runs required off the final ball, wicketkeeper Jos Buttler and Jason Roy combined to run out Guptill as he came back for the second. Both sides finished on 15 so England won due to a tie-break rule because they hit more boundaries. After defeats in previous finals against Pakistan in 1992, Australia in 1987 and the West Indies in 1979, it was a cathartic moment for English cricket.

"My heart is still racing. It's the biggest thing I've ever won, a great bunch of fellas, a really good family to me," Archer said. Stokes was in tears as England's players danced joyously around the pitch.

"I'm pretty lost for words. All the hard work over four years, to get here and be champions of the world. It's an amazing feeling. I'm pretty done," Stokes said with an expression that mixed elation with bewilderment.

"Playing against New Zealand is always a great event. They are a seriously good team and really good lads. I said to Kane Williamson I'll be apologising for that for the rest of my life."

# **Russia** Power Past USA to Win Second VNL Title

HICAGO (Dispatches) - Russia defeated hosts the United States 3-1 (25-23, 20-25, 25-21, 25-20) to claim a historic second FIVB Volleyball Nations League title on Sunday in the 2019 VNL Finals at the Credit Union 1 Arena in Chicago. Russia also claimed Volleyball Nations League gold in 2018 when they defeated France in the final of the inaugural edition of the competition.

Four Russia players scored in double digits during the final, including Dmitry Volkov (17), Egor Kliuka (14), Ivan Iakovlev (12) and Victor Poletaev (11). Taylor Sander scored 20 for USA and Matt Anderson 19.



The two teams met in the pool stage of the Finals on Friday when coach John Speraw's USA players prevailed in three sets. But with the trophy at stake, the North Americans were unable to restrain a Russia team which also defeated reigning back-to-back world champions and 2019 VNL bronze medallists Poland en route to the final in yesterday's semifinals. Highlighting outstanding performances during the Men's Finals in Chicago, an MVP/Best Opposite award was received by the USA's Matt Anderson. Other players receiving awards in the Best Outside Hitter category included Russians Egor Kliuka and Dmitry Volkov and Poland's Bartosz Bednorz, who led his team to the bronze medals. Ivan Iakovlev of Russia and Max Holt of USA received the Best Middle Blocker honours.

Hawaiian Micah Christenson was rewarded for his performance at the setting role, and his ability to distribute the ball with pinpoint precision. His teammate, 29-year-old Erik Shoji received the prize for best libero, after again demonstrating his ability to keep the ball alive in even the most difficult situations.
