TEHRAN - Health Ministry says 85,064 patients have so far recovered from the COVID-19, the disease caused by the novel Coronavirus.

The Ministry's spokesman, Kianoush Jahanpour, on Saturday confirmed 1,529 new cases of Coronavirus infection, increasing the total number of cases to 106.220. He said 48 people have also died of the disease in the

past 24 hours, raising the death toll to 6,589. According to the spokesman, 2,696 patients are in

severe conditions of the disease. So far, he added, 573,220 COVID-19 tests have been

taken across the country. Meanwhile yesterday Deputy Health Minister Iraj Harirchi said Iran's healthcare system has acted perfectly to keep the death toll and hospitalizing level low.

In response to question about the latest situation in Khuzestan province j Harirchi, deputy head of Health Minister in a live video presser on Saturday 9 May, said that Khuzestan situation on COVID-19 epidemic is worrying and agonizing and the infection is rocketing there. See Page 7

## **Over U.S. Violation of JCPOA**

TEHRAN - Foreign Minister Mohammad-Javad Zarif has written a letter to United Nations Secretary-General Antonio Guterres to elaborate on the U.S. violations of the Joint Comprehensive Plan of Action (JCPOA) and the UN Security Council Resolution 2231, demanding the international body to safeguard its reputation.

Zarif discussed issues like the U.S. withdrawal from the deal and restoration of sanctions on Iran and intended to draw the attention of the UNSC to the U.S. repeated and overt violation of Article 25 of the UN Charter, which has endangered the credibility and integrity of the United Nations and threatens the international peace and security.

Zarif wrote to Guterres that the U.S. withdrew from the JCPOA on May 8, 2018, and restored all the sanctions that had been removed by the deal, which was a basic violation of the JCPOA, which is an overt violation of the UNSC Resolution 2231. Withdrawing from the deal and restoring the sanctions make the US accountable before the UN charted and international human rights.

The U.S. violated UNSC Resolution 2231 that was confirmed with consensus on January 20, 2015. The UN should at once do its duty and make the US accountable for blatant violation of the UN Charter and international law, which will tarnish the UN's credibility.

It is crystal clear to everyone that the U.S. illegal actions openly ignore the international law and the UN Charter and weaken the principle of the peaceful resolution of disagreements, endangers multilateralism and its institutions, signifies a return to the failed time of unilateralism, and also encourages illegal actions, which all show an open threat to international peace and security.

Zarif also said that Resolution 2231 stresses that "the JCPOA is conducive to promoting and facilitating the development of normal economic and trade contacts and cooperation with Iran", and "calls upon all members-states, regional organizations, and international organizations to take such actions as may be appropriate to support the implementation of the JCPOA, including by taking actions commensurate with the implementation plan set out in the JCPOA and this resolution and by refraining from actions that undermine implementation of commitments under the JCPOA'

He wrote not only has the US not acted according to its JCPOA commitments, but it has also kept impeding the measures taken by other members of the deal.

Zarif wrote since President Donald Trump has taken office, the US has taken up unilateral actions and 129 sanctions against Iran to deal an irreparable blow to Iran's economy and its trade exchanges with other countries. Such negative actions have had a direct impact on the Iranian private sector and have cut the income of ordinary people of Iran and weakened the private sector for production and entrepreneurship. The economic conditions are worse than how it was before the JCPOA. See Page 7 "The complete list of the sanctions is enclosed to further clarify the issue," Zarif wrote in his letter.

### **U.S. Breach of UN Resolution 2231 Mockery of Int'l Law**

TEHRAN (IFP) - Iran's ambassador to the United Nations says the United States' violation of UN Security Council Resolution 2231 makes a mockery of international regulations.

Majid Takht Ravanchi also fulminated against Washington for threatening other countries. "One of the living examples of systematic mockery of international law is the U.S. breach of UNSC Resolution 2231 and its blatant threats against other countries to make them violate the resolution or face punitive measures," said the top diplomat at a virtual and unofficial meeting of the UN Security Council held Friday, marking the 75th anniversary of the of World War II.

He also stressed the need to reinforce multilateralism. "Multilateralism has faced numerous challenges, and the strengthening of the rule of law, international cooperation and interaction are the requisite for those challenges to be removed," he said.

The top diplomat said lessons should be learned from the bitter experience of World War II.

He also said the UN was established to serve as a center to coordinate actions by countries in order to solve global problems. See Page 7

### Any U.S. Effort to **Exploit UNSC Resolution 2231 "Futile"**

BEIJING (Dispatches) - Permanent Mission of the People's Republic of China to the United Nations called Iran's nuclear deal 2015 a multilateral agreement, saying any effort to exploit the Security Council Resolution 2231 would go nowhere.

"Iran's nuclear deal 2015 has been approved by the UN Security Council as a multilateral agreement and is still legally binding and effective," the mission said on its Twitter page on Friday.

Ambassador Zhang Jun, Permanent Representative of China to the UN added: "It is the responsibility of all parties to the agreement, known as the Joint Comprehensive Plan of Action (JCPOA), must act by its provisions as well as Resolution 2231. Efforts to exploit the resolution will not work."

"We support the United Nations in taking more decisive action in the face of the problems of the most vulnerable countries," he went on to say, pointing to the global Coronavirus Pandemic.

'COVID-19 is a common enemy of all, and to fight it, we must stand with the United Nations and the World Health Organization, prioritize people, respect science, and protect life and health," he said.

### **Swiss Humanitarian Channel Yet to Process** A Single Deal for Iran

TEHRAN (Dispatches) - A new report published in the American media shows a Swiss trade channel much publicized by Washington as a secure way of delivering humanitarian assistance to Iran at a time of sanctions has failed to process any single deal on Iranian medicine imports.

The Daily Beast reported that Iranians have got almost nothing from the Swiss Humanitarian Trade Agreement (SHTA) since it was launched in January with the support and consent of the US.

The channel was meant to find a way around the US sanctions to use Iranian funds deposited abroad to buy food and medicine for the country via the Swiss bank BCP.

However, companies seeking to participate in the scheme have found it very difficult to comply with the criteria set by the U.S. government to avoid violating the general rules governing the sanctions, said the report.

Fabian Maienfisch, a spokesman for Switzerland's State Secretariat for Economic Affairs (SECO), which oversees the channel, admitted in comments made to the Daily Beast that the initiative had effectively failed to meet its objectives.

### India Sugar Exports Boosted by Strong Demand From Iran

MUMBAI (Dispatches) - Sugar exports from India have gained momentum due to strong demand from Indonesia and Iran as the rupee slid to a record low, increasing exporters' margins from overseas sales, five industry officials told Reuters.

Higher exports from India, the world's biggest producer of sugar, could put pressure on global prices and limit shipments from rivals such as Brazil and Thailand.

"In the last few days, Iran and Indonesia were buying for May and June shipments," Rahil Shaikh, managing director of trading company MEIR Commodities India, told Reuters.

Indian sugar mills have already dispatched 3.7 million tons out of around 4.1 million tons of contracts signed for exports in the 2019/20 marketing year ending on Sept. 30, Shaikh and two other dealers with global trading companies, said.

Traders have shipped 719,922 tons to Iran so far in the season, while Indonesia bought a record 324,112 tons, according to data released by All India Sugar Trade Association (AISTA) on Thursday.

Indonesia has increased imports of Indian sugar after New Delhi boosted purchases of Indonesian palm oil amid a spat with rival supplier Malaysia, dealers said.

Indonesia and Malaysia account for 85% of the world's palm oil output while India is the biggest buyer of the edible oil. India effectively halted imports of refined palm oil from Malaysia in early January which sources have said was in retaliation for Malaysia's criticisms over a citizenship law.

Large scale Indian exports to Indonesia were made possible after Jakarta changed purity regulations for sugar imports, said Shaikh See Page 7

### U.S. Sets Up New Military **Base in Syria's Oil-Rich** Dayr al-Zawr

DAMASCUS (Dispatches) - The United States has reportedly established a new military base in Syria's oil-rich eastern province of Davr al-Zawr after bringing in reinforcements to the war-torn Arab country.

The so-called Syrian Observatory for Human Rights (SOHR) quoted reliable sources as saying on Friday that the new U.S. base is located in Day al-Zawr's al-Jazrat area.

The U.S.-based monitoring group reported that more than 300 trucks, carrying ammunition, weapons, military and logistical supplies, had entered Syria over the past few days and that most of those trucks headed to al-Jazrat.

It further said the U.S. forces are expanding their base in the al-Omar oil field in the eastern countryside of Dayr Al -Zawr.

Recently, it added, American soldiers and other U.S.-led coalition troops had arrived at the base.

Washington runs several military bases in Syria, mainly in northern and eastern regions where the Kurdish-led Syrian Democratic Forces (SDF) are operating.

TEHRAN - In a note on the occasion of U.S. withdrawal from JCPOA, Iranian Government Spokesman Ali Rabiei announced that US sanctions have made the Iranian nation more creative and the nation will eventually defeat the American embargoes.

"May 8 marks the day President Trump pulled out from the JCPOA, which was an illegal international move, seeking a separation between Iranian establishment and nation." he wrote.

"Sanctions are kind of indirect murder, which increases the risks of common people's lives," Rabiei underlined.

He noted that under the sanctions, Iran needs dynamic diplomacy to foil the accusations made by the U.S. against Iran on the way to negatively influence world public opinion against the Islamic Republic.

"Two years after the imposition of unprecedented sanctions on Iran, the Iranian government and people have gone through a difficult period."

"The Iranian society has become increasingly resilient and creative, and the



government has worked hard to maintain Iran's independence in the eyes of the international community," he wrote, "Iran's government could convert U.S.' face in the world from a rightful state to an irrational government that rules the world only relying on its political and economic power."

He added that even under the sanction and coronavirus pandemic, Iran has been successful to preserve its economy resilient and managed to export some anti-coronavirus products to various world countries.

Rabiei underscored that Iran's fate will not be similar to those countries which are also under the US sanctions and the Iranian nation will eventually make sanctions kneel down.

### **President Urges Producing Coronavirus Test Kits Fit for Exports**

TEHRAN (IRNA)- President Hassan Rouhani hailed successful achievements in meeting the needs for countering coronavirus and called for development of coronavirus detection kits both to meet domestic needs and export to applicant countries.

After listening to a report on the country's situation on fighting coronavirus, way of screening and implementation of health protocols by Minister of Health, Treatment and Medical Education Saeed Namaki late on Friday, he appreciated medical personnel for their efforts in containing the disease, saying that all relevant institutes are duty-bound for cooperation with Health Ministry in executing health guidelines so that all businesses will resume operation.

The chief executive also stressed the need for effective information dissemination and public awareness, urging continued implementation of all health protocols until complete break of the chain of coronavirus spread.

Rouhani also called on health minister to review necessary issues and present in next Sunday session of National Coronavirus Taskforce to make necessary decisions in this respect.

### Iran Sent 40,000 Test Kits to Several Countries

TEHRAN (PressTV) - The Iranian foreign minister has stressed the importance of international cooperation on the response to the coronavirus pandemic, thanking Indian Parsis for sending aid to Iran, and saying that Tehran has sent 40,000 COVID-19 test kits to several countries.

"The Parsis of India-Zoroastrians whose ancestors long ago emigrated to India-have remained ever faithful in their love for Iran. Grateful for their Covid-19 package for Iranians," Mohammad Javad Zarif said in a tweet on Friday.

Up to 69,000 Parsis, who are Zoroastrians of Iranian origin, currently live in India.

Zarif also said that 40,000 "advanced Iran-made test kits" have been exported to Germany, Turkey and other countries.

"[We are] in this together," he added.

The Parsis of India-Zoroastrians whose ancestors long ago emigrated to India-have remained ever faithful in their love for Iran. Grateful for their #Covid19 package for Iranians.

The export of Iranian diagnosis kits comes after Tehran announced last week that it had permitted the export of test kits after a reported surge in their production.

### Tehran, Zagreb Seek Expansion of Bilateral Cultural Cooperation

TEHRAN (IP) - Iran's ambassador in Zagreb met and held talks with Grand Mufti and President of the Meshihat of Islamic Community in Croatia Aziz Hasanovic on Friday to expand bilateral cultural cooperation.

Iran's ambassador to Croatia Parviz Esmaeili praised Grand Mufti's management in preserving Croat Muslims' health and observing health protocols amid the Coronavirus outbreak.

"Making optimal use of virtual space for promoting spiritual activities and cultural communication is a valuable experience for the religious undertaking," Esmaeili said during the meeting.

Meanwhile, Grand Mufti Aziz Hasanovic appreciated close ties between Iran's Embassy in Croatia and Meshihat of Islamic Community and pointed to the extensive arrangements for saving Muslims' health in the country against the Coronavirus.

"Only three of Croat Muslims have been infected with the COVID-19 and one has died of the virus," he noted.

The Grand Mufti of Croatia stressed that if the situation normalizes, holding of the International Holy Qur'an Competition in Zagreb will be on the agenda of Meshihat of Islamic Community.

ISLAMABAD (IRNA) - Consul General of Iran in Pakistan's Karachi says that the independent countries of the world should take it upon themselves as a duty to compel Donald Trump to abide by international laws and commitments.

Ahmad Mohammadi wrote in his article on Saturday that the exit from the Joint Comprehensive Plan of Action (JCPOA) by the U.S. is now into its second year.

"The JCPOA is an international agreement which was the result of Iran's years of several talks with the P5+1 countries," he said.

Mohammadi added it is considered as one of the most unparalleled diplomatic measures which came as a welcome development for the experts and the world public opinion for resolution of the lingering issue of Iran's nuclear program and showed that logical-talks bring logical results.

"The UN General Assembly welcomed the agreement and its Security Council abrogated its sanctioning resolutions against Iran, besides removing Iran's nuclear issue from chapter 7 of the UN charter," noted the diplomat. Mohammadi said it was for the first time in the world that the issue of a country was removed without resorting to using power and war measures and only through negotiations and consent.

"Unfortunately, before long, the US administration unilaterally exited from this international agreement. This exit was actually a plan that Donald Trump had in his head since the start of his presidential election campaign, he noted.

He said on May 8, 2018, the Trump administration, on baseless pretexts, exited officially from the JCPOA and announced the reimposition of the unilateral and illegal sanctions against the proud nation of Iran.

"These sanctions are into their second year and are continuing even when Iran is badly hit by the coronavirus pandemic, hindering Iran's war against this deadly virus and endangering the lives of people as well as those of medics and paramedics," said the envoy.

He said the exit from the JCPOA is not the sole example of Trump's backing out from international agreements.

### Iran Handicrafts Exports Reach \$427m in 11 Months

TEHRAN (MNA) - Iran's exports of handicrafts in the 11 months of the past fiscal year to February 19 amounted to \$427 million, said the deputy cultural heritage, handicraft and tourism minister.

Pouya Mahmoudian added that of the total amount, some \$237 million accounted for official exports, and the remaining \$190 million belong to the suitcase trade. According to the available data, the figure shows a 13.3% and 8% growth in terms of value and volume, respectively, compared with the corresponding period of the year before.

Noting that the country had set a \$440-million goal for last fiscal's handicrafts exports, the official said, the 11-month figure indicates a 97% realization of the plan. Iran's handicrafts exports reached \$289 million in the fiscal (2018-2019), suggesting a mild growth of 3% year on year. Traditional ceramics, pottery vessels, handwoven cloths as well as personal ornamentations with precious and semi-precious gemstones were the main products exported last year.

Iraq, Afghanistan, Germany, the U.S., the UK, were the top five export destinations of Iran during the said period.



### **No Surge in Production Possible Without Facilitating Exports**



TEHRAN - Chairman of Iran Steel Producers Association criticized recent decision of the government for limiting the amount of steel exports and called it a serious hurdle in way of the slogan of surge in production.

Dr. Bahram Sobhani said that instead of encouraging the exports, the government restricts exports, adding that with the current restrictions, the surge in production in steel industry will be in danger.

He criticized recent decision of the government to limit exports of steel to only 25 percent of the production, and called it a hurdle in way of surge in production.

He noted that all decisions which are made are against the needs of national steel industry and the government creates hurdle in way of steel exporters instead of encouraging them. Sobhani reiterated that surge in production will be impossible without facilitating the export process.

On the current programs of steel production in the country and the amount of production surplus in the country, he said it is expected the raw steel production to hit 30m tons this year. He added that some 10 million tons of raw steel will be produced in Mobarakeh Steel Group, Hormuzgan Steel Company and Saba Steel Company.

Sobhani noted that if production of 1.5m tons of Khouzestan Steel Company's slab steel production is reduced from 30m tons target, some 28.5m tons of steel will be produced in the country and some 7m tons is needed by the domestic production in



the rolling units. He added that the country's steel production is more than what the domestic market needs and some 10 to 11m tons of produced steel ingots are surplus in the country and should be exported.

He also criticized restrictions on steel exports, adding that he does not know why there is concern regarding steel exports. He further said while two-thirds of steel ingot production is over than domestic market needs and it should be exported, there is no reason to have concerns about the amount of steel exports.

Sobhani reiterated that exports of 10 to 11m tons of steel in the sanctions era is not an easy job and the government in this condition should facilitate the exports rather than creating hurdle.

He recommended while the country is in dire need of non-oil exports forex, it is necessary the exports to be facilitated.

He warned if the country wants to materialize the surge in production, it should think of solving the current cumbersome regulations, reiterated that with current regulations, last year's record of 27m tons of production will not touch 30m tons this year, and to this end, all should be mobilized to ease exports.

#### Tehran Stock **Exchange Index Passes 1m Points**



TEHRAN (IFP) - The Tehran Stock Exchange (TSE) index has surpassed 1 million points for the first time in history.

The overall index increased by more than 26,000 points as trading opened on Saturday, May 9, 2020, to reach 1,004,474 points.

The benchmark Tehran Stock Exchange index has been growing in recent weeks.

According to experts, the main reason for the unprecedented increase in the stock market index and its record-breaking is the flow of stray cash into the stock market and the pressure to buy stocks of limited companies on the stock exchange and over-the-counter.

### Iran Purchases Iraqi Goods in Exchange for Exporting Electricity

TEHRAN (ILNA) - The spokesman of the Petroleum Products Exporters Union, Seyed Hamid Hosseini announced that Iran purchases Iraqi goods in exchange for exporting electricity to Iraq.

The member of the Chamber of Commerce said Iran will not be able to withdraw the money but will be able to use it to purchase goods from Iraq.

He further explained "Iraq imports around 1,500 MW of electricity and 30 million cubic meters of gas for power stations from Iran," adding that Iraqis do not pay us any money for the gas they import and all the money is now in the account of the Tejarat Bank of Iraq.

The spokesman of the Union for Exporting Oil Products said "Following the U.S. sanctions, some arrangements have been taken to use the blocked money in the central bank's account in another way."

"The central bank has announced its readiness to allocate the money to buy goods from Iraq," Hamid Hosseini added. Iraq has always been a customer of more than eighty percent of Iran's electricity exports.

On May 7, shortly after new Iraqi Prime Minister Mustafa al-Kadhimi received confirmation from parliament, U.S. Secretary of State Mike Pompeo called the new premier and told him that Washington will move forward with a 120-day waiver to allow Iraq to import electricity from Iran.

Iraq is still Iran's most loyal business partner despite hurdles imposed by sanctions, protests, the coronavirus crisis, and --- most importantly of all --- the United States' continuous pressure on Baghdad to try to get it to drop out of the deals to buy Iranian electricity and gas.

### 17% Increase in Gold Ingot Production Envisaged in Iran

TEHRAN (IRNA) - Iranian Mines and Mining Industries Development and Renovation Organization's (IMIDRO) manager announced a 17% rise in gold production in Mouteh Gold Mine (Isfahan) and Zarshouran Gold Mine (West Azarbaijan) in the current Iranian year compared to the figure for the previous year.

Omid Emami added that last year, gold bullion production in these units stood at 1,139 kilograms while 1,333 kilograms have been targeted for 2020.

This year, designated as the Year of Surge in Production', all sectors are expected to experience growth and iron ore is projected to see a 19% increase this year compared to the figure for last year, he said. According to Emami, production of iron ore at IMIDRO's mines will reach 75 million tons, up from 62.5 million ton last year.

There are 10,404 licensed mines across the country, of which 5,600 are active.

Mouteh Gold Mine, located in Isfahan Province, is owned by Iran Minerals Production and Supply Company. Zarshouran Gold Mine is located 35 kilometers from Takab in the northwestern province of West Azarbaijan is Iran and Middle East's richest gold deposit.

He added that by this measure, the life span of equipment will increase and the operation and repair costs will reduce.

Ebrahimi noted that by operation of this unit, the total production capacity of the refinery has reduced from 375,000 barrels per day to 360,000 barrels.

He added that by launching the distillation unit, the existing viscosity reduction units

have been pulled out of crude oil circle and have been placed in the main operation circle.

He stated these developments have reduced the amount of mazut oil production and instead they have increased valuable products like gasoline, kerosene, jet fuel and gas oil.

Ebrahimi reiterated that in case the country needs increase in gasoline production, the company can increase its daily gasoline production by 70,000 barrels per day by using two of its peripheral units.

He then pointed to some projects of the company which are underway like construction of gas oil refining, construction of utility and off-site project of gas oil refining and new boilers and water unit (DM).

### **U.S. Approves Helicopters to Egypt**

WASHINGTON (AFP) - The United States has approved a \$2.3 billion deal on attack helicopters for Egypt, but an official insisted Friday that Washington was still pressing on human rights concerns.

President Donald Trump's administration informed Congress on Thursday that it has given the green light to the package to refurbish 43 Apache helicopters.

R. Clarke Cooper, the State Department official in charge of military sales, said the deal was intended to support Egypt's campaign against Islamist militants in the Sinai peninsula and to ensure its interoperability with Israel's military.

### **U.S. Reversal Prevents Vote on Pandemic Truce**



NEW YORK (Dispatches) - The United States on Friday stunned other members of the UN Security Council by preventing a vote on a resolution for a ceasefire in various conflicts around the world to help troubled nations better fight the coronavirus pandemic, diplomats said.

Washington's reversal came a day after it agreed to the text, negotiators said under cover of anonymity.

"The United States cannot support the current draft," the country's delegation declared, without further detail, to the 14 other Security Council members, after nearly two months of difficult negotiation over the text.

The latest stalemate continues to leave the global peace and security body largely mute in the face of a once-in-a-century pandemic that has killed more than 270,000 people and raised further fears for the world's most vulnerable.

When asked for an explanation of the US move, a State Department official told AFP that China had "repeatedly blocked compromises that would have allowed the Council to move forward." Diplomats told AFP that the language used in the draft to describe the World Health Organization was behind the U.S. move to prevent the vote. But other sources said Washington wanted the Council to return to an initial draft of the resolution which highlighted the need for "transparency" in global cooperation in tackling the pandemic.

"In our view, the Council should either proceed with a resolution limited to support for a ceasefire, or a broadened resolution that fully addresses the need for renewed member state commitment to transparency and accountability in the context of COVID-19," the State Department official said.

U.S. President Donald Trump has accused the WHO of downplaying the seriousness of the outbreak in China. The procedure blocked by the United States would have allowed the sponsors of the resolution, France and Tunisia, to put it to a vote. The latest version of the text -- obtained by AFP -- called for a cessation of hostilities in conflict zones and a 90-day "humanitarian pause" to allow governments to better address the pandemic among those most suffering.

It called on all nations to "enhance coordination" in the virus fight and highlighted the "urgent need to support all countries, as well as all relevant entities of the United Nations system, including specialized health agencies, and other relevant international, regional, and sub-regional organization."This wording, which implicitly refers to the

WHO without explicitly mentioning it, was the compromise obtained from US and China on Thursday night, according to diplomats

Washington had threatened to use its veto if there were any explicit reference to the WHO, while Beijing brandished its own veto if the global health body were not mentioned, before in the end accepting that it would not be.

Diplomats said the U.S. had let go more than a week ago of its demand for mention of transparency in the French-Tunisian text. The "ball was in the Chinese camp" now, one of them said previously.

The U.S. turnaround "is a very, very bad news for United Nations, the Security Council and multilateralism," said one ambassador from a Security Council member. UN Secretary-General Antonio Guterres has been pushing for a cessation of hostilities around the world since March 23, urging all sides in conflict to lay down arms and allow war-torn nations to combat the coronavirus. French Ambassador Nicolas de Riviere told AFP that he would like "of course to continue to try to reach an agreement, if there is room for that." His Tunisian counterpart Kais Kabtani said discussions are continuing "to convince the Americans." He vowed that the procedure for going to a vote would be taken up again. Ironically, the Security Council was also engaged Friday in a major videoconference organized by Estonia, which holds the body's rotating presidency this month, on the 75th anniversary of the end of World War II. More than 50 ministers from around the world participated, most of them issuing a "plea for multilateralism."

Pro-GNA forces have been able to reverse some of the losses they suffered last year with the help of Turkish drones and air defence systems, which stopped most air strikes by the LNA and its allies. The LNA is supported by the United Arab Emirates, Egypt and Russia.

Wednesday's Misrata blasts came after an attack by the pro-GNA forces on al-Watiya airbase west of the capital, one of the LNA's most important strongholds in western Libya. The pro-GNA forces have also moved towards Tarhouna, another key LNA bastion. The U.N. Libya mission said last month that during the first quarter of 2020, at least 131 civilians were killed or injured, a rise of 45% over the last quarter of 2019 as the fighting escalated. It said ground fighting was the main cause of the deaths and that four fifths of them were caused by forces affiliated to the LNA.

### Trump, Saudi King Reaffirm **Defense Ties Amid Tensions**

WASHINGTON (Reuters) - U.S. President Donald Trump and Saudi Arabia's King Salman spoke by phone on Friday and "reaffirmed the strong United States-Saudi defense partnership," the White House said, amid tensions over Saudi's oil output.

The conversation came a day after a variety of reports said the United States plans to withdraw two Patriot antimissile batteries from Saudi Arabia that have been a defense against Iran.

Trump had worked last month to persuade Saudi Arabia to cut its oil output after an increase in production during the early stages of the coronavirus pandemic put heavy pressure on U.S. oil producers.

### Venezuela Charges Americans With Terrorism, Conspiracy

CARACAS (AFP) - Venezuela has charged two former U.S. soldiers with terrorism and conspiracy for allegedly taking part in a failed bid to topple President Nicolas Maduro, the attorney general said on Friday.

Luke Alexander Denman, 34, and Airan Berry, 41, were among 17 people captured by the Venezuelan military, which said it had thwarted an attempted invasion by mercenaries in the early hours of Sunday.

Attorney General Tarek William Saab said they had been charged with "terrorism, conspiracy, illicit trafficking of weapons of war and (criminal) association," and could face 25-30 years in prison. Eight attackers were reportedly killed in the incident.

Saab said Venezuela had requested an international arrest warrant for the capture of former US army medic Jordan Goudreau, who allegedly organized and trained the mercenary force.

### Germany Wants Europe to Be Less Dependent on Other Countries

BERLIN (Reuters) - The coronavirus pandemic has shown Europe is too reliant on other countries for some medical supplies, and European states should work together to further diversify international supply chains, German Economy Minister Peter Altmaier told Reuters.

"Germany, which will take over the rotating EU presidency from July on, feels a special responsibility in the coronavirus crisis to actively shape Europe in a spirit of solidarity," Altmaier said in remarks cleared for publication on Saturday.

Altmaier, a close ally of Chancellor Angela Merkel, said the single market remained the economic backbone of the European Union and the envy of many other countries, even more so in light of the coronavirus pandemic.

"The current crisis shows that we have to avoid one-sided dependency and diversify international supply chains to a greater extent," Altmaier said, adding that Europe had to become less dependent on non-European suppliers of medical precursors as well as medical protection gear such as masks.

"For this we need a European industrial strategy to strengthen the industrial base in Europe, combined with good framework conditions, especially for small and medium-sized companies," Altmaier told Reuters.

But the minister insisted that such a strategy had to be compatible with the ules of the World Trade Organization (WTO), adding: "The current crisis does not mean a farewell to globalization. On the contrary, it underlines the importance of clear international trade rules that everyone must abide by."

The German government is preparing a change to its foreign trade regulations that would require the government to be informed of purchases by countries outside the European Union of stakes in key healthcare companies.

Altmaier also said the EU should combine the task of supporting the economic recovery from the pandemic with the broader goal of reducing greenhouse gases to slow down global warming.

"After the crisis, Europe has to become a source of ideas for a socially just transformation, a climate-friendly economy and a successful shift towards renewable energies," he said. "Technologies that were already a thing of the past before the crisis will be even more so after the crisis," he added.

"We have to design the European Green Deal as a growth strategy for our economy so that innovations and new clean technologies can help us to find new export markets and secure jobs."

Maduro has accused President Donald Trump of being behind the alleged invasion -- and Saab said Friday the Venezuelans involved would be tried for "conspiracy with a foreign government."

Trump has roundly rejected the accusation, telling Fox News on Friday: "If I wanted to go into Venezuela I wouldn't make a secret about it."

"I'd go in and they would do nothing about it. They would roll over. I wouldn't send a small little group. No, no, no. It would be called an army," he said. "It would be called an invasion."

Venezuela said on Monday it had arrested the two former US special forces soldiers and on Wednesday Maduro, who showed the pair's passports on state television, said they would be tried.

The U.S. army has confirmed they were former members of the Green Berets who were deployed to Iraq. Secretary of State Mike Pompeo said the U.S. government would "use every tool that we have available to try to get them back."

Maduro described the raid as a "remake" of the failed 1961 Bay of Pigs invasion, when Cuban exiles covertly financed and directed by the U.S. government attempted to overthrow then Cuba leader Fidel Castro.

Announcing the arrests, Saab said Venezuela's opposition leader Juan Guaido, who is backed in his challenge to Maduro's authority by the United States and more than 50 other countries, was behind the mission.

### UK to Place All Incoming Travelers Under 14-Day Quarantine

LONDON (Reuters) - British Prime Minister Boris Johnson will announce on Sunday that all travelers coming to the United Kingdom will be quarantined for a fortnight, The Times reported

"Passengers arriving at airports and ports including Britons returning from

abroad, will have to self-isolate for 14 days," the newspaper said, adding that travelers will have to provide the address sat which they will self-isolate on arrival.

Travelers from Ireland, the Channel Islands and the Isle of Man will be exempt, as will lorry drivers bringing crucial supplies, the report added.

The authorities will carry out spot checks and those found to be breaking the rules are to face fines of up to 1,000 pounds or even deportation, the report added.

According to The Times, travelers will have to fill in a digital form with details of where they plan to self-isolate themselves for the duration of the quarantine.

The measures will help reduce the "transmission of the virus as we move into the next phase of our response," the report said, citing a government source

The measures are expected to come into force in early June.

Johnson will announce a very limited easing of Britain's coronavirus lockdown next week, adopting a cautious approach to try to ensure there is no second peak of infections.

### Coronavirus May Push Up Euro Zone Borrowing by 1.5 Trillion Euros

FRANKFURT (Reuters) - Euro zone governments may need to borrow an additional 1.5 trillion euros(1.31 trillion pounds) this year to keep their economies afloat amid the coronavirus pandemic, European Central Bank President Christine Lagarde said on Friday.

"The ECB estimates that - in our medium scenario of a drop in GDP of around 8% - the additional government financing needs in the euro area this year resulting from the recession and the required fiscal measures may exceed 10% of euro area GDP," Lagarde said. "This would put the additional debt issuance due to the pandemic in the range of 1 trillion to 1.5 trillion euros in 2020 alone.





### **U.S. Suffers Biggest Job Losses** In History Amid Coronavirus

NEW YORK (Dispatches) - With shops and factories closed nationwide due to the coronavirus pandemic, nearly all of the jobs created in the U.S. economy in the last decade were wiped out in a single month.

An unprecedented 20.5 million jobs were destroyed in April in the world's largest economy, driving the unemployment rate to 14.7 percent compared to 4.4 percent in March, the Labor Department said in its monthly report, the first to capture the impact of a full month of the lockdowns The United States is home to the world's largest and deadliest coronavirus outbreak, with more than 75,000 fatalities and 1.2 million cases reported as of Thursday, according to Johns Hopkins University. The economic damage has been swift and stunning.

In the two years of the global financial crisis, the world's largest economy lost 8.6 million jobs and the unemployment rate peaked at

10 percent in October 2009. During the recovery, from February 2010 to February 2020, 23 million positions were created.

The plunge in nonfarm payroll employment last month was the largest ever recorded dating back to 1939, while the jobless rate saw its highest and biggest increase dating back to 1948, the report said. And job losses in March were worse than initially reported, falling 870,000 even though the business closures happened mostly in the second half of the month.

Employment fell sharply in all major industry sectors. Leisure and hospitality was the first sector hit and the one bearing the brunt of the impact of the lockdowns, and posted a loss of 7.7 million jobs. However, the Labor Department noted that some workers were misclassified in the report as employed when they should have been counted as laid off. Had they been listed properly, the unemployment rate would have been nearly five percentage points higher.

President Donald Trump said Friday the numbers were expected, and promised: "I'll bring it back."

"Our country is warriors and maybe now more than ever because they are going back to work," he said on Fox News. And even that double-digit rate underestimates the impact of the virus, since many employees are simply leaving the workforce altogether or have been forced into part-time work instead of full time.

The measure of the labor force as a share of the total population dropped to 51.3 percent, its lowest in history, while number of people not in the labor force who currently want a job nearly doubled to 9.9 million.

New claims for unemployment benefits remain at a staggering 33.5 million since mid-March, meaning the jobless rate could go much higher still.

"We knew it was bad out there but it is looking like it is even worse that we thought," economist Joel Naroff said in his analysis prior to the release of the data.

"Now I am wondering if we will hit 40 million (jobs lost), which would take us to an unemployment rate of 25 percent or more. That is truly scary, as you have to go back to the early 1930s, during the Great Depression, to see anything nearly like that," he said. Despite nearly \$3 trillion in financial aid approved by Congress in March alone and trillions more in liquidity provided by the Federal Reserve, there is a growing fear that the temporary shutdowns imposed to contain the spread of the virus will become permanent for many companies.

### Taiwan Warns on China-U.S. Trade Frictions as Exports Tick Down

TAIPEI (Reuters) - Taiwan's exports, a key gauge of global demand for gadgets, fell slightly for a second month in April and the government said the second quarter would be tough due to the coronavirus pandemic and renewed concerns over U.S.-China trade friction.

Exports dropped 1.3% from a year earlier to stand at \$25.24 billion(20.37 billion pounds) in April, the finance ministry said. A Reuters poll had forecast an annual drop of 1%.

In March, Taiwan's exports slipped 0.6%, but they have risen 2.4% on the year so far in 2020.

The ministry said strong demand for telecommuting amid the coronavirus outbreak and advanced chips vas offset by weakening global consumption for products from textiles to minerals.

Taiwan, whose largest trading partner is China, warned of "limited" growth prospects for the island's xports in the first half, adding that lingering concerns over U.S.-China trade could add to the uncertainty. Taiwan's May exports were expected to range from a decline of 4% to 6% on the year, Beatrice Tsai, head of the ministry's department of statistics, told reporters. She said it would be "difficult" for exports to maintain growth in the second quarter and the ministry will need to "significantly" trim its earlier forecast of a yearly growth of 2.5% for the period due to gloomy global economic outlook.

While Taiwan has so far prevented a rapid spread of the disease without a total lockdown, the government has repeatedly varned of an uncertain trade outlook and is rolling out an economic stimulus package worth T\$1.05 trillion (\$35 billion). It has also pledged to lure manufacturers to move production home from China, saying returning investment to Taiwan from China would reach over T\$320 billion this year and give a boost to its economy.

### IMF Giving \$18b to Help 50 Nations Bear Virus Impact

WASHINGTON (Dispatches) - The International Monetary Fund (IMF) has approved a total of \$18 billion so far to help dozens of countries bear the impact of the coronavirus pandemic, a spokesperson said.

"Since roughly the beginning of April until May 6th, yesterday, we have approved financing for 50 countries under these emergency facilities," Gerry Rice, the head of the IMF communications department, said at a virtual press briefing.

"It's an IMF moving at an unprecedented speed in an unprecedented way to meet this unprecedented challenge, which we are all facing of course."

He said over 100 countries had requested or expressed interest in assistance from the IMF since the start of the COVID-19 crisis.

The spokesperson said the fund had increased access to its emergency facilities the rapid credit facility and the rapid financing instrument – to meet an expected global demand of \$100 billion.

Rice explained that the emergency assistance for COVID-19 was not comparable with normal IMF programs since the funds were not tied to certain conditions.

### German Export Plunge in Maï BERLIN (Reuters) - German exports fell

by 11.8% in March, their steepest drop since current records began in 1990, as the coronavirus crisis reduced demand for goods from Europe's biggest economy, the Federal Statistics Office said on Friday.



Seasonally adjusted imports fell by 5.1% and the trade surplus narrowed to 12.8 billion euros (£11.2 billion) from a downwardly revised 21.4 billion euros in February, the office said.

Economists polled by Reuters had expected exports to fall by 5% and imports by 4%. The trade surplus was expected to come in at 18.9 billion euros. The German government expects the economy, which depends on exports, to shrink by a post-World War Two record of 6.3% despite a massive rescue package of 750 billion euros to cushion the impact of the pandemic. Economists expect any recovery to be slow and the pace to largely depend on how fast Germany's European neighbors and other trade partners like China and the United States emerge from the crisis. "The interdependence of the global economy will be disastrous for the export sector during the coronavirus crisis," Alexander Krueger of Bankhaus Lampe wrote in a note, adding that the worst was still to come.

Friday's trade figures were the latest data to offer a gloomy outlook for Germany, which had been in its 11th straight year of growth before the outbreak. Both industrial orders and output posted record drops in March, data published earlier this week showed. Germany's export-oriented manufacturers had been struggling with weak demand set off by trade frictions that preceded the coronavirus crisis, leaving the economy to rely on consumption and state spending for growth. But lockdown and social distancing measures introduced in mid-March have curtailed


household spending expectations even as Germany starts to gradually reopen its economy.

A survey by the GfK institute on Friday showed that a third of Germans plan to spend less and 33% believe their financial situation will worsen in the next 12 months. That bodes ill for the prospects of a consumption-driven recovery. "The new 'normal' will be marked by a difficult economic

situation and tight consumer budgets," said Petra Sueptitz of GfK. "Retailers and manufacturers must adjust to this."

A separate survey by the DIHK Chambers of Commerce found that 60% of Germany's companies are suffering from reduced demand and 80% expect revenues to fall this year. The DIHK's Volker Treier said that one silver lining of the crisis could be a detente in the trade conflict between China and the United States, which would benefit German companies present in both countries.

"We are sliding into a global economic crisis," said Treier. "We expect German exports to fall by at least 15% this year."



TOKYO (Reuters) - Japan's economy likely shrank for a second straight quarter in the first three months of this year, a Reuters poll showed, meeting the technical definition of recession as the coronavirus pandemic wiped out consumption and business activity.

Gross domestic product (GDP) data, due out on May 18, is likely to show the world's third-largest economy contracted an annualized 4.6% in the January-March period, a poll of 14 analysts showed on Friday.

That would follow a 7.1% decline in the previous quarter, which was blamed on the hit to consumption from a domestic s tax hike rolled out in October. The two straig

### Moody's Sees India's Economic Growth at 0% in 2020-21

NEW DELHI (Dispatches) - Analysts across the board have been certain about the heavy economic toll that the pandemic will take on the country.

The impact of the coronavirus outbreak will exacerbate the material slowdown in India's economic growth, with the country expected to see 0 per cent expansion in the current fiscal year, analysts at Moody's said on Friday.

The ratings agency said it expected India to see no growth in financial year 2021 and bounce back to a 6.6 per cent GDP growth in FY22, while the fiscal deficit is seen rising to 5.5 per cent of GDP in FY21 versus the budgeted estimate of 3.5 per cent.

The COVID-19 spread in the country has also "significantly reduced the prospects of a durable fiscal consolidation," it said in a report. In November, Moody's cut the outlook on India's sovereign rating of Baa2 to "negative" from "stable" due to a slowdown in growth and had said it will monitor the country's debt levels closely.

Baa2 is the second-lowest investment grade score.

"Prolonged financial stress among rural households, weak job creation and, more recently, a credit crunch among non-bank financial institutions have increased the probability of a more entrenched weakening," the agency noted.

If nominal GDP growth does not return to high rates the government will face very significant constraints in narrowing the budget deficit and preventing a rise in the debt burden, Moody's said.

India has so far outlined Rs 1.7 lakh crore stimulus plan providing direct cash transfers and food security measures to give relief



to crores of poor and a second package focussing on help for small and medium businesses is expected soon.

Moody's reiterated that the negative outlook indicates an upgrade is unlikely in the near term.

"We would be likely to change the rating outlook to stable if we saw a significant increase in the probability of fiscal metrics stabilizing and strengthening over time," it said. It added that a downgrade of India's rating would likely occur "if we expected its fiscal metrics to weaken materially". India's eight-week long lockdown, one of the world's most stringent, has helped contain the spread of the coronavirus, officials say, with the country having reported only 56,342 cases and 1,886 deaths, compared to the 38.6 lakh global infections.

Many analysts expect the economy to suffer an even deeper contraction in the current quarter, as the government's decision to declare a state of emergency in April intensified the drive for citizens to stay home and businesses to close.

With infections in Japan exceeding 15,000, the government extended a state of emergency on Monday through to the end of the month, pressuring companies to shut down factories and stores longer than previously expected.

### **Coronavirus Deals Powerful Blow to Putin's Grand Plans**

MOSCOW (Dispatches) - The bombastic military parade through Moscow's Red Square on last Saturday was slated to be the spectacle of the year on the Kremlin's calendar

Standing with Chinese leader Xi Jinping and French President Emmanuel Macron, President Vladimir Putin would have overseen a 90-minute procession of Russia's military might, showcasing 15,000 troops and the latest hardware.

But that was before the coronavirus pandemic.

Now, military jets will roar over an eerily quiet Moscow, spurting red, white and blue smoke to mark 75 years since the defeat of Nazi Germany. Putin will lay flowers at a war memorial near an abandoned Red Square and address a nation growing angry with his handling of the country.

The parade is not the only victim of the coronavirus pandemic, which has crippled Russia's economy, hospitalized the prime minister and slashed Putin's approval ratings.

Russians had been due last month to cast their votes on constitutional reforms that would have paved the way for Putin to stay in power until 2036, but those plans too were scuppered by the virus. What was supposed to be a triumphant spring for Putin has become a political letdown, observers say, one that could be difficult for the president to recover from.

"This is the first time in 20 years that Putin is facing a crisis this serious," said political analyst Tatiana Stanovaya. "This is a new experience for him."

The timing of the pandemic, hitting just as Putin was unveiling major constitutional reforms, amounts to "a powerful blow to his plans", she told AFP.

After initially reporting fewer cases than in western Europe, Russia has witnessed a grim and steady rise in new coronavirus infections in recent days. Health officials registered another record increase on Thursday and the country now ranks fifth in the world in overall infections.

Russia's death rate is low compared to the European countries hardest hit, but some observers say that discrepancy is due to how the death count is calculated.

Putin this week praised the government's response, saying that by implementing mass testing and keeping fatalities low, Russia had become a model for other countries.

"What we did was absolutely right," he said. "Many foreign countries followed our path." Yet many Russians appear to disagree. Unlike other world leaders battling the pandemic, Putin's approval ratings have not rallied in light of the crisis.

According to independent pollster Levada, they fell to a historic low of 59 percent last month from 63 percent in March.

Already strained by Western sanctions, Russia's economy is under serious threat from the pandemic, which analysts say could deepen resentment towards the Kremlin.

Since Russia imposed a lockdown to slow the spread of the virus, small businesses have struggled to survive and millions of Russians have been left without wages, despite promises from the government to support companies and employees.

Igor Nikolayev, director of the Institute for Strategic Analysis at FBK Grant Thornton, said the timing of the crisis was unfortunate as it coincided with a steep fall in the price of oil, a key export which balances the Russian budget.



He said Russians were not prepared for this dual shock, noting that 60 percent do not have savings and that real incomes have fallen 7.5 percent over the last year. Russia can weather the storm for around 18 months, he said, thanks to reserves in its sovereign wealth fund of some \$150 billion.

But if the crisis persists and "life does not become easier, this will affect the attitude of the people to the authorities," Nikolayev told AFP.

Putin could well bounce back. He has weathered many crises over 20 years in power and is credited by many Russians for bringing the country out of the chaos of the 1990s and restoring its global prestige.

Officials have said both the parade and the constitutional vote will be held later in 2020, though analyst Andrei Kolesnikov said that alone may not be enough to salvage Putin's year. Putin "enjoyed Russians' approval for many years," said Kolesnikov, of the Carnegie Moscow Centre. "Now he will personally accumulate all their disapproval."

"In the context of the coronavirus crisis, the vote will not mobilise the nation," he said, and the military parade alone "will not seriously help support Putin's falling ratings."

Stanovaya said that after so many years in power Putin has "distanced himself from the people" and lost the ability to empathize with Russians. If the Kremlin cannot address economic problems, "social irritation will grow, there will be protests," she warned.

### **Oceans May Rise** Over a Meter by 2100, Five Meters by 2300



PARIS (AFP) - Oceans are likely to rise as much as 1.3 meters by 2100 if Earth's surface warms another 3.5 degrees Celsius, scientists warned Friday.

By 2300, when ice sheets covering West Antarctica and Greenland will have shed trillions of tons in mass, sea levels could go up by more than five meters under that temperature scenario, redrawing the planet's coastlines, they reported in a peer-reviewed survey of more than 100 leading experts.

About ten percent of the world's population, or 770 million people, today live on land less than five meters above the high tide line.

Even if the Paris climate treaty goal of capping global warming below 2C is met -- a very big "if" -- the ocean watermark could go up two meters by 2300, according to a study in the journal Climate Atmospheric Science. Earth's average surface temperature has risen just over one degree Celsius since the pre-industrial era, a widely used benchmark for measuring global warming. "It is clear now that previous sea-level rise estimates have been too low," co-author Stefan Rahmstorf, head of Earth system analysis at the Potsdam Institute for Climate Impact Research (PIK), told AFP. The new projections for both the 2100 and 2300 horizons are significantly higher than those from the UN Intergovernmental Panel on Climate Change (IPCC), including a special report on oceans it released in September.

### **Shortages of Virus Test Materials Critical**

VIENNA (AFP) - Shortages of materials needed in tests for the novel coronavirus remain "critical", according to the head of a UN lab, which is supplying countries with COVID-19 detection kits.

In particular the chemical reagents for the tests are still in short supply, said Giovanni Cattoli, head of the Animal Production and Health Laboratory run jointly by the UN Food and Agriculture Organization (FAO)

and the International Atomic Energy Agency (IAEA).

"There is indeed on the global market a shortage of some items, particularly reagents, because there are demands from all over the world," Cattoli told AFP this week during a tour of the laboratory at Seibersdorf, 40 kilometres (25 miles) outside Vienna. "The situation is still critical," he said. "We are working... to accelerate purchase and investigate if there are alternative reagents.'

The U.S. withdrawal from the deal and restoration of the oppressive sanctions on Iran should be considered as a warning against international peace and security. In fact, this is the first time in the history of the UN that a permanent member of the UNSC punishes the member states for following a Security Council resolution.

It is high time that the UNSC and its members guaranteed a complete implementation of the ICPOA by its parties. Instead of passively observing the insulting actions of the US, The UNSC should severely condemn the US re-imposition of illegal sanctions against the people of Iran, which is an overt violation of Resolution 2231 and international law. The US should be made accountable for the damage made to the people of Iran and all the damages should be compensated. The international community should guarantee the implementation of and loyalty to the JCPOA.

As mentioned in Iran's statement issued on January 20, 2015, following the confirmation of the deal in the UNSC, removal of the sanctions by the US and the European Union means that all the trades and activities mentioned in the JCPOA with Iran and the Iranian people should be done with no fear of punishment due to extraterritorial impediments. The JCPOA openly states that both the U.S. and the EU should avoid restoration and re-imposition of the restrictive sanctions that were removed by the JCPOA.

Unfortunately, as the result of the re-imposition of sanctions on Iran since May 2018, Iran has been deprived of the benefits of removal of the sanctions stipulated in the JCPOA. In fact, the understanding was that Iran "will treat such a re-introduction or re-imposition of the sanctions specified in Annex II, or such an imposition of new nuclear-related sanctions, as grounds to cease performing its commitments under this JCPOA in whole or in part". It was stated in Article 26 of the deal.

Malaysia has also stepped up purchases since February and has so far bought a record 327,292 tons of sugar, according to data compiled by AISTA.

Indonesian buying has now slowed but Iran is still making purchases, said a Mumbai-based dealer with global trading firm, who is not authorized to speak to the media. ### European Leagues President Warns Against Opportunist Changes to Football

BERN (Reuters) - The coronavirus stoppage should not be used as an excuse to end European football's Financial Fair Play rules or make "opportunist" changes to the international calendar, the head of the European Leagues umbrella organization said on Friday.

As football begins to reawaken after the stoppage, which began in mid-March, European Leagues president Lars-Christer Olsson, whose members include 27 top-flight leagues, told Reuters he believed most clubs would survive.

The Bundesliga is due to re-start on May 16 while leagues in Hungary, Croatia, Poland, Portugal and Serbia have also set dates for a resumption.

Olsson said he was "sincerely worried" about the Financial Fair Play (FFP) rules, which bar clubs from spending more than the revenue they generate and were introduced to stop rich owners from pumping money into their clubs.

Some clubs had asked for them to be dropped during recent discussions, Olsson said. "What is important is that the coronavirus doesn't mean we abolish Financial Fair Play and club licensing rules because that will undermine the achievements so far," he said in a phone interview from Sweden.

He said that ending FFP would be "the opportunity for the richest clubs to widen the gap. This would take us back to the time where the clubs had debts which continued to build ... and that would be detrimental."

### Barca Return to Training As La Liga Eyes Restart

ADRID (Dispatches) - Barcelona returned to training on Friday after the La Liga champions allowed their stars to enter their facility to prepare for a potential restart to football in Spain.

Lionel Messi and company took the fields at Joan Gamper training centre for individual sessions, for which the players arrived alone in kit and took to the three pitches without passing through the changing rooms.

As well as doing their routines, they were also subjected to tests to see what effect two months of coronavirus quarantine has had on their bodies.

"Finally we are getting back to normal. We hope to carry on and that soon we can get back to enjoying what we like to do most," Arturo Vidal told sports daily Marca. Sevilla, Villarreal, Osasuna and

Sevilla, Villarreal, Osasuna and Leganes also returned to training, while Real Madrid -- who were two points behind league leaders Barca Olsson said that, while FFP was introduced for European competition, some national leagues had subsequently adopted their own versions of it.

"There should be more licensing, not less," he said.

He was also unimpressed by FIFA president Gianni Infantino's suggestion that this could be the time to reform the calendar and by vice-president Victor Montagliani's proposal that Europe could switch to a calendar-year season.

"It is opportunistic because it's trying to change things by using the crisis as the reason and moving things in the direction of their own ideas, rather than having a proper decision-making process," said Olsson.

"They are also taking the opportunity to create room for new FIFA competitions like the Club World Cup so we have to be cautious."

Despite the long stoppage, Olsson said he was optimistic that clubs would avoid the worst.

"Generally speaking the governments have accepted their responsibilities... for the future life of football clubs," he said. tinist of the second se

"There is a good chance that almost all clubs will survive especially if we start (playing) now... commercial partners have taken their responsibility towards the clubs in a very good way so far."

Olsson said he was happy that football was starting again and that there had been an "exchange of best practices" between the leagues.

"We have been working for the last month or so, trying to convince all leagues that they should work on establishing protocols for conditions on restarting the season," he said.

"The main condition is that starting football should not increase the general health risk. There are some risks involved but this is a cautious and sensible way of playing matches." He added: "Psychologically, it's very important because football is important for a lot of people and it is a good sign for society in general that football can resume and be played in a secure way."

ADRID (Reuters) - Real Madrid forward Luka Jovic has not conducted full training or played any matches for over two months due to the coronavirus pandemic, but he somehow still managed to break his foot and is expected to be out of action for around seven weeks.

A statement from Real on Friday said the Serbia striker, who cost 60 million euros (52.36 million pounds) last year but has only scored two goals all season, had fractured a bone in his right foot but did not say when Jovic could hope to return. Spanish newspaper El Pais reported that Jovic had injured himself training at home in the Spanish capital and said he would be out for around seven weeks.

Jovic, 22, was given permission to return to Serbia during Spain's state of emergency to fight the pandemic but was caught breaking the rules of Serbia's lockdown in March.

Real, who are two points behind leaders Barcelona in the Spanish title race with 11 fixtures remaining, are due to return to individual training for the first time in two months on Monday.



L ONDON (Dispatches) - Tottenham Hotspur striker Son Heung-min was named one of the top five recruits in his unit as he finished three weeks of compulsory military training in South Korea on Friday.

South Korea's marine corps posted pictures of Son wielding an M-16 assault rifle and saluting on their Facebook page as he completed his stint at a boot camp.

All able-bodied South Korean men are obliged to serve in the military for nearly two years, making up the bulk of Seoul's 600,000-strong forces -- who face off against North Korea's army of 1.3 million.

But Son -- the top Asian goalscorer in Premier League history, and the Asian Football Confederation's reigning international player of the year -- was in the South Korean team that earned an exemption by winning gold at the 2018 Asian Games in Indonesia.

The Spurs star broke down in tears of joy after the 2-1 extra-time win over Japan, which meant he could fulfil his obligations with just three weeks' basic training and around 500 hours of community service.

In April he reported to a marines camp on the island of Jeju for the basic training, which involved lengthy hikes, as well as tear-gas training and rifle practice.

He was judged among the five best recruits out of 157 on his course, a spokesperson for the Republic of Korea Marine Corps told AFP.

### India to Accept Quarantine to Save Aussie Test Series

NEW DELHI (Dispatches) - India's cricket team is prepared to undergo quarantine to salvage a money-spinning Test series against Australia, a top official said Friday, but there was less optimism about this year's Twenty20 World Cup taking place Down Under.

Virat Kohli's men are scheduled to contest a four Test series in Australia towards the end of the year but will need to isolate for two weeks under current COVID-19 rules. Board of Control for Cricket in India treasurer Arun Dhumal said the Test team were willing to make that sacrifice to save the series, which cash-strapped Cricket Australia desperately needs to replenish its coffers.

"There is no choice — everyone will have to do that (quarantine). You would want to resume the cricket," Dhumal told Fairfax newspapers.

"Two weeks is not that long a lockdown."

Australia this month dethroned India as the world's top-ranked Test team, setting up the series as a blockbuster rivalry. The series would also generate hundreds of millions of dollars for a host organisation struggling during the coronavirus shutdown.

Revenue from the series is so important to Cricket Australia that it has proposed adding a fifth Test, which would mean ditching a one-off Test against Afghanistan in November.

### Klose Joins Bayern as Assistant Coach

BERLIN (Dispatches) - Miroslav Klose, who holds the record for the most goals scored at men's World Cups, has joined Bayern Munich as assistant coach, it was announced.



"It feels very good, I'm really looking forward to the task," said the 41-year-old, who scored 16 goals at four World Cups and won the 2014 title with Germany. Klose will be on the Bayern bench when the Bundesliga restarts in nine days after having been suspended since mid-March due to the coronavirus, with Bayern travelling to Union Berlin on Sunday May 17.

The former Bayern striker says joining his old club is "the next step" in his coaching career after having worked with their Under-17 team for the last two seasons.

Klose signed a deal until June 2021 which reunites him with Bayern head coach Hansi Flick, Germany's assistant coach at the 2014 World Cup.

"We trust each other both professionally and personally," Klose said of Flick. Klose's record on the pitch speaks for itself with 71 goals in 137 internationals for Germany. "With his experience as a former professional at the highest international level, 'Miro' is the perfect addition to our team of coaches," said Flick.

Klose also scored 53 goals in 150 appearances for Bayern, who he left for Lazio in 2011 before retiring after five years in Italy.
