Tehran Raps U.S. Attempts to Ruin JCPOA

VIENNA (Dispatches) - The head of Iran's nuclear agency said Monday that the landmark 2015 deal between Tehran and world powers on his country's atomic program is struggling since the unilateral U.S. withdrawal, but is still worth preserving.

Ali Akbar Salehi told delegates at a conference of the International Atomic Energy Agency in Vienna that the so-called Joint Comprehensive Plan of Action, or JCPOA, has been "caught in a quasi-stalemate situation" since President Donald Trump pulled the U.S. out in 2018.

The deal promises Iran economic incentives in exchange for limits on its nuclear program. The remaining world powers in the deal — France, Germany, Britain, China and Russia — have been struggling to offset re-imposed American sanctions. Iran has been steadily breaking restrictions outlined in the deal on the amount of uranium it can enrich, the purity it can enrich it to, and other limitations in order to pressure those countries to do more. Salehi, speaking in a video address, said it's of the "utmost importance" that those countries find a solution

to resolve "the difficulties caused by the illegal withdrawal of the U.S. from the deal." See Page 7

177 More Added to Iran COVID-19 Death Toll

TEHRAN (PressTV) - Health Ministry spokeswoman says the novel coronavirus has killed 177 patients since Sunday noon, increasing the overall death toll to 24,478.

In a press briefing on Monday, Sima-Sadat Lari said 425,481 patients have contracted the virus so far, including 3,341 new cases identified in the past 24 hours, the highest daily rise in new patients since June 6.


So far, she added, 361,523 patients have recovered from the disease or been discharged from the hospital. Lari said 3,912 patients are also in critical conditions caused by more severe infection.

The spokeswoman noted that 3,773,300 COVID-19 tests have been taken across the country so far.

She said the high-risk "red" zones include Tehran, Qom, Mazandaran, East Azarbaijan, Isfahan, Yazd, Ardabil, Khorasan Razavi, Khuzestan, Hamadan, West Azarbaijan, Bushehr, Alborz, Lorestan, Markazi, Ilam, South Khorasan, Kermanshah, North Khorasan, Semnan, Gilan, Zanjan, Qazvin, and Kerman provinces.

The "orange" zones also include Golestan, Hormozgan, Chaharmahal and Bakhtiari, Kohgiluyeh and Boyer-Ahmad, and Fars provinces, she added.

Iraqi Imposed War Proved Cost of Invading Iran Very High

TEHRAN – Supreme Leader of the Islamic Revolution Ayatollah Seyed Ali Khamenei says Iran's decisively victorious defense against foreign-backed forces of Iraq's former dictator Saddam Hussein proved that invading the country is a "very costly" undertaking.

"When a nation shows that it has the diligence and power to defend itself and delivers a crushing response to invaders, invaders would then think twice before perpetrating any incursion against this country and its people, and realize that such an act of aggression would be very costly for them," the Leader said on Monday.

Ayatollah Khamenei made the remarks via video-link during an event held in the capital Tehran to honor one million veterans of the country's 1980-88 war against Saddam's invading forces.

Successful engagement in the war, therefore, awarded the country its current level of security, the Leader noted, enumerating the rewards of the Sacred Defense.

The name signifies Iran's eight-year struggle under the leadership of the late founder of the country's Islamic Republic, Imam Khomeini against the Iraqi aggressor.

The invading forces took on Iran with untrammeled foreign support in 1980, just one year after the victory of the Islamic Revolution. The war lasted until 1988, leaving a treasure trove of memories of self-sacrifice and spiritual conviction in ultimate divine victory.

The Leader said the defensive struggle also equipped the Iranian nation with a sense of self-belief in its ability to fend for itself and put it on a course of technological and scientific development because it had to wade into many new areas to be able to buttress its defense capability.

The war taught us that "some things that appear to be impossible, are actually possible," Ayatollah Khamenei stated. While specifying the actual goal of the warmongers as being the destruction of the country's Islamic Revolution and its Islamic establishment, the Leader noted that Saddam and his Ba'ath party were just being used as "tools by powers, such as the United States, that had suffered serious blows from Iran's Revolution."

Others, like the Soviet Union, the Western military alliance of NATO, as well as some other Western and even European countries also contributed to the war because they were "concerned" about the emergence of a new phenomenon in the region that had been founded upon religion, Ayatollah Khamenei said.

Documents that surfaced afterwards showed the U.S. had entered some agreements with Saddam before the war, the Leader remarked, adding that during the war too, Washington would generously provide the former Iraqi dictator with intelligence and arms support. Ayatollah Khamenei reminded how weapon-laden vessels would dock at regional ports to shore up the invading forces against Iran on a daily basis during the wartime. See Page 7

Iran Ready for Arms Exports After Lifting of Embargo

TEHRAN (Tasnim) – Commander of the Islamic Revolution Guards Corps Aerospace Force Brigadier General Amir Ali Hajizadeh voiced Iran's readiness to export arms as soon as a UN embargo is terminated next month.

Speaking to reporters on Monday, Hajizadeh said the export of Iranian military equipment would be facilitated after the termination of the arms embargo.

The Islamic Republic of Iran's arms program is not going to change at all, the commander added, saying Iran has already become self-sufficient in the military industry.

"We do not rely on foreigners to supply our demand for arms," he underlined. The general said termination of the UN arms embargo in October will have several advantages, as it marks a political victory for Iran and would allow the export of arms.

He further dismissed the U.S. president's threat of military action against Iran, saying Trump has already made such nonsense comments which have been proved wrong, such as his previous threat to hit 52 locations in Iran.

The U.S. suffered an embarrassing diplomatic defeat in August when the United Nations Security Council rejected a proposal to indefinitely extend the arms embargo on Iran.

Int'l Community Urged To Rise From Abstention To Active Defiance

TEHRAN (IRNA)- Iranian Diplomatic Mission in the European Union in a message urged the international community to rise from abstention to active defiance in safeguarding the rules-based international order.

"The int'l community must rise from abstention to active defiance in safeguarding the rules-based international order," Iranian mission wrote on its official Twitter account.

"In the face of a bully who backs his statements with roguish deed, mere words would not suffice," it added. "All countries have a responsibility to safeguard the rule of law."

Earlier, High Representative of the European Union for Foreign Policy and Security Affairs Josep Borrell in a statement had rejected the US claim with regard to the restoration of the UN sanctions against Iran, saying sanctions lifting commitments under JCPOA continue to apply. See Page 7

Russia Launches Military Drills, Featuring Forces From Iran, China

TEHRAN (Moscow) - Russia has launched the Kavkaz (or Caucasus) 2020 joint military drills with neighboring countries in its Southern Military District and in the Black and Caspian Seas.

The joint military exercises, which started on September 21 and will run through September 26 involve about 80,000 personnel, including officers of the Russian Emergencies Ministry and the Russian Guard, as well as up troops from Iran, Armenia, Belarus, China, Myanmar and Pakistan.

In addition, more representatives from the armed forces of Iran, Azerbaijan, Indonesia, Kazakhstan, Tajikistan and Sri Lanka will participate as observers of the military drills. About 12,900 military personnel from the participating countries are going to take part in activities covered by the 2011 Vienna Document of the Negotiations on Confidence-and Security-Building Measures. Most of the action on the ground will be taking place in the Southern Military District.

Up to 250 tanks, 450 infantry fighting vehicles and armored personnel carriers and 200 artillery and missile systems will participate.

Ships of the Black Sea Fleet and the Caspian flotilla will join the action, too, enjoying the company of the Iranian Navy vessels. About 60 Ilyushin Il-76 military transport planes have been moved to operational airfields as part of the military drills.

The distance of the flights was up to 2,000 km, according to a statement by the Russian Defense Ministry, Russia's Armed Forces will pay particular attention to combating cruise missiles and unmanned aerial vehicles during the exercise, the Ministry stated.

"The Kavkaz-2020 drills will particularly focus on combating cruise missiles and unmanned aerial vehicles, as well as on fire and electronic warfare activities against entire enemy formations, on training airborne troops' vertical envelopment capability and ways to rapidly shift between military activities," the statement read. The event is led by Chief of the General Staff Army General Valery Gerasimov.

TEHRAN (MNA) – Ministry of Foreign Affairs of the Russian Federation announced that Iranian Foreign Minister will travel to Moscow on Thursday to meet with his Russian counterpart.

Iranian Foreign Minister Javad Zarif will visit Moscow on September 24 and have a meeting with Russian Foreign Minister Sergey Lavrov, Zamir Kabulov, the head of the Foreign Ministry's Second Asian Department and special presidential representative for Afghanistan, told Sputnik on Monday.

"Yes, he [Zarif] is coming. His consultations with Sergei Lavrov are planned for September 24", Kabulov said. "They will discuss the usual issues — bilateral relations, Syria, JCPOA, other regional issues". According to Kabulov, the ministers will discuss the potential lifting of an arms embargo.

Moscow previously defended Tehran, criticizing the unilateral actions of the United States in connection with the situation around Iran's nuclear program. Russia stressed that Washington's claim that the UN sanctions on Iran were restored was misleading as the UN Security Council (UNSC) took no such steps. Zarif's previous visit to Moscow took place in July. During his visit, he met and bilateral talks with senior Russian officials.

Judiciary Chief Slams U.S. for Violation of Int'l Regulations

TEHRAN (MNA) – Iran's Judiciary Chief Ebrahim Raeisi said the current behavior of the US is a clear violation of the international treaties and laws.

He made the remarks in his meeting with high judiciary officials on Monday.

Raeisi underlined the significance of being determined in resolving domestic problems and noted that tying the solution of internal problems to external issues [the result of the US Presidential elections] is a strategic mistake.

Today's behavior of the Americans about previously accorded agreements is a clear violation of international regulations and treaties, he said.

Raeisi called on the European parties to the 2015 nuclear deal to honor their commitments practically instead of voicing verbal support.

He also said, "Europeans must honor their commitments in practice. Issuing statements and making speeches are not sufficient."

The top judge also stressed that need for plans to urge the EU to fulfill its undertakings.

He further lashed out at the U.S. government for reneging on the previous agreements, saying it amounts to a brazen violation of the international law and the law of treaties.

The Judiciary chief also warned that linking the settlement of Iran's internal problems to the foreign issues or the results of elections in the other countries would be a strategic mistake.

The top Iranian judge then decried the humiliating move by a number of regional countries to normalize ties with the Zionist regime.

Raeisi finally underlined that the Islamic Republic's strategy is based on active and mighty resistance in the face of enemy, building the country with reliance on domestic capacities, and defending the national rights at the international organizations.

He also criticized the normalization of ties between some regional Arab rulers and the Israeli regime and said that Iran's strategy is Resistance against the enemies and making improvements relying on domestic capabilities.

The sacred defense has brought power and authority to the country and this power must be used intelligently, the Judiciary chief said.

U.S. Rotten From Inside, Isolated From Outside

TEHRAN (MNA) – Stating that U.S. has been rotted from the inside, IRGC Commander Major General Hossein Salami advised Iranian people not to be concerned about the U.S. threats.

He made the remarks on the sidelines of the commemoration ceremony for honoring more than one million war veterans during eight years of Sacred Defense on Monday.

Referring to the U.S. President's recent threats to strike Iran "1000 times greater in magnitude", Salami said that the U.S. has lost its symbols, and even the American people are now chanting the slogan "Down with USA".

American People are defacing iconic statues in the United States and burning the American flag, he added.

He noted that the U.S. has been rotted from the inside and isolated outside of the country as well. Salami also advised Iranian people not to worry about the U.S. threats.

Recently, U.S. President Donald Trump threatened to strike Iran "1000 times greater in magnitude" following a false report of a US media on alleged Iran plan to assassinate a US diplomat.

In reaction to Trump's threat, General Salami on Saturday said that Iran is serious about taking Martyr Soleimani's revenge as it will target those behind the assassination and will take revenge in a fair manner.

Iran to Unveil New Defense Projects

TEHRAN (Tasnim) - Chief of Staff of the Iranian Armed Forces said this year's Sacred Defense Week in Iran would be marked with the unveiling of tens of new defense projects.

Chief of Staff of the Iranian Armed Forces Major General Mohammad Hossein Baqeri attended a ceremony at the Islamic Revolution and Sacred Defense Museum of Tehran on Monday morning, held in commemoration of the veterans of the imposed war of the 1980s.

The top commander said this year's Sacred Defense Week would be marked with the inauguration of "tens of defense projects and hundreds of construction projects".

He also noted that 8 new Sacred Defense museums will open across Iran during the Sacred Defense Week, bringing the total number of war museums to 23. In 2025, Iran will have 36 Sacred Defense museums and a museum of war against arrogance in the eastern city of Tabas, he added.

In Iran, the 1980-1988 Iran-Iraq war is known as the Sacred Defense, and the Sacred Defense Week is held on the anniversary of the beginning of the war in September. The outbreak of coronavirus has canceled this year's military parades in remembrance of the martyrs in the eight-year Iraqi-imposed war.

New Russian Contractor to Start Work on Power Plant South of Iran

TEHRAN – Energy Minister Reza Ardakanian said Russia has changed the contractor that was supposed to work on the Sirik power plant in southern Hormozagan Province and the new contractor is going to start working on the project in the coming weeks.

Iran had signed a memorandum of understanding (MOU) with the Russian Company Technopromexport for implementing the 1,400-megawatt power plant project in August 2016, and the Russian side pledged to invest up to \notin 1.2 billion in the project.

The construction of the mentioned thermal power plant started in February 2017, however, it came to a halt due to some administrative and funding problems from the Russian side. "[After years of postponing] eventually, the Russian side came to the conclusion that the contractor [for the project] should be replaced. On this basis, a new contractor was selected, which is also approved by our country," Ardakanian told IRNA on Monday.

Necessary administrative steps related to this replacement are currently underway, the energy minister said.

Ardakanian noted that the credit line for this project is expected to be opened in the coming weeks and the new contractor will hopefully start the project's executive operations. Once fully operational, the Sirik project would add some 12

terawatt-hours (TWh) of power to Iran's current production capacity. The project has been described as a symbol of Russia's growing inclination to invest in Iran at a time the United States is piling massive economic pressure on the country.

Russia has committed itself to other infrastructure projects in Iran worth nearly \$5 billion.

- Oil Minister Reiterates No "Hike" in Fuel Oil Price

TEHRAN – Oil Minister Bijan Namdar Zanganeh yesterday reiterated that the ministry refutes reports that it is to increase the price of fuel oil.

Speaking on the sidelines of a ceremony for signing 13 oil agreements in Tehran, Zanganeh said that he does not know who is behind this allegation that the government is to increase the price of fuel oil, rejecting all allegations on price hike of the fuel oil.

On the shortage of liquefied gas in Sistan and Baluchistan Province, he said that unfortunately citizens of the province are facing shortage of the liquefied gas, adding that he has ordered for shipping more liquefied gas to the province to meet the demands of the residents, and this problem will be resolved soon.

On the value of the agreements signed in the ceremony, Zanganeh said that these agreements are valued at over 1500b tomans. He said that these 13 agreements can boost exploitation from the oil and gas fields.

He said some nine more agreements had been earlier signed, adding that now 50 percent of national oil reserves are under coverage of these researches and hundreds of students and experts are working on them and will present hundreds of papers and articles.

Zanganeh praised the role and value of universities, saying that their value is not less than oil production in those oil fields.



He went on to say that university and industry should work together and they are correlative, adding that all should be patient because universities are the transplanted heart of oil industry and this transplantation has happened now.

He said this time universities stepped forward for signing the deal voluntarily and they welcomed the ministry's proposals.

He also blasted the monopoly, adding that monopolization is not a good thing and competition is valuable.

Zanganeh also said that some good and important agreements have been signed in the downstream of oil industry which need support in order that the country can possess license and knowhow.

He also pointed to the beginning of the Sacred Defense Week, saying that jihad should continue in all layers of the life and today the country is alive because of efforts of unknown jihadis who continued their endeavors after the eight-year war in different fields.

Indian, Emirati Container Ships Dock In Chabahar Port

CHABAHAR (IRNA) - The Managing Director of Ports and Maritime Organization of Iran (PMO) Behrouz Aqaee said on Monday that two container ships carrying kitchen utensils, detergents and wheat from India and UAE to Afghanistan docked in Chabahar Port.

Aqaee said the two ships consisted of 666 containers. Referring to special discounts granted to businessmen in Chabahar, he said that thanks to Chabahar capacities in accepting different kinds of ships, decreasing sea transfer charges, loading and unloading and movement of consignments with less time and cost, the cargo shipments will continue from Chabahar Port.

He added that by setting up infrastructure and granting special incentives to Chabahar Port, it is now an important port and a low-cost route for the regional countries.

He noted that Chabahar Port has encouraged investors in various fields especially owners of businesses, goods and shipping lines to take advantage of the capacities. Earlier, Aqaee said Chabahar has experienced 28% growth in foreign trade.

He added that by the end of August and after 20 months of cooperation between Iran-India joint operator in Chabahar, the consignment which was transited to Afghanistan through Chabahar Port make up for 23% of total traffic.

He also referred to first Indian sugar consignment to Afghanistan which was transited in 70 containers through Chabahar Port.

NIOC Inks Oil Research Deal With Local Universities, Research Centers

TEHRAN (Shana) – The National Iranian Oil Company (NIOC) has signed 13 major oil and gas extraction research contracts worth a total of ϵ 35 million and Rls. 7,160 billion with 13 Iranian universities and research centers.

The documents were signed on Monday, September 21, 2020, in a ceremony held in the presence of Iranian Minister of Petroleum Bijan Zanganeh in Tehran.

Accordingly, National Iranian Oil Company signed the research contracts with Tehran University, Sharif University of Technology, Amirkabir University of Technology, Sahand Tabriz University, Shiraz University, the University of Petroelum Industry, Islamic Azad University, Ferdowsi University of Mashhad, Science and Technology University, Shahid Chamran University of Ahvaz, Isfahan University of Technology, Persian Gulf University and the Research Institute of Petroleum Industry (RIPI).

These contracts were signed in continuation of the technological development path of oil reservoirs, which had kicked off since 2013 with the interaction between the National Iranian Oil Company and the country's universities and research centers to study strategies to

Based on the contracts signed today, the studies of Yadavaran oil field have been awarded to the University of Tehran, South Pars gas field to Sharif University of Technology, Alvand field to Amirkabir University of Technology, Rag Sefid field to the Research Institute

of Petroleum Industry (RIPI), Masjed Soleiman field to Sahand University of Tabriz, Esfand field to Shiraz University, Forouzan field to the University of Petroleum Industry, Khesht field to the Islamic Azad University (Science and Research Branch), Binak field to Ferdowsi University of Mashhad, Doroud field to the University of Science and Technology, Tang-Bijar field to Shahid Chamran University of Ahvaz, Maroon field to Isfahan University of Technology.

So far in the oil and gas fields, EOR studies, 22 major research contracts with a total value of Rls. 10,090 billion and \notin 49 million have been signed between the National Iranian Oil Company and 13 universities and research centers in the country which are being followed up.

Vacancy Tax Law Soon

INTA to Officially Start Implementing

TEHRAN - Iran's Transport and Urban Development Ministry has referred a list of 109,000 vacant housing units in the capital Tehran to the National Tax Administration (INTA) to be taxed under the new vacancy tax law.

According to the Deputy Transport Minister for Housing and Construction Affairs Mahmoud Mahmoudzadeh, the information regarding the owners of the mentioned houses have been given to INTA and the process for collecting tax from them will begin soon. In the first stage of the implementation of the program for collecting tax from the country's vacant housing units, only units belonging to natural persons are targeted, Mahmoudzadeh said. "The list of vacant houses belonging to legal entities will also be provided to the tax body soon," he added.

According to Mahmoudzadeh a total of 6.6 million households or 30.7 percent of the country's 18.1 million urban households live in rented homes. The implementation of the vacancy tax law, as part of Direct Tax Reform Law, was put on the agenda in the Iranian calendar year ending March 2016 and was enforceable from the year ending March 2017, however there was little data on the number of vacant units then, according to Mahmoud Alizadeh, a senior official with Iran National Tax Administration. Technology Foundation (MSTF) was held on Sunday where the major topic of discussion was around the efficacy of 2019 Mustafa (PBUH) Prize laureate's mRNA vaccine.

Several prominent scientific figures attended the meeting and discussed different vaccines in development by different countries.

Rasoul Dinarvand, professor of Pharmaceutical Nanotechnology at Tehran University of Medical Sciences, stated that currently two gene-based vaccines have entered the third stage of vaccine development, one of which is being led by 2019 Mustafa (PBUH) Prize laureate and the CEO of BioNTech, Ugur Sahin.

This mRNA-based vaccine, which is being jointly developed by BioNTech, Pfizer, and Fosun Pharma, is to finish the third stage of vaccine development "by mid-October," Dinarvand said.

"In late October they might get the approval," he continued.

He contended that "Ugur Sahin might be one of the heroes of the battle against COVID-19." Dinarvand emphasized that this vaccine is also estimated to be cost-effective.

Emphasizing that generally the modern vaccines are either DNA-based and RNA-based, he asserted that "at least 70% of the world population must be vaccinated in order to break the chain of infection."

He said "mRNA-based vaccines can be produced in large amounts."

"Another advantage of it is that with a low dose of mRNA-based vaccines, a high amount of immunity against the virus is developed in the body," he added. Alireza Biglari, Director of Pasteur Institute of Iran, explained how gene-based vaccines work, stating that in this method "the genetic code of the antigen is delivered to the cells, and the immune system gets stimulated." Hossein Ghanaati, head of Coronavirus think tank in Tehran province, and professor of Neurointerventional Radiology at Tehran University of Medical Sciences, stated that "No medication is proven to be fully effective on COVID-19 patients yet." In confronting the current pandemic, "medication was a wrong path we took," he observed.

He said that "the only hope for defeating this virus is vaccine." Science Promotion Meetings are a series of meetings held by the Mustafa (PBUH) Science and Technology Foundation (MSTF) with the purpose of emphasizing the role of Muslim scientists in latest scientific achievements.



On the actions during implementation of the project for supplying sustainable water to 32 villages, he highlighted some of them like expanding transfer pipeline.

Iranian Planes to Resume Flights to Istanbul

India's Coronavirus Infections Surge to 5.4m

MUMBAI (Reuters) - India's coronavirus case tally surged to 5.4 million as it added 92,605 new infections in the last 24 hours, data from the federal health ministry showed on Sunday.

The country has posted the highest single-day caseload in the world since early August, and lags behind only the United States, which has 6.7 million cases in terms of total infections.

A total of 1,113 people died of COVID-19 in the last 24 hours, the health ministry said, taking mortalities to 86,752, which is a relatively low 1.6% of all cases.

Mass Rallies in Belarus Keep Pressure on Lukashenko



MINSK (Reuters) - More than 100,000 people marched through Minsk on Sunday on the sixth straight weekend of protests against President Alexander Lukashenko, keeping up the pressure on the veteran Belarusian leader to quit.

Many walked in a vast column that stretched back several kilometres, decked out in red-and-white opposition colours and chanting "go away" as helmeted riot police patrolled the streets with water canons on hand, a witness said.

Several protesters were dragged away from the crowd by security forces. In the city centre, riot police rhythmically beat their shields as a warning while several people threw glass bottles at them.

Videos shared by local media outlets showed security forces in helmets or masks hauling protesters off the streets in simultaneous protests in other cities.

The eastern European country was plunged into turmoil following a presidential election last month that Lukashenko says he won by

a landslide, but the opposition says was rigged.

In power for 26 years, the former Soviet collective farm manager has shown scant inclination to resign, buoyed by support from Russia.

The European Union vowed weeks ago to impose sanctions on Minsk for alleged election fraud and human rights abuses, but is likely to miss its own Monday deadline for action

own Monday deadline for action. In tandem with the protests, anonymous hackers leaked the personal data of more than 2,000 police officers in retaliation for a crackdown in which thousands of people have been detained, many



Suga, Trump Hold First Talks by Phone

TOKYO (Reuters) - Japanese Prime Minister Yoshihide Suga said he and U.S. President Donald Trump had held their first telephone conversation on Sunday since Suga took over as Japan's new leader.



Suga on Wednesday became Japan's first new leader in nearly eight years, succeeding Shinzo Abe. Abe had forged close ties with Trump, playing golf together and engaging in frequent phone calls and meetings. "I told him the Japan-U.S. alliance was the foundation of regional peace and stability," Suga told reporters after the talks. "We agreed to coordinate closely."

Thai Protesters Install Plaque Symbolizing Democracy

BANGKOK (Dispatches) - Openly challenging the monarchy of Thai King Maha Vajiralongkorn, thousands of protesters marched once again in Bangkok on Sunday to present demands that include a call for reforms to curb his powers and for more democracy.

Occupying a historic field in the Thai capital, the pro-democracy demonstrators installed a plaque symbolising the country's transition to democracy to replace the 1933 original that disappeared mysteriously three years ago. Protesters have grown ever bolder during two months of demonstrations against Thailand's palace and military-dominated

establishment, breaking a longstanding taboo on criticising the monarchy – which is illegal under lese majeste laws. The Royal Palace was not immediately available for comment. The king, who spends much of his time in Europe, is not in Thailand now.

The mass student-led rally that began Saturday was the largest in a series of protests this year, with thousands camping overnight at Sanam Luang, or Royal Field, near the Grand Palace in central Bangkok.

Italians Vote in Regional Elections, Referendum in Test for Coalition

ROME (Reuters) - Italians voted on Sunday in a raft of local ballots and a referendum, with the ruling coalition under pressure in its first electoral test since the coronavirus crisis.

Voters have largely approved of Prime Minister Giuseppe Conte's handling of the pandemic, but recent opinion polls suggest this will not help his coalition allies in the vote for the heads of seven regions and mayors in almost 1,000 towns. The rightist opposition, led by Matteo Salvini's League, is expected to win at least four of the regions up for grabs, and could capture the traditional leftwing stronghold of Tuscany.

A drubbing for the ruling parties would galvanise the League and its allies, but most analysts say it would be unlikely to trigger a government collapse in the midst of the coronavirus crisis and as the country prepares a crucial 2021 budget. Voting took place over two days and exit polls will be published today.

The co-ruling anti-establishment 5-Star Movement and centre-left Democratic Party are fielding separate candidates almost everywhere, hurting their chances against a united centre-right.

5-Star, which does not run any of Italy's 20 regions, is pinning its hopes on the only nationwide ballot -- a referendum it champions to cut the number of lawmakers to 600 from 945.

Early voting went smoothly despite concerns over possible delays due to coronavirus social distancing rules.

"The polling station president and the staff were very clear about the rules. It took 15 seconds longer to vote perhaps, but everything was fine," said 69-year-old university professor Carlo Di Giovine after voting in the referendum in Rome.

The centre-left is expected to lose control of Marche in the centre and Puglia in the south, while holding on to the southern region of Campania. Tuscany looks like a neck-and-neck race. The right should easily keep power in the two

> northern regions where it currently governs -- Liguria and Veneto. The seventh region at stake is the tiny, French-speaking Valle D'Aosta which has its own party system.

Turkey Warns Against EU Sanctions

ISTANBUL (Reuters) - Turkey and Greece could soon resume talks over their contested Mediterranean claims but European Union leaders meeting this week will not help if they threaten sanctions, Turkey's presidential spokesman said on Sunday.

The NATO members and neighbours have been locked in a bitter dispute over the extent of their continental shelves in the eastern Mediterranean. Tensions flared last month when Turkey sent a vessel to survey for gas and oil in contested waters.

European Union member Greece condemned the move as illegal and pressed, along with Cyprus, for a strong response from EU leaders when they meet on Thursday. Ankara withdrew the Oruc Reis vessel last week. It described the move as a routine maintenance stop but later said it opened up the chance for diplomacy to reduce tensions with Athens. "At this point, the climate has become much more suitable for negotiations to begin," presidential spokesman Ibrahim Kalin told Dogan News Agency. "...Exploratory talks may start again." resuming those "exploratory" talks, suspended in 2016. But Turkey broke off contact and sent Oruc Reis into disputed waters after Greece signed a maritime demarcation deal with Egypt, angering Ankara.

Erdogan has had talks with EU Council president Charles Michel, who chairs the meetings of EU leaders, and German Chancellor Angela Merkel, who is seeking to ease the crisis.

But Cyprus, protesting the presence of two Turkish exploration vessels in waters off the divided island, insists on sanctions against Ankara and has blocked EU action against Belarus for alleged election fraud until its demands are met. "Threats of blackmail and of sanctions against Turkey does not give results," Kalin said. "European politicians should know this by now." Erdogan tweeted at the weekend that Turkey believed the dispute could be resolved through dialogue while still defending its rights in the region. "We want to give diplomacy as much space as possible, by listening to every sincere call," he tweeted. "With this vision, we will continue to defend any drop of water and area of our country to the end." Trump on Saturday promised to nominate a woman and said he will make his nomination this week, naming federal appeals judges Amy Coney Barrett and Barbara Lagoa as possible candidates to fill the vacancy created by the death of liberal icon Ruth Bader Ginsburg on Friday. "I will be putting forth a nominee next week. It will be a woman," Trump said at a campaign rally in Fayetteville, North Carolina, where supporters chanted "fill that seat".

"I think it should be a woman because I actually like women much more than men," he said. The death of Ginsburg could affect the November election, with Republican brass promising to vote on an appointee before voters go to the polls, despite resisting a similar election-year nomination by Democrats in 2016.

China Approves Investment Projects Worth 13b in August

BEIJING (Xinhua) -- China's top economic planner approved six fixed-asset investment projects with combined investment totaling 88.2 billion yuan (about 13 billion U.S. dollars) in August, official data showed. The projects were mainly in the transportation and information industries, according to Meng Wei, spokesperson for the National Development and Reform Commission.

Earlier data showed China's fixed-asset investment edged down 0.3 percent year on year during the January-August period, with the decline narrowing from the 1.6-percent fall in the first seven months. Fixed-asset investment includes spending in infrastructure, property, machinery and other physical assets.



World Economy Seen Withstanding Virus Better Than Forecast

PARIS (Dispatches) - The global economic slump won't be as sharp as previously feared this year, though the recovery is losing pace and will need support from governments and central banks for some time yet, according to the OECD.

The world economy will shrink 4.5% this year, less than the 6% forecast in June, the Paris-based institution said on Wednesday, upgrading its outlook in response to rebounds in activity since lockdowns ended. There were big revisions for the U.S. and the euro area, as well as China, which is now forecast to grow modestly,

the only Group of 20 country with such a prospect.

The better view reflects the strong economic pickup in recent months and the vast injection of public resources. The U.S. unemployment rate fell more than forecast in August, while China this week reported positive retail and industrial production data.

While that initially strong pickup means the 2020 number looks a little less grim, the pace of the recovery is now fading, and output in many countries will still be below its pre-crisis level at the end of 2021. There's also a risk of long-lasting damage to economies, as well as bankruptcies and job losses.

Amid such dangers, the OECD said governments and central banks will need to continue to provide support into 2021, after huge efforts this year that have bloated balance sheets and stretched fiscal budgets.

"The problem is that this V-shaped recovery is not going to happen," OECD Secretary General Angel Gurria said on Bloomberg Television. "What we are saying is number one, don't take away the support, don't take away the relief, too fast."

But it added that assistance programs must evolve as growth picks up, allowing money to be better targeted at protecting businesses and jobs in sectors with a viable future. That echoes comments from the Bank for International Settlements on Monday, which said the challenge is to support companies without creating "zombie" firms that damage economies in the longer term.

While the OECD upgraded the global outlook, it also made huge downward revisions to a number of emerging markets. India's economy will shrink 10.2% this year, almost three times the previously forecast, while Argentina, Mexico and South Africa will also suffer more than predicted in June.

The OECD said there's still huge uncertainty about the outlook, and its latest projections assume continued sporadic outbreaks of the virus along with targeted local interventions. The new forecasts compare with its "single shock" scenario in June, which was based on no second wave of Covid-19.

- Uzbekistan Economic Growth in 2020 to Slow Further, Rebound in 2021 -

TASHKENT (Dispatches) - Economic growth in Uzbekistan is projected to further decelerate this year as a result of the coronavirus pandemic, weak demand, slowing industrial output, and a decline in services, according to a new report released by the Asian Development Bank (ADB).

In an update to its flagship annual economic publication, Asian Development Outlook (ADO) 2020, ADB forecasts Uzbekistan's GDP growth at 0.5% in 2020, down from the 1.5% forecast in June. However, GDP is expected to rebound strongly to 6.5% in 2021, consistent with ADB's projection earlier this year.

"While our report estimates reduced growth this year, it is expected to rebound in 2021 with anticipated recovery in services and industry," said ADB Country Director for Uzbekistan Cindy Malvicini. "We continue to stand by the people of Uzbekistan, helping to mitigate the adverse health, social, and economic impacts of the disease, so that the country can overcome the pandemic and the economy can recover as quickly as possible."

The bank's forecasts for inflation remain unchanged at 13% in 2020 and 10% in 2021. Pandemic-related disruptions raised food price inflation in the first 7 months of 2020, while inflation for other goods and services in the same period slowed. Meanwhile, depreciation of the Uzbek sum year on year against the US dollar rose from 2.5% in the first half of 2019 to 6.7% this year.

Philippine External Debt Ratio Lowest Among ASEAN Peers

MANILA (Dispatches) – The Philippines' external debt relative to gross national income (GNI) is the lowest among its peer economies in the Association of Southeast Asian Nations, known as the ASEAN-5, according to the Department of Finance (DoF).

Citing data from the World Bank, the DoF in an economic bulletin said the gross foreign debt stock was 20.11% of GNI in 2019, from 19.98% in 2018.

Thailand's ratio was 34.07% in 2019,

British Economy Unlikely to Reach Pre-COVID Level Until Early 2023

LONDON (Dispatches) - The continuing impact of the COVID-19 virus is expected to see the UK economy contract by 10.3% in 2020, but a second lockdown of even just four weeks could exacerbate the drop in GDP to -12.6\%, according to

In a text message Sunday, Finance Undersecretary Gil S. Beltran, the department's chief economist, said the ratio measures the debt burden carried by each country, reflecting its ability to pay back creditors and how much room they have to take on more debt.

"In the face of a slowing global economy and dampening of investment activities resulting from the COVID-19 pandemic, countries scramble for funds to fuel economic recovery. This is where countries' overall debt scenario is crucial," he said in the bulletin.

Italy Sees GDP Down 9% This Year, Risin More Than 5% in ROME (Reuters) - Italy expects its coronavirus-hit economy to grow bis

coronavirus-hit economy to grow by more than 5% next year after shrinking 9% in 2020, two government sources told Reuters on Sunday.

In April, the government of the anti-establishment 5-Star Movement and the centre-left PD

party forecast a fall in gross domestic product of 8% this year and a 2021 rebound of 4.7%. The new forecasts, along with public finance projections, will be published next week, providing the framework for the 2021 budget which must be presented to the European Commission in mid-October.

The euro zone's third-largest economy has not seen annual growth of 5% for more than 40 years.


The new forecasts, which still need to be finalized, are based on an unchanged policy scenario. This means they do not incorporate planned expansionary measures to be financed by the European Union's Recovery Fund, the sources said.

The government estimates it will get some 209 billion euros (\$247 billion) in cheap loans and grants by 2023 from the fund, designed to help the EU nations hardest hit by COVID-19. Rome aims to present its so-called National Recovery and Resilience Plan, which will front-load the spending of up to 10% of this total, to the European Commission early next year, Economy Minister Roberto Gualtieri said last week.

Among a raft of projects under discussion, the government wants to create a national ultrafast broadband network, upgrade its rail lines and spend more than 30 billion euros in six years to strengthen its healthcare system.

In a paper published this week, the government said Europe-funded reforms could help Italy double its growth rate, narrow its north-south divide and even increase its birth rate - one of the lowest in the world.

COVID-19 Provides Opportunity to India, Japan to Further Strengthen Ties



NEW DELHI (Dispatches) - The COVID-19 pandemic has provided a unique opportunity to both India and Japan to further strengthen economic ties by enhancing cooperation in areas like software development, modern technology, infrastructure and manufacturing, according to a report.

The report, prepared by Shardul Amarchand Mangaldas and FICCI, also said that Japan has always treated India as a preferred partner in terms of economics, trade and commerce.

"COVID-19 pandemic has provided great opportunities for the two nations and its businesses to join hands and forge a new alliance in terms of harvesting the fruits of demographic dividend that India provides, and push India towards becoming a major global manufacturing hub amidst the changing economic atmosphere," it said.

However, given advancements in vaccine developments for COVID-19, there is a high chance that the pandemic will be overcome by mid-2021. Growth is expected to pick up to 8.4% next year if a vaccine is rolled out by April with the economy reaching pre-COVID level by early 2023. Three alternative scenarios were considered for the timing of the recovery, based on potential different dates of the vaccine being approved and then rolled out in the UK – and a Brexit deal outcome. KPMG's base scenario assumes that a vaccine will be approved in January, immediately reducing uncertainty, and rolled out by the end of April enabling all social distancing measures to be removed.

It also assumes the UK and the EU reach an agreement on their future relationship before the end of the transition period this year. But even just a three-month delay in rolling out the vaccine could see GDP growth fall to 7.1% in 2021, instead of 8.4%.

A range of risks is also considered, where the outcome will impact potential growth. They include a no deal with the EU next year and limited progress in eradicating the pandemic. If these play out, growth in 2021 could fluctuate by between 8.4% and 4% at the least. KPMG has forecasted a GDP decline in the South West of 9.4%* for 2020, with Plymouth, Cheltenham and South Somerset expected to be worst hit with an 11.3% fall in GDP predicted. Swindon is expected to be the least hardest hit, with a 7.3% decline this year.

The region's largest cities are not immune, and are likely to be hit hard. Bath (and NE Somerset) could see a drop in GDP of 10.6%, closely followed by Bristol with a decline of 9.2%.

Andrew Hodgson, senior partner for KPMG in Bristol, comments: "This is a uncertain and demanding time for businesses in the South West. There are also mixed messages about how the consumer is reacting as we come out of lockdown and how sustainable



any early signs of recovery are. Especially when you consider that unemployment is growing and the impact of the unprecedented fall in GDP bites. Businesses are cancelling their investment plans and there is a concern that persistently weak business investment could hold back the UK's recovery."

Yael Selfin, Chief Economist at KPMG UK, concludes: "The pandemic has had a more significant impact on sectors that are more labor-intensive – and the recession will generate permanent change in some of them, meaning there will be a bigger effect on the labour market than the fall in GDP would imply.

"While uncertainties abound, debt metrics are among the important indicators being watched by both domestic and international investors, along with credit rating agencies," he added.

The Japanese business community is upbeat about its investments and ventures in India, it said adding Japan continues to be the fourth largest investor in India.

It suggested that policy reforms are required in India to bring in greater synergies and reap the benefits of the de-risking activities being undertaken by Japanese companies to move their supply chains out of China to countries like India, Vietnam, Thailand, Indonesia, Malaysia and Myanmar.

Shardul S Shroff, Executive Chairman and National Practice Head – Insolvency and Bankruptcy, Shardul Amarchand Mangaldas & Co, said, "We need to look at the pandemic as an opportunity to bring India and Japan's economic relationship closer".

He said that the Indian economy holds the potential to bounce back quickly on the back of a slew of fiscal and economic measures undertaken by the government such as reduction in corporate tax rates, further reforms in the GST regime, revamping labour laws, taking measures to ensure ease of doing business, to attract foreign investment.

"While the Indian government has taken plethora of measures and policy decisions to make India an investor friendly destination for the Japanese business community, a lot more needs to be done to meet the new challenges posed by the pandemic and to harvest the investor sentiments looking for safe investment destinations," he added.

Japan's "Abenomics" Set to Continue Into Post-Abe Era

TOKYO (Dispatches) - Japan's 'Abenomics', which is a combination of aggressive monetary and fiscal expansion with structural reforms is expected to be continued into the post-Abe era, QNB has said in an economic commentary.

On August 28, Shinzo Abe announced his resignation as prime minister of Japan. The decision followed a deterioration of his health and the need for comprehensive medical treatment.

Effectively, this development marks the end of a political era, as Abe was the longest serving prime minister in Japan's history (2012-2020).

'Make no mistake, the change of leadership in Japan is no small matter, especially as the country faces a plethora of challenges, including the Covid-19 pandemic, the current economic recession and the fast geopolitical movements in Asia. While the transition may open the debate for some policy changes, we believe that the basic macroeconomic tenets of the last few years should remain intact or could even be deepened, QNB noted.

In other words, the economic doctrine often referred to as Abenomics is expected to be continued into the post-Abe era. QNB expects such a continuation for three reasons.

First, despite some progress thus far, Abenomics still did not fully deliver on its mandate to steer Japan completely away from the deflationary trap of low growth, low inflation and high levels of indebtedness. In order to achieve that, the country needs to produce more inflation and faster nominal GDP growth. While there was a significant improvement on both metrics vis-à-vis the previous period, they were still undershooting strategic targets. Ideally, for Japan, nominal growth and inflation should run above 2%.

Second, the massive Covid-19 shock amplifies Japan's economic woes, as nominal GDP growth collapses, deflationary pressures build up and the level of indebtedness increases. Under such conditions, the policy measures under Abenomics will need to be used even more aggressively.

This includes more monetary easing and an even looser fiscal stance. A strong policy push will be necessary to jump start the economy again, preventing another negative deflationary spiral.

Third, given that Japan's official rates have already reached the effective lower bound (rates are currently slightly negative by 10 basis points), policy alternatives are few and far between. The government needs to ramp up the fiscal impulse and



this requires more coordination with the Bank of Japan (BoJ).

In fact, in order to respond to such needs, the BoJ will have to expand even more its balance sheet. As it stands now, the BoJ's total assets amount to JPY 690tn (\$6.5tn) or about 125% of the country's GDP.

Despite the bloated size of the BoJ's balance sheet, QNB said there is still theoretically more room for quantitative easing or large scale asset purchases.

The BoJ now owns about 54% of Japan's outstanding government securities and holds the equivalent of 6% of the total market capitalisation of the Tokyo Stock Exchange.

'All in all, we believe that Abenomics will enter a second phase in post-Abe's Japan. Monetary and fiscal authorities will likely continue to be bold, sizing up their unorthodox measures in response to the Covid-19 shock.

'Therefore, 'Abenomics 2' should provide important information for other policymakers as more advanced economies follow Japan in the use of ever expanding economic stimulus measures.

In a world of low growth and low inflation, Abenomics could well end up going global, QNB said.

EU Seeks New Powers To Penalize Tech Giants

LONDON (Reuters) - The European Union wants to arm itself with new powers to penalize big technology companies, the Financial Times reported on Sunday.

'There is still a broad agreement among the international community that the JCPOA should be preserved," he said.

Speaking after Salehi, U.S. Energy Secretary Dan Brouillette made no reference to the deal, saying only that the "United States remains committed to addressing the threats posed by the nuclear programs of both North Korea and Iran."

"On top of its horrific record as the world's largest state sponsor of terrorism. Macron Challenger Presses France to Save Tire Plant PARIS (Reuters) - France should invest in a Bridgestone tire plant threatened with closure, the head of its regional government who plans to run against President Emmanuel Macron in 2022 said on Sunday, ahead of a ministerial visit to the site. The call by Xavier Bertrand, a former minister who now leads the Hauts-de-France region, adds pressure on the government to prevent an outright closure of the facility, as the coronavirus pandemic batters confidence. The Japanese tire maker's announcement on Wednesday that it planned to close the Bethune plant, which employs 863 workers in Bertrand's northern region, drew swift government condemnation. Labour Minister Elisabeth Borne is expected to visit the factory on Monday. Bertrand, a conservative who served as health minister between 2005 and 2007 in the government of Nicolas Sarkozy, told Europe 1 radio "everything must be done" to avoid a closure - invoking a 2013 precedent in which Italy invested in a Bridgestone plant to avert closure and save 60% of its jobs. Bertrand also stepped up his criticism of Macron in a separate interview with Le Parisien, declaring himself "more determined than ever" to challenge France's centrist incumbent in the next presidential election.

According to the Argentinian energy minister of Neuquen province, where the vast Vaca Muerta field is located, resurrecting the shale play will take more than a year. Achieving pre-COVID-19 production levels, he said, will take an estimated 12-18 months due to a lack of market demand, which may not be bouncing back any time soon. "We believe it will take a while for fuel demand to fully recover," Monteiro told listeners on Monday in an industry webinar.

Before COCID-19. Vaca Muerta had been in a state of rapid expansion, as Bloomberg's "next potential shale hotspot" description would indicate. The novel coronavirus, however, stopped this expansion in its tracks, leaving many projects half-completed. "Many wells have been drilled but not connected, but even when demand fully recovers it will take even longer for drilling activity to return to pre-pandemic levels because of storage constraints," MercoPress reported this week, summing up the energy minister's

production in July, the numbers pale in comparison to what they could have been in a business-as-usual scenario. "Vaca Muerta registered just 44 fractures in July, compared with 398 a year earlier," U.S.-based services firm NCS Multistage told MercoPress.

The Argentinian government does have strategies in place to revive the domestic shale industry and get Vaca Muerta's development back on track, including a new gas subsidy plan, but Monteiro says that more and stronger policy measures, including tax incentives and lowered crude export taxes, will be necessary to bring the nation's shale sector back to pre-COVID levels of activity.

Taking a step back, however, putting more investment dollars and more taxpayer funding into the shale sector may be a shortsighted endeavor.

Mane was involved in the turning point at Stamford Bridge as the first clash between Premier League title contenders this season swung Liverpool's way.

In first half stoppage-time, Jordan Henderson picked out Mane's run behind Christensen and the Denmark defender responded by rugby-tackling the Senegal star to the ground. Referee Paul Tierney initially booked Christensen, but VAR told him to consult the pitchside monitor and he changed his decision to a red card.

Mane grabbed his first goal of the season in the 50th minute as he met Roberto Firmino's cross with a thumping header after eluding Reece James' slack marking.

Mane was gifted his second goal as Chelsea keeper Kepa Arrizabalaga made a hash of trying to play out from the back, allowing the Liverpool forward to intercept and slot into the empty net.

It was the latest costly blunder from Kepa, who was dropped twice by Chelsea manager Frank Lampard last season despite his status as the world's most expensive keeper.

Lampard will be relieved that Chelsea are reportedly close to signing Rennes' Senegal international Edouard Mendy as he looks to replace Kepa.

Thiago Alcantara made his Liverpool debut at half-time after his move from Bayern Munich, but the Spain midfielder conceded a 74th-minute penalty with a foul on Timo Werner. Alisson Becker came to Thiago's rescue as he saved Jorginho's spot-kick.

Alli's Tottenham **Future in Doubt After** Southampton Axe

ONDON (Dispatches) - Dele Alli's Tottenham future is in doubt after he was dropped for their Premier League match at Southampton on Sunday as Jose Mourinho claimed he has "too many players".

Alli was substituted at half-time of Tottenham's defeat against Everton last weekend and was missing from the squad for their Europa League qualifier against Lokomotiv Plovdiv on Thursday.

The England international was expected to return against Southampton, but Tottenham manager Mourinho did not include him in the matchday squad.

scenes at Tottenham last season. Alli was linked with a move to Real Madrid as part of the deal that eventually saw Gareth Bale join Tottenham on loan on Saturday, while Manchester United are reported to be interested in the 24-year-old.

Netherlands international Van de Beek took no consolation from his debut goal. "To play for all the fans in stadiums like this it's more nice to score," he said.

"But still I scored but we lose and this is the most important thing, that we win. "We lose but it's always really nice to play for a club like this.

"I made my first game and I hope to help the team and next time that we win, for sure."

Mbappe Inspires PSG To Victory in Nice

PARIS (Dispatches) - Kylian Mbappe returned to the starting line-up for Paris Saint-German on Sunday and scored the opener in a 3-0 win at Nice which marks another step on the road to recovery for the French champions.

The 21-year-old, who tested positive for coronavirus on September 7, was on target from the penalty spot in the 38th minute. Angel di Maria added a second just before half-time and Marquinhos headed the third after 66 minutes. Mbappe thought he had scored a fourth late on but it was ruled out for offside. He was replaced by Pablo Sarabia shortly after.

It was a second successive Ligue 1 win for PSG who began the season still smarting from defeat in the Champions League final. They lost their opening two games and the second ended in a mass brawl against Marseille which led to the suspension of Brazilian forward Neymar.

Juve Open Bid for 10th **Straight Title**

TURIN (Dispatches) - Andrea Pirlo got his coaching career off to a winning start as Juventus launched their bid for a 10th consecutive league title with a 3-0 win over Sampdoria on Sunday.

Swedish debutant Dejan Kulusevski opened the scoring after 13 minutes in Turin with Leonardo Bonucci adding a second on 78 minutes and Cristiano Ronaldo a late third. The match was played in front of 1,000 spectators as Serie A stadiums reopened on Sunday to a limited number of fans after a seven-month coronavirus lockdown. Pirlo could not have hoped for a better start to his coaching career having taken over from Maurizio Sarri this summer.

The win against Sampdoria, coached by veteran Claudio Ranieri, came just days after the former Italy and Juventus star received his coaching diploma. "It will take time to put together the mode of play, but I will not copy and paste," warned the 41-year-old.

"I will take inspiration from teams that have impressed -- there was little time, the lads returned from the national teams, we only worked together for a week.

"Today and already with (the friendly against) Novara we have seen something, it will take time. We lack players but we're trying to do the best with what we have.'

Juventus handed debuts to new signing Weston McKennie and Kulusevski, who joined from Atalanta in January before immediately returning to Parma on loan.

Kulusevski curled in the first goal in a move started by Ronaldo, who hit the bar minutes later.

Djokovic Into 10th Italian Open Final

ROME (Dispatches) - Top men's seed Novak Djokovic advanced to the final of the Italian Open for the 10th time on Sunday with a straight sets win over Casper Ruud.



The world number one came through 7-5, 6-3 to advance to the final of the clay-court tournament he has won four times.

Djokovic will also bid for a record 36th Masters title, being currently tied on 35 with Rafael Nadal who fell in the quarter-finals.

The 33-year-old next plays either Argentine eighth-seed Diego Schwartzman or Canadian Denis Shapovalov, the 12th seed.

Schrwartzman shocked nine-time Rome winner Nadal, the two-time defending champion on Saturday, in the tune-up event ahead of the French Open in Roland Garros

Djokovic was pushed in his first meeting with 34th-ranked Ruud, but knew how to tighten his game at key moments of an intense match, to the delight of the fans.

Meanwhile in women's event, Simona Halep ousted Garbine Muguruza in three sets on Sunday to advance to her third Italian Open final in front of the first set of spectators allowed in the stands at this year's tournament.

A small number of fans saw top seed Halep hold off a late Muguruza fightback to advance 6-3, 4-6, 6-4 in just over two hours, in a battle of former French Open champions before Roland Garros starts in a week's time.
