# **France Is Not in Position To Preach on Ethics**


TEHRAN (PressTV) - An Iranian diplomat has hit back at France for its meddlesome stance, saying a country deeply involved in Yemen's carnage cannot preach about morality.

Yemen has turned into the worst humanitarian disaster in the world as a result of the sales of deadly weapons by France and its partners to the Saudi-led coalition, Mohammad Sadati-Nejad, who is in charge of human rights issues at the Iranian mission to the UN in Geneva, said on Thursday.

The remarks came a day after France's Foreign Ministry said a French national, who was under consular protection, was detained in Iran in May 2020, and that authorities are "attentively following the situation of our fellow national."

Also, in a speech to the UN Human Rights Council on Wednesday, French Foreign Minister Jean-Yves Le Drian accused Iran of human rights violations and demanded the release of Fariba Adelkhah, a French-Iranian national.

Adelkhah, a 60-year-old anthropologist and researcher at Sciences Po's Center for International Studies (CERI) in Paris, was arrested in Iran in June 2019 on espionage charges. See Page 7



TEHRAN - The Iranian envoy to the UN says there is no need for negotiations over America's potential return to the 2015 nuclear deal, and that Washington must secure a return to the accord by lifting its sanctions within the next three months, a timeframe agreed between Tehran and the UN nuclear watchdog over nuclear inspections beyond the February 21 deadline set by Iran.

No talks are needed to pave the way for the US's return to compliance with the Joint Comprehensive Plan of Action (JCPOA), as the deal is formally named, said Majid Takht-Ravanchi in an interview with Al Jazeera Arabic, excerpts of which were released late on Wednesday. See Page 7

In meeting with Romanian envoy Ms. Mirela-Carmen Grecu, President Rouhani said Iran stands ready to share its experience in the fight against the coronavirus pandemic with other countries, including Romania.

He expressed hope relations between the two countries will further expand as a new chapter of mutual cooperation has opened.

"The two countries enjoy good potential to enhance their cooperation on economic and scientific fronts," said Rouhani.

The top Romanian diplomat, in turn, said Tehran and Bucharest have always had cordial and friendly relations, which should be best utilized to tap into the existing potentialities to upgrade bilateral cooperation.

She said the implementation of some agreements between the two countries has been delayed due to the COVID-19 pandemic.

She underlined efforts have been made to hold a meeting of the Iran-Romania Joint Cooperation Commission as soon as possible to make up for the delays and settle the problems which have emerged on the way of boosting bilateral ties.

Later in the meeting with the Slovak Ambassador Ladislav Ballek, the President said companies in Iran and Slovakia's private sectors can be at the forefront of efforts to enhance mutual relations and cooperation.

He also welcomed closer partnership between Tehran and Bratislava. "Iran and Slovakia have great potential for expanding their relations in scientific, cultural and economic fields," said the president.

He further pointed to the outbreak of the coronavirus in the world, and said universal cooperation among all countries is needed to effectively confront the pandemic.

"The Islamic Republic of Iran is currently developing and testing three types of coronavirus vaccines, and is ready to share its experiences with other countries, including Slovakia, in this regard," he noted.

Ladislav Ballek, the new Slovakian ambassador to Tehran, said his country attaches special respect and importance to Iran, and is resolved to promote its ties with Tehran in different fields.

"The coronavirus pandemic has made it all the more necessary to expand collaborations and humanitarian ties between countries of the world," he added.

In meeting with new Bolivian Ambassador to Tehran Ms. Romina Perez Ramos, the President noted that Iran is determined in scientific and industrial cooperation with Bolivia, Iran's President stressed the expansion of the ties between the two countries. He also said the exchange of the goods needed by the two countries could expand their ties in different areas.

TEHRAN (PressTV) - Iran has stated talks on free trade with an economic bloc of Eurasian countries known as the EAEU more than a year after Tehran clinched a preferential trade agreement with the grouping.

A senior official at Iran's Trade Promotion Organization (TPO) said on Wednesday that both Iran and the EAEU were eager to remove trade tariffs for nearly 80 percent of the goods they exchange.

"New talks for free trade started in February so that the two side can negotiate about all goods they trade but 20 percent that they have no interest in liberalizing," said Behrouz Olfat, who serves as TPO's head of Europe and America office. Olfat said reaching a free trade deal with the EAEU may take years although he insisted that Iran is determined to clinch the agreement because of the long-term impacts it could have on business and economic activity in the country.

The official added that the two sides have a potential to increase the value of their annual trade to \$30 billion from a current figure of \$3.5 billion. Iran reached a preferential trade agreement with the EAEU in October 2019 to reduce tariffs for 883 items of goods. Olfat said the two sides had implemented the new tariff regime on 780 goods.

The EAEU bloc consists of Russia, Armenia, Kazakhstan, Belarus and Kyrgyzstan. Reports have suggested that Armenia is seeking to significantly increase its imports from Iran after a recent war in neighboring Azerbaijan caused Yerevan to impose a six-month ban on products coming from Turkey.

Olfat said trade with Armenia is expected to increase by at least \$60 million per year, adding that Iran would invest more to increase its exports of textiles and garment products to Armenia.

## Int'l Mechanisms Fail to Preserve Rights of Iranian Nation

TEHRAN (IP) - The head of the High Council of Human Rights said that despite the fact that the policy of 'maximum pressure' against Iran was



failed, the international legal mechanisms also could not fulfill the minimal rights of the Iranian nation.

At the 46th session of the UN Human Rights Council, Ali Baqeri Kani said that the human society was ashamed of the crimes being committed against the Yemeni and Palestinian people and noted that as long as the human rights bodies depended on the will of the US and Israeli regime or the affiliate groups, the rights of the world's nations were not fulfilled.

Baqeri Kani highlighted the costs the Iranian nation so far suffered as victims of the terrorism, including the assassination of 17,000 people by U.S.-Europe-backed MKO group, and pointed to the US and Israeli regimes assassination of Lt. Gen. Qasem Soleimani and Dr. Mohsen Fakhrizadeh as only a part of the costs the Iranian nations paid in fighting against terrorism.

He referred to the outbreak of the coronavirus. He noted: "Today, the perpetrators and supporters of illegal and criminal sanctions against the Iranian people, who have blocked access to medical equipment even amid the coronavirus outbreak, pretend that they are concern about the human rights situation."

Emphasizing Iran's will to play an effective role in human rights mechanisms, called on the UN to facilitate practicing justice, investigating crimes, and fighting against criminals' impunity away from any political bias.



TEHRAN (IFP) - Ali-Asghar Khaji, a senior advisor to the Iranian foreign minister, had a phone conversation with Sweden's special envoy for Yemen Peter Semneby as part of Iran's international consultations to settle the Yemen crisis.

During the Wednesday conversation, the two sides exchanged views on the new developments pertaining to Yemen, especially the issue of supporting the UN peace plan.

The Swedish representative expressed content with Iran's constructive role in helping resolve the Yemen crisis politically, calling for such efforts to continue. He also elaborated on Stockholm's attempts in line with the peace process in Yemen and an upcoming meeting on offering assistance to Yemen, which is to be jointly hosted by Sweden and Switzerland on March 1, 2021.

Khaji, in turn, evaluated as positive the achievements of a trip to Tehran by UN Special Envoy for Yemen Martin Griffiths.

He expressed hope a change of approach by the Saudi-led coalition and its Western supporters vis-à-vis Yemeni people will lead to lasting peace in that country. He also hoped the establishment of a ceasefire in Yemen and the lifting of a blockade on the country will improve people's living conditions. TEHRAN (IFP) – Foreign ministry spokesman says UN Special Rapporteur on extrajudicial or arbitrary executions Agnes Callamard has no authority to comment about the Ukrainian plane crash in Iran.

In a statement on Wednesday, Saeed Khatibzadeh explained that the incident is outside the UN official's remit based on her mission objectives stipulated in a UN Human Rights Council resolution.

"In international law, there are specific as well as precise legal and technical frameworks to look into this issue, and the rapporteur's sphere of activity has nothing to do with these regulations and frameworks; rather, the rapporteur's unwarranted involvement might have an unconstructive impact on the legal procedures as well," Khatibzadeh said.

"She has put forward numerous points indicating the information which she had received and was the base of her report was distorted, tainted with numerous mistakes, biased and irrelevant," he noted.

"Accordingly, some charges have been levelled against the Islamic Republic of Iran without any valid evidence and documents," he added.

"It specifically seems that she has got involved in this issue hastily, and the result of this hasty action was an unprofessional, invalid and undocumented text which has resulted in questions and ambiguities about the motive behind this move," Khatibzadeh explained.

He underlined that even if Callamard considered reviewing the case within her purview, she could have waited until a technical report on the incident as well as an indictment for the accused were issued.

"A technical report on the incident was drawn up in accordance with international standards on December 29, 2020 and sent to relevant countries," Khatibzadeh said.

"So far, three countries have sent to the relevant authority their technical viewpoints about this report. Most of those views confirmed the technical report," the spokesman explained.

"Moreover, based on comments made by the relevant official, the final report will be made public by the end of the current Persian Year (ending March 20, 2021)," Khatibzadeh said.

"The report, which contains hundreds of pages, precisely, professionally and comprehensively deals with factors contributing to the accident and other relevant issues," he explained.

Khatibzadeh said an indictment for those accused in the case is about to be issued by Iranian judicial authorities.

He said the court will soon begin looking into charges against the accused once the case is completed at the military prosecutor's office.

## Iran, Belarus Confer On Economic Contacts

**TEHRAN - Trade and investment capacities of Sweden were** reviewed in a virtual meeting with presence of Deputy Head of Iran Chamber of Commerce, Industries, Mines and Agriculture (ICCIMA) for International Affairs Mohammad-Reza Karbasi and Head of Iran Sweden Chamber of Commerce Mr. Abdolreza Rezaie as well as representatives of chambers and economic activists and it was decided Iran and Sweden to focus on boosting ties in the field of technical and engineering services.

Addressing the meeting, Karbasi said that Iran and Sweden can have high level cooperation with each other in the field of engineering and technical services, adding that Sweden is a country which is in high position in the world in terms of progress in types of services and equipment, and by the way Iran has good experience and considerable capability in the field of technical and engineering services.

He went on to say that Sweden is one of the most developed countries in the world and it has always had sensitive and close economic relation with Iran, adding that in the past years, Swedish companies have opened offices in Iran although in the past two years and after reimposition of sanctions, those companies decided to leave Iran market but some of them have remained committed and continued their cooperation with fits and starts.

Karbasi added that the foreign trade volume of Sweden was over \$320b in 2019 while Sweden's trade volume with Iran has declined from \$500m in 2019 to \$70m in 2019. He expressed hope that the country would see increase in economic cooperation



with Sweden with the increase in economic cooperation and existing capacity, and with the efforts of the joint chamber of commerce as well as change in Sweden's approach regarding cooperation.

He hailed the efforts of Iran Sweden Chamber of Commerce for its efforts which topped it among the joint chambers in the country.

Then Rezaei briefed the participants of the economic properties of Sweden and the country's mentality regarding the economic activities. He said that despite having huge natural resources, Sweden has never resorted to sell raw material and avoided it, adding that production of goods is several times more than its imports and people try to use home-made products especially in the field of agro products.

He also said trade with EU accounts for 70 percent of Sweden's total foreign trade, and Norway, Germany, the U.S. and Finland are the major trade partners of Sweden and the Netherlands, France and UK are also among the other trade partners of this country, noting that among the Asian countries, China tops the list of Sweden's trade partners.

Rezaie went on to say that the most of Iran's exports to Sweden are types of raw materials of course dried-fruits and foodstuff are also among Iran's exports. He noted that some of Iranian goods are exported to Sweden via London and Iranian pistachio and carpet are provided via Hamburg market. He reiterated that Iran's imports from Sweden are capital commodities like packing, telecommunications, mining equipment as well as technical knowhow.

### South Korea to Pay \$1b of Its Arrears to Iran

TEHRAN (IRNA) - Governor of the Central Bank of Iran Abdolnasser Hemmati said on Wednesday that South Korea is to start paying \$1 billion of its arrears to Iran from the total amount of \$7b.

Speaking to reporters on Wednesday, Hemmati elaborated on the agreement between Iran and South Korea on transfer of Iran's assets, saying Korea has called for negotiations.

If South Korea does not pay Iran's debt, Iran will initiate proceedings with international justice, he said. He hailed the current atmosphere, saying extensive talks

have been held with Oman, Japan, Iraq and South Korea Earlier, in an interview with Bloomberg held in January, Hemmati said South Korean officials promise to release Iranian assets but take no practical steps to pay arrears to Iran because of US sanctions.

# India, Pakistan Militaries Agree **To Stop Cross-Border Firing**

NEW DELHI (Dispatches) - The militaries of India and Pakistan said in a rare joint statement on Thursday that they had agreed to observe a ceasefire along the disputed border in Kashmir, having exchanged fire hundreds of times in recent months.

The nuclear-armed neighbors signed a ceasefire agreement along the Line of Control (LoC) in the Kashmir region in 2003, but the truce has frayed in recent years, and there have been mounting casualties among villagers living close to the de facto border. "Both sides agreed for strict observance of all agreements, understandings and cease firing along the Line of Control and all other sectors with effect from midnight 24/25 Feb 2021," the joint statement said

# **Thousands Rally in Armenia After PM Warns of Coup Attempt**



YEREVAN (Reuters) - Armenian Prime Minister Nikol Pashinyan warned of an attempted military coup against him on Thursday, and thousands took to the streets of the capital to support him after the army demanded he and his government resign.

Russia, an ally of Armenia which has a military base in Armenia, said it was alarmed by events in the former Soviet republic and called for the situation to be resolved peacefully and within the constitution.

Pashinyan, 45, has faced calls to quit since November after what critics said was his disastrous handling of a six-week conflict between Azerbaijan and ethnic Armenian forces over the Nagorno-Karabakh enclave and surrounding areas.

Ethnic Armenian forces ceded swathes of territory to Azerbaijan in the fighting and Russia, which worries about instability in the former Soviet Union, has deployed peacekeepers to the enclave, which is internationally recognized as part of Azerbaijan but populated by ethnic Armenians. Pashinyan, a former journalist who swept to power in a peaceful

revolution in May 2018, has rejected calls to step down despite opposition protests. He says he takes responsibility for what happened but now needs to ensure his country's security.

On Thursday, the army added its voice to those calling for him to resign.

"The ineffective management of the current authorities and the serious mistakes in foreign policy have put the country on the brink of collapse," the army said in a statement.

It denounced Pashinyan's sacking of the first deputy head of the army's general staff, a move it described as irresponsible, groundless and detrimental to the state.

Two former presidents - Robert Kocharyan and Serzh Sarksyan - released statements calling on Armenians to throw their support behind the military.

It was unclear whether the army was willing to use force to back its statement, in which it called for Pashinyan to resign.

Pashinyan responded by calling on his followers to rally in the centre of the capital, Yerevan, to support him and took to Facebook to address the



# Biden Overturns Ban on Many **Green Card Applicants**

WASHINGTON (Dispatches) - U.S. President Joe Biden has revoked a proclamation issued under the Trump administration that blocked many green card applicants from entering the United States.

The order by former President Donald Trump, known as Presidential Proclamation 100014, cited a need to protect U.S. jobs amid high unemployment rates caused by the coronavirus pandemic.

In a statement, the White House announced that Biden overturned the measure through an executive order, saying Trump's ban separated families and "does not advance the interests of the United States".

# Two Dead in Niger Election Unrest, **Opposition Figure Sought**



NIAMY (Dispatches) - Two people in Niger have died in post-election violence and hundreds have been arrested, the government said Thursday, accusing a prominent opposition figure of stoking the unrest.

The toll is two dead," Interior Minister Alkache Alhada said, reporting on violence that began on Tuesday after the results of a presidential runoff were announced.

Alhada told the press that 468 arrests had been made, "including certain politicians" whom he did not identify. He accused a well-known opposition figure, Hama Amadou, of being "the main person responsible" for the unrest. "(He) is being sought and as usual he is on the run, but we will find him," Alhada said.

Violence erupted after the electoral commission declared former interior minister Mohamed Bazoum the winner of Sunday's runoff vote with 55.75 percent, while opposition candidate Mahamane Ousmane garnered 44.25 percent.

Ousmane angrily disputed the result as fraudulent and claimed he narrowly won with 50.3 percent of the vote. The elections have been trumpeted as a democratic watershed for the Sahel state -- the world's poorest nation

# U.S. Report on Khashoggi Murder Critical for Justice

NEW YORK (Dispatches) - The pending release of an unclassified United States ntelligence report on the murder of Saudi journalist Jamal Khashoggi will be a critical step in the ongoing search for justice, a leading United Nations expert has said.

Agnes Callamard, the UN special rapporteur on extrajudicial, summary or arbitrary executions, said the report by the Office of the Director of National Intelligence (DNI) is expected to provide information on who was responsible for the October 2018 killing. "Once we have further evidence, it will be really impossible for the rest of the world to ignore whatever information will be provided," Callamard said late on Wednesday during a panel discussion hosted by the Knight First Amendment Institute at Columbia University.

Khashoggi, a Washington Post newspaper columnist and prominent critic of Saudi Crown Prince Mohammed bin Salman, was killed at the Saudi consulate in Istanbul, where he had gone to retrieve documents for his upcoming marriage.

His murder sent shockwaves around the world and spurred demands from human rights advocates, press freedom organisations, UN experts and legislators for the perpetrators to be held accountable.

"For the sake of accountability and for the sake of American democracy, the DNI report must be released." Callamard said. White House Press Secretary Jen Psaki told reporters on Wednesday the Biden administration remains committed to releasing the DNI report. She did not give a specific timeframe for its release, saying only it would be "soon".

Biden told reporters he has read the report and expected to speak by phone soon with Saudi King Salman bin Abdulaziz al-Saud. The US president he did not say when the call would take place, the White House press pool reported.

YANGON (Dispatches) -Supporters of Myanmar's military, some armed with knives and clubs, others firing



Thursday, as protests against the new junta continued in the country's largest city. Myanmar has been in turmoil since the army seized power and detained civilian government leader Aung San Suu Kyi and much of her party leadership after the military complained of fraud in a November election. Protests and strikes have taken place daily for about three weeks, and students had planned to come out again in the commercial hub Yangon on Thursday. But before many coup opponents congregated, about 1,000 supporters of the military turned up for a rally in the city centre.

In Pashinyan's earlier livestream, he said he had dismissed the head of the general staff of the armed forces, a move that still needs to be signed off by the president.

Pashinyan said a replacement would be announced later and that the crisis would be overcome constitutionally.

Some threatened news photographers, media workers and witnesses said, and scuffles soon escalated into more serious violence in several parts of the city. Several people were set upon and beaten by groups of men, some armed with knives, others firing catapults and hurling stones, witnesses said. At least two people were stabbed, video footage showed.

In one incident, several men, one wielding a large knife, attacked a man outside a city-centre hotel. Emergency workers helped the bloodied man after his attackers moved off but his condition was not known.

"Today's events show who the terrorists are. They're afraid of the people's action for democracy," activist Thin Zar Shun Lei Yi told Reuters. "We'll continue our peaceful protests against dictatorship."

As dusk fell, dozens of riot police fired tear gas into a neighborhood in the city to disperse a crowd that had gathered at an administrative office to protest the appointment of a local official by the junta, according to a witness and live-streamed video.

The violence will compound worries about a country largely paralysed by the protests and a civil disobedience campaign of strikes against the military. Earlier, police blocked the gates of Yangon's main university campus, stopping hundreds of students inside from coming out to demonstrate.

Facebook said that due to the risks evident from the "deadly violence" seen since the coup it had banned the Myanmar military from using its Facebook and Instagram platforms. The spokesman for the ruling military council did not respond to a telephone call seeking comment.

# **Gov't Opens Key Motorway to Ease Traffic in Five Provinces**

TEHRAN - President Hassan Rouhani has opened a key motorway that encircles the capital Tehran to ease traffic moving from west to the south and from east to the west of the country. Rouhani attended a virtual inauguration ceremony on Thursday to open the Ghadir Highway, a 158-kilometer ring road that has cost some 70 trillion rials (\$280 million) and five years to build.

The highway links the city of Abyek in the northern province of Qazvin to Charmshahr located to the southeast of the capital Tehran.

Authorities say the road will ease traffic passing through five Iranian provinces, especially in the province of Alborz where roads accommodate a bulk of traffic entering the capital Tehran.

It also reduces the length of travel from the west to the south of Iran by an average of 100 minutes while it significantly slashes fuel consumption and helps boost air quality in major cities like Tehran.

The six-lane highway has been jointly funded and executed by the government and the Khatam headquarters, a construction company affiliated with the Islamic Revolution Guards Corps (IRGC).

Khatam contracted 34 companies and 2,000 civil engineers to finish the road. The IRGC firm will get back its 70-percent share of investment in the project from toll fees in a period of 20 years.

Reports said thousands of workers have been recruited during the various construction phases of the motorway while it will create 250 permanent jobs.



Rouhani hailed the project as a sign of the failure of the U.S. sanctions on Iran. He said his administration would continue to expand the road network in the country until his second term expires next summer.

He said that the construction of the Ghadir Freeway was a sign of the defeat of the enemy's maximum pressure.

At the inauguration of 'Ghadir Freeway', Rouhani stated: "The implementation of this project shows that despite the economic war, sanctions, and maximum pressures, these pressures, as the enemy says, have failed."

He also said that Iran's East-West and West-South transit was provided by the Ghadir Freeway and noted that the freeway was part of the Silk Road and was very important.

### Salehi, German Ambassador Discuss Issues of Mutual Interest

TEHRAN (IRNA) - Head of Atomic Energy Organization of Iran (AEOI) Ali-Akbar Salehi and German Ambassador to Tehran Hans-Udo Muzel reviewed various issues concerning the Joint Comprehensive Plan of Action (JCPOA) and Tehran-Berlin ties.

The meeting was held on Tuesday but IRNA reported on Wednesday.

Takh-Ravanchi said Washington must remove the sanctions it re-imposed on Iran after unilaterally withdrawing from the JCPOA in May 2018, adding, "If sanctions are lifted within the next three months, Iran will act in line with its commitments."

Elsewhere in the interview, the senior Iranian diplomat explained that the countermeasures that Iran began to take a year after Washington's exit do not amount to an escalation of tensions.

The comments come days after Iran stopped the voluntary implementation of the Additional Protocol to the Non-Proliferation Treaty (NPT) Safeguards Agreement — which allows snap inspections by the International Atomic Energy Agency (IAEA) of nuclear facilities — under a law passed by the Iranian Parliament requiring the administration to tighten its retaliatory measures.

The law had set February 21 as the deadline for the removal of US sanctions against Iran before Tehran goes ahead with the halt in the IAEA's additional inspections two days later. On the day of the deadline, however, Tehran and the IAEA reached "a temporary bilateral technical understanding," as part of which the UN nuclear watchdog would continue its "necessary verification and monitoring activities for a period of up to three months."

The Atomic Energy Organization of Iran said the Islamic Republic had agreed to keep recording information on its inspection equipment for three months without granting the IAEA access.

"If the sanctions are completely lifted within three months, Iran will give this information to the agency. If not, the information will be deleted forever," it added.

Meanwhile, the IAEA chief on Wednesday said the international community will face a "completely new situation" over Iran's nuclear program if Tehran and world powers, including the United States, fail to reach an agreement to end the row.

Grossi spoke in an exclusive interview with NHK, the first one since Iran announced that it had stopped the voluntary implementation of the NPT.

The suspension of the Additional Protocol was "a very important loss" for the international community, the UN nuclear agency's chief added.

Meanwhile on Tuesday, Takht-Ravanchi said unilateral economic sanctions are one of the main obstacles to effectively counter the negative effects of climate change and must be lifted. Majid Takht-Ravanchi made the remarks during a meeting of the UN Security Council that discussed the effects of climate change on global peace and security.

Takht-Ravanchi described dealing with the negative dimensions of climate change as a "collective" responsibility and said all governments must fully implement their obligations under the UN Framework Convention on Climate Change (UNFCCC) and the Paris climate accord.

"Sanctions severely undermine the ability of a number of developing countries, such as Iran, to meet the challenges of climate change," the top Iranian diplomat said.

"Unilateral U.S. sanctions against Iran have not only prevented the country's access to the necessary financial resources and technologies, but have also adversely affected the effective use of national capabilities to meet its obligations, and therefore these illegal and inhumane sanctions should be lifted," he added.

Majority of lawmakers believe that the government has ignored the Strategic Action Plan law regarding the removal of sanctions which was approved in Majlis and forced the government to implement it as of February 23 as the law forbids the voluntary implementation of additional



protocol of the IAEA. Some 200 lawmakers on Wednesday February 22 in a letter to the Judiciary Chief lodged a complaint against President Hassan Rouhani, Head of AEOI Mr. Salehi and Foreign Minister Mohammad Javad Zarif and called for annulment of the agreement between Iran and the IAEA.

Lawmakers interpreted this agreement as violation of the law that they had approved and reported the offenders of the agreement, namely President and other government officials, to the Judiciary. After the Sunday, February 21 agreement between the Islamic Republic of Iran and Grossi on the IAEA's inspection of Iran's nuclear program and the day after it, Majlis convened a closed session and the outcome of the meeting was to report the above-mentioned people and offenders to the Judiciary but in reaction to these measures and Majlis's strong stand, on Tuesday evening and by issuing a statement regarding to Majlis opposition and dispute over the agreement with the IAEA, the government stipulated that this agreement was fully in compliance with the Supreme National Security Council of Iran (SNSC) approval and it is for reducing the cost of the law and is a strategic action. The government statement has called Majlis efforts for annulment of agreement with the IAEA an irrational decision and against the national security and also a "regrettable" one.

The government of the Islamic Republic of Iran has emphasized that if Majlis insists on annulling the agreement with the IAEA, it should also accept all consequent responsibilities against the public and it should be accountable for all the consequent costs. The government's emphasis on the SNSC has important significance that it follows the following intentions of the two sides: one is Majlis which pursues the strong demand of the public and is eager to confront strongly with the offenders of the JCPOA either the U.S. or Europe which have not taken any effective measures in implementing the JCPOA, and the other side is the government which still looks optimistically to the Western diplomacy system and insists that it has provided appropriate and required time for the Western side to get past the smear campaign of the Zionists in order that U.S. President Joe Biden and European sides can swallow Iran's conditions and scale back from the Western norms and welcome their return to the JCPOA with offering a logical proposal.

That Majlis from the view of the law considers the issue and that the SNSC with paying some attention to the government's demand for using its diplomatic capacity can be considered both in the same line and can pave both the U.S. and Europe's path.

But this remark is very crystal clear and rightly that the Western side has not been committed to its JCPOA obligations and this lack of commitment has caused irreparable damages like waste of seven years of people's time with having a hopeful look at the JCPOA, and ultimately with empty hands and no result. By the way, this has happened while the government of the Islamic Republic of Iran has closed down the whole nuclear industry with pouring cement under the JCPOA commitment and has fully disarmed Iran in this regards.

On Monday February 22, Chairman of Majlis National Security and Foreign Policy Commission Mojtaba Zonnouri during the open session of Majlis and during reviewing the joint statement of IAEA and AEOI criticized it from this view that he questioned, "Is it expected Majlis only to approve laws that are not to be implemented?"

Regardless of difference in the way and timing of implementation of Iran's gradual voluntary stopping implementation of the Additional Protocol, Spokesman for the United States Department of State Ned Price on Monday evening has said that if Iran returns to full compliance with the deal, the United States would be prepared to do the same. The spokesman in his press briefing has claimed that Iran's action is to move further away from its JCPOA commitments and expressed his concerns. It is very clear that since January when Joe Biden has taken the helm of the foreign policy in the White House, this delusion has been shaped in his mind that the government of the Islamic Republic of Iran may be influenced by the media pressure and Western smear campaigns, and it is forced to sit at the negotiation table for adding more obligations to its former JCPOA commitments. And unfortunately they try to show this demand as a legitimate one and they think that the Supreme Leader of the Islamic Revolution who has always held the helm of the national foreign policy in his hands would this time retreat his words and show flexibility in a condition that the Islamic Republic has put behind at least 65 to 75 percent of hardships of the effective pressures of sanctions and with little more resistance it will be able fully and innovatively to overcome sanctions. In fact, the ball is on the other side's court. Iran today has passed the level of uranium enrichment to 20 percent purity and will continue its path for self-sufficiency for its needs in this field. Therefore, the government of the Islamic Republic of Iran will be, for a short time, obliged to obey Majlis demand which is the Leader and the public's demand, too, in facing the stubbornness of the West. So Iran's path will have an articulated definition and the West will have no way but to backtrack from its irrationality and pertinacity.

The Iranian diplomat rejected France's claims of human rights violations, saying Paris was not in a position to comment on the issue.

"Canada and the U.S., besides France, Germany and Britain, are accomplices to the war crimes being committed against the innocent people of Yemen and Palestine in the hands of their clients," Sadati Nejad said. He said given their horrific human rights records which include systematic racism against minorities, the U.S., Canada, France and Germany are not entitled to preach about ethics.

The Iranian diplomat also said the United States, as the frontrunner in the spread of terrorism and unilateral and bullying policies against a large part of the world's population, must be held accountable for the crimes caused by its economic terrorism against civilians.

France is the third largest exporter of arms to Riyadh, with Paris accounting for 4 percent of the kingdom's arms imports between 2015 and 2019, behind the US (73 percent) and UK (13 percent), according to the most recent figures released by the Stockholm International Peace Research Institute (SIPRI). Over the same period, France was the second largest exporter of arms to the UAE, according to the Middle East Eye.



### Holloway Breaks 60m Hurdles World Record

**P**ARIS (Dispatches) - America's Grant Holloway broke Colin Jackson's long-standing 60m indoor hurdles world record at Wednesday's athletics meeting in Madrid.

Holloway had already run 7.32sec in the heats and blitzed the competition in customary style on the way to claiming the new record, with Britain's Andrew Pozzi finishing second in 7.51sec. # Real Madrid, Man City In Sight of Champion League Quarters

L ONDON (Dispatches) - Ferland Mendy put Real Madrid within touching distance of the Champions League quarter-finals with the late strike that sank 10-man Atalanta 1-0 in Bergamo.

The French left-back's curling effort came four minutes from time in a last 16, first leg clash in which the hosts had to play a man down for over 70 minutes, giving Zinedine Zidane's side the advantage heading into the second leg in Madrid on March 16.

"We didn't have a great game tonight, but the most important thing was the result, scoring away was important for us," said Zidane.

"It's a very good result against an Atalanta team even at ten, because they defended very well.

"The tie is open. We are going to have a great return match."

Atalanta had attacked early but the game was transformed when Swiss midfielder Remo Freuler was harshly send off in the 17th minutes for tripping Mendy at the edge of the penalty area.

Gian Piero Gasperini's woes continued with forward Duvan Zapata limping off after half an hour with a muscular problem with midfielder Mario Pasalic coming off the bench.

"The game was ruined," said Gasperini.

"I don't know what would have happened 11 against 11.

"I just got banned for saying something in Serie A, if I say something now then UEFA will ban me. But this is football suicide.

## **Barty Withdraws From Qatar Open**

LONDON (Dispatches) - World number one Ash Barty has withdrawn from next week's Qatar Open in Doha due to a left leg injury, organisers of the WTA 500 tournament said.

Barty's decision comes after being knocked out of the Adelaide International on Wednesday, losing 6-3 6-4 to American Danielle Collins in the second round.

The 24-year-old Australian was struggling with a left thigh strain throughout the Australian Open, where she bowed out in the quarter-finals last week.

"Unfortunately I have withdrawn from the Qatar Total Open with a left leg injury," Barty said.

"I wish the tournament a safe and successful event and hope to play there next year.

"Thank you to the event organisers and the WTA for all the work you are doing, I look forward to competing again in "Enough of these referees who've never played a game and don't know the difference between a challenge and a foul." Spanish midfielder Isco got a rare start up front for injury-hit Real Madrid playing alongside Marco Asensio and Vinicius. The 13-time European champions were

without striker Karim Benzema due to an ankle problem with an injury list also



including Sergio Ramos, Eden Hazard and Dani Carvajal.

"It's true that there are many casualties, but the players who are here are doing well, committed, every time there is a change we adapt," added Zidane.

Meanwhile Manchester City moved to the verge of the Champions League quarter-finals with a 2-0 win over Borussia Moenchengladbach on Wednesday but coach Pep Guardiola insisted his team still need to "be more clinical up front".

A first half header from Bernardo Silva and a Gabriel Jesus strike in the second period of the last 16 first leg tie extended a winning streak by Guardiola's high-flying side to 19 games in all competitions.

Premier League leaders City camped inside the Gladbach half for most of the game, which was moved to Hungary due to Germany's Covid-19 travel restrictions.

Although dominant, City took time to break down a stubborn German defence, often foiled by the interceptions of Algeria left-back Ramy Bensebaini.

While Guardiola said afterwards he was "pleased" with the result, he added City "have to improve" to challenge for Champions League honours.

"We controlled the game. Unfortunately we were not clinical up front, it is something we have to improve in this competition, we were not good enough in the box, we didn't dribble and shoot enough," said Guardiola.

"In this competition you have to be perfect to be sure you can go through," he said. Debutants in the Champions League knockout stages, Gladbach had been urged by coach Marco Rose to be brave against Guardiola's side.

**N**EW YORK (Dispatches) - Tiger Woods could return to competitive golf within a year, top orthopedic surgeons said on Wednesday, but the road back from serious leg injuries sustained in a car crash will be a long and grueling one.

Already credited with one of sport's great comebacks when he returned from back surgery to win a fifth Masters in 2019, ending an 11-year majors drought, Woods will have to be even more resilient if he is to overcome the damage done in Tuesday's accident.

The 45-year-old golf great was hospitalized in Los Angeles and underwent emergency surgery on Tuesday for injuries suffered when his sport utility vehicle careened off a road and rolled down a hillside.

Woods sustained compound fractures of his tibia and fibula to his right leg in the early morning crash along with additional injuries to his foot and ankle, according to a statement posted on the former world No. 1's official Twitter account.

He also suffered trauma to the muscle and other soft tissue of the leg.

The devastating injuries have raised concerns over whether Woods will return to competitive golf, with any comeback further complicated by his long history of knee and back problems.

# Sadal Pulls Out of Rotterdam Open With Back Issue

LONDON (Dispatches)- World number two Rafa Nadal has withdrawn from next week's Rotterdam Open due to a back injury, organisers of the ATP 500 event said on Thursday.

The 20-time Grand Slam winner has been struggling with a back issue since the build-up to the Australian Open and was forced to

skip Spain's ATP Cup ties earlier this month.

"Unfortunately, Rafael Nadal is forced to pull out of the 48th ABN AMRO World Tennis Tournament," the tournament organisers said in a statement. "The back problems that started in Australia prevent him from playing next week."

Despite the injury, Nadal did not drop a single set at the Australian Open until the quarter-final stage, where he was knocked out by Greek Stefanos Tsitsipas last week. World number three Daniil Medvedev will replace Nadal as the top seed in the Rotterdam event, which will run from March 1-7.

### Gauff Advances to Semifinals At Adelaide International

ADELAIDE (AP) - Coco Gauff and Jil Teichmann have advanced to the Adelaide International semifinals after three-set wins on the Memorial Drive hard courts.

Teichmann beat Anastasija Sevastova 6-4,6-7 (8), 7-5 and was later joined by 16-year-old Gauff, who beat fellow American Shelby Rogers 2-6, 6-4, 6-4. Teichmann had five match points in the second-set tiebreaker but was unable to close it out. The 23-year-old Swiss player was then forced to save two match points while trailing 5-4 in the third.

"It was a rollercoaster and what I felt was nerves," Teichmann said. "It was a very tense match, very long rallies every time. Anastasija is a tough player and you have to play every point and every game, doesn't matter if you're serving or returning."

### Copa America

**B**RASILIA (Dispatches) - Australia and Qatar have pulled out of the 2021 Copa America starting in June, South American football's governing body CONMEBOL said.

CONMEBOL's deputy general secretary Gonzalo Belloso said that the two members of the Asian Football Confederation (AFC) would not be able to participate due to a clash with World Cup qualifying dates.

"The Copa America is absolutely going ahead. But Qatar and Australia, who had asked to take part, will not be able to come," Belloso told Argentine radio La Red. "The Asian confederation has programmed World Cup qualification on the same dates as the Copa." The news was confirmed by both the Australian and Qatari football federations.

"It is with great disappointment that Australia cannot feature at the Copa America in 2021," said Football Australia CEO James Johnson. "To have participated in such a prestigious competition and to experience the unique South American football culture would have been a thrill for Australian players, staff and fans alike."

Johnson said the Socceroos were still hoping to be invited again in the future.

"The Socceroos' players and staff were greatly looking forward to the unique opportunity of playing in the Copa America," head coach Graham Arnold said.

"On behalf of the team I thank CONMEBOL for the invitation, which would have presented our team with a fantastic opportunity to test itself against some of the world's best." Although Qatar are hosting the 2022 World Cup, they're taking part in the preliminary campaign because it is doubling up as qualification for the 2023 Asian Cup in China. The AFC has scheduled qualification matches for June 11 and 15.

### **Dispatch Elche**

BARCELONA (Dispatches) - Lionel Messi soared past Luis Suarez to become La Liga's top scorer by adding his 17th and 18th goals of the season in a much-needed 3-0 victory for Barcelona over Elche.

Barca had followed up last week's crushing Champions League loss to Paris Saint-Germain by drawing at home to Cadiz on Sunday but eased the strain with a comfortable win at the Camp Nou.

Messi's double owed much to a pair of superb assists, with a supreme dribble by Frenkie de Jong coming after a sublime flick from Martin Braithwaite, who also set up Jordi Alba to score a third. After failing to take full advantage of league leaders Atletico Madrid's defeat by Levante on Saturday, this victory puts Barcelona back in third, five points off the top, having played a game more than Atletico.

"We cannot lose any more," said Ronald Koeman. "The problem was we were not good enough at the start and we have to win all the games now if we want to do something in the league."

Even if Atletico prove too far ahead to catch, a positive performance was important, especially with a semi-final second leg to come next week against Sevilla in the Copa del Rey, which may be their only chance of winning a trophy this term.

Messi's return to top form comes as a huge boost too. The 33-year-old came off unfavourably in comparisons made with Kylian Mbappe last week but these kinds of performances show he is far from finished yet.

This was Messi's fifth and sixth goal in his last four games while no player from the top five European leagues has scored more than his 13 this year in all competitions. Bayern Munich's Robert Lewandowski is closest on 12.
