### Legal Leniency Will Be **Extended to Include Security**, **Media Crimes Convicts**

TEHRAN (IFP) - The spokesman for Iran's Judiciary says the body's new chief has ordered officials to prepare a list of all security crimes convicts, with details on the type of their crime and their punishment. The spokesman said these convicts will now benefit from commutation of punishments under required conditions.

"The approach of the new Judiciary Chief [Gholam-Hossein Mohseni Ejei], as we have seen it, is that when implementing the law, there will be no difference between security convicts and others and trials must strictly follow legal standards. In the new approach, legal leniency, within the framework of the regulations, will cover security and media [crimes] convicts, that means the leniency will hinge on the behavior of the convict and his/her expression of regret and compensation for his/her past," said the spokesman Gholam-Hossein Esmaeili. "At the very beginning of tenure of the new Judiciary Chief, Mohseni Ejei, he ordered [officials] to prepare a list of all security [crimes] convicts in the country detailing the type of their crime and their punishment as well as their behavior, during the period they have been serving their conviction, and their current status, and each of these convicts, who is eligible and qualified to benefit from the legal leniency, it will be applied to them, within the framework of regulations.'

This pandemic-as any other-calls for a strong coordinated international response that can rapidly expand access to tests, treatments and vaccines while recognizing extensive immunization as a public good that must be available and affordable for all, including—and perhaps especially— developing countries.

The Islamic Republic of Iran has consistently and continuously demonstrated its commitment to multilateralism as the tenet of a robust foreign policy. As such, we continue to advocate the vision of common, comprehensive, cooperative and sustainable security in West Asia. In this context, we are engaged in active cooperation with the UN in peace efforts in Yemen, Syria and Afghanistan. We proposed the "Hormuz Peace Endeavor-HOPE" as well as a "Regional Dialogue Forum" in the Persian Gulf, as inclusive approaches to cooperation and dispute settlement.

### Verw Point **JCPOA** Talks Really **In Final Stage?**

After weeks of talks between P4+1 and Iran in Vienna over the fate of Iran's nuclear deal, known as the JCPOA, it seems it is approaching its final stage as Iran's Foreign Ministry Spokesman Saeed Khatibzadeh has claimed.

On Monday Khatibzadeh has claimed the delegations in Vienna talks are reaching the final stage of the negotiations, which are aimed at reviving the 2015 Iran nuclear deal with world powers that was thrown into a state of limbo after US illegally withdrew from the accord and Tehran took remedial measures to reduce its commitments as per the agreement. "We have come a long way so far, but the rest of the way is not going to be an easy path," he added.

The sixth in-person round of the negotiations in Vienna came to an end on June 20, two days after Iran's presidential election that resulted in the victory of Ebrahim Raisi.

Six rounds of talks in Vienna have reportedly made progress but yielded no final deal.

The United States and European powers warned Iran last week that its latest uranium-enrichment efforts could imperil those negotiations.

Iran has already announced that the country's stance on the JCPOA "will not alter with a change of administration." "We hope the other parties [to the JCPOA] would be

able to make their decisions. In that case, we would achieve an agreement, which would be desirable for all," Khatibzadeh said.

Khatibzadeh added that all participating delegates believe that good advances have been made in the talks, "but they are also in agreement that some key issues must be first dealt with by higher authorities in their respective countries.

He added that Iran's position has not changed since the commencement of the talks in Vienna.

"We demand the removal of sanctions followed by verification before our country restarts fulfilling its commitments. On the other hand, the United States as the violator of the JCPOA, must give necessary assurances [that it will not leave the deal again]," Khatibzadeh said.

Khatibzadeh's claims come while there are different views in the U.S. and the West which are in contradiction to what Khatibzadeh has said.

The NATO Secretary-General has reportedly 're-stressed Allies' continued calls on Iran to uphold and fully implement all its obligations under the Treaty on the Non-Proliferation of Nuclear Weapons and its safeguard agreement with the International Atomic Energy Agency. NATO Secretary General Jens Stoltenberg wants Iran to fully implement all its obligations under the JCPOA while the U.S. and Europeans

### **EU Distances Itself From Slovenia PM's Remarks**

BRUSSELS (Dispatches) - The EU foreign policy chief says the speech delivered by Slovenian Prime Minister Janez Jansa at a summit organized by the anti-Iran Mujahedin Khalq Organization (MKO) terrorist group does not represent the official position of the 27-nation bloc.

Josep Borrell made the comments in a statement to reporters on Monday, two days after Jansa ---whose country holds the rotating EU Council presidency - made a controversial video address to the annual MKO meeting. Iran's Foreign Ministry Spokesman Saeed Khatibzadeh earlier denounced the presence of Western politicians in the virtual event, saying they "sell themselves cheap for a Europe-hosted circus arranged by a once Saddam-backed terrorist cult with Iranian blood on its hands."

Slovenian Ambassador to Tehran Christina Radi was summoned to the Iranian Foreign Ministry, where she was handed over an official letter of protest.

In the letter, Tehran voiced its vehement condemnation of the Slovenian premier's move, while strongly rejecting all baseless allegations leveled against the Islamic Republic during the meeting.

## **Tehran Confirms Talks With U.S. Over Prisoner Exchange**

TEHRAN (MNA) – The negotiations of Tehran and Washington over exchanging prisoners are underway, and more information will be released after achieving results, the Iranian Government Spokesman said on Tuesday.

While speaking in his weekly presser on Tuesday, the Iranian Government Spokesman spoke about Washington's claims over releasing all Iranian prisoners in this country and other countries.

Negotiations are underway in this regard, and more information will be released after achieving results, Ali Rabiei said.

The Islamic Republic of Iran has repeatedly reiterated its readiness to exchange all political prisoners in return for the release of all Iranians imprisoned at the behest of the United States across the world, he said.

During the Trump administration, it was the Iranian side who announced its readiness to hold negotiations in this regard but the Trump administration refused to come to the negotiating table, insisting on taking the Iranians hostage, Rabiei added. Earlier, Iranian Foreign Minister Mohammad Javad Zarif had proposed the

The Attorney General added: "One of the critical issues between these countries is the legal regime of the Caspian sea, which the Islamic Republic has prepared to join the convention, but has not yet signed.

The ambassador also said: "One of the dangers that the Caspian Sea will face in the future is misuse of natural resources of the sea and its environmental issues."

Jalali added: "Prosecutors general of the Caspian littoral states can protect it with judicial cooperation." Caspian Sea littoral states signed a joint declaration on protecting the environment and biological resources of the Sea on Wednesday, 07 July 2021, in St. Petersburg of Russia. Caspian Sea Legal Regime Convention signed by the 5 littoral states of the Caspian Sea Iran, Russia, Kazakhstan, the Republic of Azerbaijan, and Turkmenistan in 2018.

Bandar Lengeh is a port city and capital of Bandar Lengeh County, in Hormuzgan province of Iran on the coast of the Persian Gulf. Iran produces approximately 5,000,000 tons of bitumen annually, half of which is exported to the Middle East, South Asia, East and Southeast Asia, Africa and Europe.

- Iran Garment Exports **Decline to \$60m Per Year**

TEHRAN - Deputy Head of Tehran's Union of Garment Manufacturers and Sellers says Iran's garment exports were very considerable in the past but in recent years it has declined.

Speaking at a presser, Majid Eftekhari said that in recent years Iran's garment exports have declined to \$50m to \$60m but the figure rebounded last year to \$113 and it was due to the devaluation of the national currency and its comparatively cheap price.

He added that neighboring states like Iraq and Afghanistan are the major destinations for exports of Iranian apparel and countries like the Central Asian and Arab states are the other destinations for the products of this industry but the current banking restrictions have created hurdles for exports.

He went on to say that we see traders of other countries enter Iran and buy different products like garment and carpets with Iranian national currency and take them to other countries and most of them are not even registered anywhere.

Eftekhari also pointed to the problems of this industry in the country and blamed the shortage of the raw material and smuggling as the major problems that this industry is facing. He said industry ministry has imposed some unwise and uncalculated restrictions for import of raw material and it has even helped the price of the domestic raw material to rise by 40 percent. He stated by the outbreak of the COVID-19 in the world, some commodities in countries like China and Bangladesh had no demands and they are ow ready to be offered in the market and it will make the condition tough for Iranian garment producers.

He also pointed to the figures released by the officials regarding the decline in the amount of smuggling of the apparel into the country from \$1.8b to \$600m, and added

that the imports are divided in two parts of official and smuggling. He said that official import of the apparel is banned and if the statistics regarding to the decline of smuggling to \$600m is true, then some changes should have been seen in the domestic market and production.

Eftekhari said that the number of involved people in the apparel industry has been around 300,000 people in the country and so far no major change has happened in it and for this reason one can cast doubt on the statistics regarding the smuggling.

He said after imposing ban on imports of apparel to save the forex, many international brands decided to produce their products in Iran and for this reason apparel production in the country picked up. He reiterated that the slim advantage in the apparel production is vanishing due to the shortage in raw material and lack modern machineries

Eftekhari reiterated that raw material in Turkey is up to 30 percent cheaper than Iran and it can boost the smuggling, adding that due to the economic condition of the households, they are after cheaper commodities because the final cost of Iranian products is more expensive.

He then asked the government and the next president to support this industry. adding that many websites are busy with selling the smuggled garments online.

### Iran 2nd Largest Global Producer of Sponge Iron in 2020

TEHRAN (PressTV) - Iran was the second largest global producer in 2020 of sponge iron, a pre-reduced ferrous material used to make steel, according to latest figures by the World Steel Association (worldsteel).

The figures cited in a Monday report by Iran's staterun metals conglomerate IMIDRO showed that sponge iron production in the country reached 30.2 million metric tons last year, up 5.96% against 2019.

That puts Iran only second to India at 33.6 million tons of sponge iron output in 2020, said IMIDRO report.

Sponge iron, or what is technically known direct reduced iron (DRI), accounts for a bulk of the feedstock used in the Iranian steel mills.


Worldsteel figures showed Iran's raw steel production totaled 29 million tons last year, making the country the 10th largest steel producer in the world in 2020.

IMIDRO and its subsidiary steel makers churned out a total of 18.9 million tons of steel last year as the company became the 18th largest steel producing firm in the world, showed the figures. Iran has continued to develop its massive metals industry by investing more in mines and building new mills and smelters across the country in recent years.

That has come despite U.S. sanctions targeting the country's metals trade since 2019.

Government authorities are now boasting of a higher role for minerals in Iran's non-crude exports, saying the country is gradually moving away from sheer reliance on oil revenues by building out its metals sector.

Government estimates suggest Iran could reach an annual steel output of 55 million tons by 2025.

## **Dutch PM Apologizes for Easing of COVID-19 Curbs**



AMSTERDAM (Reuters) - Dutch Prime Minister Mark Rutte conceded on Monday that coronavirus restrictions had been lifted too soon in the Netherlands and he apologized as infections surged to their highest levels of the year.

Rutte last Friday reimposed curbs on bars, restaurants and nightclubs in an effort to stop a spate of infections among young adults, just two weeks after most lockdown measures were lifted as cases were falling. The government also cancelled all multi-day festivals and events with large crowds until Aug. 14.

## **Cuba Blames Unrest on U.S. Asphyxiation as Biden Backs Protests**



HAVANA (Dispatches) - Cuban President Miguel Diaz-Canel on Monday blamed historic protests this weekend on U.S. "economic asphyxiation" and social media campaigns by a minority of counter-revolutionaries while U.S. President Joe Biden said he stood with the Cuban people.

The protests erupted amid Communist-run Cuba's worst economic crisis since the fall of former ally Soviet Union, with the tightening of decades-old U.S. sanctions exacerbating shortages of food and medicine as well as power outages amid a surge in COVID-19 infections.

"In the last few weeks the campaign against the Cuban revolution has increased in social media, drawing on the problems and shortages we are living," Diaz-Canel said in a televised address alongside his Cabinet.

A minority of counter-revolutionaries were fomenting unrest, he said, denouncing vandalism that took place across various cities on Sunday in Cuba's biggest anti-government demonstrations in decades.

"They threw stones at foreign currency shops, they stole items ... and at police forces, they turned over cars - a totally vulgar, indecent and delinquent behavior," he said.

### **Pro-Western Party Wins Moldova Election**

CHISINAU (Reuters) - Pro-Western Moldovan President Maya Sandu's PAS party won the country's snap parliamentary elections, data from the central election commission showed on Monday, on a platform of fighting corruption and carrying out reforms.

Sandu hopes to win a majority in the 101-seat chamber to implement reforms she says were blocked by allies of her pro-Russian predecessor, Igor Dodon. After the counting of 99.63% of ballots, only three political forces will be represented in the new chamber, the data showed. PAS had 52.60% of the vote, while its main rival, Dodon's Socialists and Communists bloc, had 27.32%.

The party of Ilan Shor, a businessman convicted of

closer ties with the European Union, defeated Dodon last year but was forced to share power with the parliament elected in 2019 and the government run by lawmakers aligned with Dodon.

In April, Sandu dissolved parliament, in which PAS had 15 lawmakers while Dodon's Socialists had 37. Together with allies he controlled a majority of 54 deputies.

"I hope that Moldova will end today a difficult era, the era of the rule of thieves in Moldova. Our citizens must feel and experience the benefits of a clean parliament and government that cares about people's problems," Sandu said on Facebook.

She said that after the final count of votes she intended to form a new government as soon as possible.

### Myanmar's Suu Kyi Hit by New Charges in Mandalay Court

YANGON (Dispatches) - Myanmar's deposed leader Aung San Suu Kyi is facing four additional criminal charges, filed in a court in the country's second biggest city Mandalay, her lawyer said on Monday.

The legal team has little information about what Suu Kyi was accused of but the charges included corruption and that two were also leveled at Min Thu, a former minister in her government, lawyer Min Min Soe told Reuters. "There are corruption charges. We do not know why do they sue? Or for what reasons? We will find out about it," she said.

# Afghan Special Forces Moved in on Taliban



KANDAHAR (Reuters) - Soldiers from Afghanistan's Special Forces paused for a short prayer late on Sunday night on a deserted stretch of highway in the southern province of Kandahar. They do so each time they prepare to face Taliban militants in battle.

The highly trained troops had been called in to flush out insurgents who attacked regular forces and local police hours earlier, only to find that the Taliban had disappeared into the darkness leaving behind a few civilians and wounded soldiers. "We received a report that the enemy had infiltrated here and wanted to overthrow the district," Major Mohammad din Tasir, a member of the special forces unit deployed in the Taliban's former stronghold of Kandahar, told Reuters after the operation.

The report had suggested up to 300 Taliban fighters were present in the area, he said. "Unfortunately, what we heard in the report and what we saw on the scene did not match."

Tasir said the absence of Taliban fighters showed that claims by the group that they now controlled up to 85% of the country's territory were exaggerated. It also underlined the difficulty in facing an enemy that mixes open assaults on

### Colombia Says No "Hypothesis" in Haiti Plot

BOGOTA (Reuters) - Colombian police said they could not share any hypothesis about the murder of Haitian President Jovenel Moise and that they respect the Haitian state's autonomy, after 18 Colombians tied to the case were arrested and three more killed.

Moise was shot dead early on Wednesday at his Port-au-Prince home by what Haitian authorities describe as a unit of assassins formed of 26 Colombians and two Haitian Americans. Haitian police said on Sunday they had arrested another key suspect.

The death of the president has plunged the troubled country into deeper turmoil, and U.S. officials traveled there on Sunday to assess the situation and meet three politicians who have staked competing claims to take charge of Haiti.

On Sunday, Haitian police said they had detained one of the suspected plot masterminds, 63-year-old Christian Emmanuel Sanon, a Haitian man whom authorities accuse of hiring mercenaries to oust and replace Moise. They did not explain Sanon's motives beyond saying they were political. read more

"We cannot construct any hypothesis," General Jorge Luis Vargas, head of the Colombian national police, told journalists in Bogota. "We respect the judicial autonomy of the Haitian state and its authorities.'

Families of some of the Colombians, many ex-soldiers, have said their relatives were hired as bodyguards, not as mercenaries, and that they did not kill Moise.

The men were initially contracted to protect Sanon, and were later presented with warrant to arrest Moise, Haiti's National Police Chief Leon Charles said Sunday. Photos said to be of Sanon meeting with a group of men, including another suspect in the case, Haitian-American James Solages, began circulating on social nedia late on Sunday. Reuters could not verify the authenticity of the images.

A man by Sanon's name is listed online as a doctor who has worked in Florida, where a security company that Haitian authorities say hired suspects in the case is based.

Most of the detainees were held after an overnight shoot-out on Wednesday in a suburb of Port-au-Prince, and three killed.

The court said in its judgment that the main opposition leader Sher Bahadur Deuba should replace Oli by late Tuesday, as he had presented "a claim (of majority) ... as the prime minister".

Deuba has to win a vote of confidence in the lower house within a month to retain the prime ministership.

Deuba, the head of the Nepali Congress, earlier claimed to have the support of 149 members of the 275-seat lower house.

Political analyst Lok Raj Baral told AFP the court had stopped Oli from "doing as he pleases".

"Political stability ahead depends on an alliance among sharply divided political parties and their factions," he added.

The Oli government came to power in 2018 with a two-thirds majority. There was optimism that his strong mandate at the polls would end years of instability and short-lived governments exacerbated by a devastating earthquake in 2015.

Deuba was elected as Nepal's prime minister four times between 1995 and 2018, including during the brutal, decade-long Maoist insurgency.

# **Bitcoin Is Steady**

LONDON (Dispatches) - Led by bitcoin, most major cryptocurrencies have spent the past seven days in relative tranquility. Bitcoin and ether have been trading -0.69% and -4.46% on the week respectively, according to crypto data aggregator COIN360. The biggest movers are Binance's BNB, which has added 6.95% over the same period, and Dogecoin, which is down by 8.28%.

Bitcoin is still facing resistance at \$33,576 though on-chain metrics

are becoming more bullish. For instance, "bitcoin exchange balances have started to show signs of sustained outflows," tweeted blockchain data and intelligence provider Glassnode.

Approximately 40,000 BTC, or \$1.37 billion, have been withdrawn over the last three weeks, reversing weeks of inflows that coincided with the 50% market crash. The withdrawals suggest that traders are moving their funds to outside wallets and aren't looking to sell in the near term.





# Ireland Sticks to Its Guns

BRUSSELS (Reuters) - The European Union has agreed to delay a corporate tax plan for the bloc following pressure from the U.S. administration and in a bid to facilitate a broader global tax deal, but EU member Ireland reiterated its criticisms of the wider reform. The world's 20 largest economies endorsed on Saturday a plan for a global overhaul of corporate tax that would introduce a minimum tax rate and change the way large companies like Amazon and Google are taxed, based partly on where they sell their products and services rather than on the location of their headquarters.

The reform, if finalized in October, would need parliamentary approval in the more than 130 countries that support it, including the U.S. Congress where it could face opposition from the Republicans. All EU member states must also approve tax reforms - including the envisioned global deal.

In an attempt to eliminate one possible hurdle to the global deal, the EU bowed to U.S. pressure and said on Monday it would delay its own plan for a separate levy on online sales, which the U.S. administration had feared could have led to more criticism of the global tax overhaul in the U.S. Congress.

"We have decided to put on hold our work on our new digital levy," EU commission spokesman Daniel Ferrie told a news conference in Brussels on Monday, noting the bloc will reassess the situation in autumn. The tax proposal had been planned for later in July.

The announcement coincided with U.S. Treasury Secretary Janet Yellen's visit to Brussels and followed repeated pressure from her during a G20 summit at the weekend and before.

EU economics commissioner Paolo Gentiloni told journalists postponing the bloc's plan would make it easier to concentrate on achieving "the last mile" of the global deal.

However, there remain some holdouts against the global deal, including three EU countries - Ireland, Hungary and Estonia.

Ireland has said it cannot support the floor of 15% for the global tax rate, which is intended to stop multinationals shopping around for the lowest tax rate but would force Dublin to raise its 12.5% rate, which has been instrumental in convincing several companies to make the island their EU headquarters.

Yellen reiterated on Monday her call on all 27 EU countries to join the global deal. "We need to put an end to corporations shifting capital income to low tax jurisdictions, and to accounting gimmicks that allow them to avoid paying their fair share," she said in a statement.

But Irish Finance Minister Paschal Donohoe did not appear to have changed his criticism of the reform. After a meeting with Yellen, his spokesperson said he had repeated to her Ireland's support for the shift in the way multinationals are taxed but its opposition to the 15% minimum rate.

Donohoe said, however, that Ireland was committed to the process and was ready to engage in the coming weeks with the Organization for Economic Co-operation and Development (OECD) which is coordinating talks on the global reform.

### China "Recession" Risk Sparks Unease in Economic Circles BEIJING Dispatches) - A surprising move to cut the banking system's reserve requirement ratio (RRR)

BEDING Dispatches) - A surprising move to cut the banking system's reserve requirement ratio (RRR) signals looming headwinds of a potential recession for China's economy while further widening a divergence from Washington's pro-tightening economic stance, according to economists.

The People's Bank of China will slash the RRR by 0.5 percentage points on Thursday, unleashing 1 trillion yuan (US\$154 billion) worth of liquidity into the interbank system, with the primary aim of using more credit to help support small, cost-pressured domestic businesses. It is the first such cut in 15 months.

But the move has left some economists wary on the nation's economic outlook. Some have predicted that gross domestic product (GDP) will grow by 5 to 6 per cent in the second half of 2021, year on year, after first-quarter growth jumped 18.3 per cent – albeit against a low base comparison with last year when the coronavirus pandemic resulted in widespread lockdowns.

Ren Zeping, chief economist at Soochow Securities, said that the "window of China's monetary easing cycle" is opening amid weakening economic momentum. China freeing up 1 trillion yuan will help support businesses, but impact seen as 'negligible' to economy in near-term

China's slowdown stems from weak consumer spending and because small and medium-sized firms – the nation's biggest employers – are struggling with the high cost of raw materials and reduced production. A surge in commodity prices are now at late-stage stagflation and in the early recession of the economic cycle," Ren said in a note published in Chinese media on Monday. "The second half of this year and the first half of next year will be the transition point ... the economy will slow down, quarter by quarter. Real estate and exports will cause the biggest drag on the economy."

In an earlier note on Saturday, Ren said: "New export orders have fallen for two consecutive months. In the second half of the year, as external demand gradually shifts from durable goods to services, and as overseas production capacity gradually recovers, high growth in exports [from China] may not be sustainable."

### U.S. Consumers' Short-Term Inflation Outlook Jumps

WASHINGTON (Reuters) - U.S. consumers expect the economy to continue its rapid resurgence from the COVID-19 pandemic over the next year, with forecasts for inflation, earnings, income growth and spending all increasing in June, according to a monthly

survey released on Monday by the New Yorkd Federal Reserve.

One-year-ahead median inflation expectations jumped for the eighth consecutive month to 4.8% in June, up from 4.0% in May and marking a new series high since the survey was launched in 2013. At the three-year outlook, they were unchanged at 3.6%.

The internet-based survey taps a rotating panel of 1,300 households and is a useful barometer for the U.S. central bank as it weighs its inflation outlook.

# OPEC+ Yet to Make Progress in Resolving Impasse

MOSCOW (Dispatches) - OPEC+ is yet to make progress closing divisions between Saudi Arabia and the United Arab Emirates that last week prevented a deal to raise oil output, making another policy meeting this week less likely, OPEC+ sources said.

Russia has been working behind the scenes to bring Riyadh and Abu Dhabi back to the table to find a path to agreement, sources told Reuters. But a Russian source said on Monday a meeting this week was not expected.

A dispute between the two Persian Gulf OPEC allies was exposed last week, scuppering for now a deal that would have boosted output from August. Oil prices, already near their highest since 2018 due to a tightening market, rose further on the lack of a deal.

The spat forced the Organization of the Petroleum Exporting Countries, Russia and other producers, known as OPEC+, to abandon talks on boosting production after days of negotiations.

The White House said last week the United States was monitoring talks among OPEC and its partners.

The Kremlin said on Monday that Russian President Vladimir Putin and his U.S. counterpart Joe Biden did not discuss OPEC+ or oil prices during a call on Friday.

In a joint statement on Monday, Saudi Arabia and Oman called for continued cooperation between OPEC and its allies.

OPEC+ agreed last year to record oil output cuts of almost 10 million barrels per day (bpd), or about 10% of world output, as the pandemic hit demand. The curbs have been gradually relaxed and currently stand at about 5.8 million bpd.

### India's Consumption Story To Create \$15 Trillion Economy



MUMBAI (Dispatches) - The covid-19 led disruptions notwithstanding, consumption by India's middle class will help create a \$15-trillion economy in two decades, said Gautam Adani, chairman of Adani group, on Monday.

In his address to shareholders at the annual general meeting of Adani Enterprises, Adani also rejected "reckless, irresponsible reporting" about the company's shareholding in June which caused unexpected fluctuations in the market prices of his group's stocks.

Adani added that there should be no doubt about India's target to be a five-trillion-dollar economy in four years. "History has shown that, out of every pandemic crisis, there emerge several learnings – and I believe that India and the world are wiser as we go through this pandemic," he said.

"India will be 5 trillion-dollar economy--and then go on to be a 15 trillion-dollar-plus economy over the next two decades. India will emerge as one of the largest global markets, both in terms of consumption size and market cap," Adani told shareholders. Referring to the drop in share prices of the group companies. Adani said the group's focus is on creating long-term sustainable value. "Recently, a few media houses indulged in reckless and irresponsible reporting related to administrative actions of regulators. This caused unexpected fluctuations in the market prices of Adani stocks. Unfortunately, some of our small investors were affected by this twisted narrative in which some commentators and journalists seemed to imply that companies have regulatory powers over their shareholders and that companies can compel disclosure. In the long term, such diversions will not impact us." he said. For the fiscal year 2021, the consolidated EBITDA (earnings before interest, taxes, depreciation, and amortization) of the group's listed portfolio was over ₹32,000 crore: a year-on-year growth of 22%. "All the Adani stocks generated returns over 100 percent and our businesses ensured that we returned close to ₹9,500 crore to you, our equity shareholders. This is a 166% increase in profit after tax on a year-on-year basis," he said.

### Malaysia to Cut 2021 GDP Growth Outlook, Likely Close to 4% KUALA LUMPUR (Dispatches) - Malaysia will lower its economic growth outlook for this year due to movement

restrictions against Covid, the country's finance minister said, signaling the government may forecast expansion around 4%. While there's optimism that the current surge in cases can be contained and lockdowns can be eased, the government still expects to lower its gross domestic product estimate for 2021, Finance Minister Tengku Zafrul Abdul Aziz said Monday in an interview with Bloomberg TV.

"We're in the midst of revising to a lower number and will share the exact number after we get data from the ground," Zafrul said. Asked if the forecast could be cut to around 4%, Zafrul responded that it could be "around the range you mentioned." The government has already said it will revise the outlook, currently at 6%-7.5%, next month.

Pressure is mounting on Prime Minister Muhyiddin Yassin with lockdowns costing the economy 1 billion ringgit (\$239 million) a day and only 10% of the population fully vaccinated, while the largest party in his ruling coalition just withdrew its support for the premier. New Covid cases reached a record 9,353 on Saturday, with the Klang Valley --- which includes Kuala Lumpur -- accounting for about 60% of the total.

"Markets are priced up for a deteriorating economic outlook as the Covid wave shows no signs of subsiding," said Prakash



Sakpal, senior economist at ING Groep NV in Singapore, who cut his 2021 GDP growth forecast for Malaysia to 4.4% from 5.3% last week. "Making the matter worse for the markets now is the elevated political uncertainty."

The benchmark stock index slid 0.5% at the close after capping the third week of losses on Friday. The ringgit was little changed at 4.1905 per dollar after falling to a 11-month low on Friday, while 10-year bond yields rose 6 basis points to 3.27%.

Zafrul was appointed last week as coordinating minister for the nation's National Recovery Plan, responsible for monitoring the implementation of strategy. While an accelerated vaccine roll-out has allowed the government to ease virus curbs in seven states, much of the country remains under a lockdown since June 1.

"Our focus today is for the economy to open safely," Zafrul said. "It's a dynamic and agile plan." The Fed's preferred inflation gauge has surged to the fastest annual pace since 1992 and is well above the central bank's 2% target, but policymakers remain divided about how long the higher inflation readings will persist as supply bottlenecks caused by the pandemic begin to fade.

Consumers also have increasing confidence in the jobs market, the survey showed. The average expectation that the U.S. unemployment rate will be higher one year from now dropped to a series low of 30.7% in June, down from 31.9% in May. The perceived odds of losing a job over the next year also fell to a series low.

Median expected earnings growth over the year ahead edged up 0.1 percentage point to 2.6% in June, the highest reading since the beginning of the pandemic, and those surveyed reported they felt they had better odds of finding a job if they became unemployed. Those expected odds rose to 54.2% in June from 54.0% in May, although that was still well below pre-pandemic levels. There were, however, tentative signs that the booming housing market may be reaching its peak, with consumers' home price expectations remaining unchanged. That said, uncertainty about future home price growth rose to the highest levels ever.

### **Iranian Military Supply** Water to Deprived Villages

TEHRAN (IFP) - The Ground Force of the Iranian Army and Judiciary officials along with relief teams have launched work to supply water to rural areas in the southeastern Iranian province of Sistan and Baluchestan.

That came after video was released showing a girl,

with a haggard face, crying and complaining of water shortage in the area where she lived.

A village in Sistan-Bluchestan, which has a population of just around a hundred, and where water is supplied manually, faced water shortage for almost two months.



### **Covid Triggered Biggest Increase in Hunger in Decades**

PARIS (Dispatches) - The Covid pandemic caused an estimated 18 percent increase in the number of people facing hunger, a UN report released on Monday found, dealing a massive setback to efforts to ensure everyone has access to food.

The world was already off track to achieve its goal of eradicating hunger by 2030, but the report warned that Covid had now sent it back in the wrong direction.

The "economic downturns as a consequence of Covid-19 containment measures all over the world have contributed to one of the largest increases in world hunger in decades," said the annual food security and nutrition report compiled by several UN agencies.

Although the full impact of the pandemic cannot yet be determined, the report estimated around 118 million more people faced hunger in 2020 than in 2019, an increase of 18 percent.

The rise in moderate or severe food insecurity was equal to the previous five years combined. "Nearly one in three people in the world (2.37 billion) did not have access to adequate food in 2020 -- an increase of almost 320 million people in just one year," the report said.

One in 10 people were undernourished.

The increase in hunger was widespread as the economic downturn affected almost all low- and middle-income countries.

But the biggest impact was in countries where there were also climate-related disasters or conflict, or both.

"The Covid-19 pandemic is just the tip of the iceberg," said the report.

"More alarmingly, the pandemic has exposed the vulnerabilities forming in our food systems over recent years as a result of major drivers such as conflict, climate variability and extremes, and economic slowdowns and downturns."



The UN agencies said there is a unique opportunity to reverse the dynamic this year however, thanks to two major food and nutrition summits plus the COP26 meeting on climate change.

The report was jointly published by the Food and Agriculture Organization of the United Nations (FAO), the International Fund for Agricultural Development (IFAD), the United Nations Children's Emergency Fund (UNICEF), the UN World Food Program (WFP) and the World Health Organization (WHO).

### **Big Oil Keeps Brakes On Spending Even With Crude Rally Windfall**



LONDON (Dispatches) - Leading international energy companies are resisting the temptation to rush and spend an unexpected windfall from rallying oil and natural gas prices as they focus on longer-term energy transition challenges, executives and analysts said.

Benchmark crude oil prices more than doubled in the second quarter of 2021 from a year earlier and have risen further in recent weeks to close to \$78 a barrel, their highest in almost three years as OPEC and other major producers failed to strike an agreement to lift output.

That, along with higher global natural gas prices because of supply issues, will boost the coffers of oil companies after firms like Exxon Mobil, Royal Dutch Shell and BP sharply cut costs in the wake of the coronavirus pandemic last year.

"The cash flow for majors is looking very strong, they're certainly firing on the oil and natural gas cylinders," Redburn analyst Stuart Joyner said, adding that things could improve further once demand for refined products fully recovers.

The companies are expected to provide updates on their spending plans in second quarter earnings reports over coming weeks, but are unlikely to significantly shift tack with investors laser-focused on securing higher returns from the sector after a disappointing decade.

While the heads of top energy companies said last month \$100-a-barrel oil was achievable again in coming years, they added prices would be volatile, meaning there is little incentive, at least for now, to commit billions to projects that could take a decade or more to show a return on investment. Also dampening the bullish mood is huge uncertainty over near-term energy demand due to the resurgence of COVID-19 in parts of the world and longer-term with the shift to lower carbon fuels to fight climate change. "The international oil companies are still rebuilding their balance sheets," Brian Gilvary, CEO of INEOS' oil and gas division INEOS Energy and a former BP chief financial officer told Reuters. Shell said last week it will increase returns to shareholders earlier than expected thanks to higher revenue, holding its annual capital expenditure at no more than \$22 billion. For companies such as BP and Shell, France's Total Energies and Spain's Repsol, the coronavirus crisis has already accelerated the roll-out of new strategies aimed at lowering carbon emissions and growing renewables businesses So, unlike previous cycles when rising oil prices loosened purse strings, executives will likely stick to their spending discipline and focus on their energy transition strategies. "Higher oil prices allow us to extract more value from our existing businesses, which in turn will generate more resources for our spending on transformation in line with our energy transition roadmap," Repsol Chief Executive Josu Jon Imaz told Reuters in a statement.

### EU Seeks to Rival China's "Belt and Road" With Own Infrastructure

BRUSSELS (Reuters) European Union foreign ministers agreed on Monday to launch a global infrastructure plan linking Europe to the world, its latest step after deals with India and Japan and a similar pledge by the Group of Seven richest democracies. Suspicious of Chinese President Xi Jinping's Belt and Road Initiative to

link Europe to Asia via infrastructure in a bid for greater influence, the EU set out a formal path for an ambitious "connectivity" plan from 2022.

"We see China using economic and financial means to increase its political influence everywhere in the world. It's useless moaning about this, we must offer alternatives," German Foreign Minister Heiko Maas told reporters at a meeting with his EU counterparts in Brussels.

"It is important that the European Union ... coordinates them very closely with the United States," he said.

The EU has already signed partnerships with Japan and India to coordinate transport, energy and digital projects linking Europe and Asia. Both Tokyo and Delhi are worried about Chinese largesse that officials say makes poorer countries beholden to Beijing because they are forced to take on such large debts.

Through development banks, first-loss guarantees to private companies and by offering Western government



China in 2014 to fund a 41-km (25-mile) stretch of road, an amount that has threatened to bankrupt the country. It is now negotiating with Western banks to swap or refinance the debt, Reuters reported this month.

The EU strategy, called "A Globally Connected Europe", makes no mention of China and Luxembourg's veteran Foreign Minister Jean Asselborn cautioned on Monday about making China an adversary, noting that German carmakers sold more vehicles in China every year than in Germany.

But one EU diplomat involved in drafting the strategy said the eight-page document had "China written all over it".

The Slovenian ambassador was also reminded that supporting a terrorist group is in violation of the UN Charter, internationally-recognized principles and human rights values.



## Musk Defends Tesla's \$2.6b Deal for SolarCity

WILMINGTON (Dispatches) - Elon Musk took the stand on Monday to defend Tesla Inc's 2016 acquisition of SolarCity against a lawsuit by shareholders seeking to recoup the \$2.6 billion the company paid for the ailing solar panel maker. Soon after taking the stand, Musk denied the deal was a bailout of SolarCity as Tesla shareholders have alleged. "Since it was a stock-for-stock transaction and I owned almost exactly the same percentage of both there was no

financial gain," he said, responding to questions from his attorney. Musk's testimony kicks off a two-week trial in Wilmington, Delaware, before Vice Chancellor Joseph Slights,

who will decide whether the SolarCity deal was fair to Tesla stockholders.

The lawsuit by union pension funds and asset managers alleges the celebrity CEO strong-armed Tesla's board to buy SolarCity, just as it was about to run out of cash. Musk owned a 22% stake in SolarCity, which was founded by his cousins. At the time of the purchase, he also owned about a 22% stake in Tesla.

Shareholders asked the court to order Musk, one of world's richest people, to repay to Tesla what it spent on the deal, which would represent one of the largest judgments ever against an individual. However, even if the judge finds the deal was unfair, he could award a much lower amount of damages.

Musk, wearing a dark suit, white shirt and dark tie, testified that for years before the SolarCity deal he saw the solar panel company as a natural part of the transition to sustainable energy. He touted the deal at the time as central to his "Master Plan, Part Deux," which aims to reshape transportation

by using sustainable energy to power fleets of self-driving electric vehicles.

Musk said on Monday that he did not control the appointment of board members or their compensation and that they negotiated the SolarCity deal and its economic terms without his influence.

Asked by his attorney, Evan Chesler, to describe his relationship with the board of directors Musk said: "I'd say good. They work hard and are competent. They provide good advice and are rigorous in acting on behalf of shareholders. On cross-examination, shareholder attorney, Randall Baron warned Musk that "we plan to spend a lot of time with you. It's going to be a grind."

Musk grimaced, poked at the six-inch thick binder exhibit and replied "I can tell by the binder."

Legal experts said the judge will be looking for evidence that Musk threatened board members or that directors felt they could not stand up to him.

The shareholders' lawsuit accuses Musk of dominating deal discussions, pushing Tesla to pay more for SolarCity and misleading shareholders about the deteriorating financial health of the solar panel maker.

Central to the case will be allegations that Musk, with his 22% stake in Tesla at the time of the deal, was nonetheless a controlling shareholder. If he was, it would impose a tougher legal standard and increase the likelihood the deal was unfair to shareholders.

"It would be a surprise to most people if the court were to come out and say that he doesn't control here," said Brian Quinn, a professor at Boston College Law School. "Because he certainly acts like he does." Tesla's directors settled allegations from the same lawsuit last year for \$60 million, paid by insurance, without admitting fault. Slights will likely take months before he issues a ruling.

"In line with the policy of using the potential of Iranian expatriate elites, using their help to expand exports of technological products is on the agenda."

ONDON (Dispatches) - Britain's Dina Asher-Smith has withdrawn from the British Grand Prix event in Gateshead on Tuesday, her last race before the Tokyo Olympics, due to a tight hamstring.

The 25-year-old sprinter was due to run in the 200 metres at the Diamond League meeting as part of her buildup to the July 23-Aug. 8 Olympics but said she had to make the "smart" decision and not take any risks.

# **Bucks Trounce Suns to** Cut NBA Finals Deficit to 2-1 21

NEW YORK (Dispatches) - The Milwaukee Bucks scorched the Phoenix Suns 120-100 in Game Three of the NBA Finals in front of an electric home crowd, cutting the deficit in the best-of-seven series to 2-1.

The Bucks had not been at their best in the previous two games in Phoenix but were a different team with home-court advantage, ending the first half with a 15-point lead as two-time league MVP Giannis Antetokounmpo put up 18 points and grabbed eight rebounds.

Unlike Game 2, Antetokounmpo got efficient help from co-stars Jrue Holiday and Khris Middleton, who combined for 39 points, 15 assists and 12 rebounds on 14-for-28 shooting (8 of 17 from 3-point range). Just as important, they led a perimeter defensive effort that held Chris Paul, Devin Booker and Mikal Bridges to 33 combined points three nights after that Suns trio torched the Bucks for a total of 81 points.

In the heart of America's Dairyland, for once home cooking in Milwaukee tastes pretty sweet.

The Bucks dominated their first home NBA Finals game since 1974, defeating the Phoenix Suns 120-100 in a must-win Game 3 on the strength of Antetokounmpo's 41 points, 13 rebounds and six assists in 38 minutes. Following a 42-point effort in Game 2, Antetokounmpo joined LeBron James, Shaquille O'Neal and Michael Jordan as the only players in the last 50 seasons to log back-to-back 40-point Finals games.

Jordan holds the record with four straight 40-point games in the 1993 Finals.

"I'm not Michael Jordan," Antetokounmpo said Sunday, "but all I care about right now is getting one more."

**Skupski** Partners Krawczyk to Wimbledon Mixed Title

ONDON (Reuters) - Britain Lwelcomed a new Grand Slam champion in the form of Neal Skupski as he partnered American Desirae Krawczyk to the mixed doubles title at Wimbledon. The seventh seeds beat all-British duo

Harriet Dart and Joe Salisbury 6-2 7-6(1) on Centre Court. It was Krawczyk's second successive

Grand Slam success after she and Salisbury won the French Open in June. Dart and Salisbury were hoping to become the first all-British pair to win the mixed doubles event at Wimbledon since Jo Durie and Jeremy Bates in 1987.

### Osaka Gets Own Line of Barbie Dolls

ONDON (Dispatches) - Four-time Grand Slam singles champion Naomi Osaka now has her own line of Barbie dolls. The 23-year-old world No. 2 tennis As a sign of how well Fiserv Forum served the Bucks after two straight double-digit

losses in Phoenix, Antetokounmpo made 13 of his 17 free-throw attempts. Only once in his playoff career had he shot such a high percentage on at least 10 free throws. He was even more effective in the paint, where he made 14 of 18 field-goal attempts. This was all-time level stuff from a player long criticized for his postseason play.

The Suns trailed by 22 heading into the final quarter and were unable to make a game of it heading to the buzzer.

"We knew what type of game it was going to be, we knew that we had to come here, play good basketball, compete as hard as possible and I was just trying to be aggressive," Antetokounmpo said.

The 26-year-old forward ended with 41 points, 13 rebounds and six assists. He scored 42 points in Game Two and is only the sixth player to have 40-or-more points in consecutive NBA Finals games.

The Suns made just nine of 31 three-point attempts and coughed up 14 turnovers. The teams meet again in Milwaukee on Wednesday for Game Four.

ONDON (Dispatches) - Novak Djokovic became the first player to qualify for this year's ATP Finals after the world number one tied Roger Federer and Rafa Nadal's record with his 20th major at Wimbledon on Sunday.

Djokovic defeated Italy's Matteo Berrettini 6-7(4) 6-4 6-4 6-3 in the final to seal a sixth Wimbledon title and qualify for the Nov. 14-21 ATP Finals in Turin.

"I am happy to have qualified for Turin so early," Djokovic, who will play in his 14th ATP Finals, said in a statement.

"Italian fans are very much into tennis so I am sure it will be a great event with a fantastic atmosphere.'

The Serbian will look to win the season finale for the sixth time, aiming to match Swiss ace Federer's record at the event. The 34-year-old, who is on course to finish the year as the top-ranked player

for a record-breaking seventh time, has won 34 out of 37 matches this year.

Greek Stefanos Tsitsipas, the 2019 ATP Finals champion, is next in line to qualify in the second position for the Turin event, followed by local favourite Berrettini.

South American confederation CONMEBOL ultimately transferred hosting rights to Brazil at the last minute despite that country having seen more than half a million virus deaths, the second highest global tally after the United States.

Messi, 34, also paid tribute to the memory of Maradona, who died aged 60 last November, saying that "Diego was surely urging us on wherever he is".

Argentina's success over the Brazilians in Rio was not just Messi's first major trophy for the Albiceleste but his country's first continental honor in 28 years.


Messi had been desperate to lead the side to glory after a series of disappointments both at World Cups and the Copa.

Given its battle against the further spread of the virus, Argentina has not organized celebrations to mark their title win.

After arriving back in the country on Sunday, the squad were briefly received at the country's football federation headquarters and then dispersed for a pre-season break. Despite the low-key welcome, thousands of fans took to the streets despite tight virus restrictions.

"To continue to party we must continue to take care of each other -- let's not forget we have a long way to go to get back to normality," Messi warned.

### **England Players** Is Unforgivable

**Racist Abuse of** 

ONDON (Dispatches) - Gareth LSouthgate has condemned the "unforgivable" racist abuse aimed at the three England players who missed penalties in Sunday's Euro 2020 final defeat against Italy.

Marcus Rashford, Jadon Sancho and Bukayo Saka were the victims of sickening social media taunts in the aftermath of the 3-2 penalty shoot-out loss at Wembley.

While some people identifying as England fans used racial slurs in blaming the trio for the defeat, other offensive messages were accompanied by "Forza Italia" hashtags. England's players have made a strong stand against racism at the tournament, taking a knee before all their games including Sunday's final.

"For some of them to be abused is unforgivable," England boss Southgate said at a press conference on Monday.

"Some of it has come from abroad, we have been told this, but some of it is from this country. "We have been a beacon of light to bring people together and the national team stands for everybody. We felt the energy and positivity from the fans and I'm incredibly proud of that." Having infamously missed a crucial penalty in England's Euro 96 semi-final shoot-out defeat against Germany, Southgate knows what it is like to endure taunts and jibes after such an agonising loss.

Many past and present England players, including David Beckham and Raheem Sterling, have been vilified by Three Lions fans after major tournament failures. Southgate said ensuring his stars were supported after the penalty heartbreak was "top of his thinking".



ONDON (Dispatches) - Matteo Berrettini learned some harsh lessons during his defeat by Novak Djokovic in the Wimbledon final on Sunday but is sure he can grow from the experience and return to lift the trophy.

Although world number one Djokovic was the overwhelming favourite to win the title, an upset victory for the 25-year-old Berrettini had not been completely ruled out by pundits. After all, with his booming serves and crushing forehands, the Italian came into the showpiece match on Centre Court having won the Wimbledon lead-up event at Queen's. But, despite Djokovic losing the opening set on a tiebreak, Berrettini nearly always looked second-best in the match. "Obviously now I'm disappointed," the seventh seed, who was bidding to become the first Italian to win the Wimbledon singles title, told reporters.

"I'm pissed because I lost, because I think I didn't play my best match. But I have to say it's thanks to Novak in a way that he... made me play in this way. That's his strength probably. That's why he's one of the best."

Berrettini was, however, keen to see the positives in his strong run on grass this season and was confident he would return to claim the title at the All England Club.

"I know that I can win this title. I'm not sure if I'm going to do it, but I know I can do it," Berrettini said. "So that's what I'm going to do in the next weeks, in the next months and years: try to lift the trophy."

Berrettini was beaten by Rafa Nadal in his maiden Grand Slam semi-final at the 2019 U.S. Open and also lost to Djokovic in the French Open quarter-finals last month.
