Iran-China Trade at Over \$10b in First 9 Months of 2021

TEHRAN - The volume of trade between Iran and China reached 10,425,000,000 dollars in the first nine months of 2021. According to figures released by China's customs administration, bilateral trade decreased 7% compared to the same period in 2020. China's imports from Iran in the January to September period grew 5 percent year on year to reach 4.818 billion dollars.

But China's exports to Iran fell by 15% to 5.607 billion dollars. China is Iran's biggest trade partner and remains an important customer of its crude oil even as many other countries avoid buying Iranian oil out of fear of unilateral sanctions imposed by the United States. The two sides signed a 25-year cooperation agreement this year to strengthen their long-standing economic and political ties. Meanwhile on Friday China reiterated its support for the implementation of the JCPOA, saying "diplomatic efforts" and "concrete actions" are key to a smooth restart of talks between Iran and the P4+1 group of countries slated to be held in the Austrian capital of Vienna later this month. Tehran Urges Clarification Of True, False Narratives On Israeli Crimes

TEHRAN (PressTV) - Iran's permanent ambassador to the UN office in Geneva has called for clarification of true and false narratives, referring to the stories that equate victims of Israeli crimes with the perpetrators of the heinous acts.

Ismail Baqaei Hamaneh made the remarks in a meeting between ambassadors of the member states of the Organization of Islamic Cooperation (OIC) residing in Geneva and members of the Commission of Inquiry of the United Nations Council on Human Rights, during which the sides discussed the Israeli crimes against the Palestinians.

"It is the duty of all of us to clarify the true and false narratives, the narrative that equates the victims of Israeli crimes with their killers, which is humanly shocking, legally unfounded and morally shameful."

He added that the inquiry commission has a historic responsibility to prevent the normalization of systematic human rights violations by the Israeli regime. The Iranian diplomat invited all the participants in the meeting to call for justice and do not allow war crimes, crimes against humanity and blatant violations of human rights to become normal.



Iran Trade Balance Improves by \$2b in H1

TEHRAN - The statistics released by the Iran Custom Administration shows Iran's trade balance which was negative in first half of last year has improved in the first half of the current Iranian calendar year. According to reports, Iran's trade balance last year was minus \$1.3b in the first half of the past year but it has improved by \$2b in the same period this year. As per report, the foreign trade of the country in the first half of

the year has been \$44.9b as the country has exported \$21.8b and in return it has imported around \$23b. The report shows that the country's goods trade has increased 47.7% and 25.7% respectively.

Meanwhile on Saturday the spokesman for Iran's Customs has said that neighboring states had a 52-percent share in Iran's foreign trade in the last seven months.

Iran's non-oil exports in the first half of the year has been valued at around \$16b (almost 73% of the total exports excluding crude oil) which shows 63% growth comparing to the same period last year.

The report shows some European countries like UK, the Netherlands, Germany and Switzerland have been the major exporters to Iran in the first half as their trade with Iran has been around \$3b.

Meanwhile yesterday the Tehran Chamber of Commerce announced that the value of trade between Iran and the EU in the nine months of 2021 has reached about 3.4 billion euros, which is 19% of Iran's total trade

China, Iraq and Turkey have been the major destinations for export of Iranian goods in the first half of the year. Rouhollah Latifi said that Iran's foreign trade in the last seven months totaled 54.8 billion dollars with over 98.68 million tons of goods traded.

From the amount, he added, over 61.46 million tons worth of about 28.32 billion dollars accounted for business transactions with 15 countries neighboring Iran.

This shows that the share of neighbors in Iran's foreign trade accounted for 62 percent in terms of weight and 52 percent in terms of value, according to Latifi.

The official also said that Iraq topped the list of Iran's export destinations in this period, with 19.74 million dollars of imports from Iran.

On the other hand, the United Arab Emirate has the biggest share of Iran's imports, with about 8.6 billion dollars of exports to Iran, as said by the official.

The spokesman added that balance of trade in Iran was +1.246 billion dollars in the last seven months.

IRGC Seizes Foreign Ship Smuggling Diesel In Persian Gulf

TEHRAN (PressTV) - Iran's Islamic Revolutionary Guards Corps (IRGC) has seized a foreign ship in Persian Gulf waters for smuggling diesel, according to a Navy Guards commander.

A foreign ship carrying smuggled diesel was seized by the Iranian flotilla off the coast of the southern Parsian, Hormozgan Province, on Saturday.

"Through intelligence monitoring and in a well-coordinated operation, the Marines of this navy managed to seize a foreign ship with 11 crew members in our country's waters," said Colonel Ahmad Hajian, the commander of the Naval Type 412 Zulfaqar in Parsian.

"After the inspection, more than 150 thousand liters of smuggled diesel was seized and the 11 foreign crew members were handed over to judicial offices of Parsian," he added.

Hajian underscored that his unit will "decisively encounter" any fuel smuggling in the sea for the support of Iran's economy.

Monthly Loading, **Unloading of Goods Rise 12.5% in Iranian Ports**

TEHRAN (MNA) - Loading and unloading of goods increased 12.5 percent in the ports of Iran during the seventh Iranian calendar month Mehr (September 23-October 22), as compared to the same month in the past year, according to the data released by Iran's Port and Maritime Organization (PMO).

The PMO's data indicate that 11.968 million tons of commodities have been loaded and unloaded in the ports during the seventh month, while the figure was 10.642 million tons in the same month of the previous year.

Loading and unloading of basic goods also rose 29.5 percent to 2.621 million tons in Mehr of this year from 2.024 million tons in Mehr of past year.

Meanwhile, as previously reported, loading and unloading of goods in the ports of Iran rose 10.7 percent during the first seven months of current Iranian calendar the year (March 21-October 22), as compared to the same period in the previous year. See Page 7

LONDON (Dispatches) - Resistance groups have strongly condemned Britain's decision to ban Hamas, which could see supporters of the Palestinian resistance movement punished with 14 years in prison.

"The decision is not surprising at all as Britain is the founder of the (Israeli) occupation," Mohammed Ali al-Houthi, a member of Yemen's Supreme Political Council, said Saturday. "The move coincides with the anniversary of the Balfour Declaration, and underscores Britain's continued support for the criminal regime," Houthi added.

The Balfour Declaration was a public statement issued by the British government in 1917 during the First World War, which laid the foundations for the entity of Israel. The declaration is seen as a catalyst for the 1948 Nakba (catastrophe) where more than 750,000 Palestinians were expelled from their homes.

"We had hoped that Britain would not commit a new crime against the Palestinian nation following the Balfour Declaration," said Khalil al-Hayya, deputy head of the Hamas political bureau.

UK Home Secretary Priti Patel on Friday announced the move to bring Britain into line with the European Union and the United States, which designated Hamas a terror group in 1995. The British parliament will vote on the proposals next week and if successful, could become effective from next Friday.

The al-Qassam Brigades military wing of Hamas has been banned in Britain since March 2001. Patel argued an outright ban was necessary because it was not possible to distinguish between Hamas' political and military wing. Israel applauded the news, with its foreign minister Yair Lapid saying the move was a result of "joint efforts" between the British and Israeli regimes.

The proposals would see the outlawing of flying Hamas' flag, arranging to meet its members or wearing clothing supporting the group.

Politically, it could force Britain's Labour party to take a position on Hamas, given the strong pro-Palestinian support of the main opposition party. Showing support for Hamas in Britain could be punished with 14 years in prison if the government succeeds in banning the group.

Tehran, Islamabad Reach **Barter Trade Agreement**

TEHRAN (Dispatches) - Iran and Pakistan have reached an agreement to use barter trade in order to boost bilateral trade in the face of U.S. sanctions, Pakistani news outlets reported on Friday.

As reported by DAWN newspaper, the decision was announced by Pakistani Commerce Secretary Sualeh Faruqi in a meeting of the Senate Standing Committee on Commerce.

According to Sualeh, due to the lack of banking channels with Iran, some issues existed in trading with Tehran and the barter trade agreement is expected to resolve such issues. He further said that barter trade with Iran would start in a month.

Earlier this month, Iran and Pakistan had also announced that a free trade agreement between the two sides was going to be implemented within the next three months as the two sides looking to expand the annual trade exchanges to \$5 billion by 2023.

The MOU for the new trade target was reached during the ninth meeting of the two countries' Joint Economic Committee which was held on November 6 in Tehran.

President Calls for Lifting COVID-Related Night Curfews

TEHRAN - President Seyed Ebrahim Raisi on Saturday ordered the termination of night-time curfews on motorists in large cities, which have been in effect for months with the purpose of slowing the spread of the coronavirus.

In comments at a Saturday meeting of the Coronavirus Fight National Headquarters, Raisi ordered that the night-time curfew imposed on the movement of vehicles in big cities be lifted considering the growing rate of public vaccination.

Urging the ministries of interior and health to keep the border travels under strict control to avert a new wave of pandemic, the president said the smart controls would contain the infectious disease.

"The more the dimension and extent of smart controls increase, the less the nonsmart restrictions could become," he noted.

Raisi said, "Coronavirus is a matter of self-sacrifice, and problems can be overcome by maintaining and strengthening this spirit".

The President added, "The main concern and priority of the government is to protect

the lives of the people, and we will continue this path powerfully until the desired conditions are achieved".

Raisi described the importance of controlling traffic through the country's borders important and said, "The Interior Ministry and the Health Ministry have a duty to control the movement of people across the borders with sensitivity and seriousness".

"As the dimensions and volume of smart controls increase, non-smart restrictions can be reduced," the President said, emphasizing the continued use of smart controls and their impact on controlling COVID-19.

He emphasized, "Due to the general vaccination, the ban on night traffic in cities should be lifted".

GC Approves Bill on Supporting Family, Young Generation



TEHRAN (IP) – The Guardian Council Spokesman said the body approved the bill to support the families and young generation.

Hadi Tahan-Nazif said on Saturday that the bill was discussed several times between the parliament and the Guardian Council, and finally, in recent weeks, this bill was approved by the Guardian Council.

Speaking to the reporters in his weekly presser, Tahan-Nazif stated, "The Constitution has special attention to the family. Article 10 of the Constitution has stipulated safeguarding the family, so we hope to make a family-oriented society."

Approving the amendments to the International Convention on the Standards of Training, Certification, and Protecting Seafarers, he said that the bill was not contrary to Islamic law and the Constitution.

Elsewhere in his remarks, the spokesman referred to the car imports bill and has said no permission has yet been received on regulating the car industry, stressing that the car industry should be regulated and the cars should be sold at a reasonable price and quality. Tahan-Nazif stated: "We are not familiar with car import. Of course, the opponents and the proponents discussed in the parliament and in cyberspace. Our mission in the GC is merely to examine the car import regulations being compatible with the law.' "Of course, we are not seeking to make obstacles for the import of cars, but looking for a solution," said the spokesman and noted," The ratifications of the parliament should not be against the constitution."

FM Condemns UK's Decision to Designate Hamas as "Terrorist" Organization

TEHRAN (PressTV) - The Iranian foreign minister has condemned the United Kingdom's decision to designate Palestine's resistance movement Hamas as a "terrorist organization", stressing that the rights of the Palestinian nation cannot be trampled upon through distorting facts.

"We condemn the UK's decision to declare the popular resistance movement of HAMAS a terrorist organization. Rights of Palestinians cannot be trampled on by distorting facts. The only political solution for Palestine lies in holding a referendum among all indigenous residents," Hossein Amir-Abdollahian said in a post on his official Twitter account on Friday night.

We condemn the UK's decision to declare the popular resistance movement of HAMAS a terrorist organization. His comments came hours after the British government announced that it intended to label Hamas "a terrorist organization", joining the United States, Canada and the European Union in fully banning the Gaza-based Palestinian resistance group, which plays a significant role in defending Palestinian rights against frequent Israel aggression.

Environmental Protection, Long-Term Investment

TEHRAN (IP) – President Seyed Ebrahim Raisi described environmental protection as a cause of power, security and a kind of long-term investment and growth of the country's products.

"In order to protect the environment, the university should be strengthened as a think tank with the executive apparatus," Raisi said on Friday at a meeting with elites and environmental activists, which was held on the occasion of the anniversary of the announcement of general environmental policies by the Leader of the Islamic Revolution.

Referring to the necessity and importance of paying attention to the environment, the President said: "Human society should be sensitive to aggression against the environment. Unfortunately, major world powers make the worst use of the environment and

then, through a mechanism, use the environment as a weapon against developing countries, such as the issue of human rights."

Raisi added: "Preservation of the environment should be considered as a divine gift for human life and all living beings, and in this regard, it is necessary to create structures appropriate to this great mission and correct some incorrect behaviors."

Emphasizing the priority of paying attention to the environment over development and economic activity, and that development is a subset of the environment, the President said: "Although development and economic activities are a necessary issue, they must have an environmental attachment and pay attention to the environment."

Defense Ministry Ready to Assist With House Construction

Martyr Soleimani Foiled U.S. Plots in West Asia

TEHRAN (IRNA) - A former Iranian diplomat has described Daesh terrorist group as a plot hatched by the United States to destroy West Asia, but Iran's Lieutenant General Qasem Soleimani succeeded in foiling the conspiracy.

TEHRAN (MNA) – Iranian Ambassador to Azerbaijan met and held talks with First Deputy Prime Minister of Azerbaijan for examining the recent political and economic developments in the relation of the two countries.

Iranian Ambassador to Azerbaijan Seyed Abbas Mousavi wrote in his tweeter account that in a meeting with First Deputy Prime Minister of Azerbaijan Shahin Mustafayev, the latest developments in bilateral political and

organized resistance in the region to foil American plot, so the current decline and withdrawal of the US from the region come from Martyr General Soleimani's efforts.

The United States created terrorist groups, Daesh in particular, in West Asia to destabilize Muslim countries in a bid to provide the Zionist regime with security, the diplomat argued.

As a result of financial issues and pressures on American soldiers, the United States decided to pull out its military forces from West Asia, but they started forming terrorist groups in order to wreak havoc in the region, particularly in Iraq and Syria on behalf of the U.S., Pakaein warned.

Iran's former ambassador to the Republic of Azerbaijan went on to say that the U.S., Europe, and certain regional states seek to overthrow the legitimate government of Syria and some other Islamic countries in order to disintegrate the Muslim nations with the aim of weakening them in the face of the Zionist regime.

But Martyr Soleimani identified their plots for the region and stood against the Daesh terrorism until they were uprooted, the former diplomat added.

Today, the resistance movement is the most organized entity that stands against the US and the Zionist regime, following up the downfall of these two regimes in the region, he mentioned.

The U.S. assassinated Lieutenant General Soleimani because he played a key role in containing and destroying Daesh's menace in the region, Pakaein said. Elsewhere in his remarks, he expressed hope that ruling groups in Afghanistan can stand against Daesh in the war-torn country in order to foil the United States' plot to turn Afghanistan into another Syria.

He further urged Russia, China, and Iran to be vigilant when it comes to fight terrorism in the region.

Refugees in Iran To Be Vaccinated

TEHRAN (IRNA) -The director general of Bureau for Aliens and Foreign Immigrants Affairs (BAFIA) of Iranian Ministry of Interior has announced that refugees will be vaccinated in Iran with cooperation of international organizations.

Mehdi Mahmoudi said that 1.6 million doses of COVID-19 vaccines have been delivered to Iran under the Humanitarian Buffer within the COVAX Facility, according to a Saturday report from the information center of Ministry of Interior.

Due to importance of inoculation of refugees and foreign nationals against coronavirus, the Islamic Republic of Iran has held various meetings with international bodies, Mahmoudi added. Humanitarian Buffer within the COVAX Facility is under the support of the United Nations. To fight the pandemic, Iran has been implementing a broad project on vaccination in recent months. Coronavirus has killed over 5,150,000 worldwide since its outbreak in December 2019.

TEHRAN (Tasnim) – The Defense Ministry of Iran expressed readiness to help the Ministry of Roads and Urban Development in the house construction sector by sharing its technical know-how to build houses at an industrial scale. Iranian Minister of Road Rostam Qassemi on Saturday paid a visit to the "industrial building factory", belonging

to the Ministry of Defense.

During the visit, Defense Minister Brigadier General Mohammad Reza Ashtiani said the factory manufactures prefabricated steel buildings with modern technologies at an industrial scale.

Voicing the Defense Ministry's readiness to assist the Road Ministry with the housing projects, the general said the average age of the new buildings has been increased from 30 to 100 years.

The buildings constructed with the new method are resistant to strong earthquakes and can be finished in only six months, six times sooner than the ordinary methods, he added.

"The Defense Ministry is prepared to provide the other institutions and organizations in charge with the technology of industrial construction of buildings. We have the capability to establish such factories wherever and with whatever capacity needed," the defense minister noted.

In September 2016, Leader of the Islamic Revolution Ayatollah Seyed Ali Khamenei outlined general policies on family, known as the cornerstone of the Islamic society.

Int'l Flights Passing Iranian Airspace Rise by 36%

TEHRAN (MNA) – Managing Director of Iran Airports and Air Navigation Company said that international flights crossing airspace of the country in Iranian month of Mehr (Sep. 23-Oct. 22) showed 36 percent growth.

Siavash Amir Makri Chief Executive of Iran Airports and Air Navigation Company broke the news and reiterated that international flights passing from Iranian airspace in the last Iranian month of Mehr (From Sep. 23 to Oct. 22) registered a 36 percent growth as compared to the same period of last year. He went on to say that 80 percent of flights have been conducted through 10 airports of the country, adding that Mehrabad, Kish and Mashhad account for the most traffic airports in the country in this period.

Iran, Russia Confer on Int'l and Regional Issues

TEHRAN (IP) - At a meeting, the Iranian Ambassador to Russia and Russian Deputy Foreign Minister discussed important regional and international issues.

Russia's Foreign Ministry in a statement on Friday said that Iran's ambassador Kazem Jalali had met with Deputy Foreign Minister Sergey Vershinin in Moscow and that the two sides discussed key aspects of Moscow-Tehran cooperation at the United Nations and on global and regional issues.

The Iranian ambassador to Moscow and the Russian deputy foreign minister discussed the settlement of disputes in the West Asian region with a focus on

humanitarian and security issues.

The two sides agreed to increase their cooperation in the international community. Iran and Russia are actively involved in the issues of the West Asian region, and the interaction between the two countries has yielded good results so far.

Cooperation between Tehran and Moscow, as well as Ankara in the framework of the Astana talks, has led to the political settlement of many Syrian issues and has brought peace and security to this country.

Iran and Russia have also been cooperating with Iraq and Syria in the framework of the Regional Counterterrorism Center in Baghdad.

Tehran, Jakarta **Economies Complementary**

TEHRAN - Head of Iran Chamber of Commerce, industry, Mine and Agriculture (ICCIMA) Mr. Gholam-Hossein Shafei in meeting with Ambassador of Indonesia to Tehran Mr. Ronny Prasetyo Yuliantoro said economies of Iran and Indonesia are complementary and called for broadening bilateral cooperation.

In the meeting which was arranged at Mashhad Chamber of Commerce where some economic activists of Indonesia and Iran where present, Shafei said Indonesia is the most populous Muslim country in the world and it has a stable and developed economy and it enjoys an important place in the world economic and political relations, adding that Iran considers Indonesia as a good opportunity for entering the ASEAN market.

He noted that both countries fortunately enjoy having valuable political relations but he believes both countries have not taken advantage of their economic capacities. He called the economic potentials of the country complementary and called the mentioned capacity a good opportunity for defining joint co-operations and noted some of the goods being produced in Indonesia are needed in Iran and in return some of Iranian products have good markets in Indonesia.

Shafei added that for example two products of saffron and precious stones from Khorasan Razavi can be welcomed by the Indonesians and currently Iran and Khorasan's turquoise has customers in Indonesia.

He then pointed to the economic potentials of Khorasan Razavi Province and stipulated that the strategic location of this region has caused that major parts of eastbound exports or transit of goods of Iran are done via Khorasan Razavi Province.



Shafei noted that Mashhad itself for the Holy Shrine of Imam Reza (AS) hosts 30m tourists mainly religious tourists annually and the tourism potentials of this city have valuable potentials for attracting international tourists from Muslim states in the East Asia. He expressed hope this visit of ambassador to Mashhad to be an opening for cooperation between Iran and Indonesia and invited the members of Indonesia's Chamber of Commerce to visit Iran.

Shafei then pointed to the role of ambassadors in strengthening the economic relations and said despite good economic relations between the two states, the economic activists of the two countries are unaware of the potentials and capacities for cooperation, and exchange of trade delegations and holding joint economic events can boost information and acquaintance of the economic activists with economic capacities of the two states.

Then Indonesian Ambassador Yuliontoro, for his part, said that Indonesia is also keen to develop economic relations with Iran because there are huge potentials in the economic sector of the two countries and all should work to improve it.

He also called for holding a joint webinar between the chambers of commerce of Iran and Indonesia and said Indonesia is keen to study fields for the joint investments and to prepare the ground for the cooperation of the private sectors of the two countries in those fields.

He also said that tourism and halal products that Indonesia is one of the biggest producers and exporters are of good examples for these good potentials.

Iran, Brazil Launch Chamber of **Commerce in Sao Paulo**

TEHRAN - Iranian and Brazilian private sectors have launched a chamber of commerce in São Paulo, the largest and most important city in South America.

The event which was jointly formed by the two sides' private sectors was the first one ever in two countries' bilateral trade exchange. Iran's Ambassador to Brasilia Hossein Qaribi, who attended the opening ceremony of the chamber of commerce, called for expansion of bilateral relations. The ambassador referred to removal of financial exchange problems, establishment of direct shipping line, and airlines as facilitators of trade cooperation.

Referring to the role and position of Iran and Brazil in their regions, as well as the potentials of the two economies, Qaribi said: "The trading capacity between the two countries is much higher than the selling some essential agricultural items, and in addition to maintaining and developing the current situation, it can expand to various trade interactions with the presence of small and medium companies on both sides."

He added that removing banking barriers, creating a direct shipping line, and the airline would facilitate these goals.

The Iranian ambassador also said: "Brazil is an important member of Mercosur and Iran has a huge market in a region adjacent to Asia, Eurasia and West Asia and can facilitate activities between Mercosur and Eurasia.'

For the first time, Iranian and Brazilian private sectors have launched a chamber of commerce in São Paulo, the largest and most important city in South America. Brazil is the eighth largest economy globally and Iran's most important trading partner in the Americas. The first joint virtual meeting of the parliamentary

friendship groups of Iran and Brazil was held with the participation of MPs member to the friendship groups and ambassadors of the two countries in Oct.

Mercosur, officially Southern Common Market, is a South American trade bloc established by the Treaty of Asunción in 1991 and the Protocol of Ouro Preto in 1994. Its full members are Argentina, Brazil, Paraguay, and Uruguay.

IME Weekly Trade Hits Record High

TEHRAN - Iran Mercantile Exchange (IME) last week witnessed trade of 1,953,000 tons of commodities with a total trading value of more than \$608m, posting growths of 4% in volume and 28% in value of trades comparing to the figures in the preceding week.

According to a report by the IME's international affairs and PR, the exchange traded on its metals and minerals trading floor 1,566,000 tons of commodities valued at more than \$380m.

Commodities sold on this floor included 1,000,035 tons of cement, 269,829 tons of steel, 110,000 tons of iron ore, 11,550 tons of copper, 9,375 tons of aluminum, 7,300 tons of sponge iron, 640 tons of zinc, 280 tons of molybdenum sulfur, 15 tons of precious metals concentrate and 20 kg of gold bars.

Furthermore, the IME saw on both domestic and export pits of its oil and petrochemical trading floor trade of 882.000 tons of commodities worth almost \$220m.

The IME's customers purchased on this floor 160,229 tons of bitumen, 78,686 tons of polymeric products, 61,000 tons of vacuum bottom, 42,000 tons of lube cut, 26,565 tons of chemicals, 8,200 tons of sulfur, 4,406 tons of base oil and 68 tons of insulation. It's worth noting that the IME's agricultural trading floor played host to trading 1 ton of saffron. Last but not least was the IME's side market with 14,889 tons of commodities traded on it.

Biden to Hold Africa Summit to Boost U.S. Ties

ABUJA (Dispatches) – U.S. President Joe Biden plans to hold a summit with African leaders to show US commitment to the continent, Secretary of State Antony Blinken announced.

Blinken, who is on his first visit to sub-Saharan Africa as secretary of state, did not give a date for the summit.

Modi U-Turns on Indian Farm **Laws After Mass Protests**



NEW DELHI (Dispatches) - India will scrap agricultural reform laws that sparked a year of huge protests by farmers, Prime Minister Narendra Modi said in a stunning U-turn that sparked celebrations but also criticism from economists. Thousands of farmers have been camped out on the borders of the capital New Delhi since November last year,

handing Modi one of the biggest challenges since his Hindu nationalist government came to power in 2014. The rallies became a lightning rod for opposition to Modi's administration in a country where two-thirds of the

1.3 billion population rely on agriculture for their livelihood. In a contrite address to the nation coinciding with a major Sikh festival — the religion of many farmers — Modi

said the laws would be repealed in parliament's winter session, which begins later this month.

"I appeal to all the farmers who are part of the protest ... to now return to your home, to your loved ones, to your farms, and family. Let's make a fresh start and move forward," the 71-year-old said.

The surprise announcement sparked muted celebrations today with farmers chanting, waving flags and beeping tractor horns at two protest sites outside Delhi.

Turkish Opposition Calls for Early Election Amid Lira Meltdown

ANKARA (Dispatches) - Turkish opposition leaders called for immediate early elections on Thursday after the lira plunged 6% to new lows following the central bank's decision to cut interest rates amid pressure from President Tayyip Erdogan.

The lira saw its worst day since a 2018 currency crisis, tumbling to 11.3 versus the dollar and a low against the euro after the central bank decided on a rate cut seen as dangerous for the emerging market economy. It stood at 11.06 to the dollar at 1636 GMT. "Stop Already, Erdogan! Election Immediately," tweeted Kemal Kilicdaroglu, leader of the main opposition CHP.

State Department spokesman Ned Price said Washington stood by its treaty ally the Philippines amid an "escalation that directly threatens regional peace and stability."

Beijing "should not interfere with lawful Philippine activities in the Philippines' exclusive economic zone," he said in a statement.

"The United States stands with our Philippine allies in upholding the rules-based international maritime order and reaffirms that an armed attack on Philippine public vessels in the South China Sea would invoke U.S. mutual defense commitments." Price said.

Lebanese President Baulks at March Polls

BEIRUT (Dispatches) - Lebanese President Michel Aoun said he would not sign any authorisation for legislative elections to take place in March, adding to doubts about when the vote can be held amid economic and political meltdown.

Aoun told the Al Akhbar newspaper the early date for elections, approved by parliament in October, would deprive thousands of voters from reaching the voting age of 21.

Snowy weather in March would also mean voters could face difficulties eaching polling stations through blocked mountain roads, he said.

The planned March 27 election date would give Prime Minister Najib Mikati's government even less time to try to secure an IMF recovery plan.

"I will not agree to legislative elections except on one of two dates, May 8 or May 15," Aoun was quoted as saying by the paper.

Aoun had previously refused to sign a law passed by parliament bringing forward the election to March and sent it back to the legislature, which once again adopted it.

Gebran Bassil, the leader of Aoun's Free Patriotic Movement (FPM) and his son-in-law, withdrew with his parliamentary bloc from that parliamentary session in October when the date was approved again.

The FPM this week presented a legal complaint to the constitutional council disputing the date of the election and the proposed election law.

Lebanon's financial crisis, which the World Bank labelled one of the deepest depressions of modern history, has been compounded by political deadlock and a row over the probe into last year's Beirut port blast that killed more than 200 people.

Egypt's Remittances From Workers Abroad Rises to \$2.7b

DUBAI (Dispatches) - Remittances from Egyptians working abroad rose to \$2.7 billion in August, compared to \$2.4 billion in the same month last year, the central bank said on Thursday. Remittances in January-August amounted to \$21.4 billion, up by a total of \$2 billion from the same period a year prior, the bank added.

The ECB is due to decide on the future of its bond-purchase programs at its December 16 policy meeting.

While the central bank has already signalled its 1.85 trillion euros Pandemic Emergency Purchase Program would end in March, Lagarde said asset purchases would still be "important" after that date.

"Even after the expected end of the pandemic emergency, it will still be important for monetary policy — including the appropriate calibration of asset purchases — to support the recovery and the

sustainable return of inflation to our target of 2 per cent," she said. The Bank of England is widely expected to raise rates later this year and the Federal Reserve is winding down its bond-buying program.

But Lagarde argued that tightening policy now would squeeze household incomes, which are already facing a shock from soaring energy costs that will likely dampen growth.

"In this situation, tighter monetary policy would only exacerbate the contractionary effect on the economy," she said.

While Lagarde acknowledged that the outlook for inflation had improved after a decade of sluggish price growth, she said the ECB should "nurture" demand.

"As positive demand forces in the economy gain strength, the inflation outlook over the medium term is looking better than it did before the pandemic," Lagarde said. "So, we should continue nurturing these forces by not withdrawing policy support prematurely.

Qatar Not Reporting All Work-Linked Deaths

DOHA (Dispatches) - Qatar is not adequately investigating and reporting worker deaths including unexplained fatalities among seemingly healthy laborers, the International Labor Organization (ILO) said.

The small but wealthy Persian Gulf state, where foreigners make up the majority of the population, has faced scrutiny over worker conditions in the run up to its hosting the football 2022 World Cup next November.

Data collected at government-run trauma centers and ambulances in 2020 showed 50 workers died and more than 500 were severely injured, the ILO said. "Most were suffered by migrant workers from Bangladesh, India and Nepal, mainly in the construction industry. Falls from height and road traffic accidents were the top causes of severe injuries, followed by falling objects on worksites," the report said.

The ILO said numbers could be higher as authorities don't classify all work-related deaths as such, including unexplained deaths among healthy workers and heat-related fatalities.

That data gap should be addressed, with better injury investigations, Max Tuñón, head of the ILO's Qatar office, told Reuters In August, Amnesty International criticized Qatar for failing to investigate thousands of unexplained deaths.

A widely-reported Guardian newspaper analysis in February concluded 6,500 South Asian migrants had died in Qatar since 2010. However, Tuñón cautioned that Qatar worker death data is frequently reported without necessary nuance. "The [Guardian's] number includes all deaths in the migrant population ... without differentiation between migrant workers and the general migrant population, let alone fatalities that resulted from occupational injuries,'

Yemen Moves to Tackle Foreign Currency Woes

DUBAI (Dispatches)- Yemen's central bank has begun weekly auctions of dwindling foreign exchange reserves to banks in a bid to bolster the currency and temper inflation, and is also seeking to tap IMF reserves offered in August, the bank and an IMF source said.

The International Monetary Fund has allocated \$655 million worth of Special Drawing Rights (SDRs) to Yemen, which would boost foreign exchange reserves by 70%, to help ease an acute economic and humanitarian crisis in the war-torn nation.

But to spend SDRs, countries must first exchange them for hard currencies, requiring them to find a country willing to be an exchange partner.

The war split Yemen's central bank into rival branches, one run by the Houthis in the north, the other answering to the internationally-recognized government in Aden, which is backed by Saudi Arabia.

An official at Yemen's internationally-recognised central bank, who declined to be named, told Reuters the government was still looking for a partner and that Britain was a candidate for that. The UK Treasury and Bank of England declined to comment.

Britain is among Western nations that have provided support to the Saudi-backed coalition. The Aden-based central bank has run through

Turkey's Central Bank Cuts Rates Again, Lira Sinks To Record Low

ANKARA (Dispatches) - The Turkish lira fell to a record low after the central bank cut borrowing costs for a third straight month, a move that risks further undermining price and currency stability.

The lira fell as much as 4.1% to 11.0877 against the dollar, extending the biggest depreciation in emerging markets this year. Policy makers cut the one-week repo rate by 100 basis points to 15%, in line with the median estimate in a Bloomberg survey, and said they would consider ending the easing cycle next month.

It comes as consumer inflation accelerated to almost 20% in October, a level last seen in the wake of a currency crisis three years ago. Yet under pressure from President Recep Tayyip Erdogan, the central bank has lowered interest rates by 400 basis points since September, driving the currency's real yield well below zero.

The central bank has "narrowly avoided fueling a full blown currency crisis today by including a reference to potentially halting the cutting cycle in December," said Simon Harvey, senior FX market analyst at Monex Europe. "However, terminology around such a decision remains loose. Therefore, pressure on the lira remains."

Easier policy in Turkey also leaves the lira vulnerable to further gains in the U.S. dollar and higher Treasury yields as speculation grows the Federal Reserve may tighten policy sooner than anticipated. The greenback rose to the strongest level in more than a year against a basket of peers this week, piling pressure on riskier emerging-market currencies that have benefited from exceptionally loose policy in the developed world.

The lira has lost around a third of its value against the dollar since December and is poised for a ninth straight yearly loss. It has weakened more than 20%

since the central bank started cutting rates in September.

Before the decision, the chairman of Turkey's biggest business group Tusiad said the central bank shouldn't forget its main target of controlling inflation. It reflects mounting concerns that extended currency weakness risk destabilizing the economy which sits on \$446 billion of gross external debt, according to central bank data.

Turkish companies and the government have to repay \$13 billion in foreign-currency debt in the final two months of the year. More than half - \$8 billion - is set to mature in November, the biggest amount due over the next 10 months, according to the latest available data.

Turkey's benchmark BIST 100 Index erased earlier gains to trade 2.4% higher after the decision. The yield on 10-year government bonds jumped as much as 57 basis points, the biggest increase since September.

But to spend SDRs, countries must first exchange them for hard currencies, requiring them to find a country willing to be an exchange partner.

Asia Looks to Release Oil Reserves After U.S. Request

TOKYO (Dispatches) - The world's biggest economies said today they were looking into releasing oil from their strategic reserves, following a rare request from the United States for a coordinated move to cool global energy prices.

The U.S. move reflects frustration with the Organization of the Petroleum Exporting Countries (OPEC) and allies such as Russia who have rebuffed Washington's requests to speed up oil production as the world economy rebounds from the pandemic.

It also comes as U.S. President Joe Biden fends off political pressure ahead of midterm elections next year over rising gasoline prices and other costs driven by the recovery.

The Biden administration has asked big oil buyers such as India and Japan — as well as China for the first time — to consider releasing stocks of crude, several people familiar with the requests told Reuters.

Oil prices sank about 4 per cent to a six-week low after Reuters reports about the U.S. request and China's decision to release some crude, before recovering some ground later on Thursday.

"Brent is now under 80 bucks," said John Driscoll, managing director at consultancy JTD Energy in Singapore. "It's having a short-term effect on oil markets. It's probably good for at least a 5 per cent correction."

China's state reserve bureau told Reuters it was working on a release of its crude oil reserves, although it declined to comment on the U.S. request.

A Japanese industry ministry official said Washington had requested Tokyo's cooperation in dealing with higher oil prices but he could not confirm whether the request included a coordinated releases of reserves. By law, Japan cannot release reserves to lower prices, the official said.

A South Korean official confirmed the United States had asked Seoul to release some oil reserves.

"We are thoroughly reviewing the U.S. request, however, we do not release oil reserve because of rising oil prices. We could release oil reserve in case of supply imbalance, but not to respond to rising oil prices," the official said.

The United States and its allies have coordinated strategic petroleum reserve releases before, such as in 2011 when supplies were hit by a war in OPEC member Libya.

But because the current proposal involves China for the first time, it represents an unprecedented challenge to Opec, the cartel that has influenced oil prices for over five decades. There was no immediate official reaction from OPEC+ members.

One source in the group, who spoke on condition of anonymity, said it would be surprising to see stocks released for the purpose of lowering prices, rather than meeting a supply shortage.

Opec sees signs of an oil supply surplus building from next month, Secretary General Mohammad Barkindo said earlier this week.

Another OPEC+ source said A release of strategic reserves was, "not necessary, as Covid cases are increasing and surely new containment measures will be imposed that will reduce the demand for oil and affect prices". A third source said a release would have a "limited impact".



The U.S. SPR was set up in the 1970s after the Arab Oil Embargo to ensure the United States has adequate supply to weather an emergency.

If China is doing its release in coordination with other nations, it would be the first such time, said Sengyick Tee, analyst at Beijing-based consultancy SIA Energy.

China rolled out its first public auction of state crude oil reserves to a select group of domestic refiners in September, aiming to stabilize energy prices.

Biden and top aides have discussed the possibility of a coordinated release of stockpiled oil with close allies including Japan, South Korea and India, as well as with China, over the past several weeks, sources told Reuters earlier.

OPEC and other major producers including Russia, known collectively as OPEC+, have been gradually unwinding record production cuts made in 2020 by raising output by 400,000 barrels per day per month.

But they have resisted Biden's calls for more rapid increases, arguing that the rebound in crude demand could be fragile and there were already signs of a surplus building in 2022.

The Biden administration had not addressed the "root cause" of high prices, which was limited domestic U.S. supply, said Tilak Doshi, managing director at Doshi Consulting in Singapore.

He cited the cancellation of the Keystone XL pipeline to bring oil from Canada's Western tar sands to U.S. refiners, and bans on drilling on Federal lands.

The Biden administration had been "doing everything to stymie domestic oil and gas producers," Doshi said, adding that he believed Washington's call for a coordinated response from allies plus China was a first.

In May, the UN Human Rights Council agreed to initiate an international probe into "systematic" human rights abuses committed during the asymmetrical war between Israel and Palestinian resistance groups in the besieged Gaza Strip. The 47-member forum adopted a resolution presented by Pakistan on behalf of the OIC and the Palestinian delegation to the UN, by a vote of 24 states in favor, 9 against, and 14 abstentions.

The UN rights body agreed to establish "an ongoing independent, international commission of inquiry" into the war to probe "underlying root causes of recurrent tensions and instability, including systematic discrimination and repression based on group identity."

Israeli troops have on numerous occasions been caught on camera brutally killing Palestinians, with the videos going viral online and sparking international condemnation. The Tel Aviv regime has been criticized for its extensive use of lethal force against and extrajudicial killing of Palestinians who do not pose an immediate threat to the occupation forces or to the Israeli settlers.

In a statement released on Tuesday, the Palestinian Ministry of Foreign Affairs and Expatriates called on the International Criminal Court (ICC) to launch an immediate investigation into the Tel Aviv regime's crimes in the occupied Palestinian territories after Israeli forces shot dead a young man in the northern part of the West Bank.

North American Leaders to Curb Methane, Boost Vaccines

NEW YORK (Dispatches) - Canada, Mexico and the U.S. are set to agree to curbs on methane and a boost to COVID-19 vaccine donations during the first leaders' meeting in five years, senior officials in the administration of U.S. President Joe Biden told reporters.

The U.S. officials, who spoke on background, said the three countries are expected to agree to cut methane emissions in their oil-and-gas sectors by 60 to 75 percent by 2030 during their meeting in Washington, DC, on Thursday.

Canada and Mexico are also set to announce plans to donate millions of doses of COVID-19 vaccines – initially loaned to them by the U.S. – to other countries, one of the officials said. The deals are part of a larger effort by Biden to revive the so-called Three Amigos, a North American working group abandoned by his predecessor, former President Donald Trump.

Washington wants to shore up alliances with the neighboring countries to help reorient the economy to a lighter carbon footprint, fight the pandemic, ease immigration pressures and compete with China, the officials said.

Iraq Ready to Pay Back Debts to Iran for Imported Gas

Iran to Produce 20m Doses of Domestic Covid Vaccine

TEHRAN (PressTV) - Iran will have produced some 20 million doses of the Razi Cov Pars coronavirus vaccine by March 2022.

"So far, we have produced as many as 5 million doses of the Razi Cov Pars vaccine, and with a permit for emergency use being issued, we are seeking to produce 20 million doses by the end of the [Persian] year (ending March 21, 2022) and hand them over to the Ministry of Health and Medical Education," said Mohammad Fallah, the deputy head of the Razi Vaccine and Serum Research Institute, which has developed the vaccine. "It is up to the health ministry to decide on the timing of the public distribution of the Razi Cov Pars vaccine across the country, and whenever an agreement is concluded and the vaccine is prepurchased, the vaccine can be supplied to different centers through the health ministry's distribution networks and made available to the public in different parts of the country," he added. He said a protocol is being drawn up to use this vaccine as a booster dose for all other COVID-19 vaccines.

Razi Cov Pars is the second Iranian coronavirus vaccine the clinical trial of which has already begun. The recombinant protein method has been used in developing Razi Cov Pars, making it one of the safest vaccines. Razi Cov Pars can both be inhaled or injected. According to PMO's Ports Affairs Director Ravanbakhsh Behzadian, loading and unloading of goods at the country's commercial ports reached 82.24 million tons in the mentioned period, while the figure stood at 74.31 million tons in the past year's same time span.

During the said seven months, unloading and loading operations in the container sector reached 11.09 million tons, for dry bulk the figure stood at 26.56 million tons, in liquid bulk the figure was 2.56 million tons, while for general cargo (general and miscellaneous goods) it was 11.46 million tons and for the petroleum products loading and unloading volume amounted to 30.57 million tons, Behzadian said. He noted that the loading and unloading operations in the dry bulk sector grew by 14.5 percent in the mentioned period compared to the last year's same time span, while in the liquid bulk sector the figure increased by 27.5 percent, in the general cargo sector the growth was 8.8 Percent and the petroleum sector also experienced a growth of 17.1 percent compared to the same period last year.

While Iran is combating the U.S. unilateral sanctions on its economy, the country's

ports as the major gates of exports and imports play some significant role in this battle. This role makes all-out support to ports and more development of them serious and vital.

Such necessity has led the government to define projects for more development of the ports and also take some measures to encourage investment making in ports, in addition, to facilitate loading and unloading of goods, especially basic commodities, there.

It is worth mentioning that PMO has defined a high number of projects to develop and improve the country's ports, as the country aims to double the capacity of its ports in a course of five years.

Mercedes' Brazil Grand **Prix Appeal Rejected**

DOHA (Dispatches) Formula One Officials have rejected the request by Mercedes for a review of Max Verstappen's driving during the Sao Paulo Grand Prix, motorsport's governing body said.

"I feel so lucky to be going to work with a squad which is in a great position on all fronts and largely has that experience of being winners," Van Bronckhorst told the club website.

"I look forward to carrying on and enhancing the work that has been done already alongside (sporting director) Ross Wilson and the board of the club, and I'm grateful for the chance to work again at this huge football club."

Federer Is Very Important For Our Sport

TURIN (Dispatches) - World number one Novak Djokovic said on Wednesday he hopes rival Roger Federer will return to competitive action soon and be able to compete with the best again after the Swiss great said he would miss the Australian Open in January.

Federer, 40, told Swiss media he is unlikely to return to competition until mid-2022 as he recovers from multiple knee surgeries and would be "extremely surprised" if he was able to play at Wimbledon, a Grand Slam he has won a record eight times.

The 20-times major champion said he would be able to resume running in January and return to training on the court in March or April.

"Roger is an icon of our sport and people around the world love him. They love watching him play, love seeing him around," Djokovic said after securing a semi-final spot at the ATP Finals with a 6-3 6-2 victory over Russian Andrey Rublev.

"He's very important for our sport on and off the court. For the sake of our sport, I sincerely hope that we can see him play at least another time. I'm sure he doesn't want to end his career this way.

"I think he's going to definitely give it a last push, a last try. For everything he has achieved and created for this sport, he deserves to play and deserves to have a proper farewell."

Djokovic is looking to match Federer's record of six titles at the season-ending ATP Finals.

ATP Finals Last Four Spot

TURIN (Dispatches) - Casper Ruud will face Daniil Medvedev in the last four of the ATP Finals after coming from behind to beat Andrey Rublev 2-6, 7-5, 7-6 (7/5).



Fifth seed Rublev came into the match unbeaten in his four previous meetings with Ruud but after a strong start fell to a deserved defeat, failing to qualify for the knockout rounds from the Green Group.

The way Rublev strolled through the first set suggested a quick victory but Ruud fought back gamely in the second set, forcing his higher-ranked opponent into unforced errors and hitting 13 winners as he broke Rublev twice to take the set.

Rublev was visibly angry with the way his performance levels dropped, taking his frustration out on his racket after allowing Ruud to immediately break back in game four to level the set at 2-2 when he had the match by the scruff of the neck.

From there Ruud gained further confidence and wasn't even fazed when his serve was broken in game five of the third set, hitting straight back to level the scores.

He eventually came through the tie-break afer a tense round of games held to serve, in which both players pulled out some beautiful shots, to set up a huge clash with U.S. Open champion Medvedev.
