# Kurdish Companies Urged To Export Goods to Iran

ERBIL (Dispatches) - Iranian Ambassador to Iraq Iraj Masjedi said on Tuesday that he hopes Kurdistan Region's companies will begin exporting goods to his country, adding that they are ready to support the Region to prosper in industry, agriculture and advanced technology.

Attending the second trade and industrial fair in Erbil, organized for Iranian companies, Masjedi told Kurdish companies that Tehran "wants to further strengthen its economic ties with the Kurdistan Region in the field of business, exportation, investment and transportation. This will be in the interest of both countries. The Islamic Republic of Iran wants the Kurdistan Region to prosper in industry, agriculture and advanced technology. We are ready to help."

"We would like the Kurdistan Region to import [goods] to Iran as well. We do not want our relations to be unilateral," he added. The expo opened on Tuesday and will last for five days. About 135 Iranian companies from 10 sectors are participating.

The Kurdistan Region and Iran have enjoyed good relations in the past, and share several border crossings. Tehran-Erbil trade volume is estimated to be around \$13 billion. See Page 7

# Iran Trade With EAEU Up 73% y/y

TEHRAN (PressTV) - The Iranian customs administration (IRICA) says trade between the country and members of the EAEU bloc rose by 73% in value terms in March-November compared to the similar period last year.

IRICA spokesman Rouhollah Latifi said that the value of trade with the Eurasian Economic Union had reached \$3.626 billion in the eight months to November 22.

Iran's exports the five-member EAEU rose by 18% year on year in March-November to more than \$763.6 million, said Latifi.

He said the value of imports from the bloc into Iran had nearly doubled over the same period to over \$2.862 billion, adding that shipments imported from the EAEU had risen by 66% in volume terms year on year.

Iran signed a preferential trade agreement with the EAEU in November 2019 amid efforts by the government to diversify trade routes and to offset the impacts of American sanctions on the country's economic exchanges with the rest of the world. See Page 7

# **President Says Current Price Regulation "Unacceptable"**

TEHRAN – President Seyed Ebrahim Raisi expressed his dissatisfaction over the current situation of price regulation in the country despite some economic achievement in the international trade.

Referring to the achievements of the 13th government in various fields, including significant growth in oil sales, boosting trade with Eurasian countries and the like, Raisi said, "Despite promising achievements in various fields, the current situation in regulating and controlling the market and prices is not acceptable".

Speaking in a cabinet meeting, the President stressed the cooperation and synergy between the government and parliament to solve the country's problems, and said, "The most important way to create this synergy in the interaction between government and parliament are parliamentary liaisons of executive bodies".

On the existing problems in the supply of paper needed by the country, especially for publications, he said, "The relevant officials seriously put the issue of nationalization of the needs of the publishing field, especially paper, on the agenda".

Emphasizing the need for full coordination in the government in the field of information, the President said, "Announcing positions and informing about issues related to the government should be done in full coordination with the government spokesman".

During the meeting, the Governor-General of Khuzestan Sadegh Khalilian presented a report on the actions taken in the province, and the President said, "We owe a lot to this province and its noble and devoted people".

Ayatollah Raisi also stated that part of the resolutions of the Supreme Leader's visit to Khuzestan province has not been fully implemented yet, adding, "We believe that one of the ways out of the problems of this province is the full implementation of the plans approved during the Supreme Leader's visit".

The President mentioned the good work that has been done to rebuild the quake-hit area and resettle the people of Andika, stressing the need for jihadist action to complete rebuilding plans due to the cold season.

Raisi also tasked the Vice-President for Executive Affairs with holding meetings with the governor-general and local managers and, if necessary, travel to Khuzestan to follow up on the issues and resolutions of the President's visit.

# Iran Exports to Russia Grow by 123%

TEHRAN - Russia's 10-month customs statistics show that the country's exports to Iran grew by 123 percent compared to the same period last year.

Russia exported \$1.15 billion in exports to Iran during the first 10 months of last year, but in the same period this year it peaked at \$2 billion and \$565 million, according to customs statistics published on its website. Russia is Iran's only major trading partner, which has increased sharply under sanctions. Russian customs statistics show that Russian imports from Iran also grew by 22 percent to \$779 million in the 10 months of 2021. Thus, Russia's exports to Iran are approximately 3.5 times

more than its imports form the Islamic republic. Russian customs statistics show that the country's total

exports during the first 10 months of this year were about \$387 billion and imports were \$237 billion. Therefore, Iran's share in Russian foreign trade was about half a percent.

Russia's total exports have increased by about 43 percent in 10 months, mainly due to the growth in oil prices and oil and gas export revenues. Imports also grew by more than 28% compared to the same period last year.

# Iraqi Delegation Set to Visit Iran

BAGHDAD (Dispatches)- Iraq will send a technical delegation to Iran this week to negotiate the release of water into the country as the majority of its rivers and marshes are drying up.

For years, the neighboring countries have been in a dispute over water issues — especially as Baghdad relies on the Tigris and Euphrates rivers for nearly all of its water but Tehran is building dams to divert more of the flow of the two rivers.

Iraq has been suffering from acute water shortages. Iraqi experts say the country's southern marshes which lie in some of the hardest hit areas — are drying up as a direct result of Iran's water policies.

"The southern Hawizeh marsh has been suffering from water scarcity for eight months, although the ministry of water resources have launched expenditures from the nearby Khala River but it's not enough," said Hatem Hamid, the director general of the National Centre for Water Resources Management. The Hawizeh marsh straddles the border between Iran and Iraq. See Page 7

# U.S. Threatens Iran With Other Options If Vienna Talks Fail

WASHINGTON (Dispatches) - The United States has once again threatened Iran with considering "other options" if negotiations in the Austrian capital fail to restore the 2015 agreement, three years after the US itself pulled out of the deal and imposed draconian sanctions on Iran.

Speaking with CNN on Tuesday, U.S. special envoy for Iran Robert Malley warned of a "period of escalating crisis" if diplomacy failed to restore the Joint Comprehensive Plan of Action (JCPOA).

The remarks came days after negotiators from Iran and the remaining parties to the JCPOA concluded the seventh round of talks in Vienna, aimed at bringing the U.S. back into compliance with the agreement by removing its sanctions against Iran.

Provided that the U.S. fully honors its obligations under the accord, Iran is also expected to reverse the steps it took in the aftermath of Washington's illegal 2018 withdrawal and subsequent sanctions.

Referring to Iran's retaliatory measures, Malley said, "If they continue at their current pace, we have some weeks left [to restore the deal] but not much more than that, at which point the conclusion will be there's no deal to be revived."

"At some point in a not-so-distant future, we will have to conclude the JCPOA is no more and we would have to negotiate a wholly different deal and we would go through a period of escalating crisis," he added.

Iran's Foreign Ministry spokesman said on Monday that the parties to the Vienna talks reached two agreed-upon texts in the seventh round of talks.

U.S. Secretary of State Antony Blinken said on Tuesday that the U.S. has a strong interest in reviving the deal, warning that if the Vienna talks fail, "then we are actively looking at alternatives and options."

"I'm not going to put a time limit on it," Blinken told reporters, but the remaining runway for a deal is 'getting very, very, very short."

He blamed the former American administration of Donald Trump for "the worst decisions made in American foreign policy in the last decade" by withdrawing from the accord in 2018.

"In getting out of that agreement, we were promised that it would be replaced by a stronger one ... Instead, of course, we've seen just the opposite," he said.

### EU's Top Court Allows European Firms to Scrap Iran Deals

BRUSSELS (Dispatches) - The European Court of Justice (ECJ) in Luxembourg has ruled that EU companies can end contracts with Iranian firms if they face "disproportionate economic loss" as a result of US sanctions.

The EU's Supreme Court has intervened to protect European companies against legal action by Iran for failing to fulfill their contractual obligations.

The European Court of Justice (ECJ) in Luxembourg has ruled that EU companies can end contracts with Iranian firms if upholding the deals would lead to "disproportionate economic loss" as a result of US sanctions.

The ruling was prompted by a lawsuit from the German branch of Iran's Bank Melli against Deutsche Telekom after the telecommunications provider terminated a contract with the bank in 2018 prior to its expiry.

The decision effectively neutralizes a "blocking statute" that prohibited individuals and companies in the European Union from complying with US sanctions imposed in 2018 by then U.S. president Donald Trump after he decided to withdraw unilaterally from the Iran nuclear deal.

**TEHRAN** - Foreign Minister Hossein Amir-Abdollahian said that Iran welcomes further economic and trade cooperation with Azerbaijan.

Iranian Foreign Minister Hossein Amir-Abdollahian on Wednesday made the remarks upon his arrival in Baku, the capital of the Azerbaijan Republic.

"Today, we will have high-level meetings with the officials of the Republic of Azerbaijan and we are glad that the relations between the two countries are growing, developing, and strengthening", the Iranian Foreign Minister stated.

Amir-Abdollahian added that he has a variety of ideas for expanding bilateral cooperation which he will be discussed in a meeting with the President of Azerbaijan Ilham Aliyev.

The Iranian and Azeri Foreign Ministers have been in touch during the past three months and have held meetings in New York, Ashgabat, and Islamabad in which the



frameworks of expanding the cooperations were discussed, according to Hossein Amir-Abdollahian.

The Iranian diplomat went on to say that during his visit, he's going to discuss and finalize the quality of the frameworks in a meeting with the President of Azerbaijan, stressing that Iran welcomes further economic and trade cooperation with Azerbaijan. This is Amir-Abdollahian's first visit to Baku since his appointment as foreign minister.

Jeyhun Bayramov invited Hossein Amir-Abdollahian to visit Baku.

### Japan Ready to Expand Cooperation With Iran



MASHHAD (IRNA)- Japanese Ambassador to Iran Kazutoshi Aikawa said on Wednesday that his country was ready to expand cooperation with Iran, highlighting the long-standing ties between the two countries.

Aikawa made the remarks in a meeting with the Vice-Chairman of Astan Qods Razavi Malek Rahmati in Mashhad.

He underscored the cooperation between Japan and Iran in fighting against the coronavirus spread taking advantage of modern medical equipment and standing against the bilateral US sanctions as well as Tokyo's humanitarian aids to the Afghan refugees settled along Iran's border with Afghanistan.

Rahmati, as his part, said that Iran and Japan were well aware of the dimensions of economic sanction which is one of the domination tools used by the global arrogance, i.e. the US.

The U.S. was the only country in history to actually use nuclear weapons, as no one in the world would forget the US' nuclear attack on the Japanese cities of Hiroshima and Nagasaki, he noted. The very country restricts other countries under the pretext of the possibility that those states may make nuclear weapons, Rahmati went on to add. He also mentioned the abilities of Astan Qods Razavi in various areas, including pharmacy, agriculture and architecture, saying that the entity was ready to cooperate on such projects as desalination and digital economy.

# IRGC Ground Force Employs New Homegrown Tank in Military Drill

TEHRAN (PressTV)- Marking the third day of massive joint military exercises, the Islamic Revolution Guards Corps (IRGC)'s Ground Force has employed an advanced homegrown tank dubbed Karrar for the first time.

Karrar, an upgraded version of the T-72m tanks, came into service during the Great Prophet 17 joint drills in the country's southern coasts on Wednesday.

The new tank is furnished with special coatings to withstand heatwaves and can hide from heat-seeking missiles. It is also equipped with GPS navigation systems.

The Great Prophet 17 drills kicked off on Monday, covering the coastlines of the southern Iranian provinces of Hormozgan, Bushehr, and Khuzestan.

The IRGC Ground Force's special units practiced their defensive skills in Lark Island.

They used new weapons and military equipment as well as new tactics to carry out offensive and defensive operations. After receiving intelligence on the hypothetical enemy, they hit the identified targets with heavy and semi-heavy weapons. Iran's Armed Forces hold routine military exercises throughout the year.

Iranian military experts and technicians have in recent years made great progress in developing and manufacturing a broad range of domestically-manufactured equipment, making the armed forces self-sufficient in this regard.

# Tehran to Host 18th Astana Summit

TEHRAN (MNA)- Russia, Iran, and Turkey have agreed to hold the next Astana format summit in Tehran in February-March 2022, Senior Assistant to Iranian Foreign Minister for Special Political Affairs Ali Asghar Khaji said on Wednesday.

"Yes, it [the summit] is planned. We are preparing to hold it early next year. It will depend on the pandemic situation. But in general, we have agreed to hold the summit. Most likely, we will be able to hold it in February or March," the Iranian diplomat said told TASS.

Khaji said the issue was on the agenda of talks in Nur-Sultan and will be reflected in a separate provision of the guarantor nations' final statement. When asked whether the summit will be preceded by a foreign ministers' meeting, he replied, "Yes, we have agreed on the matter. It will be next year. In January or early February, we will hold a meeting of foreign ministers, and a summit will follow that."

He also said that the next international Astana format meeting on Syria will be convened within a few weeks after the summit of Russia, Iran, and Turkey. "It [the date] depends on the summit, several weeks after the summit," the Iranian diplomat said.

On July 1, 2020, Russian, Iranian and Turkish leaders held an online summit dedicated to Syrian regulation, discussing the prospects of a face-to-face meeting in Tehran when the epidemiological situation improves.

# New Iran-Azerbaijan-Georgia Corridor To Facilitate Transit to Europe

TABRIZ (IRNA) - A new corridor among Iran, Azerbaijan and Georgia will facilitate transit of commodities to Europe, an Iranian official said.

Orujali Alizadeh, head of Eastern Azerbaijan's Road Maintenance and Transportation Organization, told IRNA on Wednesday that the new corridor has been constructed following a memorandum of understanding inked by these three countries.

Three vehicles carrying flags of Iran, Azerbaijan and Georgia departed Tabriz, the capital city of East Azarbaijan province in Iran, to Batumi port city in Georgia's Autonomous Republic of Adjara symbolically, Alizadeh noted.

According to the official, the transit corridor not only facilitates the export of cargos from Iran to Batumi on the coast of the Black Sea but also provides the Islamic Republic with the opportunity to export to other regional states, adding that it will increase the transit of goods from former republics of the Soviet Union to Europe.

### Minister Addresses Metropolitan Issues, Measures to Contain Omicron

TEHRAN (IP) - Interior Minister discussed the country's metropolitan problems in various areas and measures to contain the Omicron variant in meeting officials and mayors of the country.

In the meeting held on Tuesday afternoon Ahmad Vahidi said the problems of metropolitan cities were heard from the officials, some of which were related to laws.

Problems of revenue sources, transportation, clean air, environment, and human resources were raised in this meeting. He emphasized that due to the importance of municipalities in providing services and creating a calm environment for the people, the necessary decisions were made, and some follow-ups with some organizations are required.

# Industry Ministry Urged to Set Up an Independent Department for SMEs

TEHRAN (MNA) - Given the importance of small and medium-sized enterprises (SMEs), at least one independent department should be established in Ministry of Industry, Mining and Trade for them so that they will be specifically supported, a board member of Iran Chamber of Commerce, Industries, Mines, and Agriculture (ICCIMA) stressed.

Criticizing the same view toward the SMEs as that toward the large industries, Keyvan Kashefi said: "The rules and regulations are the same for both categories of industries, which puts double pressure on small and medium industries."

Today, about 80 percent of Iran's exports are made by about 1,200 large companies, and this has led to the focus of attention and resources, especially the governmental resources, on these industries; he lamented, adding, "Although large industries are drivers of the economy and should be considered, small and medium industries should not be neglected." He further considered the neglect of small and medium industries as the main harm to the country's economy.

Iran's Ministry of Industry, Mining and Trade's data

show that 31.187 trillion rials (about \$107.5 million) has been paid to small and medium-sized enterprises (SMEs) and semi-finished industrial projects with an over 60 percent physical progress during the first three months of the current Iranian calendar year (March 21-June 21).

The mentioned facilities, which are provided for renewing machinery, equipping production units, or completing semi-finished projects, have been paid in the form of bank loans to 917 projects and production units.

The program for offering bank facilities to SMEs and semi-finished projects was kicked off in February 2019 by the Industry Ministry in collaboration with the Central Bank of Iran (CBI). port to reach Europe via the Black Sea, he added that the corridor will also help Iran in particular Tabriz develop trade ties with European countries.

Moreover, the European nations can also export their goods to Iran through Batumi port, he said.

The Iran-Azerbaijan-Georgia transit corridor is considered one of the shortest routes and the most cost-effective corridors between Europe and Iran, he said, noting that the corridor is a proper alternate for existing routes.

The distance between Tabriz to Batumi on the map is 557 kilometers.

The Islamic Republic of Iran also conducts trade exchanges with European states via Turkey.

# Martyrdom of Iran Envoy Biggest Evidence for Saudi Crimes in Yemen

TEHRAN (IRNBA) - Yemeni Ambassador to Iran Ibrahim Dailami said on Wednesday that Ambassador Hassan Irlou's martyrdom was the biggest evidence for the crimes Saudi Arabia committed against the Yemeni people. Irlou who had tested positive for COVID-19 in Yemen last week passed away on Tuesday after coming back to Iran for remedy.

Speaking in the concession ceremony of Irlou, Dailami said that the late ambassador was the best person to represent Iran in Yemen and the Yemeni people would never forget his struggles for Yemen.

Irlou had been also suffering from injuries inflicted by chemical weapons used by the ousted regime of Saddam Hussein during the eight-year war between Iran and Iraq in the 1980s.

Iran's Foreign Ministry has said that he was brought back to Iran in an inappropriate condition due to a delay in required cooperation by some countries in the region.

Iran had contacted some states in the region to bring Irlou back to the country.

# **Sri Lanka Inks** \$251m Tea for Oil Debt **Deal With Iran**

TEHRAN - Iran and Sri Lanka and Iran on Tuesday signed a Memorandum of Understanding (MoU) to settle \$251 million worth of credit outstanding with Ceylon Petroleum Corporation (CPC) with supply of tea of equivalent value.

The Plantation Ministry and Iran's Ministry of Industries, Mines and Trade were the signatories of the MoU. Under the scheme, \$ 251 million outstanding from CPC to Iran's National Iranian Oil Company will be settled via the export of Ceylon Tea to Iran.

The Ministry of Plantation of Sri Lanka and the Ministry of Industries, Mines and Trade of the Islamic Republic of Iran agreed to formulate a scheme for the settlement of a sum of US\$ 251 Million outstanding from the Ceylon Petroleum Corporation to the National Iranian Oil Company by means of utilizing the said sum to facilitate the export of Ceylon Tea to Iran by signing a memorandum of understanding.

The MoU was signed Dr. Ramesh Pathirana, Minister Plantation of Sri Lanka and Alireza Paymanpak, Deputy Minister of Industry, Mine and Trade of Islamic Republic of Iran.

Iran is among the top 10 importing countries of Ceylon Tea for the past several decades. Ceylon Tea which had a market share of around 47% in 2016 dropped to around 25% in 2020 due to the economic sanctions resulting in banking restrictions. Due to U.S. sanctions imposed on Iran in November 2012 and with the absence of an accepted payment mechanism through the banking system, Sri Lanka tea exporters found it difficult to receive the export proceeds from Iranian buyers.

The proposed scheme is to seek the possibilities of operationalizing a mechanism to settle the long outstanding debt to the National Iranian Oil Company (NIOC) by Ceylon Petroleum Corporation (CPC) through increasing the export of Ceylon Tea.

Under this scheme, the Ministry of Finance is expected to release Sri Lanka Rupees of an equivalent amount of \$5m per month in settlement of the outstanding debt arising until the entirety is settled.

The Tea Board will then pay individual exporters in rupee at the central bank exchange rate.



"This scheme will not violate any UN or US sanctions since tea has been categorized as a food item under humanitarian grounds while none of the black listed Iranian Banks will be involved in the equation," Sri Lanka's Plantation Ministry said in a statement. The deal will neither bring foreign exchange to the country and non will go out, the ministry said.

Sri Lanka had exported \$14.5m of tea to Iran up to November 2021, up 0.39 percent from a year earlier.

Sri Lanka's Plantation Ministry said Ceylon Tea export to Iran had dropped from a peak of 38.42 million kilograms in 2013.

After signing the MoU, Paymanpak said that unfortunately oil has been the major trade item between Iran and Sri Lanka and the non-oil exports to Sri Lanka are less than \$100m.He added that unfortunately Sri Lankan business activists are not aware of Iran's economic capacities or its non-oil exports and he has tried to prepare the grounds for boosting cooperation during his visit.

He noted that a joint economic committee is to be first launched and then the two countries will move for the launch of the joint chamber of commerce.

He noted that Sri Lanka can be a good market for Iranian companies in the fields of petrochemicals and dairy products, and in return Iran can import some raw material but talks should be held on the price for materializing the deal.

Paymanpak noted that Iran can take advantage of Sri Lanka in production of agro machineries or assembling final products in this country as Sri Lanka can be a good gateway for Iran's products to the East Asia.

He reiterated that direct relation between business activists of Iran and Sri Lanka is the best solution for expansion of trade ties between the two countries and called for the launch of the joint chamber of commerce.

He went on to say that there are huge agro and mining resources in Sri Lanka that can create good opportunity for direct or indirect exports of Iranian products.

# **HOSCO Voices Readiness for** Indigenization of Marine Industries Needs

TEHRAN - The CEO of Hormozgan Steel Company (HOSCO) Mr. Ataollah Maroofkhani in meeting with the commander of Iran's Navy Rear Admiral Shahram Irani hailed the navy for providing security in the region and said outcome of this security is the efforts of Iranian industrialists in the economic front.

# South Pars Rich **Gas Output Exceeds** 700 mcm/d



TEHRAN (Shana) - Production and Operations Director of Pars Oil and Gas Company (POGC) said a daily production of 705 million cubic meters of rich gas has been realized at South Pars Gas Field.

According to Pars Oil and Gas Company, Alireza Ebadi stated that gas production from the 37 operational platforms of South Pars was going on avorably and according to the plans, adding "Considering the role of natural gas in the macroeconomic management of the country and the commitment of Pars Oil and Gas Company in providing 70% of the increasing demand for gas, especially in the cold season, we were able to go beyond the approved plan of the National Iranian Oil Company in recent days, with more than 100% of the required gas recovery." The official further noted that production of gas from the field stood at an average of 682 mcm in the month of Azar (the ninth month in the Iranian calendar which ends on December 21). He said that the daily gas production capacity of the joint gas field is 700 million cubic meters, and added: "We hope that with the completion of some wells of developing platforms and reaching the production capacity ceiling, this figure will be proportionate to the increase in annual gas consumption of the country next year."

# Iran, India Agree to Increase Freight Traffic Through Chabahar

TEHRAN (PressTV) - India has agreed to increase its freight transit through Iran to help more traffic pass through the strategic port of Chabahar, according to the Iranian transportation minister Rostam Ghasemi.

"We have had some good discussions on the issue and we agreed that freight transit through this path should increase," Ghasemi said in a briefing with reporters.

The comments come more than a week after Iran, India and Uzbekistan held a virtual meeting to discuss the situation on the Chabahar, Iran's only Ocean port located on the Sea of Oman where trade has plummeted after the takeover of the Taliban in Afghanistan.

Chabahar had been viewed as a major trade gateway between the Indian Ocean and Afghanistan and other landlocked countries in the Central Asia region.

Iran has invested heavily on construction of a railroad connecting Chabahar to the Afghan border while India has contributed financially to provision of port operation equipment in one of the terminals in Chabahar.

Ghasemi said that Chabahar has a capacity for processing 30 million tons of cargo per year, adding that Iran expects other parties involved in the project to increase their financial contribution to development work.

He said Iran will need to invest more on the transportation network supporting Chabahar, adding that railway connected to the port should reach northern Iranian areas bordering Central Asian countries.

The minister said that size of investment requires assurances from countries like India that freight traffic through Chabahar will increase.

He described previous agreements with India on Chabahar as imperfect, adding that Tehran and New Delhi should work to improve the deal.

# **Thailand Reimposes Quarantine for Travelers** BANGKOK (Dispatches) - Thailand reimposed mandatory coronavirus

# **Putin Warns West of Military Measures Over Ukraine Threats**



MOSCOW (AFP) - President Vladimir Putin warned that Russia was prepared to take military steps in response to "unfriendly" Western actions over the Ukraine conflict, in a sharp escalation of rhetoric.

The Russian president has for weeks accused the United States and the Washington-led NATO military alliance of stoking tensions near Moscow's borders, but these were his first comments hinting at potential conflict.

Putin told defense ministry officials that if the West continued its "obviously aggressive stance" Russia would take "appropriate retaliatory military-technical measures". Russia "will react toughly to unfriendly steps", he said, adding that he wanted to underscore that, "we have every right to do so".

The United States has been sounding the alarm since mid-November that Moscow could be planning a large-scale attack on its ex-Soviet neighbor Ukraine and has warned Putin of unprecedented sanctions.

Western governments have accused Moscow of amassing some 100,000 troops near its border with eastern Ukraine, where Kiev has been fighting pro-Russia separatists since 2014. Russia denies plotting an invasion and has demanded legal

guarantees over its security from the United States and NATO, demanding the alliance stop an eastward expansion. Last week Moscow presented demands to the United States and NATO saying the alliance must not admit new members or establish military bases in ex-Soviet countries. Putin said Tuesday that Russia was "extremely concerned" over what he said was US missile deployments in Poland and Romania, which he said would soon be capable of launching Tomahawk cruise missiles. "If this infrastructure moves further -- if US and NATO missile systems appear in Ukraine -- then their approach time to Moscow will be reduced to seven or 10 minutes," he said,

Georgia's jailed opposition leader and ex-president Mikheil Saakashvili rallied Tuesday vowing a "mass hunger-strike" to secure his release after doctors said he was tortured in custody.

Waving Georgia's five-cross flag and holding banners that read "Free Saakashvili!" protesters marched through the capital Tbilisi before gathering outside parliament for the rally timed to coincide with the politician's 54th birthday. Saakashvili's arrest exacerbated a political crisis

stemming from parliamentary polls last year that the opposition denounced as fraudulent.

It also spurred the largest anti-government protests in a decade. "Today, we are launching a mass hunger-strike that will not end until Mikheil Saakashvili is released from captivity," Nika Melia, the chairman of Saakashvili's United National Movement (UNM), said to applause. It was not immediately clear how many people intended to participate in the hunger-strike outside the UNM headquarters.

# Zuma Can Appeal **Return to Jail**

JOHANNESBURG (Dispatches) - South Africa's former president Jacob Zuma can appeal a court ruling last week that he should not enjoy medical parole and should return to jail.

High Court Judge Elias Matojane ruled last Wednesday that the September decision to place the 79-year-old medical parole was "unlawful".

The same judge on Tuesday decided to allow an appeal.

"In my view, this matter merits the Supreme Court of Appeal's attention," he said at the end of a virtual hearing. He said another court may find that Zuma should be treated with "compassion, empathy and humanity" because of his ill health and advanced age.

Chile's New President Pledges an Orderly Economy

SANTIAGO (Dispatches) - Chilean leftist Gabriel Boric pledged to maintain an "orderly economy" and to move swiftly on naming a Cabinet, a day after a sweeping electoral victory propelled him to become Chile's youngest-ever democratically elected president.

Boric, a former student protest leader who leads a leftist coalition and has pledged to overhaul Chile's economic model, firmly beat out far-right rival Jose Antonio Kast, who quickly conceded defeat, helping give certainty to the result.

The win marked another advance for Latin America's left, and bolstered talk of a new "pink tide" in the region, as raging poverty fanned by the coronavirus pandemic sways voters toward those who promise bigger government and higher social spending.

His rise - and the wider polarization of the vote - had rattled Chile's markets and spooked mining firms concerned about his rhetoric to "bury" the country's market-orientated economic model, push higher taxes and tighten environmental regulation. Boric, the 35-year-old former law student, had previously pledged to bury Chile's "neoliberal" economic model but in recent weeks softened his tone in an apparent nod to more centrist voters.

### **Romanian Crowd Tries to Storm** Parliament in Protest at COVID-19 Pass

BUCHAREST (Dispatches) - Romanian protesters tried to force their way into parliament on Tuesday, blocking traffic and vandalizing some cars in the capital Bucharest in an attempt to prevent lawmakers from making a COVID-19 health pass mandatory for workers.

Riot police were caught off guard when hundreds of protesters poured in through a yard gate, spray painting cars and forcing security staff to block the building's entryways. The protesters later left. Police did not use force.

While the ruling coalition of centrists and leftists is currently negotiating the terms of a health pass mandate, no such bill is on parliament's legislative agenda at the moment.

An estimated 2,000-2,500 people from across the country gathered outside parliament in the morning waving Romanian flags and chanting "Freedom," in a protest organised by the opposition ultra-nationalist Alliance for Uniting Romanians (AUR).

In October, Romanian senators narrowly rejected a bill requiring medical staff, public sector workers and those of large privately-owned firms to carry a COVID-19 health pass which was aimed at boosting vaccine uptake.

The coalition government is negotiating a new bill which would require most workers to show they are either vaccinated, have recovered from the virus or have a recent negative test, but have yet to agree on who pays for testing and for how long.

A number of people are reported to have died in the harsh conditions.

Western countries accuse Belarus of having engineered the migrant influx to pressure the bloc, which has imposed sanctions over the regime's crackdown on the opposition and independent media.

Belarus denies this and has urged the EU to take in the migrants.

Throssel called Tuesday on "both countries to urgently address this appalling situation in line with their obligations under international human rights law and refugee law."

Without access to the border, she said the UN team had interviewed 31 people who had arrived in Poland through Belarus between August and November this year.

"They described dire conditions on both sides of the border, with no or limited access to food, clean water and shelter, often amid freezing temperatures," Throssell said.

Throssell said most of those interviewed by the UN team described being "beaten or threatened by security forces" on the Belarusian side.

# Spain Extends Energy Tax Cuts to May 2022

MADRID (Dispatches) -Spain will extend a series of tax cuts brought in to provide relief to consumers hit by sky-high energy bills until May 2022, government spokesperson Isabel Rodriguez said on Tuesday. Extending the package of cuts, which were introduced in June and were due to expire at the end of the year, will have an impact of some 2 billion euros (\$2.26 billion) over the first months of next year, Rodriguez told

reporters after the weekly cabinet meeting.



Strong demand for power as economies emerge from the pandemic, plus infrastructure outages and low stocks

BEIRUT (Dispatches) - Lebanon needs to receive 12 to 15 billion dollars from its partners to kickstart its economic recovery and shore up fast-diminishing foreign currency reserves, Central Bank Governor Riad Salameh said Tuesday.

Lebanon is grappling with an unprecedented economic crisis branded by the World Bank as one of the planet's worst in modern times. More than 80 percent of the population lives in poverty and the currency has lost more than 90 percent of its black market value amid political squabbling that has delayed an agreement with the International Monetary Fund.

"Our quota in the International Monetary Fund is 4 billion," Salameh said in an AFP interview.

"If countries add to it, we could reach 12 to 15 billion, an amount that could help start Lebanon's recovery and restore confidence," he said.

Lebanon defaulted on its debt for the first time last year but political leaders have continued to resist key reforms demanded by donors to unlock necessary funds.

Meanwhile, the central bank's mandatory dollar reserves have been slashed by more than half, according to Salameh, who is widely viewed as a key culprit behind an economic crash many blame on central bank policies.

"The mandatory reserves are around 12.5 billion dollars," that the central bank can't spend, Salameh said, explaining that an additional \$1.5 billion in reserves had been freed up for central bank spending. The mandatory reserves stood at \$32 billion before the start of the economic crisis in 2019.

Salameh dismissed criticism blaming him for the crisis, saying that "had it not been for the central bank and its reserves, Lebanon would not have been able to carry on".

"The central bank deals with the outcome of the crisis, it is not the side causing it."

The fast-diminishing reserves are threatening a subsidy program that had initially covered fuel, medicine, flour and other key imports before it petered out.

The central bank can afford to finance partial subsidies on a few remaining key imports for "around six to nine months,"

if no additional measures are taken to combat the depreciation of the Lebanese pound, Salameh said.

Officially pegged at 1,507 to the greenback since 1997, the Lebanese pound sold for nearly 30,000 to the dollar on the black market earlier this month, a record low. The official fixed rate is "no longer realistic", Salameh said, while explaining that a unified exchange rate

Lebanon last year started IMF talks that were derailed due to differences between officials over the size of financial sector losses.

But IMF talks have relaunched in recent weeks during which Lebanese officials have agreed that financial sector losses amount to around \$69 billion.

"Lebanon is still in the stage of crushing numbers," said Salameh who is part of Lebanon's IMF negotiating team.

"The Lebanese side hasn't yet presented a plan to the IMF for discussion." Salameh, one of the world's longest-serving central bank governors, is facing judicial investigations in France, Switzerland and other European countries on suspicion of money laundering and illicit enrichment among other charges.

# World Bank Sees Malaysia's Economy Growing 5.8%

KUALA LUMPUR (Dispatches) - Ecnomic recovery in Malaysia is expected to gain momentum in 2022, with the World Bank projecting the economy to grow by 5.8 per cent, mainly driven by an acceleration in private consumption.

The Washington, DC-based institution said exports are projected to continue to expand, albeit at a slower pace, in line with the expected moderation in global trade growth and anticipation that it is to be broad-based, with recovery across all economic sectors.

According to the latest World Bank Malaysia Economic Monitor report titled "Staying Afloat" launched today, the forecast for the year ahead follows growth estimates of 3.3 per cent in 2021, which remains clouded by several downside risks, including new Covid-19 outbreaks and weaker-than-expected global and regional growth.

The World Bank noted that limited fiscal space remains a key challenge whereby the Federal Government revenue, which has been declining since 2013, is projected to reach 14.3 per cent of Gross Domestic Product (GDP) in 2022. The report also said that rigid operating expenditures, namely emoluments, retirement charges, and debt service payments, have grown markedly over time and are expected to take up two-thirds of Federal Government revenue next year, increasing fiscal rigidity and crowding out discretionary spending.

"The pandemic has further constrained Malaysia's already limited fiscal space. Government revenue is expected to decline while rigid expenditures remain high.

# Bangladesh, S. Korea Sign \$100m Loan Agreement

DHAKA (Dispatches) - A agreement on "Program Loan for Sustainable Economic Recovery Program (Subprogram)" has been signed between Bangladesh and Korea to provide budget support to mitigate the adverse impact of Covid-19.

Under the agreement, the Korea Eximbank will provide \$100.00 million to Bangladesh government to implement the project.

The loan will bear simple interest rate of 0.05% per annum while maturity period will be 40 years, including a grace period of 15 years.

The loan is aimed at recovering the economy by implementing various reforms in revenue collection system and design schemes to support entrepreneurs who have been adversely affected by Covid-19.

Md Shahriar Kader Siddiky, wing chief and additional secretary of the Economic Relations Division and Kim Tae-soo, Executive director of Korea Eximbank signed the agreement on behalf of respective governments.

Since 1993, the Korea Eximbank has been providing soft loans to various priority development sector projects in Bangladesh.



The Commerce Department said on Tuesday that the current account deficit, which measures the flow of goods, services and investments into and out of the country, accelerated 8.3% to \$214.8 billion last quarter. That was the largest shortfall since the third quarter of 2006.

Data for the second quarter was revised to show a \$198.3 billion deficit, instead of \$190.3 billion as previously reported. Economists polled by Reuters had forecast a \$205.0 billion deficit last quarter.

The current account gap represented 3.7% of gross domestic product. That was the largest share since the fourth quarter of 2008 and was up from 3.5% in the April-June quarter. Still, the deficit remains below a peak of 6.3% of GDP in the fourth quarter of 2005 as the

United States is now a net exporter of crude oil and fuel.

The wider deficit is not a problem for the United States given the dollar's status as the world's reserve currency. The third quarter likely marked a peak for the current account gap, though much would depend on the severity of the COVID-19 Omicron variant. The trade deficit narrowed sharply in October.

"Robust export growth in the fourth quarter suggests the balance has likely reached a cyclical trough and the latest trade data signals a narrower deficit in the fourth quarter," said Mahir Rasheed, a U.S. economist at Oxford Economics in New York. "Assuming a moderate impact from the Omicron variant in the first quarter, we look for stronger foreign consumption and moderating U.S. demand to drive the current account deficit lower next year."

> Imports of goods increased \$10.0 billion to a record \$716.4 billion, boosted by petroleum products and chemicals. Services imports rose \$12.6 billion to \$141.0 billion, mostly reflecting personal travel as well as sea freight and air passenger transport.

### Japan Upgrades Economic View for First Time in 17 Months

TOKYO (Dispatches) - Japan raised its overall economic assessment for the first time in 17 months in December, as consumers and companies have turned more optimistic about the outlook due to falling COVID-19 cases at home even amid risks from the omicron variant of the coronavirus.

Authorities raised their views on private consumption and business conditions, with the services sector underpinned by easing coronavirus restrictions, but flagged ongoing risks from supply constraints and raw material prices.

The world's third-largest economy shrank slightly faster than initially reported in the third quarter. But economists expect a rebound in the final quarter of 2021 after pandemic curbs were lifted by the end of September.

"The economy is picking up as severe conditions due to the coronavirus are gradually easing," the government said in its December economic report on Tuesday. The report underscores how Japan has so far managed to avoid the fast spread of



omicron seen in the U.S. and the U.K. In the U.S., the variant accounted for 73% of new cases last week, while Japan had confirmed fewer than 70 omicron cases in total as of last weekend.

The Cabinet Office said attention should be given to the new variant, but still sees the economy picking up in the short term. Supportive government policies and progress in the country's return to a semblance of normal life should help, it said.

Authorities raised their view on private consumption for the second month running. "We upgraded our consumption assessment given the further recovery in services ranging from restaurants to entertainment and other sectors, as well as the rebound in car (sales) amid eased supply constraints," a government official told reporters before the Cabinet approved the report.

The government also upgraded its view on business conditions after the Bank of Japan's quarterly tankan survey showed Japan's service-sector mood improved to a two-year high. Authorities also raised their employment assessment

for the first time in 15 months due to increased job postings.

The government downgraded its view on capital expenditure for the first time in 13 months. Firms' capital spending, especially on software investments, slowed in the third quarter, partly because a COVID-19 resurgence over the summer hampered business meeting opportunities, the official said.

Authorities also downgraded their views on housing construction for the first time in 27 months on weak housing starts.

The December report kept assessments on other economic elements such as production and prices unchanged. It also flagged downside risks from supply constraints and fluctuations in raw material prices, maintaining references seen in the November report.

To support the recovery further, parliament approved a record ¥36 trillion extra budget on Monday including payouts to households and companies.

"Additionally, Gazprom has traditionally shipped around 20% of its supply to Europe through Poland, but these flows have been inconsistent this year and driving up uncertainty about how much gas Europe will actually receive from Russia."

# **Foreign Shoppers Swarm Turkey After Lira Crash**

EDIRNE (Dispatches) - The sea of Bulgarian buses parked outside a market in Turkey's historic city of Edirne betrays the scale of the currency crisis impeding President Recep Tayyip Erdogan's path to a third decade of rule.

The mosque-filled city on Turkey's western edge was an early capital of the Ottoman Empire when it was expanding across the Middle East and Europe in the 14th and 15th centuries.

It is now the place where shoppers from Bulgaria and the Balkans -- themselves some of Europe's poorest countries -- go to stock up on everything from underwear to walnuts at a fraction of their cost back home.

"For us, the crisis is good, but it is very bad for the Turkish people," said tour guide Daniela Mircheva before boarding a bus back to her Bulgarian hometown of Yambol.

"We were in a similar situation maybe 10, 11, 12 years ago," the 49-year-old said, in reference to the 2008 global financial crisis. "It is very difficult."

Turkey's beleaguered lira has crashed under the weight of an unusual economic experiment Erdogan is conducting in a bid to boost support before elections due by mid-2023

Erdogan has pushed the central bank to slash interest rates in fervently-held belief that this will finally cure Turkey's chronic inflation problem.

It has -- as economists had universally predicted -- done the exact opposite. Consumer prices are climbing at an annual rate of more than 20 percent.

Some economists think this pace could accelerate in the coming months.

The lira has shed a third of its value since the start of November alone.

It was beginning to lose five percent a day until Erdogan announced new currency support measures Monday that managed to suspend the slide.

This means Mircheva can afford to pile a few extra jugs of sunflower oil on her bus packed with Bulgarian shoppers.

"It is half the price it is in Bulgaria. It is much cheaper for us, much cheaper," she said. But the mood among the market's Turkish traders is grim.

"It is humiliating," said Gulsen Kaya from behind her counter filled with sweaters and winter clothes. "Look at what he has done to Turkey!"

Erdogan is betting that a cheap lira will create exports-driven growth that puts Turkey on a path followed by China during an economic transformation that pulled millions out of poverty and created a new middle class.

He championed the poor when bringing his Islamic-rooted party to power against all odds in 2002.

Erdogan then surprised many by opening Turkey up to foreign investment and marshalling nearly a decade of vigorous growth.

Economists and diplomats -- as well as some Bulgarians -- struggle to understand why Erdogan has decided to reverse course so dramatically in the past few years.

"I think that the people who rule Turkey, if they do the things that I think they should do, then the lira will come back to the levels it was in the summer very, very quickly," Bulgarian shopper Tinko Garev said.



"I am very unhappy for the Turkish people because I realise what these cheaper prices mean for them.<sup>3</sup>

One senior Western official said the drop in Erdogan's approval ratings in most polls to as low as 30 percent had put the veteran Turkish leader "in political survival mode".

"You can choose not to believe (individual polls) but the trajectory is clear," the official, who spoke on condition of anonymity, said. "He is down to the very bottom of his base of support.'

Bulent Reisoglu has been running the Edirne market since it opened after moving from its original location in Istanbul 15 years ago.

He said the number of weekly shoppers filling his hangar-like trading center has ballooned from 50,000 to nearly 150,000 since the full effects of the crisis set in.

"The number of foreign shoppers have gone up four- or five-fold," he said. Yet the merchants are making less money because the extra sales are more than

offset by the depth of the lira's collapse.

"Our suppliers are sending us new price lists every week," market trader Utku Bitmez complained.

"All the raw materials come from abroad, from Europe, China and Italy," he said. The price of these products has doubled since last year.'

Reisoglu said he watches merchants nervously eyeing the latest lira exchange rates on their phones.

"We are in shock," the market manager said. "No one expected this big of a devaluation." The Bulgarian shoppers also seemed to have mixed feelings about getting such great deals.

"Local people cannot buy all these things," said Ilyana Todorova while shopping for clothes with her teenage daughter. "For ordinary people, it is no good."



LONDON (AFP) - All four of Big Ben's dials will be on display for the first time in four years as London rings in 2022, UK parliamentary authorities said on Tuesday.

The Great Clock and the Elizabeth Tower have been shrouded in scaffolding since 2017 for extensive renovation work which has also largely silenced the trademark bongs and chimes of the famous bell inside it. But the restoration is nearly complete, and Big Ben will strike 12 for the last time using a temporary mechanism before the original is back in place early in the new year.

The 11.5-tonne Victorian-era mechanism removed from the tower overlooking the River Thames at one end of the UK parliament to protect it from the dust and debris created by works on the 96-metre-high tower.

# U.S. to Be World's Biggest LNG Exporter in 2022

LONDON (Dispatches) - The

United States is set to become the world's biggest liquefied natural gas (LNG) exporter in 2022, surpassing Qatar and Australia, and may hold that title for years to come. In a year when China and

other large economies in Europe and Asia scrambled to source enough supply for heating and power generation, the United

States was sitting on a bevy of supply - one that will grow in coming years.

Global LNG demand has hit record highs each year since 2015, due mostly to surging demand in China and the rest of Asia. Much of that global appetite has been met by steadily rising U.S. LNG exports, which have reached new records every year since 2016 and is poised to continue in 2022.

The U.S. Energy Information Administration projects U.S. LNG exports will reach 11.5 billion cubic feet per day (bcfd) in 2022. That would account for roughly 22% of expected world LNG demand of 53.3 bcfd next year, according to analysts at Goldman Sachs and would outpace both Australia and Qatar, the two largest exporters at present.



The growth of U.S. LNG exports helps people worldwide "get greater access to an abundant and reasonably-priced product that helps ease the world's current supply crunch," said Charlie Riedl, executive director for the Center for Liquefied Natural Gas (CLNG).

Gas prices around the world repeatedly reached record highs in 2021 as utilities tried to lock in LNG cargoes to rebuild low stockpiles in Europe and meet heavy demand in Asia. U.S. gas futures also rose, hitting a 12-year closing high in October. But after mild weather in early December, U.S. natgas stocks were replenished, and prices overseas are now 11 times higher. The oil and gas industry touts natural gas as a less polluting fossil fuel than coal or oil. Gas burns more cleanly, so switching from coal lowers emissions, although unburned gas or methane released to the atmosphere contributes heavily to global warming. Utilities around the world have been using gas to keep power prices relatively low and maintain reliable electric grids as they meet rising energy demand while transitioning from coal to cleaner renewables. However, some countries, including China, have boosted coal production due to the lack of available LNG.

'The situation will continue unless the flood waters come from the Iranian side," Mr Hamid said. Iraq needs Iran to "co-operate to open the flows of water from its Tayeb and Dureij rivers," Mr Hamid added. Earlier this month the ministry of water resources completed procedures to file a lawsuit with the International Court of Justice against Iran's water policy.

But action in court will depend on decision-makers in Baghdad.

The ministry also issued a warning that Iraq's Tigris and Euphrates rivers could dry up by 2040 because of declining water levels and climate change. "The rate of decline in water imports to Iraq has begun gradually and will decrease to 30 per cent by 2035," the Ministry of Water Resources said.

The country's water inflows during the summer are estimated to be about 40 billion cubic meters. A decrease in supply to 30 per cent of normal levels will result in Iraq receiving 11 billion cubic meters annually, the report said.

Jack Grealish and Phil Foden played in City's 7-0 thrashing of Leeds United in midweek but both were unused substitutes in the 4-0 victory at Newcastle United, with Guardiola saying the decision to drop them

was not to keep the squad fresh.

The Telegraph newspaper published a picture of the England duo on a night out after the Leeds game. "No, not rotation," Guardiola said. "I decided on this team because they deserved to play ... and not the other ones.

"At Christmas time I pay a lot of attention to behavior on and off the pitch. And when off the pitch isn't proper, they're not going to play.

"We have to be focused all the time because of distractions at Christmas time and everything that happens - you have to still be focused," Guardiola added. The Premier League leaders next play Leicester City on Dec. 26.

### **Bencic**, Jabeur Test Positive For COVID-19

ONDON (Dispatches) - Olympic Ltennis champion Belinda Bencic and Tunisian Ons Jabeur have tested positive for COVID-19 following their trip to Abu Dhabi, both said on Tuesday, a day after Rafa Nadal announced he had also tested positive.

Bencic, Jabuer and Nadal had travelled to Abu Dhabi to play in the Mubadala World Tennis Championship exhibition event last week.

# **Tottenham to Appeal Incredible Expulsion From Europe**

ONDON (Dispatches) - Tottenham Lmanager Antonio Conte described UEFA's decision throw his side out of the Europa Conference League as "incredible" and suggested Spurs will launch an appeal through the courts.

Spurs were handed a 3-0 defeat for their final group stage match against Rennes after the match was postponed due to a wave of positive coronavirus cases among Tottenham players and staff.

A new date before the deadline of December 31 could then not be agreed between the clubs. Tottenham had needed to win their final game against the French side, who had already secured top spot in the group, to progress ahead of Vitesse Arnhem.

"It is not definitive, but there is another step to confirm or not this incredible decision," Conte said on Tuesday. "We are very, very confident for the next step and I repeat we deserve to play the qualification on the pitch, not in the court.

"I can't accept this. We are very, very disappointed with UEFA for this decision." Should Spurs fail to overturn that decision, one chance for Conte to end the club's trophy drought stretching back to 2008 will have gone.

But the Italian has another opportunity in the League Cup with Wednesday's quarter-final against West Ham to go ahead despite rising Covid case numbers across London that have forced mayor Sadiq Khan to declare a "major incident" in the English capital.



### 01 . (( . Shiffrin Secures 72nd World Cup

ONDON (Dispatches) - American Mikaela Shiffrin crushed the opposition in Tuesday's giant slalom in Courchevel in France to claim her 72nd alpine skiing World Cup victory.

The 26-year-old was in a league of her won in the opening run in the French resort and kept things under control in the second to clinch her third World Cup win this season and second in a giant slalom.

Shiffrin clocked a combined best time of two minutes 15.35 seconds to beat Sweden's Sara Hector by 0.86 and Swiss Michelle Gisin by 1.08.

The result took her to the top of the overall World Cup standings on 670 points, 35 ahead of Italian Sofia Goggia, who had taken the lead after a super G-downhill double in Val d'Isere last weekend.

"Today was quite a difficult one after the last weeks, pushing the schedule hard. It's been a lot just to get here," said Shiffrin, who also raced in the super-G in Val d'Isere.

"I'm not full tank right now. But tough, very good day."

Switzerland's Lara Gut-Behrami, the giant slalom world champion, and Austrian Katharina Liensberger, the slalom world champion as well as New Zealand' Alice Robinson had to sit the race out after testing positive for COVID-19.
