National Rights Not to Be Sacrificed for **Fake Deadlines**

TEHRAN - Iran has entered the 7th round of talks in Vienna with clear demands and proposals and is ready to engage as long as needed, but will not sacrifice the nation's rights for the sake of deadlines, senior Iranian diplomat said.

"The Islamic Republic has come to Vienna with full seriousness and is negotiating with transparent demands and proposals," the source told Press TV on the condition of anonymity on Wednesday.

The country, the source added, "stands prepared to continue intensive talks as long as needed, [but] it will not be ready to sacrifice its principled demands and the Iranian nation's rights for mere artificial deadlines or time tables."

Meanwhile the European parties engaged in the Vienna talks on the revival of the 2015 nuclear deal have called for an immediate end to the current round of negotiations, a source said.

The informed source told Tasnim on Wednesday that the European representatives in Vienna have urged an immediate conclusion of this round of negotiations. See Page 7

Tehran Ready to Host 10th Global Summit on Urban Tourism

TEHRAN - Tehran Mayor Alireza Zakani has written to the World Tourism Organization (UNWTO), voicing the Iranian capital's readiness to host the United Nations specialized agency's 10th Global Summit on Urban Tourism.

Meanwhile, Iran's Deputy Minister of Cultural Heritage, Tourism and Handicrafts Ali Asghar Shalbafian, who was also present in the meeting, outlined Tehran's latest plans to develop its tourism industry, saying the country's new administration attaches special significance to this sector. Gov't Seeks Next Year Budget Without Deficit, Inflation



TEHRAN - President Seyed Ebrahim Raisi says, "The next year budget is the first important financial document to be submitted to Majlis in this government, adding that the government wants this budget to have no deficit and inflation and to include economic growth".

Speaking in the meeting of the government and the Majlis on Wednesday, Raisi said, "We consider consulting with our friends in the Majlis and experts as an asset for us."

Referring to the priority of a bill over a plan in the statements of the Supreme Leader of the Revolution in a meeting with the members of the Islamic Consultative Assembly, the President emphasized, "Sometimes the concerns of the parliament members are presented in the form of a plan; this is the right of the representatives, but if the plans are drafted using the opinion of experts and government officials, they will become law with more richness".

While emphasizing the clarification of the provisions of the Sixth Development Plan, Ayatollah Raisi said, "The next year budget is the first document that is to be submitted to the parliament. The head of the Plan and Budget Organization will take advantage of the opinions of MPs to draft a budget bill. The government wants the 1401 budget not to have deficits and inflation and to have economic growth." See Page 7

Washington Impeding Global Development Goals

TEHRAN - Iran's ambassador and permanent representative to the United Nations (UN) has blasted the US for the imposition of unilateral sanctions against various countries, saying the coercive measures have undermined global development goals at a time that the world is struggling to contain the coronavirus pandemic.

Majid Takht Ravanchi made the remarks in a statement at the 45th Annual Meeting of Ministers for Foreign Affairs of the Group of 77 and China in New York on Tuesday, a group which is the largest intergovernmental organization of developing countries in the world body.

Takht Ravanchi said the U.S.-imposed economic sanctions are in defiance of multilateralism that is needed to fight the coronavirus, and the lack of decisive international action to counter those illegal measures has rendered the issue of sustainable development "meaningless." See Page 7

21 States Among Iran Target Markets for Export

TEHRAN (IRNA) - Some 21 countries, including members of the Eurasian Economic Union (EAEU), neighboring states, African nations, and Far East countries, are among export destinations and priorities of the Islamic Republic of Iran, an official says.

Deputy Chairman of Iran's Trade Development Organization for export development Farhad Nouri made the remarks in the national seminar of "Eurasia: a bridge to global trade," noting that the organization has prepared 10 plans for expansion of trade ties with 21 prioritized countries, and that the program will go into effect one year from now.

Referring to the share of government in economy in terms of setting laws, he argued that governments are not good traders; so, they should stop competing with private sector and play the role of a facilitator to invest in infrastructure.

Export and trade enterprises, businesses and overseas problems are three main areas of the 10 plans scheduled for four years later to double Iran's trade indices, the official added. See Page 7

Iran Delivers 2m Barrels of Condensate To Venezuela

TEHRAN (PressTV) - Venezuela swaps its heavy oil for Iranian condensate to improve the quality of its tar-like crude. Venezuela's state-run firm Petroleos de Venezuela (PDVSA) has received 2 million barrels of condensate from Iran, S&P Global Platts reports.

The cargo was expected at the Jose terminal in northeastern Venezuela between Nov. 27-29, the financial news provider said, citing PDVSA's internal production reports.

PDVSA had received 2 million barrels of condensate from Iran at end-September and another 2.1 million barrels on Oct. 25, it added.

Venezuela swaps its heavy oil for Iranian condensate to improve the quality of its tar-like crude. This allows PDVSA to minimize cash payments since the U.S. has blocked the company from using US dollars.

Like Iran, which is also subject to illegal U.S. sanctions, the South American country is using innovative methods to boost its oil exports.

The sanctions on both nations have crimped their oil sales in recent years, spurring Iran to support Venezuela, including through shipping services and fuel swaps.

UAE to Send a Delegation to Iran Soon

Gov't to Remove Sanctions Through Dignified Negotiations

TEHRAN (IRNA) - Majlis Speaker Mohammad Baqer Qalibaf on Wednesday expressed hope that President Ebrahim Raisi and his cabinet members will do their best to remove the oppressive sanctions through dignified negotiations.

Qalibaf made the remarks speaking during the joint meeting of Iran's legislative and executive branches of the Islamic System.

This joint meeting was held on the occasion of Azar 10th (December 1), which marks the National Parliament Day in Iran.

Addressing President Raisi, Qalibaf expressed certainty that Raisi's government will with effort be able to restore Iranian's rights and remove the oppressive sanctions.

The Speaker also said that the rights of the nation will be restored with a good and fair agreement, so that oppressive sanctions will be lifted.

He added, "I am sure that with the efforts made in the field of foreign policy, the rights of the nation will be restored with a good and fair agreement and the oppressive sanctions will be lifted from the shoulders of the people."

Qalibaf said in the joint meeting of the legislative and executive branches of government: "More than one hundred days have passed since the beginning of the thirteenth administration, and I testify that the President has made a militant effort." Referring to the measures taken by the government to control the outbreak of COVID-19, Qalibaf said: "The government reduced the casualties from 700 to 70 in less than 70 days, and this was not possible except by virtue of efforts of the



government and the support of the parliament in providing funds."

He added: "The relationship between the 13th administration and the 11th parliament should be exemplary for the future and our cooperation is undoubtedly responsible. The parliament considers itself as source of help for all members of the cabinet and at the head of it, the president to solve the people's problems."

Qalibaf continued: "We must trust the expert opinions of the lawmakers and consider them as our companions, because they are the representatives of the people and among the people." In this regard, we have expectations from the administration. Law enforcement, implementation of budget and program provisions, addressing the issue of stock exchange, livelihood, employment, housing, youth and raising the purchasing power of the people are the expectations of the parliament from the government."

The joint meeting of Iran's Legislative and Executive branches of Islamic System was held in Tehran with participation of the heads of the two branches, as well as Iranian parliamentarians, ministers, and vice presidents.

Commander Warns Enemies Against Smallest Act of Aggression

TEHRAN (PressTV) - A senior Iranian commander says that the Islamic Republic is prepared to deliver a "harsh response" to even the slightest aggression by the country's enemies.

"We will deliver a harsh response to the enemies' smallest [aggressive] move," Brigadier General Amir-Ali Hajizadeh, commander of the Aerospace Division of Iran's Islamic Revolution Guards Corps (IRGC), said on Tuesday.

"Today, Iran's security and [its] missile and defensive power are stable and exemplary," he added. He asserted that the country's defensive prowess, including its missile and drone capabilities, had turned into "a thorn in the side" of the adversaries.

Hajizadeh noted how the country's adversaries, themselves, acknowledge the premium status of Iran's defensive power.

The commander cited the country's successful 1980-88 confrontation against the Western-backed invading military of former Iraqi dictator Saddam Hussein as a case in point for the Islamic Republic's decisiveness and devotion to preserving its sovereignty and security.

"Today too, we can triumph against the enemy's economic and media war through steadfastness and determined struggle," he noted.

The remarks came as the Israeli regime keeps beating the drums of war with Iran.

Talks Between AEOI Head, IAEA Chief "Constructive"

TEHRAN (MNA) – A member of Iran Parliament's National Security and Foreign Policy Commission said that the recent talks between head of Atomic Energy Organization of Iran and International Atomic Energy Agency Chief were 'constructive'. Speaking about the meeting of Parliament National Security and Foreign Policy Commission with the head of Atomic Energy Organization of Iran (AEOI) Mohammad Eslami, member of Parliament National Security and Foreign Policy Commission on Tuesday and submitted a comprehensive report on the recent visit of IAEA Chief Rafael Grossi to the Islamic Republic of Iran. Officials of the Islamic Republic of Iran in a meeting with the Director-General of the International Atomic Energy Agency (IAEA) stressed that the Agency must refrain from politically-motivated approaches, he emphasized.

Iran expects the IAEA to carry out its technical and professional supervisions properly and must refrain from making politically-motivated comments, he said, adding that this issue has been one of the important issues brought up by Iranian officials and they deemed it as necessary to remind the issue to the IAEA Director-General. Also, Iranian officials stressed in their recent meeting with IAEA Chief Grossi that the IAEA should not be under the control

of oppressive and bullying powers and should perform its expert-level duties within the framework of law, Azizi added. The Islamic Republic of Iran stressed in the meeting between AEOI and the IAEA chiefs that "Strategic Action Plan

to Counter Sanctions and Protecting Rights of Iranian People" piece of legislation as approved by the Iranian lawmakers last December must be strictly implemented, the lawmaker quoted AEOI head Mohammad Eslami as saying.

They rushed to Raisi upon seeing him and put forward their demands about medicines and treatment challenges of their loved ones.

Raisi expressed sympathy with them and promised that his administration will do its best to resolve problems of people suffering from specific diseases including SMA patients.

Spinal muscular atrophy (SMA) is a rare neuromuscular disorder that results in the loss of neurons and progressive muscle wasting. The US sanctions have hampered Iran's efforts to import highly-needed medical supplies.

Tehran Sympathizes With Azerbaijan Over Copter Crash

TEHRAN (Tasnim) – The Iranian Foreign Ministry's spokesman sympathized with the Republic of Azerbaijan over the fatal crash of a military helicopter. TEHRAN - Thousands of Iranians travelled to Turkey recently for shopping during Black Friday sales, as the American commercial tradition has spread throughout the world.

The spokesman of Iran's customs, Rouhollah Latifi told local media that 16,759 crossed land borders to turkey in what he said was an unprecedented rush to take advantage of sales as quality consumer goods in Iran are more expensive.

Latifi said that almost all travelers to Turkey in a two-week period returned to Iran from November 27-29, which proves they crossed the border for shopping purposes.

Tourists traveling to Turkey's Mediterranean coast mostly use charter flights.

Although international clothing brands are sold in luxury malls in Iran, prices are much higher than in open economies like Turkey where every brand has its own retail outlets and large department stores have sales.

Starting Capital Requirements for Offshore Banks to \$5m Lowered

TEHRAN (PressTV) - The Iranian government has persuaded the country's central bank to significantly lower the starting capital requirements needed to set up an offshore bank in free trade zones amid efforts to boost foreign investment in those regions.

Government's top man on free trade zones Saeed Mohammad said on Tuesday that investors and lenders will be able to establish an offshore bank in the Iranian FTZs with a starting capital of \$5 million.

The figure is 30 times lower than a previous minimum set in the law governing offshore banks in Iran, said Mohammad.

He criticized those laws and said they had deterred investment from the FTZs.

"When some people in Iran declared the starting capital at \$150 million, it basically meant that setting up offshore banks in the country would be impossible," Mohmmad was quoted as saying by ILNA news agency.

The change in law comes amid Iran's efforts to boost investment and manufacturing activity in free trade zones where laws and regulations are less stringent compared to the mainland.

Iran hopes higher trade and manufacturing activity in its FTZs can help the economy recover from the economic impacts of the coronavirus pandemic and the sanctions imposed by the United States.

Mohammad, a former commander of Iran's elite IRGC military force, said that offshore banks in the Iranian FTZs will be able to process funds belonging to Iranian nationals living abroad.

He added that the government had received numerous requests for setting up offshore banks in recent months, adding that Iran's central bank will soon issue guidance on how the process can be regulated.

Iranians Abroad to Be Facilitated

TEHRAN (IP) - The Deputy for International Affairs of Iran's Judiciary says Iranians abroad who seek investments in the country should be facilitated.

The Iranians abroad who have innovation plans must be provided with the necessary space, based on their talents as a precious asset, Kazem Gharibabadi told reporters following a Joint meeting held to discuss the issue of Iranians abroad. The joint meeting was held in the presence of the Judiciary's Deputy Minister for International Affairs, the Secretary of the Human Rights Headquarters of the Islamic Republic of Iran and some other related organizations, including Iran's Parliament. Gharibabadi said: "By the sublime order of Iran's Judiciary Chief, Gholamhossein Mohseni-Ejei, consular services are provided to Iranians abroad, and the judicial authorities should not issue any ruling in this regard." Elsewhere in his speech, he recalled the issue of Iranians imprisoned abroad, he said constant negotiations were being held with the relevant authorities in the target countries to solve the problems of Iranians imprisoned abroad.

"Iran offers services to the families of some of the prisoners, who are inside the country to meet their livelihoods."

The Joint meeting to discuss Iranian issues living abroad was held on Tuesday in the Ministry of Foreign Affairs with Kazem Sajjadi, the Deputy for Foreign Affairs with the Deputy for International Affairs of Iran's Judiciary Kazem Gharibabadi.

TEHRAN - Iran has opened its first trade center in Syria amid efforts to boost economic exchanges between the two allied countries.

The center was opened in the Free Zone of the capital Damascus on Tuesday in a ceremony attended by visiting Iranian trade minister Seyed Reza Fatemi Amin, according to a report by Syria's official SANA agency.

The report said that the Iranian trade center will host offices of major Iranian trade and manufacturing companies, including those active in agriculture and construction activities.

Keyvan Kashfi, a businessman watching over private sector trade between Iran and Syria, told Iran's IRNA agency that the center will help boost the presence of Iranian companies in Syria at a time the Arab country is seeking increased foreign investment to emerge from nearly a decade of terrorism and war.

Iran has declared its full support for Syria's reconstruction efforts. Fatemi Amin, who also heads Iranian government's departments on mines and industries, reiterated the pledge on Tuesday as he visited a number of factories closed by the war in the Adra region on the outskirts of Damascus.

The minister said Iran will be ready to help Syria rebuild its manufacturing sector, especially the once-booming textile industry in the Arab country.

On the third and final day of his trip to Syria, Fatemi Amin also held a key meeting with Syrian Prime Minister Hussein Arnous on Tuesday while he also opened a second trade fair dedicated to the Iranian companies in Syria.

Meanwhile Fatemi-Amin said that Iranian companies are ready for reopening the halted industries in Syria and also putting up joint industries.

Fatemi-Amin said that the objective of his visit of Syria was surveying the



supportive capacities for restarting the Syrian industries, especially the textile industries, and helping them regain their economic status that was lost in Syria's war against terrorist.

In order to increase the joint investments and exchange experience, there have been consultations between the two countries' officials, so that after supporting Syria in the post-crisis era, the two countries' trade volume will increase to a more logical level, he added.

During this visit, four cooperation documents were signed between the two countries, said an official at the ministry.

The Iranian Industry, Mining, and Trade Fatemi Amin in his visit to Syria met and held talks on the industrial cooperations between the two countries with the Syrian minister of economy and foreign trades, said the Deputy of the Iranian Industry, Mining, and Trade Minister Alireza Peyman-Pak on Wednesday.

He added that four cooperation documents were signed during the trade committee and industrial committee sessions between the two countries.

Elsewhere in his remarks, the official pointed out that the Iranian minister on his visit to Syria visited several places including Iran House of Innovation and Technology and Iran's trade center in Damascus, as well as the Syrian-Iranian Automobile Manufacturing Company (SIAMCO) and Kaveh Glass manufactory in Adra Industrial City.

Majlis Trying to Alleviate Economic Problems

TEHRAN (IP) -Head of the Iranian Parliament's Economic Commission says the 11th Parliament has put on the agenda plans that can alleviate part



of Iran's economic atmosphere in the short term. Mohammad-Reza Pour-Ebrahimi stated that one of the plans of the 11th administration was the plan for the justice shares, which was put on the agenda of the Economic Commission.

"In the field of macroeconomic issues, tax system reorganization and the bill on empty houses' tax was approved to reduce the rental price in the country," he noted. "Completion of the VAT law was another measure that was finalized after four years and its implementation is on the agenda. Amendments to the anti-trafficking

law are also in the final stages," he added. "The stock market is a highly diverse market in which people participate with short-term and risktaking investments and undergo these fluctuations; in Iran, due to the lack of proper infrastructure and accurate information, new events are taking place in the capital market, and people think that they will make huge profits in a very short period of time while this market is directly related to the general economic conditions," he said.

The anniversary of the martyrdom of Martyr Modarres is named national day of the parliament in Iran. Seyed Hassan Modarres (c. 1870 - December 1, 1937), confronted conspiracies and plots which were being hatched by the colonial powers to gain dominance in the strategic important region. "The news coming from the Program and Budget Organization indicates that the organization has made changes, and we hope to see a budget plan with a minimized balance deficit," Pour-Ebrahimi concluded.

Energy Ministry Only Wants Cash Not Goods From Iraq *IRAN NEWS ECONOMIC DESK it can pay major part of Iran's debts.*

TEHRAN - Head of the Iran-Iraq Joint Chamber of Commerce Yahya Al-e Eshaq says Iran's energy ministry does not accept goods instead of cash for the sale of electricity to Iraq and it insists on getting money from Iraq.

Speaking to ILNA, Al-e Eshaq said energy ministry should talk with Iraqi officials for return of its money for the sales of electricity to get favorable result, adding that the ministry does not accept goods instead of money and it insists on getting its money in cash. He noted that Iran's frozen money in Iraq is estimated at between 5 to 7 billion dollars and the total amount of sold gas to Iraq by the energy ministry has been on the basis of dollar.

On the release of the frozen money from Iraq, he said Iraq owes Iran some certain amount of money which it has delayed in repayingt because of some conditions and it seems this country is currently less under pressure for repaying Iran's debts and the talks between the two countries are bearing fruits. Therefor Iraq will pay major part of Iran's money, he noted.

He noted that Iraqis had financial problem and been under the U.S. pressures which hindered paying their debts and currently the political pressures have reduced, and on the whole the country is now in a condition that Al-e Eshaq added that on how the money is being paid, the energy ministry should talk with Iraqi officials to get results. He reiterated that energy ministry does not accept goods in exchange for its money and it insists on getting cash.

He noted currently no deadline has been set for the return of money and Iran does not want to put Baghdad under pressure for repaying its money and by the way Iraq is not the country dodging from repaying its debts to Iraq.

He also refuted reports on Iran's cutting electricity supply to Iraq, adding that Iraq is in dire need of Iran's electricity and Iran has no reason to cut the power supply.

Al-e Eshaq also reacted to the proposal for the launch of economic union between Iran, Turkey and Iraq and said if it happens, it will have great positive impacts but this needs a strong determination by all parties.

On Monday it was reported a spokesman for the Iraqi Ministry of Electricity has said his country is ready to pay back its debt for imports of gas and electricity to Iran.

"The Ministry of Electricity is ready to pay back its debts to Iran based on the agreement of the delegations that previously visited Tehran. They money is a weight on our shoulders that we have to pay to Iran," Ahmed Musa told Baghdad al-Yawm news agency.

Putin Hits Back as NATO Warns Moscow Against Attacking Ukraine



RIGA (Dispatches) - Russia would pay a high price for any new military aggression against Ukraine, NATO and the United States warned on Tuesday as the Western military alliance met to discuss Moscow's possible motives for massing troops near the Ukrainian border.

President Vladimir Putin countered that Russia would be forced to act if U.S.-led NATO placed missiles in Ukraine that could strike Moscow within minutes.

Ukraine, a former Soviet republic that now aspires to join the European Union and NATO, has become the main flashpoint between Russia and the West as relations have soured to their worst level in the three decades since the Cold War ended.

"There will be a high price to pay for Russia if they once again use force against the independence of the nation Ukraine," NATO Secretary General Jens Stoltenberg told reporters.

U.S. Secretary of State Antony Blinken echoed Stoltenberg, saying: "Any escalatory actions by Russia would be a great concern to the United States.

Germany Jails Iraqi **Jihadist for Life**

FRANKFURT (AFP) - A Frankfurt court on Tuesday handed a life sentence to an Iraqi man who joined the Islamic State group for genocide against the Yazidi minority, in the first verdict worldwide to use the label.



Taha Al-Jumailly, 29, was found guilty of genocide, crimes against humanity resulting in death, war crime aiding and abetting war crimes and bodily harm resulting in death after joining IS in 2013.

Proceedings were suspended as the defendant passed out in court when the verdict was read out. The Yazidis, a Kurdish-speaking group hailing from northern Iraq, have for years been persecuted by IS militants who have killed hundreds of men, raped women and forcibly recruited children as fighters.

Moqtada Sadr's Bloc Declared Biggest Election Winner

BAGHDAD (Dispatches) - Iraq's Shiite cleric Moqtada Sadr was Tuesday confirmed the biggest winner of last month's parliamentary election that had sparked charges of voter fraud from pro-Iranian factions.

Sadr's movement won 73 out of the assembly's 329 seats, the election commission said, after a lengthy manual recount of hundreds of ballot boxes.

A distant second with 17 seats was the Fatah (Conquest) Alliance, the political arm of the pro-Iran Hashed Al-Shaabi former paramilitary force, which is now integrated into Iraq's state security apparatus

Hashed leaders had rejected the preliminary result, which was sharply down from their 48 seats in the outgoing assembly, as a "scam," and their supporters have held street protests chanting "No to fraud."

Their activists have staged sit-in protests outside Baghdad's ultra-secure Green Zone district, where the government, the assembly and many foreign embassies are located.

Sudan Security Forces Fire Tear Gas at Demonstrators

KHARTOUM (Dispatches) - Sudanese security forces fired tear gas at protesters rallying against last month's military takeover and a deal that saw the prime minister reinstated after his ouster in the coup, witnesses said

Thousands of demonstrators gathered in central Khartoum and marched on the presidential palace when security forces fired tear gas to disperse them, they said. Security forces were stationed around the palace to prevent demonstrators rom approaching.

"No partnership, no negotiation, no legitimacy," protesters chanted, urging the military "to go back to their barracks".

"I'm here to demand the fall of military rule," demonstrator Mohamed Alaaldin told AFP.

Sudan's top general, Abdel Fattah al-Burhan, seized power and detained Prime Minister Abdalla Hamdok on October 25, but after international condemnation and mass protests he reinstated the premier in a deal they signed last week.

Critics lambasted the agreement as "whitewashing" and accused Hamdok of 'betrayal" as pro-democracy activists vowed to maintain pressure on the military-civilian authority.

The Sudanese Professionals Association, an umbrella of unions which called for Tuesday's protests, accused Hamdok and Burhan of seeking to "reproduce the former regime" of president Omar al-Bashir who was ousted in April 2019 following mass protests.

"Taking to the streets is a clear and decisive response to the putschists" nonsense," said the SPA, which was also instrumental in the anti-Bashir protests. Hamdok, who has been prime minister in the transitional government since the ouster of long-time autocratic ruler Bashir, has defended the deal which

was signed on November 21. He has told local media he had partnered with the military to "stop the bloodshed" and to "not squander the gains of the last two years'

Analysts have warned that ---in a country still recovering from decades of war and chaos, and where most parties have armed wings — political disputes could spark a dangerous escalation. On November 7, Prime Minister Mustafa Al-Kadhemi — leader of the outgoing government ---escaped unhurt when an explosive-packed drone hit his Baghdad residence. The attack was not claimed by any group.

Petronas Posts Q3 Profit, Sees Modest Demand Growth

KUALA LUMPUR (Reuters) - Malaysia's state energy firm Petroliam Nasional Berhad, or Petronas, swung to a third-quarter profit on higher prices and demand, and forecast a modest recovery in demand. The company reported third-quarter profit of 16.3 billion ringgit, compared with a loss of 3.4 billion ringgit in the year-ago quarter.

Revenue rose 50% to 61.8 billion ringgit, mainly due to higher average realized prices, the company said.

"The current trajectory of the oil and gas industry is expected to continue, given modest recovery in demand underpinned by improvements of economic activities globally," the company said in a statement.

Growth during the three months through September matched the median forecast among nine economists surveyed by Bloomberg. The seasonally and working day-adjusted figures showed an expansion of 2.7% in the last quarter from the previous three months, when gross domestic product surged 22% as the economy bounced back from the worst phase of the pandemic. The lira weakened after the data release, trading 0.5% lower at 12.8884 against the dollar at 11:47 a.m. in Istanbul. The currency has hit a series of record lows in recent weeks as the central bank has embarked on a cycle of interest-rate cuts that have turbo-boosted growth but hit incomes and shaken confidence. Investors have warned against further easing, arguing that uncontrolled inflation would ultimately act as a brake on growth, and even drag the economy into recession.

"With the current acute lira selloff akin to the 2018 episode which triggered a recession, our expectation is for the growth momentum to markedly weaken in the quarters ahead owing to higher FX volatility and a decline in purchasing power," Ehsan Khoman, head of emerging market research for Europe, Middle East and Africa at MUFG Bank in Dubai, said after the data.

Khoman said growth would slow from a projected 8.8% for this year to 3.4% in 2022, with the risk firmly on the downside. He predicted that the central bank would push ahead with cuts for

the same quarter last year. The projected growth is slower than 20.1 percent growth in the previous quarter - which largely reflected a bounce back from last

year's crash – but marks a fourth straight quarter of expansion. The recovery is "led by the services sector, with individual mobility back to pre-COVID levels, and ultra-accommodative

financial conditions," as well as higher government expenditures, said Gaura Sen Gupta, an economist with IDFC First Bank in Mumbai.

While she said it was too early to predict the impact of the omicron strain, the cost of lockdowns has been falling as they become more targeted and shorter.

The improvement in workplace mobility became possible due to the government's extensive vaccination program, Sunil Sinha, principal economist at India Ratings and Research, said in a statement emailed to Al Jazeera. Cumulative vaccinations in India leapfrogged to 890.21 million at the end of the September quarter, up from 335.72 million at the end of the previous quarter, the ratings agency said.

Sinha, however, warned that growth numbers should be "interpreted with caution" as growth in the first six months

of the current financial year was "mainly due to the lower base" of the same period last year.

Fast-moving indicators including exports, electricity generation, rail freight and bank deposits showed improving signs of growth momentum in October while vehicle sales, fuel sales and tax collection showed slower growth.

Private economists have said the economy is on the cusp of recovery helped by a resilient farm sector growth, but risks included slowing global growth, rising manufacturing prices as well as new variants of COVID-19.

As the market awaited the figures, health authorities warned they were tightening testing at airports in the wake of the spread of the Omicron variant. Prime Minister Narendra Modi on Saturday ordered a review of plans to ease travel curbs.

"COVID risks have resurfaced globally and (these need to be watched) for implications for the timing of monetary policy normalization,' Shubhada Rao, economist at Mumbai-based QuantEco Research, said.

Global Jet Fuel Demand Under Pressure From Omicron

SINGAPORE (Dispatches) - Global jet fuel markets stayed under pressure on Tuesday as more countries expanded border restrictions to keep the new Omicron coronavirus variant at bay, prompting travelers to reconsider their plans.

From a year earlier, industrial output rose 4.8 percent. Output in the manufacturing sector declined

U.S., Allies Biggest Beneficiaries of Australia's \$17b China Trade Row NEW YORK (Dispatches) - Australia's closest security allies, led by the United States, have been the

biggest beneficiaries of Beijing's campaign of economic coercion against Canberra, a report has found. More than 18 months after China kicked off the trade war against Australia amid a series of spats between the two countries, the University of Technology Sydney found it was Canberra's partners who were picking up much of the slack. UTS's Australia-China Relations Institute has released figures that show the value of 12 Australian exports to China affected by sanctions fell by \$U.S.12.6 billion (\$17.3b) in the first nine months of this year compared with 2019.

During the same period, the value of U.S. exports of the same commodities increased by \$U.S.4.6 billion (\$6.3 billion), while those of Canada and New Zealand jumped by \$U.S.1.1b and \$U.S.786 million, respectively.

Institute director James Laurenceson said the data showed Australia's pursuit of closer security ties with the US and other western democracies was not stopping its allies from capitalizing on its trade predicament. "Of course, the U.S. is our great security ally and strategic mate," Dr Laurenceson said.

"Sometimes we get very excited by U.S.-based commentators, and indeed senior Biden officials, saying, We will stand shoulder to shoulder with Australia.'

South Korea Industrial Output Falls by Most in 18 Months in October

SEOUL (Dispatches) - South Korea's industrial output fell by the most in 18 months in October as production in the manufacturing sector lost steam amid global supply chain bottlenecks, data showed Tuesday

Industrial output declined 1.9 percent in October from the previous month, a turnaround from a 1.1 percent on-month gain in September, according to the data compiled by Statistics Korea.

It marked the largest on-month fall since April 2020, when industrial output fell 2 percent.

*Government spending rose 9.6% after a revised 3.4% increase in the previous quarter.

Leading indicators show activity remains strong in the fourth quarter even as the official economic confidence index dropped to 99.3 in November, compared to 101.4 in the previous month.

Shell Eyes Return to Libya With Oil, Gas, Solar Investments

LONDON (Dispatches) - Royal Dutch Shell is considering a return to Libya with a plan to



Jet fuel demand - the biggest laggard in the oil complex - had been forecast to post the strongest growth of 550,000 barrels per day to 5.9 million bpd in fourth quarter, according to the International Energy Agency in its Nov. 16 report.

"Current jet demand levels are just 1 mb/d above last winter, when cases and hospitalizations were far higher and before



any widespread vaccinations," Goldman Sachs analysts said in a Nov. 26 note.

"While a worst case outcome could be a return to last winter's levels, 0.5 mb/d downside to our current base-case until 2Q22 would be a conservative assumption given what we know at present."

Global airlines, most of which have been struggling since last year's plunge in air travel as a majority of long-haul international flights remained grounded, are now scrambling to limit the impact of the latest variant on their networks. "In total, 2.4% of scheduled (global airline) capacity has been removed for the next four months," aviation data firm OAG said.

"But it is too soon to say whether this is due to slightly weaker demand than expected, or an early response by some airlines to the prospect of the Omicron variant of the COVID-19 virus causing a return to border restrictions for international air travel."

on-month last month, following a 1.8 percent on-month decline in September.

The statistics agency said economic recovery momentum has slowed down, coupled with fewer working days and September's high base effect.

South Korea used alternative holidays to create two back-to-back extended weekends in October in an effort to help prop up domestic demand.

"Economic uncertainty remains high, given the virus situation, global supply chain disruptions and rising commodity prices," Eo Woon-sun, a senior Statistics Korea official, told reporters.

The country implemented the "living with COVID-19" scheme on Nov. 1 with eased virus restrictions in a bid to gradually return to normal life.

Economic policymakers expect the relaxed virus curbs to boost private spending. But spikes in COVID-19 cases and the emergence of the omicron variant are raising concerns that economic uncertainty could heighten.

Shell still needs some new projects to maintain output as reserves in existing oil and gas fields have rapidly fallen after years of slowing drilling activity.

Under the Libya plan, discussed with state-run National Oil Corporation (NOC), Shell would explore for new oil and gas fields in several blocks in the onshore Sirte and Ghadames basins, as well as the offshore Cyrenaica basin.

Shell also proposed re-developing ageing fields such as block NC-174 in the Murzuq basin and developing new fields including in the Ain Jarbi block.

The plan includes developing a solar energy project south of the Sirte Basin, part of Shell's strategy to cut oil output by up to 2% a year by 2030 and hike investment in renewables and low carbon technologies to make up 25% of its budget by 2025.

"Shell is preparing to return as a major player," Shell's proposal said, according to the sources and details seen by Reuters. The proposal did not give details about the value of any investment or scale of the oil, gas and solar projects.

A Shell spokesperson declined to comment. NOC did not immediately respond to a request for comment. Other firms now working in Libya, include TotalEnergies, Italy's Eni and ConocoPhillips.

Shell's \$9.5 billion sale of its U.S. onshore Permian basin operations in September freed up about \$1 billion for other upstream activities, a senior company source told Reuters.

Moderna Boss Warns Against Omicron Vaccine Struggle

LONDON (AFP) - Existing Covid-19 inoculations will struggle against the fastspreading Omicron variant, the head of vaccine manufacturer Moderna warned Tuesday, as countries ramp up vaccination programs and impose further restrictions in an effort to curb growing concern.

First reported to the World Health Organization in South Africa less than a week ago, the new strain has rapidly spread from Africa to the Pacific, and from Europe to North America as dozens of countries have announced travel restrictions.

While no deaths have yet been reported from Omicron, and it could take weeks to know how infectious and how resistant the strain may prove to vaccines, its emergence underscores how besieged the world remains by Covid-19, nearly two years after the first cases were recorded.

Stephane Bancel, the head of U.S. vaccine manufacturer Moderna, told the Financial Times in an interview published Tuesday that data would be available on the effectiveness of vaccines in the two weeks' time, but that scientists were pessimistic.

"All the scientists I've talked to ... are like 'this is not going to be good'," Bancel said, warning against a "material drop" in the effectiveness of current jabs against Omicron.

Moderna, U.S. drugmaker Pfizer and the backers of Russian vaccine Sputnik V have all announced that they are already working on an Omicron-specific vaccine. Scientists in South Africa said they had detected the new variant with at least 10 mutations, compared with three for Beta or two for Delta -- the strain that hit the global recovery and sent millions worldwide back into lockdown.

China warned that the fast-spreading Omicron variant would cause challenges in hosting next February's Winter Olympics in Beijing, with thousands of athletes, media and participants arriving from overseas required to enter a strict "closed-loop" bubble. "I think it will definitely lead to challenges linked to prevention and control," foreign ministry spokesman Zhao Lijian said.

"But China has a lot of experience in responding to Covid-19," Zhao added. "I firmly believe the Winter Olympics will be conducted smoothly."

On Monday, U.S. President Joe Biden said the strain was "a cause for concern, not a cause for panic," stressing that he does not foresee new lockdowns or extending travel restrictions for now.

G7 health ministers called for "urgent action" to combat the Omicron variant.

The WHO said the overall risk from Omicron was "very high" and warned that any major surge would put pressure on health systems and cause more deaths.

Omicron could slow the recovery of the U.S. economy and labour market and heighten uncertainty over inflation, Federal Reserve Chair Jerome Powell is to tell the Senate Banking Committee.

Governments, particularly in western Europe, had already struggled with rapid rises in case numbers and have reintroduced mandatory mask-wearing, social-distancing measures, curfews or lockdowns -- leaving businesses fearing another grim Christmas.



her successor, Olaf Scholz, and regional leaders Tuesday on whether to toughen up restrictions to tame raging infections in the European Union's largest economy.

Germany's constitutional court has ruled that sweeping restrictions such as curfews, school closures and contact restrictions were lawful, likely to pave the way for further curbs with hospitals, already over capacity, long sounding the alarm.

"Contacts must be reduced," said Germany's vice-chancellor-in-waiting Robert Habeck, calling for tougher restrictions such as banning unvaccinated people from "all public facilities" apart from essential shops.

On Tuesday, Greece said coronavirus vaccines would be compulsory for over 60s, a day after Britain said all adults would be now eligible for a third Covid jab. On Tuesday, Norway also said it would offer a booster shot to all adults before Easter, as preferable to lockdown.

And in Switzerland, ahead of what some had hoped would be a prosperous ski season, hoteliers said they were facing a wave of winter cancellations following quarantine restrictions being imposed on travellers from certain countries, including Britain.

Hotels had seen "massive cancellations of corporate events and Christmas parties," said industry group HotellerieSuisse, calling on political leaders to take steps to avoid a lockdown and to maintain financial assistance to the sector already hard hit by the pandemic.

A ministerial meeting on the World Trade Organization, which had been due to take place this week in Geneva but which was postponed due to Omicron, could now take place in early March 2022, the body said.

The first confirmed case of the Omicron variant was in South Africa on November 9, with infections spreading rapidly in the country.

Kazakhstan has banned flights from December 3 to Egypt, a popular tourist destination, over Omicron.

MADRID (Dispatches) - The Spanish economy could be hit by supply bottlenecks, rising inflation and a surge of COVID-19 in Europe, prompting a slight downward revision of growth forecasts in the fourth quarter and early 2022, Bank of Spain Governor Pablo Hernandez De Cos said on Tuesday.

He said these recent developments were likely to prompt a "significant downward" revision of the bank's estimates for Spain's economic growth in 2021, due to be updated in December, and also affect the 2022 forecast.

Taking into account these projections, pre-pandemic levels of economic activity would not be reached until around early 2023. Tourism, which used to account for more than 12% of Spain's GDP before the coronavirus outbreak, would not fully reach pre-pandemic levels until the summer of 2023, De Cos said.

AIDS: Years of Research But Still No Vaccine

PARIS (AFP) - Covid vaccines began to show promise just months after the novel coronavirus started spreading across the globe. One answer is that the political will and colossal investment that have spurred on Covid vaccine development have largely been missing from AIDS vaccine research since HIV was discovered in 1983. But another lies in the complexity of the science behind HIV.

"With COVID vaccines, researchers worry about the vaccine being able to fend off a handful of variants that have become particularly worrisome," reads a June report by the International AIDS Vaccine Initiative (IAVI). "But for HIV, there are millions and millions of different viruses that have resulted from the virus's stealth ability to rapidly mutate... It is this astonishing level of diversity that any HIV vaccine must contend with."

Olivier Schwartz, head of the viruses and immunity unit at the Pasteur Institute in Paris, says that while most people can recover naturally from an initial coronavirus infection and thus acquire immunity, this is not the case for HIV.

"HIV mutates much more easily than Covid and so it is more difficult to generate so-called broadly neutralizing antibodies that could prevent infection," he said.

Only a handful of people naturally produce these antibodies when exposed to HIV.

Research into a vaccine has meant studying those rare responses, understanding how they work, and trying to replicate them in healthy people's immune systems.

Several dozen vaccines are being studied, with one by U.S. firm Moderna seeking to use the same mRNA delivery method as its popular Covid vaccine. The June report describing the research explains how the mRNA jab is meant to deliver instructions for a process called "germline targeting". This means "guiding the immune system, step by step, to induce antibodies that can counteract HIV", the report explains. So far, the technique is complex, involving an initial shot to activate important B-cells before several jabs attempt to spur the body into producing a range of antibodies.

Being able to visualize a way forward has given researchers hope, and some say it's thanks in no small part to the pandemic.

Meanwhile on Tuesday a group of U.S. lawmakers in the U.S. House of Representatives prepared an anti-Iran bill, calling for preventing the country from advancing its defense activities in the field of

Spanish inflation hit its highest in nearly three decades in November as a jump in food and fuel costs pushed consumer prices up to 5.6% year-on-year.

The rate accelerated from October's 5.4% to reach its highest level since September 1992's 5.8%. Inflation has been rising across the euro zone in recent months, with Spain particularly hard hit.

UEFA's New Charter Urges Clubs to Teach Players, **Staff About Concussion**

ONDON (Dispatches) - UEFA has Llaunched a concussion charter in a further measure to safeguard players sustaining blows to the head, European football's governing body said.

The charter, drawn up by the UEFA Medical Committee, is aimed at educating players, coaches, referees, doctors and the public about the dangers of concussion in football.

As part of the charter, clubs and national teams are being urged to provide education sessions to brief players, coaches and staff about concussion procedures.

"Concussion is undoubtedly a serious injury which needs to be managed and treated properly," Tim Meyer, UEFA Medical Committee chairman, said in a statement.

"Although research studies report a low incidence in football, everyone should know how to react and what to do in the event of a concussion on the pitch. "By signing this charter, clubs and

MADRID (Dispatches) - Real Madrid coach Carlo Ancelotti said today Karim Benzema is "not crying" about missing out on winning his first Ballon d'Or.

Lionel Messi, who left Barcelona for Paris Saint-Germain last summer, won the Ballon d'Or for a record seventh time.

The 34-year-old Messi led Argentina to the Copa America title in July and has scored 40 goals in 2021, including 28 for Barca.

Benzema, 33, finished fourth behind Messi, Bayern Munich striker Robert Lewandowski, and Chelsea midfielder Jorginho.

In his Madrid press conference today, Ancelotti was asked if the Ballon d'Or "still has credibility" following Messi's latest victory. "We have to respect the decision. Messi won and he's still a great player," Ancelotti said.

"For the players, individual awards are important and they give motivation - but if they don't win them, it doesn't matter.

"Benzema has had a great season and finished fourth and now he will have extra motivation to finish first next year."

Ancelotti added: "It's an important award but it's still individual. Karim Benzema isn't crying about not winning it, nor Thibaut Courtois. They have accepted it without any problems.'

Ancelotti said he would have voted Benzema, Vinicius Junior and Luka Modric as his top three.

Ronaldo Hits Back at Ballon d'Or Rivalry With Messi

MANCHESTER (Dispatches) - Cristiano Ronaldo has hit back at comments made by Ballon d'Or organiser Pascal Ferre, saving the editor-in-chief of France Football "lied" about his rivalry with Lionel Messi. Ferre told the New York Times that Manchester United forward Ronaldo's sole ambition was to retire with more of the awards for the world's best player than Messi.

FIFA Goal of the **Year Nominees** Announced

ZURICH (Dispatches) - FIFA have announced an 11-player shortlist for this year's Puskas Award, with Patrik Schick's goal against Scotland at Euro 2020 among the nominees.

Czech forward Schick beat goalkeeper David Marshall with one of the most remarkable goals in European Championship history, a stunning 45-metre strike from just inside the halfway line as his team beat Scotland 2-0.

Schick's effort was subsequently voted goal of the tournament.

Tottenham Hotspur forward Son Heung-min won the award in 2020 for his solo effort against Burnley in the Premier League in which he ran nearly the length of the pitch, dribbling past several Burnley defenders before scoring.

Woods Rules Out Full-Time Return to Golf

OS ANGELES (Dispatches) - Tiger Woods has ruled out making a full-time return to professional golf as he works his way back from career-threatening leg injuries.



The 15-time major winner told Golf Digest in an interview published that although he is confident of eventually making a return to the sport, he expected he would only play select tournaments from now on.

The 45-year-old former world number one suffered compound fractures in his right leg after a car he was driving in a Los Angeles suburb in February veered off the road and flipped several times. Before the accident, Woods was already playing a reduced schedule following multiple surgeries on his back and knee over the years.

He told Golf Digest yesterday that his days as a full-time member of the PGA Tour were now effectively over, saying he now expected to "pick and choose" events in future.

"I think something that is realistic is playing the Tour one day - never full time, ever again - but pick and choose," Woods said.

"Pick and choose a few events a year and you play around that.

"I think that's how I'm going to have to play it from now on. It's an unfortunate reality, but it's my reality. And I understand it, and I accept it."

Woods generated buzz earlier this month after posting video on Twitter of himself hitting balls, with the caption "Making progress."
