UK Discussing How to Repay £400m Iran Debt

LONDON (Dispatches) - UK government officials were in Tehran last week discussing legal ways to pay Britain's historical £400m debt to Iran, the Iranian ambassador to London has said. Mohsen Baharvand added that he was in live discussions with the Foreign Office, and said the issues were not insurmountable.

The UK Foreign Office has refused to discuss any details of the payment to Iran, or what has been holding up the settling of the £400m debt dating back to an arms sale to Iran in the mid-1970s.

Families of the UK dual nationals detained in Iran have repeatedly said they believe their family members are being held hostage until the debt is paid. The former foreign secretary Jeremy Hunt has also said he does not think the UK dual nationals will be released until the debt is paid.


Baharvand, speaking to reporters in London on Friday, said Iran and the UK had been close to an agreement on the debt in the summer: "We wanted to use that deal to ask our people that we are seeing a good sign from the UK and then that gives us a possibility to expedite our efforts to help the dual nationals and things like that. Then we had a deal. We signed it but two days after the signature of that deal the UK government said they could not implement it because of U.S. sanctions," he said. See Page 7

Official says Dishonest Reports Not to Affect Iran's Will

TEHRAN (PressTV) - Iran's chief negotiator in Vienna talks has once again reaffirmed the Islamic Republic's determination to reach a deal with the P4+1 group of countries on the removal of sanctions during the ongoing negotiations in the Austrian capital, saying "dishonest reports" from outside the negotiating room will fail to have any impact on Tehran's will.

"Dishonest reports from outside negotiating room won't weaken our will to reach a deal securing our nation's rights & interests," Ali Bagheri Kani said in a post on his Twitter account on Friday as talks are underway between Iran and the five remaining signatories to the 2015 nuclear agreement aimed at securing the removal of the sanctions imposed by the US on Iran after Washington's withdrawal from the accord, and reviving the embattled deal.

Bagheri Kani, who serves as Iran's deputy foreign minister for political affairs, emphasized that the nuclear agreement, officially known as the Joint Comprehensive Plan of Action (JCPOA), is alive "because of Iran's responsible conduct."



Iran Serious, Seeking **Good Deal in Vienna**

TEHRAN - President Seved Ebrahim Raisi says the ongoing negotiations in Vienna will result in a good deal if the other parties are determined to remove U.S. sanctions against Tehran.

Addressing Iranian ambassadors and heads of Iranian diplomatic missions abroad on Saturday, President Raisi said Tehran definitely pursues such an agreement.

"The fact that we presented the text of Iran's proposal to the negotiating parties shows that we are serious in the talks, and if the other side is also serious about the removal of sanctions, we will achieve a good agreement. We are definitely after a good agreement," he said. Last week, Iran submitted two draft proposals to the other parties concerning the removal of sanctions and Tehran's nuclear commitments, but the Europeans requested a break to take them to their capitals for discussion.

The talks resumed on Thursday, with Iran's top negotiator, Ali Bagheri Kani, stressing that Tehran is sticking to the stance it laid out last week.

Rasi said the brutal U.S. sanctions against the Islamic Republic are mainly economic-based and the enemy's strategy is to keep and expand the shadow of these sanctions on the Iranian nation, adding Iran should primarily focus on defusing and breaking the impact of the bans.

He underlined that his administration is doing its best to thwart the effect of the sanctions and our decision in the fields of oil sales and financial resources are geared toward managing the country in case the sanctions continue.

Elsewhere in his remarks, the Iranian president pointed to a serious effort to establish better ties with neighboring countries, insisting that Tehran needs to develop a correct view about its borders and look at its neighbors as opportunities, not threats. Emphasizing the significance of developing strong economic ties with neighboring nations, Raisi further underlined that establishing ties with Israel can neither bring security to the occupying regime, nor to the states of the region.

He added that maintaining good relations with regional countries is what will culminate into security in our region. Raisi described foreign authority as an extension of domestic authority and said, "We believe that relations with neighboring countries should be stable. Everyone knows that the connection with the Zionist Regime by some countries in the region does not provide security for them. Wherever the Zionist Regime has infiltrated, the host country has suffered. Countries in the region can contribute to security and peace by interacting with the Islamic Republic of Iran".

The President emphasized, "All hardships we have is because of the presence of outsiders in the region. NATO and the United States have been in Afghanistan for 20 years, but the people of this country have not felt peace for a day" Stating that there is an infrastructure of economic relations with neighbors, Raisi said, "Deep knowledge of domestic capabilities is very important for the missions of the Islamic Republic of Iran abroad and they should introduce Iran's scientific and technical capabilities to the world". Emphasizing that we are determined to pursue a policy of interaction with our neighbors, the President said, "Today, the sanctions imposed on the Islamic Republic of Iran are economically based. The strategy that the enemy is pursuing is to put Iran under sanctions, but we are pursuing two steps of lifting them and neutralizing them".

Tehran Condemns Inhumane U.S. Measures Against Iranian People

TEHRAN (PressTV) - An Iranian envoy to the United Nations has denounced as inhumane and illegal what have been branded as the unilateral coercive measures by the United States against the Iranian people.

Zahra Ershadi, deputy permanent representative of Iran to the UN, made the remarks in a statement on Friday, stressing that Washington uses Unilateral Coercive Measures - or UCMs - as political leverage against other countries.

"The Islamic Republic of Iran considers the inhumane and illegal UCMs not only as one of the main obstacles which hinder international efforts to provide humanitarian assistance but also as one of the main sources in creating humanitarian crises and devastating humanitarian principles around the world," she said in a statement before the UN General Assembly Plenary.

In the statement on "Strengthening of the coordination of humanitarian and disaster relief assistance of the United Nations, including special economic assistance", Ershadi added that the sanctions froze the funds Tehran held in foreign banks for purchases of coronavirus vaccines. See Page 7

IRGC Navy Takes Delivery of More Combat Speedboats

TEHRAN (PressTV) - The Islamic Revolution Guards Corps (IRGC) Navy has taken delivery of 110 domestically-manufactured combat speedboats for maritime operations in Iran's southern territorial waters.

The speedboats joined the IRGC Navy's fleet during a Saturday ceremony attended by the IRGC Chief Commander Major General Hossein Salami and high-profile military figures in the southern Iranian port city of Bandar Abbas.

The speedboats are highly maneuverable, and are equipped with missile and rocket launchers as well as surveillance and reconnaissance devices.

In comments at the event, General Salami said Iran's advanced naval vessels have high destructive power to defend the country in terms of range, speed, accuracy.

Rear Admiral Alireza Tangsiri, commander of the Islamic Revolution Guards Corps (IRGC) Navy, said the new speedboats have been developed by local experts and can reach speeds of 75-90 knots (138-166 km/h). See Page 7

Mali Keen to Cooperate With Iran in Extraterritorial Cultivation

TEHRAN (MNA) - Director-general of the Malian Foreign Affair Ministry's Asia and Oceania Office has said his country is ready to cooperate with Iranian companies for extraterritorial cultivation, the portal of the Tehran Chamber of Commerce, Industries, Mines and Agriculture (TCCIMA) reported.

Addressing the meeting with the TCCIMA Deputy Head for International Affairs Hesamedin Hallaj on Saturday, the Malian official called on Iranian companies to expand agricultural activities in Mali, saying that his country is fully prepared to provide suitable land and water for agriculture to Iranian companies. Emphasizing the high capacity of cooperation between the two countries, he stressed that his country does not have a complicated bureaucracy for the economic activity of Iranian companies and it is fully prepared for cooperation with Iranian companies.

"Mali is the third-largest economy in Northwest Africa, but unfortunately financial and economic relations between Iran and Mali are not at the level of political relations between two countries; While in the fields of agriculture, mining, and handicrafts, there is a lot of potential for cooperation between the two countries," he said. Having two large rivers, Mali has abundant water resources and suitable land for agriculture, the official said, adding that the country's Agriculture Ministry and the finance institutions are ready to transfer land and water to Iranian companies for cultivation.

He also informed about his country's need for chemical fertilizers for agriculture, including phosphate and urea fertilizers, and said: "I have an order for 260,000 tons of urea fertilizer for a company in Mali right now. If Iranian producers are ready, they can sign contracts with financial companies to export chemical fertilizers to my country." Further in this meeting, Hallaj referred to the low volume of economic relations between the two countries and noted that this issue is due to the lack of knowledge about the two sides' potentials and capacities and stressed the need to activate the relations between the two countries' chambers of commerce.

Iraq Deplores Reduction In Gas Supplies From Iran

BAGHDAD (Dispatches) - Iraq's ministry of electricity said that a reduction in gas supplies from Iran had meant a power loss of around 3,400 megawatts, the state news agency reported.

Iraq's reliance on Iranian energy imports has geopolitical consequences and has been a source of ongoing tensions with the U.S. Washington has conditioned successive sanctions waivers, enabling these imports to continue, on Iraq becoming more energy independent.

The stakes are high for Iraq as electricity outages have routinely led to violent protests, particularly in the south.

Gas and electricity imports from Iran often meet up to a third of Iraq's power demands.

"Iraq relies on Iranian energy imports heavily, especially in peak summer months," said Yesar al-Maleki, Persian Gulf analyst at the Middle East Economic Survey.

"Gas imports from Iran range from 1.5-1.8 billion cubic feet per day. Now, we see generation in the south collapsing below one (gigawatt), meaning not just these lines are offline but even gas flow is down."

Bagheri is in Vienna to attend negotiations on lifting sanctions against Iran. Earlier, Bagheri slammed the unseriousness shown by some participants, saying that the delegation of the Islamic Republic of Iran was serious in the talks.

Tehran Set to Get U.S. Sanctions Lifted

TEHRAN - Iran's foreign minister says his ministry is duty-bound to work towards the lifting of Washington's sanctions against Tehran.

"The diplomacy apparatus' innate responsibility is to make every effort and use all its diplomatic know-how and experience to get the United States' cruel and unilateral sanctions lifted," said Hossein Amir- Abdollahian in a meeting with Iranian ambassadors and heads of Iranian diplomatic missions overseas.

He said the administration of Iranian President Seyed Ebrahim Raisi took office on a platform of getting U.S. sanctions lifted, adding the foreign ministry is commissioned to work towards that end.

Also present at the meeting was President Raisi, who said if the other parties to the Vienna talks are determined to lift the U.S. sanctions against Iran, the negotiators will reach a good deal.

He said Tehran definitely pursues such an agreement.

Reports coming out of the Vienna talks on Friday suggest the negotiating teams had a better assessment of the discussions than their previous meetings.

In a report, IRNA said Tehran's proposals have been explained to the other sides and ambiguities are being cleared.

Meanwhile, Russian representative to the meeting Mikhail Olyanov said at the first meeting of the second round of talks that important ambiguities in the talks have been resolved and the negotiations are moving forward.

Reports also indicate the European troika have returned to Vienna with a more realistic approach after examining Tehran's proposals.

Meanwhile Amir-Abdollahian added that neighboring countries are the main focus of the Islamic Republic of Iran in foreign policy.

He went on to say: "The government's slogan is a balanced foreign policy and



active, dynamic, and intelligent diplomacy, and the government's four-year plan has been prepared and planned in this regard.'

He also went on to say that looking at Asia is one of the priorities of the government's foreign policy, stressed: "We will pursue sustainable economic development without looking at the Vienna talks."

Amir-Abdollahian added: "Paying special attention to Iranians abroad and eliminating their separation with the country is one of the serious plans of the government."

The Iranian Foreign Minister also said: "In the coming days, we will hold the first meeting of the Council of Iranians Abroad, chaired by the President, and we hope that the approval of the law on the protection of Iranians abroad will be one of the outcomes of this meeting."

Referring to the Foreign Ministry's mission in the field of neutralizing and lifting sanctions, Amir-Abdollahian added: "In this regard, we have a duty to move with a revolutionary and jihadist approach."

The Iranian Foreign Minister also said: "We will pursue sustainable economic development without looking at the Vienna talks. However, the inherent duty of the diplomatic apparatus is to use all its diplomatic efforts and experience to lift the oppressive and unilateral sanctions of the United States."

Expansion of Ties With Syria, Region Top Priority for Iran

TEHRAN (MNA) - Iran's vice president for parliamentary affairs said that Iran is seeking to implement all the agreements between Iran and Syria, adding the expansion of ties with Syria and other regional countries is top priority for Tehran.

Seyed Mohammad Hosseini, the Iranian vice president for parliamentary affairs on Saturday held talks with Shafiq Dayoub, Syrian Ambassador to Tehran.

UNGA Approves Iran's Membership

TEHRAN (PressTV) - The United Nations General Assembly (UNGA) has approved Iran's full membership in the UN Scientific Committee on the Effects of Atomic Radiation (UNSCEAR).

Before obtaining membership on Friday, the Islamic Republic had observer status at the UNSCEAR.

Iran's accession was first approved last month in the General Assembly's Fourth Committee, despite opposition from the Israeli regime and the United States.

In addition to Iran, Norway, Algeria and the United Arab Emirates (UAE) also joined the UNSCEAR, increasing the number of the body's permanent members from 27 to 31.

The UNSCEAR was set up by resolution of the General Assembly in 1955. Its mandate is to assess and report on the levels of and the effects of exposure to ionizing radiation.

A secretariat, located in Vienna and functionally linked to the UN Environment Program, organizes the annual sessions and manages the preparation of documents for the Committee's scrutiny.

Iran has shown the peaceful nature of its nuclear program to the world by allowing the most transparent cooperation ever with the International Atomic Energy Agency (IAEA). It signed the Joint Comprehensive Plan of Action with six world states — namely the US, Germany, France, Britain, Russia and China — in 2015.

Following a year of strategic patience, Iran resorted to its legal rights stipulated in Article 26 of the JCPOA, which grants a party the right to suspend its contractual commitments in case of non-compliance by other signatories, and let go of some of the restrictions imposed on its nuclear energy program.



Turning to the previous visit of the Turkish foreign minister to Iran, Qalibaf said, "During the visit, officials of the two countries of Iran and Turkey discussed drawing up a comprehensive cooperation document."

He evaluated his visit to Turkey as' positive' and stated that the two countries showed their vehement interests to boost their ties in all fields, especially in the economic areas.

In his meeting with Turkish entrepreneurs and businesspersons, he said that the 13th government of Iran under President Raisi is seriously determined to remove barriers ahead of trade and economic ties between the two countries.

Qalibaf also held a high-profile meeting with Turkish President Recept Tayyip Erdogan to discuss issues of mutual interests.

"The most important crisis in West Asia is Palestine, and the resolution of the crisis will be possible only with the participation of all the main inhabitants of Palestine and its acceptance by the int'l community." Kamal Kharrazi said in a virtual speech at the 30th International Conference on the Anniversary of Kazakhstan's Independence.

Kharrazi also described the Yemeni crisis as a "fruitless and costly war," adding: "The time has come for the siege of Yemen to be lifted and for a people's government to rule the country based on the fundamental principle of democracy."

Referring to the U.S. defeat in Afghanistan after 20 years of occupation, the eventual withdrawal, and its escape from the country, the former Iranian Foreign Minister said: "The only solution to the crisis is the formation of an inclusive government in Afghanistan."

TEHRAN – Iran Mercantile Exchange (IME) last week witnessed trade of 1,977,000 tons of commodities with a total trading value of almost \$519m, posting growths of 6% in volume and 16% in value of trades compared to the figures of the previous week.



According to a report by the IME's international affairs and PR, the exchange traded on its metals and minerals trading floor 1,693,000 tons of commodities valued at almost \$334m.

Commodities sold on this floor included 1,000,275 tons of cement, 345,240 tons of steel, 81,000 tons of iron ore, 35,500 tons of sponge iron, 12,510 tons of copper, 10,275 tons of aluminum, 1,600 tons of zinc and 21 tons of precious metals concentrate.

Furthermore, the IME saw on both domestic and export pits of its oil and petrochemical trading floor 275,000 tons of commodities worth more than \$181m.

The IME's customers purchased on this floor 86,042 tons of polymeric products, 51,000 tons of vacuum bottom, 51,000 tons of lube cut, 46,980 tons of bitumen, 36,607 tons of chemicals, 3,795 tons of base oil and 1.309 tons of sulfur.

Last but not least was the IME's side market with 8,464 tons of commodities traded on it.

Car Manufacturing Rises 4.7% in 8 Months yr/yr

TEHRAN (MNA) - Car manufacturing in Iran has risen 4.7 percent during the first eight months of the current Iranian calendar year (March 21-November 21), as compared to the same period of time in the past year.

According to the data released by the Industry, Mining, and Trade Ministry, Iranian carmakers manufactured 651,408 vehicles in the eight-month period of this year, while the figure was 622,144 in the same time span of the previous year.

During the said eight months, IKCO manufactured 319,710 vehicles, which was 0.1 percent less than the output in the same time span of the previous year.

SAIPA manufactured 283,593 vehicles in the mentioned period. Production by this automaker rose 6.2 percent in comparison to the previous year's same time span.

TEHRAN - The interim free trade agreement between the Eurasian Economic Union and Iran has been extended until 2025, official representative of the Eurasian Economic Commission (EEC) Iva Malkina told a briefing for the press after the Supreme Eurasian Economic Council meeting on 10 December on Friday. "During the summit, the parties signed a protocol to the interim agreement leading to the formation of a free trade zone between the Eurasian Economic Union and Iran," Iya Malkina said. "The interim agreement has been extended until 27 October 2025 or until the free trade agreement enters into force, whichever comes first."

She recalled that the negotiations on the full-fledged free trade agreement are based on the regime in force between the EAEU and Iran in accordance with the interim agreement since October 2019. In H1 2021, trade with Iran posted a great growth: the exports of the EAEU member states surged by almost 47% to total \$1.35 billion, imports - by 34% to \$825 million. Trade between the EAEU countries and Iran increased by 27% over the same period in 2019, exports rose by 27%, imports - by almost 70%.

The Supreme Eurasian Economic Council summit was held via video conference. It was attended by Belarusian President Aleksandr Lukashenko.

Czech President Rejects New Nominee for FM

PRAGUE (Dispatches) - Czech President Milos Zeman said on Friday he had rejected the nomination of a foreign minister in the incoming cabinet over the candidate's reservations toward Israel and toward cooperation with other members in a central European alliance.

Zeman said in a statement he was ready to appoint the rest of the cabinet but the rejection sets the stage for a legal battle with the new prime minister, Petr Fiala, leader of the centre-right Civic Democrats.

Fiala has backed the foreign minister nominee, Jan Lipavsky, from the liberal Pirate Party, which is part of Fiala's coalition that won an election in October.

Macron Welcomes Scholz, Seeking **Common Ground After Merkel**



PARIS (Dispatches) - President Emmanuel Macron and Germany's new Chancellor Olaf Scholz played down differences over reform of EU budget rules and the place of nuclear in green investment financing, pledging on Friday to keep the Franco-German axis strong.

The trip to meet Macron in Paris was Scholz's first foreign visit since he became Germany's chancellor on Wednesday, ending 16 years of conservative rule under Angela Merkel. His three-party coalition has pledged to further strengthen European integration.

"During the last four years I have worked with Angela Merkel on all these subjects ... I know that we will continue together, dear Olaf, this close collaboration," Macron told Scholz at a joint news conference.

Myanmar Anti-Coup Activists Protest Against Junta

YANGON (Dispatches)- Protesters in Myanmar closed businesses and stayed off the streets on Friday in a "silent strike" against rule by the military and its ousting of the Southeast Asian country's democratically elected government in a February coup.

Photos published by Myanmar media showed deserted streets and markets in towns across the country, while protesters in the northern city of Shwebo wore black clothes and marched in silence.

LONDON (Dispatches) - WikiLeaks founder Julian Assange moved a step closer to facing criminal charges in the United States for one of the biggest ever leaks of classified information after Washington won an appeal over his extradition in an English court.

U.S. authorities accuse Australian-born Assange, 50, of 18 counts relating to WikiLeaks' release of vast troves of confidential U.S. military records and diplomatic cables which they said had put lives in danger.

Assange's supporters cast him as an anti-establishment hero who has been persecuted by the United States for exposing U.S. wrongdoing and double-dealing across the world from Afghanistan and Iraq to Washington.

At the Royal Courts of Justice in London, the United States won an appeal against a ruling by a London District Judge that

Pakistani Taliban Ends Ceasefire, Future of Peace Talks Uncertain

ISLAMABAD (Dispatches) - The Tehreek-e-Taliban Pakistan (TTP) armed group, also known as the Pakistani Taliban, has unilaterally announced an end to a month-long ceasefire with the Pakistani government, accusing authorities of reneging on promises made in the initial stages of peace talks, a statement says.

The ceasefire came into effect on November 9, after the Pakistani government announced the start of talks with the armed group, which has been fighting Pakistan's government since 2007 and has carried out dozens of attacks targeting civilians and security forces across the country.

The TTP announced "it is not possible for the ceasefire to continue" under current conditions, in a statement released to journalists.

Pakistan's government is yet to comment on the developments, and Information Minister Fawad Chaudhry did not immediately respond to an Al azeera request for comment.

On November 8, Chaudhry confirmed that the month-long ceasefire had been agreed upon between the government and the TTP.

"The state's sovereignty, national security, peace in relevant areas and social and economic stability will be considered during the talks," he was quoted by state-run television broadcaster Pakistan Television as saying.

The announcement came a month after Prime Minister Imran Khan first announced that talks between the two sides were ongoing, following the fall of the Afghan government to the Afghan Taliban in mid-August.

The TTP and Afghan Taliban are allied, although maintain separate operation and command structures.

On November 14, acting Afghan Foreign Minister Amir Khan Muttaqi confirmed that the Afghan Taliban were acting as mediators in the talks.

The TTP's statement on Thursday cited concerns with implementation by the Pakistani government of six initially agreed upon points for withdrawing from the ceasefire.

"We do know, however, that this deprives Nicaragua's people of a steadfast partner in its democratic and economic growth," spokesperson Ned Price said in a statement. "We encourage all countries that value democratic institutions, transparency, the rule of law, and promoting economic prosperity for their citizens to expand engagement with Taiwan. Chinese Foreign Minister Wang Yi said Taiwan's allies - now only 14 countries - have stayed with Taipei only because of pressure from the United States and Taiwan's "dollar diplomacy", accusations Taipei denies. Gazprom Neft Supports OPEC + Deal After 2022

MOSCOW (Dispatches) - Alexander Dyukov, the head of Russian oil producer Gazprom Neft, said on Friday it would be "logical" to keep the current OPEC+ agreement to manage oil output after 2022.

In an interview to Rossiya 24 TV station he also said that global oil demand will continue to increase despite the emergence of the variants of COVID-19. He said he expects the company's oil and gas condensate production to rise by around 10% next year.





OPEC+ Output Hike Gamble Pays off as Oil Prices Recover

LONDON (Dispatches) - The gamble taken by OPEC and its allies, under pressure from top oil consumer the United States, to raise oil output in January despite its own forecasts of oversupply, appears to be paying off as prices stabilize.

Oil has steadied around \$75 a barrel as market participants brush off concerns of a glut, in part because they don't believe the Organization of Petroleum Exporting Countries and its allies can reach their new output target and demand is still expected to rise. Heading into its Dec. 2 meeting, OPEC+ had every reason to lower supply. A U.S.-led release of oil from strategic stocks was set to increase the surplus. Oil fell 10% on Nov. 26 when reports of the new coronavirus variant emerged and below \$66 on the day of the meeting.

But OPEC+ stuck to its guns and went ahead with the nominal monthly increase of 400,000 barrels per day, taking a view that demand would not be severely hit. Oil's rise since has added to OPEC confidence that there won't be a major demand shock. "The market has taken the decision well," said an OPEC delegate. "The variant news made

for short-lived negative sentiment, with no clear evidence." While a new round of movement restrictions as a result of

the Omicron variant threatens to impact demand, there has not been a return to the strict limits on travel seen during earlier waves of the pandemic.

At the same time OPEC+, which has been unwinding last year's record output curbs through monthly increases, has been under-delivering on the pledges due to a lack of capacity to pump more in some of the alliance's producers.

"The bottom line: everything is good when Brent is quoted at around \$75," said a Russian OPEC+ source.

Prices could head even higher in 2022, according to Christyan Malek and other analysts at JP Morgan, who think OPEC+ will struggle to add 250,000 bpd a month and forecast \$125 oil next year in a Nov. 29 note.

The decision to hike output was good for big oil consumers, which have been urging OPEC+ to do more to lower prices. The White House, which has lobbied for more oil, welcomed the OPEC+ decision to increase output.

In the days leading up to and following the Dec. 2 meeting, OPEC had a number of meetings with representatives of consumer nations. A U.S. delegation met with a number of UAE and Saudi officials, as well as from non-OPEC Qatar.

OPEC Secretary General Mohammad Barkindo and others held a meeting on Dec. 3 with Chinese officials, an OPEC source said, adding it was a "positive" meeting and came a day after the OPEC+ decision to stick to planned output increases.

OPEC officials deny that their decisions had anything to do with consumer pressure. A White House spokesperson said: "The delegation meetings were not related to the OPEC+ meetings and that was not the purpose of the trip," which focused on a range of economic issues.

Neil Atkinson, a veteran oil analyst and former senior official at the International Energy Agency, said the OPEC+ decision was good for both producers and consumers.

He said the actual OPEC+ increase was likely to be less than 400,000 bpd, so was unlikely to amplify the surplus of oil expected in the first quarter, and it was hard to see a return to the intensity of earlier lockdowns.

"I doubt there will be a major demand shock," he said. "OPEC+ did the right thing. Thus far, they have added barrels carefully as demand has

UK Economy Almost Flat-Lined in October

LONDON (Dispatches) - Britain's economy barely grew in October, even before the emergence of the Omicron coronavirus variant, further denting expectations that the Bank of England will raise interest rates next week for the first time since the pandemic struck.



Gross domestic product edged up by a weaker than expected 0.1%, slowing sharply from monthly growth of 0.6% in September.

That meant the economy remained 0.5% smaller than in February 2020, just before Britain went into its first COVID-19 lockdown, the Office for National Statistics said on Friday.

"We've always acknowledged there could be bumps on our road to recovery," finance minister Rishi Sunak said.

"But the early actions we have taken, our ongoing 400 billion pound economic support package and our vaccine program mean we are well placed to keep our economy on track." Economists polled by Reuters had forecast monthly GDP growth of 0.4%.

Maike Currie, investment director at Fidelity International, said Britain's fast-rising inflation rate and the spread of Omicron might mean the world's fifth-biggest economy starts to shrink again.

"The Bank of England will be acutely aware that it's harder to dig an economy out of recession than to cool rising inflation, which makes an interest rate rise next week increasingly unlikely."

Sterling dipped after the ONS figures were published as investors took them as another reason for the central bank not to follow through on its signals in recent months that it would start to raise borrowing costs in the face of growing inflation pressure.

The Bank of England is currently holding its December policy meetings and is due to announce its decision next Thursday. Britain's economy bounced back strongly earlier this year from its nearly 10% slump in 2020 when the pandemic hit.

But the rebound slowed in recent months as supply chain problems hit manufacturers and it is expected to lose more momentum because of new COVID-19 rules to slow the spread of the Omicron variant.

IMF Chief Economist Sees Inflationary Pressures, Risks From Omicron

GENEVA (Dispatches) - Central banks do not have the space to keep monetary policy loose and interest rates low, the International Monetary Fund's chief economist said on Thursday, also warning that the pandemic could turn out far more costly than estimated.

Gita Gopinath, IMF chief economist, said that it had estimated that a more transmissible SARS-CoV-2 variant such as Omicron could cost the global economy a further \$5.3 trillion, in addition to the current projected loss of \$12.5 trillion. She was speaking to an event organized by the World Health Organization (WHO) which seeks \$23.4 billion for vaccines and other tools against the COVID-19 pandemic through the ACT (Access to COVID Tools) Accelerator, co-run with the GAVI Vaccine Alliance.

"We are now in the phase where countries around the world just don't have the space to keep monetary policy very loose, to kind of keep interest rates extremely low. We are seeing inflationary pressures building up around the world," she said. "And so think of a situation where you could have this pandemic last longer, you have longer supply disruptions that are putting inflationary pressures, and then we have the real risk of something we have avoided so far, which is stagflationary concerns," Gopinath added.

Concerns over Omicron, which the WHO says has been reported by 57 countries since it was first detected last month in southern Africa and Hong Kong, was "an obvious hit to recoveries everywhere in the world", she said. The IMF had simulated the case of what would happen if there were a more transmissible variant than Delta, she said, referring to the current dominant strain.

"Our projections are that that would add another loss of around \$5.3 trillion to the global economy. So that is in addition to the current projected \$12.5 trillion lost," she said.

Indian Economy Likely to Grow 9% Next Fiscal

NEW DELHI (Dispatches) - Swiss brokerage Credit Suisse expects the economy to continue to show positive surprises and record up to 9 percent growth in the next fiscal.

For the current financial year too, the brokerage anticipates growth to be higher than the consensus forecast of 8.4-9.5 percent, and printing in at around 10.5 percent.

As a policy, Credit Suisse does not provide absolute growth numbers in its forecast.

However, an extrapolation of data available and projections indicate that economic growth

during the pandemic, contributing to a 0.4% rise in output in Britain's dominant services sector. By contrast, industrial output fell 0.6%, hit by big falls in electricity and gas and in mining and quarrying. The manufacturing sector flat-lined as the sector struggled with supply chain problems and staff shortages.

Construction fell by the most since April 2020, down by 1.8% from September, also hit by a shortage of supplies.

Separately, the ONS released trade data showing that Britain's goods trade deficit narrowed to 13.9 billion pounds in October from 14.7 billion pounds in September.

German Exports Rebound in **October Despite Supply Bottlenecks**



BERLIN (Dispatches) - Germany's exports bounced back in October despite global supply chain bottlenecks, according to figures released Thursday by the federal statistics agency, Destatis.

"Despite all the negative factors, German foreign trade is at last back at pre-crisis levels," Dirk Jandura, head of the German federal trade and services association BGA, said, in reference to the coronavirus pandemic, which throttled trade around much of the world.

Japan's Q4 Business Mood Likely Improved

TOKYO (Dispatches) - Japan's business mood improved in the three months to December and exports continued to benefit from robust global demand in November, a Reuters poll showed, offering policymakers hope the economy is gradually emerging from its pandemic-induced slump.

The data would bode well for the Bank of Japan, which is set to maintain ultra-easy policy next week and debate whether to phase out pandemic-relief fund schemes that expire in March. The BOJ's closely-watched "tankan" survey is likely to show the headline index for big manufacturers' sentiment edged up to plus 19 in December from plus 18 three months ago, according to analysts polled by Reuters.

"Manufacturers' sentiment will likely improve as the worst has passed in terms of chip shortages, and supply constraints caused by Southeast Asian factory shutdowns are gradually easing," said analysts at Mizuho Research & Technologies.

Big non-manufacturers' sentiment index is also seen improving to plus 6 from plus 2, as the Sept. 30 lifting of state of emergency curbs to combat the pandemic helped boost consumption, the poll showed. Big manufacturers and non-manufacturers both expect conditions to improve three months ahead, according to the poll, highlighting growing optimism among companies over the outlook. The tankan will also show big firms plan to increase capital expenditure by 9.8% in the fiscal year ending in March, slightly lower than an estimate for a 10.1% gain in the previous survey, the poll showed. But the December tankan is unlikely to factor in much of the impact of the recent spread of the Omicron new variant, which could hurt business confidence ahead, analysts say.



Markets are also focusing on the tankan's indices gauging corporate funding for clues on whether the BOJ will decide next week to scale down pandemic-relief funding support. The BOJ will release the survey on Dec. 13 at 8:50 a.m. local time (Dec. 12 at 2350GMT).

Separate data on Japan's trade balance will show exports rose 21.2% in November from a year earlier, a sign robust global demand continues to underpin the economy, the poll showed. Machinery orders, a leading indicator of corporate capital expenditure, likely rose 2.1% in October from the previous month, the poll showed.

"The economy is expected to continue to show positive surprises even though the recovery has so far been lop-sided but in the next three-six months most of low-income jobs should recover too," Mishra said on Thursday. While warning that high energy prices could be a headwind, Mishra said the economy has the capacity to sustain faster import growth. The pace of growth might moderate if imported energy prices (crude oil, gas, coal, fertiliser and palm oil) remain high.

Another drag could be low employment/ re-employment in some key sectors like education, travel, construction materials and auto manufacturing, which are not yet back to the pre-pandemic levels. However, these should improve as the economy continues to open up, helped by high seroprevalence, he pointed out. According to him, other positives for higher growth is the recovery in consumer spending, strong equity fund-raising that has helped repair the risk capital that was lost during the pandemic, growing IT demand globally and the resultant around 5 lakh hiring in the offing and the pickup in dwelling construction.

On the markets, he said since the country's price-to-earnings premium of 21 percent over global equities and 72 percent over the emerging markets is already too high, further upside in the metric is unlikely.

"This is really good news, given the many supply chain problems," Jandura said. However, he added that logistical problems were likely to persist into the months ahead with a shortage of containers and skilled staff — and local coronavirus outbreaks.

According to Destatis, German exports were up 8.1% on the previous October, and also back above the pre-coronavirus crisis levels of February 2020 when seasonally adjusted.

Germany exported €121.3 billion (\$137.4 billion) worth of goods in October, 4.1% more than in the previous month when seasonally adjusted.

Exports to EU countries were up 11.6%, while exports to countries outside the bloc climbed by 4.1%. And exports to China, an important trading partner for Germany, were up by 8.5% year-on-year in October.

Meanwhile, imports surged 17.3% against the previous October, also 13.5% higher than in February 2020 before COVID restrictions started kicking in worldwide. Germany imported €108.5 billion worth of goods in October, 5% more than in the previous month.

The trade surplus fell to €12.5 billion from €12.9 billion in the previous month.

Sebastian Dullien, director of the IMK economic research institute, saw the data as a strong performance that could help Germany "avoid a mini-recession at the end of this year due to the fourth wave of the coronavirus."

China's Economic Growth in 2022 Seen at 5.3%

BEIJING (Dispatches) - China's economy is expected to grow around 5.3 percent in 2022 following an expected 8 percent growth this year, a top government think tank said. According to the blue book on Chinese economy forecasts by the Chinese Academy of Social Sciences, policymakers should set a 2022 economic growth target above 5 percent, giving them more room to deal with challenges and focus on pushing reforms and boosting high-quality development.

The blue book's release coincided with a market eagerly waiting for clues to next year's economic policy agenda from the annual Central Economic Work Conference, which will be held later this month.

Li Xuesong, director of the Institute of Quantitative and Technological Economics, which is part of the CASS, said the recommended target of above 5 percent growth next year will leave some room for leeway, which will allow all the parties concerned to focus on promoting reform, innovation and high-quality development.

Citing the new blue book, Li said policymakers need to take more steps to shore up growth in 2022 amid downward pressure, with focus on moderately increasing countercyclical adjustments and enhancing cross-cyclical adjustments.

Countercyclical tools seek to offset possible negative effects of economic cycles like a slowing economy by adding stimulus to stoke growth. Such tools could involve tax, credit, monetary, government expenditure and industry policy.

Cross-cyclical tools like interest rate cuts/hikes and higher/lower investment in infrastructure underline small but prompt measures to achieve long-term goals, depending on whether the economy is slowing or accelerating currently.

"China's fiscal policy needs to remain proactive in 2022, with a focus on promoting its efficiency and quality, especially in fields like industrial upgrade and urbanization," Li told a news conference in Beijing. "And a prudent monetary policy should focus on stabilizing credit growth and dealing with inflation."

Given the grim and complicated economic situations at home and abroad, the government should make a big push to ensure stable prices and supplies, strengthen the industrial and supply chains, effectively prevent and control the COVID-19 pandemic, continuously boost technological innovation, effectively expand domestic demand, prepare to fend off risks and expand reforms and opening-up in key fields, Li said.

The blue book said the expected 5.3 percent growth in 2022 will bring the average annual growth rate forecast for the 2020-22 period to 5.2 percent, higher than the figure of 5.1 percent from 2020 to 2021.

The blue book estimated China's overall prices will rise moderately in 2022, with the producer price index and the consumer price index increasing 5 percent and 2.5 percent, respectively. And imports and exports in 2022 are expected to grow 10.4 percent and 6 percent, respectively.



"We expect the macroeconomic policy stance to ease in response to the downward pressure on growth," said Louis Kuijs, head of Asia economics at Oxford Economics, a think tank.

"We think policymakers have a bottom line for GDP growth, which is currently probably around 5 percent year-on-year... With our forecast seeing GDP growth dipping to 3.6 percent year-on-year in Q4(fourth quarter), we expect policymakers to take more steps to shore up growth in late 2021 and early 2022."

Kuijs said the overall real investment is expected to edge up in 2022 due to the rise in infrastructure investment and resilient manufacturing investment. "In this setting, we expect 5.4 percent GDP growth in 2022, following an expected 8 percent in 2021." Kuijs estimated that export growth may slow in 2022, following an exceptional 2021 performance.

"While there have been efforts (in some developed economies) to 'decouple' from China, the relatively strong performance of China's export-oriented manufacturing sector during COVID is limiting the shift of production. China's global market share has risen in 2020-2021," he said.

"With foreign demand growth slowing and foreign spending shifting more to services, we expect China's export growth to fall to 5 percent in real terms, from 17.3 percent in 2021."

Asia Pacific's Monetary Policy to Diverge in 2022



SINGAPORE (Dispatches) - Monetary policy in the Asia Pacific region will continue to diverge next year as rich countries raise rates to battle inflation and emerging economies keep rates low, according to a new report.

South Korea and New Zealand's central banks are likely to tighten policy due to inflation concerns in 2022 after twice hiking rates this year, according to a research briefing by Oxford Economics released on Wednesday.

The Reserve Bank of New Zealand will lift the benchmark rate by 125 basis points to 2.25 percent, with the Bank of Korea to announce two 25 basis-point hikes to bring the policy rate to 1.5 percent, Oxford Economics predicts. The Reserve Bank of India is also expected to raise its policy rate by 25 basis points in the first quarter to 4 percent. "The new Omicron variant has increased the risks around the monetary policy outlook. If the variant dampens demand more than it exacerbates supply-chain disruptions, it could prove disinflationary," Sian Fenner, the lead Asia economist, said in the briefing. "But the reverse is equally true. Thus, we see most central banks prioritising growth and not shifting policy material." Southeast Asian economies including Malaysia, Thailand, and the Philippines are considered unlikely to raise rates before 2023 due to gross domestic product remaining 4-6 percent below pre-pandemic levels. Indonesia is not expected to consider a rate hike until after the US Federal Reserve raises rates, which is not expected until September 2022. "We forecast core and headline inflation to trend higher over 2022, but we still expect inflation, on average, to remain below central banks' medium-term inflation targets," Fenner said. "As such, central banks have the room to prioritise supporting their nascent recoveries." China is considered unlikely to raise rates in 2022 after adopting accommodative policies this year to boost flagging economic growth, according to the briefing, as authorities "remain keen on containing financial risks and leverage". But Trinh D Nguyen, a senior economist at Natixis, told Al Jazeera she expected more broad-based tightening across the region.

Germany Invests Additional €20m in the UNDP Accelerator Labs

"We are trying. We should not be that pessimistic. We are working with our Foreign Office colleagues maybe to reach that deal. We are in the process of discussions. Last week there was a delegation from the UK in Iran and personally I was talking to the Foreign Office and I am hopeful we will reach an agreement."

Referring to reports that the money could be paid in the form of humanitarian aid, he said: "It's not aid. Our money is here and we want our money. That is very simple. We want to receive our money. We are not insisting on interest. Otherwise it would be billions. We are talking to our UK colleagues as to which channel are the most probable to transfer that money to our accounts."

Asked if the U.S. could give a letter of comfort to the UK to guarantee the payment would not be sanctioned, he said: "The U.S. is not doing that. They have to help the UK government to do that. It is not impossible. Obstacles are not insurmountable, but we have to discuss, negotiate and find a way. We are now discussing through what channel that money be transferred. There is a negotiating process now."

He also stressed that the issue of the detainees' release was a matter for the Iranian judiciary, and could not be mixed up with the wider issue of the Iran nuclear talks in Vienna.

In response to the Iranian ambassador's remarks a Foreign, Commonwealth and Development Office spokesman said: "We continue to explore options to resolve this 40-year-old case and will not comment further as discussions are ongoing."

Foreign office sources stressed that the UK recognizes that it legally owes a debt to Iran, but said it was unhelpful to connect wider bilateral issues with those unfairly detained in Iran.

Meanwhile, the Russian lead negotiator has said Iran and the P4+1 group of countries -- Britain, France, Russia, China and Germany -- are working on the text of a "final document" during the talks.

"It will take time and a lot of efforts but participants are result-oriented," the Russian ambassador to international organizations in Vienna, Mikhail Ulyanov, said in a post on his Twitter on Friday.

The Russian Foreign Ministry said in a statement on Friday that all participants in the talks once again expressed determination to put maximum effort for restoring the JCPOA in its original form. "All sides reaffirmed their intention to pay maximum effort with the goal of finally defining practical steps, needed to re-launch the extensive implementation of JCPOA in its initial form, without additions or deletions."

It added that Iran and the P4+1 group of countries decided to continue intense contacts, including at the level of experts, within the framework of working groups on the removal of US sanctions and nuclear issues.

He added that all military equipment for the boats, including missiles, rockets, and radar systems, have been manufactured by IRGC specialists.

She stressed that such bans hinder humanitarian assistance and create humanitarian crises around the world.

"We strongly reject the imposition of UCMs by a number of certain states as a political leverage, especially during the COVID-19 pandemic. Even in times of the deadly coronavirus, the United States' illegal and inhumane unilateral coercive measures have targeted innocent Iranian citizens by freezing our assets in foreign banks – the assets which we desperately wanted to use for the provision of vaccines and other humanitarian needs," the Iranian envoy said.

Ershadi also noted that humanitarian aid must be distributed across the world fairly and without any interference by donors.

"We strongly condemn situations wherein the humanitarian needs of populations in dire needs are taken hostage as a political mean or military tool, including by imposing blockages to starve to death civilians. Furthermore, the United Nations must assure that all humanitarian aid should be distributed among all populations in need indiscriminately and without any interference by donors," she further said.



Iran feeds gas into Iraq through two pipelines used to power plants in Basra, Samawa, Nasiryah and Diyala. Generation from these plants also plummeted, suggesting supply from Iran in these plants is also low. The impact has been immediate.

In Basra, the province requires 4,000 megawatts but is currently receiving 830 MW.

Iraq owes Iran billions of dollars for energy imports. The country' economic crisis has in part caused payment delays. A complex scheme designed to evade U.S. sanctions has slowed down transfers to pay for imports.

Through the scheme, Iraq is unable to pay Iran directly for the imports, but can pay for goods, medicines and other expenses related to Tehran's diplomatic mission and Iranian companies working in Iraq. In early 2021, Iraq purchased vaccines for Tehran.

But Iran has complained the money is trickling in too slowly.

Grizzlies Maul Lakers Jazz Outpace 76ers

OS ANGELES (Dispatches) - Jaren Jackson scored 25 points and Desmond Bane added 23 as the Memphis Grizzlies withstood LeBron James's 100th career triple-double in a 108-95 NBA victory.

Lakers superstar James scored 20 points, pulled down 10 rebounds and handed out 11 assists and Anthony Davis added 22 points for Los Angeles, but it wasn't enough as the Lakers coughed up 22 turnovers to fall to a Grizzlies team still missing top scorer Ja Morant and also without defensive stalwart Dillon Brooks.

But they led by six at halftime and pulled away in the fourth quarter as the uneven Lakers found themselves unable to build on their comfortable victory over the Boston Celtics on Tuesday.

"Our biggest battle, our biggest problem this year is consistency," said Lakers coach Frank Vogel. "Once we take one step forward we fall back, we have a disappointing performance. We have to find a way to catch ourselves from that."

James said the turnovers, which led to 27 Grizzlies points, were key.

"Tonight turnovers killed us," he said. "We were doing a hell of a job over the last seven games averaging only 12.5 turnovers. Tonight we had 22 for 27 points. "That's been our Achilles heel before the last seven games, and tonight it bit us

in the butt." At 13-13, the star-studded Lakers are in sixth place in a Western Conference in which the Golden State Warriors and Phoenix Suns are jockeying for supremacy and the best record in the league.

The Utah Jazz tightened their hold on third place on Thursday with a 118-96 victory over the 76ers in Philadelphia, where French center Rudy Gobert laughed off critics with a dominant display.

Gobert scored 17 points and pulled down 21 rebounds for the Jazz, who pushed their winning streak to six games.

Donovan Mitchell led the Jazz with



22 points -- one of eight Utah players to score in double figures in the second night of a back-to-back for both teams.

Utah were coming off a 136-104 victory over Minnesota on Wednesday, after which Timberwolves guard Anthony Edwards insisted that Gobert -- a three-time NBA Defensive Player of the Year, "put no fear in my heart."

Gobert acknowledged that he'd heard the comments, but said they didn't provide an extra spur. "I'm motivated every night," Gobert said.

"It's more funny than anything. People love to take shots at me for no reason. I never take shots at anyone, I just come in and do my job every night. When you're the best in the world at something, people become insecure.'

The Jazz were fuelled by 15 three-pointers, five of them from Mitchell. They also held the edge in points in the paint, pushing their lead to as many as 23 in the fourth quarter.

Joel Embiid had 19 points and nine rebounds for Philadelphia. But 11 of those points came in the first quarter and Embiid was bothered later by pain in his right side, visiting the locker room in the second half but returning to the game.

"I honestly don't know, but it was pretty painful," Embiid said of the trouble. "I'm not sure what happened."

Despite the uncertainty, Embiid said he thought he'd be ready when the 76ers host the Warriors on Saturday.

"I'll be fine," he said.

MELBOURNE (AFP) - Ashleigh Barty will return to action for the first time in four months at Adelaide in January while Naomi Osaka and Rafael Nadal kickstart their Australian Open build-up in Melbourne, officials said Friday.

Barty hasn't played since a shock third-round loss at the US Open in September, but the Australian still finished 2021 as world number one after a season in which she won five titles.

The reigning Wimbledon champion headlines an Adelaide International field that boasts nine of the world's top 10 women, including Iga Swiatek, who will be defending her title.

Former world number ones Garbine Muguruza, Karolina Pliskova and Victoria Azarenka are also entered for the January 2-9 event, along with world number two Aryna Sabalenka. The only top 10 player missing in Adelaide will be seventhranked Estonian Anett Kontaveit.

Defending Australian Open champion Osaka, who has slipped to 13 in the world, will play at the Melbourne Summer Set event from January 3-9, which features simultaneous women's and men's tournaments.



That means Verstappen can be champion without needing to score another point if Hamilton also draws a blank at Yas Marina.

The pair have collided on track three times already this season.

"I don't give it any energy," Hamilton told reporters after appearing with Verstappen in a Thursday news conference with the championship trophy placed between them.

Drivers Are All a Bit Crazy

"We never thought we would be neck and neck going into the last race, we've had an amazing recovery collectively as a team... we don't waste energy on things that are out of our control.

Reminded that he had labelled Verstappen 'crazy' and 'dangerous' during last Sunday's chaotic Saudi Arabian race, when he ran into the back of the suddenly slowing Red Bull, Hamilton played down those comments.

"When we are in the races we say all sorts of things," he explained.


"We are in the heat of the moment, the adrenalin is firing, your emotions are on edge... I think ultimately us racing drivers we're all a bit crazy to be able to do what we do and take the risks that we do.'

Asked if he trusted Verstappen to race fairly, Hamilton swerved.

"At the end of the day, I do believe everyone here racing comes to win," he said. "I would like to believe everyone wants to do it in the right way, so I don't even let that creep into my mind."

U.S. President Joe Biden's administration has maintained pressure on China over various issues including human rights and China's maritime claims in the South China Sea.

Wang pointed out that the United Nations on Dec. 2 adopted a resolution, co-sponsored by more than 170 of 193 member states, for an "Olympic Truce" calling on states to rise above politics and unite in sports during the Beijing Games.

"Quite a few" foreign leaders and members of royal families had registered to attend, he said.

Russian President Vladimir Putin is the only leader of a major country who has publicly accepted an invitation. Wang said the United States and its allies would "pay the price for their mistaken acts" and they had "used the Olympics platform for political manipulation".

To Criticize Rules And Officials

ABU DHABI (Dispatches) - Max Verstappen continued his criticism of Formula One rules and officials ahead of the title showdown in Abu Dhabi, saying he has been singled out for sanctions.

The 24-year-old Dutchman, who was penalised twice in last Sunday's Saudi Arabian Grand Prix, said he is punished for his driving style and that others, who drive in the same aggressive and unforgiving way, are not.

He also claimed that FIA Race Director Michael Masi's official pre-race warning about driving standards and possible sanctions was intended to apply for him alone in a race which Verstappen and Lewis Hamilton start level on points atop the driver standings.

"Well, clearly, these don't apply for everyone," he said. "That's because the things I did in terms of defending, two other guys, in terms of racing, also did, and they didn't even get a mention, or penalty.

"I don't understand because I thought I was just racing hard. What happened, for me, didn't deserve any penalty. Really, the other two people who did it, they didn't get one. "It's only me who gets it and, of course, fighting up the front, people were more critical, I guess. For me, I don't understand ... '

His abrasive stance and mood ahead of Sunday's title decider at the Yas Marina Circuit demonstrated that he had not reconciled himself to last weekend's events or the widespread paddock perception that he had gone 'over the top'.

Verstappen was handed a five-second penalty for running wide at Turn One and 10 seconds for an incident that was perceived as him 'brake-testing' Hamilton when trying to slow to allow him to pass, as demanded by the race officials.

Leave Man Utd **In January**

ONDON (Dispatches) - Anthony Martial wants to leave Manchester United in the January transfer window after struggling to get game time at Old Trafford this season, according to his agent.

The 26-year-old France forward, who joined United from Monaco in 2015, has started only two Premier League games this season and has scored just once.

Martial's representative, Philippe Lamboley, executive director of USFA Management, told Sky Sports News: "Anthony wishes to leave the club in January.

"He just needs to play. He doesn't want to stay in January and I will speak to the club soon." Martial still has at least three years left on his contract at Old Trafford, having signed a new deal in 2019 that includes an option to extend for a further year.

He has fallen down the pecking order at United, who have an array of attacking talent to choose from, including Cristiano Ronaldo, Edinson Cavani, Marcus Rashford, Jadon Sancho and Mason Greenwood.

While he did not mention Martial by name, United interim manager Ralf Rangnick hinted there could be departures in January when he was asked about the bloated size of his squad today.

"It's still a big squad. We need to make sure that players want to stay here," he said. "If they see they are not getting enough game time here it might make sense to speak to players individually and see if a loan deal might make sense, but right now it's too early." Rangnick also revealed that injured United midfielder Paul Pogba is still around four

weeks away from returning to action.

Pogba has been undergoing recovery work in Dubai after suffering a thigh injury on international duty with France last month.
