FM Hopes JCPOA Talks Will Lead to Good Agreement

TEHRAN (PressTV) - Iranian Foreign Minister Hossein Amir-Abdollahian says he hopes the ongoing talks between Tehran and the P4+1 group of countries on the revival of the 2015 deal in the Austrian capital of Vienna will lead to a "good agreement in the near future."

Speaking in Germany on the sidelines of the 58th Munich Security Conference (MSC), Amir-Abdollahian said the meeting would be an opportunity to announce the Iranian administration's foreign policy and its stance on regional issues, not least the current crises in West Asia.

"As for the Islamic Republic of Iran and the active initiatives it has put on the negotiating table, we are very close to a good agreement.'

"But it is the Western parties that must show their true initiative and flexibility and determine these negotiations will lead to a result within the next few days or weeks (with their approach to Iran's initiatives)."

The top Iranian diplomat emphasized that there are still some outstanding issues in the Vienna talks but Iran's lead negotiator Ali Bagheri Kani and members of his team would continue the negotiations with seriousness in order to reach a good agreement. See Page 7

TEHRAN – New report shows that the value of trade between Iran and the European Union reached €4.863 billion in 2021, registering a nine-percent growth compared to the previous year.

According to the data released by the European Union's statistics office Eurostat, the trade between Iran and the European Union during 2020 stood at €4.458 billion, Tasnim news agency reported.

Iran exported 122 million worth of commodities to the union during January-December 2021 to register a 29-percent rise year on year.

Based on the released data, the exports from Europe to the Islamic Republic in the said year also increased by five percent, standing at €3.941 billion.

Iran had imported €3.745 billion worth of commodities from the European Union states in 2020, while exporting \notin 713 million to the region.

Åmong European countries, Germany was Iran's top trading partner in 2021, accounting for about a third of Iran's trade with the European Union. Germany exported € .449 billion worth of goods to Iran while importing €274 million worth of commodities from the Islamic Republic. The country's total trade with Iran was 1.723 billion euros.

Italy was Iran's second-biggest trading partner with €628 million euros of commodity exchanges. The country exported €450 million worth of goods to Iran while importing €178 million worth of products from the country. The Netherlands stood in third place with a trade of €481 million. The country exported €443 million euros worth of goods to Iran and imported €38 million.

Iran mainly exports foodstuff and livestock, beverages and tobacco, raw materials, mineral fuels, and vegetable oils to the European countries, while foodstuff, beverages and tobacco, mineral fuels, vegetable oils, and chemicals are also the main products imported from the union.

The value of trade between Iran and the European Union had reached €3.4 billion during the first nine months of 2021, a two-percent growth compared to the same period last year.

According to the data released by the Tehran Chamber of Commerce, Industries, Mines and Agriculture (TCCIMA), Iran exported €54 million worth of commodities to the union during the said nine months, while importing goods valued at €2.7 billion.

Last week the U.S. administration had a controversial decision which shocked the world, and even some of its allies have criticized this decision and called it "theft".

U.S. President Joe Biden's decision to effectively seize the Afghan central bank's funds in the United States and repurpose half of the money as compensation to the victims of the 9/11 attacks drew rebuke and accusations of "theft" against Washington.

Biden issued an executive order last Friday that would split \$7.1b belonging to Da Afghanistan Bank (DAB) almost evenly between humanitarian assistance to the struggling country and funds to cover judgments from lawsuits that 9/11 victims and their families had filed against the Taliban in U.S. courts.

This arrogant decision drew criticisms from friends and foes of the U.S. "The people of Afghanistan had nothing to do with 9/11; that is an undeniable fact," Bilal Askaryar, an Afghan-American activist, told Al Jazeera.

"What Biden is proposing is not justice for 9/11 families, it is theft of public funds from an impoverished nation already on the brink of famine and starvation brought on by the United States' disastrous withdrawal." The U.S.-backed Afghan government collapsed in August

of last year, with the Taliban capturing Kabul amid the pullout of US troops from the country after a 20-year war. Washington, which had negotiated its withdrawal

with the Taliban, quickly moved to freeze DAB's US-based assets. The 9/11 victims' families then sought the money through the courts. One particular case that had obtained a default judgment against the Taliban in 2012 became central in that effort.

The plaintiffs originally sued a host of entities and individuals across the Middle East and Afghanistan many at odds with one another and adversarial to al-Qaeda, which carried out the attacks in 2001. The defendants included former Iraqi President Saddam Hussein, Lebanon's Hezbollah, Iran's Supreme Leader Ali Khamenei – and the Taliban. See Page 7

Iran Warns Europe Over Supporting MKO Terrorists

TEHRAN (PressTV) - A senior Iranian Judiciary official has warned Europe that its support for the anti-Iran terrorist Mujahedin-e-Khalq Organization (MKO) will come at a price just as it did with the Daesh Takfiri terrorist group.

Kazem Gharibabadi, the Judiciary chief's deputy for international affairs and secretary of the country's High Council for Human Rights, on Friday censured the European Parliament for supporting the MKO and referring to it as 'political opponents'.

It is shameful for members of the European Parliament to pursue their own political interests and turn a blind eye to the crimes committed by the MKO, which has killed over 12,000 innocent Iranians and still continues its terrorist activities while freely traveling through European countries, he said.

"The Europeans should know that as their support for Daesh has backfired on them in a way that more than 4,000 Daesh members were European citizens and created insecurity for them, their support for the MKO will equally be costly," the senior Iranian human rights official said. See Page 7

OPEC+ Would Seek to Bring Iran Into Oil Supply Deal

LONDON (Dispatches) - OPEC+ will work to integrate Iran into its oil supply-limiting accord should agreement be reached on reviving its nuclear deal with world powers, sources close to the group said, seeking to avoid market share competition that could hit prices.

A successful outcome to the talks could lift U.S. sanctions on Iran's exports, according to the International Energy Agency, potentially bringing 1.3 million barrels per day (bpd) of Iranian oil back into the market. That could ease tight global supply and take some heat out of a rally that has taken benchmark prices to just a few dollars short of \$100 a barrel.

Due to the impact of sanctions on its exports, Iran is exempt from the existing deal between the Organization of the Petroleum Exporting Countries and allies, known as OPEC+, to limit oil supply. While that exemption allows Iran to boost output, OPEC+ would eventually seek to bring Iran into the accord, sources said.

"It is very likely OPEC will adjust Iran into the deal, as there is no other option," said an OPEC+ source, who added that an agreement on reviving the nuclear accord looked close.

A source familiar with Iranian thinking said Iran would first seek to restore its lost output, but would likely, after talks with OPEC+, agree to a quota. Iran is one of the five founding members of OPEC.

Iran is pumping about 2.5 million bpd, some 1.3 million bpd less than in 2018 when former U.S. President Donald Trump withdrew the United States from the nuclear accord and re-imposed sanctions, drastically cutting Tehran's oil income.

"With the lifting of sanctions, Iran will increase its oil production according to its facilities, capabilities and interests, to compensate for its lost oil revenues," the source familiar with Iranian thinking said.

"In my opinion, OPEC+ will set a quota for Iran's oil production but will apply it gradually, and Iran will accept the quota with some bargaining to show its support for OPEC."

OPEC Secretary General Mohammad Barkindo, asked if OPEC+ would work out a new supply agreement that included Iran, said the group's track record gave grounds for confidence. "Having survived the last five years since the establishment of the historic partnership between OPEC and non-OPEC that helped us to navigate through two oil cycles, we have every reason to remain reasonably optimistic going forward," he told Reuters.



Demand for Russian Grain Growing in Iran

TEHRAN - The demand for Russian goods in Iran is growing from year to year amid shortage of areas under crops and growing consumption in the country, Chairman of the Russian-Iranian Business Council Vladimir Obydenov told TASS in an interview.

"The demand for grain from the Russian Federation is growing increasingly in view of shortage of cultivation areas and rising consumption," Obydenov said. "It is worth to remind that Iran came out on top among Russian grain buyers in 2021. It is obvious such trend will continue." he said.

"The Russian market is being progressively filled with Iranian goods," the chairman said. "Fruits and vegetables of high quality from Iran are slowly but steadily consolidating their hold on shelves of our stores, competing increasingly with products from Turkey, Egypt and Azerbaijan," he noted.

"Iranian industrial goods: petrochemical products, laundry and home care and construction materials are gradually taking their niche in Russia," Obydenov added.

President Calls for Smart Monitoring for Containing COVID

TEHRAN – President Seyed Ebrahim Raisi stressed the need for more rigorous implementation of health protocols and the implementation of intelligent controls to counter the growing trend of coronavirus pandemic.

Speaking on Saturday at the meeting of the National Task Force Against Coronavirus, Raisi appreciated the efforts of all agencies and medical staff across the country in the fight against the disease, and said, "Although the situation of coronavirus in the country is much better than in the past, but the amount of cases and deaths is very high and urgent action must be taken to deal with it".

The President called on the people to strictly observe health protocols and to refrain from gatherings, and stressed to the authorities, "By no means should the rise in the number of infected people, especially corona victims, become commonplace, both for those involved and for the people".

"The death of even one person because of corona is high and should not happen. Justifications such as the fact that in the past the death toll had risen to 700 should never lead to the normalization of the pandemic conditions," he said.

Raisi also stated, "The Ministry of Roads and Urban Development and other related agencies such as municipalities ought to follow health protocols carefully on flights, subways and other means of public transport".

"We must not allow the lives of people, especially children, to be endangered by neglecting to follow health protocols," he said, referring to the rising incidence of children with the new variant of coronavirus.

In another part of his speech, Raisi emphasized the validity of the previous resolutions and decisions of the National Task Force Against Coronavirus.

In the end, Raisi once again stressed the need to strictly follow the health protocols



and added, "In addition to following the guidelines, intelligent controls must be fully implemented to significantly reduce the incidence of corona".

In this meeting, it was decided that the kindergartens will be closed for another week and the telecommuting of working mothers who have young children will be extended for another week.

Meanwhile yesterday, in order to support production in carrying out the recent orders of the Supreme Leader of the Revolution, President Raisi issued instructions to prevent and combat the smuggling of goods and currency.

FM Warns of Afghan Refugee Crisis, Yemen Disaster

TEHRAN (PressTV) - Foreign Minister Hossein Amir-Abdollahian has warned of the burden of a new wave of refugees from Afghanistan in the aftermath of the Taliban takeover of the Central Asian country and also stated that the ongoing Yemen crisis has reached a critical point that requires concerted international efforts.

Amir-Abdollahian made the remarks in a meeting with United Nations Secretary-General António Guterres on the sidelines of the 58th Munich Security Conference (MSC) in southern Germany on Friday evening.

The Iranian foreign minister stressed the need for the continuation of humanitarian assistance to the Afghan people and the formation of an inclusive government in Afghanistan with the involvement of all ethno-political groups in order to effectively address the lingering problems in the country.

He pointed to the continuing influx of refugees from Afghanistan, warning that the trend could result in the spread of terrorism as well as illicit drug production and trafficking, which would subsequently undermine regional and international stability and security.

The top Iranian diplomat also called for greater assistance by the United Nations High Commissioner for Refugees (UNHCR) to Afghanistan's neighboring states, including Iran.

Afghanistan has been in the grip of a major humanitarian disaster, worsened by the freezing of assets worth billions of dollars by the United States and its allies.

Since last August, international aid, which financed nearly 80 percent of the war-ravaged country's budget, has been suspended and nearly \$9.5 billion in assets belonging to Afghanistan's central bank have been frozen by Washington, contributing to the pitiable plight of millions of Afghans.

This is while unemployment has skyrocketed in the country and civil servants' salaries have not been paid for months, as banks are out of cash and the government is grappling with a dearth of funds.

Amid the rapidly deteriorating humanitarian situation, hunger now threatens 23 million Afghans, or 55 percent of the total population, according to the UN.

Amir-Abdollahian also pointed to the ongoing Yemen conflict, saying the crisis has reached a "critical point." "Efforts should be increased in order to reach a political solution to the [Yemen] conflict and prevent the deterioration of the humanitarian catastrophe there," he added.

Tehran Dismisses Bogus Rumors of Chinese Military Deployment

TEHRAN (IFP) - The Iranian Oil Ministry has dismissed rumors of China's military deployment to Iran to protect its energy projects there, saying such claims could be a reaction to Tehran's gains from enhanced economic ties with Beijing.

"Over the past days, rumors have resurfaced about the deployment 5,000 Chinese security forces to the sidelines of oil and gas projects being implemented by Chinese firms," the ministry said in a statement on Friday.

The projects are part of the 25-year partnership deal between Iran and China in a variety of sectors. In mid-January, the sides announced the launch of the agreement, which has sharply irked the Western states.

The statement said such "amateurish news fabrication" came earlier from certain businessmen supporting the ex-Iranian administration. This time, the rumors were spread by British media outlets covering oil and gas news, it added.

"The spread of such rumors are related to the [Iran's] success in paving the ground for attracting investments in recent months as well as to a remarkable rise in Iran's oil exports," the statement added.

It said such rumors are in the first place designed by certain "domineering" countries in order to harm Iran's relations with other world countries. The rumors then get circulated by currents that seek unconditional submission to the West's cruel demands, it added.

TEHRAN - Agriculture Minister Javad Sadatinejad in meeting with visiting Brazilian Minister of Agriculture, Livestock and Supply Ms.Tereza Cristina called for balancing the current trade between Iran and Brazil which is currently in favor of Brazil considerably.

In the meeting, Sadatinejad said that unfortunately there is no trade balance between Iran and Brazil and major part of Brazil's imports from Iran is urea fertilizer and only 2% of Iran's agro products are exported to Brazil while agro products account for 50% of Brazil's exports to Iran. He called on Brazilian minister to promise on working on promoting Iranian agro products in Brazil, and for the long-term plan both countries use ship- against-ship policy.

Sadatinejad reiterated the lowest amount of pesticides or fertilizers are used in Iran's agro products and they are predominantly organic and holding joint exhibition is a good idea that Tehran welcomes it. He added Iran is neighboring with 17 countries and it can be a hub for livestock inputs in the region and Iran can distribute Brazilian inputs in its neighboring states.

He added that cruel sanctions have increased pressures on the people but the nation has stood against it considerably. He added that barter trade is the best means to skirt sanctions to resolve payment. He noted Brazil is one of the major urea and phosphate fertilizers consumers in the world as everybody knows well that Iran is one of the biggest producers of these petrochemical products in the world.

He reiterated that Iran has billion tons of phosphate soil which can be exported and the two countries can work to provide the ground for exports of Iranian agro products to Brazil. Sadatinejad noted that Iran seeks strategic approach for providing national interests of both countries and pursue it seriously.

He said one of the hurdles is the tariff system of Brazil, adding that Brazil has levied 120% tariff on Iranian agro products while Iran's tariff is only 4%. He also criticized the bureaucratic process in way of trade between the two countries and called for its removal, adding that both countries should provide the ground for activating the preferential trade between the two states and expand barter trade. He reiterated that Iran has turned into a hub in the world for procuring urea and Brazil is one of the top producers of livestock inputs.

He also called for establishing the trade line for pistachio and saffron between the two countries and preparing a long-term roadmap in the field of agriculture is very important for both countries.

Then Brazilian Minister Cristina said that the trade tie between Iran and Brazil is in good point and they can expand it as both countries have progressed well in agro and foodstuff sectors.

She went on to say that her country was not yet self-sufficient in producing wheat and Iran could supply part of that if it were interested.

Cristina said Brazil intended to increase imports from Iran while exporting to the country achieving a leveled economic exchange.

By 2050, food demand will increase by 60 percent, and food-supplying countries need to make progress and come up with new ways to grow and harvest," Brazil's agriculture minister recalled.

Cristina stated that the purpose of her trip to Iran is to increase bilateral relations between the two countries in the field of agriculture.

Noting that Brazil is currently buying urea chemical fertilizers from Iran, which is important for the agricultural sector, Brazilian senior official added Brazil needed fertilizers to boost the production of sugar cane which is the main part of the Brazilian agriculture.

The Brazilian minister noted that direct and face-to-face talks could help resolve issues between the two countries, saying: "Because of the technology capacity and the ground we have, Brazil is ready to attract Iranian investors."

"Iran imports materials from rival countries that we can import to Brazil at a competitive price," she said, " Rice is exported to Iran in small quantities; Sugar or cotton in the same way; we can interact more in this area.'

The Brazilian agriculture minister said her country didn't much care about the sanctions and that she believed the development of the Tehran-Brasilia must be focused on boosting bilateral interests.

At the end of the meeting Sadatinejad and Cristina signed a MoU on developing agro cooperation between Iran and Brazil.

Forming Joint-Stock Cooperative Best Way of Privatization of Tehrani Soccer Clubs

IME Posts Higher Records in Value and Volume of Trades **IRAN NEWS ECONOMIC DESK**

TEHRAN Iran Mercantile Exchange (IME) last week witnessed trade of 2,514,000 tons of commodities with a total trading value of almost \$702m, posting growths of 39% in volume and 40% in



value of trades compared to the figures of the previous week. According to a report by the IME's International Affairs and PR, the exchange traded on its metals and minerals trading floor 2,200,000 tons of commodities valued at almost \$472m. Commodities sold on this floor included 1,059,000 tons of cement, 626,000 tons of iron ore, 400,486 tons of steel,

92,000 tons of sponge iron, 10,000 tons of cast iron, 7,100 tons of aluminum, 6,980 tons of copper, 1,000 tons of coke, 935 tons of zinc ingots, 150 tons of molybdenum concentrate, 21 tons of precious metals concentrate and 1 kg of gold bars. Furthermore, the IME saw trade 304,048 tons of commodities on both domestic and export pits of its oil

and petrochemical trading floor valued almost \$222m. The exchange customers purchased on this floor 116,840 tons of bitumen, 90,265 tons of polymeric products, 45,000 tons of vacuum bottom, 24,000 tons of lube cut, 22,907 tons of chemicals, 3,750 tons of sulfur, 2,609 tons of base oil, 800 tons of slops wax and 150 tons of argon.

TEHRAN - According to the Iranian Supreme Audit Court, the owners of expensive and empty housing units paid no taxes in the first ten months of 1400. According to a continuous report by the court, despite the designation of "the end of February [this year] as the deadline for depositing taxes on expensive residential units" in the budget law of 1400, the amount of its materialization by the end of January was still zero percent and the amount of tax collection on "uninhabited residential units" was also lacking due to its "failure to ratify the executive regulations". Mahmoud Mahmoudzada, deputy minister of roads and urban development, announced on December 9 that two million and 300,000 vacant housing units were identified in the country and said that the acquisition of 900,000 units was in the hands of government agencies. Mahmudzadeh had said this April that Iran had 10 times more empty homes than England. The existence of so many empty houses in the country that do not pay taxes is announced by the Iranian authorities, while the Central Bank of Iran in November published a report on the growth of 50 to 55 percent of rents in Tehran and its suburbs.

Steel Ingot Output Volume Exceeds 29m Tons

TEHRAN (MNA) - A study of performance of major mining and mineral industrial companies shows that more than 29,765,707 tons of steel ingot and steel products were produced in country in the first 10 months of current Iranian calendar year.

According to statistics, large mining and mineral industrial companies managed to produce 18,001,873 tons of steel ingot and 11,763,834 tons of steel products in the first 10 months of the current year (from March 21, 2021, to Jan. 22, 2022), showing a four and three percent decline respectively as compared to the last year's corresponding period.

Another statistic showed that the country produced 42,835,030 tons of iron concentrate, showing a three percent growth as compared to the same period of last vear. In addition, 42,950,856 tons of conglomerate was produced in the country, registering an 11 percent hike as compared to the last year's corresponding period. These large companies also managed to produce 1,021,457 tons of copper concentrate during the same period, showing a two percent growth.

Six African Nations to Get Own mRNA Jab Production

BRUSSELS (AFP) - Six African countries have been chosen to establish their own mRNA vaccine production, the World Health Organization said Friday, with the continent largely shut out of access to Covid jabs.

Egypt, Kenya, Nigeria, Senegal, South Africa and Tunisia were selected as the first recipients of technology from the WHO's global mRNA vaccine hub, in a push to ensure Africa can make its own jabs to fight the Covid and other diseases. "More than 80 percent of the population of Africa is yet to receive a single dose. Much of this inequity has been driven by the fact that globally, vaccine production is concentrated in a few mostly high-income countries," WHO chief Tedros Adhanom Ghebreyesus told a ceremony on the sidelines of an EU-Africa summit in Brussels.

U.S. Unwilling to Adequately Perceive Russia's Key Security Demands



MOSCOW (Dispatches) - Te United States and other NATO countries are yet unwilling to perceive Russia's key security demands adequately, Russian President Vladimir Putin said after talks with his Belarusian counterpart Alexander Lukashenko on Friday.

The Russian leader said that at the request of his Belarusian counterpart, he briefed him on the latest contacts with the leaders of Western states on long-term and legally binding security guarantees for Russia from the United States and NATO. Putin said that he considered "it quite natural that the Belarusian allies are also concerned over this issue.

"We discussed the situation developing with regard to Russia's demands to the West whose key points stipulate that NATO should abandon its designs on eastward expansion, assume the commitment of not deploying strike weapons near the Russian borders and return to the alliance's military potential and infrastructure in Europe as of 1997 when the Russia-NATO Founding Act was signed. As I have already spoken about, the United States and other members of the alliance are yet unwilling, unfortunately, to perceive these three core elements of our initiative adequately," the Russian president said.

Mudslides, Floods Kill at Least in Brazil PETROPOLIS (Dispatches) - The death toll from number of victims of the tragedy. The police said more than 100 people are missing while the prosecutor's office said at least 35 people are missing. During the day, the local morgue was forced to use

a refrigerated truck as a back-up as more victims were being brought in while other bodies still awaited to be identified by their families.

Rio de Janeiro's civil defense head Leandro Monteiro worked overnight, with poor lighting on soggy ground to find survivors. He is among the more than 500 rescue workers, along with neighbors and relatives of the victims who are still searching for loved ones.

"I've been living here for 44 years and never saw anything like that... All my friends are gone, they are all lead, all buried," resident Maria Jose Dante de Araujo said. The downpours, which on Tuesday alone exceeded the average for the entire month of February, caused mudslides that flooded streets, destroyed houses, washed away cars and buses, and left gashes hundreds of meters (yards) wide on the region's mountainsides. It was the heaviest rainfall registered since 1932 in Petropolis, a tourist destination in the hills of Rio de Janeiro state, popularly known as the "Imperial City" as it was the summer getaway of Brazilian royalty in the 19th century.

Germany Cannot Supply **Ukraine Weapons**

MUNICH (Dispatches) - German Foreign Minister Annalena Baerbock defended her country's decision not to send weapons to Ukraine to fend off a possible Russian invasion, saying its World War Two past meant it had a duty to seek other ways to secure peace.

Germany was Ukraine's biggest donor, for example, Baerbock said in a panel at the Munich Security Conference with her U.S. counterpart Antony Blinken, who agreed that Western powers were working in a complementary, coordinated way. "This is our strength - we are standing all together but using our different roles of support, with

our different histories," Baerbock said.

Leading Edge Russian Forces At Ukrainian Border Gm MOSCOW (Dispatches) - Russia's claims it was pulling

forces back from the border are false, U.S. Secretary of State Antony Blinken said in a statement on Friday, adding that "on the contrary, we see additional forces going to the border including leading edge forces that would be part of any aggression."

Blinken also said that everything Washington has seen happening on Russia's border with Ukraine in the past 24 to 48 hours is part of a scenario of creating false provocations designed to elicit a response. The U.S. top diplomat was speaking at the Munich Security Conference alongside German Foreign Minister Annalena Baerbock.

Earlier on the same day, the U.S. ambassador to the Organization for Security and Co-operation in Europe (OSCE) Michael Carpenter said that Russia's buildup of military personnel threatening Ukraine probably totals up to 190,000 during a meeting on the Ukraine crisis.

Attack on Ethiopia Refugee Camp Kills Five

ADDIS ABABA (Dispatches) - Fighting in northern Ethiopia's Afar region has engulfed" a camp housing refugees from neighboring Eritrea, the UN said, killing five people and forcing thousands to flee.

The attack earlier this month is the latest blow to the more than 100,000 Eritrean refugees living in Ethiopia, whose camps have been repeatedly caught up in a grinding 15-month war.

It also underscores the growing toll of fighting in Afar, which has emerged in recent weeks as the most active front in the conflict pitting Prime Minister Abiy Ahmed's government against the Tigray People's Liberation Front (TPLF) rebel group.

Survivors of the Bahrale camp attack in Afar reported that "at least five refugees were killed and several women were kidnapped" after armed men entered on February 3, the UN refugee agency said in a statement.

"Family members lost one another in the chaos of fleeing the camp," the statement said. The Barahle camp is situated near the border between Afar and Tigray, the nome region of the rebels.

The TPLF controls most of Tigray and in January announced it had expanded operations into Afar, claiming it had been provoked by attacks on its positions by pro-government forces.

Friday's UN statement did not specify which forces the survivors had accused of targeting the camp.

However AFP interviewed several survivors this week in the Afar capital Semera who said they believed the TPLF was responsible. "I had never seen anything like that," refugee Mahamooda Ahmed said, recalling what he described as an assault on civilians, with no pro-government combatants in the area.

Niger, Mali and Burkina Faso have struggled to contain armed groups that have killed hundreds, displaced millions and made swathes of territory in the tri-border West African Sahel area ungovernable.

Maïkol Zodi, a leader of a movement that has been leading protests against foreign troops in Niger, said on Thursday that their presence was illegal.

"It is unacceptable and intolerable to accept this redeployment on our territory. If they do, we will treat them as an occupying force," Zodi said. Mali has struggled to regain stability since 2012, when ethnic Tuareg rebels and loosely aligned armed groups seized the northern two-thirds of the country. Forces from former colonial power France intervened and helped beat the armed groups in 2013, but the fighters regrouped in the desert and began carrying out regular attacks on the army and civilians. They have since exported their

methods to neighboring Burkina Faso and Niger where violence has skyrocketed in recent years, leaving a grave humanitarian crisis in its wake.

Britain Sees Record Investment in £10b Cyber Sector

LONDON (Dispatches) - British cyber security firms raised more than £1b in 84 deals last year, as foreign investors tapped into growth in capabilities such as network security and threat monitoring, government data showed. Companies that received new investment included Bristol-based Immersive Labs, which raised £53.5 million, and London-headquartered Tessian, which secured more than £52 million, the government said in its Annual Cyber Sector Report.



Employment across the industry rose 13 per cent, with more than 6,000 new jobs created, to bring the total number of people working in cyber in Britain to 52,700, the report said.



lation, Geopolitical Risks Threaten Rec LONDON (Dispatches) - Finance leaders from the Group of 20 major economies view inflation and geopolitical risks as threats to a

global recovery from the COVID-19 pandemic that already is "asynchronous" due to uneven access to vaccines, a draft communique obtained by Reuters showed.

The G20 finance ministers and central bank governors, meeting both virtually and in Jakarta, pledged in the draft to use "all available policy tools to address the impacts of the pandemic," but warned that future policy space was likely to be "narrower and uneven."

"We will continue to strengthen the resilience of global supply chains. We remain vigilant of the impacts of these challenges on our economies," the G20 finance ministers and central bank governors said in the draft statement, which will be finalized on Friday, when their meeting concludes.

"We will also continue to monitor major global risks, including those arising from (current) geopolitical tensions and macroeconomic and financial vulnerabilities," the ministers said.

The statement contained no direct reference to the crisis on the Ukraine-Russia border, and the word "current" in brackets indicates that it may be deleted. Russia is a member of the G20. Fears that Russia might invade Ukraine overshadowed the

start of a meeting that was expected to focus heavily on growing risks from inflation and monetary tightening to control it. Indonesian President Joko Widodo issued a direct warning that tensions over Ukraine could disrupt the recovery, adding "now is not the time for rivalry." Moscow has denied it is planning an invasion of its neighbor.

The finance leaders said in the draft communique that inflation is currently elevated in many countries, prompted in part by "supply disruptions, supply demand mismatches and increased commodity prices, including energy prices." "Central banks will act where necessary to ensure price stability in line with their respective mandates, while remaining committed to clear communication of their policy stances," the ministers and governors said, adding that central bank independence was crucial for credibility.

They confirmed a commitment to "well-calibrated, well-planned and well-communicated exit strategies to support recovery, with due consideration for individual country circumstances.'

The G20 finance leaders voiced support for ensuring timely and affordable access to COVID-19 vaccines, therapeutics, diagnostics and other medical supplies for low- and middle-income countries, according to the draft.

They asked the G20 Joint Finance-Health Task Force to report by April on options to establish a fund for pandemic preparedness, for further work in July and in October with G20 health ministers.

U.S. Treasury Secretary Janet Yellen earlier on Thursday urged her G20 counterparts to back the proposed fund, with needed health system investments estimated at \$75 billion.

The G20 finance leaders affirmed their commitment to developing the rules and other instruments to implement a global tax agreement reached last year to put the new rules into effect in 2023.

Australian Unemployment Holds at 13-Year Low

SYDNEY (Dispatches) - Australia's unemployment rate held at a 13-year low in January as a surge in coronavirus cases took more of a toll on hours worked than on jobs, and hiring still rising moderately in the month.

Airbus Posts AIRBUS **Record Profit, Eyes** More Deliveries in 2022

PARIS (Dispatches) - European aircraft giant Airbus posted record profits in 2021 after two years of losses as it cruises past the pandemic-induced crisis in the travel industry, company results showed.

Net profit surged to €4.2 billion with deliveries of aircraft rising eight per cent to €611 planes, Airbus said in an earnings statement.

Signaling its optimistic outlook for the future, the company is targeting 720 commercial aircraft deliveries in 2022.

"2021 was a year of transition, where our attention shifted from navigating the pandemic towards recovery and growth," Airbus chief executive Guillaume Faury said in the earning statement.

"Thanks to the resilience and efforts of our teams, customers and suppliers, we delivered remarkable full-year results," he said.

The good results were due to the higher number of deliveries, good performance of the company's helicopter, defense and space businesses, and efforts to contain costs, Faury said. Deliveries are an important gauge of profitability in the aviation industry as clients pay most of their bills when they receive their orders.

In its guidance for 2022, Airbus said it "assumes no further disruptions to the world economy, air traffic, the Company's internal operations, and its ability to deliver products and services," Airbus said. The air travel industry collapsed in 2020 as the emergence of Covid-19 prompted countries to close borders.

Airbus drastically reduced production and cut 10,000 jobs when Covid spread around the world in 2020.

The group, which employs more than 126,000, plans to recruit 6,000 people this year.

China Expanded Statist Economic Policies Over 20 Years in WTO



WASHINGTON (Dispatches) - China has not adopted the rules of the World Trade Organization (WTO) even after 20 years' membership, the United States said, adding that the world's second-biggest economy had "retained and expanded" its statist approach to the detriment of businesses and workers globally.

Iraq Strengthens Grip on India Oil Market

NEW DELHI (Dispatches) - India's imports of oil from Iraq surged in January to a 29-month high of about 1.3 million barrels per day (bpd), making up nearly a third of the supplies to Asia's third largest economy, data from shipping and industry sources show.

Iraq's importance as a key supplier is set to grow this year as at least two Indian refiners have increased their annual oil import deals with the second biggest OPEC producer.

India imported 4.6 million bpd of oil in January, a decline of about 1% from the previous month and about 3% from the year earlier, data compiled by Reuters showed. Imports from Iraq were the highest since Aug. 2019. From April 2021 through January 2022, the first 10 months of this fiscal year, India, the world's third biggest oil importer and consumer, shipped in 4.2 million bpd of oil, up 6.5% from a year ago, as refiners raised runs to meet rising fuel demand

India's oil imports in February and March could rise as state refiners, which make up 60% of its total apacity of 5 million bpd, traditionally raise runs in the final fiscal quarter to meet production targets set by the government.

Indian refiners buy medium to heavy grades from the Middle East under annual deals at official selling prices OSPs) and rely on the spot market for most of their requirement for sweet light oil, mainly from West Africa. Brent crude's premium to Dubai swaps, or the spread between low- and high-sulphur crude, averaged \$4.58 a barrel in November, said Refinitiv analyst Ehsan Ul Haq.

Turkey's Central Bank Leaves Policy Rate Unchanged at 14%

ANKARA (Dispatches) - Turkey's central bank held interest rates unchanged at 14% for a second meeting on Thursday, in line with the market expectations.

All 22 economists earlier surveyed by Bloomberg expected the Central Bank of the Republic of Turkey (CBRT) to keep the benchmark one-week repo rate unchanged. Economists surveyed by AA Finance also predicted that the policy rate would remain at 14%. The median of economists' year-end policy rate expectations was 14%.

The bank said in a statement that it is expecting the disinflation process to start on the back of measures taken and financial stability along with the decline in inflation thanks to the base effect.

It also underlined the level of capacity utilization and other leading indicators showing that domestic economic activity remains strong thanks to robust external demand.

"Strengthening of the improving trend in the current account balance is important for price stability," the statement said, adding: "The committee assesses that extending long-term Turkish lira investment credit will play a significant role in achieving this target.'

The bank also said the share of sustainable components of economic growth continues to

Figures from the Australian Bureau of Statistics on Thursday showed employment rose 12,900 in January, pipping forecasts of a flat outcome and following two months of exceptional gains.

The unemployment rate stayed at 4.2%, matching the lowest reading since 2008 when it bottomed out at 4.0%. The impact of the Omicron wave was felt most in hours worked which slid 8.8% as employees stayed home sick or were forced to isolate.

Yet these workers remained attached to their jobs and unemployment barely moved, setting the stage for a quick rebound now that coronavirus cases have tapered off.

"As cases have fallen sharply we expect the impact on the labor market to fade in February," said Ben Udy, an economist at Capital Economics.

"It highlights the resilience of the labor market and supports our forecast that the RBA will hike rates in June."

The Reserve Bank of Australia (RBA) has been aiming to drive unemployment to 4% or lower in the hope of reviving wage growth after years of sub-par growth, and is now near that goal.

The tightening labor market combined with rising inflation also suggests a rate rise is getting closer. RBA Governor Philip Lowe last week said it was plausible a hike could come later in the year should the economy recover as expected.

Markets are wagering the 0.1% cash rate could rise to 0.25% as early as June, and keep climbing to 1.25% by year end. Among the major local banks, CBA is tipping a first rise in June, Westpac sees August, ANZ September and NAB November. Much will depend on how wages progress with the ABS wage price measure for the December quarter due next week.



Analysts look for an uptick to 2.4%, which would be the fastest pace since 2014 but short of the 3%-plus desired by the RBA. Still, the central bank recently emphasized it was looking at a wider suite of labor cost indicators and not just wages to decide when to tighten policy.

Analysts took that as a sign the RBA could hike even with wages running at less than 3%.

"ABS data, private surveys and our internal data that captures salaries paid into CBA bank accounts indicates that wages growth has further accelerated," says Gareth Aird, CBA's head of Australian economics. He also expects the consumer price report for the March quarter to show an alarming acceleration in core inflation to 3.5%, up from 2.6% and above the RBA's 2-3% target band.

Worker Shortage Jeopardizes Spain's EU-Funded Recovery Plan

MADRID (Dispatches) - When Spain's decade-long housing boom spectacularly bust in 2008, some 1.8 million jobs vanished and a nation littered with cranes and building sites slid into brutal recession.

Now those construction workers are urgently needed back: an unprecedented labor shortage is jeopardizing multi-billion euro building and renovation projects funded by the European Union to help Spain's economy recover from COVID-19.

As elsewhere around the continent, Spain is short of at least half a million building workers, according to unions and companies. Firms are training new staff round the clock, paying better, and leaning on migrants from Africa and Latin America.

"If you have a certificate, companies will hire you," enthused Moustapha Diedhiou during a break in an evening class for scaffolding in Madrid.

The 32-year-old Senegalese arrived on a rickety boat in 2019, picked fruit for a living during the pandemic, but now works as a bricklayer thanks to another previous course. Though scaffolding is riskier, he can earn more.

Despite such keenness, at least seven out of 10 construction companies had to turn down contracts in 2021 due to lack of staff, according to preliminary data seen by Reuters of a survey from Spain's main building association.

And that before the first 5 billion euros (\$5.65 billion) in housing rehabilitation funds go to tender this spring.

After Italy, Spain is receiving the most EU aid: around 140 billion euros (\$166 billion), half grants and half loans.

The government is pinning hopes of 7% economic growth this year on the funds, but red tape, material shortages and labor gaps are hampering investment.

Spain had almost 3 million real estate workers before the 2008 implosion, after which many took refuge in the equally massive tourism sector. Now they seem reluctant to come back. So employers, unions and the government have clubbed together to run free training courses for would-be builders. They drew 90,000 people in 2021, and the target now is 200,000.

At one Madrid course earlier this month, most signing up were migrants from non-EU countries, optimistic that along with Spain, they too would see a turnaround in their fortunes.

Francisco Dieguez, director of a training institute in Catalonia, said a construction worker's typical annual salary of 24,000 euros surpassed some architects' wages. Most other manual workers are on about 18,500 euros.

Jose Adel Sosua, who teaches the Senegalese immigrant Diedhiou, is dismayed at how hard it is to attract students, blaming bad memories of the housing crash.

"Many Spaniards don't want to do these courses, in part as they are a bit afraid of going back to work in this sector," said Sousa, whose 15 students only included one Spaniard. Spain is second only to Greece for unemployment in Europe, with nearly one in three young people out of work. A survey of those aged 15-29 in work last year found that 11% were working on building sites.

"Here in Spain they say that if you don't study you have to be a bricklayer, as if it were a punishment," said Sergio Estela, a leader at Spain's General Workers Union (UGT-FICA). Crane operators, carpenters, welders and site managers are most scarce, according to a dozen sources from unions and companies, because they require officially

accredited training. Ismael Lazaro, a 24-year-old Spaniard, took a welding course after losing his job as an Amazon delivery driver. He is the only one among his friends trying to enter construction. "My mother told me there was a lot of demand for welders," he said.

The predicament is echoed around Europe. Though less pummeled by the pandemic, Germany, France, Ireland and the United Kingdom

also lack hundreds of thousands of construction workers, employers' associations say.

World Funds Own Destruction With \$1.8 Trillion Subsidies

LONDON (Dispatches) - The world must slash \$1.8 trillion in annual subsidies that destroy the environment, according to a study Thursday from business groups including one founded by tycoon Richard Branson. The report, estimating the value of damaging state subsidies, was commissioned by Branson's nonprofit initiative The B Team and global coalition Business for Nature, which comprises academic, corporate and environmental organizations.

The vast subsidies, totaling two percent of global GDP, fund the "global destruction of nature" and governments worldwide must act, the two organizations added in a statement. The study "finds the fossil fuel, agriculture and water industries receive more than 80 percent of all environmentally harmful subsidies per year", the organizations concluded. And they called upon governments to "redirect, repurpose or eliminate" those subsidies by 2030 to help "finance a net zero global economy". Governments across the world pay an estimated \$640 billion in support to the fossil fuel industry, contributing to climate change, air and water pollution and land subsidence, the study found.

Halema Wali, cofounder of Afghans for a Better Tomorrow, a U.S.-based advocacy group, stressed that the money in the Afghan central bank belongs to the people of Afghanistan, who are experiencing a dire humanitarian crisis.



With skyrocketing inflation and the state institutions in shambles, the Afghan economy – which has depended on foreign aid – is all but falling apart. The UN World Food Program has warned that 23 million people are facing "severe hunger" in the country.

Reacting to this decision, the Taliban said Afghanistan will be forced to reconsider its policy towards the United States unless Washington reverses a decision to freeze part of the country's assets as compensation for victims of the 9/11 attacks.

The move drew an angry response from the country's new Taliban leaders, which branded the seizure a "theft" and a sign of U.S. "moral decay."

"The 9/11 attacks had nothing to do with Afghanistan," said Monday's statement, signed by deputy spokesman Inamullah Samangani.

"Any misappropriation of the property of the Afghan people under the pretext of this incident is a clear violation of the agreement reached with the Islamic Emirate of Afghanistan," the statement added, using the Taliban's name for the country.

"If the United States does not deviate from its position and continues its provocative actions, the Islamic Emirate will also be forced to reconsider its policy towards the country." This is not the first time that the U.S. confiscates the wealth and money of the nations in its own or nationals' favor under different pretexts.

The U.S. governments once in a while perform new form of their piracy and looting which are sometimes inspired from the Hollywood movies or inspire the Hollywood directors to copy the U.S. officials' innovation in theft or action thrillers in countries.

Tehran says it will not settle for anything less than the removal of all US sanctions in a verifiable manner. It also wants guarantees that Washington would not abandon the agreement again.

Gharibabadi also denounced the recent European Parliament resolution on the death penalty in Iran, saying it is based on political goals and fails to represent the existing realities in the country.

OPEC+ is gradually boosting oil output after making record cuts in 2020 when demand collapsed due to the pandemic. But it has failed to hit its target because some producers did not make the investment or do the maintenance needed on oilfields during the pandemic to keep those facilities ready to increase output quickly.

For the United States, it would make sense to lift the sanctions on Iran to help lower prices given the domestic pressure the administration of President Joe Biden is facing due to rising inflation. The United States may also be considering that any output from Iran would ease the impact on global oil markets of any conflict between Russia and the Ukraine, a source familiar with Russian oil thinking said.

"The U.S. will surely lift the sanction from Iran as soon as they decide to put more pressure on Russia given the current tensions over Ukraine," the source said. "Iranian oil will cool oil prices."

OPEC+ sources have also made the point that extra Iranian supply could also help plug the hole in OPEC's output target misses. OPEC+ has not dealt with this issue by, for example,

having larger producers step in to boost output to compensate for those who cannot. These talks can be difficult as they encroach on sensitive topics such as national prestige and market share. But any nuclear deal will most likely force OPEC+ to rearrange its quotas to make room for Iranian barrels, as in previous years.

When Tehran last returned to the fold from U.S. sanctions in 2015-2016, it negotiated strongly among oil producers for its own interests by first refusing to take part in a proposed output "freeze" to address oversupply as it recovered output. Later, during talks to form OPEC+ in 2016 while the other producers were agreeing on production cuts, Iran eventually secured a quota that allowed it to increase output, citing the impact of sanctions that had squeezed its market share. Still, a third OPEC+ source said the group would not shy away from talks on a return of more Iranian oil to the market, and has a track record of tackling similarly thorny issues. "We will deal with it very well," this source said. "OPEC has been around for 60 years and we can deal with all issues."

Marte Olsbu Roeiseland and Boe led the Norwegian medal charge in the 2022 biathlon events, with Therese Johaug and Johannes Klaebo doing the same a short distance away at the cross-country track, while at the ski jumping venue in between Marius Lindvik took gold on the large hill.

At Pyeongchang 2018, Germany and Norway had equalled the record of 14 gold medals won by

a country at one Winter Olympics Games, matching the tally Canada had set at Vancouver 2010. Norway's chef de mission Tore Oevreboe is not surprised by the country's success at the Winter Games.

The Norwegians also had a long-term approach when taking the altitude at the Beijing Games into account.

"Some of the sports have chosen to do much more of their basic physical work at high altitude than others," Oevreboe said.

"From my experience, as a coach and also a former athlete, I think it's very important to spend many, many, many weeks and days, even months, at high altitude the last two or three years before you have a competition at higher altitude."

For Oevreboe Norway's gold medals are a result of many factors and he is well aware things can change quickly in sport.

"Sometimes the competition is tougher than you think, then you will feel more disappointed than when the competition is a little bit lower than maybe expected," he said.

"Then they feel more happy. But we are very proud on the performance side of it, so we try to analyze what is what, and we try to develop even when we are at the top level."

Djokovic Eager for Dubai Comeback

DUBAI (Dispatches) - World number one Novak Djokovic said he has missed playing tennis as he prepares for his comeback in Dubai after the coronavirus vaccine row that kept him from defending his Australian Open title.

The Serb, who was deported from Australia over his vaccination status, toured the Serbian pavilion at Dubai Expo, removing his black mask when requested and writing a long message in the visitors' book.

"I am excited to go back and play on Monday," he said, referring to the Dubai ATP tournament during brief remarks to media. "I miss tennis after all that has happened."

The 20-time Grand Slam-winner has kept a low profile since his deportation last month over his potentially careerchanging decision not to take the coronavirus vaccine.

Spanish rival Rafael Nadal won the Australian Open in Melbourne to become the first player to win 21 major titles, one ahead of Djokovic and Roger Federer.

This week, Djokovic told the BBC he was not anti-vaccination but that he was prepared to miss more major tournaments over his refusal to get jabbed.

"Yes, that is the price that I'm willing to pay," he said.

"I was prepared not to go to Australia. I understand not being vaccinated today, I am unable to travel to most of the tournaments at the moment," Djokovic added.



DOHA (Dispatches) - Top seed Denis Shapovalov lost in straight sets to Frenchman Arthur Rinderknech in the quarter-finals of the Qatar Open.

World number 61 Rinderknech broke once in each set to advance 6-4, 6-4 to a semi-final against Nikoloz Basilashvili, the third seed and defending champion in Doha.

"It feels great to win and be through to the semi-finals, especially against a great player,"

said Rinderknech. "I am really happy. I worked pretty hard during the off-season, I think my body is in good shape, which helps."

Georgia's Basilashvili, who began the 2022 season with six consecutive defeats, fought back to defeat Marton Fucsovics 1-6, 6-3, 7-5.

Basilashvili, ranked 22 in the world, defeated Roger Federer in last year's tournament. Spanish second seed Roberto Bautista Agut, who sent Andy Murray crashing to his heaviest loss in over seven years on Wednesday, was just as ruthless with compatriot Alejandro Davidovich Fokina.

Bautista Agut, the Qatar champion in 2019, cantered to a 6-1, 6-1 win and will face either Marin Cilic or Karen Khachanov for a place in the final.

But the 24-year-old needed to survive a thrilling clash with fellow former Grand Slam winner Kvitova, battling to a 5-7, 7-5, 7-6 (11/9) victory.

Ostapenko was a set and a break down before Kvitova failed to serve out the match in the 10th game of the second set. Ostapenko made it four straight games to force a decider, which finished in a lengthy tie-break.

She saved one match point before finally getting over the line on her fourth attempt.

Mercedes, Red Bull Could Be Playing Catch-Up In New F1 Season

LONDON (Dispatches) - Formula One managing director Ross Brawn believes Mercedes and Red Bull could be off the pace when the new season starts next month after they were caught up in last year's "intense" world championship battle.

Hamilton Hungry for F1 Return

LONDON (Dispatches) - Lewis Hamilton said today he was ready to attack the new Formula One season after getting over a "difficult time" following the traumatic end to his 2021 world championship campaign.

The British driver, 37, was speaking for the first time since he lost the championship in controversial circumstances to Max Verstappen in Abu Dhabi on December 12.

Hamilton was poised to capture a record-breaking eighth world title at the season finale before a controversial safety car restart allowed Dutch driver Verstappen to pass his British rival on the last lap.

The seven-time world champion was disillusioned following his defeat and, at one stage, it was unclear if he would return to the grid.

But Hamilton, speaking at the launch of the Mercedes car for the 2022 season — and a day after Michael Masi was removed as F1 race director — said he was still hungry for more success. "I never ever said I was going to stop," he insisted.

"I love doing what I do, and it is such a privilege working with this large group of people and you feel like you are part of a family. There is nothing quite like it."

Maguire Denies Reports Of Ronaldo Rift At Man Utd

LONDON (Dispatches) - Manchester United captain Harry Maguire has denied reports of a power struggle with Cristiano Ronaldo as the club battle to end the season in the Premier League's top four.



Maguire has been well below his best this season and it has been reported that the United skipper feels undermined by Ronaldo's influence, with his continued role as captain questioned.

United forward Marcus Rashford dismissed talk of a dressing room divide involving Ronaldo earlier this week and Maguire has denied the latest reports.

"I've seen a lot of reports about this club that aren't true and this is another," he posted on Twitter today ahead of Sunday's Premier League match at Leeds.

"Not going to start posting about everything that is written but I needed to make this one clear. We're united and focused on Sunday. Enjoy your day everyone."

United's 2-0 win against Brighton on Tuesday lifted them back into fourth place in the English top-flight — the top four teams all qualify for next season's Champions League. But the club, under interim manager Ralf Rangnick, face a tough battle, with a number of other sides also in the mix, most of whom have games in hand.
