Serbia Seeks Strong Political, Strategic Relations With Iran

TEHRAN (PressTV)- Serbia's President Aleksandar Vučić says his country seeks to further boost trade and commercial cooperation with Iran, promoting it to the level of strategic ties.

Vučić made the remarks in a late Saturday phone call with Iran's President Ebrahim Raisi, during which the two sides discussed bilateral relations as well as major international developments.

"Belgrade is after enhancing the level of commercial and business ties and establishing strong political and strategic relations [with Tehran]," the Serbian head of state noted.

He hailed the Islamic Republic for the "invariably independent positions" that it has adopted over time, saying this could serve as a basis for close bilateral cooperation between the two sides concerning international issues.

Vučić named agriculture, food industry, manufacturing, building, mining, energy, information technology, education, culture, and sports as major areas that yield "great opportunity" for bilateral cooperation.

Iran Southeastern Borders In Full Security

TEHRAN (MNA) – Chief of Staff of Iranian Armed Forces Major General Mohammad Bagheri said that security of borders at southeastern parts of the country enjoys positive and reassuring growth.

Speaking among reporters during his visit to southeastern Sistan and Baluchestan province on Sunday to inaugurate some operational projects and also defense achievements in the fields of armor, air force and ICT of Army Ground Force, Major General Bagheri said that security situation of southeastern borders of the country is 'satisfactory' as compared to the previous years and there is no major problem in this regard.

Bagheri pointed to the situation of security at joint borders between Iran and Pakistan and stated, "Relying upon the assistance of the Almighty God, common border between Iran and Pakistan is the border of peace and friendship in a way that trade and business activity is done in this area with peace of mind."

Regarding the joint borders between Iran and Afghanistan, he noted, "In spite of existence of some problems at Afghanistan, borders of the two country enjoy suitable security and if there are some problems in this regard, they will be resolved by border guards of the two countries."



Majlis Lawmakers Set Conditions for Nuclear Deal

TEHRAN - A large majority in Iran's parliament issued a statement urging President Ebrahim Raisi not to agree to any new nuclear deal without ensuring Iran's demands.

In the Sunday statement signed by 250 lawmakers, out of 290, stressed that getting credible guarantees is a red line to ensure the interests of the Iranian people is protected. Hardliners loyal to Iran's Supreme Leader Ali Khamenei dominate the Iranian parliament since 2020, after elections in which most rivals were banned from contesting.

Iran has been insisting to obtain a political guarantee from the United States that it would not renege on a new nuclear agreement. Former president Donald Trump unilaterally withdrew from the Joint Comprehensive Plan of Action (JCPOA) in 2018, reimposing crippling sanctions on Tehran.

Lawmakers said the negotiations to revive the 2015 deal have reached a critical point, calling on the president not to compromise on any of the demands reiterated by the Islamic Republic. These include not only a political guarantee, but also the removal of all sanctions imposed on Iran, whether for nuclear or other reasons, such as human rights violations or terrorism. The text explicitly mentions guarantees by France, Germany and the United Kingdom, the three European signatories of JCPOA, to remove all sanctions.

The statement said the U.S. and the three European signatories of the nuclear deal have shown in the past eight years that they are not committed to any agreement and used all the possible means against the interests of the Iranian people, adding that they also put sanctions on medicines – a highly questionable claim.

The lawmakers also asked Raisi to get credible will not use JCPOA's trigger mechanism designed to reimpose international sanctions in case Iran violates the nuclear agreement.

According to the statement, the U.S. and the three European countries must lift all the sanctions related to nuclear, terrorism, missiles, and human rights issues, including the Countering America's Adversaries Through Sanctions Act (CAATSA), CAATSA U-turn, and the Iran Sanctions Act (ISA).

The U.S. and JCPOA signatories must fulfill their obligations about sanctions in a manner verifiable for Iran, they said, noting that the administration should brief the parliament on the removal of oil and banking sanctions, then the parliament would approve reducing the nuclear activities.

Saudi Arabia Plans for Fresh Round of Talks With Iran

RIYADH (Dispatches) - Saudi Foreign Minister Prince Faisal bin Farhan Al Saud said on Saturday that if the 2015 nuclear pact was revived that should be "a starting point, not an endpoint" in order to address regional concerns. Saudi Arabia has been critical of the deal for not tackling Tehran's missiles program.

"That will indeed require from our neighbors in Iran a serious desire to address the underlying issues that exist ... We hope that there is a serious desire to find a new modus operandi," he said.

"If we see substantive progress on those files, then yes, rapprochement is possible. So far, we have not seen

that," he told the Munich Security Conference.

Tensions between the two countries spiked in 2019 after an assault on Saudi oil plants that Riyadh blamed on

Iran, a charge Tehran has denied, and continue to simmer over Yemen.

Prince Faisal said Iran continued to provide the Houthis with ballistic missile and drone parts as well as conventional weapons, a charge both Tehran and Yemen's Houthi group denies.

"This does not contribute to finding a path to settle that conflict, but we are committed and we are supportive of the United Nations representative," he said, referring to stalled UN-led efforts for a ceasefire in Yemen.

Tehran and Riyadh have held four rounds of talks in Iraq, with Baghdad hoping its mediation would stop the neighbours seeking to settle scores on its territory. Saudi Arabia has described the talks as cordial but exploratory, while Tehran says they had gone a "good distance".

Earlier this month Iranian President Ebrahim Raisi said Iran was ready for more talks with Saudi Arabia if Riyadh is willing to hold the talks in an atmosphere of mutual understanding and respect, the semi-official news agency Fars reported

"Iran is ready to continue these negotiations until reaching an outcome, provided that the Saudis are willing to continue the negotiations in an atmosphere of mutual understanding and respect," Fars quoted Raisi as saying in a phone call with Iraqi Prime Minister Mustafa al-Kadhimi.

Riyadh and Tehran have said they hope the talks can ease tensions while playing down expectations of a significant diplomatic breakthrough.

Canada, the Bogus Human-Rights Defender

Canada has been one of those countries which has always been boasting its defense of human rights issue and every time the country jumps to meddle in the domestic affairs of other countries after any incident but it has been unable to observe human rights standards on its own lands.

The country in recent months have faced several challenges which have questioned capability of it in handling the human rights issues but when it comes to other countries, it acts more Catholic than Pope.

First in November 2021, an Indigenous community said it found evidence that 215 children were buried on the grounds of a British Columbia school, one of the many in Canada set up to forcibly assimilate them.

For decades, most Indigenous children in Canada were taken from their families and forced into boarding schools. A large number never returned home, their families given only vague explanations, or none at all.

But the Canadian officials and Judiciary have been indifferent and passive towards this kind of behavior against the indigenous people. Suppose such an incident happens in an Asian or African country like Iran or Sudan. Like the Ukrainian plane crash in Tehran. Immediately the Canadian officials jump to condemn the governments under the pretext of defending human rights.

In several occasions Canadian officials have meddled in Iran's domestic issues while they currently have no diplomatic relation and Canada has currently turned into a haven for corrupts and criminals who are at large and are on the wanted list of the Interpol.

In recent days Canada is challenging with another domestic issue, namely the protests of the truckers, that it has resorted to the force and some so-called anti-human measures against the drivers who are protesting against mandatory COVID vaccination.

On Friday, Canadian police resorted to tough measures to stop protesters and used pepper spray and stun grenades to disperse truckers and other demonstrators who had occupied the downtown core of the capital Ottawa in an effort to bring an end to three weeks of protests against the COVID-19 restrictions.

Police officers clashed with protesters who had gathered in front of the parliament building and the prime minister's office on Saturday, arresting several people, a day after clearing part of the blockade and making more than 100 arrests.

Any Vienna Agreement Must Result In Removal of All Sanctions

TEHRAN - President Ebrahim Raisi says any possible agreement between Iran and the P4+1 group of countries in the Austrian capital of Vienna must include the removal of all sanctions, the provision of valid guarantees and cessation of political issues and claims.

The Iranian president made the remarks in a phone conversation with his French counterpart Emmanuel Macron on Saturday as the two sides discussed the latest status of the ongoing talks in Vienna between Tehran and the five remaining signatories to the 2015 Iran deal, officially known as the Joint Comprehensive Plan of Action (JCPOA), aim to secure the revival of the agreement.

Raisi said the Iranian negotiating team has repeatedly announced that it welcomes the initiatives that would guarantee the provision and protection of the nation's rights. He added that certain "political pressures or claims have been made with the aim of maintaining the leverage of pressure on the Iranian nation which undermine the prospect of reaching an agreement [in Vienna]."

He noted that the Iranian delegation is advancing the talks in the Austrian capital with "seriousness," saying, "In the course of the [Vienna] negotiations, the Islamic Republic of Iran has offered constructive proposals and has examined the proposals made by the other side of the talks based on the their conformity with the interests of the Iranian people.'

Report Denies Any Direct Link Between Iran and Tanker Fire Near China

TEHRAN (PressTV) - A report by Iran's official IRNA news agency has denied there was any direct link between the country and an oil tanker fire that took place on Friday in the Far East.

The Saturday report by IRNA said neither the tanker that had caught fire near China a day earlier nor its crude oil cargo were related to Iran.

"IRNA has learnt from informed sources that this oil tanker does not belong to Iran and the only possibility is that its cargo belongs to one of Iran's customers," said the report, suggesting that the cargo had been sold by Iran to an intermediary for delivery to a final customer.

The statement comes after some media outlets claimed a tanker carrying half a million barrels of Iranian oil had caught fire near China's shores on Friday in an incident that was not widely reported. Shipment tracking service Tanker Trackers said

on Twitter that the crew of the foreign-flagged tanker had quickly extinguished the fire. Reports have indicated that Iran normally uses

Tehran Eyes \$1b Trade With Doha

TEHRAN - Head of Trade Promotion Organization of Iran (TPOI) said that \$1 billion trade with neighboring country of Qatar is on Iran's agenda.

Alireza Peyman-Pak, Head of Trade Promotion Organization of Iran said on Saturday with regards to the upcoming visit of Iranian President to Qatar and said, "Participating in Gas Exporting Countries Forum (GECF) and holding bilateral talks with senior Qatari officials have been cited as the two main aims behind upcoming visit of Iranian President Raeisi to Qatar."

Turning to the high capacities and opportunities of cooperation between Iran and Qatar, Peyman-Pak stated, "In addition to holding talks pertinent to oil by senior officials of Iranian Petroleum Ministry, Iranian ministers of industry and tourism will also hold bilateral talks with their Qatari counterparts for the development of trade and tourism cooperation."

He put the current trade volume exchanged between Iran and Qatar at about \$300 and \$400 million which is very negligible and stated, "With the planning made in this regard, it is expected that bilateral trade between the two countries will increase to \$1 billion next year."

Cooperating in the field of industrial development for exporting products to third countries and using high capacities and capabilities of Qatar for development of value chain and transit are of the other issues with regards to expanding trade ties between the two countries, he added.



Elsewhere in his remarks, the deputy minister of industry referred to the opportunity of Free Trade with Eurasian Economic Union (EAEU) next year (to start March 21, 2022) and also lucrative \$500 billion market of EAEU and stated that giant steps have been taken in order to expand trade and economic activities with EAEU member states.

Iran and Qatar signed a memorandum of understanding (MOU) for cooperation in a variety of areas at the end of the two countries' seventh Joint Economic Committee meeting which was held in Isfahan in late November 2020.

Based on this MOU, the two sides agreed to cooperate in forming a joint trade working group between the two countries, establishing trade centers between the private sectors of the two sides, establishing commercial affiliates in the embassies of the two countries in Tehran and Doha, and using the ports of the two countries to boost the export and import of goods.

Cooperation between the two countries' chambers of commerce to encourage the private sectors of the two sides for joint ventures, the development of cooperation in the fields of agriculture, electricity, water and wastewater and gas, cooperation in the field of cultural heritage, handicrafts, and tourism, including holding a cultural week in Isfahan, were among other provisions of the mentioned MOU.

Kuwait Expels Iranian Workers

TEHRAN - Abdullah Raisi, executive secretary of Shahrekord's Worker's House, pointed out that Kuwait was one of the overseas destinations for workers in Chaharmahal and Bakhtiari Province, saying, "Kuwait does not accept Iranian workers and has expelled those who were working."

He did not mention the number of Iranian workers fired, but said hidden unemployment in the province had increased and if problems were not solved, the province would witness massive economic and social crises.

The unemployment rate in the province is more than 13 percent, according to the latest government statistics. The executive secretary of Shahrekord's

Worker's House also pointed out that hyperinflation has caused farmers to be unable to afford their living expenses, saying that farmers in the province have been forced to migrate "to southern provinces such as Bushehr, Hormozgan, Khuzestan or Chabahar" as seasonal workers in order to cover living expenses.

He also said the employment crisis has pushed the marriage age in the province from 20 to 34, with the number of drug sales, theft and corruption increasing.

Iran, Brazil to Mull Over Customs Tariff of Commercial Goods

TEHRAN (MNA) — Islamic Republic of Iran and Brazil will explore the customs tariff of commercial goods exchanged between the two countries.

Visiting Minister of Agriculture, Livestock and Supply of Brazil Tereza Cristina Corrêa da Costa Dias welcomed

expansion of trade ties with the Islamic Republic of Iran and said that setting customs tariff is one of the main barriers facing trade and business activity of the two countries.

Speaking in the signing and sealing ceremony of

cooperation agreement between Iran and Brazil, she added, "In the past 50 years, Brazil has tried to be one of the largest food producers in the world. Of course, Iran has made salient progress in the field of agriculture." The two countries of Iran and Brazil enjoy high potentials



and capacities which can broaden their cooperation in agricultural field suitably, she emphasized.

Referring to the beginning of a new chapter in relations between Iran and Brazil, the Agriculture Minister of Brazil stated that trade exchanges between the two countries in the field

He went on to say that in line with indigenizing and preventing the flight of forex from the country, this manufactured device saves considerable forex amount and it makes the country needless of its imports.


Jamshadian added that this achievement is a big step towards materialization of the strategic goals of Mobarakeh Steel Company in the field of design and production of new products.

Lithuania Asks U.S. to Strengthen Baltic States With Troops

VILNIUS (Dispatches)- Lithuania's president called today for Baltic states' security to be boosted with US troops as the region worries about Russia's massing of troops near Ukraine.

"The Russian military buildup at the eastern NATO border is changing the security situation," President Gitanas Nauseda said in a statement after the meeting U.S. Defense Secretary Lloyd Austin in Vilnius.

"It is critically important to strengthen the (Baltic states) regional security with additional troops from the United States and quicken cooperation in military procurement," he added.

Putin Launches Nuclear Drills as Russia Poised to Invade Ukraine



DONETSK (Dispatches) - Russia's President Vladimir Putin launched exercises by strategic nuclear missile forces on Saturday and Washington said Russian troops massed near Ukraine's border were "poised to strike".

As Western nations fear the start of one the worst conflicts since the Cold War, U.S. Defense Secretary Lloyd Austin said Russian forces were beginning to "uncoil and move closer" to the border with its former Soviet neighbor.

"We hope he steps back from the brink of conflict," he told a news conference on a visit to Lithuania, saying an invasion of Ukraine was not inevitable.

Russia ordered the military build-up while demanding NATO stop Ukraine ever joining the alliance but says predictions it is planning to invade Ukraine are wrong and dangerous. It says it is now pulling back while Washington and allies insist the build-up is mounting.

Russian-backed separatist leaders in eastern Ukraine earlier declared a full military mobilization, a day after ordering women and children to evacuate to Russia, citing the threat of an imminent attack by Ukrainian forces.

Kyiv flatly denied the accusation and both it and Washington say increased shelling across the ceasefire line this week is part of Russia's plan to create a pretext for an invasion of Ukraine.

Moscow said on Saturday a Ukrainian shell had exploded inside Russia and Russian news agencies later cited an unnamed source reporting a second.

Multiple explosions could be heard on Saturday morning in the north of the separatist-controlled city of Donetsk in eastern Ukraine, as more people got on buses to leave, a Reuters witness said. The origin was not immediately clear. Ukraine said earlier that one of its soldiers had been killed.

"It's really scary. I've taken everything I could carry," said Tatyana, 30, who was boarding a bus with her 4-year-old daughter.

U.S. President Joe Biden, who has given regular warnings of an impending invasion, said on Friday he now believes the capital Kyiv would be targeted by Russia but that he does not think Putin is even remotely contemplating using nuclear weapons.

Biden said Putin would invade in the coming days. "As of this moment, I am convinced that he has made the decision," he told reporters.

The Kremlin said Russia had successfully test-launched hypersonic and cruise missiles at sea and land-based targets during the exercises by Russia's nuclear forces.

Putin sat observing the exercises on screens along with the president of neighboring Belarus, Alexander Lukashenko, from what the Kremlin described as a "situation center". Austin said the nuclear exercises were stoking concern among defense leaders around the world given that Russia's military was focused on a massive build-up of forces around Ukraine.

U.S., YPG Carry Out Military Exercise in Syria's East DAMASCUS (Dispatches) - The United States and the PKK terrorist organization's Syrian wing the YPG

DAMASCUS (Dispatches) - The United States and the PKK terrorist organization's Syrian wing, the YPG, conducted a military exercise in the war-torn country's eastern Deir el-Zour province, according to local sources. U.S. troops launched the armed training with YPG

terrorists in the morning in and around the industrial zone located in the Abu Khashab desert, northwest of Deir el-Zour, according to the sources who spoke on condition of

anonymity over security concerns.

Combat aircraft and helicopters, as well as several tanks and armored vehicles, are joining the exercise. The YPG terrorists will get training on using mortars, artillery fire and guided anti-tank missiles during the

exercise, in which some troops from the Global Coalition Against Daesh are participating.

In December 2021, U.S. troops conducted joint armed exercises with the YPG terrorists in the desert.



HAVANA (Dispatches) - Russia and Cuba will deepen ties and explore collaboration in transportation, energy, industry and banking, Cuba's Foreign Ministry said following a visit from Russia's Deputy Prime Minister Yuri Borisov. In a statement, Cuba's communist-run government expressed support for

Russia as tensions mount in Ukraine, and accused long-time rival the United States and its allies of targeting Moscow with what it called a "propaganda war" and sanctions.

Cuba "reiterates its position against the unilateral and unjust sanctions imposed by the West on the Eurasian country and against the expansion of the North Atlantic Treaty Organization towards the Russian borders."

Borisov earlier this week visited Nicaragua and Venezuela, key Russian allies in Latin America, and said Russia would also deepen bilateral ties with both countries. His tour follows visits to Moscow by Latin American leaders - including Argentina's Alberto Fernandez and Brazil's Jair Bolsonaro - for talks with Russian President Vladimir Putin, prompting some analysts to suggest Russia is courting the region as tensions rise over Ukraine.

Putin launched exercises by strategic nuclear missile forces on Saturday, as Washington said Russian troops massed near Ukraine's border were "poised to strike". Cuba and Russia have a long history of deep economic and military collaboration since Fidel Castro's 1959 revolution, though in recent decades those ties have faded.

Borisov, who met with Cuban Deputy Prime Minister Ricardo Cabrisas, said in Cuba's statement that Russia had ramped up humanitarian aid to Cuba between December 2021 and January 2022. He also noted prior shipments of medical supplies to the island amid the coronavirus pandemic.

Russia said in December that escalating tensions over Ukraine could lead to a repeat of the Cuban missile crisis, when the world stood on the brink of nuclear war.

Indonesia Urges G20 Collaboration

JAKARTA (Dispatches) - The crisis in Ukraine overshadowed a gathering of finance leaders from the world's top 20 economies that kicked off on Thursday, with host Indonesia's president warning "now is not the time" to create new risks to a fragile global recovery.

Russia's military presence on its borders with Ukraine has led to one of the deepest crises in East-West relations for decades, jolting financial markets and adding to the headwinds facing a global economy emerging from the COVID-19 pandemic.

Geopolitical risks and the economic fallout from the pandemic will likely be among key topics of debate at the G20 finance leaders' meeting, as well as rising global inflation and tighter monetary policy in some regions.

Indonesia's President Joko Widodo urged G20 nations to focus on collaboration to revive a global economy that is "still shaken" from the pandemic. "In a situation like now, it is not the time for rivalry," he

said in opening remarks at the G20 meeting, which many ministers are attending online due to the pandemic.

"It is not the time to create a new tension that disrupts the

global recovery, especially one that endangers the safety of the world like what is happening in Ukraine now." Analysts, however, warn the diverse membership of the rivals China and Russia, may make policy coordination hard. In a draft of the G20 communique to be issued at the end of the two-day meeting on Friday, the finance leaders flagged inflation and "(current) geopolitical tensions" as major risks

With the U.S. central bank moving toward raising interest rates and some of its counterparts expected to follow suit, the G20 finance leaders are likely to call on major central banks to communicate their intentions clearly to prevent big market swings.

The G20 policymakers are also expected to warn emerging nations to brace for potential market fallout from monetary tightening in major economies, according to a document with the agreed position of European G20 members, seen by Reuters.

"Divergent economic recovery may have significant implications, since it can lead to a different pace of policy normalization and potentially create a tighter global financial condition," Indonesian Finance Minister Sri Mulyani Indrawati told the G20 finance leaders.

"In this regard, global coordination, including a discussion on exit strategy, will be critical," she said.





TUNIS (Dispatches) - A member of Tunisia's suspended parliament, Yassin Ayari, told Reuters that a military court sentenced him in absentia to 10 months in prison on charges of insulting the president and the army after he described the president's move to freeze parliament as a military coup.

President Kais Saied suspended the Parliament on July 25, dismissed the government and seized control of most authorities, drawing widespread criticism at home and abroad.

The prison sentence will reinforce opposition fears that Saied is seeking revenge on his opponents, after he also dissolved the Supreme Judicial Council, the body which guarantees independence of the judiciary

Ayari in a Facebook post had described Saied's actions as a military coup.

"It's ridiculous. ... Yesterday Saied said in Brussels that he is not a dictator and today a military court issues a prison sentence against freedom of expression to a lawmaker," Ayari told Reuters by phone from Paris.

Saied's critics accuse him of seeking dictatorial powers and undermining the rule of law.

Saied has said he will uphold rights and freedoms won in the 2011 revolution that brought democracy to Tunisia and will put a new constitution to a referendum this summer, with new parliamentary elections to follow in December.

EU's Oil and Petroleum **Consumption Hit Record Low in 2020**

LONDON (Dispatches) - Pandemic restrictions in 2020 reduced the European Union's oil and petroleum consumption in energy use to its lowest in 30 years, the bloc's statistics office said on Friday.

Eurostat said the final consumption of oil and petroleum products across the region registered its sharpest drop ever, falling by about 10% to 310 megatons of oil equivalent (Mtoe) in only one year.


In March 2020 EU governments began to limit people's movements to curb

the spread of COVID-19, leading to a significant decline in consumption of transport fuels such as diesel and gasoline.

The use of kerosene-type jet fuel in aviation, which in 2019 reached an absolute high at 48.2 Mtoe, slumped more than 56% in 2020 as travel restrictions forced airlines to cancel flights.

Luxembourg registered the largest decrease in oil and petroleum products consumption in energy and non-energy use, down 21% from 2019.





BRUSSELS (Dispatches) - EU and African leaders agreed to a "renewed partnership" at a summit Friday with pledges of major investments, but Europe was accused of ignoring calls to waive patents for Covid-19 vaccinations.

"We now have a historic opportunity to look at the basis of a new kind of partnership, a renewed partnership, we want to build together," Senegal's President Macky Sall, who currently chairs the African Union (AU), told a closing press conference.

The EU has announced mammoth ambitions to mobilize 150 billion euros (\$170 billion) from the public and private sectors for investments in Africa over the next seven years as it looks to challenge Chinese and Russian influence.

A final declaration from the Brussels summit said investments would focus on key infrastructure including internet access, renewable energy and transport -- but gave few concrete details on funding.

The EU repeated a pledge to give Africa 450 million Covid-19 vaccines by mid-2022 and offered 425 million euros to help health services on the continent deliver the jabs.

Europe -- the home of some of the major companies behind the vaccines -- has opposed the move arguing that the first priority was to build up production capacity in poorer countries.

European Commission chief Ursula von der Leyen said EU officials would hold talks in Brussels with counterparts from the AU this spring to try to come up with a solution.

"EU leaders continue to make a song and dance about the importance of their relationship with the African continent. Yet they once again put the interests of their profit-hungry pharmaceutical corporations first," said Jeroen Kwakkenbos, Oxfam EU aid expert.

"The point-blank refusal to even consider the waiver at this summit is shameful and an insult to the millions of people in poorer countries.

Earlier Friday, the World Health Organization in Geneva announced that six African countries have been chosen to establish their own mRNA vaccine production.

Egypt, Kenya, Nigeria, Senegal, South Africa and Tunisia were selected as the first recipients of technology from the WHO's global mRNA vaccine hub, in a push to ensure Africa can make its own jabs to fight the Covid and other diseases

As used in the Pfizer/BioNTech and Moderna Covid-19 vaccines, mRNA technology provokes an immune response by delivering genetic molecules containing the code for key parts of a pathogen into human cells.

The EU also faced criticism at the Brussels summit for not making headway on a key demand from Africa to provide it with a bigger share of post-Covid recovery aid from the International Monetary Fund.

The final summit statement called for "ambitious voluntary contributions" to add to funds worth some \$13 billion already pledged by EU member states.

Turkey's **Annual House Sales Surge 25% In January** ANKARA (Dispatches) - Residential

property sales in Turkey surged 25.1% year-over-year in January, official data

showed on Friday, but dropped from the extremely high level a month earlier. Sales jumped to 88,306 properties in January, the Turkish Statistical Institute (TurkStat)

said. Total sales in December had soared 113.7% year-over-year to 226,503, the data showed. The reading of last month reflected last year's low base effect caused by the coronavirus pandemic when sales were well below historical averages, sector analysts said. Sales were thus more than 60% lower than in December.

"Due to restrictions and weak sales during the pandemic, we have a low base effect. Turkey's average monthly house sales are around 100,000-110,000 units," said Makbule Yönel Maya, general manager of the TSKB Real Estate Appraisal company.

According to central bank data, new house prices surged 67% year-on-year in December. Official data for January showed consumer prices rose by 48.69% annually, a 20-year high. The government has pledged to act and vowed to safeguard households against soaring prices.

"We have several reasons for the weakening demand: high inflation, skyrocketing house prices and high mortgage rates. People are pausing investing in houses," Maya said. Monthly mortgage rates for new houses are close to 2% among private banks.

Istanbul, Turkey's largest city by population, had the highest share with 17.1%, or 15,110, house sales in January, followed by the capital Ankara with 9.3%, or 8,255, and the Aegean province of Izmir with 6.2%, or 5,486.

The data showed January mortgage sales jumped 69.4% from a year earlier to 18,183.

Real estate sales had accelerated amid a depreciation in the Turkish lira, with the authorities pursuing the new economic policy of low interest rates to boost credit, exports and investments, saying it would help the country weather inflation.

To support the drive, Turkey's central bank had brought down the benchmark policy rate by 500 points since September to 14% but paused the easing cycle in January and kept the one-week repo rate unchanged

In 2021 as a whole, total house sales dropped 0.5% to around 1.49 million properties, with mortgaged sales down 49%

The lira has been broadly stable since the start of the year following a 44% decline in 2021. It traded 0.3% lower at 13.63 against the United States dollar as of 3 p.m. local time (12 p.m. GMT) on Friday and eyed a weekly decline of 0.8%.

With buyers pausing investment in houses due to surging inflation, one major builder is offering buyers land instead of homes as a novel way for Turks to invest in real estate.

India Makes Record U.S. Soyoil Purchases

MUMBAI (Dispatches) - Indian traders have contracted to import a record 100.000 tons of soyoil from the United States because of limited supplies from drought-hit South America, at a time when prices of rival palm oil are scaling record highs, three dealers told Reuters.

aid. A Reuters poll of eight economists had on average forecast 7.8%

The higher purchases from the United States are expected to support U.S. soy oil prices, which have climbed nearly 20% this year to close to their highest in a decade, fuelling worries about food inflation.

The world's biggest edible oil importer traditionally buys soyoil from Argentina and Brazil, but lower bean output in these two leading exporters of the commodity forced New Delhi to turn to the United States, they said.

"Indian buyers have bought U.S soyoil vessels. Prices were attractive and supplies were not enough in South America," said the India head of a global trading firm, who sought anonymity because of the company's policy.

"Buying of another two vessels in the short term is possible.'

India usually gets two-thirds of its soyoil needs from Argentina, and the rest from Brazil. But last season's reduced soybean output has tightened soyoil reserves in Argentina, forcing Indian buyers to shop around for alternatives, such as sunoil from the Black Sea region.

"Sunflower oil is cheaper than palm and soyoil, but some buyers are sceptical about deliveries because of geopolitical tension (in Russia)," said Sandeep Bajoria, chief executive of Sunvin Group, a vegetable oil brokerage and consultancy firm.

"They are going with sovoil."

Crude palm oil (CPO) is being offered at about \$1,575 a ton, including cost, insurance and freight (CIF), in India for March shipments, compared with \$1,620 for crude soybean oil and \$1.515 for crude sunflower oil, traders said.

Soyoil was cheaper than palm and sunflower oil last month, but the sudden jump in soyoil demand has lifted prices by 16% in a month to the highest in 14 years, traders said.

India gets nearly two-thirds of its edible oil needs through imports, mainly palm oil from Indonesia and Malaysia.

But Indonesia's decision to curb palm oil exports has lifted the price of the tropical oil to a record and created scarcity in the edible oil market, said a Mumbai-based dealer with a global trading firm.

"Edible oil importers were looking for an alternative in the form of soyoil, but massive output reduction is going on for the soybean crop in South America," the dealer said.





ZURICH (Dispatches) - Credit Suisse aims to make a profit this year, Chief Executive Thomas Gottstein told Swiss newspaper Finanz und Wirtschaft in an interview published on Friday.

"We expect a profit in 2022. But uncertainty factors such as Russia, China, inflation and the interest rate environment are difficult to assess," he said.

Switzerland's second-biggest bank has been plagued by scandal and last week reported a \$2.2 billion quarterly loss. It said 2022 earnings would be weighed down by restructuring and compensation costs.

Gottstein said he was convinced the bank's strategy of focusing even more on wealth management would pay off in the long run.

Asked about his relations with new Chairman Axel Lehmann, Gottstein said they were good. "We agree 100% on strategic issues and are concentrating on implementing the new strategy," he said.

Addressing speculation that a plunge in the bank's stock price had left Credit Suisse exposed to a takeover. Gottstein said he believed the group was substantially undervalued.

"That this can trigger takeover fantasies is neither new nor surprising. If the bank is so undervalued. you should have had an offer on the table long ago," he said.

"Firstly, taking over a systemically important bank is not easy. Secondly, and more importantly, Credit Suisse, with its 165-year history, has many strengths that arouse interest among rivals. But we want to play to our strengths ourselves, both nationally and internationally," he added.

Argentina's \$40b IMF Deal Trundles Closer Despite Push-Back

BUENOS AIRES (Dispatches) - Argentina's deal with the International Monetary Fund (IMF) to refinance over \$40 billion in debts is trudging closer to the finish line, despite protests in the South American country that has a long and uneasy history with the global lender.

The two sides have been in winding talks for over a year to revamp a failed \$57 billion facility agreed in 2018 under former conservative president Mauricio Macri, which was unable to keep Argentina from sliding into debt, currency and economic crises. A final agreement that could be worth \$40-45 billion appears likely in coming weeks after an "understanding" with the IMF in late January.

The accord would still need IMF board approval and support in Argentina's Congress, where some lawmakers have openly opposed it. "We understand that it may be soon," presidential spokeswoman Gabriela Cerruti told reporters when asked about sending the agreement to Congress.

"We are going to reach the best possible agreement that will help us start finding a solution to the largest debt Argentina ever took on, and also the largest that the IMF ever gave out."

The difficult talks have buffeted stocks and sovereign bonds, which are in distressed territory even after a major \$110 billion debt restructuring with private creditors in 2020. Some local media reported a deal could come as early as this weekend, though officials privately talked down this

possibility, signaling it would likely be later this month. "My understanding was next Friday an agreement on the IC (letter of intent) would be sealed and after March 1 it would

be sent to Congress," one official said. Another government official with knowledge of the

Islamophobia Infiltrates Educational Institutions in France

PARIS (Dispatches) - A recent study conducted in France revealed that those with a Muslim name and surname applying to graduate programs are discriminated against more than those with ethnically French names.

Researchers at both the Higher Education Discrimination and Equality Monitoring Agency (ONDES) and Gustave-Eiffel University sent more than 1,800 emails in March 2021 to the education directors of 607 graduate programs from 19 universities to test the latter's discrimination against people with disabilities and those with foreign origins, according to local media.

The test was conducted by researchers with false names, for both those with disabilities and those without – used as test cases – to graduate program directors.

The directors whom researchers contacted claimed to embrace diversity in their applicants and did not prioritize people who come from a European background, but the researchers found otherwise.

Those with a Muslim name, the study found, were 12.3% less likely to receive a response to emails sent to each of their graduate programs. This rate was 33.3% in the field of law, 21.1% in the fields of science, technology and health, and 7.3% in the fields of language, literature, art, humanities and social sciences.

The researchers anonymously interviewed the same educational directors three months after the study concluded on behalf of the Ministry of Higher Education "about the difficulties they encountered in the process of recruiting students," finding then the double standard when it came to the directors' desire to embrace diversity.

No discrimination was found for students who said they were physically disabled. The rights of Muslims have been the subject of intense debate over the past decade in France as the country has struggled with violent extremist events like the Charlie Hebdo attacks of January 2015 that killed 12 people, followed by the horrific Bataclan attacks in November the same year in which 130 people died in one night of coordinated violence. Teacher Samuel Paty was beheaded in mid-October 2020 outside the middle school where he taught north of Paris. Around two weeks later, three people died at the hands of a knife-wielding man inside the Notre Dame basilica in Nice, one of them beheaded as well.



All were carried out by professed members of the Daesh terrorist group. Despite the separation of church and state being a founding principle of France's democracy dating to the French Revolution, the government has a particular approach to its adherence to a secular ideology, and even a term for it: 'laicite." Renault Looks to Tap Into Electric Boom

JAKARTA (Dispatches) - Indonesia's lenders are likely to attract more foreign investment as they prepare for stricter capital requirements by end-2022 and as the country's economic growth prospects improve.

Indonesia Banks

May Attract More

Foreign Investment

Nearly half of 83 Indonesian banks covered by S&P Global Market Intelligence will need to raise new capital from investors to meet more stringent capital requirements, based on their Tier 1 capital levels as of Sept. 30, 2021. All lenders must have at least 3 trillion rupiah of Tier 1 capital by Dec. 31, as part of the Financial Services Authority's efforts to strengthen the nation's banking system. At least 32 banks had capital below 2 trillion rupiah as of Sept. 30, 2021.

More deal activity is likely among smaller, less capitalized lenders in 2022, analysts said. These banks may turn to foreign investors that have long been drawn to the Indonesian banking system for its above-average margins and loan growth, said Yulinda Hartanto, an analyst at brokerage CGS-CIMB Sekuritas Indonesia.

This year "will be the last year for banks to meet the requirement and some banks have not met this capital level; thus, it shall continue in 2022," Hartanto said.

Indonesia's banking and payment sector companies offer attractive growth prospects to foreign investors seeking to tap the nation's population of more than 270 million people. The aggregate return on average equity of Indonesian banks was 7.37%, 12.31% and 12.93%, respectively, for the last three years. Banks' aggregate net interest margin was 4.96% in 2020, well above most other jurisdictions in the Asia-Pacific region, according to Market Intelligence data. Economic growth prospects are improving for the country amid the ongoing recovery from induced slowdown, with Asian Development Bank anticipating GDP to grow 4.8% in 2022.

Since 2017, the Southeast Asian country has seen 35 banking M&A deals and 9 payments sector deals, according to data compiled by Market Intelligence. Deal activity cooled after a busy 2019 when more than a dozen deals were announced, including Bangkok Bank PCL's \$2.40 billion acquisition of PT Bank Permata Tbk.

Indonesian banks and payments companies could also see investments from technology companies as more such players make a shift to financial services. Ride-hailing service provider Grab Holdings Ltd. recently teamed up with Singtel to buy a combined 32.52% stake in PT Bank Fama International. The acquisition followed foreign investments in mobile wallet PT Visionet Internasional and payments infrastructures iKaaz Software Pte. Ltd. and KuDo Technology Indonesia LLC.

"[Indonesia] would be the focus for all the tech companies entering the financial sector, especially the lending segment," Hartanto said.

Investors from Japan, South Korea, Thailand and other Asian markets have remained active in Indonesia's banking sectors in the past few years as they sought to gain scale and get higher returns outside their home markets. Between 2014 and 2019, Japanese financial institutions paid or pledged at least US\$9 billion for stakes in several Indonesian lenders. Those investments included Mitsubishi UFJ Financial Group Inc.'s multi-billion-dollar acquisition of PT Bank Danamon Indonesia Tbk in 2017.

PARIS (Dispatches) - Renault is looking at creating separate divisions for electric and combustion engine cars, an idea other automakers have resisted in case it weakens their ability to use profits from polluting vehicles to fund a cleaner future.

The French automaker announced its "strategic

studies" on Friday as it reported an annual profit for the first time in three years and said its turnaround plan was ahead of schedule.

With its finances on a surer footing, the company is now accelerating efforts to catch up with the likes of Tesla (TSLA.O) and Volkswagen, whose share prices have soared as they take a lead in the switch to electric vehicles.

In a presentation to investors, Renault said a "pure electric entity" could be focused on France and be open to partnerships, while a separate one for combustion engine and hybrid cars could be focused outside France and do the same

Spain is Renault's main hub for hybrid powertrain production. The company sources combustion engines from Romania, Turkey and South Korea.

The growing preference among investment managers for companies focused on low-carbon technology has helped Tesla become the world's highest-valued automaker, and led some investors and analysts to urge other carmakers to consider separating their combustion engine and electric businesses.

However, companies such as General Motors have resisted those calls, arguing profits from petrol and diesel vehicles will fund the transition to electric ones.

European governments are pushing automakers to phase out combustion engines, and the Renault car brand has said it is aiming to be all-electric in Europe by 2030. But other markets, including Latin America, Southeast Asia and Eastern Europe, are expected to continue using petrol and diesel for longer.

Renault also said its finance chief of six years, Clotilde Delbos, would move to lead its Mobilize business full time.

The business, which covers areas such as car sharing and data management, is part of its strategy to achieve carbon neutrality in Europe by 2040.

Delbos will continue as deputy to CEO Luca de Meo

and be succeeded as finance chief by her current second-in-command deputy, Thierry Pieton.

De Meo is leading a wide-ranging restructuring effort under the name "Renaulution" aiming to cut costs and emphasize value over sales volume.

Rocked by the 2018 arrest of Carlos Ghosn, the architect of its alliance with Japan's Nissan, Renault was then hit hard by the

COVID-19 pandemic. But now de Meo's efforts are bearing fruit,

Last month, Renault and Nissan said they would work more closely together on electric vehicles, as they detailed a five-year, \$26 billion investment plan.

Sources familiar with the matter told Reuters that Nissan and other alliance partner Mitsubishi Motors were only recently informed that Renault might move its internal combustion engine and hybrid operations into a separate entity.

But they said in almost identical emailed statements to Reuters that they "believe this step to be a preparation for the next stages of the Renaulution plan," adding they would "continue to collaborate as an alliance partner."

Asked whether the plan might change the alliance structure, de Meo said: "It's a project that on paper we are capable to do on our own, we don't need anyone to do it, but obviously we will leave the door open to our partners in case they are interested in making the company's structure evolve."

Renault reported a bigger than expected net profit of 888 million euros (\$1.0 billion) for 2021, and an operating margin of 3.6%. The "Renaulution" plan had aimed for a margin of above 3% in 2023.

Police also used loud speakers to warn the crowd to disperse or face arrest. They also smashed vehicle windows to arrest people locked inside, while some loud bangs of stun grenades were heard.

Ottawa has been gridlocked by a so-called "Freedom Convoy" consisting of truckers and other motorists for nearly three weeks now. The government has already declared a state of emergency in the city.

What started last month as a movement opposing a Canadian vaccine mandate for cross-border drivers, a requirement mirrored by a U.S. rule, has morphed into a rallying point against the government's public health measures.

The drivers have occupied areas outside government buildings in the capital city as well as three border crossings with the United States.

Paraguay Soy Crushers, Hit by Drought, Risk Running out of Beans

ASUNCION (Dispatches) - Paraguay's soybean crushing industry will run out of beans to process by the middle of the year due to a drought hammering production, the country's trade industry body told Reuters, adding it was in talks to import beans for the first time ever.

The landlocked South American country, the world's fourth largest soybean exporter, is facing its worst soy harvest in a decade, with a drop in production that could see just half the amount of soy versus the previous season. The Paraguayan Chamber of Oilseed and Cereal Processors (Cappro) told Reuters the impact of the drought could be even worse, estimating a drop of around 60% compared with the previous campaign, when the soy harvest was some 10 million tons.

"This figure could worsen, depending on rainfall in the coming months," the chamber said in exclusive replies to Reuters questions, adding that idle crushing capacity could be 60%-70% in the latter half of 2022. "Given this situation, it is expected that firms will hardly be able to continue processing soybeans during the second half of the year."

MARSEILLE (Dispatches) - World number four and top seed Stefanos Tsitsipas suffered an embarrassing straight sets defeat to 163rd-ranked Russian qualifier Roman Safiullin in the Marseille ATP quarter-finals.

Conte Slams Talk of Rift with Spurs Chairman Levy

London (Dispatches) - Tottenham manager Antonio Conte insists his relationship with chairman Daniel Levy will not be damaged by people trying to "create problems" after his controversial comments about the club's transfer policy.

Bernal Pedals Again After Horror Road Accident

In a video posted to his Instagram account, Bernal kicks a football twice, while in another he pedals on a stationary bike as two fluffy dogs look.

A wheelchair is seen behind the exercise bike, and the video pans over a long scar visible along Bernal's spine.

The video was posted with the message: "Never let anyone tell you that you cannot do something." Bernal has said he "almost died" after smashing into a bus during a training run last month.

The 25-year-old broke 11 ribs, a knee cap, a thigh bone, two vertebrae and a thumb, as well as puncturing both lungs, while practicing for the Tour de France -- a title he won in 2019 aged just 22 -- with his Ineos Grenadiers teammates near Bogota.

Traffic police said he was "so focused" that he did not hear warning shouts from his teammates that the bus in front of him had stopped.

He underwent five bouts of surgery, and was discharged from the University Clinic of La Sabana, on the outskirts of Bogota, after two weeks.



German Newcomer Nolte Blazes to Olympic Bobsleigh Gold

YANQING (Dispatches) - Laura Nolte blazed to Olympic gold in the two-women bobsleigh Saturday, just a year after winning the junior world title, as Germany again ruled at the Winter Games sliding center.



The 23-year-old Nolte left a field of former Olympic medallists in her wake with German team-mate and 2018 Pyeongchang champion Miriama Jamanka second, 0.77sec behind. The USA's Elana Meyers Taylor, 37, was third at 1.52sec to win the fifth Olympic medal of her career and the second of these Games after taking monobob silver.

Her team-mate Kaillie Humphries, the 2010 and 2014 two-woman Olympic champion and the monobob gold medallist in Beijing, lost time in Saturday's opening heat and ended up seventh.

It was a stunning display by Nolte, who earned a world bronze last year and has racked

up 14 podium places on the World Cup circuit since her debut season of 2019/20.

Having finished fourth in the monobob on Monday, Nolte was peerless Saturday,

clocking a top speed of 133 kilometres per hour (83 miles per hour) on her third run. Her victory means Germany have won eight of nine events at the Yanqing National Sliding Centre.

They can make it nine victories from ten in the men's four-man event on Sunday with Francesco Friedrich holding a narrow lead over fellow German pilot Johannes Lochner going into the final day.

Britain Stripped Of 4x100m Olympic Silver

LAUSANNE (Dispatches) - Great Britain were Friday stripped of their silver medal in the men's 4x100 meters relay at last year's Tokyo Olympics after CJ Ujah was found to have committed a doping violation.



Ujah tested positive for the prohibited substances ostarine and S-23, commonly used to build muscle, after the race on August 6.

The British team just lost out to Italy for the gold medal in Japan. Canada are expected to be awarded silver, with China promoted to the bronze-medal position.

A statement from the Court of Arbitration for Sport's anti-doping division said: "Ujah is sanctioned with the disqualification of his results in the 4x100m sprint relay final... together with the forfeiture of any medals, diplomas, points and prizes."

Ujah said in a statement that he accepted the decision with "sadness" but claimed he had "unknowingly consumed a contaminated supplement".

The 27-year-old apologized to his teammates, Zharnel Hughes, Nethaneel Mitchell-Blake and Richard Kilty.

"I would like to make it clear that I unknowingly consumed a contaminated supplement

and this was the reason why an anti-doping rule violation occurred at the Tokyo Olympic Games," Ujah said in a statement.

"I would like to apologize to my teammates, their families and support teams for the

impact which this has had on them.

"I'm sorry that this situation has cost my teammates the medals they worked so hard and so

"I'm sorry that this situation has cost my teammates the medals they worked so hard and so long for, and which they richly deserved. That is something I will regret for the rest of my life."
