## Rise in Iran's Foreign **Currency Revenues**

TEHRAN (IFP) - The governor of the Central Bank of Iran (CBI) says the country has witnessed a rise in its foreign currency income over the past months and has thus no problem with allocating foreign currency to the provision of essential goods.

Ali Salehabadi said on state television that the increase in Iran's foreign currency revenues was due to a hike in global oil prices and a growth in the country's crude production capacity.

"The oil production capacity has returned back to the presanctions levels. Our banking relations with friendly and neighboring states are also improving," the official added.

"Therefore, we fortunately face no problem in providing foreign currency for basic goods," he said.

The comments come amid concerns among Iranians over soaring prices of a number of essential goods such as flourbased products in the aftermath of a decision by the government to eliminate the relevant subsidies. The CBI chief also rejected the claims that the failure to join the Financial Action Taskforce (FATF) was hampering Iran's global trade under sanctions, saving this is not posing a "serious obstacle" and cannot hinder the country's exchanges with its partners.

Salehabadi also elaborated on the government's plans to counter the smuggling of foreign currency.


### **Good Outcome Within** Reach in Vienna If U.S. **Adheres to Commitments**

TEHRAN (PresTV) - Foreign Minister Hossein Amir-Abdollahian says Tehran and the P4+1 group of countries still have the opportunity to reach a "good and reliable" agreement on the revival of the 2015 deal if the United States makes the necessary decision and honors its commitments.

In a post on his Twitter account on Friday, Amir-Abdollahian said his contacts with the European Union's foreign policy chief Josep Borrell and his deputy Enrique Mora's talks with senior Iranian negotiator Ali Bagheri Kani in Tehran this week provided "another opportunity to focus on initiatives to resolve the remaining issues.'

"A good and reliable outcome is within reach if US makes its decision & adheres to its commitments," the top Iranian diplomat tweeted.

Mora launched his two-day visit to Tehran on Wednesday and met the chief Iranian negotiator to the Vienna talks with the five remaining parties to the 2015 deal, officially known as the Joint Comprehensive Plan of Action (JCPOA), on efforts to salvage the deal, which has been on life support since the US withdrawal in 2018 and its subsequent coercive measures against the Islamic Republic. # \$160b on Offer in **Iran Oil Show for Investment**

TEHRAN - Iran has offered a chance to participants in the 26th International Oil, Gas, Refining and Petrochemical Exhibition to channel \$160 billion in investments in the upstream sector of the country's oil industry, said a high-ranking official in Tehran. Talking to Shana, the National Iranian Oil Company (NIOC) managing director added that his country enjoys a special status in terms of holding international oil exhibitions, as Iran, thanks to its hydrocarbon reserves, ranks first in the world.

Given its widespread transfer and transit infrastructure, Iran has easy access to underground resources, boasted Mohsen Khojasteh-Mehr, continuing, "Sustainable energy supply is of great importance in today's world, and this is exactly one of the main features of the Islamic Republic's sovereignty."

Elaborating on the country's capacities, the NIOC head said Iran can meet a considerable portion of the global energy need or transport it to the four corners of the world.

The 26th edition of the exhibition, aka Iran Oil Show 2022, has focused on the motto of the current Iranian calendar year "Production: Knowledge-Based and Job-Creating" designated by Leader Ayatollah Seyed Ali Khamenei, explained Khojasteh-Mehr, adding the initiative has been highly welcomed by its participants.

According to the official, 100 knowledge-based firms and 20 top universities supported by the exhibition organizers have taken part in Iran Oil Show, playing a major role in the international event.

Khojasteh-Mehr said the National Iranian Oil Company will hold numerous rounds of negotiations with the participating companies during the four-day exhibition.

Iran Oil Show, which opens Friday, is hosting 1,200 Iranian and 44 foreign companies or their agents.

The companies and other participants are showcasing their latest achievements and products in 908 pavilions, of which 815 are the stands for companies, 23 for universities as well as scientific and research centers, and 70 for knowledge-based firms, startups, and industrial parks.

Meanwhile on Friday and during the opening of Iran Show Oil, Majlis Speaker said that the legislature, as the facilitator and regulator, will spare no effort to help the country's oil industry develop.

Mohammad Baqer Qalibaf, who made the pledge in his speech during the opening ceremony of the 26th International Oil, Gas, Refining and Petrochemical Exhibition in Tehran, added, "Direct injection of money into a country's economy leads to inflation, as we witness it today."

He said, "We are convinced that underground resources do not belong to governments," underlining that "they elong to present and future generations and therefore it is not a right way to sell crude oil and use for current expenditures."

Statistics indicate that the demand for oil is on a downward trend while the demand for natural gas is growing, said Qalibaf, calling for the development of the country's gas industry.

Selling crude oil is the main issue facing the country's energy sector, reiterated the top lawmaker, calling for solving the problem by the Legislative, Executive, and Judicial branches.

"Iran's oil industry is one of the driving forces of the Seventh Development Plan and can cause a major development in the country at the shortest time possible," he vowed.

## Navy Foils Pirate Attack, IRGC Seizes Vessel Smuggling Fuel

TEHRAN (PressTV) - Iran's Navy says its forces have foiled a pirate attack against a merchant ship sailing in the Gulf of Aden. The Iranian cargo ship came under attack early on Friday by unidentified pirates, who were later forced to flee following an exchange of fire with forces of the Navy's 80th fleet.

The vessel is now sailing safely to its designated destination thanks to the timely action by the Navy's escort team. Back in October 2021, an Iranian warship successfully foiled a pirate attack on an Iranian oil tanker in the Gulf of Aden following a heavy exchange of fire.

"The 78th naval fleet of the Islamic Republic of Iran, consisting of the Alborz destroyer, was attacked by five pirate boats this morning while escorting two Iranian tankers," Navy Commander Rear Admiral Shahram Irani said in an interview at the time, describing the incident as "maritime terrorism."

Irani also said during a presser last September, the country's maritime strength and reach has grown to such a level that its naval forces can now sail to any point across international waters.

"Iran is the only country that provides for its own naval security," he added.

## Zionists Silencing True Journalism

The Zionists have stepped up their crimes in recent days and they continue killing Palestinians and even they do not spare murdering journalists who try to reveal the true picture of them amid the silence of the international bodies and this time they killed one of the prominent journalist of Qatar's Aljazeera's News channel.

Shireen Abu Akleh, a longtime TV correspondent for Al Jazeera Arabic, was killed on Wednesday after being shot in the head while covering the Israeli army's raids in the city of Jenin in the northern occupied West Bank. Shatha Hanaysha, another Palestinian journalist who

was with Abu Akleh when she was murdered, asserted the incident was a "deliberate attempt" by Israeli forces to kill the journalists. Of course this is not the first time that the Zionist

forces have shown their true nature to the media but this time they have no excuse but trying to silence anyone who wanted to reveal their nature to the world.

Some 230 international rights organizations and networks strongly condemned the killing of veteran Palestinian journalist Shireen Abu Akleh by Israeli forces in the occupied West Bank, calling for the regime in Tel Aviv to be held accountable for the brutal crime.

The Palestinian Ma'an news agency said the 229 signatories affirmed in a statement that the Israeli occupation forces' targeting of the Palestinian journalist was a "deliberate and premeditated act and a full-fledged assassination operation."

But so far, Reporters Without Borders has been silent regarding this murder by the Israeli forces and now its independence has been questioned because of this passive attitude.

Reporters Without Borders is an international non-profit and non-governmental organization with the stated aim of safeguarding the right to freedom of information. It describes its advocacy as founded on the belief that everyone requires access to the news and information, in line with Article 19 of the Universal Declaration of Human Rights that recognizes the right to receive and share information regardless of frontiers, along with other international rights charters.

But it seems someone should awaken this organization to react to this brutal savagery of the Zionists against one of the prominent Palestinian journalists. We have once and again seen that this organization takes stand against suppressing media and journalist in the countries but it seems they just take stand whenever they want and against some certain countries like Russia, China or any other country that this organization is at odd with them. ## Iran to Fix Venezuela's PDVSA El Palito Refinery

TEHRAN (IRNA) - National Iranian Oil Engineering and Construction Company on behalf of the National Iranian Oil and Distribution Company (NIORDC), signed A fundamental repairs contract and the launch of PDVSA El Palito refinery in Venezuela with a sum of 110 million Euros.

"The agreement came after recent negotiations and investigations carried out with the presence of Iran's Oil Minister Javad Owji, Deputy minister and ceo of the National Iranian Oil and Distribution Company and managing director of National Iranian Oil Engineering and Construction Company in Venezuela.

The deal aimed at repairs, commissioning and completion of a refinery capacity of 140,000 barrels per day in Venezuela (currently operating with 50 % of its capacity), Farhad Ahmadi, managing director of the National Iranian Oil and Distribution Company (NIORDC) said .

The project will be financed by Naftiran Intertrade Company whose financial contract is signed between the NICO and the Venezuelan company, he added.

Ahmadi said that the crude oil feed of the refinery will be provided by the participation of National Iranian Oil Company through NICO company.

# **President Emphasizes Completing Citizens' Health Database**

TEHRAN - Referring to the significant decrease in the number of deaths and patients of COVID-19 in the country, President Seyed Ebrahim Raisi advised the officials of the Ministry of Health to use this opportunity to prepare a health ID and complete the citizens' health database.

Speaking on Saturday at the meeting of the National Task Force Against Coronavirus, Raisi referred to the significant reduction in the number of deaths and patients with COVID-19, thanking the efforts of the country's medical staff to protect the lives of the people".

President called the fair and disciplined handling of the requests of those who have not received the subsidies one of the most important tasks of the related agencies and



instructed the relevant authorities to identify those who are really entitled to receive the subsidy and to compensate for them as soon as possible.

TEHRAN (PressTV) - Foreign Ministry has reiterated its full solidarity with the Palestinian cause, calling on world governments and organization to fulfill their human and legal duty and end the Israeli regime's occupation and crimes. The ministry issued a statement on Friday, on the eve of the Nakba Day (the Day of Catastrophe), when in 1948, hundreds

"The Islamic Republic of Iran, while expressing its full solidarity with the Palestinian cause, ... calls on all governments and international bodies to shoulder their human and legal duties vis-à-vis the oppressed Palestinian people and prevent a continuation of occupation and crimes by the regime occupying al-Quds and the spread of its racist policies in occupied Palestine," the statement read.

It said as history shows, any compromise with the sworn enemies of Muslim nations encourages the apartheid Zionist regime in its inhumane acts and violations of human rights.

"The Muslim nations and their leaders should know the only way to realize the Palestinian people's rights is maintaining unity, and keeping up support from the freedom-seeking governments and Muslim nations for resistance against the occupiers and bullying powers," the ministry said.

"Iran believes that just and lasting peace will not be established in the Middle East unless through the resolution of the fundamental issues in this crisis, including ending the organized occupation of Palestine, securing a return of refugees, deciding Palestine's future establishment via a referendum participated by all of its true owners, and the formation of a unified Palestinian government, with al-Quds as its capital."

The statement said May 14, 1948 is reminiscent of occupation, massacre and displacement of the true owners of the Palestinian land at the hands of the Zionist occupiers and usurpers, and the onset of a trend of systematic violations of the Palestinian nation's basic rights.

## Latest COVID-19 Map Has No Red, Orange Zones

TEHRAN (PressTV) - After a spirited fight against the COVID-19 pandemic, lasting more than two years, the new virus map released by Iran's health on Friday has brought a big cheer to peopl across the country.

In a daily health bulletin on Friday, the ministry announced 385 new infections and 8 fatalities.

However, what is remarkable is how the color of the nationwide coronavirus map has transformed, with no red or orange zones visible anymore.

While no city is currently marked in the "high-risk" red category, the cities in the "moderate-risk" orange category have also dropped from 4 to 0, according to

The number of cities with "low-risk", marked as vellow, has also decreased from 319 to 259 cities on the latest map, as a testament to the successful fight against the pandemic that has wreaked havoc across the globe.

The highly-contagious delta and omicron variants of the pandemic, which fueled the surge in infections and deaths in Iran in recent months, have almost faded, according to health experts, taking the shape of normal flu.

The fight against the cataclysmic virus in Iran, however, has not been an easy one, because the Western powers left no stone unturned in weaponizing it against the Iranian nation.

When the first cases of the virus were detected in Iran in February 2020, the US and its allies, instead of extending a helping hand, tightened the screws of cruel sanctions and created seemingly insurmountable hurdles for the country.

# **Tehran, Minsk Explore Ways to Boost Economic Cooperation**

### TEHRAN - Iran and Belarus in a webinar explored ways to take advantage of opportunities for broadening economic cooperation.

According to reports, the webinar was held by Tehran Chamber of Commerce where some economic activists of Iran and Belarus as well as the ambassadors of the two countries were present.

In the event, Secretary General of Tehran Chamber of Commerce Mr. Bahman Eshqi announced readiness of the chamber for hosting the delegation of Belarusian entrepreneurs in the upcoming months and reminded that Tehran Chamber with sending invitations to this Belarusian association has started plans for gathering and direct talks between the businessmen of the two countries.

He pointed to the West's sanctions as the commonality of Iran and Belarus and said both sides have potentials to provide required products of the other side, adding that since Belarus is unable to send its products to EU due to sanctions, it can transit its goods via the transit route to Afghanistan and India through Iran.

Eshqi then stipulated that Belarus can resolve Iran's restriction for broadening its trade exchange with neighboring states by providing containers and wagons on the Astara, Sarakhs and Inchebron routes.

He also criticized Belarus for revaluating Iran's agro products in Belarusian custom office which leads to the price rise and it reduces the chance of competition of Iranian



products with other rivals. He recommended Belarus to define a unified mechanism for revaluating the goods among the Eurasian Economic Union members.

Ambassador of Belarus to Tehran Dmitry Kaslov, for his part, pointed to the interests of the Belarussian companies for joint cooperation with Iranian entrepreneurs in the field of food and agro products, machineries, medicines and apparel and stipulated that his provincial meetings in Iran with officials and economic activists of each province bespeaks of high capacities for cooperation between the two countries.

MOSCOW (Dispatches) - The leader of Georgia's breakaway region of South Ossetia on Friday set July 17 as a date for a referendum on joining Russia.



ISTANBUL (Dispatches) - President Recep Tayyip Erdogan on Friday said Turkey did not have a "positive opinion" on Finland and Sweden joining NATO, throwing up a potential obstacle for the nations' membership bid. The leader of NATO-member Turkey spoke ahead of expected confirmations from the Nordic nations on Sunday that they will apply to join the Western military alliance.

Erdogan accused both countries of harboring "terrorist organizations" in his unfavorable assessment of the membership bids.

"We do not have a positive opinion," Erdogan told journalists after Friday prayers in Istanbul.

"Scandinavian countries are like a guesthouse for terror organizations," he said.

Turkey has long accused Nordic countries, in particular Sweden, which has a strong Turkish immigrant community, of harboring extremist Kurdish groups as well as supporters of Fethullah Gulen, the U.S.-based preacher wanted over the failed 2016 coup.

Erdogan cited a "mistake" made by Turkey's former rulers who greenlit Greece's NATO membership in 1952. "We, as Turkey, do not want to make a second mistake on this issue," he said.

Moscow's February 24 invasion of Ukraine has swung political and public opinion in Finland and Sweden in favor of membership as a deterrent against Russian aggression. Both countries have long cooperated with NATO, and are expected

to be able to join the alliance quickly. NATO chief Jens Stoltenberg has repeatedly said they would be

welcomed "with open arms". Turkey's "not positive" response is the first dissenting voice at the prospect of the

two Nordic countries' NATO prospects. Stockholm and Helsinki have cranked up their international contacts

to seek support for their potential bids. Once a country has decided to apply for NATO membership, the 30 members of the alliance must agree unanimously

to extend a formal invitation, which is followed by membership negotiations. The final approval could then take place at a NATO summit in Madrid at

the end of June. The 30 member states would then have to ratify the decision.

Turkey, which enjoys good relations with Kyiv and Moscow, has been keen to play a mediating role to end the conflict and has offered to host a leaders' summit.

Ankara has supplied Ukraine with combat drones, but has shied away from slapping sanctions on Russia alongside Western allies.

Turkey's position on Sweden and Finland's NATO membership risks making it look like the "Hungary of the EU", said Washington Institute fellow Soner Cagaptay.

Pro-Russia Hungary often breaks from its EU colleagues on a broad range of issues, including rule of law and human rights.

Cagaptay said Ankara should have negotiated its terror-related concerns behind closed doors with the two countries.

"The fact that this is done publicly is going to hurt Ankara's image significantly," he said.

Erdogan's comments may also raise tensions with France, whose President Emmanuel Macron has said that NATO was undergoing "brain death" partly due to Turkey's behavior.

### Slain Al Jazeera Journalist Shireen Abu Akleh Laid to Rest

BEIRUT (Dispatches) - Veteran Al Jazeera journalist Shireen Abu Akleh has been laid to rest in a cemetery in occupied East Jerusalem, three days after she was fatally shot by Israeli forces while reporting on a raid in the occupied West Bank.

Thousands of people gathered for Abu Akleh's funeral on Friday, including family, friends, and those who only knew Abu Akleh as a mainstay for 15 years in Al Jazeera's coverage of the occupied Palestinian territories and the lives of everyday Palestinians.

Some mourners hoisted Palestinian flags, with many chanting "Palestine, Palestine" as the coffin was moved from St Louis French Hospital in occupied East Jerusalem's Sheikh Jarrah neighbourhood to a funeral service at Jaffa Gate in Jerusalem's Old City and finally to the Mount Zion Cemetery, where Abu Akleh was buried next to her parents.

Her niece, Lina Abu Akleh, remembered her aunt's "commitment to making sure that people know the truth, and her love for the people in making sure they know the truth."

"She knew how much she was loved, but she was so humble, she never wanted to be at the centre of attention," she said. "I think she would have been proud to see how the Palestinian people supported her and supported our family,

Father Fadi Diab, the priest who conducted the funeral, told Al Jazeera that Abu Akleh's killing would "have influence all over the world".

"Shireen Abu Akleh was a messenger for Palestinians and for their rights," he said. "Life is sacred and we're not allowed to assassinate life. God created life not to be assassinated, but to be nurtured."

"If someone imagined that the influence of Shireen will stop, no," he said. Now, she will have influence all over the world."

Still, constant reminders of the Israeli occupation on which Abu Akleh so often reported loomed over the three days of memorials that preceded the burial.

Israeli police entered the Al Jazeera veteran's home on Wednesday, hours after she was killed, removing a Palestinian flag and telling mourners to turn down patriotic music.

Kuleba also urged the EU to ensure that an embargo is placed on Russian oil, warning that an omission of the ban on the bloc's next package would mean its unity was "broken"

The war in Ukraine had led to greater unity among Western allies, Kuleba said.

## Sri Lanka Opposition, Protesters Push Anti-Gov't

COLOMBO (Dispatches) - Sri Lanka's main opposition party joined anti-government protesters on Friday in rejecting the appointment of a new prime minister and insisted the president resign to take responsibility for the country's disastrous economic crisis.

President Gotabaya Rajapaksa appointed five-time prime minister Ranil Wickremesinghe to his sixth term late on Thursday, but opposition comments signalled it was not likely to resolve the political and economic disarray in the strategic Indian Ocean island nation.

A week of violent clashes between protesters and government supporters across the country has left nine people dead and more than 300 wounded. The president's elder brother, Mahinda Rajapaksa, quit as in hiding in a military base.

The rest of the cabinet quit earlier.

"It is clear the (new) prime minister is remote controlled by the president," said Eran Wickramaratne, a parliamentarian and senior member of the main opposition party, the Samagi Jana Balawegaya. "This country wants the Rajapaksas to go home. We are committed to that goal."

Protesters who have camped out at a site near the prime minister's office for over a month also rejected the appointment. "We will stop this struggle when our people get justice," said Chamalage Shivakumar, one of the hundreds of people at the "Gota Go Home"

protest site, named after the president.

"Whoever they appoint as prime minister, we will not stop this struggle until people get relief."

Wickremesinghe, 73, is the only lawmaker from his United National Party in parliament and will be reliant on rival political parties to form a coalition government. An alliance led by the Rajapaksas holds about 100 of parliament's 225 seats, while the opposition has 58 seats. The rest are independent.

On Friday, Wickremesinghe held talks with foreign envoys representing India, Japan, the United States and China, his office said.

"Discussed continued cooperation for economic recovery and stability in Sri Lanka through democratic processes," the Indian High Commission in Colombo said in a tweet.

New Delhi is battling China for influence in Sri Lanka, which lies on key shipping lanes between Asia and Europe and is home to major infrastructure projects financed by both countries.

The prime minister also held an emergency meeting with officials from the energy ministry regarding chronic fuel shortages that have blighted the island for months.

Protesters said the appointment of Wickremesinghe will do little to ease the anger against the president, who they say is ultimately responsible for the worst economic crisis to hit the nation since it became independent from Britain in 1948.



## **UAE President and Pro-West** Modernizer Khalifa Dies



ABU DHABI (Dispatches) - United Arab Emirates President Sheikh Khalifa Bin Zayed Al Nahyan, a pro-Western moderniser who had aligned the Persian Gulf Arab state closer to the United States and its allies, died on Friday. read more

The Ministry of Presidential Affairs announced the death of Khalifa, who was also ruler of the UAE's richest emirate, Abu Dhabi, but gave no details. Khalifa, born in 1948, had rarely been seen in public since suffering a stroke in 2014. He was buried and funeral prayers were held on Friday, state news agency WAM said.

"The UAE has lost its righteous son and leader of the 'empowerment phase' and guardian of its blessed journey," his half-brother and Abu Dhabi Crown Prince Sheikh Mohammed bin Zayed said on Twitter, praising Khalifa's wisdom and generosity.

Mohammed, known as MbZ, has for years been the de facto ruler of the UAE, an OPEC oil producer and a major trade and tourism hub which has moved to build its political influence in the region and abroad.

UAE state media on Friday started referring to MBZ as the new ruler of Abu Dhabi, which holds most of the UAE's oil wealth and has held the presidency since the founding of the UAE federation by Khalifa's father, the late Sheikh Zayed bin Sultan al-Nahyan, in 1971.

Under the constitution, vice-president and premier Sheikh Mohammed bin Rashid al-Maktoum, ruler of Dubai, would act as president until the federal supreme council which groups the rulers of the seven emirates meets within 30 days to elect a new president.

Diplomats and analysts expect MbZ to become new president, further consolidating Abu Dhabi's power which had already grown under Khalifa, who came to power in 2004.

Khalifa's death comes at a time when Abu Dhabi's ties with Washington have been visibly strained over perceived U.S. disengagement from its Gulf allies' security concerns.

"Not much will change in UAE foreign & domestic policies, except MbZ will have even less reason to seek consensus w/Dubai & other Emirates,"

tweeted Cinzia Bianco, research fellow at European Council on Foreign Relations. MbZ led a realignment of the Middle East that created a new anti-Iran axis with Israel and fought a rising tide of political Islam around the region.

# Musk Puts \$44b Twitter Deal on Hold

NEW YORK 9Dispatches) - Elon Musk put his \$44 billion deal for Twitter "temporarily on hold" on Friday while he awaits data on the proportion of its fake accounts, sending the shares in the social media platform plunging.

In a tweet, the Tesla billionaire linked to a Reuters story from May 2 citing a financial filing from Twitter that estimated false or spam accounts made up fewer than 5% of the company's "monetizable daily active users"

"Twitter deal temporarily on hold pending details supporting calculation that spam/fake accounts do indeed represent less than 5% of users," Musk wrote on Twitter.





## **OPEC Cuts 2022 World Oil Demand Forecast Again on Ukraine War**

LONDON (Dispatches) - OPEC cut its forecast for growth in world oil demand in 2022 for a second straight month, citing the impact of Russia's invasion of Ukraine, rising inflation and the resurgence of the Omicron coronavirus variant in China.

In a monthly report, the Organization of the Petroleum Exporting Countries (OPEC) said world demand would rise by 3.36 million barrels per day (bpd) in 2022, down 310,000 bpd from its previous forecast.

The Ukraine war sent oil prices briefly above \$139 a barrel in March, the highest since 2008, worsening inflationary pressures. OPEC has cited suggestions that China, with strict COVID EU Readies 195b Euro Plan to Quit Russian Fossil Fuels

lockdowns, is facing its biggest demand shock since 2020 "Demand in 2022 is expected to be impacted by ongoing

geopolitical developments in Eastern Europe, as well as COVID-19 pandemic restrictions," OPEC said in the report. Nonetheless, OPEC still expects world consumption to surpass the 100 million bpd mark in the third quarter, and for the 2022

annual average to just exceed the pre-pandemic 2019 rate. OPEC cited rising inflation and continued monetary tightening, and lowered this year's economic growth forecast to 3.5% from

3.9%, adding upside potential was "quite limited". "It may come from a solution to the Russia and Ukraine situation, fiscal stimulus where possible, and a fading pandemic, in combination with a strong rise in service sector

activity," OPEC said. Oil extended an earlier decline after the report was released, trading further below \$106.

OPEC and its allies which include Russia, known as OPEC+, are unwinding record output cuts put in place during the worst of the pandemic in 2020 and have rebuffed Western pressure to raise output at a faster pace.

At its last meeting, OPEC+ swerved the Ukraine crisis and stuck to a previously agreed plan to boost its monthly output target by 432,000 bpd in June.

OPEC+ has been undershooting the increases due to underinvestment in oilfields in some OPEC members and, more recently, losses in Russian


output as a result of sanctions and buyer avoidance. The report showed OPEC output in April rose by 153,000 bpd to 28.65 million bpd, lagging the 254,000 bpd rise that OPEC is allowed under

the OPEC+ deal. The growth forecast for non-OPEC supply in 2022 was reduced by 300,000 bpd to 2.4 million bpd. OPEC cut its forecast for Russian output by 360,000 bpd and left its U.S. output growth estimate

largely unchanged. OPEC expects U.S. tight oil supply to rise by 880,000 bpd in 2022, unchanged from last month, although it said there was potential for further expansion later in the year.

The Southeast Asian nation's economy grew a better-than-expected 8.3% in the first quarter, the government said on Thursday. It was the fastest annual growth since the June quarter of 2021 and exceeded a 6.6% forecast in a Reuters poll.

On a seasonally adjusted basis, the economy grew 1.9% in January-March from the previous quarter, with the easing of COVID-19 curbs and election-related spending

underpinning domestic demand. The Philippines thus was the fastest growing economy in the East Asia Region for the period, officials said.

That gives the Bangko Sentral ng Pilipinas (BSP) scope to raise interest rates to tackle rising inflation, which threatens to dampen consumer sentiment and derail the economic recovery.

"The BSP stands ready to adjust our monetary policy settings, should we see material risk of these supply-side pressures spilling over to the demand side," BSP Governor Benjamin Diokno said following the data release.

The BSP holds its next policy meeting on May 19, with some analysts seeing higher chances for an interest rate hike as early as its May 19 meeting.

"With GDP now back to pre-COVID levels and with inflation accelerating, we fully expect BSP to hike policy rates at the May 19 meeting," said ING senior economist Nicholas Mapa.

Diokno, however, has flagged a possible hike in June, and he said the BSP was looking at raising rates two to three times to bring down inflation by next year.

Economists have raised concerns the BSP, which has kept benchmark interest rates steady since November 2020 at record lows, could fall behind the curve as central banks around the world step up monetary tightening to fight inflation.

"Since we are doing relatively well on the economic opening as evidenced by the Q1 data, the immediate priority is to address inflation, especially those that affected people the most, food prices," Economic Planning Secretary Karl Kendrick Chua told a news conference.

To sustain the growth momentum, Chua also urged the next administration to pursue further tax reforms, continue fiscal prudence and boost tax revenues needed to finance infrastructure projects and human capital development.

BRUSSELS (Dispatches) - The European Commission plans to unveil a 195 billion euro plan to stop importing Russian fossil fuels by 2027, combining a faster rollout of renewable energy and energy savings with a switch to alternative gas supplies, draft documents show.

The draft measures, which could change before they are due to be published next week, include a mix of EU laws, non-binding schemes, and recommendations national governments could take up, including by revising their plans to spend the EU's huge COVID-19 recovery fund to free up more funding for the energy transition.

The Commission expects the measures to require 195 billion euros in investments, on top of those already needed to meet the bloc's 2030 climate target, which would help slash Europe's bill for fossil fuel imports. To spearhead the plans, Brussels is considering proposing higher targets for renewable energy and energy efficiency, according to the draft proposals and EU officials.

Goals under discussion include a target for a 45% share of renewable energy by 2030, replacing the current 40% proposal, and a 13% cut in EU-wide energy consumption by 2030 compared with expected use, replacing the Commission's current 9% proposal. Among other proposals would be tweaks to EU law to fast-track permitting deadlines for some renewable energy projects, and new EU schemes to jumpstart a arge-scale rollout of solar energy and rebuild Europe's solar manufacturing industry.

Brussels will also outline plans to produce 10 million tons of renewable hydrogen by 2030 and import another 10 million tons, supported by legislation defining which types of hydrogen can count as renewable.

### **Emirates Airline Announces Significantly Lower \$1.1b Annual Loss**

DUBAI (Dispatches) - Emirates airline announced a "significantly reduced" annual loss of \$1.1 billion dollars on Friday, five times lower than a year before, as pandemic travel restrictions ease.

Losses came in at 3.9 billion dirhams (\$1.1 billion) in the 2021-2022 financial year to March, with revenues up 91 percent, as the airline expanded its global capacity and reinstated flights, Emirates said in a statement.

The Middle East's largest carrier said it received a capital injection of \$954 million from its owner, the government of Dubai, to help it survive the crisis.

"This year, we focused on restoring our operations quickly and safely wherever pandemic-related restrictions eased across our markets," said its chairman and chief executive, Sheikh Ahmed bin Saeed Al-Maktoum.

"Business recovery picked up pace particularly in the second half of the year. Robust customer demand drove a huge improvement in our financial performance compared to our unprecedented losses of last year and we built up our strong cash balance."

In Friday's statement, it said the Emirates Group -- which includes ground-handling firm Dnata -- recorded an annual loss of 3.8 billion dirhams (\$1.0 billion), but with revenues up by 86 percent and "strong customer demand".

Over the fiscal year, Emirates carried 19.6 million passengers, up from 6.6 million in the same period of the previous year.

"2021-22 was also a significant year as the UAE marked its 50th anniversary and hosted the world at Expo 2020 Dubai which generated increased global engagement and visitation to the UAE," Sheikh Ahmed said.

In the previous year, Emirates posted a \$5.5 billion annual loss, its first in more than three decades, after the pandemic devastated the aviation industry.

Like many other major airlines, it announced heavy layoffs when its fleet was grounded.

In Friday's statement, it said that as operations ramped up, "employees previously on furlough or made redundant were recalled and rehired, and new recruitment drives were held".

The group's total workforce increased by 13 percent to 85,219 employees, it added.

Emirates specialises in long-haul flights, with its fleet solely composed of large Airbus A380 and Boeing 777 aircraft, dozens of which it grounded amid a lack of passenger traffic.

It added that the group invested \$2.2 billion in new aircraft and facilities and received its final five new A380 plane during the financial year.

Emirates is currently flying to 140 destinations, almost its full travel network of 158 destinations in 85 countries before the pandemic.

## Turkish Industrial Output Beats Forecasts to Expand by 9.6%



ANKARA (Dispatches) - Turkey's industrial production exceeded forecasts by expanding 9.6% year-over-year in March, official data showed Friday, rising for a 21st consecutive month as factory activity remains strong despite high inflation. Year-over-year growth has remained positive and

sustained a solid trend in economic activity since the lifting of measures to combat the coronavirus pandemic in 2020.

On a monthly basis, the index shrank 2.4% in January due to electricity and natural gas cuts at industrial facilities stemming from a technical failure in Iran.

The median estimate in a Reuters poll of seven institutions this week had forecast a year-over-year growth of 6.5% in the calendar-adjusted industrial production index.

Month-on-month, industrial output shrank 1.8% in March on a calendar and seasonally adjusted basis. the Turkish Statistical Institute (TurkStat) said.

Economists expect the pace of growth in the index to slow in the coming months and approach a neutral level around summer. A potential drop in external demand or a supply chain disruption due to Russia's invasion of Ukraine could also impact industrial production.

In April of 2020, output dropped more than 30% in the face of the initial coronavirus wave. It has since made a strong recovery because subsequent measures largely skirted the manufacturing sector and most remaining restrictions were lifted in July of last year.

Turkey's economy grew 11% last year, up sharply from a year earlier, but a sharp decline in the lira in December affected the company and household budgets and increased inflation via import prices.


# China Denies Suspending Passports, Invalidating Foreign Residency Cards

BEIJING (Dispatches) - China's immigration authority is still providing services for necessary trips outside the country, it said on Friday, denying rumors that passport issuances were halted and that residency cards for living in foreign countries were being invalidated.

Officials have promptly processed certificates for people who need to travel abroad for necessary and urgent matters such as study, scientific research, trade and businesses and medical issues, the National Immigration Administration (NIA) said in a statement.

The NIA was responding to what it said were "foreign media reports" that falsely said the agency had suspended passport issuances and had invalidated residency cards issued by foreign countries to Chinese citizens eligible to live overseas by cutting off the corners. The NIA statement did not include examples of the reports.

The statement followed the NIA's announcement on Thursday that it would "strictly limit" unnecessary overseas travels by Chinese citizens to minimize the risks of a resurgence in COVID-19 cases caused by infections among international travelers. "There remain great uncertainties in the development of the pandemic and a big risk of getting infected during trips



"People in the country should continue not to travel abroad for unnecessary, non urgent purposes."

Overseas travel from China has become more difficult with frequent flight cancellations and travel curbs in areas with domestic COVID outbreaks, as the country insists on stringent moves including citywide lockdowns to curb a wave of infections this year.

The country has suspended issuing common passports for trips considered unnecessary. In February, the NIA said it has not resumed issuing or renewing passports for leisure tours.


Trips in or out of the country made by mainland citizens in 2021 plunged nearly 80% compared with the level in 2019, NIA data showed.



## **Iran Reacts to Discovery of Mass Graves of Native Americans**

TEHRAN (IRNA) - Secretary of Islamic Republic of Iran Human Rights Headquarters reacted to discovery of mass graves of Native Americans in United States, and criticized U.S. finding faults with others despite its own broad violations of the same.

"Poor Native American children were separated from their families, prohibited from speaking their languages, abused, raped, and finally dumped in mass graves," wrote Kazem Gharibabadi in a tweet.





# **U.S. Nears 1m Covid Dead**

NEW YORK (Dispatches) - The United States is about to cross the threshold of one million deaths from Covid-19, a grim milestone that comes as cities like New York try to turn the page on the pandemic despite threats of another surge.

"It's unfathomable," Diana Berrent, one of the first people in New York state to catch coronavirus, said of the toll that far exceeds epidemiologists' worst predictions made at the outbreak of the crisis in spring 2020.

Then, New York City was the virus epicenter. Hospitals and morgues overflowed and empty streets rang to the sound of ambulance sirens as then-president Donald Trump responded chaotically in Washington.

Two years on, and life in the Big Apple is largely back to normal as residents attempt to put the collective trauma of the virus that has killed 40,000 New Yorkers behind them.

Broadway stage lights are once again illuminated, tourists are back riding in horse carriage in Central Park, yellow taxis clog main avenues and bars in business districts hum with post-work chatter.

"Without a doubt you feel the energy of the people that are on the streets. It's been a long time coming," Alfred Cerullo, president of a business improvement group in Midtown Manhattan, told AFP.

New York's rebound has been aided by its high vaccination numbers -- some 88 percent of adults are fully vaccinated, a rate that was boosted by mandates, including for indoor activities like dining.

Some U.S. hospitals became overwhelmed with patients during infection surges in the Covid-19 pandemic

Jeffrey Bank, owner of Carmine's restaurant near Times Square, says sales at the Italian eatery are better than they were in 2019, as residents and tourists make up for lost time.

"People have been sitting at home for two years. They want to celebrate and they're entitled to," he told AFP.

But the city has a long way to go. Many stores remain empty and only 38 percent of Manhattan office workers are in the office on an average weekday, according to Kastle Systems, a security firm that tracks building occupancy.

The Big Apple's tourism board also doesn't expect visitor numbers to get back to the 67 million of 2019 people for a few years.

And business owners fear another wave of infections.

"Obviously we are worried," Frank Tedesco, who is unsure how he could keep his jewelry business afloat if another shutdown occurred, told AFP.

A vigil was held in January 2022 in Lafayette Park, Washington DC, for nurses who died during the pandemic

The rise has coincided with the lifting of mask mandates.

"I think we are in a place where psychologically and socially and economically, people are largely done with the pandemic," said Celine Gounder, an infectious disease expert at New York University.

"(But) the pandemic is not over. So you have a disconnect between what is happening epidemiologically and what's happening in terms of how people are responding," she told AFP.

Among the most at-risk are the unvaccinated, lower-income populations, uninsured people and communities of color, she says.



America recorded its first coronavirus death, on the West Coast, in early February 2020. By the next month, the virus was ravaging New York and the White House was predicting up to 240,000 deaths nationwide.

But those projections were way off.

Trump was late to back social distancing, repeatedly undermined top scientist Anthony Fauci, peddled unproven medical treatments, and politicized mask-wearing -- before eventually being hospitalized with the virus himself.

In New York and other northeastern urban centers, hospitals become overwhelmed and morgues failed keep up with the dead.

"There were nurses that said if they closed their eyes at night they could hear the patients struggling to breathe and they couldn't get it out of their heads," recalled Boston nurse Janice Maloof-Tomaso.

Ideological clashes over curfews and mask and vaccine mandates ensued as America racked up the world's highest death toll.

Trump did pump billions of dollars into vaccine research, however, and by mid-December 2020, the first vaccines were available for health care workers.

But deaths kept soaring amid a slow take-up of shots in conservative areas of the country, and in February 2021 America counted 500,000 dead.

New President Joe Biden and many Democratic governors enforced mandates but Republican-led states like Florida and Texas outright banned them, highlighting America's patchwork of rules that made forming a unified response to the pandemic difficult.

"We went from 'stay home and save lives' to let it rip," recalled 47-year-old Berrent, who, after her illness in 2020, founded the group Survivor Corps for people looking for information about long-haul Covid or a current Covid-19 infection.

"The question is no longer, 'Have you had Covid?' It's, 'How many times have you had Covid, and what symptoms do you still have?"

### **Renewable Energy to Grow** Tourism Recovering, But Not Back to Pre-Pandemic Levels To New Record in 2022



PARIS (Dispatches) - The world will set a new record for renewable power capacity this year led by solar energy in China and Europe, but growth could lose steam in 2023, the International Energy Agency said.

A record 295 gigawatts of new renewable power capacity was added in 2021 despite supply chain bottlenecks, construction delays and high prices of raw materials, the IEA said in a report.

An additional 320 gigawatts is expected to be installed this year, equivalent to the entire electricity demand of Germany or the European Union's total electricity generation from natural gas.

Solar energy will account for 60 per cent of renewable power growth in 2022, ahead of wind and hydropower, according to the agency, which advises developed nations on energy policy.

"The additional renewables capacity commissioned for 2022 and 2023 has the potential to significantly reduce the European Union's dependence on Russian gas in the power sector," the IEA said.

"However, the actual contribution will depend on the success of parallel energy efficiency measures to keep the region's energy demand in check.'

The EU set a goal of slashing its heavy reliance on Russian natural gas by two thirds this year following Moscow's invasion of Ukraine.

"Energy market developments in recent months especially in Europe — have proven once again the essential role of renewables in improving energy security, in addition to their well-established effectiveness at reducing emissions," IEA Executive Director Fatih Birol said in a statement.

He urged governments to cut red tape, accelerate the deliveries of permits and provide the right incentives for a faster deployment of renewables.

PARIS (Dispatches) - Global tourism is roaring back to life despite Covid travel headaches and the effects of the war in Ukraine, but it has yet to return to its pre-pandemic health.

International tourist arrivals worldwide have more than doubled, up 130 percent in January 2022 on the same period last year, according to the latest UN World Tourism Organization figures

Travellers are regaining confidence, and Europe and the Americas are leading the resurgence. Worldwide, there have been 18 million additional visitors, the UNWTO said, "equivalent to the total increase recorded over the whole of 2021"

In 2019, global tourism revenues reached \$1.48 trillion. That figure dropped by almost two thirds due to the pandemic the following year. While January confirms the recovery trend that began in 2021, the UNWTO highlighted how the Omicron Covid

variant recently put the brakes on the rise. International arrivals in January 2022 were still 67 percent lower than before the pandemic. Most regions have seen travellers return and rebound from the low levels of early 2021, with Europe faring three

times better and the Americas twice as well. That's still some way off pre-pandemic numbers, but Larry Cuculic, general manager of the Best Western hotel

company, is optimistic. "I travelled earlier this week and I can tell you that the airports, the international terminals in the US are very crowded and there is a demand or an interest in travelling to Europe, because for several years we couldn't do that," he told AFP.

The Middle East is also experiencing a boom, with arrivals up 89 percent on 2021, and so is Africa, with numbers up 51 percent -- but these two regions are still very far from their 2019 totals, according to the UNWTO. Perhaps unsurprisingly, the number of travellers is falling in the Asia-Pacific region, where several destinations

remain closed. In January, international tourist arrivals were down 93 percent from pre-pandemic levels. Travel by Chinese tourists, the world's biggest spenders before the pandemic, is also severely affected by China's

According to travel analyst ForwardKeys, the second quarter of 2022 still looks "more promising for international travel in the world than the first quarter".

The Caribbean and South America are drawing tourists looking for sea and sunshine in the northern hemisphere summer. Costa Rica, the Dominican Republic, Aruba and Jamaica are among the 20 most popular destinations. even exceeding pre-pandemic levels. In Europe, tourists are flocking to France, Spain, Portugal, Greece and Iceland, but not in the same numbers as before Covid.

France is doing well enough, though. In February, international tourism revenues in the country "came close to those of 2019", according to France's tourism minister Jean-Baptiste Lemoyne.

Mojtaba Ghahramani, head of the Justice Department of Iran's southern province of Hormozgan, said Saturday that the IRGC Navy forces have identified and confiscated a vessel carrying more than 42 thousand liters of fuel.

Several rounds of negotiations between Iran and the P4+1 group of countries - Britain, France, Germany, China and Russia – have been held in the Austrian capital since April 2021 to bring Washington back into the deal. The Vienna talks, however, exclude American diplomats due to their country's withdrawal.

The Joe Biden administration disagrees, even though it has admitted on countless occasions that Trump's maximum pressure policy has been a disastrous failure. It has retained the IRGC's designation and the economic sanctions as leverage

The Iranian foreign minister said last month that the United States' current administration should have the courage to correct its predecessor's mistakes concerning re-imposition of oppressive sanctions against Iran.

The European Union's foreign policy chief also on Friday expressed hope that the stalled talks over the JCPOA revival and the removal of sanctions against Iran can lead to a final agreement, saying that he believed there had been enough progress during Mora's consultations with Iranian officials in Tehran this week to re-launch the talks after two months of deadlock.

Speaking to reporters at a G7 foreign ministers' meeting in northern Germany, Borrell added that Iran's response had been "positive enough" after Mora had delivered a message that things could not continue as they were.

"These kind of things cannot be solved overnight, but let's say the negotiations were blocked and they have been deblocked," he said, emphasizing that "there is a perspective of reaching agreement."

"It has gone better than expected - the negotiations were stalled, and now they have been reopened."



## **Amir Khan Announces Retirement**

ONDON (Dispatches) - Britain's former light-welterweight Lworld champion Amir Khan announced his retirement from boxing on Friday after defeat to compatriot Kell Brook in February.

Khan, Olympic lightweight silver medallist at the 2004 Athens Games when he was 17 years old, won the WBA light-welter belt from Ukrainian Andriy Kotelnyk in 2009 and added the IBF title in 2011 when he beat American Zab Judah.

He bows out with a record of 34 wins from 40 fights, with six defeats.

## Nadal Falls in Italian Open to Shapovalov ROME (Dispatches) - Defending champion Rafael Nadal crashed out of the Italian Open in the third round with the record 10-time Rome winner complaining of a recurring foot problem after a shock 1-6, 7-5, 6-2 defeat by Canadian Denis Shapovalov. Defeat in Rome for 'King of Clay' Nadal casts doubt over his prospects at the upcoming French Open, where he has been crowned champion 13 times but faces a threat from teenage phenomenon Carlos Alcaraz.

The 35-year-old, who had reached at least the quarter-finals every year in Rome since 2008, had been out for six weeks with a rib injury before returning for last week's tournament in Madrid.

Nadal began limping in the third set, later telling reporters that a foot problem had flared up during the second set but couldn't say whether he would be able to take part at Roland Garros. "I'm not injured, I am a player living with an injury. That's it," Nadal told reporters.

"It's something that is there unfortunately and my day by day is difficult. I am trying hard but of course it is difficult for me. A lot of days I can't practice.

"I don't want to take anything away from Denis... today is for him so well done to him." Nadal has won an all-time record 21 Grand Slam titles in a glittering two-decade career which may now finally be reaching its downturn.

World number 16 Shapovalov, who had pushed Nadal all the way when knocked out at this stage of the tournament last year, will now face Casper Ruud in the quarter-finals.

"It definitely sucked to see him in pain at the end... He brings so much to our sport so hopefully he's fit and ready to go for the French," said Shapovalov.

"It's super satisfying to beat the best player on clay of all time."

Last year's Rome runner-up Novak Djokovic swept past Swiss veteran Stan Wawrinka

week as the world number one and must reach at least the semis to avoid losing his

Wawrinka, whose first-round victory over Reilly Opelka was his first win in Djokovic and beyond a few classic passing shots he offered little resistance.

"It's great to see Stan back... You can see that physically he's still not there where he wants to be but nevertheless he's Stan Wawrinka. He can hurt you if you give time," Djokovic said after the match.

World number three Alexander Zverev saw off Alex de Minaur 6-3, 7-6 (7/5) in the early match on center court to set up a last-eight clash with Cristian Garin, who beat Marin Cilic

Monte Carlo Masters champion Stefanos Tsitsipas was forced to work harder for his 4-6, 6-0, 6-3 win over former Paris Masters winner Karen Khachanov which sets him up with home hope Jannick Sinner.

Women's world number one Iga Swiatek claimed her 25th straight victory, defeating Victoria Azarenka 6-4, 6-1 despite a rocky start.

Swiatek, 20, is the favourite for the French Open which starts later this month and showed why in an impressive performance against Azarenka, herself a former top-ranked player and the two-time Australian Open winner.

However she had to come back from losing the first three games of the match and then battled through a series of long games before finally breaking Azarenka's resolve early in the decisive second set.

"I'm happy that I could kind of win ugly in the first set, then improve in the second," Swiatek told reporters.

"It gives me confidence that even when my game is not hundred percent good, I can still win matches. So it works both ways."

BERLIN (Dispatches) - Robert Lewandowski has opened the door to a high-profile transfer after telling Bayern Munich that he will not be extending his contract beyond June 2023 when it expires, German media reported

The 33-year-old Poland international forward has scored 343 goals for Bayern and twice picked up FIFA's Player of the Year Award since joining from Dortmund in 2014.

"Goal machine Robert Lewandowski will leave the club no later than the summer of 2023," claimed the daily

"In recent weeks, FIFA's 2021 Player of the Year told his bosses at Bayern that he would not extend his contract, which is still valid for one year."

The Sport1 site, citing its own sources, confirmed this information.

Until now, Bayern has maintained they would not part with Lewandowski but, as the German media points out, not selling him now would mean the Pole would leave for free next summer.

According to several reports, Lewandowski has recently been in contact with Barcelona.

Barcelona coach Xavi, however, felt that this transfer would be "complicated" because of the club's financial situation.

### Nike Ends **Sponsorship Deal** With Spartak Moscow

MOSCOW (Dispatches) - Nike has terminated its sponsorship deal with Russian Premier League club Spartak Moscow because they will not be taking part in European competitions next season, the company and the club said.

UEFA, the governing body of European soccer, decided Russia would have no affiliated teams participating in its club competitions in the 2022-23 season due to Moscow's military campaign in Ukraine.

Spartak, who had been sponsored by Nike since 2005, said on Thursdaythey were looking for a new equipment supplier after Nike told them it would no longer be sponsoring the club.

In an emailed statement to Reuters on Friday, Nike said it had informed Spartak that it would no longer be the club's kit sponsor "given UEFA's decision to suspend all Russian clubs from UEFA competition."

The Europa League last-16 matches between Spartak and RB Leipzig were called off in February after UEFA suspended all Russian clubs from its competitions.

Russia sent tens of thousands of troops into Ukraine on Feb. 24 in what it called a special operation to degrade its southern neighbor's military capabilities and root out people it called dangerous nationalists.


The West has imposed sweeping sanctions on Russia and provided Ukraine with military support in response.

Cups over a 10-year period at City. The statue, created by sculptor Andy Scott, joins those of Aguero's former team


mates Vincent Kompany and David Silva that were unveiled at the Etihad



Son, having already been booked for wrestling the South Korean earlier. "I have two options I can lie to you, or I can be suspended, and I really want to be on the touchline against Newcastle," Arteta told reporters when asked about the first-half decisions that left his side in disarray.

"If I say what I think I'm suspended six months. I'm allowed to give my interpretation of what happened but I don't know how to lie. Ask the referee to come in front of the camera to explain his decision. It's a shame because such a beautiful game was destroyed today.'

Despite the defeat, Arsenal remain in pole position in the race with Tottenham for fourth place and qualification for next year's Champions League. With two games remaining they have one more point than their arch-rivals. "This game is history. Now it's Newcastle. This is gone. It went out of our hands and we have to accept it," Arteta said.
