## Armenia Calls for EAEU-Iran Free Trade Accord

TEHRAN (IRNA)-Armenia's Prime minister Nikol Pashinyan has underscored that Yerevan is keen on finalization of an all-out free trade agreement between the Eurasian Economic Union (EAEU) and the Islamic Republic of Iran.

According to news.am, Pashinyan made the remarks in a meeting of the Supreme Eurasian Economic Council, noting that the bloc attaches importance to utilizing mechanisms in order to minimize challenges and menaces of unprecedented economic crises, which happened in recent months.

"t is advisable to think about the development of pilot projects and joint events aimed at expanding and deepening trade and economic relations and building up cooperation," the Armenian premier stated.

"I consider it important to draw attention to Armenia's interest in concluding a full-fledged free trade agreement between Iran and the EAEU. The experience of the functioning of the interim agreement with Tehran clearly shows the attractiveness of the Iranian market and the prospects for further deepening cooperation... We also want to start negotiations on concluding an agreement between the Union and Indonesia."

### IRGC Seizes 2 Greek Oil Tankers in PG Over Violations

TEHRAN (PressTV) - Iran's Islamic Revolution Guards Corps (IRGC) on Friday seized two Greek oil tankers in the Persian Gulf over violations, days after an Iranian oil tanker was captured by Greece in its territorial waters followed by transfer of the oil to the US.

"The IRGC Navy today seized two Greek oil tankers for violations they have carried in the azure waters of the Persian Gulf," the IRGC said in a statement.

Earlier in the day, Iran's Nour News reported that the country was going to take "punitive action" against Greece over the tanker's seizure.

Nour News, which is affiliated with the country's Supreme National Security Council (SNSC), made the announcement without explaining what kind of action the Islamic Republic intended to take.

Iran's Ports and Maritime Organization (PMO) issued a statement on Wednesday, describing the US seizure of the Iranian oil cargo from a Russian-operated ship in Greece's territorial waters as an "act of piracy" that was "in violation of international standards".

# Iran Army Unveils Two New Drone Achievements

TEHRAN - The Islamic Republic of Iran Army unveiled two new drone achievements during the visit of the Chief of Staff of the Iranian Armed Forces Major General Mohammad Bagheri to an army-owned UAV secret base.

Major General Mohammad Bagheri visited an army-owned UAV secret base on Saturday. During his visit, the 'Heidar-1' cruise missile and 'Heidar-2' cruise UAV were unveiled by the Army of the Islamic Republic of Iran.

According to the announced information, the 'Heidar-1' cruise missile has a range of 200 kilometers and its speed at the moment of hitting the target is 1,000 km/h. It is the first cruise missile capable of firing from a drone. By setting up such a secret base designed and constructed hundreds of meters deep in the ground, the Islamic Republic has turned into the drone superpower in the region.

As the secret base which was designed and built at a depth of hundreds of meters has been operationalized, the Islamic Republic of Iran has become the superior drone power in the region.

After visiting the army-owned UAV secret base, General Bagheri emphasized the importance of UAVs in modern warfare.

He also appreciated Iran's Army Commander Major General Seyyed Abdolrahim Mousavi, saying that one of the concerns of all the country's commanders in Army Air Defense, Air Force and Navy is how to be prepared for possible future battles.

Iran is one of the top countries in the world in the field of UAVs, he said, adding that the Army is rapidly developing drone power and capability.

Stating that the achievements in the UAV field are completely indigenous and have been achieved with the efforts of young scientists amid sanctions imposed on the country, he said that the missiles with high accuracy and with a range of up to 2,000 kilometers are stationed in underground bases.

#### Certain Regional, Extra-Regional Countries Transferring Terrorists to Afghanistan

TEHRAN (PressTV)- The secretary of Iran's Supreme National Security Council (SNSC) says certain countries in the region and beyond are transferring Takfiri terrorists to Afghanistan.

Speaking at the fourth meeting of the Regional Security Dialogue in Tajikistan's capital of Dushanbe on Friday, Ali Shamkhani said terrorism and extremism are among the main causes of insecurity in Afghanistan. "Unfortunately, we have alarming evidence of the presence and involvement of some regional and extra-regional countries in the transfer of terrorists to Afghanistan."

Shamkhani urged regional countries to focus on efforts that would boost security and put joint deterrent measures on the agenda to prevent insecurity and instability. Iran's top security official emphasized that all countries and Afghanistan's acting Taliban government must fulfill their responsibilities in this regard. Shamkhani pointed to the regional circumstances, not least in Afghanistan over the years and the disgraceful defeat of the United States there, and said Washington must not only release the frozen assets of the Afghan

people, but also compensate for the damage it has caused in the war-ravaged country.

He pointed the finger at the United States, saying Washington and its "wrong expansionist" policies are at fault for the "two catastrophes of the 20-year war in Afghanistan and the war in Ukraine."

Referring to Iran's efforts to boost security in its neighboring country, the SNSC secretary said, "The Islamic Republic of Iran has always called for the establishment of security, peace, and stability in Afghanistan and deems it necessary for the development and welfare of Afghans and other nations in the region."

He said Iran has been hosting about five million Afghans in recent years, and this issue has created a host of issues for the country due to the absence of effective international aid and the existence of cruel sanctions.

The SNSC secretary said discrimination and deprivation of rights in various fields are among the main factors that allow terrorist groups to abuse the situation in Afghanistan. The establishment of a broad-based government in Afghanistan, he said, would promote stability.

Shamkhani also underscored the importance of adopting proper ways to solve Afghanistan's problems, particularly in the economic sector, saying, "if we want to limit grounds for the US interference in Afghanistan." In a meeting with his Russian counterpart Nikolai Patrushev earlier in the day, Iran's top security official voiced concern over the unfolding developments in Afghanistan and the emergence of various terrorist groups in the country.

## U.S., Leader of New Age of Piracy

In the 1600s and 1700s, the world shipping transportation had been affected by a phenomenon dubbed "piracy" that the British were the pioneers in this criminal industry and through the time and with development of the countries and maturations of the nations, this business gradually faded away but it seems the business is resurging again and this time the U.S. is becoming the pioneer in this business but in different styles.

In the media and among the reports we had read or heard about Somalia pirates but it seems they are nothing comparing to their big bosses the Americans but the Americans commit piracy in a civilized way and under the label of confiscating the illegal transportation or deal.

On Thursday once again media outlets revealed another act of piracy by the U.S. but the country did it through its ally Greece. According to the report, the United States government confiscated an Iranian oil cargo held near Greece for nearly a month one day after Iranian authorities protested against Athens' decision to hand over the cargo to American authorities.

The Thursday report by Reuters cited statements by unnamed source showing that the U.S. Department of Justice had confiscated 700,000 barrels of Iranian oil cargo seized last month off the southern Greek island of Evia onboard a Russian-operated ship.

A Greek source said that the oil cargo had been transferred to another ship hired by Washington and will be send to the U.S.

The source said the U.S. Department of Justice had "informed Greece that the cargo on the vessel is Iranian oil". Another source confirmed the American seizure and said that the Iranian oil cargo is currently being transferred to the Liberia-flagged tanker Ice Energy, which is operated by Greek shipping company Dynacom.

The confiscation comes a day after Iranian Foreign Ministry summoned charge d'affaires of Greece's embassy in Tehran to declare its strong objections to the seizure of an Iranian-flagged ship in Greek waters.

The ship, previously Russian-flagged, had been sailing in international waters before it was forced to anchor near Greece over technical problems.

Iranian authorities have said they will hold the Greek government responsible for the confiscation.

It is the second time the U.S. confiscates Iranian oil outside its territorial waters on trumped-up charges brought by American courts. In 2020, four cargoes of Iranian oil bound for Venezuela were seized by the US with the help of foreign agents. The cargoes were then sold for more than \$40 million, according to reports.

#### Russia Supports Expansion of Cooperation Between Iran, EAEU

MOSCOW (Dispatches) - Russian President Vladimir Putin says his country supports the initiative to extend an interim free trade agreement between the Eurasian Economic Union (EAEU) and Iran despite the "confrontation" by the "collective West."

Negotiations are proactively underway on a full-fledged free trade agreement between the EAEU and Iran to replace the current temporary pact of 2018, the Russian president, who is also one of the heads of the EAEU, said.

Putin made the remarks at a plenary session held during the First Eurasian Economic Forum which opened in Bishkek, Kyrgyzstan, on Thursday. The heads of the EAEU states participated in the forum via videoconferencing.

Putin said the EAEU-Iran trade turnover increased by 73.5 percent to \$5 billion in 2021 due to the current agreement.

"Despite the confrontation unleashed by the so-called collective West, it is quite obvious to all of us that many foreign partners have shown growing interest in the activities of the EAEU," he said.

### Venezuela Calls for Iran's Know-How to Make Vaccine

TEHRAN (MNA)- The Iranian Health Minister Bahram Einollahi said on Saturday that Venezuela called for Iran's know-how to make vaccines.

Einollahi met and held talks with Venezuela's deputy health minister here on Saturday.

#### Gov't Targets \$1b of Annual Fishery Exports for 2025

Organization (IFO) Hossein Hosseini has said the country is aiming to increase the exports of fishery products to one billion dollars by the Iranian calendar year 1404 (begins on March 21, 2025), IRIB reported.

Hosseini said the country's fishery production in the previous Iranian calendar year (ended on March 20) stood at 1,268,000 tons, and according to the IFO's new reform plan, fishery production is set to increase to 2,600,000 tons by the year 1404.

According to the official, Iran exported 160,000 tons of fishery products worth \$556 million last year.

Following the IFO's reform plan, the organization is implementing a program to provide the country's fisheries with low-interest bank loans since subsidized input is no longer provided for them.

According to the director-general of IFO's Planning

Agriculture Ministry is collaborating with IFO for providing working capital at a rate of 10 to 12 percent to the country's livestock, poultry, and aquaculture production units.

The IFO head has held several meetings with the representatives of the Agriculture Ministry after which primary agreements have been reached for the allocation of the mentioned resources.

Hopefully, the allocation of the mentioned facilities will begin in the next few days after Agriculture Ministry finalizes the directive in this regard,



#### Gov't May Lift Ban on Import of Several Commodities

TEHRAN (Tasnim) - Iran is reviewing the plan to eliminate the import ban on four or five commodities, said the Minister of Industries, Mine and Trade Reza Fatemi.

He pointed out possible reforms in the import ban policy for goods that have similar domestic equivalents, however, the main structure of the 2018 import ban will remain on 2.000 luxury goods.

The minister has stressed that the administration will not ban the import of basic materials and machinery.

## No Problem With Oil Debt Collection

SHANA (Tehran) – The managing director of the National Iranian Oil Company (NIOC) here on Friday said there is no problem regarding oil debt collection.

Mohsen Khojastehmehr added with absolute certainty that the 13th administration is exporting more oil when compared to the previous government and seriously following up and managing the issues related to exports.

Asked about the views of some critics who argue the conflict between Russia and Ukraine and Moscow's decision to sell oil cheaper would cast a shadow over Iran's presence in its traditional markets and result in a reduction in the country's exports, the NIOC CEO responded, "The country is exporting its oil like the past, and in the meantime the oil market has always its own rules and regulations."

Responding to a question whether the 40 percent hike in oil exports announced by Seyyed Ebrahim Raisi during his presidency and confirmed by the Central Bank of Iran (CBI) and Ministry of Economic Affairs and Finance was due to selling it to the traditional customers or finding new buyers, Khojastehmehr said the country has sold its oil to new customers at new destinations and also managed to revitalize some parts of its traditional markets.

He praised the industrious staff of the National Iranian Oil Company for their great efforts and contribution to the increase in the country's exports.

Shifting to investment in Iran's oil industry, he said the production of 5.7 million barrels per day is a real possibility and based on the oil reservoirs' extraction capacities.

To that end, the oil sector needs to invest \$90 billion, and the country will first utilize its own financial resources,

the NIOC chief noted but did not rule out the investment of foreign companies in the development projects.

Khojastehmehr touched upon the sanctions imposed on Iran and continued, "If we apply all domestic capacities

to neutralize the sanctions, the country will not be shaken, and this is exactly the resistance economy."

In response to a question posed about Iranian companies' technical know-how needed for participation in other countries' giant oil projects, he said nobody believed in 2011 – during the 10th administration's term – that domestic companies could develop the phases of the South Pars field, but a contract worth around \$22 billion was

signed on the development of 10 SP phases with Iranian companies and it worked.

Iranian companies have gained invaluable experiences and can implement international projects, he assured.

Khojastehmehr said Iran has signed contracts and memorandums of understanding on the participation of domestic companies in international projects.

The country's private sector has also carried out some measures for exporting technical and engineering services, explained the NIOC CEO, adding his company is also ready to export these services.

According to him, the NIOC is planning to modify the process of offering crude oil at the Iran Energy Exchange (IRENEX).

The NIOC has made a proposal that is under study, Khojastehmehr mentioned, adding the new model consists of bonds for commodity deposit certificates.

### Official Hails Knowledge-Based Produced Medical Equipment

TEHRAN (IP) - Vice President for Science and Technology stressed the exhibition of the capabilities of the domestic knowledge-based companies active in medicine.

The 23rd edition of Iran's international exhibition is underway at Tehran International Permanent Fairground to display medical and dental equipment, pharmaceutical products, machinery, laboratory equipment, food supplements, hospital equipment, consumer products, vitamins, and herbal drugs.

On the sidelines of the exhibition, Sorena Sattari told Iran Press in an interview on Thursday: "High-quality medical equipment are produced domestically and are exported to numerous countries, that is indicative of the health system in the private sector's creative knowledge-based companies."

Sattari hailed the presence of the knowledge-based companies in the exhibition and expressed hope that the advancements continue and a good knowledge-based ecosystem would be formed across the country.

### Iran Becomes World 19th Largest Automaker

TEHRAN (IRNA) - Iran manufactured nearly 900,000 cars in 2021, making the country the world's 19th

Statistics released by International Organization of Motor Vehicle Manufacturers (OICA) shows that the global auto production has increased to 80,145,000 cars in 2021, showing a 3% growth compared to the year before.

Iran's production, according to the figures, has grown 2%, producing a total of 894,298 in 2021. OICA's figures indicate that Iran has been the world's 19th largest automaker. China was by far the largest automaker, with over 26 millions of cars produced by the country in 2021.

# Ministry of Communications Cooperates With Army on Technology Sector

TEHRAN (IP) - A comprehensive memorandum of understanding was signed between the Army of the Islamic Republic of Iran and the Ministry of Information and Communications Technology.

Referring to the cruel sanctions of the enemies against Iran, Major General Seyed Abdolrahim Mousavi, the Commander-in-Chief of the Army, said at the signing ceremony: "The sanctions are mostly aimed at the Armed Forces and what you see today is a small percentage of our defense capabilities and all these achievements."

General Mousavi added: "The enemies have invested a lot in the field of information technology, and naturally we must work and plan in such a way that we are not behind them, but move one step ahead of the enemy, and this level of cooperation and cooperation that occurs between organizations is He is blessed and will surely help us.

In the ceremony, Issa Zarepour, the Minister of Information and Communications Technology of Iran, referring to the areas of cooperation between the Ministry and the Army of the Islamic Republic, said: "The two sides have one thing in common, and that is that the glorious army of the Islamic Republic defends the country's physical borders, and we are the borders of the country's cyberspace.

The Minister of Information and Communications Technology added: "Bordering cyberspace is not an easy task because now foreign platforms or platforms have entered the country, crossing the borders of our cyberspace (and the whole world).

## NICICO Sees 8% Growth In Copper Cathode, Anode Production






The state-run Korean Central News Agency (KCNA) said "progress" has been made in diagnosing and treating patients thanks to "the devoted efforts" of medical workers.



### **U.S. OKs Potential Sale of Chinook Helicopters to Egypt**

WASHINGTON (Dispatches) - The U.S. State Department has approved the potential sale of CH-47F Chinook helicopters and related equipment to Egypt, the Pentagon announced on Thursday, explaining that the possible sale will strengthen Egypt's homeland defence and deter regional threats.



Boeing Helicopter Co. will be the principal contractor.

The DSCA said it delivered today the required certification notifying the US Congress of this possible sale to give its approval.

## **Russians Claim Control of Key Town in East Ukraine**



KYIV (Dispatches) - Russia's separatist proxies in eastern Ukraine claimed full control of the important battlefield town of Lyman, and Ukraine appeared to concede it, as Moscow presses its biggest advance for weeks.

Lyman, site of a major railway hub, has been a front line target as Russian forces press down from the north, one of three directions from which they have been attacking Ukraine's industrial Donbas region. The pro-Russian Donetsk People's Republic separatists said they were now in full control of it.

Oleksiy Arestovych, adviser to Ukrainian President Volodymyr Zelenskiy, appeared to confirm the fall of Lyman in an interview posted on social media overnight, and said the battle there showed that Moscow was improving its tactics. "According to unverified data, we lost the town of Lyman," Arestovych said in the video, adding that the attack had been well organised. "This shows, in principle, the increased level of operational management and tactical skills of the Russian army," he said.

The Ukrainian governor of the Donetsk region, Pavlo Kyrylenko, told media outlet Hromadske that Lyman was "mainly controlled by Russian troops'

but the Ukrainian military had taken up new fortified positions in the area.

After being driven back from the capital Kyiv in March and from the outskirts of the second biggest city Kharkiv earlier this month, Russian forces are staging their strongest advance in weeks in the eastern Donbas region.

Western military analysts say success could set the stage for a protracted conflict.

In the easternmost part of the Ukrainian-held pocket, Russian forces are trying to encircle Ukrainian troops in the cities of Sievierodonetsk and Lyshchansk, after breaking through Ukrainian lines further south in the city of Popasna last week.

Popasna, reached by Reuters journalists in Russian-held territory on Thursday, was a blasted wasteland of burnt-out highrise apartments and shattered municipal buildings. Russian tanks and other military vehicles tore through the rubblestrewn streets kicking up dust with their treads, and low-flying attack helicopters thundered overhead. The bloated body of a dead man in combat uniform lay in a courtyard.

Natalia Kovalenko had finally come up in recent days from the cellar where she had been sheltering, to sleep amid the wreckage of her own flat. The balcony had been blown away and windows blasted off by a direct hit from a shell.

Russian ground forces have now captured several villages northwest of Popasna, Britian's Ministry of Defence said.

Russia's advance in the east follows a Ukrainian counter-offensive that pushed Russian forces back from Kharkiv this month. But Moscow has prevented Ukrainian forces from attacking the rear of Russian supply lines to the Donbas.

Brazil Invites Election Observers on Record Scale

BRASILIA (Dispatches) - Brazil is preparing to receive a record number of international observers for its October election, according to electoral authorities and participating organizations, amid a polarized presidential race in which President Jair Bolsonaro has questioned the reliability of electronic voting machines.

Bolsonaro's government objected to an invitation last month extended by Brazilian electoral authorities to the European Union to send observers for the first time, sinking that proposal.

But the parliament of South American trade bloc Mercosur, known as Parlasur, will send a formal observer mission for the first time, as will the U.S.based Carter Center and the International Foundation for Electoral Systems (IFES).

The 34-nation Organization of American States also will send more observers than it did in 2018, when Bolsonaro was elected.

"We don't know the size of the mission vet, that will depend on the money available, but we intend to make it bigger," said a source at the hemispheric forum in Washington, requesting anonymity to comment on preliminary discussions. "In 2018, there were 40 observers and we want to exceed that number."

Bolsonaro, a far-right populist, gave vocal support to former U.S. president Donald Trump's baseless allegations of fraud in the 2020 election. He has raised similar doubts about Brazil's electronic voting system, calling it liable to fraud, without providing evidence.

Those allegations, along with Bolsonaro's criticism of the electoral authorities who defend Brazil's voting systems, have raised concerns he might not accept defeat by his leftist rival Luiz Inacio Lula da Silva, who is leading in opinion polls.

"For this reason we are inviting, in an unprecedented way, all international organizations and specialized centers to act as observers of our election," Edson Fachin, head of Brazil's Superior Electoral Court (1SE) said last week.

"We are aiming for more than 100 international observers during the electoral process," said Fachin, one of a rotating set of Supreme Court justices running the TSE this year.

Parlasur was invited by the TSE to send representatives for the 2018 election as foreign guests. This year, it will send an official election observation mission for the first time, according to the mission's director Alexandre Andreatta.



## Beijing Says Blinken Speech "Smears China"



BEIJING (Dispatches) - China's foreign ministry on Friday accused US Secretary of State Antony Blinken of "smearing" the country, after America's top diplomat delivered a landmark policy speech calling for action to counterbalance Beijing's influence.

In the most comprehensive statement to date on China by US President Joe Biden's administration, Blinken said on Thursday the Asian power posed "the most serious long-term challenge to the international order".

China has faced a chorus of warnings from the United States and Western allies in recent days over its growing

influence and global ambitions. Blinken warned of China's "intent to reshape the international order" and called on countries to defend the status quo.

#### U.S. Targets N.Korea Missiles With Sanctions on Russian Banks

WASHINGTON (Dispatches) - The United States imposed fresh sanctions over North Korea's missile launches, including on two Russian banks, after Russia and China blocked action by the UN Security Council.

The Treasury Department said it was freezing any U.S. assets and criminalizing transactions with the Far Eastern Bank and Bank Sputnik, Russian institutions accused of working with North Korea.

It also targeted Jong Yong Nam, alleged to be working out of Moscow-allied Belarus for North Korea's weapons research body, and a trading company affiliated with state carrier Air Koryo, which is already under sanctions.

Senior Treasury official Brian Nelson said the banks were targeted as they 'knowingly provided significant financial services" to the North, formally known as the Democratic People's Republic of Korea.

"The United States will continue to implement and enforce existing sanctions while urging the DPRK to return to a diplomatic path and abandon its pursuit of weapons of mass destruction and ballistic missiles," he said in a statement.

The United States and South Korea have said that North Korea tested three ockets, including an intercontinental ballistic missile, on Wednesday and that it could be preparing its first nuclear test since 2017.

The United States on Thursday forced a vote at the Security Council on toughening sanctions, saying that North Korea had brazenly violated a unanimous 2017 resolution that warned of consequences for further tests.

> But Russia, whose relations with the West have sharply deteriorated over the Ukraine war, and China vetoed the U.S.-drafted resolution, saying that sanctions would heighten tensions.

The U.S. ambassador to the United Nations, Linda Thomas-Greenfield, accused Beijing and Moscow of emboldening North Korea and said the United States would take unilateral measures against Pyongyang.

He also accused Beijing of raising tensions over Taiwan -a self-ruled island China claims as its territory -- and said Beijing has "cut off Taiwan's relations with countries around the world and (is) blocking it from participating in international organizations".

Beijing hit out angrily at the speech on Friday, saying it "spreads false information, exaggerates the China threat, interferes in China's internal affairs and smears China's domestic and foreign policies".

Foreign ministry spokesman Wang Wenbin told reporters that China "firmly opposed" the speech and it showed Washington sought to "contain and suppress China's development and maintain US hegemony and power".

The United State recently launched a loose new trade framework across Asia and has set up a forum with the European Union to set technological standards.

The efforts are aimed at uniting like-minded nations as China dominates new fields, such as artificial intelligence.

Blinken acknowledged a growing consensus that other nations cannot change the trajectory of China, saying that under President Xi Jinping it has become "more repressive at home, more aggressive abroad".

### Turkey Seeks Concrete Action From Sweden, Finland for NATO Bids



ISTANBUL (Dispatches) - Turkey expects Sweden and Finland to take concrete action and halt what it says is their support for terrorist groups in order for Ankara to lift its objections to them joining NATO, Foreign Minister Mevlut Cavusoglu said.

Finland and Sweden formally applied to join NATO last week, seeking to boost security following Russia's invasion of Ukraine. They hoped it would be a quick accession process and other NATO members touted the planned enlargement as historic.

However, Turkey challenged the move saying they harbour people linked to the Kurdistan Workers Party (PKK) militant group and followers of Fethullah Gulen, whom Ankara accuses of orchestrating a 2016 coup attempt.

All 30 NATO states must give their approval before a new member can be admitted and thus benefit from the pact's collective-security guarantee. "A concrete step needs to be taken regarding Turkey's concerns," Cavusoglu told reporters at a news conference. "They have to cut the support given to terrorism."

Delegations from the two countries visited Ankara for talks with Turkish officials on Wednesday

President Tayyip Erdogan's spokesman later said Ankara had observed a positive attitude on lifting an arms exports embargo. Swedish Foreign Minister Ann Linde said on Twitter afterward that the dialogue was constructive and would continue.

Sweden and Finland banned arms exports to Turkey after an incursion into Syria against the Kurdish YPG militia. Ankara regards the YPG as identical to the PKK and views both groups as terrorist organisations.

### UK Imposes 25% Energy Windfall Tax

LONDON (Dispatches) - Britain announced a 25% windfall tax on oil and gas producers' profits, alongside a 15 billion pound (\$18.9 billion) package of support for households struggling to meet

The move, which will give each UK household a 400 pound discount on their energy bill and more for lowest-income households, marks a change of heart for Prime Minister Boris Johnson's government, which had previously resisted windfall taxes, calling them a deterrent to investment.

It is the second emergency policy intervention to help with rising bills this year.





### hina Premier Issues Warning On Covid-Hit Economy

BEIJING (Dispatches) - China's premier has sounded an unusually stark warning about the world's second-largest economy, saying it must return to normal as the country's zero-Covid strategy bites into growth.

China is the last major economy welded to a policy of mass testing and hard lockdowns to eliminate virus clusters, but the strict curbs have battered businesses.

Restrictions around the nation in recent months -- including on the manufacturing hubs of Shenzhen and Shanghai as well as the breadbasket province of Jilin -- have tangled supply chains and dragged economic indicators to their lowest levels in around two years. In some ways, the challenges now are "greater than when the pandemic hit hard in 2020", Premier Li Keqiang told a State Council meeting on

Wednesday, according to a readout by the official Xinhua news agency. "We are currently at a critical juncture in determining the economic trend of the whole year," Xinhua quoted Li as saying. "We must seize the time window and strive to bring the

economy back onto a normal track." Li also said officials ought to make sure there is "reasonable" growth in the second quarter, fuelling fears that the country's ambitious target for yearly expansion of around 5.5 percent may not be met.

His remarks are the latest in a growing chorus of calls from officials and business leaders for more balance between stopping the virus and helping the ailing economy.

On Monday, the central bank and banking regulator urged financial institutions to boost lending, citing pressure on the economy, Chinese media reported.

This came as retail sales plunged 11.1 percent on-year in April while factory output sank 2.9 percent -- the worst showing since the early days of the Covid crisis. And the urban unemployment rate edged back towards its February 2020 peak.

In March and particularly in April, indicators including employment, industrial production, electricity consumption

and freight dropped "significantly", Li said at the Wednesday State Council meeting. He stressed the importance of coordinating virus control and economic development, according to Xinhua.

On Thursday, the State Council will also send teams to 12 provinces to oversee local work in implementing state policies, the report said.

China's current virus outbreak -- fuelled by the highly transmissible Omicron variant -- is the worst since the early days of the pandemic in 2020. Its biggest city and business hub Shanghai has been almost entirely sealed off since April, crushing businesses, while curbs are creeping in across the capital Beijing with no clear end in sight.

The government has offered tax relief and a bond drive to help industries, and President Xi Jinping earlier called for an "all-out" infrastructure push. But analysts have cautioned that growth will keep wilting until China eases its rigid virus controls.

S&P Global Ratings this month lowered its full-year growth forecast for China from 4.9 percent to 4.2 percent due to Covid curbs.

Western nations, grappling with record inflation rates that are threatening economic growth, have repeatedly asked the group to accelerate its output hikes.

Under a deal reached in July last year, the Organization of the Petroleum Exporting Countries and allies ed by Russia, have been easing record production cuts by increments of about 400,000 bpd every month. The cuts are set to be fully unwound by the end of September but the group's oil output has been falling sharply n reality as sanctions and buyer reluctance hit Russian output, and Nigeria and Angola pump well below target. BERLIN (Dispatches) - German home prices will rise faster this year than thought only three months ago, as a supply shortage outweighs a deepening cost of living crisis and the prospect of higher interest rates, a Reuters poll found.

However, the resulting squeeze on disposable incomes is expected to keep property price rises in the next two years in check.

13 analysts polled May 11-25, with the pace seen slowing to 3.0% in 2023 and 2.0% in 2024. In a March poll those respective forecasts were 6.3%, 4.5% and 2.8%.

"House prices will continue to rise, albeit at a slower pace, as higher interest rates, the surge in prices over the last years and lower disposable income are undermining affordability," said Carsten Brzeski at ING.

The European Central Bank is expected to raise its rates for the first time in over a decade in July and on Tuesday ECB President Christine Lagarde implied a lift of at least 50 basis points by end-September.

Like much of the world, Germany has seen runaway prices with inflation hitting its highest in more than four decades in April, driven by soaring fuel and energy costs in the wake of Russia's invasion of Ukraine.

Out of 13 respondents who answered additional questions about affordability, all expected conditions to worsen both for first time home buyers and for the rental market.

Of those 13, ten saw significantly worsening affordability for first-time home buyers and four for renters.

"It's the worst of all worlds: Still-rising house prices, rapidly-increasing interest rates, building delays due to scarce skilled labour. reduced purchasing power owing to high inflation," said Timo Klein at S&P Global.

Klein said he also expected rents to go up driven by reduced building activity, landlords trying to keep ahead of inflation and additional demand from Ukrainian refugees.

Asked how high the ECB's deposit rate, currently -0.50%, would have to go to significantly cool housing market activity, the median response was 1.00%, a level not expected before 2024 according to another Reuters poll.

But one respondent, Marco Wagner, senior economist at Commerzbank, said 0.00%, a level forecast for end-September.

"Basically, each and every rate hike will do and contribute to a slowdown of the price increases," he said.

The latest central bank data also gave cause for concern, with net international reserves dropping to \$9.56 billion in the week to May 20, bringing their decline since mid-April to nearly \$10 billion.

KARACHI (Dispatches) - Pakistan and the IMF have worked out the outlines for the release of over \$900 million in funds that would come through once Pakistan removes its fuel subsidies, a Pakistani source directly involved in talks in Qatar said, requesting anonymity.

The talks in Qatar capital Doha on the resumption of a funding program concluded on Wednesday. An IMF official said in a statement that considerable progress had been made, but he emphasized the urgency of Pakistan removing fuel and energy subsidies to get back on track.

"When we raise fuel prices, the deal will be done. We have worked out the outlines of a deal," the source told Reuters in a text message after the end of the talks in Doha.

The IMF representative in Pakistan did not immediately respond to a Reuters request for comment. Pakistan entered a three-year, \$6 billion IMF deal in 2019, but about half of the funds are yet to be released.

A pending tranche of over \$900 million dollars is contingent on a successful IMF review. A successful review would also unlock other funding avenues for cash-strapped Pakistan, whose foreign reserves cover less than two months' worth of imports.

It was not clear when the review would take place. Pakistan's fuel price caps were introduced by ousted Prime Minister Imran Khan as he faced pressure to tame rising inflation. The IMF on Wednesday said the move was a deviation from policies agreed to in the 2019 funding deal. The new government, which took charge in April, has been reluctant to remove the fuel price caps. The source, however, said finance officials were confident they could convince Prime Minister Shehbaz Sharif to raise prices soon.

The Pakistan government convened a joint session of parliament on Thursday to discuss the economic situation after the talks, according to an order seen by Reuters. Pakistan's consumer price index rose 13.4% in April from a year earlier.

A removal of fuel subsidies would likely have political consequences for the new coalition government, with elections expected within 16 months.

### Russian Central Bank Slashes Key Rate

MOSCOW (Dispatches) - Russia's central bank slashed its key interest rate to 11% and said it saw room for more cuts this year, as inflation slows from more than 20-year highs and the economy heads towards a contraction.

It announced the move, which followed two previous 300 basis point cuts which took the rate to 14%, at an extraordinary meeting. The bank has been gradually reversing an emergency rate hike to 20% in late February that was triggered by Russia's Feb. 24 move to send tens of thousands of troops into Ukraine and the imposition of Western sanctions in response. Governor Elvira Nabiullina said inflationary risks were easing, but warned that the economy was entering a period of structural transformation and that banks needed additional capital support.

Inflation expectations of households and businesses are falling, she told a banking conference in Moscow, helping to significantly lower inflationary risks.

The rouble's recent appreciation to multi-year highs has had a significant, if temporary, disinflationary impact, she said. The Russian currency has been supported this year by capital controls imposed in late February to cap financial stability risks and defend the economy against sweeping western sanctions.

"Thanks to these factors, inflation is falling faster than we expected," Nabiullina said. "This allows us to lower the key rate today without creating new pro-inflationary risks."

"We allow for the possibility of further easing of the key rate at upcoming meetings."

The central bank said external conditions for the Russian economy are still challenging but financial stability risks have somewhat decreased, opening room for easing of some capital control measures.

"The first months (since February) were a time for tactical decisions: we had to counteract the first sanctions shock," Nabiullina said. "We managed to protect financial stability and not allow an inflation spiral to unfold. "But this, of course, absolutely does not mean that we can breathe easily."



The rouble's performance has "given policymakers room to reverse emergency measures introduced since February", Capital Economics analysts said in a note.

"We suspect that the CBR won't continue this pace of easing ... A further easing of capital controls and additional rate cuts seem likely." they said.

The rouble extended intraday losses as Nabiullina spoke, sliding to 63.41 against the dollar, down 6.9% on the day.

The central bank could cut its key rate further by 50-100 basis points at the next rate-setting meeting scheduled for June 10, said Dmitry Polevoy, head of investment at LockoInvest.

### Iran to Resume Hajj Flights

TEHRAN (IFP) - Iran Air will begin Hajj flights on June 12 to take Iranian pilgrims to Saudi Arabia after a two-year hiatus, an official with the airline announced.

The head of the airline's public relations office, Hossein Jahani, said, "Iran Air will take about 40,000 pilgrims in 158 flights to Jeddah and Medina airports, in Saudi Arabi8a, for this year's pilgrimage."

Saudi Arabia lifted this year some of the coronavirus-related restrictions on the Hajj after two years.

The Saudi Ministry of Hajj and Umrah announced in a statement last month it would permit one million Muslims from inside and outside the country to participate in this year's hajj, a sharp uptick after the massively downsized pilgrimage for the past two years.



### **Turkey Starts Search for Astronaut for Its First Human Space Mission**

ANKARA (Dispatches) - Turkey has started a search for a citizen that will be sent on a scientific mission in space, as part of the nation's ambitious space program.

Applications opened as of late Monday, as part of which one candidate will be selected and become the first Turkish citizen to go to the International Space Station (ISS).

"As part of the national space program, Turkey is officially starting the process of sending our citizen to the International Space Station," President Recep Tayyip Erdoğan said Monday after a Cabinet meeting.

The Turkish astronaut should be ready by the end of the year and is expected to embark on the journey as early as the first half of 2023.

The candidate will conduct scientific experiments during their 10-day stay at the International Space Station, the Industry and Technology Ministry said in a statement.

"There is no doubt that this will be a national duty. Our citizens, whom we will send to space, will have the opportunity to conduct scientific tests and experiments that he or she or other scientists in Turkey want to do in a gravity-free space environment," Erdoğan said.

According to the required qualifications, citizens who are under the age of 45, have a bachelor's degree in engineering, natural sciences or basic sciences and speak English very well can apply for the program at uzay.gov.tr. Applications will be accepted until June 23, 2022.

They should also be of height between 149.5 and 190.5 centimeters, weigh between 43 and 110 kilograms and have full vision acuity in both eyes naturally or after correction with glasses or contact lenses.

Candidates will be tested, examined and interviewed for their English language abilities. At the end of all these processes, the number of candidates will be narrowed to just two, one of which will get the opportunity to be the first Turkish citizen to go to the International Space Station.

The mission is a part of Turkey's ambitious 10-year space road map, unveiled a year ago, which also includes missions to the moon and developing internationally viable satellite systems.

First contact with the moon is planned to be achieved in 2023, the centennial of the founding of the Republic of Turkey. The program also envisages working with other countries on building a spaceport and creating a global brand in satellite technology.



The training of the citizen that will be selected for the scientific mission will last around four to six months, Turkish Space Agency (TUA) head Serdar Hüseyin Yıldırım said last month.

"We anticipate that the selection process will take about two to three months. By the end of the year, our astronaut will be ready and will go into space next year," Yıldırım said.

The TUA was established in 2018 with the aim of joining a handful of other countries with space programs.

Turkey plans to send a rover to the moon by the end of the decade using a domestically built rocket engine that will first fly to the moon in a test mission in 2023.

The rover, which is expected to be launched in 2028 or 2029, will land softly on the moon and collect scientific data on its surface.

The rocket that launches the moon rover will be domestically built, using a hybrid engine that is currently being developed in Turkey. To help make sure it's ready for the rover launch, a prototype of the rocket is expected to fly to the moon in late 2023.

The London-based think tank InfluenceMap analysed advertisements and declarations by the companies in the weeks before and after Russia's invasion of Ukraine on February 24.

It said the companies spread the misleading message that US climate change policies were to blame for rising energy prices and that more US-produced oil and gas was the solution.

As Western countries that import Russian hydrocarbons looked for alternatives in order to cut ties with Russia, InfluenceMap detected "an active effort from the US oil and gas industry to capitalise on the war in Ukraine".

They pushed "long-standing policy asks relating to the continued expansion of oil and gas," despite the widely-documented role such operations play in driving deadly global climate change, InfluenceMap said.

The group identified one of the key players in the messaging effort as the American Petroleum Institute, a lobbying organisation that has numerous major fossil fuel companies among its members.

InfluenceMap said it detected a surge in the number of ads about US-based energy and energy independence placed via one of the API's Facebook pages in the weeks before and after the Russian invasion.

One series of ads received nearly 20 million views on the social platform.

"The sector has quickly mobilised around the war in Ukraine and high gas prices to promote the need for more 'American-made energy', often relying on potentially misleading or questionable claims," InfluenceMap Program Manager Faye Holder said in the report.

It also analysed public statements by oil and gas executives, finding that several of them publicly blamed climate change policies or promoted US-produced energy as part of the solution to the energy crisis.

The report documented cases where it said the sector had succeeded in securing some of its demands since the invasion, such as a commitment by authorities to speed up approvals for new gas projects.

Many posts by users on social media have blamed a surge in gasoline and crude oil prices on US President Joe Biden's decisions to limit drilling and to halt the Keystone XL pipeline project as part of his low-carbon energy transition plan.

Biden's March 8, 2022 announcement of a ban on Russian oil imports did lead to a jump in prices.

But analysts told AFP in March that swings in energy prices in 2022 were due to a variety of factors, including a rebound in economic activity following the Covid-19 pandemic.

LONDON (Dispatches) - Having made it through the spring planting season, sometimes with the help of bulletproof vests and helmets, Ukraine's farmers are facing another challenge: finding enough diesel for the harvest to come.

The war with Russia cut fuel supplies just as farmers stepped up work for the spring season and they have lost about 85% of their normal supplies since the conflict started on Feb. 24, farmers, fuel distributors and analysts say. The total area planted with grain this spring is already expected to be up to 30% smaller than last year because of the fighting, and yields could drop too if farmers don't get fuel so they can apply chemicals and harvest crops at the right time. Ukraine was the world's fourth-largest grain exporter last season, shipping staples such as wheat and maize to Africa and

the Middle East, as well as supplying half of the grain procured by the U.N.'s World Food Program for emergency aid. With Ukraine's Black Sea ports blockaded, getting crops out is fast becoming a global issue and U.N. Secretary-General Antonio Guterres is attempting to broker a deal for grain shipments to resume – and calm world food markets. In the 2020/21 season ending in June last year, Ukraine exported 45 million tons of grain. It had been expected to ramp that up to 65 million after a record harvest late last year but the war has left some

21 million tons stranded in silos across territory it controls as the 2021/22 season comes to an end next month.

And while security has been the most pressing issue for farmers so far, with swathes of land cut off by Russian advances or damaged by shelling, fuel shortages are starting to bite as the next harvest looms.

"Fuel is the biggest problem at the moment, more than anything," said Kees Huizinga, a Dutch national who runs a 15,000 hectare dairy and crop farm in central Ukraine.

Ukrainian farmers use most of the 1.5 million tons of diesel they consume each year, or more than 10% of Ukraine's annual fuel demand, in the spring season, said Taras Panasiuk, commercial director of petrol station operator WOG.

Ukraine usually relies on Russia, Belarus and imports from elsewhere coming in by sea for most of its fuel. Last year, for example, more than 60% of its diesel came from Russia and Belarus, Ukrainian oil products consultancy A-95 estimates. Now, Ukraine has been forced to embark on costly and complex ways to bring in fuel via land from neighbors such as Poland and Romania, though a lack of capacity and red tape has slowed these efforts, the Ukrainian Oil and Gas Association said.

That task has become more daunting as countries nearby are facing their own diesel shortages, while Russian strikes on the Kremenchuk oil refinery and fuel depots have further squeezed supplies within Ukraine.

A shortage of tanker drivers is also hampering fuel deliveries as many have been enlisted to fight, analysts say. Roman Gorobets, director of FE Astra, which cultivates about 2,000 hectares in the central Poltava region, said

waiting times for diesel deliveries to farms were now two to four weeks.
"Things have worsened. We are facing severe fuel shortages all over the country," he said.

The government has announced contracts to import 300,000 tons of diesel and 120,000 tons of petrol to cover May, and the deputy chief of staff at Ukraine's presidency, Kyrylo Tymoshenko, said on Friday that 1,500 tons of fuel had reached a customs point in Lviv in the previous 24 hours.

Eight years after signing a contract to establish the Eurasian Economic Union, the treaty seems to be a promising and attractive association, he added.

As an economic union of post-Soviet countries in Eurasia region, the Treaty on the Eurasian Economic Union was inked on May 29, 2014 by the leaders from Belarus, Kazakhstan, and Russia. The treaty came into force on January 1, 2015.

Armenia and Kyrgyzstan joined the Eurasian Economic Union on October 9 and December 23, 2014 respectively. The EAEU has an integrated single market of 184 million people and a gross domestic product of over 5 trillion dollars.

Armenia, Belarus, Kazakhstan, Kyrgyzstan, and Russia are full members and Cuba, Moldova and Uzbekistan are observers in the Eurasian Economic Union.

Iran and EAEU reached a free trade agreement in October 2018 based on which about 862 commodity items were subjected to preferential tariffs.

Iran and the EAEU have listed 862 types of commodities in their three-year provisional trade agreement. As per the deal, Iran will enjoy easier export terms and lower customs duties on 502 items and the same goes for 360 items from the EAEU member countries.

The seizure also comes a day after the U.S. government announced sanctions targeting a Russian-backed oil network supporting Iran's anti-sanctions activities.

Meanwhile on Wednesday, the U.S. imposed sanctions on what it described as a Russian-backed oil



smuggling and money laundering network for the I RGC's Quds Force. The sanctions seem to be a justification for this confiscation.

According to international regulations approved by IMO regarding safety of lives at sea, all countries are required to provide assistance to vessels in distress near their coastlines, until the danger is resolved, and safety of the vessel and people on board can be guaranteed, while any necessary repairs and facilities should be provided to achieve or facilitate the above.

Moreover, the International Convention for the Prevention of Pollution from Ships (MARPOL) has also stipulated limitations for bunker operations or any other activities that pose the risk of pollution to the marine environment. The Greek government, nevertheless, has been acting in full violation and negligence of these provisions as well.

But it seems international bodies try to remain passive when it comes to react to the U.S. or West's violation of international laws and as it was mentioned before, it is not the first time that Iran's cargo is confiscated by the pirate U.S. or its allies. But when Iran wants to take retaliatory action or stops vessels over the violation of international waters on its waters, all international bodies stand against Tehran and condemn it while they really know that the U.S. is the main culprit.

The PMO said the vessel had been held by the Greek government on the coasts of that country, and the cargo on board the ship was seized upon court order and in coordination with the US government.

On Thursday, Reuters quoted unnamed sources as saying that the US Department of Justice had confiscated 700,000 barrels of Iranian oil cargo seized last month off the southern Greek island of Evia onboard a Russian-operated ship. Meanwhile, the US Navy's Mideast-based 5th Fleet said it was "looking into" reports that Iran had seized two Greek oil tankers.

Cmdr. Timothy Hawkins of the 5th Fleet told The Associated Press that the Navy was continuing to investigate, without further elaborating.

A report by Lloyd's List Intelligence said that in two seemingly similar operations, the suezmaxes Delta Poseidon and Prudent Warrior, both under Greek flag, were seized by Iranian forces on Friday afternoon.

Athens announced on Friday that Iranian navy helicopters had landed gunmen on the two tankers earlier in the day. One of them, the Delta Poseidon, was sailing in international waters at the time, the Greek Foreign Ministry said, adding that the second tanker was near the Iranian coast when seized.

The ministry also said nine Greeks were among the crews of both vessels, but did not give a number of other sailors on board.

Athens has informed the European Union and the International Maritime Organization of the incident, it added. According to Lloyd's List Intelligence, Delta Poseidon's destination was Agioi Theodoroi, near Corinth, and the cargo is understood to be for the Motor Oil refinery located there.

# Nadal, Djokovic Sweep Into French Open Last 16

PARIS (Dispatches) - Rafael Nadal continued his pursuit of a 14th French Open title, cruising past Dutch 26th seed Botic van de Zandschulp 6-3, 6-2, 6-4 to reach the last 16. The 21-time major champion will play Canadian ninth seed Felix Auger-Aliassime for a place in the quarter-finals, where world number one Novak Djokovic could await him. Nadal is now 108-3 at Roland Garros in his career.

"I think I played a good match against a good player. I'm very happy to win," said Nadal. The Spaniard had a break point for 5-0 in the third set, but Van de Zandschulp refused to roll over, winning four of the next five games before Nadal put away his second match point, having saved a break point in between the two.

'You always feel a little bit the nerves to finish the match, so I'm happy to be through in straight sets," said Nadal.

"I think it was my best match of the tournament so far for two-and-a-half sets, so I'm very happy with that."

Nadal has reached at least the fourth round in 17 of 18 visits to Paris, with the exception of 2016 when he withdrew in the third round with a wrist injury.

Earlier world number one and defending champion Novak Djokovic eased into the French Open fourth round for the 13th straight year.

The top seed cantered to a 6-3, 6-3, 6-2 win over Slovenia's Aljaz Bedene, firing nine aces and 30 winners past his 195th-ranked opponent.

Next up for the 35-year-old, who was also French Open champion in 2016, is a match-up

with Argentina's Diego Schwartzman, the 15th seed, for a place in the quarter-finals. Djokovic, bidding for a record-equalling 21st Grand Slam title, has a perfect 6-0 record

over Schwartzman including a five-set win in Paris in the third round in 2017.

Mertens reached the last 16 with a 6-2, 6-3 win over Varvara Gracheva of Russia. American Amanda Anisimova advanced to the fourth round of the French Open, after her Czech opponent Karolina Muchova was forced to retire with an ankle injury sustained

The 25-year-old Muchova, who reached the Australian Open semi-finals in 2021, has been plagued by injuries over the last 12 months.

Having ousted Greek fourth seed Maria Sakkari in her previous match, Muchova took a medical timeout to get her left thigh taped after overturning a 5-1 deficit in the tiebreaker to win the first set.

#### FIA Extends F1 **Jewelry Exemption** To End of June

MONACO (Dispatches) - Seven times world champion Lewis Hamilton will be able to continue racing with piercings for the next three races after Formula One's governing body extended an exemption on fixed items of jewelry.

The FIA confirmed the push back until the end of June for items requiring special intervention for removal, with the medical commission evaluating feedback from drivers and others.

The period covers this weekend's showcase Monaco Grand Prix, the races in Azerbaijan on June 12 and Canada on June 19 and expires before Mercedes driver Hamilton's home race at Silverstone on July 3.


Hamilton, the sport's most successful driver with 103 wins, has said he cannot remove one of his piercings without assistance.

He was given a two-race exemption after a standoff at this month's Miami Grand Prix, which would have meant breaching the regulations in Monaco if he failed to remove the piercings before then.

"Honestly I feel there's way too much time and energy been given to this," the 37-year-old driver told reporters in Monaco.

"I've said everything I feel I need to say. I've taken the (ear) studs out every time I've been in the car." "I think we've all worn jewelry our whole careers in F1 and it's never been a problem in the past and there's no reason for it to necessarily be a problem now." The Briton said it was positive to be working with the FIA on reaching a solution but "we shouldn't have to keep revisiting this subject every weekend, we have bigger fish to fry." The ban on jewelry, as well as the wearing of non-compliant undergarments, has long been in the rules but rarely enforced until the FIA clamped down this season.

### Can Make Nation Proud in World Cup Playoff

ONDON (Dispatches) - Ukraine full Lback Oleksandr Zinchenko said his team hope to make their country proud when they take on Scotland in a World Cup playoff semi-final next week.

Ukraine play Scotland at Hampden Park on June 1 in a match that was postponed from March due to the Russia's invasion, which Moscow calls a "special military operation."

"The first period when it just started, it was so complicated to be focused on football," Zinchenko told the BBC. "All my thoughts were with Ukraine, Ukrainian people. I would say for everyone, for every Ukrainian footballer ...

"This game is one of the most important games in my life. The guys look ready and it's not necessary to talk about motivation." It will be Ukraine's first competitive match since the invasion began in February.

The Ukrainian Premier League season was abandoned last month. "The physical condition, obviously without the games, it's not easy to prepare yourself for the guys that haven't played for a while," Zinchenko said.


"In this case, there is no excuses and we have to do our job as best as we can.

"I can promise all the Ukrainian people that every one of us is going to give everything to win the game and to make them proud of us and just maybe for a few seconds we would like to give them this smile."

The winner of the playoff will face Wales in Cardiff on June 5 for a spot in Qatar later this year.

#### **Warriors Eliminate Dallas and Advance** To NBA Finals

AN FRANCISCO (Dispatches) - Klay Thompson scored a game-high 32 points and the Golden State Warriors advanced to the NBA Finals for the sixth time in eight seasons by defeating Dallas 120-110.



"This is a blessing for us to get back here, to get back where we belong," said Golden State guard Stephen Curry, who was named the Western Conference playoff Most Valuable Player. Andrew Wiggins scored 18 points and grabbed 10 rebounds for the Warriors while Draymond Green added 17 points and nine assists, Jordan Poole scored 16 points off the bench, Curry added 15 and nine assists, and Kevon Looney added 10 points and 18 rebounds. The Warriors have not lost a playoff game at home this season, the first post-season run

in their new arena in San Francisco after leaving behind their old home in Oakland. "It's special to do it in our new building," Curry said. "This isn't the ultimate goal but we've got to celebrate this for all we went through the past three years."

After missing the playoffs the past two seasons while rebuilding, the Warriors are playing for the trophy again with champion core stars Curry, Thompson and Green back setting the pace. "This one is special because this is a group no one thought would ever be back here." Green said.

"This group put the work in every day and we're here. We're back."

It will be the sixth consecutive trip to the NBA Finals for Thompson, who missed the entire 2019-20 campaign after left knee surgery and the entire 2020-21 season with a

#### Real Madrid Remain Europe's Most Valuable Football Club

ONDON (Dispatches) - Real Madrid ✓remain Europe's most valuable football club despite the ever-increasing dominance of the English Premier League, according to two reports by analysts published.



value based on their annual financial statements and assessing squad values, put Real top with a valuation of 3.184 billion euros (\$3.4 billion).

Real, who face Liverpool in Saturday's Champions League final, came out on top for the fourth consecutive year of the report.

That is still short of their valuation in 2020, just before the pandemic, of nearly 3.5 billion euros, although the report points out that they were one of few clubs to register a net profit in both seasons impacted by the pandemic.

In a separate study, Forbes also ranked Real top but with a valuation of \$5.1 billion.

"Real Madrid have extended their lead at the top due to continuous sporting and commercial success," said the Football Benchmark report's author, Andrea Sartori.

It said Real lost 84 million euros due to the absence of matchday revenues with supporters shut out due to the pandemic. However, Real "made the made the most of the restrictions...accelerating works on the
