

Mahan Air Reacts to Seizure of **Boeing 747 in Argentina**

TEHRAN - The Iranian Mahan Air has reacted to the reports alleging that a Venezuelan Boeing 747 belonging to the Iranian airline is detained in Argentina. saying that the airliner does not belong to Mahan Air. Mahan Air Public Relations said in a statement on Sunday: The ownership of this airliner has been transferred to a Venezuelan company for a year and is not leased to the airline.' "The seizure of this plane, in the name of Mahan Air, has political purposes," it added.

"The flight is operated by Venezuelan Airlines and has nothing to do with Mahan Air," the statement said. Media reports on Sunday claimed an Iranian Boeing 747 belonging to Mahan Air was seized in Argentina. There was no official confirmation of the report.

According to Aviacionline, a Boeing 747-300M with registration YV3531, belonging to Emtrasur Cargo, the freight division of the Venezuelan flag carrier Conviasa, has been detained in Buenos Aires' Ezeiza Airport.

Iran Exports to Africa At \$1.2b Last Year

TEHRAN (PressTV) - Iranian customs office (IRICA) figures show exports to Africa reached a total of \$1.2 billion in the year to late March.

IRICA Spokesman Rouhollah Latifi said that shipments sent to Africa over the past calendar year had accounted for only 2.5% of all Iranian exports.

Latifi said Iranian exports had reached 50 out of 55 African countries over the period. Total shipments had amounted to over 2.5 million metric tons (mt) in volume terms, he said, adding that imports from Africa into Iran had stalled at a tiny figure of just over \$60 million for just more than 65,000 mt of goods over the same period.

IRICA figures showed that Ghana was the largest

Iran Warns Neighbors Against Letting Israel Gain Foothold in Persian Gulf

TEHRAN (PressTV) - The commander of Iran's Islamic Revolution Guards Corps (IRGC) Navy has warned neighboring countries against allowing Israelis into the Persian Gulf, saying such a move would bring nothing but chaos and instability to the region.

In a visit to the Persian Gulf island of Greater Tunb on Saturday, Rear Admiral Alireza Tangsiri hailed the Persian Gulf's "good security," which he attributed to cooperation and synergy among neighboring countries. However, he said, if a country allows "the miserable child-killer regime" in Tel Aviv to establish a foothold in this region, that country and the entire region will be inflicted with insecurity, chaos, and instability.

"We advise our friendly and brotherly [neighbors] in the Persian Gulf not to establish relations with the Zionist regime, because by doing so, they will undermine the security of the region," he stated.

Iran, Pakistan Seek **To Maintain Maritime Security**

TEHRAN (IP) - Deputy Chief of Iran's Army for Coordination says Iran and Pakistan have great capabilities in maritime security and can maintain it, especially in the North Indian Ocean and the Oman Sea.

Rear-Admiral Habibollah Sayyari stated: "There is never a need for strangers to establish security, and they are obliged to leave our region and establish security in their area."

Major-General Rahat Nasim Ahmad Khan, at the head of the delegation of the National Defense University of Pakistan, met with the Deputy Chief of Iran's Army for Coordination, Rear-Admiral Habibollah Sayyari.

Sayyari noted that the head of Pakistan's National Defense University expressed satisfaction while visiting the Army of the Islamic Republic in Isfahan and Tehran and was surprised by the developments that the units of the Iranian army had achieved.

He said: "The Pakistani group said that all this progress in upgrading the combat equipment of the Armed Forces of the Islamic Republic of Iran is unbelievable for them."

Hamidreza Kazemi, the deputy head of the embassy told the Middle East Eye, "We in Iran have been fighting narco-trafficking by way of the eastern borders of Jordan for 40 years." Kazemi noted that more than 3,000 Iranian security personnel have been martyred in this war.

Iran-Venezuela Direct Flights To Start as of 18 June

TEHRAN (MNA) – The direct flights between Tehran and Caracas will start on 18 June, the Iranian envoy to Caracas said, adding that no visa will be needed for traveling to the Latin American country.

Speaking on the IRIB TV program on Saturday night, the Iranian Ambassador to Venezuela Hojjatollah Soltani hailed that political relations between Tehran and Caracas are at the best possible level.

Referring to the strong will of President Raisi's administration to strengthen and expand cooperation with Venezuela, Soltani said that so far, the countries' relations have expanded in various fields and are moving forward.

Venezuela is a very potential market for Iran's goods, the Iranian envoy also said, adding that today Iran exports medicine, medical equipment, hemodialysis machines, detergents, food and etc. to this country.

He also referred to the emphasis of the Leader of the Islamic Revolution on strategic relations between Iran and Latin America, saying that Latin America is a perfect and suitable region for Iran's activities in political, cultural, and economic arenas.

Elsewhere in his remarks, the Iranian ambassador said that direct flights between Tehran and Caracas will start next week on June 18.

According to him, Iranians will not need to get a visa to travel to this Latin American country.

Afghans Failing to Take Part In Census to Be DeportedUnit

TEHRAN (IFP) - Interior Ministry says Afghans who fail to participate in an ongoing census for foreigners will be treated as illegal and deported from the country.

The ministry's Department of Foreign Nationals and Refugees added that June 22 will be the last date on which Afghan nationals can participate in the census.

It also said that the census will not be extended.

Iran says nearly 5 million Afghan refugees are living in the country.

The latest refugee influx from Afghanistan happened last August following the Taliban takeover of the country.

Iran has repeatedly demanded the UN and also European countries assist it in hosting the Afghan refugees.

Tehran says it has yet to receive substantial help for this purpose.



The tanker delivered to Venezuela on Saturday can carry 113,000 mt or 750,000 barrels of oil. The 250-meter-long vessel is equipped with a 21,000 horsepower engine and three diesel generators that are capable of producing 900 kilowatts of electricity.

Sadra is a subsidiary of Iran's elite military force the IRGC and its shipbuilding yards are based along the Persian Gulf coast in Bushehr province. The company had carried out test sails on the Venezuelan Aframax tanker earlier this week in a ceremony watched by senior IRGC commanders.

Its CEO Ali Zarei said building a third and fourth Aframax tanker by the company, which have reportedly been ordered by Venezuela, will begin soon.

Beijing Warns of Explosive Covid Outbreak

SHANGHAI (Dispatches) - China's capital Beijing is facing an "explosive" Covid-19 outbreak connected to a bar, a government spokesman warned, as the commercial hub of Shanghai began mass testing to contain a jump in cases tied to a popular beauty salon.

The warning followed a renewed tightening of Covid curbs in Beijing since Thursday, with at least two districts — including its most populous, Chaoyang - closing certain entertainment venues after a flare-up in a busy neighborhood known for its nightlife, shopping and streets of embassies.

Bolivian Ex-President Sentenced to 10 Years in Prison

LA PAZ (Dispatches) - Bolivian ex-president Jeanine Anez was sentenced to 10 years in prison, more than a year after her arrest for an alleged plot -- dismissed as fictional by many -- to oust her rival and predecessor Evo Morales.

Anez, who has been held in pre-trial detention since March 2021, has consistently denounced what she calls political persecution.

The former interim leader will serve 10 years in a women's prison in La Paz, the administrative capital's First Sentencing Court announced in a decision that comes three months after her trial began.

U.S., Allies Trade Barbs With China



SINGAPORE (Dispatches) - The United States and its allies traded barbs with China at Asia's premier security meeting, especially on Taiwan, but the war in Ukraine and a remote speech by President Volodymyr Zelenskiy dominated proceedings. U.S. Defence Secretary Lloyd Austin earlier told the Shangri-La Dialogue in Singapore that Washington will do its part to

manage tensions with China and prevent conflict even though Beijing was becoming increasingly aggressive in the region. Zelenskiy, speaking via video link from an undisclosed location in Ukraine's capital, Kyiv, told the delegates that their nations' support was crucial not just to defeat the Russian invasion, but to preserve the rules-based order.

"It is on the battlefields of Ukraine that the future rules of this world are being decided along with the boundaries of the possible." he said.

He noted that Russia is blocking ports in the Black Sea and Azov Sea, keeping Ukrainian food exports from the world market. "If ... due to Russian blockades we are unable to export our foodstuffs, the world will face an acute and severe food crisis and famine in many countries in Asia and Africa," he said.

China and the United States, which have clashed in recent months over everything from Taiwan and China's human rights record to its military activity in the South China Sea, were again at odds.

Austin and Chinese Defense Minister Wei Fenghe met on Friday and reiterated they want to better manage their relationship but there was no sign of any breakthrough in resolving differences. Austin said the United States would continue

to stand by its allies, including Taiwan. "That's especially important as the PRC (People's Republic of China) adopts a more coercive and aggressive approach to its territorial claims," he said.

China claims self-ruled Taiwan as its own and has vowed to take it by force if necessary. Austin said there had been an "alarming" increase in the number of unsafe and unprofessional encounters between Chinese planes and vessels with those of other countries.

Australia has said a Chinese fighter aircraft dangerously intercepted one of its military surveillance planes in the South China Sea region in May, and Canada's military has accused Chinese warplanes of harassing its patrol aircraft as they Kim Jong Un Vows "Power to Power" Military SEOUL (Dispatches) - North Korea promoted its key and defense research to protect North Korea's sovereign

"Secretary Austin underscored that the U.S. commitment to the defense of (South Korea) is ironclad and underpinned by the full range of U.S. capabilities, including nuclear," the U.S. Defense Department said in a statement.



PATNA (Dispatches) - Indian police shot dead two protesters and arrested more than 130 others during street rallies sparked by a ruling party official's remarks about the Prophet Muhammad (PBUH), authorities told AFP.

There have been widespread protests in the Muslim world since last week when a spokeswoman for Prime Minister Narendra Modi's party commented on the relationship between the prophet and his youngest wife on a TV debate show.

In India and neighboring countries, Muslims took to the streets in huge numbers after Friday prayers to condemn the remarks, with police firing on a crowd in the eastern Indian city of Ranchi.

"Police were forced to open fire to disperse protesters... resulting in the death of two," a police officer in Ranchi told AFP.

Germany Urges Bulgaria to Lift Veto on N. Macedonia EU Entry Talks

SOFIA (Dispatches) - German Chancellor Olaf Scholz called on Bulgaria to lift its veto on EU accession talks for North Macedonia, saying the bloc should avoid dashing the membership hopes of countries in Western Balkans. read more

Scholz, visiting Sofia as part of a two-day tour of the region ahead of an EU-Western Balkans leaders' summit on June 23, said he sensed a "new willingness" by the EU to expand after Russia's invasion to Ukraine.

The war has lent new urgency to the process of trying to tie the Western Balkans closer to the 27-member bloc in a bid to counter Russian and Chinese influence. The German chancellor has made the matter a foreign policy priority, and fashioned himself as a mediator during his trip.

"I see chances for progress," Scholz said in a news conference with Bulgarian Prime Minister Kiril Petkov. "We will stay in close exchange in coming days." Petkov reiterated Bulgaria's stance that North Macedonia must meet three conditions related to historical and cultural disputes between the two countries, urging Brussels to guarantee they were met.

The issue is sensitive for Bulgaria's domestic politics. This week, one of Petkov's four coalition partners quit, accusing him of being ready to lift Bulgaria's veto in disregard of national interests, among other allegations.

Earlier on Saturday, Scholz visited North Macedonia, which has already carried out many reforms in its bid to become an EU member, such as changing its name to meet Greek objections.

Speaking in Skopje alongside North Macedonian Prime Minister Dimitar Kovacevski, Scholz said Russia's invasion of Ukraine made it important for Europe to stand together.

On Friday, he visited Serbia and Kosovo, which declared independence from Belgrade in 2008. He urged the leaders to reach an agreement on normalising relations.

Shortly before returning to Germany, Scholz said the will among many EU members to get the Western Balkans into the EU was stronger than it had been "for many years".

France is also ready to help on allowing access to the port of Odesa, where some of Ukraine's grain stocks are ready to be exported, the official said.

"We're at the disposal of the parties so that an operation can be set up which would allow access to the port of Odesa in complete safety," the official said.

The official didn't elaborate on what that help would be.

The Black Sea, where Odesa is located, is crucial for shipment of grain, oil and oil products. Its waters are shared by Bulgaria, Romania, Georgia and Turkey, as well as Ukraine and Russia.

Ukrainian government officials estimate 20 million tons of grain are unable to travel from what was the world's fourth largest exporter before Russia's invasion.

Taiwan Threatens WTO Action

TAIPEI (Dispatches) - Taiwan's government threatened to take Beijing to the World Trade Organization on Saturday after China suspended the import of grouper fish from the island saying it had detected banned chemicals, the latest agricultural spat between the two.

Last year China suspended imports of pineapples, sugar apples and wax apples from Taiwan, citing concerns about pests, which Taiwan strongly denied.

Relations between Taipei and Beijing, which claims democratically ruled Taiwan as its own territory, are at their lowest in decades, with China increasing political and military pressure to get the island to accept its sovereignty.

BEIJING (Dispatches) - China's factory-gate inflation cooled to its slowest pace in 14 months in May, depressed by weak demand for steel, aluminum and other key industrial commodities due to tight COVID-19 curbs and bucking the global trend of rapidly accelerating prices. The producer price index (PPI) rose 6.4% year-on-year, the National Bureau of Statistics (NBS) said, after an 8.0% rise in April and

in line with forecasts in a Reuters poll. It was the weakest reading since March 2021. The consumer price index (CPI) gained 2.1% from a year earlier in May, in line with April's growth. In a Reuters poll, the CPI was expected to rise 2.2%.

The cooling inflation marks a sharp contrast to decadeshigh readings seen in other major economies and reflects the slump in demand due to China's strict COVID-19 controls, which has chilled factory and retail activity in recent months.

The modest price pressures also allow China's central bank to release more stimulus to prop up the economy even as monetary authorities in most other countries scramble to hose down inflation with aggressive interest rate hikes.

"Factory gate inflation will continue on its downward trajectory throughout the rest of the year," said Sheana Yue, China Economist at Capital Economics.

"Further policy rate cuts before $\log -$ the first of which might come as soon as next Wednesday," she noted, referring to the People's Bank of China's medium-term liquidity operations next week.

The world's second-largest economy has slowed significantly in recent months, hit by strict COVID-19 controls, disrupting supply chains and jolting production and consumption. China's cabinet in late May announced a package of 33 measures covering fiscal, financial, investment and industrial policies to revive its economy.

Last month, widespread COVID-19 lockdowns shut factories and stores, choking purchases of metals-intensive products from cars to appliances. Chinese auto sales grew in May from April but were still down 16% year-on-year, according to the Chinese Passenger Car Association.

The urban jobless rate rose to 6.1% in April, the highest since February 2020 and well above the government's target ceiling of 5.5%

Non-food prices rose 2.1% from a year earlier, 0.1 percentage point slower than the previous month, affecting the CPI by about 1.68 percentage points, the NBS said in a separate statement.

On a month-on-month basis, CPI fell 0.2%, swinging from a 0.4% rise in April. "The CPI inflation remained stable. The rising commodity prices were offset by weak service prices such as travel and entertainment," said Zhiwei Zhang, Chief Economist at Pinpoint Asset Management.

"The transmission from PPI to CPI has turned out to be muted, because of weak domestic demand."

Beijing has taken a series of measures from cutting benchmark lending rates to allowing delays on loan repayments to arrest the economic slowdown.

Goldman Sachs last month lowered its 2022 growth forecast to 4% from 4.5%, below China's official target of around 5.5%.

meant to harness its banks and bond markets to cool soaring inflation and stabilize a sliding currency, doubling down on President Tayyip Erdogan's aversion to raising interest rates.

While the Treasury said fighting inflation remained its "top priority", some analysts



said the measures announced would do little to relieve an economy saddled by high living costs. Among the steps, the Treasury said it would issue domestic bonds indexed to the revenues of state enterprises to spur lira asset savings, the central bank raised the required reserves ratio for lira commercial cash loans to 20% from 10%, and the banking watchdog tweaked a maturity limit for consumer loans.

"All of our institutions are acting with the understanding of a joint struggle," the Treasury said. In response to the coordinated steps, the lira initially rallied then skidded to settle at 17.06 to the dollar, near its lowest since a currency crisis in December. It has shed 23% this year after dropping 44% last year.

Underscoring how risky the emerging market economy has become due largely to Erdogan's unorthodox policies, 5-year credit default swaps rocketed to a record 830 basis points while international bonds came under pressure.

Taken together, the steps aim to boost individual Turks' lira confidence and holdings while also cooling some forms of credit growth, which helped push inflation to a 24-year high above 73% last month.

The inflationary spiral was precipitated by a series of central bank interest rate cuts carried out late last year under pressure from Erdogan, who says the monetary stimulus is needed to boost exports and investments ahead of elections in mid-2023.

Analysts were skeptical how much the latest steps could move the needle given they skirted the need to raise rates and could prove costly for the state.

"There isn't any policy change available to take inflation under control," said Arda Tunca, Istanbulbased economist and columnist at PolitikYol. "All these schemes cause the Treasury to shoulder the burden of yields to be paid to investors.'

Bankers said time deposit yields had been rising in recent weeks, and the latest steps could raise banks' costs and further lift loan rates.

Earlier this week, sources told Reuters the government was considering pushing a supplementary budget through parliament before a recess next month to cover possible summer payments.

The lira crisis has driven up import prices, a trend exacerbated by Russia's war in Ukraine that hiked Turkey's energy and food import bills.

Bundesbank Halves 2022 Growth Forecast, Doubles Inflation Projection for Germany

FRANKFURT (Dispatches) - The Bundesbank cut its growth projections for the German economy on Friday and predicted sharply higher inflation, as soaring food and fuel prices sap households' purchasing power and batter confidence.

The German central bank now sees prices rising by 7.1% in 2022, well above the 3.6% projected in December while the 2023 figure was raised to 4.5% from 2.2%.

"Inflation this year will be even stronger than it was at the beginning of the 1980s," Bundesbank President loachim Nagel said, referring to the previous period of painfully high consumer price growth.

"Price pressures have even intensified again recently, which is not fully reflected in the present projections," Nagel said. "If this development is assumed to continue, the annual average (inflation) rate for 2022 could be considerably above 7%.

The update is broadly in line with the European Central Bank's revisions of its own forecasts on Thursday, which showed accelerating inflation from surging fuel and food prices but a big hit to growth.

In 2024, the last year of the Bundesbank's projection horizon, inflation is seen at 2.6%, well above the ECB's own 2% target for the euro zone.

"Euro area inflation rates won't fall by themselves," Nagel added. "Monetary policy is called upon to reduce inflation through resolute action." The ECB on Thursday said that it would raise rates in July by 25 basis points and an even bigger increase may be necessary in September before a string of further hikes.

Russian Central Bank Slashes Interest Rates to Pre-War Level

MOSCOW (Dispatches) - Russia's central bank lowered interest rates back to their prewar levels and said it will continue to explore the scope for more cuts, as inflation slows from near 20-year highs and economic contraction looms.

It said inflation and economic activity were developing better than expected despite sweeping Western sanctions imposed in response to the war in Ukraine.

The bank lowered its key rate by 1.5 percentage points, to 9.5%. The rate was hiked to 20% in the immediate aftermath of Moscow's dispatch of armed forces into Ukraine on Feb. 24 and the resulting sanctions by the U.S., the European Union and other nations that restrict dealings with Russian banks. individuals and companies.

But the bank had since cut rates three times in steps of 300 basis points - the last of them two weeks ago.

Economists say that over time the sanctions will corrode growth and productivity, but the central bank has managed to stabilize Russia's currency and financial system through drastic measures such as high interest rates, restrictions on flows of money out of the country and a requirement that importers sell their foreign currency earnings for rubles.

Those measures have helped push the Russian currency's exchange rate to 58.12 against the dollar Friday, compared with 78.8 rubles to the dollar on Feb. 23, the day

Fitch Raises India Outlook to Stable, Maintains Rating

NEW DELHI (Dispatches) - Fitch Ratings raised its outlook for India's long-term foreign currency Issuer Default Rating (IDR) to "stable" from "negative", citing diminished downside risks to medium-term growth.

The upgrade brings its view of Asia's third-largest economy in line with Standard and Poor's and Moody's ratings and outlook. S&P has a 'BBB-' rating on India, with a stable outlook, while Moody's has a Baa3 rating and stable outlook. Fitch maintained its rating of BBB- on India.

"India's economy continues to see a solid recovery from the COVID-19 pandemic shock," it said in a statement.

The ratings agency said risks to the country's medium-term growth lessened due to rapid economic recovery and easing financial sector weakness, despite near-term headwinds from the global commodity price shock.

"High nominal GDP growth has facilitated a near-term reduction in the debt-to-GDP ratio," Fitch said.

Fitch lowered India's economic growth for 2022/23 to 7.8% from the 8.5% it had forecast in March, saying the inflationary impacts of the global commodity price shock were dampening some of the positive growth momentum.



However, Fitch's projection was ahead of Reserve Bank of India's (RBI) projection of 7.2%

In 2021/22, India's economic growth was 8.7%.

Fitch expects inflation to average 6.9% in the current fiscal year due to a rise in global commodity prices and said it expects RBI to continue to raise repo rates to 6.15% by next fiscal year.

Earlier this week, India's central bank raised its repo rate by 50 basis points to 4.90%, the second hike in two months, while raising its inflation forecast to 6.7% from 5.7%.

Fitch said external risks remain relatively well-contained despite high oil prices due to RBI's over \$600 billion forex buffer.

It forecast current account deficit of 3.1% of GDP in 2022/23 from 1.5% in the last fiscal year.

Inflation was an annual 17% in May but appeared to have passed its post-invasion peak of 17.8% and to be headed down amid lower price increases in May and June, the central bank said. It predicted inflation would average 14% to 17% this year, decline to 5% to 7% next year and return to 4% in 2024.

Recent data pointed to a halt in the decline of business activity in May.

"The external environment for the Russian economy remains challenging and significantly constrains economic activity," the central bank said.

While the bank has been able to prop up indicators such as the exchange rate, economists say the long-term impact of Russia's disrupted ties with the global economy will be severe.

On top of sanctions, many international companies have abandoned their investments in Russia due to the increased difficulty of doing business or because they do not want to be associated with the war.

The Institute of International Finance (IIF) predicts the Russian economy will contract by 15% in 2022, followed by a further 3% decline in 2023, and the country faces the loss of the last 15 years of economic gains.

much-needed bailout payments.

"There are still some concerns the IMF has about our budget and numbers and stuff like that," Ismail said in an interview at his office in Islamabad.

He said the IMF was concerned about fuel subsidies, a widening current account deficit, and the need to raise more direct taxes.

Fuel subsides have been cut in the last two weeks, and the remaining support is expected to be removed in coming days.

Proposed budget estimates also seek to rein in the current account deficit, but direct tax revenues remain a concern and Ismail said "slight differences" remain there.

IMF's resident representative in Islamabad did not immediately respond to a request for comment.

Ismail said Pakistan would seek to allay the concerns before the budget has to be passed by parliament. Pakistan's financial year runs from July 1 to June 30.

"If there are some changes that we need to make to bring them onboard, we shall do so," he said.

Pakistan is halfway through a \$6 billion, 39-month IMF programme which has stalled over the lender's concerns over the status of some of its objectives, including fiscal consolidation.

Pakistan urgently needs funds in the face of dwindling foreign exchange reserves, which have reached \$9.2 billion - enough for less than 45 days of imports.

U.S. Inflation Roars to 8.6% in May, a New 40-Year High

NEW YORK (Dispatches) - The costs of gas, food and other necessities jumped in May, pushing inflation to a new four-decade high and giving American households no respite from rising costs.

Consumer prices surged 8.6% last month from 12 months earlier, faster than April's year-over-year increase of 8.3%, the Labor Department said Friday. The new inflation figure, the biggest yearly increase since December 1981, will heighten pressure on the Federal Reserve (Fed) to continue raising interest rates aggressively. On a month-to-month basis, prices jumped 1% from April to May, much faster than the 0.3% increase from March to April. Behind that surge were much higher prices

for food, energy, rent, airline tickets and new and used cars. The widespread price increases also elevated so-called "core" inflation, a measure

that excludes volatile food and energy prices. In May, core prices jumped a sharp 0.6% for a second straight month and are now 6% above where they were a year ago. Friday's report underscored the worry that inflation is broadening well beyond the spike in energy prices stemming from clogged supply chains and Russia's invasion of Ukraine. And the increased pressure on the Fed to raises rates even faster - which will mean higher-cost loans for consumers and businesses — raises the risk of recession.

"Virtually every sector has higher-than-normal inflation," said Ethan Harris, head of global economic research at Bank of America. "It's made its way into every nook and cranny of the economy. That's the thing that makes it concerning, because it means it's likely to persist.'

Gas prices jumped 4% just in May and have soared nearly 50% from a year ago. They've risen further this month. The national average price at the pump reached \$4.99 Friday, according to AAA.

The cost of groceries surged nearly 12% last month from a year earlier, the biggest such increase since 1979. Restaurant prices jumped 7.4% in the past year, the largest 12-month gain since November 1981, reflecting higher costs for food and workers.

Housing costs are also climbing. The government's shelter index, which includes rents, hotel rates and a measure of what it costs to own a home, increased 5.5% in the past year, the most since 1991. Airline fares have skyrocketed nearly 38% in the past year, the sharpest such rise since 1980.

America's rampant inflation is imposing severe pressures on families, forcing them to pay much more for food, gas and rent and reducing their ability to afford discretionary items, from haircuts to electronics. Lower-income and Black and Hispanic Americans, in particular, are struggling because, on average, a larger proportion of their income is consumed by necessities.

Some evidence in recent weeks had suggested that inflation might be moderating, particularly for long-lasting goods that were caught up in supply chain snarls and shortages last year. But that trend appeared to reverse itself in May, with used car prices rising 1.8% after having dropped for three straight months. New car prices



also rose. And clothing prices increased after having declined in April.

In light of Friday's inflation reading, the Fed is all but certain to carry out the fastest series of interest rate hikes in three decades. By sharply raising borrowing costs, the Fed hopes to cool spending and growth enough to curb inflation without tipping the economy into a recession. For the central bank, it will be a difficult balancing act.

The Fed has signaled that it will raise its key short-term rate by a half-point – double the size of the usual hike - next week and again in July. Some investors had hoped the Fed would then dial back its rate increases to a quarter-point increase when it meets in September or perhaps even pause its credit tightening. But with inflation raging hot, investors now increasingly expect yet another half-point hike in September, which would be its fourth since April.

Surveys show that Americans see high inflation as the nation's top problem, and most disapprove of President Joe Biden's handling of the economy. Congressional Republicans are hammering Democrats on the issue in the run-up to midterm elections this fall.

Surging inflation has forced Rocky Harper of Tucson, Arizona, to start doing gig work for delivery companies, on top of his regular full-time job with a package delivery service. His main job pays \$800 a week, he said, which "used to be really good money and is now just above dirt-poor."

Criticizing the United States and its European allies for the submission of an anti-Iranian resolution during the IAEA's Board of Governors meeting, Iran's top diplomat said the move was "hasty and politically motivated."

Spain Swelters in Hottest Pre-Summer Heatwave for 20 Years

SEVILLE (Dispatches) - Fan-sellers were doing good business in the southern city of Seville on Saturday as Spain sizzled in the hottest pre-summer heatwave for at least 20 years.

Carriage drivers dampened down horses who take tourists around the historic sights of Seville such as the Real Alcazar Palace and Plaza de Espana.

Temperatures reached 40 C (104 Fahrenheit) degrees in the Guadalquivir valley in Seville and the nearby city of Cordoba on Saturday, the national meteorological office AEMET said.

Temperatures could rise to 42 C (108 Fahrenheit) degrees in the Guadiana valley in Extremadura and other parts of southern Spain later on Saturday, forecasters said.

On Sunday, the heatwave intensified as temperatures could soar to 43 C (110 Fahrenheit) degrees in parts of southern Spain.

A cloud of hot air from North Africa has sent temperatures soaring, AEMET forecasters said, and the suffocating heatwave could last in most of Spain until June

FDI in Turkey Hits \$14b in 2021 as Global Flows Rebound

ANKARA (Dispatches)

Foreign direct investment (FDI) in Turkey soared 79% year-over-year in 2021, a report by United Nations' trade and development agency UNCTAD showed, as inflows rebounded around the world to pre-pandemic levels. Coming off a low base in 2020, global FDI flows rose 64% to \$1.58 trillion last

year, UNCTAD's World Investment Report 2022 said, driven by a booming merger and acquisition activity and rapid growth in international project finance due to loose financing and

major infrastructure stimulus packages. The figure had slipped to around \$963 billion in 2020, well below the low point reached after the global financial crisis a decade ago, amid a global economic fallout from the pandemic. Turkey saw the FDI inflow reach \$14 billion, up from around \$8 billion in 2020, when the country saw a relatively

smaller drop of 15%, compared to 35% on a global level. The inflows since 2002 have exceeded the level of

Manufacturing, service and agriculture topped the list among industries in Turkey, accounting for \$8.4 billion of the FDI inflow in 2021, an increase of 116% from a year ago, the Investment Office said. Investments in real estate market soared by 42.5% to \$5.6 billion, it added. European

accounted for 60% of the inflows in Turkey, followed by Asia and the Americas with 23% and 16%, respectively. The U.K. is the biggest investor among nations, accounting for 19%, followed by the U.S. and the Netherlands with 16% and 13%, respectively. Among other major investors were Switzerland, the United Arab Emirates, Germany, South Korea, Japan and Qatar, the statement said.

Number of Syrians Becoming German Citizens Tripled in 2021

BERLIN (Dispatches) - The number of Syrians who became naturalised German citizens was three times higher in 2021 than the year before, as many of those who fled between 2014 and 2016 fulfilled eligibility criteria, data showed.

The overall number of foreigners who became naturalized Germans grew 20% in 2021, reaching roughly 131,600, the Federal Statistical Office said. Of those, 19,100 were Syrians who became German citizens.

Hundreds of thousands of migrants entered Germany after former Chancellor Angela Merkel opened the borders in 2015 to refugees fleeing war and poverty in the Middle East and beyond.

While, in general, a person has to live in Germany for at least eight years to qualify for citizenship, the majority of Syrians qualified earlier - on average after 6.5 years - by showing particular willingness to integrate, for example with strong language skills and civic commitment, it said.

The office said 2021 saw the highest number to date of people who naturalised early, with just under 12,400 cases. Of those, 43% were Syrian.

Tehran, Moscow to Launch Green Customs to Strengthen Cooperation

TEHRAN (MNA) - Islamic Republic of Iran and Russian Federation will set up a customs office entitled "Green Customs" in line with invigoration of bilateral cooperation in the field of customs.

President of the Islamic Republic of Iran Customs Administration (IRICA) Alireza Moghadasi and his Russian counterpart Vladimir Ivanovich Bulavin inked two Memoranda of Understanding (MoUs) on Friday to further expansion and development of mutual ties.

The MoU in the field of educating and training of skilled forces, the two countries customs' MoU on cooperating in customs field to tackle customs violations until 2025 and a draft agreement to identify the authorized economic activists in order to use "Green Customs" Crossing were among the MoUs signed between Iran and Russia customs officials.

During the meeting, Bulavin emphasized the need for boosting bilateral cooperation to launch "Green Customs Crossing" and said that if authorized economic agents of the two countries are identified, a new customs agreement will be launched in this respect.

Referring to the tough sanctions imposed by Western countries against Russia, he said, "Since Iran has been put under tough sanctions by the United State and the West, the two countries can cooperate with each other in order to overcome sanctions."

IRICA President, for his part, pointed to cruel sanctions imposed by the US and Western countries against Iran and Russia, and stated that although sanctions can pose a threat to economy, these threats have been turned into opportunity with the resistance of Iranian people.

Moghadasi called for further cooperation of Tehran and Moscow to counter and nullify consequences of sanctions.

The warning came two days after Israeli Prime Minister Naftali Bennett visited the United Arab Emirates (UAE), marking his second official trip to the Persian Gulf country since the two sides formally normalized their relations in 2020.

Bahrain, Morocco, and Sudan were other Arab countries that normalized their ties with Israel, all under the so-called Abraham Accords pushed by then-U.S. president Donald Trump.

The normalization deals have been a "stab in the back" for the Palestinians, while exposing an increasing level of apathy on the part of the Muslim-majority countries toward the Palestinian people's sufferings.

Recent reports suggest that Saudi Arabia is also moving in the same direction, even though the kingdom has so far refrained from officially normalizing with Israel due to domestic considerations.

Iran, which has long championed the rights of Palestinians, warned against Israel's presence in the Persian Gulf, and censured the normalization schemes. However, it has remained open to talks with the Arab countries.

Warriors Square NBA **Finals With Celtics Win**

BOSTON (Dispatches) - Stephen Curry produced a dazzling 43-point display as the Golden State Warriors battled past the Boston Celtics 107-97 to level the NBA Finals series at 2-2. With the Warriors needing a victory at Boston's TD Garden to avoid going down 3-1 in the best-of-seven series, Curry delivered one of the best performances of his glittering career to reignite Golden State's hopes of a seventh championship.

Curry had entered game four with concerns swirling over his health after suffering a knock to his foot in the Warriors' game three defeat on Wednesday.

But the 34-year-old two-time NBA Most Valuable Player emphatically laid to rest any doubts about his fitness as he single-handedly hauled Golden State back into the finals with game five back in San Francisco on Monday.

Curry finished with 43 points, 10 rebounds and four assists on a night when Golden State again struggled to find their offensive rhythm for long periods against a powerful Boston line-up. Klay Thompson added 18 points for the Warriors while Andrew Wiggins produced 17

points and 16 rebounds in a crucial contribution. Jordan Poole added 14 from the bench. "A lot of pride in our group, a lot of talk over the last 48 hours about how we can get back into this series," an elated Curry said afterwards.

"It's crazy because I still feel we can play a little bit better. But to win on the road and get home court advantage back, is big for this group. We've been here six times, we've got a lot of experience of staying confident and composed.

"I'm just thankful for everyone on our team because we brought a lot of toughness and physicality tonight. "We knew how big this game was. That five-and-a-half hour flight home got a little better after tonight."

Warriors coach Steve Kerr, meanwhile, took the bold decision to remove Draymond Green from the fray during the fourth quarter before returning him to the court for the closing passage of play.

Green again struggled on offense with only two points but finished with nine rebounds, eight assists and four steals.

Real Madrid, Barcelona, Juventus to Tour U.S. in July

MADRID (Dispatches) - LaLiga clubs Real Madrid and Barcelona along with Serie A's Juventus will visit the United States in July to play a pre-season tournament, the clubs said.

The teams will participate in the inaugural 'Football Champions Tour' with Mexican teams Club America and Deportivo Guadalajara also taking part. The five-team event will be held from

July 22-30 across Las Vegas, San Francisco, Dallas and Los Angeles. The tour marks the first time since

2019 that Real and Barcelona have returned to play in the United States, while Juventus last played there in 2018. Real were crowned LaLiga champions in the 2021-22 season as Barcelona finished second, while Italian club Juventus came fourth in Serie A.

Chelsea Confirm Christensen Departure ONDON (Dispatches) - Chelsea Loconfirmed that defender Andreas Christensen will leave the club when his contract expires at the end of June.

But the undeniable man of the hour was once again Curry, a model of clear-headed composure as bedlam raged around Boston's raucous arena.



"Just stunning," was how Kerr described Curry's performance. "The physicality out there is, you know, pretty dramatic. I mean, Boston's got obviously, best defense in the league.

"Huge and powerful at every position, and for Steph to that kind of pressure all game long and still be able to defend at the other end when they are coming at him shows you, I think, this is the strongest physically he's ever been in his career, and it's allowing him to do what he's doing.'

Boston coach Ime Udoka was left pondering what might have been. The Celtics must now win at least one more game in San Francisco -- where they won game one -- to win a record 18th NBA crown.

"Had our opportunities tonight, especially when we did have a five-, six-point lead," Udoka said. "It felt like we didn't have our best possessions, and kind of let them back in the game, whether it was turnovers or poor offense.

"It could have been an easier road, obviously, if you get the win tonight. But it is what it is. We're 2-2 now. We know we can do it. We've done it before. Keep your head up and let's go get one on the road."

A closely-fought contest saw neither side lead by more than seven points until Golden State's decisive late burst in the final minutes secured a 10-point victory.



MADRID (Dispatches) - France midfielder Aurelien Tchouameni has joined Real Madrid from Monaco, both clubs announced.

According to sources the 22-year-old has cost the Champions League and La Liga holders more than 80 million euros (\$84 million) as well as an additional 20 million euros in bonuses.

The former Bordeaux playmaker has won 10 caps since making his Les Bleus debut in September.

"Real Madrid and Monaco have agreed on the transfer of the player Aurelien Tchouameni, who will be linked to the club for the next six seasons," they said.

"Next Tuesday, June 14, at 12:00 at Real Madrid City, the presentation ceremony for Aurelien Tchouameni as a new Real Madrid player will take place after the corresponding medical examination," they added.

Madrid have also signed Chelsea centre-back Antonio Ruediger ahead of the new season but missed out on Paris Saint-Germain's Kylian Mbappe last month as he decided to stay in the French capital.



PARIS (Dispatches) - Zinedine Zidane's advisor denied that the former France great is set to replace Mauricio Pochettino as Paris St Germain coach next season.

Earlier on Friday, French radio station Europe 1 reported that Zidane would immediately take over, without citing any source.

"All these rumours that are circulating are unfounded," Alain Migliaccio, Zidane's advisor, told sports daily L'Equipe.

"To this day, I am the only person allowed to represent and advise Zinedine Zidane. Neither Zinedine Zidane nor myself have been contacted directly by the owner of PSG." PSG were not available for comment.

Pochettino, who was appointed 18 months ago, has failed to help the Ligue 1 club break new ground in the Champions League, with PSG being eliminated in the last 16 by Real Madrid this season.

They wrapped up the Ligue 1 title in April to secure their only trophy of the campaign. Zidane, 49, has been without a club since he departed Real Madrid at the end of the 2020-21 season.

Draw in **Nations League**

England, Italy

LONDON (Dispatches) - England are bottom of their UEFA Nations League group without a win after drawing 0-0 with Italy in a repeat of the Euro 2020 final on Saturday, while Germany settled for a point in a 1-1 stalemate in Hungary.

The meeting in Wolverhampton between Gareth Southgate's side and the European champions was played before just 3,000 people, largely school-children, as a punishment for the incidents that marred the Euro 2020 final between the same nations at Wembley last year. UEFA rules say a match ordered to be played behind closed doors can still be attended

by children accompanied by an adult, as happened last weekend when Hungary beat England in Budapest.

England followed that reverse by drawing 1-1 in Germany and another draw at Molineux leaves them bottom of League A, Group 3 with just two points from three outings before they host Hungary at the same venue on Tuesday in their final game of a long campaign. Mason Mount hit the bar early on for England, while Aaron Ramsdale produced a fine save to deny Sandro Tonali for an Italy side featuring just two starters who also lined up in the European Championship final.

We had two or three really good chances we need to score, but just lacked that sharpness in front of goal," said Southgate.

Roberto Mancini's Italy are rebuilding after failing to qualify for the World Cup and are top of the group after Hungary and Germany cancelled each other out in Budapest. Zsolt Nagy gave Hungary an early lead, smashing in after Manuel Neuer had palmed out a Rolland Salai header.

STUTTGART (Dispatches) - Former world number one Andy Murray secured his first victory over a top-five opponent in six years with a 7-6(4) 6-3 win over Greek top seed Stefanos Tsitsipas to reach the semi-finals of the Stuttgart Open.

The two-times Wimbledon champion stepped up his preparation for the grasscourt

major starting this month by battling through a tight opening set against world number five Tsitsipas before rolling back the years in the second set to complete the win.

The Scot's biggest win by ranking since he overcame Novak Djokovic at the 2016 ATP Finals set up a semi-final meeting with either Hungarian Marton Fucsovics or Australian Nick Kyrgios.

"I thought I did well. He served unbelievably well in the first set and I had very few chances when I was returning," the 35-year-old Murray said in his post-match interview.

"But when he was creating opportunities on my serve I stayed strong. I played a really solid tiebreak and in the second set, I served well while his dropped a little bit.

"Once I was in the rallies I felt like I was dictating a lot of the points so it was a good performance."

Murray said that he was happy to hit top gear on his preferred surface.

"I don't want to say I was the smarter player, but maybe this surface suits my style. Stefanos plays well on all surfaces but this works really nicely for my game and I'm able to use my strengths better."
