Su-35 Fighters To Arrive in Iran In Coming Months

TEHRAN (MNA)- Sukhoi Su-35 fighters will arrive in Iran early next year (The Iranian year 1402 - starting from 21 March 2023), A member of the Iranian Parliament's National Security and Foreign Policy Commission said.

Shahriyar Heidari made the announcement in an interview with Tasnim News Agency.

The Iranian lawmaker added that other Russian weapons including defense systems, missile systems, and helicopters will arrive in the country in near future.

The Sukhoi Su-35 is the designation for two improved derivatives of the Su-27 air-defense fighter. They are single-seat, twin-engine, supermaneuverable aircraft.

Nothing Can Undermine Palestine Issue

TEHRAN (PressTV) - Foreign Minister Hossein Amirabdollahian has stressed that nothing can diminish the Palestinian issue, dismissing the normalization agreements signed between a number of Arab countries and the occupying Israeli regime as "worthless".

Amirabdollahian made the remarks during a meeting with a number of high-ranking officials and representatives from Palestinian resistance groups in Damascus on Saturday night.

"Palestine and al-Quds City are the principal issues of the Muslim world. Palestine will remain the foremost issue of Muslims until a Palestinian state is formed within its historical boundaries, with al-Quds as its capital," he stated.

"The United States and its allies have unveiled various plans one after another for many years, namely the Oslo Accords, the Greater Middle East, the [so-called] Deal of the Century, and the Abraham Accords. The Palestinian nation and resistance forces have, however, managed to thwart all those plots through exemplary unity, resilience and perseverance," the chief Iranian diplomat pointed out.

Amirabdollahian said that the 11-day Operation Sword of al-Quds between the Gaza-based Palestinian resistance groups and the Israeli military in May 2021 proved that Axis of Resistance and Palestine are alive.

"Even the World Cup [in Qatar] showed that Palestine is alive, and the normalization of Arab-Israeli relations is worthless," he continued. See Page 7

TEHRAN – The value of Iran's export to the European Union (EU)'s member states rose 20 percent in the first 11 months of 2022, as compared to the same period in 2021, according to the data released by the European Union's statistics office Eurostat.

The Eurostat's data show that Iran exported commodities worth ⊕76 million to the union in the 11-month period of this year, while the figure was €12 million in the same time span of the previous year, IRNA reported. The EU's export to Iran has also risen 22 percent to €.739 billion from €.048 billion.

According to the Eurostat, the total value of trade between Iran and the European Union reached €4.715 billion in January-November 2022, while the figure was €3.86 billion in the same period of 2021.

As previously reported by Eurostat, the value of trade between Iran and the European Union reached €4.863 billion in 2021, registering a nine-percent growth compared to the previous year.

The trade between Iran and the European Union in 2020 stood at €4.458 billion.

Iran exported ⊕22 million worth of commodities to the union during January-December 2021 to register a 29-percent rise year on year.

Based on the mentioned data, the exports from Europe to the Islamic Republic in the said year also increased by five percent, standing at €3.941 billion.

Iran imported €3.745 billion worth of commodities from the European Union states in 2020, while exporting €713 million to the region.

Iran mainly exports foodstuff and livestock, beverages and tobacco, raw materials, mineral fuels, and vegetable oils to European countries, while foodstuff, beverages and tobacco, mineral fuels, vegetable oils, and chemicals are also the main products imported from the union.

In recent decades and because of several international events and conflicts that the U.S. had been involved in most of them, most political analysts and experts have claimed that the U.S. is on the verge of decline and this big power is falling and losing its grandeur and even this belief has been confirmed by many Western experts.

For centuries the U.S. has been the world economy number one and it is now losing its position to China and the U.S. is even losing its political influence and power in the world and many nations have turned their back on this arrogant country.

Recent Ukraine-Russia war may trigger the collapse of the U.S. sooner than one could have thought of it while Washington is supporting the war to make most of it either economically or politically.

A famous French expert has recently claimed that the U.S. monetary control of the world will collapse if Russia resists Washington's sanctions and survives with Chinese support during the course of the war with Ukraine.

In an interview with Le Figaro on Friday, French historian and anthropologist Emmanuel Todd said, "If the Russian economy offers long-term resistance to sanctions and manages to bleed the European economy white and manages to survive with Chinese support, US monetary control of the world will collapse and with it, the US' ability to finance its mammoth trade deficit for next to nothing."

Todd stressed that the U.S. and its European allies are involved in the war and cannot get out of it before Moscow.

"This war has become existential for the United States. It cannot get out of the conflict before Russia. They cannot let go. This explains why we are now in an openended war, in a confrontation that is bound to result in the collapse of one side or the other," Todd added.

He also recalled a piece of analysis offered by Professor John Mearsheimer, a leading politician at the University of Chicago, who argued that whereas for Russia this conflict was "existential," for the U.S. it was just another game among other countries, and that victory or defeat in it would be of little importance to the U.S.

"But this analysis is insufficient. Biden now has to hurry. America is fragile and the Russian economy's resistance is pushing the US imperial system toward the abyss. Nobody had expected the Russian economy would be able to withstand the 'economic power' of NATO," Todd said, referring to Mearsheimer's analysis. See Page 7

Iranian Oil Exports End 2022 at a High

LONDON (Dispatches) - Iranian oil exports hit new highs in the last two months of 2022 and are making a strong start to 2023 despite U.S. sanctions, according to companies that track the flows, on higher shipments to China and Venezuela.

Tehran's oil exports have been limited since former U.S. President Donald Trump in 2018 exited a 2015 nuclear accord and reimposed sanctions aimed at curbing oil exports and the associated revenue to Iran's government. Exports have risen during the term of his successor President Joe Biden, who had sought to revive the nuclear deal, and hit the highest since 2019 on some estimates. This comes despite headwinds such as a stall in those talks and competition from discounted Russian crude.

Energy consultant SVB International said Iran's crude exports in December averaged 1.137 million barrels per day, up 42,000 bpd from November and the highest 2022 figure SVB has reported based on estimates given earlier. "In comparison to the Trump administration, there hasn't been any serious crackdown or action against Iran's oil exports," said Sara Vakhshouri of SVB. "January exports were so far strong like previous months."

"Lower Chinese demand and Russia's supply to China have been a major challenge for them. Most of its oil still goes to the Far East, ultimately China. Iran also helps Venezuela to export its oil."

Adrienne Watson, a National Security Council spokesperson at the White House, said the administration's enforcement of the sanctions is robust, and "Iran's macroeconomic figures clearly bear this out."

"We have not and will not hesitate to take action against sanctions evaders, together with sanctions against Iran's missile and drone trade, and human rights violations against the Iranian people," Watson said. The Treasury Department imposed sanctions late last year on an oil smuggling ring linked to Iran's Islamic Revolutionary Guards Corps (IRGC).

Consultant Petro-Logistics, which tracks oil supply, said it was also seeing an upward trend in Iranian crude exports which, in its view, in December reached their highest level since March 2019.

Kpler, a data intelligence firm, put Iranian crude exports at 1.23 million bpd in November, the highest since August 2022 and almost on a par with April 2019's rate of 1.27 million bpd, although they slipped to just below 1 million bpd in December. See Page 7

UK Recalls Ambassador From Tehran After Spy Execution

TEHRAN (Dispatches) - In a fresh act of interference, the British Foreign Minister announced that London will temporarily recall its ambassador from Tehran to carry out some consultations over the execution of a UK-backed spy.

UK prime minister Rishi Sunak, who leveled baseless human rights claims against Tehran on Saturday, once again claimed, "Our response to Iran is not limited to today. We are reviewing further action."

Akbari, 61, was arrested in 2019 after he returned to Tehran from London, where he has relatives. Akbari had engaged with British spies and received cash and other benefits from MI6, including a British passport, €1.8mn, £265,000, and \$50,000.

The ex-official Akbari was executed on Saturday Iran's judiciary sentenced him to death on charges of spying for UK MI6.

The trial of Akbari was held in the presence of his lawyer and the death sentence was issued based on "substantiated evidence".

Iran's Intelligence Ministry in a statement on Wednesday afternoon provided further details about Akbari and his arrest.

Iran Accuses U.S. of **Systematic Rights Violation**

TEHRAN - Iran has slammed the death of Keenan Anderson, the cousin of a co-founder of the Black Lives Matter movement, after he was repeatedly tasered by police officers in Los Angeles, saying the United States must be held to account for systematic violation of human rights.

Iranian Foreign Ministry spokesman Nasser Kanaani said that the U.S. government must be held accountable for this "inhumane crime" and its irresponsibility vis-à-vis the repetition of gross and systematic violations of human rights in the country, particularly the rights of minorities and people of color.

Anderson, 31, cousin of Patrisse Cullors, died at a hospital in Santa Monica, California, after suffering a cardiac arrest following the incident on the afternoon of January 3 in Los Angeles' Venice neighborhood.

According to reports, the school teacher was repeatedly tasered by Los Angeles police officers and restrained following a traffic accident.

In a 13-minute body-cam footage released by LAPD on Wednesday, Anderson is seen begging for help as multiple officers hold him to the ground and one officer presses his elbow along with his body weight onto his neck.



"They're trying to George Floyd me. They're trying to George Floyd me," Anderson can be heard saying in the footage, in reference to the US police killing of Floyd in May 2020 in Minneapolis that sparked racial justice protests around the world.

Kanaani further lambasted the U.S.' hypocritical policies on meddling with other countries' affairs, saying, "The American regime, which hypocritically interferes in the internal affairs of other countries and sheds crocodile tears in order to achieve political goals, remains silent regarding the extreme violence and discriminatory and hate-mongering actions of the country's police against people of color."

The Iranian spokesperson added that the US police's brutal action in murdering Anderson, which was repetition of Floyd's heinous killing, once again shocked the world.

A 2021 study in the medical journal The Lancet recorded 30,800 deaths from police violence across the country between 1980 and 2018, far higher than estimates offered by the US National Vital Statistics System.

Next Year Budget Bill Allocates \$775m to Transport, Urban Development Ministry

TEHRAN (MNA) – The budget bill for the next Iranian calendar year 1402, which starts on March 21, has allocated 310 trillion rials (about \$775 million) to Transport and Urban Development Ministry.

Of the mentioned figure, more than 150 trillion rials (about \$374 million) is allocated to the Construction and Development of Transportation Infrastructure Company (CDTIC) to complete railway and freeway projects.

President Ebrahim Raisi submitted the administration's draft of the national budget bill for the next year to the Majlis on Wednesday.

The president mentioned stable economic growth, people's livelihood, observing justice, and efficiency of the government system as the main approaches of the budget bill and stated: "In this bill, the establishment of a progress and justice fund in all provinces is foreseen so that the development credits of the provinces are paid systematically."

Raisi also said, "We have included the important points considered by the Leader in the general policies of the Seventh National Development Plan (2022-2026) in the drafting of the 1402 budget bill." As reported, reforming the budget structure, creating transparency, attracting governmental and private sector investments for completing semifinished projects, and implementing the government's integrated financial management system are highlighted in the budget bill for the next year.

Petchem Investors Urged to Tap Domestic Capabilities

TEHRAN (Shana) -- The CEO of the National Petrochemical Company (NPC) addressed the executives and investors of petrochemical projects, and said: "Try to use the abilities, knowledge and capacities of domestic companies more than before."

According to NPC, Morteza Shahmirzaei emphasized the need to trust the capacities available inside the country to provide technical know-how, goods and equipment for the petrochemical industry, and stated: "Petrochemical Research and Technology Company (PRTC) is ready to provide technical know-how and catalysts needed in petrochemical projects and fortunately there are capable companies to provide for other needs."

Herbal Export Can Be Increased

TEHRAN (MNA) - The chairman of the Union of Medicinal Plants Exporters of Iran said the country's export of medicinal plants can be increased through compliance more with the world standards.

Mohammad-Ali Rezaei Kamal-Abad stated that world standards are increasing due to the health-oriented consumption of herbal products, and failure to comply with these standards will lead to the return or destruction of these products.

"In the past years, poisons have entered the country, which are not only not used in other countries, but have also caused water and soil pollution in our country", he lamented.

Referring to the importance of agricultural product export standardization, he added: "Standardization is done in our country, but this standardization is not up-to-date. With the coordination of ministries, expenditure and updating of information can help to standardize agricultural products and develop the export of these products", he commented.

As previously announced by Rezaei Kamal-Abad, the value of medicinal plants exported from the country in the past Iranian calendar year 1400 (ended on March 20, 2022) was nearly 600 million dollars, but in the first nine months of this year, the value of the export of medicinal plants has decreased by 50 percent compared to the same period last year.

The budget bill for the year 1402 is printed and distributed among the members of the parliament after its presentation and they will have 10 days to submit their proposals and reviews on the budget to relevant specialized committees.

Specialized committees will also have 15 days to submit their reviews to the parliament ad hoc budget review committee (known as Talfiq Committee). Talfiaq Committee is a body consisting of MPs from different committees which is established each year to study the national budget bill. is at least twice as much as Europe.

According to global statistics, from 2020 to 2022, the turnover in the export of medicinal plants was more than 30 billion dollars, but of this amount, the export of medicinal plants from Iran was less than five percent, he further lamented.

Bolsonaro's Ex-Justice Minister Arrested

BRASILIA (Dispatches) - Brazil's former Justice Minister Anderson Torres, who was in charge of public security in Brasilia during the invasion of government buildings a week ago, was arrested in Brasilia on suspicion of "omission" and "connivance".

Torres was arrested after returning to Brazil on Saturday. He had been on vacation in Florida, the same U.S. state his ex-boss, former right-wing President Jair Bolsonaro, had traveled to after losing last year's election. Demosthenes Torres, one of Torres' lawyers, confirmed the arrest to Reuters.

The ex-minister said on Thursday that evidence produced by police was taken out of context when his home was raided this week.

Russian Missile Hits Apartment Block in Ukraine's Dnipro



KYIV (Dispatches) - Russia unleashed a major missile attack on Ukraine on Saturday, smashing a nine-storey apartment block in the city of Dnipro, killing at least five people and striking vital energy facilities, officials said. Ukraine's energy minister said the coming days would be "difficult" as months of Russian bombardment of the power grid threaten the supply of electricity, running water and central heating at the height of winter.

In the east-central city of Dnipro, 20 people were rescued from an apartment block where an entire section of the building

had been reduced to rubble, sending smoke billowing into the sky, the deputy head of Ukraine's presidential office said. "Tragedy. I've gone to the site We will be going through the rubble all night," said Borys Filatov, mayor of the rocket-making city on the Dnipro River.

Five people were killed and at least 60 people, including 12 children, were also wounded in the attack, with more people were still trapped under the rubble, the regional governor said.

Another person was killed and one wounded in the steel-making city of Kryviy Rih where six houses were damaged in President Volodymyr Zelenskiy's hometown, mayor Oleksandr Vilkul said.

In his nightly speech, Zelenskiy appealed to the West to supply more weapons to prevent further deaths from what he described as "Russian terror"

"What's needed for this? The kind of weapons that our partners have in stockpiles and that our warriors have

come to expect. The whole world knows what and how to stop those who are sowing death," he said.

Saturday's attack comes as Western powers consider sending battle tanks to Kyiv and ahead of a meeting of Ukraine's allies in Ramstein in Germany next Friday where governments will announce their latest pledges of military support.

On the front lines in the east, Ukraine said its forces were battling to hold onto control of the small town of Soledar where Russia has sacrificed large numbers of troops and resources to try to secure some kind of advance after months of setbacks.

UK Pledges to Provide Battle Tanks to Ukraine

LONDON (Dispatches) - The United Kingdom Prime Minister Rishi Sunak is pledging to provide tanks and artillery systems to Ukraine amid renewed missile attacks by Russia on Ukrainian cities.



Sunak offered to send Challenger 2 tanks and other artillery systems in a call with Ukrainian President Volodymyr Zelenskyy on Saturday, the British leader's Downing Street office said in a statement.

The statement did not say how many or when the tanks would be delivered to Ukraine.

Sunak said the tanks were a sign of the UK's "ambition to intensify our support to Ukraine", according to a readout of a phone call with Zelenskyy.

Thousands of Tunisians Rally Against President

TUNIS (Dispatches) - Protesters pushed through police barricades as they demonstrated against Tunisian President Kais Saied's seizure of near total power in central Tunis, the anniversary of a key date in the 2011 revolution that brought democracy.

The opposition remains divided in its quest to push Saied from office and Saturday's protests are split among several different groups that police said should demonstrate in separate, specified areas.

However, protesters said they planned to defy the police instructions and march towards the central Habib Bourguiba Avenue, the traditional site of rallies, and they pushed through barricades, a Reuters reporter there said. "We were on Bourguiba in January 2011 when Saied was not present... today he is closing Bourguiba to us. We

North Korea Slams UN Chief Over Nuclear Criticism

SEOUL (Dispatches) - North Korea slammed United Nations chief Antonio Guterres on Saturday over his recent description of Pyongyang's nuclear programs as a "clear and present danger".

Military tensions on the Korean peninsula rose sharply last year as the North conducted sanctions-busting weapons tests nearly every month, including firing its most advanced intercontinental ballistic missile (ICBM).

North Korean leader Kim Jong Un also recently called for an "exponential" ncrease in Pyongyang's nuclear arsenal and new ICBMs to counter what it termed US and South Korean hostility.

Guterres told the UN Security Council on Thursday the onus was on Pyongyang to resume talks, which collapsed in 2019 when nuclear negotiations between Kim and then-US president Donald Trump broke down in Hanoi.

"The unlawful nuclear weapons programme being pursued by the Democratic People's Republic of Korea is a clear and present danger, driving risks and geopolitical tensions to new heights," Guterres told a Security Council meeting on the rule of law that was chaired by Japanese foreign minister Yoshimasa Hayashi.

Pyongyang released a statement late on Saturday in which it accused Guterres of having "typical double-standards" and committing the "dangerous act of lestroying the trust of the world community in the UN"

The statement, attributed to Jo Chol Su, a senior official in Pyongyang's foreign ministry, also said Guterres was ignoring a "reckless arms buildup" by the United States that was "constantly bringing all sorts of nuclear strike means to the Korean peninsula and the region". Jo also accused Japan of having "no moral and legal qualification" to be part of the UN Security Council because

of its wartime and colonial past. Pyongyang's statement, carried by the official Korean Central News Agency, reiterated that the North will never give up its nuclear weapons.

China Set for Historic Demographic Turn HONG KONG (Dispatches) - Living under

HONG KONG (Dispatches) - Living under China's stringent COVID-19 restrictions for the past three years had caused Zhang Qi enough stress and uncertainty to consider not having babies in the country.

When China abruptly dismantled its "zero COVID" regime last month to let the virus spread freely, the balance tilted to a definite "No", the Shanghai-based e-commerce executive said.

Stories about mothers and babies not being able to see doctors as medical facilities were overwhelmed by COVID infections were the final straw for Zhang.

"I heard that giving birth at a public hospital is just horrific. I really wouldn't consider having a baby," the 31-year-old said.

A glimpse of the scars caused by the pandemic to China's already bleak demographic outlook may come to light when it reports its official 2022 population data on Jan. 17.

Some demographers expect China's population in 2022 to post its first drop since the Great Famine in 1961, a profound shift with far-reaching implications for the global economy and world order.

New births for 2022 are set to fall to record lows, dropping below 10 million from last year's 10.6 million babies - which were already 11.5% lower than in 2020.

"With this historical turn, China has entered a long and irreversible process of population decline, the first time in China and the world's history," said Wang Feng, professor of Sociology at University of California. "In less than 80 years China's population size could be reduced by 45%. It will be a China unrecognisable by the world then."

China's total population increased by 480,000 to 1.4126 billion in 2021. The United Nations predicts China's population will start to decline this year when India overtakes it as the world's most populous country.

U.N. experts see China's population shrinking by 109 million by 2050, more than triple the decline of their previous forecast in 2019.

While nine of the 10 most populous nations in the world are experiencing declines in fertility, China's 2022 fertility rate of 1.18 was the lowest and well below the 2.1 OECD standard for a stable population.

The country, which imposed a one-child policy from 1980-2015, officially acknowledged it was on the brink of a demographic downturn last year, when the National Health Commission said the population may start declining before 2025.

In October, President Xi Jinping said the government would enact further policies to boost the country's birth rate.

Since 2021 authorities have introduced measures including tax deductions, longer maternity leave, enhanced medical insurance, and housing subsidies to incentivize people to have more babies. Their impact so far has been lacklustre.

Online searches for baby strollers on China's Baidu dropped 17% in 2022 and are down 41% since 2018, while searches for baby bottles are down more than a third since 2018. In contrast, searches for elderly care homes surged eight-fold last year.

The reverse is playing out in India, where Google Trends shows a 15% year-on-year increase in searches for baby bottles in 2022, while searches for cribs rose almost five-fold.

The financial burden of children's education, some of the most stressful college entrance exams in the world and a nursery enrollment of only around 5.5% for children under 3 years - far lower than the OECD average - are key factors affecting the fertility rate, the YuWa Population Research think tank said this month.

Why Japan Is Seeking Military Ties Beyond Its U.S. Ally TOKYO (Dispatches) - Before meeting President

TOKYO (Dispatches) - Before meeting President Joe Biden in Washington D.C., Japanese Prime Minister Fumio Kishida visited Italy, France, Britain and Canada, in part to forge security ties that could help it fend off China, North Korea and Russia.

In June, Japan's defense minister at the time, Nobuo Kishi, said his country was surrounded by nuclear-armed nations that refused to adhere to international norms of behaviour.

In the wake of Moscow's attack on Ukraine, Kishida has described security in East Asia as "fragile." At the top of Japan's threat list is China, which it worries could attack Taiwan or nearby Japanese islands. Chinese military activity is intensifying around the East China Sea, including joint air and sea drills with Russia. At the same time, North Korea has fired missiles into the Sea of Japan, and in October lobbed an intermediate-range missile over Japan for the first time since 2017.

For the past seven decades, Japan, which gave up the right to wage war after its defeat in World War Two, has relied on the United States for protection.

In return for its promise to defend the country, the U.S. gets bases that allow it to maintain a major military presence in East Asia.

Japan hosts 54,000 American troops, hundreds of military aircraft, and dozens of warships led by Washington's only forward-deployed aircraft carrier.

As China's military power grows alongside its economy, the regional power balance has shifted in Beijing's favor. China's defense spending overtook Tokyo's two decades ago and is now more than four times larger. Encouraged by the United States, Japan in December unveiled its biggest military build up since World War Two, with a commitment to double defense spending to 2% of GDP within five years.

That will include money for missiles with ranges of more than 1,000 kilometres (621 miles) that could strike targets in China.

Beijing, however, is expected to continue expanding its military capabilities, and is likely to field ever more sophisticated weapons.

For that reason, and again with Washington's support, Japan is seeking new security partners to back it up both militarily and diplomatically.

That effort, for now, has focused on countries that are also strong U.S. allies, including Australia, Britain and France. Tokyo is also looking for closer security ties with India, which since 2004 has met regularly with Japan, the United States and Australia to discuss regional diplomacy as a member of the Quad group.

In London on Jan. 11, during his tour of fellow G7 countries, Kishida signed a reciprocal access defence agreement with British Prime Minister Rishi Sunak that will make it easier for the two countries to conduct military drills in each other's territory.

Japan is chair of the G7 this year and will be host to its leaders in Hiroshima in May.

As Britain tilts more towards Asia, it has sought closer defence ties. In 2021, it sent the new HMS Queen Elizabeth aircraft carrier on a visit to Japan, and announced that it would permanently deploy two warships in Asian waters.

In December, Japan announced it would build a new jet fighter with Britain and Italy, its first major international defence project with a country other than the United States since the end of World War Two. Since the start of the Ukraine war, Japan's sometimes-troubled relationship with neighbouring South Korea has also improved, opening up the possibility of closer military cooperation between the two U.S. allies.

CAIRO (Dispatches) - OPEC+ is facing "volatile prospects" in oil markets both in supply and demand, UAE energy minister Suhail al-Mazrouei told Asharq TV.

He said this was due to European sanctions on Russian crude taking effect in addition to China lifting its "zero-COVID" policy. OPEC+ production capacity was down 3.7 mln bpd due to fewer investments in the oil sector, Al-Mazrouei said. He also said UAE is taking preemptive steps to compensate for the reduced oil production capacity in some countries by bringing forward its five million barrel per day oil production capacity expansion to 2027 from a previous target of 2030.

Russian Oil Shipped to Asia in Chinese Supertankers Amid Ship Shortage

NEW DELHI (Dispatches) - At least four Chinese-owned supertankers are shipping Russian Urals crude to China, according to trading sources and tracking data, as Moscow seeks vessels for exports after a G7 oil price cap restricted the use of Western cargo services and insurance. China, the world's top oil importer, has continued buying Russian oil despite Western sanctions, after Russian President Vladimir Putin and Chinese leader Xi Jinping launched what they called a no-limit partnership before the war in Ukraine.

The sources said a fifth supertanker, or very large crude carrier (VLCC), was shipping crude to India, which like China has continued buying Russian oil sold at a discount as many Western buyers turn to other suppliers.

All five shipments were scheduled between Dec. 22 and Jan. 23, according to the sources and Eikon ship tracking data.

The G7 price cap introduced in December allows countries outside the European Union to import seaborne Russian oil but it prohibits shipping, insurance and re-insurance companies from handling Russian crude cargoes unless sold for below the \$60 cap.

With Urals prices well below the price cap, the business of buying and trading Urals is essentially legitimate," said an executive with a Chinese firm involved in the shipments.

As the United States and its allies tried to choke off Moscow's energy revenues to limit its ability to fund the Ukraine war, Russia quickly diverted oil exports from Europe last year, mainly to Asia. The

longer voyages, heavy discounts and record-high freight rates ate into profits but the use of supertankers on the Asian routes may now cut shipping costs.

The Russian energy and transport ministries declined to comment. China's Foreign Ministry did not respond to a request for comment, although Beijing has previously called the Western sanctions on Russia illegal.

Indian Oil Minister Hardeep Singh Puri said at a press briefing on Thursday that India would buy oil from wherever it could secure the cheapest price.

Industry sources say Indian refiners are securing a discount of \$15-\$20 per barrel on Russian oil on a delivered basis compared to Brent.

Russia is sending Urals from its Western ports for transhipment to supertankers Lauren II, Monica S, Catalina 7 and Natalina 7, all Panama-flagged ships bound for China, while the Sao Paulo is already approaching India, according to three trading sources and Eikon data.

Based on Eikon data and public maritime databases, Lauren II is managed by China's Greetee Co Ltd and owned by China's Maisie Ltd, Catalina 7 is owned by Hong Kong's Canes Venatici Ltd and Natalina 7 by Hong Kong's Astrid Menks Ltd with both managed by China's Runne Co Ltd, while Monica S is owned

by China's Gabrielle Ltd and managed by Derecttor Co Ltd. The Sao Paulo is owned and managed by Cyprus-based Rotimo Holdings Ltd.

Reuters was unable to immediately contact the owners and managers because of a lack of public information about them.

The executive with the Chinese firm involved in the shipments estimated a total of 18 Chinese supertankers and another 16 Aframax-sized vessels could be used for shipping Russian crude in 2023, enough to transport 15 million tonnes a year or about 10% of total Urals exports.

A VLCC can carry up to 2 million barrels, a Suezmax vessel up to 1 million barrels and Aframax up to 0.6 million barrels.

While most Russian crude is now heading to China, India and Turkey in

India to Seek Easing of EU Steel Quotas, Tariffs in Trade Talks

NEW DELHI (Dispatches) - India will seek an easing of European Union steel import quotas and tariffs in talks for a new trade deal as Indian steelmakers struggle to sell the alloy in one of world's big markets, a senior government official said.

the end of 2023. The two sides previously launched talks in 2007, but they were frozen in 2013 due to a lack of progress. "India is likely to take up the issue of EU's steel import quota and their high tariffs during the free trade negotiations," said the official with direct knowledge of the matter. The official declined to be named as India's plan to take up the issue with the EU is confidential.

India's steel and trade ministries did not immediately reply to a Reuters email seeking comment. The EU uses a system of quotas and tariffs to protect its steelmakers. Other than India, the main exporters

of steel to the EU are China, Russia, South Korea, Turkey and Ukraine. "Secondary steel manufacturers have raised the issue of EU's export quota and tariffs coming in the way

of India's steel exports to the EU," the official said. In its negotiations with the EU, India is also expected to express New Delhi's concerns over EU countries'

proposed carbon dioxide emissions tariff on imports of polluting goods such as steel and cement. 'All these countries in order to protect their industries, force their standards," the official said.

Separately, India has launched four investigations against Chinese stainless steel imports to probe potential dumping", the official said.

Indonesia to Stop Exporting Copper Ore Starting Mid-2023

JAKARTA (Dispatches) - Indonesia will stop exporting copper ore this year to increase domestic processing of the metal and boost exports of processed products, Indonesian President Joko Widodo said.

Indonesia prohibited exports of its nickel ore on January 1, 2020. The ban was considered illegal by the World Trade Organization (WTO) and the EU, since nickel is used in stainless steel production involving thousands of workers

throughout the world. In December, Widodo also announced that the country would stop exports of bauxite ore starting mid-2023 to boost domestic processing.

'We have not given up after losing in the WTO on the nickel issue. We will go even further than just banning bauxite exports. In the middle of the year, we will stop exports of copper ore," Widodo was quoted as saying by Detik news outlet.

According to Detik, the president plans to ban exports of raw ore in an effort to get more added value for processed minerals and increase profits from their exports.

Yellen Warns of **U.S. Default Risk By Early June**

WASHINGTON (Dispatches) - U.S. Treasury Secretary Janet Yellen said the United States will likely hit the \$31.4 trillion statutory debt limit on Jan. 19, forcing the Treasury to launch

extraordinary cash management measures that can likely prevent default until early June.

"Once the limit is reached, Treasury will need to start taking certain extraordinary measures to prevent the United States from defaulting on its obligations," Yellen said in a letter to new Republican House of Representatives Speaker Kevin McCarthy and other congressional leaders. She urged the lawmakers to act quickly to raise the debt ceiling to "protect the full faith and credit" of the United States.

"While Treasury is not currently able to provide an estimate of how long extraordinary measures will enable us to continue to pay the government's obligations, it is unlikely that cash and extraordinary measures will be exhausted before early June," the letter said.

Republicans now in control of the House have threatened to use the debt ceiling as leverage to demand spending cuts from Democrats and the Biden administration. This has raised concerns in Washington and on Wall Street about a bruising fight over the debt ceiling this year that could be at least as disruptive as the protracted battle of 2011, which prompted a brief downgrade of the U.S. credit rating and years of forced domestic and military spending cuts.

The White House said on Friday after Yellen's letter that it will not negotiate over raising the debt ceiling.

"This should be done without conditions," White House spokesperson Karine Jean-Pierre told reporters. "There's going to be no negotiation over it."

House Republicans are planning to move a "debt prioritization" measure by the end of March that would call on the U.S. Treasury to continue making certain payments once it reaches the debt ceiling, but details have not been finalized, a person familiar with the plan told Reuters. The proposal was first reported by the Washington Post.

The Republican plan will call on the Treasury Department to keep making interest payments on the debt, the Post reported, citing sources. It may also stipulate the Treasury should continue making payments on Social Security, Medicare and veterans benefits, and fund the military, the newspaper said.

The plan was part of a private deal reached this month to resolve the standoff between right-wing hardliners in the House and McCarthy over his election as House speaker, the Post said.

Declining Exports Hurting Pakistan Economy



KARACHI (Dispatches) - A detailed report of Pakistan Businesses Forum (PBF) stated that despite Pakistan's myriad political issues, the declining trend in exports has had a long-term negative impact on the country's economy.

Due to decreasing exports and the government's failure to end the economic crisis, approximately seven million people in Pakistan's textile and textile-related industries have lost their jobs. Dr Urwa Elahi, Additional Secretary General for Research at the PBF, said that Pakistan is already behind in achieving financial equilibrium because the volume of its imports is much higher than the level of its exports, which is hurting the country's overall economic condition.

nickel ore exports, saying it was trying to hamper the country's economic development through neocolonial practices.

"The EU includes countries that colonized Indonesia in the past. And now the position of the EU is almost identical to the one that existed during the Dutch colonial period in Indonesia... Restricting opportunities for the economic growth is the tricky practice that does not belong in this century," the president added.

At the same time, Indonesian Investment Minister Bahlil Lahadalia noted that the country also intended to put restrictions on building nickel plants so as to focus more on green industry.

"Restricting building of plants is a form of the government's care for developing products focused on green energy and green industry," the minister was quoted by Detik as saying.

In October, Lahadalia said that the country was looking into the possibility of establishing a cartel, similar to the Organization of the Petroleum Exporting Countries (OPEC), for nickel and other key metals. The goal of such a cartel would be to protect the country's metal industry and economy, according to the minister.

The crisis in the balance of payments is getting worse by the day because exports haven't improved and financial planners are trying to control imports with half-hearted measures.

There are many reasons why exports haven't increased, but it appears that most of them are not addressed in the right way, leaving the export industry stuck in the mud.

Dr Urwa Elahi stated that a structural flaw in the country's economic practices necessitates a complete overhaul, which must be completed quickly, and that it will be difficult to increase export volumes.

Exports fell for the second month in a row, falling 18.3% from \$ 2.9 billion a year earlier, proving that Pakistan's economy is consistently shrinking.

In contrast, imports increased 11.3% to \$ 5.25 billion in November, resulting in a \$ 2.88 billion monthly trade deficit. Although the coalition government is credited with reducing the annual trade deficit, many economists are of the opinion that the fictitious strategies implemented by the current finance minister may cause long-term harm to the national economy.

Police Seize War Ammo Cargo in Northwest Iran

TEHRAN (IP) - The head of the Judicial Department of Western Azerbaijan Province, northwestern Iran, reported the seizure of a cargo consisting of weapons and live bullets.

Naser Atabati said on Sunday that the cargo seized 335 rifles and 5,000 live bullets. He said that despite the seizure of 1,261 weapons of different types in the borders of Iran during the 75-day time span of the recent unrest in the country, 60 kg of C4 and TNT explosives also were discovered. Weapons have been entering the country from the eastern and western borders of Iran in recent days to be distributed among the rioters who instigated the recent unrest in Iran. From late September, some parts of Iran, including the capital Tehran, witnessed unrest from the beginning of which the footprint of the foreign-backed media was clear.



Why Malaysia Is Considering a Ban on Palm Oil Exports to EU

KUALA LUMPUR (Dispatches) - Malaysia, the world's second-largest palm oil producer, said it might stop palm exports to the European Union after the bloc imposed additional import restrictions on the edible oil due to concerns over deforestation.

Malaysia and Indonesia have for years been at loggerheads with the European Union over curbs on imports of palm oil, which the two countries say are trade barriers and protectionist measures for the bloc's domestic oilseed industries.

The EU deforestation regulation is in addition to an EU renewable-energy directive, announced in 2018, that requires the phasing out of palm-based transportation fuels by 2030.

The bloc has also set a separate safety limit on food contaminant 3-MCPD esters for palm oil compared to soft oils derived from crops such as soybean, canola and sunflower.

Indonesia and Malaysia, which account for 85% of the world's palm oil exports, have filed separate World Trade Organisation suits against the EU over the renewable-energy directive.

The palm oil producers say they have taken steps to meet EU requirements, including stepping up their national sustainable palm oil certification standards and improving environmental protection and food safety standards, but that the bloc keeps imposing new restrictions.

EU officials say their regulations do not target any one country and are aimed at ensuring that commodity production does not further drive deforestation and forest degradation.

Bursa Malaysia's benchmark crude palm oil futures have yet to react to Malaysia's proposal, although some traders said they see it as a bearish signal.

Some in the palm industry view the proposed ban as a knee-jerk reaction that will hurt the sector, and others laud Malaysia for putting its foot down.

Malaysia said it will discuss with Indonesia the possible ban and other strategies to tackle the EU measures, as both have agreed to increase cooperation to fight "discrimination" against the commodity.

It is not clear whether Malaysia is considering a direct ban on exports to the European Union or enacting tariffs.



The EU accounts for 9.4% of Malaysia's export volume in 2022. Malaysian Palm Oil Board data indicates that exports to the 27-member bloc have been declining since 2015.

In 2022, Malaysia's exports to the EU fell 10% from the previous year to 1.47 million tonnes. That is a 40% plunge from 2.43 million tons in 2015.

The Malaysian Biodiesel Association last year urged industry officials to come to terms with a steady decline in shipments of palm-based biofuels to the EU

The palm oil industry makes up about 5% of Malaysia's economy. Malaysia has in recent years actively explored new markets to offset losses from Europe, including food-importing countries in the Middle East, Central Asia and North Africa.

Several publicly-listed Malaysian palm oil companies, however, have established refineries in Europe and an export ban would disrupt their operations.

Jordan Truckers' Strike **Exposes Woes of Impoverished South**



MAAN (Dispatches) - Striking Jordanian trucker Suleiman Abu al-Zait spent several long nights on a national highway along his native city of Maan, manning picket line that created havoc to overland trade.

"Diesel is my lifeline," said 54-year-old Abu al-Zait, who has seen his livelihood thrown into jeopardy by high fuel price rises since Russia invaded Ukraine.

The month-long sit-in cost Jordan tens of millions of dollars in losses when it paralysed unloading at the Red Sea port of Aqaba, according to officials and industrialists.

The stoppage petered out late last year, after a security clampdown to stop disgruntled Bedouin vouths from desert hamlets near Maan throwing stones at tourist coaches and trailers.

The crackdown led to four deaths among security forces and one man whom authorities said was a militant fugitive, as well as scores of injuries and hundreds of arrests.

It was the latest bout of unrest in Maan, a poor tribal stronghold about 250 km (156 miles) south of the capital. Its location between Aqaba and a main pilgrimage route along the old Hejaz railway to Mecca had made it an important transport hub - and a cross-current of crime, smuggling and Bedouin disaffection. Known for its defiance of central authority, the southern region around Maan has repeatedly erupted into violent protests in recent years against International Monetary Fund-backed reforms to cut fuel subsidies. Fuel price rises, combined with high taxes and spiralling food costs in a nation that imports most goods, has made life unaffordable for many. "Spare parts, motor oil and operating costs have gone up - this is putting pressure on us," said Salamah Abdullah, a truck owner in Maan. "A truck used to have value. In better times you would put the trailer in front of your house to boast in front of people. Now it's like you have a bicycle." Though adamant that diesel price cuts would imperil reforms crucial for fiscal prudence, the government sought to meet drivers' demands half-way by raising rates they could charge for commercial haulage and transport. "We seek in all directions to ease the intensity of the economic situation on citizens," Interior Minister Mazen Farrayeh said after troops quelled the December rioting. Like many Arab states, Jordan has in the last decade seen widespread unrest as it reduced food and fuel subsidies. Its aid-dependent economy - already reeling from \$40 billion public debt and high unemployment - is seeing its once-bustling transit business to neighbours Iraq and Saudi Arabia shrink.

Tesla Extends Price Cuts to U.S., Europe to Drive Demand

NEW YORK (Dispatches) -Tesla has slashed prices on its electric vehicles in the United States and Europe by as much as 20%, extending a strategy of aggressive discounting after missing Wall Street estimates for 2022 deliveries.

The move, which prompted a 4.5% fall in Tesla's shares in pre-market U.S. trade,

came after CEO Elon Musk warned that the prospect of recession and higher interest rates meant it could lower prices to sustain volume growth at the expense of profit.

The lower pricing across Tesla's major markets marks a reversal from the strategy the automaker had pursued through much of 2021 and 2022 when orders for new vehicles exceeded supply. Musk acknowledged last year that prices had become "embarrassingly high" and could hurt demand.

More stable cost inflation was also a factor in reducing prices, said a spokesperson for Tesla Germany, confirming price cuts in its top European market.

The U.S. price cuts, announced late Thursday on its global top-sellers the Model 3 sedan and Model Y crossover SUV, were between 6% and 20%, Reuters calculations showed.

The basic version of its Model Y now costs \$52,990, down from \$65,990 previously.

That is before an up to \$7,500 federal tax credit that took effect for many electric vehicle models at the start of January. Following is a table of the price cuts by model in Germany and the United States:

The cuts may make EV cars affordable to people who may have been previously priced out of the market.

In France, customers buying the Model 3 for 44,990 euros (\$48,773) will now get a further price reduction through a government subsidy of 5,000 euros. The threshold for the EV scheme is 47,000.

"This should really boost 2023 (Tesla) volumes," Gary Black, a Tesla investor who has remained bullish on the company and its prospects through the recent, sharp share price decline, said in a tweet. 'It's the right move.'

Still shares in U.S. pre-market trading were lower, as investors worried the move might erode bumper margins, particularly as competition intensifies.

"Tesla is an outlier because it's still got eye watering valuations when it comes to the number of cars that it actually sells. But ultimately there are all the other providers that sell a hell of a lot more cars overall," said Michael Hewson, chief market analyst at CMC Markets UK.

Some users on Tesla fan forums online also complained the price cuts disadvantaged those who had recently bought their vehicle, leaving them with a lower second-hand value. "Just reducing 10,000 euros like that - definitely makes you feel that you just paid far too much," one user wrote on a 'Tesla Drivers and Friends' forum. In China, where Tesla cut prices last week by 6-13.5%, owners protested at delivery centres, calling for compensation.

The Iranian oil ministry did not respond to a request for comment on exports. Iran's draft state budget is based on even higher shipments of 1.4 million bpd, the semiofficial Fars news agency reported this week.

China is Iran's biggest customer. To evade sanctions, most of Iran's crude exports to China are rebranded as crude from other countries, according to analysts including FGE. Iran in the past has said documents were forged to hide the origin of Iranian cargoes

Also, Iran last year expanded its role in Venezuela, also under U.S. sanctions, sending supplies of light oil for refining and diluents to produce exportable crude grades.

There is no definitive figure for Iranian oil exports and estimates often fall into a wide range. Tanker-tracking companies use various methods to track the flows. including satellite data, port loading data and human intelligence. Iran generally does not release figures.

According to another analyst, Vortexa, China's December imports of Iranian oil hit a new record of 1.2 million bpd, up 130% from a year earlier.

"Most of these shipments found home in Shandong, where independent refiners have turned to discounted grades since the second half of 2022 amid sluggish

domestic demand and depressed refining margins," the company said.

The press department of China's Foreign Ministry, in response to a request for comment, said: "The legitimate and reasonable cooperation between China and Iran under the international legal framework deserves respect and protection," without directly addressing Reuters query on China's record Iranian oil purchases.

Vortexa said supply of Russian Urals, the main competing grade to Iranian oil, fell in December - when a price cap on Russian crude exports and European Union ban created uncertainty for buyers.

A revived nuclear deal would allow Iran to boost sales to former buyers like South Korea and Europe.

Still, talks have been at a stalemate since September, and Washington's special envoy for Iran said in November Tehran's crackdown on anti-government protesters and the sale of drones to Russia have turned Washington's focus away from the deal. Following Trump's removal of the United States from the nuclear deal and reimposition of sanctions, Iran's crude exports fell back to as little as 100,000 bpd at times in 2020 from over 2.5 million bpd in 2018, according to tanker trackers.

Warriors Rout Spursin Front of Record NBA Growd OS ANGELES (Dispatches) - The Golden State Warriors were the stars of the party

in San Antonio, cruising to a 144-113 NBA victory over the Spurs before a record crowd at the Alamodome.

Jordan Poole led the defending champion Warriors with 25 points off the bench, and Donte DiVincenzo added 22 as Golden State's reserves came up big.

They weren't the names that attracted a raucous crowd of 68,323 to the Alamodome - the Spurs' home from 1993 to 2002 before their move to the AT&T Center arena.

But that hardly mattered as fans celebrated both teams and the sheer size of the crowd - which shattered the previous record attendance for a regular-season NBA game of 62,046 for a showdown between Michael Jordan's Chicago Bulls and the Atlanta Hawks at the Georgia Dome on March 27, 1998.

The Spurs played the game at their old home as part of the celebrations of the franchise's 50th anniversary season.

Old-school Spurs fans relished a chance to return to the 'Dome, but plenty of those in the crowd were drawn by Warriors star Stephen Curry and his teammates.

Curry scored 15 points on six-of-12 shooting. Klay Thompson and Andrew Wiggins had 16 apiece as eight Warriors players scored in double figures.

It was a morale-boosting away win for the Warriors, who have struggled mightily on the road this season.

And it was an emotional night for Warriors coach Steve Kerr, who played four seasons in San Antonio and won two titles with the Spurs.

"Just the presentation of the game was spectacular," said Kerr, who received a huge cheer before the game.

"To get an ovation from 68,000 fans gives you chills," Kerr said. "Tonight was a great

Kilde Storms to Wengen Downhill Win

WENGEN (Dispatches) - Norway's Aleksander Aamodt Kilde claimed back-to-back wins in Wengen, beating Swiss Marco Odermatt in the men's World Cup downhill a day after winning the super-G.

Kilde, also a winner in the downhill at the Swiss resort last year, stormed down the Lauberhorn piste to finish 0.88sec ahead of overall World Cup leader Odermatt.

Italy's Mattia Casse was third at 1.01sec behind World Cup downhill leader Kilde. The start of the race, the longest and oldest on the World Cup circuit, had been lowered because of high wind.

For his final race on home snow, Swiss skier Beat Feuz, a three-time Wengen winner who retires after Kitzbuehel, Austria next weekend, finished fifth at 1.25sec.

Odermatt leads the overall World Cup standings with a 340-point lead on Kilde.

There was more on-court drama in Indianapolis, where Atlanta's John Collins tipped in the game-winner with seven-tenths of a second remaining in the Hawks' 113-111 victory over the Pacers.

Dejounte Murray's dunk put Atlanta up 108-107 with 2:08 to play. Bennedict Mathurin answered with a basket that gave the Pacers the lead with 58 seconds remaining.

Mathurin was fouled but missed the free throw, and Trae Young drained a three-pointer for Atlanta before two free throws from Indiana's Buddy Hield knotted the score at 111-111 with 21.5 seconds to play.

There were 2.1 seconds on the clock when Murray managed to corral a miss from Young but couldn't get his own basket to drop. Collins grabbed that rebound and made the put-back basket — just his second of the night — for the win.

Young led the Hawks with 26 points and De'Andre Hunter added 25.

Indiana was led by 26 points from Mathurin.

New York point guard Jalen Brunson continued his recent strong form, scoring 34 points - including four free throws in the final 14 seconds — in a 112-108 Knicks victory over the Wizards in Washington.

Julius Randle added 23 points and 16 rebounds for the Knicks, who withstood a 40-point performance from Washington's Kyle Kuzma.

In Detroit, New Orleans center Jonas Valanciunas led all scorers with 33 points and grabbed 16 rebounds to lead the New Orleans Pelicans to a 116-110 victory over the Pistons.

Minnesota's Anthony Edwards scored 31 to power the Timberwolves to a 121-116 home victory over a Phoenix Suns team missing Chris Paul and Devin Booker.

urray Undaunted by Difficult Draw at Melbourne Park

Murray said he was much more comfortable taking on a top player early on in a Grand Slam this year than he was in 2022, as the former world number one prepares to battle big-serving Matteo Berrettini in the Australian Open first round.

A five-times Australian Open runner-up, Murray's career looked set to end prematurely due to a long-standing hip injury after his first-round defeat in 2019 when he received an emotional 'farewell' on the court.

But the three-time Grand Slam champion has continued to push himself after multiple surgeries and said he was not worried about being drawn against the 2021 Wimbledon runner-up.

"Obviously a tough draw, but I also feel like I'm in a much better place than where

I feel I'm in a better place this time to deal with that."

Berrettini has won their previous three meetings, including a four-set victory at last vear's US Open.

"Obviously the match at the US Open was close, the match we played in Stuttgart was close and I won in Beijing," Murray added. "I know how I feel today in comparison to where I felt going into the US open and I'm playing better."

Fellow Briton Emma Raducanu said she was feeling good about her fitness ahead of the Australian Open after rolling her ankle in a tune-up event last week.

Raducanu retired from her second-round match at the Auckland Classic, sparking concerns she could miss the year's first Grand Slam where she will bid to add to her 2021 US Open crown.

"At the time you're a bit worried about it, when you just go over you don't know what's going on," Raducanu, who plays Tamara Korpatsch in her opener, said.

"But we've been working hard. It's been a team effort to get me to this place. We've expedited



Aveteran Richard Gasquet won his first ATP title in nearly five years as he fought back to stun second seed Cameron Norrie in the final of the Auckland Classic.

In a gruelling match two days before the Australian Open in Melbourne, Gasquet prevailed 4-6, 6-4, 6-4 over the British world number 12.

Gasquet was emotional after winning the 16th title of his career.

Norrie held triple break point to go 4-0 up in the third set but 36-year-old Gasquet held serve and then broke his opponent twice.

Ranked 67th in the world, Gasquet will go into his Australian Open first-round match against compatriot Ugo Humbert full of confidence.

It was a first loss of the year for left-hander Norrie.

The 27-year-old won all three of his matches at the recent United Cup in Australia, where his victims included Spanish great Rafael Nadal and American Taylor Fritz.

It was his second defeat in the Auckland final, having lost to American Tennys Sandgren in 2019.

A Wimbledon semi-finalist last year, Norrie has drawn French teenager Luca Van Assche in the first round in Melbourne.



Swiatek Inspired by Barty For Intense' Australian Open

MELBOURNE (Dispatches) - World number one Iga Swiatek said today she was ready for an "intense" opening Australian Open match while paying tribute to retired champion Ashleigh Barty for inspiring her to greater heights. Poland's Swiatek begins her Grand Slam

campaign on Monday against Jule Neimeier, the German world number 68 who reached the quarter-finals at Wimbledon last year.

More recently, the pair clashed in the last 16 at the US Open, where Swiatek had to dig deep after dropping the first set before coming through 2-6, 6-4, 6-0 and going on to win the tournament.

"We played in the US Open, and you saw how intense that match was, how tough," Swiatek told reporters.

"It's not going to be easy. But any match in a Grand Slam is always more intense and more stressful than other tournaments. I'll be ready for it."

Swiatek, the top seed, is a strong favourite for the first Grand Slam of the year in the absence of last year's retired champion Barty. I was during any of the Grand Slams last year ... ," Murray told a news conference today. "I feel ready to play a top player early ... whereas maybe last year at times my game didn't feel that great and getting a difficult draw or a tough match early didn't feel great.

Guardiola Fumes After VAR Controversy Sparks Man Utd Win

MANCHESTER (Dispatches) - Pep Guardiola was left fuming by the controversial VAR decision to allow a Bruno Fernandes goal that sparked Manchester United's thrilling fightback in their 2-1 win over Manchester City on Saturday.

City were leading through Jack Grealish's second-half header at Old Trafford when United snatched their dubious 78th-minute equaliser.

Marcus Rashford was clearly offside when he ran onto a through ball but Fernandes ran past him to fire home.

Although the goal was initially disallowed, it was eventually allowed to stand after a VAR check because Rashford didn't touch the ball before Fernandes scored.

With Guardiola and his players furious that VAR ignored Rashford's presence as a clear distraction to keeper Ederson, United took advantage of the champions' loss of focus to grab a late winner through Rashford's close-range finish.

"Marcus Rashford is offside, Bruno Fernandes is not. Rashford distracted our keeper and center defenders," Guardiola said.

"It is what it is. We know where we play. It is difficult for the referees in these stadiums."



ADELAIDE (Dispatches) - Korean lucky loser Kwon Soon-woo won the biggest title of his career when he outlasted Roberto Bautista Agut in a thrilling final at the Adelaide International.

Kwon had lost in the second round of qualifying for the tournament but was given a place in the main draw as a lucky loser.

After victory over Czech player Tomas Machac in the first round, the South Korean defeated second seed Pablo Carreno Busta, Sweden's Mikael Ymer and rising English star Jack Draper to reach the decider.

In a dramatic final that lasted 2hrs 43mins, Kwon saw off Bautista Agut 6-4, 3-6, 7-6 (7/4) in a match that swung both ways.

Kwon broke the Spaniard's first service game then used his powerful shot-making, his forehand in particular, to close out the first set.

Bautista Agut struck back immediately, breaking Kwon at the start of the second set and lifting his own service percentages to level the match at one set apiece.

When the 35-year-old Bautista Agut skipped out to a 3-0 lead in the third it seemed all over, but Kwon dug deep and broke back, taking the set to a tiebreak.
