Enemies Suffer From Iranians' Unity, Progress

ASSALOUYEH (IP) - President Ebrahim Raisi said that the enemies were suffering as they see the unity and progress of the Iranian nation.

Pointing out that the enemies got disappointed by the military invasion of Iran, Raisi referred to the recent unrest in the country as a part of the hybrid war to stop the country's progress.

The unrest and brawls were instigated under the pretext of Mahsa Amini, 22, who died due to a sudden heart attack in a police center in Tehran on Tuesday, September 13, after being taken there for violation of dress codes along with some other women.

Under the pretext of Mahsa's death, the anti-Iranian media and bloggers affiliated with the Western states have been fueling the unrest in Iran.

He said that the enemies imagined that Iran was like other countries they invade, so they launched street riots and a currency war in Iran to stop the production and scientific progress of the country.

President Raisi referred to a refinery opened with an investment of \$2 billion in Assalouyeh of Bushehr, the investor, engineers, and employees of which were Iranian. See Page 7

Window for JCPOA Revival Not to Open Remain Forever

TEHRAN - Foreign Minister Hossein Amirabdollahian has cautioned the United States that the window of opportunity for an agreement on reviving the 2015 Iran nuclear deal will not remain open forever, urging Washington to adopt a constructive approach to salvage the accord.

In an interview with CNN aired on Wednesday, Amirabdollahian said Iran has informed the US through mediators that the parties to the Joint Comprehensive Plan of Action are "on the path to reach an accord," but warned that this might change if the US side hangs back.

"Our relationship with the IAEA is on its correct, natural path, and we have said this to the US side through mediators that we are on the path to reach an accord but if the Iranian Parliament adopts a new law, then we'll have to abide by the parliamentary act," he said.

"So the window for an accord is still open but this window will not remain open forever," he added.

Amirabdollahian also made clear that the Islamic Republic of Iran has been and is the most committed of all the parties involved in the diplomatic endeavors to restore the JCPOA, which was abandoned by the United States in 2018. "The party that left the JCPOA was [former US president Donald] Trump and the United States," he said.

"The United States should not adopt a deceptive behavior and instead should return to the JCPOA and adopt a constructive approach."

The US party has been sending us positive messages through diplomatic channels but in its media remarks, they made very deceptive remarks that are totally different, and really, as the Iranian foreign minister, sometimes I have serious doubts," he added.

The Iranian foreign minister noted that even though the administration of President Ebrahim Raisi sees some flaws and shortcomings in the JCPOA, it has decided to continue with the dialogue in order to restore the multilateral accord, provided that all the parties come back to the negotiating table and do their utmost to reach an agreement.

Iran showed to the world the peaceful nature of its nuclear program by signing the JCPOA with six world states namely the US, Germany, France, Britain, Russia and China. But, Washington's unilateral withdrawal in May 2018 and its subsequent re-imposition of sanctions against Tehran left the future of the deal in limbo. Elsewhere in his interview with CNN's Christiane Amanpour, Amirabdollahian criticized the United States for

playing the blame game and accusing Iran of not having the "necessary resolve." "I will tell you expressively that in the past few years, we saw that the US officials were unable to make a

decision because of their own internal problems and the pressures they are under. They are still unable to make a courageous decision to return to the JCPOA," he said. See Page 7

Iran Not to Hesitate To Respond Decisively To Israeli Action

TEHRAN (PressTV) - A senior Iranian diplomat has strongly condemned Israel's threat to use military force against the country's non-military and vital infrastructure as a blatant violation of international principles, emphasizing that Tehran will not hesitate to respond decisively to any threat or wrongful action by the Tel Aviv regime.

Iran's Ambassador and Permanent Representative to the United Nations Amir Saied Iravani made the remarks in a letter addressed to the rotating president of the UN Security Council Pedro Comissário Afonso and UN Secretary General Antonio Guterres.

Iravani wrote that Israeli prime minister Benjamin Netanyahu on February 21 had resorted to the regime's repeated lies and false claims in order to openly make threats of using military force against Iran's critical infrastructure, including peaceful nuclear facilities.

He said the Israeli regime's threats are in direct contravention of the international law and the United Nations Charter.

The Iranian ambassador pointed to similar remarks by Israeli minister of military affairs Yoav Gallant on February 17, in which he made threats of employing military force against Iran's civil sites and critical infrastructure. See Page 7

U.S. Funded Iran War Plan

WASHINGTON (Dispatches) - The U.S. military allocated funds for secret contingency operations related to a plan for war against Iran, according to a damning new report citing classified Pentagon documents.

An investigative report published by the Intercept on Wednesday noted that the plan - codenamed "Support Sentry" - was exposed after The Intercept, an American nonprofit news organization, reviewed a classified Pentagon budget manual listing emergency and special programs.

According to the manual, which was produced for the 2019 fiscal year, the so-called Support Sentry plan was funded in 2018 and 2019, the report further read. The document further classified Support Sentry as an Iran "CONPLAN," or concept plan, a broad contingency plan for a war that the US Department of Defense develops in anticipation of a potential crisis.

"As a matter of policy, we do not comment on numbered plans. Iran remains the leading source of instability in the region and is a threat to the United States and our partners. We are constantly monitoring threat streams in coordination with our regional partners and will not hesitate to defend US national interests in the region," said Mai. John Moore, a spokesperson for U.S. Central Command, or CENTCOM, when asked about Support Sentry and whether it is still in place. See Page 7

Tehran, Minsk to Sign **Agreement on Permit-Free Shipping System Soon**

MINSK (Dispatches) - Belarus and Iran will soon sign an agreement that will enable international freight transportation by road without permits, BelTA learned from Belarusian Transport and Communications Minister Aleksei Avramenko before a session of the ministry's board.

Belarus and Iran advance cooperation in transportation. A document on introducing permit-free international freight transportation by road is nearly ready for signing. The practice will allow logistic companies to more widely use the potential of automobile transport for building new schemes for shipping between Belarus and Iran.

Aleksei Avramenko said: "We have plans concerning permit-free transportation to four countries. We've held negotiations with Iran. I think the agreement will be signed within the next two weeks. It is going through the authorization procedure in Belarus. The Iranian side is also about to complete the relevant authorization granting procedure."

U.S. Mentions Oil Stolen From Iran in Its Imports Data

WASHINGTON (Dispatches) - The U.S. Energy Department has mentioned illegally confiscated oil shipments from Iran in its 2022 imports data.

A Wednesday report by the official IRNA news agency showed that some 507,000 barrels of crude oil from Iran had been included in import tables released by the Energy Information Administration (EIA) for January-December 2022. Iran has no official exports of crude oil to the U.S. That comes as Washington imposes sanctions on any country or entity that is engaged in trade of crude oil from Iran. The U.S. government has also sought to confiscate Iranian oil shipments in territorial or international waters as part of its efforts to choke off Iran's oil revenues.

However, the campaign has largely failed because many countries have refused to comply with judicial orders issued by U.S. courts on the issue.

Iran has described attempts to confiscate its seaborne oil cargoes as act of piracy while warning that it would seize shipments bound for the U.S. to compensate for losses that could be incurred.

New Shipment of Iranian Relief Aid Arrives in Syria

European Territories Should Not Be Used as Launch Pad For Anti-Iran Plots

TEHRAN (President) - President Ebrahim Raisi warns European countries against allowing their territories to be used as a launch pad for plots targeting the Islamic Republic.

"The European countries' territories should not serve as a source of plot and threats against the Iranian nation's interests," the chief executive said on Wednesday as he was taking a telephone call from Belgium's Prime Minister Alexander De Croo.

Iran is inclined to preserve and enhance favorable and constructive relations with the rest of the world, including Europe, Raisi said.

He, however, cautioned foreign governments, including those in the continent, to avoid coming under the influence of false information that are propagated by anti-Iran movements.

"If a government chooses the path of confrontation under the influence of the false and misleading information [that are provided] by terrorist and mercenary movements, it stands to lose," Raisi said.

The Iranian president was referring to ongoing demonization and misinformation campaigns that have been led for decades by anti-Iran terrorist groups such as the Mujahedin-e-Khalq Organization (MKO).

The European Union has removed the name of the MKO from its list of terrorist organization and allows its ringleaders and members to roam freely across the continent and throw lavish conferences there.

This is while the group's acts of terror are responsible for killing thousands of Iranians since the victory of Iran's Islamic Revolution in 1979.

Raisi also expressed concern about some European countries' provision of support for Islamophobic activities.

Several European countries are accused of enabling "state-sponsored" Islamophobia by contributing to systematic suppression of their Muslim communities and tolerating sacrilegious insults against the Abrahamic religion.

"The Islamic Republic is inclined to resolve [its] issues [with others] through recourse to a cooperative approach, of course, on the condition that the other side opts for such an approach too," Raisi said.

The Belgian official, for his part, laid emphasis on the important development of relations between the two sides given their 130-year-old history of diplomatic relations.

"Belgium always chooses the path of dialogue towards the reinforcement of its relations with Iran, and is inclined to resolve various issues through [recourse to] an approach that is based on understanding and cooperation," he concluded.

Foreign Policy Focusing on Maximum Interaction With All Nations

TEHRAN (IRNA) - President Ebrahim Raisi has said that his administration's foreign policy focuses on extensive interaction with all countries based on dignity, wisdom and expediency.

The president made the comment in Tehran on Wednesday during a meeting with the new Iranian ambassadors to ten countries ahead of their departure from Iran.

"Maximum and extensive interaction with all countries around the world based on three principles of dignity, wisdom and expediency is the main stance of the foreign policy of the government," Raisi said.

He also advised the ambassadors to prioritize the expansion of economic ties with the countries hosting their diplomatic missions, as "the first priority of the government is to enhance the economic power".

The president also called on the envoys to pay attention to the Islamic Revolution's values and make efforts to protect national interests.

The ambassadors stressed that they would make serious efforts to boost political, economic and cultural ties with their host countries.

The new envoys are set to launch their missions in Algeria, Burkina Faso, Japan and Kazakhstan, as well as the European states of Switzerland, Greece, Belarus, Croatia and Spain.

Safari Meets Azeri FM to Discuss Embassy Shooting

TEHRAN (MNA) – Mahdi Safari, Iran's Deputy Foreign Minister for Economic Diplomacy held a meeting with the foreign minister of Azerbaijan Jeyhun Bayramov and his deputy to discuss the case of the shooting in the Azeri embassy in Tehran.

In the meeting with Beyramove and his deputy Khalaf Khalafov, Mehdi Safari expressed deep sympathy and condolences to the government and people of the Republic of Azerbaijan and the family of the victims in the embassy incident and wished a speedy recovery for the injured.

In the meeting, Safari presented a report on the latest developments in the case of the attack on the Azerbaijani embassy and he asked the Azerbaijani authorities to speed up the completion of the case.

He called for exchanging travels between teams of relevant experts from the two countries on the matter.

Some European States Made Miscalculations About Recent Unrests in Iran

TEHRAN (IRNA) - Foreign Minister Hossein Amirabdollahian said on Thursday that some European states "unfortunately" made mistakes in analyzing the recent unrests in Iran as they were influenced by the propagandist campaign of the MKO terrorist group.

Iranian, Indian Officials Ink Cultural Cooperation MoU

TEHRAN (MNA) – Iranian and Indian officials in the field of publication and international book exhibitions signed a memorandum of understanding.

The MoU was signed in the presence of the head of the National Book Union of India and the managing director of Iran Book and Literature House Ali Ramezani a report by the Iranian Ministry of Culture and Islamic Guidance's public relations department said.

According to the MoU, publishers of Iran and India will take part in the exhibitions of the two countries and will present their works, which will facilitate the cultural interactions between the two countries, according to Iran Book and Literature House director.

Translating Iranian and Persian books were another matter mentioned in the MoU.

According to the MoU, the booths needed by both sides in Tehran and New Delhi international book fairs will be provided for free.

The 31st edition of the New Delhi World Book Fair (NDWBF) officially began on Saturday (February 25) at Pragati Maidan, New Delhi. The literary event, which is scheduled to go on till March 5, has been organized by the National Book Trust (NBT) in collaboration with the India Trade Promotion Organisation (ITPO), according to Iran Press.

Iran has an active presence in the Book Fair with more than 600 books. Professors and students of India welcomed Iran's booth at NDWBF. Ali Ramezani said, within the framework of the memorandum, Tehran and New Delhi will provide booths to Indian and Iranian publishers free of charge. Shri Yuvraj Malik, Director of National Book Trust, India (under the Department of Higher Education, Ministry of Education, Government of India)., also said that based on the memorandum of understanding, India and Iran participate in each other's book fairs which is a method of cultural communication between the people of the two countries.

Malik stated that the signing of the MoU is a good start and both countries are looking for more cooperation.

Value of Iran-Russia Trade Rose by 20% in 2022

TEHRAN (IFP) - A senior Russian economic official says the value of trade between his country and Iran increased by 20 percent in 2022 to reach \$4.9 billion.

Sergey Katiryn, head of the Russian Chamber of Commerce and Industry, praised growing bilateral cooperation with Iran in an interview with Tass news agency, saying that two states expect the value of their trade to hit \$40 billion in the years to come.

He said Russian companies are interested in entering the Iranian market, describing Iran as a bridge for trade with the Middle East, South and Southeast Asia.

The Russian official, whose country has been hit tough by Western sanctions over the past year due to the Ukraine war, said Iran has a unique experience in keeping up economic activities amid similar restrictions.

Katiryn stressed the need to bolster cooperation with Iran in all fields, from agriculture to advanced technologies, energy, engineering, textile and tourism.

The comments come as Iranian Foreign Minister Hossein Amirabdollahian is expected to visit Moscow later this month for talks on closer bilateral cooperation.

President **Inaugurates South Pars Phase 14 Refinery**

TEHRAN - The 14th phase of the South Pars Refinery was inaugurated on Thursday in the presence of Iranian President Ebrahim Raisi.

Iranian Oil Minister Javad Owji had recently told reporters that by exploiting this stage, the construction of South Pars refineries will be completed and this will be its last phase. South Pars Phase 14 Refinery with the aim of producing 50 million cubic meters of gas for urabn uses(methane) and 75,000 barrels of gas condensate and 400 tons of sulfur per day. as well as one million tons of LPG and one million tons of ethane per year in order to feed petrochemical units was inaugurated. The National Oil of Iran and Pars Oil and Gas Company in an all-Iranian consortium under the leadership of Iran Industries Development and Modernization Organization operated the massive national project.

More than 70% of the total goods required for the 14th phase of South Pars were supplied by domestic factories.



The huge offshore field covers an area of 9,700 square kilometers, 3,700 square kilometers of which are in Iran's territorial waters in the Persian Gulf. The remaining 6,000 square kilometers, called North Dome, are situated in Qatar's territorial waters. The field is estimated to contain a significant reserve of natural gas, accounting for about eight percent of the world's reserves, and approximately 18 billion barrels of condensate.

Speaking to reporters in Kangan County in Bushehr Province, Javad owji, the Iranian oil minister said that the 14th phase of South Pars was the last dry refinery in South Pars gas field, voicing optimism that the Phase 11 of South Pars which is in the waters of Persian Gulf will be completed in the two months.

TEHRAN (PressTV) - Energy Minister Ali Akbar Mehrabian says politics has overshadowed the D-8 Organization for Economic Cooperation as he expresses hope that the organization could return to its core mission which is to foster economic growth in member states.

Mehrabian made the remarks in a meeting with D-8 Secretary-General Isiaka Abdulqadir Imam in Tehran. The minister said that Iran has been a key member of the D-8 since its inception in 1997 and has always supported the organization and its objectives.

"Other regional organizations have performed better than the D-8 in recent years. Thus it is necessary for the D-8 to return to its core missions," he said, adding that member states should seek to set aside their differences and commit to their responsibilities vis-à-vis the organization.

Mehrabian said he welcomes a proposal by Iranian Foreign Ministry to hold a summit of D-8 energy ministers in Tehran.

Imam, for his part, said the D-8 secretariat seeks to activate more trade potentials between members of the organization.

He said trade between D-8 members could reach some \$500 billion by 2030, up from a current figure of \$137 billion per year. The D-8 is comprised of Bangladesh, Egypt, Indonesia, Iran, Malaysia, Nigeria, Pakistan, and Turkey.

New Greek Transport Minister Promises Train Crash Answers

ATHENS (Dispatches) - Greece's newly-appointed transport minister said he was taking over with a mandate to investigate the country's deadliest train crash, to modernize an ailing railway system and to restore safety in train travel.

"It is a very heavy responsibility," Giorgos Gerapetritis told reporters during handover at the ministry.

The government has faced harsh criticism for the state of its railway system since an intercity train collided head-on with a cargo train on Tuesday night, killing at least 46 people, many of them students in their 20s, and injuring dozens.

Ukraine Clings to Bakhmut in Fierce Fight With Russian Forces



CHASIV YAR (Dispatches) - Ukrainian forces hung on to positions in the ruined eastern city of Bakhmut while Moscow said its security forces had battled Ukrainian saboteurs who had taken hostages in a cross-border raid.

Russia's FSB security force said the situation was now "under control" in Bryansk province just north of the Ukrainian border. Earlier Moscow had said armed Ukrainians had crossed the frontier, fired on a car killing one person and wounding a child, and held hostages in a shop.

In a brief television address, President Vladimir Putin said the attackers had fired deliberately on the car, knowing it held civilians.

"They won't achieve anything. We will crush them," he said, saying Russia was fighting "terrorists and neo-Nazis". An aide to Ukrainian President Volodymyr Zelenskiy called the reports a false provocation by Moscow, but also appeared to imply some form of incident had been carried out by partisans.

Near the front lines west of Bakhmut, in the Ukrainian-held town of Chasiv Yar, the thump of outgoing artillery fire could be heard.

In nearby towns and villages, new trenches had been dug on the roadside 20-40 metres (65-130 feet) apart, an apparent sign that Ukrainian forces were strengthening defensive positions west of the city.

Residents trickled out of the area, carrying bags.

"We remained until the very last. We wanted to stay. But we how can we? Our neighbor's flat has now been destroyed. It is time to go," said Svitalana, 47.

The boss of Russia's Wagner private army, Yevgeny Prigozhin, released video of his men waving a Wagner banner and musical instruments atop a ruined multi-storey building, which he said had been filmed near the centre of Bakhmut. Reuters was not immediately able to verify the location.

KCNA said Kim stressed the need to tighten discipline in implementing the economic plan, warning against "practices of weakening the organizational and executive power of the cabinet," and ordered all party units to "get their working efficiency verified."

China's Annual Parliament to Implement Xi's Tightening Grip

BEIJING (Dispatches) - China's annual parliament opens on Sunday and will implement the biggest government reshuffle in a decade as Xi Jinping tightens control while contending with a host of challenges, from an uneven post-COVID economic recovery to cratering U.S. relations.

Nearly 3,000 delegates will gather in the Great Hall of the People west of Tiananmen Square for the first National People's Congress (NPC) of the post-zero-COVID era, although some precautions remain including testing and quarantine for journalists. The rubberstamp NPC will confirm Xi's new economic team after China's most powerful leader since Mao Zedong cemented a norm-breaking third term and stacked the top of the ruling Communist Party with allies during its twice-a-decade congress in October.

Macron Says Era of French Interference in Africa Is Over LIBREVILLE (Dispatches) - President Emmanuel

Macron said the era of French interference in Africa was "well over" as he began a four-nation tour of the continent to renew frayed ties.

Anti-French sentiment runs high in some former African colonies as the continent becomes a renewed diplomatic battleground, with Russian and Chinese influence growing in the region.

Macron said France harbored no desire to return to past policies of interfering in Africa ahead of an environment summit in Gabon, the first leg of his trip.

"The age of Francafrique is well over," Macron said in remarks to the French community in the capital Libreville, referring to France's post-colonization strategy of supporting authoritarian leaders to defend its interests.

"Sometimes I get the feeling that mindsets haven't moved along as much as we have, when I read, hear and see people ascribing intentions to France that it doesn't have," he added.

"Francafrique" is a favorite target of pan-Africanists, who say that after the wave of decolonization in 1960

Scholz Urges China Not to Arm Russia

BERLIN (Dispatches) - German Chancellor Olaf Scholz urged China not to send weapons to help Russia's war in Ukraine and instead asked Beijing to exert pressure on Moscow to pull back its forces.

In a speech to the German parliament, Scholz said it was disappointing that Beijing had refrained from condemning the Russian invasion, though he welcomed its efforts towards nuclear de-escalation. China has denied any intention to arm Russia and one of its senior diplomats told the United Nations on Feb. 23 that "sending weapons will not bring peace" but add "fuel to the fire" Scholz's remarks underscored how the international response to the war in Ukraine highlighted global divisions, as China and India have refrained from condemning the Russian invasion or joining the West in imposing sanctions.

The divisions have also reared their head at a series of G20 meetings in India that descended into wrangling over the war. Germany has said it planned to counter Russian "propaganda" at this week's talks, while Russia on Thursday accused Western countries of turning the event into a "farce".

The U.S. is sounding out close allies about the possibility of imposing new anctions on China if Beijing provides military support to Russia for its war in Ukraine, sources told Reuters this week.

"My message to Beijing is clear: use your influence in Moscow to urge the withdrawal of Russian troops," Scholz said, to resounding applause from lawmakers. "And don't deliver any weapons to the aggressor Russia."

The U.S. consultations on sanctions, which are still at a preliminary stage, are ntended to drum up support from a range of countries, especially those in the wealthy Group of Seven (G7), to coordinate support for any possible restrictions. It was not clear what specific sanctions Washington will propose.

China's role in the Russia-Ukraine war is expected to be among the topics discussed when U.S. President Joe Biden meets Scholz at the White House.

France propped up dictators in its former colonies in exchange for access to resources and military bases.

Macron and his predecessors, notably Francois Hollande, have previously declared that the policy is dead and that France has no intention of meddling in sovereign affairs. Macron on Monday said there would be a "noticeable reduction" in France's troop presence in Africa "in the coming months" and a greater focus on training and equipping allied countries' forces.

France has in the past year withdrawn troops from former colonies Mali, Burkina Faso and the Central African Republic.

The pullout from Mali and Burkina Faso, where its soldiers were supporting the Sahel nations to battle a longrunning jihadist insurgency, came on the back of a wave of local hostility.

In his remarks on Thursday, Macron insisted the planned reorganisation was "neither a withdrawal nor disengagement", defining it as adapting to the needs of partners.

Taiwan Military to Get \$619m U.S. Arms Boost TAIPEI (Dispatches) - The United States has approved the potential sale of \$619 million in new weapons to Taiwan, including missiles for its F-16 fleet, as the island

Taiwan reported on Thursday a second day of large-scale Chinese air force incursions into its air defense identification zone, with its defense ministry saying that during the last 24 hours it had spotted 21 aircraft.

China has said its activities in the area are justified as it seeks to defend its territorial integrity and to warn the United States against "colluding" with Taiwan, despite the anger this causes in Taipei.

Impact of Food And Nutrition on Your Oral Health

LONDON (Dispatches) - Food habits and food components can have a profound impact on our oral and dental health. What we eat, how much we eat, and when we eat can affect oral status positively or negatively. While some foods can

improve your teeth and gums, others can aggravate disease conditions like dental caries, gum infections, and oral cancers. Read on to learn how the foods we consume impact our oral health.

Food has a substantial impact on oral health. It influences the initiation and progression of oral diseases like caries, gingivitis, periodontal disease, teeth erosion, and even oral cancers.

Besides the nutritional values of food, the form and frequency of our eating habits influence the final oral effects. Sticky forms of sugars are the main culprit in dental caries. Limiting frequent snacking on sugary beverages and acidic drinks helps prevent damage to your teeth.

A balanced and nutritious diet is key to maintaining a healthy oral status.

Different food classes like fruits, vegetables, and dairy products help to keep your teeth strong and your gums healthy.

Foods can affect your teeth and gums in 2 ways - directly via contact with harmful ingredients when we eat (local effects) — and indirectly via the absorption of ingredients into the blood (systemic effects). The types of food you take, their amount, frequency, the timing of intake, and your eating habits can add up and reflect in your oral health.

Type of foods. Foods are nutritional or empty --- with minimum or no nutritional value. We must know the contents of whatever we eat in a day.

Sugars. All sugars, in different forms, have a long-time association with teeth cavities. The milestone Vipeholm study concluded that sugars in sticky foods, ingested between meals, were linked to a significant rise in cavities.

Amount and frequency of food intake. Consuming sugary drinks and snacks regularly without taking the time to brush your teeth might lead to cavities. The World Health Organization (WHO) recognizes the danger and advises that free sugars account for no more than 10% of total calories consumed. Every time you have sugar, your teeth come under acid attack.

Eating habits. Eating patterns also dictate the harms caused to teeth. Taking sugars in between meals is linked to more caries risk than with meals. Experts recommend avoiding binge eating.

Research shows that nutritional deficiency and malnutrition are fundamental causes of early teeth loss. Fruits and vegetables are rich in antioxidants, essential nutrients, vitamins, minerals, and fibers. Consuming a varied diet loaded with veggies and fruits, decreasing the fat intake, and including fiberrich foods in meals is a great ways to get the necessary nutrients from foods.

Vitamin A, C, E. Vitamins A, C, E, and folate deficiencies can damage periodontal health. Vitamin A deficiency leads to gum infections, gingivitis, gingival hypoplasia, and supporting bone loss. Bleeding gums are often due to a lack of Vitamin C.

Vitamin B. Vitamin B-complex deficiency is linked to lower host defense against bacterial irritants. Adequate folic acid aids in the prevention of gum inflammation. Taking sufficient vitamins helps to avoid gum-related issues.

Calcium. Calcium is an important component of jaw bones and teeth — it helps increase bone density. Vitamin D. Vitamin D aids in calcium absorption — you must monitor your Vitamin D levels to maintain optimal calcium uptake.

Fighting for Their Lives: The World's Forests In Figures

PARIS (Dispatches) - Forests are central to biodiversity and the fight against climate change, as well as being a big money spinner for national economies.

But they are in critical danger.

As politicians, including French President Emmanuel Macron, prepare to descend on the West

African nation of Gabon for an international summit on forests, AFP looks at how green our globe really is. Forests cover almost a third, or 31 percent, of the global land area, according to a 2022 report by the United Nations' Food and Agriculture Organization (FAO).

They span some four billion hectares (9.9 billion acres), or close to the combined surface area of Canada, Russia, the United States and all 27 members of the European Union.

More than one-third is primary forest, which the FAO defines as being "naturally regenerated forests of native species, where there are no visible indications of human activities and the ecological processes are not significantly disturbed".

Brazil, Canada, China, Russia and the United States account for more than half of all forest area. Seven percent of the world's forests have been planted by humans.

Forests can be found in many climates but three-quarters are either in the tropics (45 percent) or in a ring around the North Pole (27 percent).

Forests, especially rainforests, are critical for biodiversity on land.

Four-fifths of the world's amphibian species live in forests, as do three-quarters of bird species, 68 percent of mammal species and many of the 60,000 kinds of trees found on Earth.

Three-quarters of the fungi species, two-thirds of the plant species and nearly half (45 percent) of the animal species considered vulnerable, endangered or extinct are found in forests.

Among the amphibians in critical danger of extinction are the Montseny brook newt in Spain and Lanza's Alpine salamander, which lives in the Franco-Italian Alps.

Forests typically act as carbon sinks, absorbing more carbon from the atmosphere than they emit.

They contain 662 billion tons of carbon, more than half of all the carbon found in soil and vegetation. Deforestation and climate change have had some impact on that function, though replanting and better forest management have helped.

According to the FAO, forests absorbed more carbon than they emitted in 2011–2020, thanks to reforestation, improved management and other factors.

But it warns in its latest report on forests (2022) that they could start emitting carbon rather than absorbing it if deforestation is not halted.

"Unless additional action is taken, an estimated 289 million hectares of forests would be deforested between 2016 and 2050 in the tropics alone, resulting in the emission of 169 gigatons of CO2 equivalent."

The forestry sector pumped more than \$1.52 trillion into the world economy in 2015, directly and indirectly. Whether working in wood putty and paper industries, forestry or solid wood products such as furniture, around 33 million people, or one percent of the world's workforce, are dependent on forests for a livelihood.

Even though the rate of deforestation has slowed, it continues to occur "at an alarming rate" according to the FAO, which says 10 million hectares of forests were wiped out each year between 2015 and 2020. The losses were not compensated by replanting and natural forest expansion, which is estimated at five million hectares per year.

Portugal Economy Grows 6.7% in 2022

LISBON (Dispatches) - Portugal's economy grew 6.7% in 2022, its strongest pace in 35 years, fuelled by domestic demand and booming tourism, but inflation put the brakes on private consumption in the fourth quarter, presaging a sharp slowdown this year.

In its second reading of gross domestic product released, the National Statistics Institute (INE) revised fourth-quarter growth slightly higher yet kept the annual figure unchanged.

It said the economy grew 0.3% in the last quarter of 2022, up from 0.2% estimated a month ago and the same as in the third quarter. Year-on-year growth reached 3.2%, up from its flash estimate of 3.1%.

However, INE said the contribution of domestic demand to year-on-year GDP was only 1.9 percentage points (pp) after 3.2 pp in the previous quarter, while external demand contributed with 1.1 pp compared to 1.6 pp in the third quarter.





Turkish Economy Logs Better-Than-Expected 5.6% Growth in 2022

ANKARA (Dispatches) - Turkey's economy expanded by more than expected in the last quarter and the whole of 2022, official data showed Tuesday, yet the pace is clouded by the devastating earthquakes this month that caused widespread destruction in the southeast of the country. The gross domestic product (GDP) grew 5.6% on an annual basis in 2022, the Turkish Statistical Institute (TurkStat) said, above market expectations that stood at around 5.2%.

The economy started cooling in the second half of 2022 with a decline in domestic and foreign demand, partly due to a slowdown in Turkey's main trading partners because of the war in Ukraine, which hurt exports.

The GDP expanded by 3.5% in the fourth quarter of 2022, the TurkStat said, down from a revised 4% in the third quarter and 7.8% in the second quarter.

In 2022, the country's gross domestic product (GDP) reached TL 15 trillion (\$905.5 billion) last year, the data showed. The GDP per capita was TL 176,589 (\$10,655) in 2022.

Finance and insurance activities grew 21.8%, followed by the services sector, which rose 11.7%, according to the data. The only contraction was in the construction sector, which shrank 8.4%, Lebanon Plans to Hike Import Tariffs for Second Time in Three Months

the data showed. Overall consumption contributed 11.5 points to annual growth,

according to economists' calculations. Net foreign trade and stocks lowered it by 3 and 5.5 percentage points, respectively.

Household spending, which is estimated to account for more than half the economy, grew an annual 19.7% in 2022, the data showed.

The spending expanded by 16.1% year-over-year during the October-December period. Government spending rose 9%, the fastest pace of growth since the presidential elections in 2018. Exports of goods and services increased by 9.1% on annual basis, while imports rose by 7.9% compared to the previous year. Outbound shipments were down 3.3% in the last quarter, while imports jumped 10.2%, the TurkStat said.

In contrast, the average GDP growth rate was 1.1% in the Organization for Economic Co-operation and Development (OECD) area in the last quarter of 2022. The rate was 1.8% for the European Union, 1.9% for the eurozone and 1% for G-7 countries.

The economy is expected to cool further this year, mainly due to catastrophic earthquakes that flattened a swathe of Turkey's southeastern region in early February, which could keep pressure on inflation and stretch the government's budget.

Indicators before the quakes suggested that GDP growth had revived with the help of domestic demand, but risks to annual growth were now on the downside after the disaster, said Haluk Bürümcekçi, of Bürümcekçi Consulting.

"The size and duration of the earthquake zone's contribution to all sectors, particularly the manufacturing industry... will be critical in shaping the magnitude of the expected slowdown in growth this year," he said.

The likelihood of a slowdown in January was "quite high," but more robust growth may be seen in the following quarters as production gains compensate for losses in other areas, Bürümcekci said.

To counter the slowdown, the central bank cut its policy rate by 500 basis points at the end of last year and then by a further 50 basis points to 8.5% last week to support growth after the earthquakes killed more than 50,000 in Turkey and neighboring Syria.

China's Urban Employment Sees Rare Decline Due to COVID-19 Curbs

BEIJING (Dispatches) - China's urban employment experienced a decline in 2022 for the first time in 60 years, and there was also an unusual decrease in per capita spending. This was caused by the strict measures imposed due to the COVID-19

to last year's growth, economists said.

"We are likely to hit the 7% GDP growth target for the year," said India's chief economic advisor V. Anantha Nageswaran at in the January-March quarter, he said.

Even though a weaker global economy is likely to pull down India's growth to near 6.4% next year, the International Monetary Fund (IMF) and the World Bank project India to be the fastest-growing major economy in 2023.



The ECB plans to raise its key rate by 50 basis points in March to 3% but some policymakers have called for more cautious steps thereafter as past rate hikes are now taking hold and the economy is starting to respond.

Inflation in France rose to 7.2% from 7.0%, beating forecasts for 7.0%, while in Spain, it jumped to 6.1% from 5.9% and ahead of the 5.5% seen in a Reuters survey

The figures also raise doubts that the euro zone's combined figure, due on Thursday, will show a fall to 8.2% from 8.6% but economists say that the German number, due on Wednesday, will be more crucial than Tuesday's releases.

Markets now fully price in another 150 basis points of rate hikes by the end of the year, taking the peak in the ECB's deposit rate to 4%, reflecting the view that it will take longer for the ECB to get price growth back to its 2% target.

Germany's 10-year bond yield, the benchmark for the euro zone, jumped to its highest level since 2011 at 2.66% as traders ramped up bets that ECB rates will peak around 4% at year-end. Expectations for the peak in ECB rates have risen by over 40 basis points this month on fears that inflation will be more persistent than expected, particularly for core goods that exclude volatile fuel and food prices.

Some investors even think there is a risk of the ECB raising rates by more than 50 basis points in March, despite its explicit guidance for the move.

> "Both reports were firmer than we had expected, suggesting more inflation persistence... hence, we flag some upside risk for (the euro zone release on) Thursday," JPMorgan economist Greg Fuzesi said.

> In France, inflation still has some way to rise after its figures were among the lowest in the 20-nation euro area for the past year.

> "The February data shows that French inflation has not reached its peak yet," ING economist Charlotte de Montpellier said. "Given how underlying global inflation will probably continue to go up in the coming months, that will give further arguments to the European Central Bank to continue to raise rates beyond the first quarter."

> In Spain, core inflation also accelerated, adding to the ECB's worries that price growth is becoming persistent.

Canada's Economy Surprises With **Q4** Flat Line



OTTAWA (Dispatches) - The Canadian economy unexpectedly stalled in the final three months of 2022, but likely rebounded in January, data showed, a result that backs up the Bank of Canada's aim to keep interest rates on hold at its next policy meeting in March.

Annualized fourth-quarter gross domestic product (GDP) was flat versus the previous quarter, Statistics Canada said, ending a streak of five consecutive quarterly increases. It was far below analysts' median forecast for a 1.5% increase. The result also came in below the Bank of Canada's Q4 forecast for 1.3% annualized GDP growth. The central bank has raised its benchmark interest rate at a record pace to tame high inflation, but last month it said it wanted to pause its tightening campaign. The Q4 figures give "the BoC just a little bit of comfort that higher interest rates are working to slow demand, especially with the conflicting signals from the labor market over the last couple of months," said Robert Both, macro strategist at TD Securities. Canada added 10 times more jobs than expected in January, and both manufacturing activity and retail sales picked up the same month. The economy likely bounced back in January, expanding 0.3%, Statscan said. "Some of the indicators are going in multiple directions and so the Bank of Canada will remain cautious evaluating the data after this meeting" next week, for which no action is a "done deal," said Derek Holt, vice president of capital markets economics at Scotiabank. Money markets still expect that the central bank will hold its benchmark rate at 4.50% at the March 8 policy announcement, and they trimmed bets that it will be forced to tighten again later this year. The economy contracted 0.1% in December from November, also below analysts' expectations that GDP would be unchanged in the month. Real GDP slowed in 2022 to 3.5% from 5% in 2021, after shrinking 5.1% in 2020 during COVID-19 pandemic restrictions.

In February, it amended the exchange rate to match, so that the official government rate was 15,000 to the U.S. dollar. Unifying Lebanon's various exchange rates is among pre-conditions set by the International Monetary Fund nearly year ago for Lebanon to get a \$3 billion bailout, but the lender of last resort says reforms have been too slow. The country has been moving towards a cash-based and dollarized economy given spiralling inflation and restrictions by banks on transactions.

India's Growth Slowed in December Quarter on Weakness in Manufacturing

NEW DELHI (Dispatches) - India's economic growth slowed further in the December quarter as pent up demand eased and weakness in the manufacturing sector continued.

Asia's third largest economy recorded yearon-year growth of 4.4% in October-December, down from 6.3% in July-September, data released by the government on Tuesday showed. The sharp fall in the year-on-year growth rate is also partly due to a fading of pandemic-induced base effects and revision

The new National Bureau of Statistics data also showed the smallest income growth over three decades.

China's urban jobs dropped by 8.4 million to 459.31 million, the first drop since 1962.

"The decline of the urban labor force reflects the severe economic challenge China faced last year," Zhiwei Zhang, president at Pinpoint Asset Management, wrote in a note to clients.

He cited the shrinking size of China's labor force, job losses due to the pandemic, and the deceleration of rural workers migrating to cities as the main reasons for the decline.

Zhang added he expects this to be a temporary drop now that China has abandoned draconian zero-COVID policies aimed at stamping out every outbreak.

China had an economic growth of just 3% in 2022- one of the weakest levels in nearly half a century.

The statistics bureau data showed that per capita spending fell 0.2% in real terms. That followed a jump of 12.6% in 2021 and marked only the third such decline since records for that data point began in 1980. Retail sales also fell 0.2%, the secondworst performance since 1968.

Xu Tianchen, an economist at the Economist Intelligence Unit, said a steep drop in income growth for China's



lowest-income earners was a key factor behind the weak spending data.

"Before the pandemic, the lowest income group was one of the fastest growing, but now, quite remarkably, it has become the slowest income group, dropping from 10.1% (income growth) to 5.2%."

Disposable income per capita in China grew by just 2.9% in real terms, the second smallest rise since 1989. Unadjusted, disposable income per capita grew to 36.883 yuan (\$5,310) last year, while spending per capita increased to 24,538 yuan.

Rural areas performed better than urbanized zones, with the disposable incomes of rural households growing 4.2% in real terms, compared with 1.9% growth for urban residents.

India's manufacturing sector shrank by 1.1% year-on-year in the third quarter, a second straight contraction reflecting lower profit margins and weaker exports.

External demand was weak as central banks globally continued monetary tightening to tame inflation.

"The major disappointment is negative growth in manufacturing," said Madan Sabnavis, economist at state-run Bank of Baroda. He said 2022/23 growth will be at 6.8% against a government estimate of 7%. The Reserve Bank of India (RBI), has raised its benchmark repo rate by 250 basis points since May last year and economists expect a further rate hike of 25 basis points to 6.75% in April, which could hurt growth in the coming quarters. India's private consumer spending, contributing around 60% of GDP, rose just 2.1% year-on-year in December quarter, compared to downwardly revised 8.8% increase in the previous quarter, while capital investment rose 8.3% year-on-year compared to revised 9.7% growth in the same period.

Private investment activity is recovering, said Nageswaran.

Government spending declined 0.8% year-on-year in the December quarter compared to revised 4.1% contraction in the previous quarter.

Aviation Industry Turns to Childcare, Free iPhones to Lure Workers

LONDON (Dispatches) - The North American aviation industry is wooing workers with daycare centers, cheaper transport and free iPhones to compete in a tight market where salaries for entry-level, low-skilled jobs often lag those at e-commerce companies like Amazon.

Shortages of workers like baggage handlers and customer service agents led to long lines and delayed luggage during the peak summer travel season last year, marring the industry's recovery from the COVID-19 pandemic and spurring demand for new initiatives to attract workers.

"If you want people to work crazy shifts, in the middle of the night, in the middle of the day, you need to be able to accommodate their family life too," Thomas Romig, vice president at airport trade group Airports Council International, or ACI World, said of services like daycare.

"Airports are taking more actions to try and recruit, retain and train (or) upskill workers.'

ACI, which has member airports around the world, is now preparing guidance for them on making jobs at 24-hour centers outside city cores more friendly to workers.

Part of the issue for the aviation industry is that low wages and taxing work have long made retaining staff at airports a challenge, a problem exacerbated by the pandemic and now, historically low unemployment rates. In the United States, the unemployment rate is at its lowest level in more than 53 years.

U.S. air transportation employment has recovered over the past year to above prepandemic levels. But the sector still needs to add jobs as U.S. air travel also rebounds forecasts show it is set to rise again this year from pre-pandemic levels hit in 2022.

Job sweeteners are necessary because average pay for U.S. airport workers at just under \$18 an hour drastically lags that of e-commerce employers like Amazon

(AMZN.O), which pay almost \$33 an hour on average, according to ZipRecruiter. Childcare programs have been one response. Apart from airports in California, they

are not usually offered at North American airports. But that is changing. The city of Phoenix's aviation department, which runs the Phoenix Sky Harbor International Airport, has launched a childcare program for airport workers and plans to build a childcare facility on airport property. The department currently has 133 of 171 jobs vacant.

Since its launch, 37 airport workers have joined the program, which covers daycare costs partially. The city of Phoenix is also spending \$1 million to develop a separate childcare facility next to the airport.

The effort is aimed at getting people back to work after the pandemic and helping the airport run smoothly, said Matthew Heil, the city department's special projects administrator.

At Kelowna International Airport in British Columbia, Canada, construction is underway for a daycare primarily for children of employees who work on airport property. The project already helped retain one customer service agent, a single father who

had considered leaving, said Phillip Elchitz, senior manager of airport operations.

"Now he knows the daycare is coming and he's not looking for (other) work anymore," Elchitz said. "That is exactly why we are doing this.

Cincinnati/Northern Kentucky International Airport is similarly weighing offering childcare on-site or nearby in a bid to offer attractive benefits to workers, said airport spokesperson Mindy Kershner.

Some California airports, which already offer daycare, are adding other services to make life easier for employees.

San Francisco in July will increase monthly subsidies offered to employees using public transit by more than 50% to \$200, while a free shuttle is being piloted for workers who live further away, an airport spokesperson said.

Kelowna's airport is also considering shuttle service for hard-to-fill night or predawn shifts when public transit is not available.

Airlines are facing similar struggles on the hiring front.



Delta Air Lines is offering a \$5,000 sign-on bonus for a ramp agent position - among the more taxing jobs in aviation - in Minneapolis. Other carriers such as United Airlines and Alaska Airlines are also trying to attract workers for ramp operations with signing bonuses, according to job postings.

Ground handling company Unifi, which provides labor and equipment to Delta, United, and Alaska Airlines, has seen costs to bring on new workers in tight labor markets rise as much as 60% from pre-pandemic levels, Unifi Chief Strategy Officer Ying McPherson said.

With Unifi's staff turnover rate above pre-pandemic levels, it has turned to incentive programs to retain talent, McPherson said.

For example, it last year gave away brand new cars to three employees and smartphones, including iPhones, to over 3,000 workers who met performance targets, a company spokesperson said. It is now offering emergency funds and sponsoring a program that allows employees to pay for purchases such as appliances and computers over time, the spokesperson added.

In some cases, airlines and aviation services companies are flying in workers and hosting them at local hotels for temporary assignments to avoid the costs of hiring additional staff in tighter labor markets, McPherson said.

Facility services and management specialist Grupo Eulen, which works with carriers like American Airlines, estimates wages for ground handlers will rise around 6% to 8% this year, although fewer hiring bonuses are being offered.

Unions argue the industry needs to do more to attract and retain workers, especially given practices like contract-flipping - work being transferred from one company to another - are common.

Yavar Qadri, a representative for Unifor, Canada's largest private sector union, says his salary was cut by 5% and he then lost dental benefits during two separate flips over the last 15 years while working as a security guard overnight for a contractor at Canada's largest airport in Toronto.

A security guard like Qadri would normally start on wages of C\$15.55 an hour and hit just C\$16.14 hourly after six years, according to Unifor, underscoring the dim pay rise prospects.

"People are working multiple jobs. Or they are trying to get a lot of overtime added Qadri. "The whole scenario creates a very toxic atmosphere. hours," Everybody is tired."

And then there are others - like Jared Barker, a 33-year-old baggage handler at Minneapolis-Saint Paul International Airport who quit and left the industry altogether last year after mass departures during the pandemic led to a heavier workload.

"It just burned me out," said Barker, who now works in insurance sales.

Lukoil Looks to Sell Stake in Offshore Oil and Gas Field

MOSCOW (Dispatches) - Russian oil firm Lukoil is in direct talks with Indian companies to sell its 38% stake in a deepwater oil and gas field offshore Ghana, Reuters reported on Monday, quoting Russian and Ghanaian sources with knowledge of the matter. The potential sale could unblock the suspension of the field development plan, which the operator of the Pecan

field, Norway's Aker Energy, hasn't submitted yet. Aker Energy holds a 50% participating interest in the Deepwater Tano Cape Three Points block in Ghana, including the Pecan

development project. Lukoil owns 38%, Fueltrade has 2%, and Ghana National Petroleum Corporation holds the remaining 10%. Seven successful exploration wells and eight appraisal wells on the block have proved a significant resource base as well

as offering a high upside, Aker Energy says. However, the company has been wary of the involvement of Lukoil as a partner in the block due to the Western sanctions on Russia and has said it would wait to see the issue resolved until it files a field development plan. Aker Energy has completed FEED and prepared a revised Plan of Development for the Deepwater Tano/Cape Three Points block, Aker said in August 2022. Earlier this month the Q4 earnings release, Aker said that the filing of the development plant "has been delayed due to the uncertainties and risks caused by the war in Ukraine and Lukoil Overseas Ghana Tano Ltd.'s 38 percent interest in the license, as well as supply chain disruptions and inflation." The current deadline for submitting the plan has been extended to April 2023.

The Iranian foreign minister added that the country has shown its initiative on many occasions and "the fact is that we are still on the path of dialogue and we still want to reach an accord.'

Amirabdollahian, however, emphasized that the Iranian government has faced a lot of pressure internally since the United States and three European parties to the JCPOA - Britain, France and Germanyinterfered in Iran's internal affairs when protests erupted in the country back in September.

"I was in Parliament last week and they said 'who do you want to make an agreement with? With the United States and three European countries that have been trying to change the system during the riots in the fall? Why are you negotiating with them? How can you trust them?"

Elsewhere in the interview, Amirabdollahian said Iran has a roadmap with the International Atomic Energy Agency (IAEA) regarding bilateral cooperation, adding that Massimo Aparo, the agency's deputy director general and the head of the Department of Safeguards, visited Iran in the past two weeks on two occasions.

He noted that Aparo held "constructive and productive" negotiations with Iranian officials while Iran also invited the IAEA Director General Rafael Mariano Grossi to come to Tehran soon.

Meanwhile he called out CNN's misinformation on Iran, including a report about alleged sexual abuse of female detainees, noting that the American broadcaster published biased and false" reports related to recent riots in Iran.

When the anchor referred to CNN's report that claims some Iranian women were tortured and raped under arrest, the Iranian minister said that "there have been so many such baseless claims made in social media and the media".

"We have seen some of CNN's reports that are biased and false," the top Iranian diplomat said, calling out CNN's fake news campaign against Iran.

He also noted that "no one was arrested in peaceful demonstrations," adding, "however, in those protests that had turned violent, some individuals who had come from outside the country and were using firearms and killing the police were arrested.'

The remarks come as on November 21, 2022, CNN published a detailed report on Iran's security forces 'using rape to quell protests."

Such a program, the report noted, is just one example of the Pentagon's increasing comfort with, and support for Israel's aggressive stance toward Iran.

Last month, US Ambassador to Israel Tom Nides encouragingly said that "Israel can and should do whatever they need to deal with [Iran] and we've got their back." The report went on to say that due to the collapse of diplomacy with Iran despite Washington's attempts under former American president Donald Trump, the Pentagon quietly moved Israel into its Central Command area of responsibility, officially grouping it with the main Arab countries of the Middle East, adding that the reshuffling has remained under President Joe Biden.

What Trump did through the so-called Abraham Accords - normalizing ties between Israel and the two Persian Gulf Arab states of Bahrain and the United Arab Emirates (UAE) - was in fact aimed at aligning these countries against a common enemy: Iran, rather than peace deals, as they are touted, it said.

Furthermore, the report added, the US and Israel have embarked upon conducting a growing number of joint military drills in recent months that Israeli leaders say are designed to test potential attack plans with Iran.

He said that based on early investigations, the Israeli regime was responsible for the attempted act of aggression in Isfahan.

"The Islamic Republic of Iran reserves its legitimate and inherent right, in accordance with international law and the United Nations Charter, to defend its national security and respond resolutely to any threats or wrongful actions by the Israeli regime, wherever and whenever deemed necessary," the envoy said.



Former France Football Legend Fontaine Dies Age 89

Bleus reaching the semi-finals in Sweden. A prolific striker with 259 goals from 283 matches in his club

career, Fontaine was one of the key players of the great Stade de Reims team who reached the European Cup final in 1959.

Suns Win in Kev Durant's Deb<u>ü</u>

NEW YORK (Dispatches) - Devin Booker scored 37 points and Kevin Durant added 23 in his Phoenix debut as the Suns beat the host Charlotte Hornets 105-91. Durant, who was in the starting lineup for his first action since Jan. 8 with the Brooklyn Nets,

racked up 23 points and six rebounds. He missed almost two months because of a ligament strain in his right knee, during which time he was traded to the Western Conference contenders. Booker was 15-for-26 from the field, while Deandre Ayton supplied 16 points and 16 rebounds.

With LaMelo Ball lost for the season following ankle surgery earlier in the day, Kelly Oubre Jr. scored 22 points in the second half to lead Charlotte with 26 points. The loss ended the Hornets' season-best five-game winning streak.

Bucks 139, Magic 117

Giannis Antetokounmpo collected 31 points, seven rebounds and six assists to fuel streaking Milwaukee's victory over visiting Orlando.

Antetokounmpo made 10 of 14 shots from the floor to send the Bucks to their 16th win in a row overall and 11th straight victory at home. Milwaukee sits four wins shy of matching its franchise record overall win streak, set during the 1970-71 season. Jrue Holiday contributed 23 points and nine assists and Brook Lopez added 18 points for the Bucks, who made a season-high 26 3-pointers.

Orlando's Cole Anthony scored a season-high 28 points off the bench and Markelle Fultz recorded 21 points, seven rebounds and five assists. Wendell Carter Jr. had 19 points and 10 rebounds and Franz Wagner added 18 points for the Magic, who have lost 13 in a row to the Bucks.

Van Dijk, Salah **Steer Liverpool to** 2-0 Win Over Wolves

IVERPOOL (Dispatches) - Virgil Lvan Dijk and forward Mohamed Salah scored second-half goals as Liverpool battled to a 2-0 Premier League home win over Wolverhampton Wanderers to boost their hopes of European football next season.

Liverpool climbed into sixth spot in the table on 39 points, ahead of Fulham on goal difference and with a game in hand, but the home side were forced to work hard on a rainy night at Anfield.

"We controlled the game without creating massively, but we found our rhythm back," Liverpool manager Juergen Klopp said in a TV interview as his side claimed their third win in an unbeaten four-game Premier League run.

Despite fashioning the first effort on goal in the game, the visitors suffered an early blow when left back Hugo Bueno went down clutching his hamstring midway

Lakers 123, Thunder 117

With LeBron James and Anthony Davis out, Dennis Schroder scored 26 points to lift Los Angeles over host Oklahoma City for its fifth win in its last seven games.

Also missing D'Angelo Russell (sprained right ankle), the Lakers got a balanced offensive effort, as five other players scored in double figures, and four Lakers players hit at least three 3-pointers, including four from Troy Brown Jr. James missed his second consecutive game with a



foot injury, and Davis sat out with a stress injury in his right foot.

Jalen Williams led Oklahoma City with 24 points and chipped in seven assists, while Josh Giddey added 22 points, 11 assists and nine rebounds. The Thunder were without All-Star Shai Gilgeous-Alexander for the fourth consecutive game with an abdominal strain. Gilgeous-Alexander also remains in the league's health and safety protocol.

Knicks 142. Nets 118

Jalen Brunson scored 30 of his 39 points during a blistering first half for New York, which continued its surge with a rout of visiting Brooklyn.

The Knicks, who have won seven straight to move into fifth place in the Eastern Conference, scored 47 points in the first quarter, one shy of the franchise record for an opening period. New York tied a franchise record by hitting 14 3-pointers in the first half, and its 142 points were a season high.

Mitchell Robinson (13 points, 10 rebounds) posted his fourth consecutive double-double while Julius Randle added 21 points, eight rebounds and eight assists for the Knicks. Cameron Johnson scored 33 points for the Nets, who have lost four straight and are 2-8 since dealing Kyrie Irving to the Dallas Mavericks on Feb. 6, shortly before Kevin Durant was traded to the Phoenix Suns.

Bulls 117, Pistons 115

Zach LaVine poured in 41 points and DeMar DeRozan added 21 as Chicago won thanks in part to a strange finish to beat host Detroit for the 14th consecutive time.

Bojan Bogdanovic pumped in 34 points for the Pistons, who have lost six straight. Hamidou Diallo had 19 points and Jaden Ivey contributed 18, but Ivey called an illegal timeout in the closing seconds, stifling Detroit's comeback bid. With the Pistons trailing 114-112 and just under 10 seconds left in the game, Ivey called

timeout when Detroit had none left. LaVine hit a technical free throw with 9.7 seconds left, then DeRozan made two free throws with 8.8 seconds to play to put the game away. Cory Joseph hit a 3-pointer in the closing seconds for the game's final points.



 $R^{\overline{O}ME}$ (Dispatches) - AS Roma coach Jose Mourinho will be banned for two games and fined €10,000 for his explosive reaction to being sent off in his side's 2-1 defeat by relegation-threatened Cremonese, an Italian sports judge ruled.

Cremonese claimed their first win of the Serie A season yesterday as Daniel Ciofani's late penalty left Mourinho's side out of the Champions League places in fifth place in the standings.

Mourinho, who was given his marching orders by referee Marco Piccinini at the start of the second half for dissent, said yesterday his reaction was caused by his treatment from the fourth official.

The 60-year-old added that he would seek legal advice.

Mourinho's punishment was for "having vehemently and provocatively contested a referee's decision in the second half, and repeating such behaviour at the time of the expulsion," a Serie A statement said.

"For having also, at the end of the match, entered the referee's dressing room, although authorised to do so, and having addressed seriously offensive expressions and inferences to the fourth official," the statement added.

Mourinho is set to miss Roma's home league games against Juventus on Sunday and Sassuolo on March 12.

Roma are fifth in the table with 44 points, one point behind fourth-placed Lazio.



UALA LUMPUR (Dispatches) - Former K Manchester United striker and Colombian national player Radamel Falcao has been linked with a 'surprising' move as he is in negotiations to join nine-time Super League champions Johor Darul Ta'zim (JDT).

According to a report in Spanish newspaper, Marca, Falcao, who still has a contract with Rayo Vallecano which competes in the LaLiga until this June, is evaluating an offer to sign a contract with the Southern Tigers.

The report stated that Esteban Solari's squad wanted Falcao for the next two seasons before making the 37-year-old striker nicknamed 'El Tigre' a post-retirement ambassador

Djokovic **Downs Machac** In Dubai Opener

 $D^{\rm UBAI}\left({\rm Dispatches}\right)$ - Novak Djokovic was made to work in his first match since winning the Australian Open last month, needing three close sets to move past world No.130 Tomas Machac in Dubai.

Undefeated so far in 2023, and carrying a 17-match winning streak coming into the UAE, dating back to last year's ATP Finals, Djokovic showed signs of rustiness in his 6-3, 3-6, 7-6 (7/1) win over the Czech qualifier.

Djokovic, who this week has broken Steffi Graf's all-time record of 377 weeks at world number one, recently recovered from a muscle tear in his left hamstring, which he sustained in Australia on his way to a record-equalling 22nd Grand Slam title.

It was an impressive performance from Machac, who was facing a top-10 opponent for just the fourth time in his career.

The two players hit a combined 78 winners during the two-hour 27-minute affair. But it was Djokovic's 28 unforced errors that at times proved costly.

Manchester United, who made six changes to the team that started Sunday's League Cup final win against Newcastle, lacked fluency in front of an expectant Old Trafford crowd. United goalkeeper David de Gea thwarted Michail Antonio when the West Ham forward bore down on goal midway through the opening period and Emerson Palmieri flashed an inviting ball across the box.

United manager Erik ten Hag brought on Casemiro for Scott McTominay at half-time but the home side remained sluggish.
