Iraq Did Not Notify U.S. of Oil For Gas Deal With Iran

BAGHDAD (Dispatches) - Iraqi officials did not notify their U.S. counterparts before reaching the recent deal to barter oil for natural gas with Iran, the Associated Press reported on 16 July, in a test of Iraqi Prime Minister Mohammed Shia al-Sudani's independence from Washington.

The oil-and-gas deal signed this week will send 250,000 barrels of crude oil to Iran per day in exchange for Iranian natural gas, which Iraq depends on for some 40 percent of its electricity production.

Iran had cut gas supplies to Iraq in recent weeks, causing severe electricity shortages at the height of a brutally hot summer due to non-payment from the Iraqi side.

The Iraqi Trade Bank must obtain waivers from the US Treasury to transfer dollars to Iran as a result of U.S. sanctions on Tehran. Such waivers are often delayed, which has caused Iraq to owe Iran some 11 billion dollars for gas already received.

TEHRAN - Minister of Economy Ehsan Khandouzi has emphasized that the existence of certain sanctions cannot seriously affect the determination of Iran and China to expand economic and trade ties.

The Iranian minister made the remarks at the Iran-China Business and Investment Forum in the Chinese capital, noting that it may not be an exaggeration to say the determination of high-ranking officials of the two countries to expand bilateral economic relations has never been so high as the recent decades.

Top Official Hails French Court's Rejection of **U.S. Anti-Iran Verdict**

TEHRAN (PresTV) - Iran's vice president for legal affairs has hailed the French supreme court's decision to reject a US request to confiscate \$247 million in Iranian assets, saying it marked an important achievement for the Islamic Republic.

On June 28, the French Court of Cassation upheld a March 2021 verdict by a court of appeal which refused the US call for confiscating Iranian assets as per a US federal court verdict in 1998

"This measure marks a very important legal achievement for the Islamic Republic of Iran and the [Raeisi] administration, because it cemented the failure of the US pressures to have their rulings recognized and implemented in Europe," Mohammad Dehqan said on Saturday.

Dehqan argued that the verdict will have an important reverberation on European countries' judicial procedure and in their courage to dismiss US bids to impose its baseless and unfounded rulings on them. Back in 1998, a US court ordered Iran to pay \$247 million to the family of Alisa Flatow, a 20-year-old US citizen killed in a bomb explosion in Gaza in April 1995, claiming that Iran was responsible for her death over its alleged support for the Palestinian Islamic Jihad, which claimed responsibility for the act.

Turning Security Borders Into Economic Borders Iran Strategy

TEHRAN – The Iranian President says transforming security borders into safe economic borders, as well as the development of border markets and cooperation in the energy sectors is the strategy of the Islamic Republic of Iran.

Seyyed Ebrahim Raisi made the remarks in an interview with Pakistan's Army chief Lt. Gen. Syed Asim Munir on Sunday, saying that strengthening relations with neighboring, aligned, and Muslim countries is one of the priorities of the foreign policy of Iran.

Pointing to the serious will of the two countries to expand relations, he said, "Accelerating the implementation of bilateral agreements will further enhance economic and commercial cooperation between Iran and Pakistan and, as a result, improve the level of political relations between the two neighbors."

Referring to the efforts of the enemies to disrupt the relations of the regional countries, he emphasized strengthening bilateral and regional cooperation by using existing opportunities and exchanging mutual capacities. General Munir, for his part, praised the Islamic Republic of Iran's policy of

strengthening relations with its neighbors, especially Pakistan, and considered it a very valuable opportunity for the Islamic world.

Good agreements have been reached to increase the level of security at the common borders, he said, adding, "Our efforts are focused on accelerating the ongoing actions to create sustainable security.'

TEHRAN (IRNA) - Iranian Foreign Ministry Spokesman Nasser Kanaani has said that the Western media empire deafens the ears of the world with the big lie of defending the freedom of expression and human rights or describes riots, chaos, violence, and destruction as protest and revolution.

Kanaani made the remarks on Sunday in reaction to Western countries' double standards in covering protests in the Occupied Territories.

The Iranian energy minister added that Iran is seeking to exchange electricity with some neighbors without payment. "Soon we will start exchanging electricity with Russia through Azerbaijan. Connecting to the Russian electricity grid through Armenia and Georgia is also on the agenda," he concluded.

Curbs on Car Imports Lifted

TEHRAN (PressTV) - Iran's top legislative body has approved a parliament law that allows unlimited imports of brand-new and second-hand cars into the country amid efforts by the government to contain rampant prices of the domestically-produced cars.

In a session held on Saturday, the Guardian Council, the Iranian government body responsible for signing parliament bills into law, endorsed a legislation ratified in June which allowed the government to lift restrictions on imports of cars into Iran.

The legislation is based on a bill submitted by the Iranian government to the parliament in April which asked for removal of bans on car imports to help contain car prices in the country and to respond to soaring demand for cars.

The move comes despite the fact Iran's ministry of industries (MIMT) has introduced various measures to control the car market in Iran, including by offering support to domestic carmakers to help them increase their output. Iran's total vehicle output reached nearly 1.4 million in the calendar year to late March, nearly double figures reported in the same period to March 2021.

However, the rise failed to have a tangible impact on car prices in Iran which continued to increase consistent with the high levels of inflation in the country.

The MIMT hopes imports of second-hand cars that are under five years of age would accelerate in the future months, especially by individuals rather than companies and from Iran's neighboring countries. Iran National Standards Organization said on Saturday that it had eased its strict controls on car imports to facilitate transfer of millions of cars into the country.

Tehran-Europe Trade in Lowest Level for Now

Speaking to ILNA, Sharif Nezam Mafi emphasized reducing any kind of political tension is to the benefit of Iran's economy, adding that economic problems in Iran have no economic solutions and most of their look is to the political development. He said that it seems any effort for minimizing the international tension will lead to blossom of the free economy in the country.

He also noted that any agreement on the JCPOA will be temporary and added that experience has shown us that if the JCPOA is agreed based on the previous formula we cannot pin hopes on it and there is a possibility that with return of extremist administration like Trump we may see the unilateral exit of the U.S. from the agreement and Iran should take advantage of the remaining days of the current U.S. administration.

Nezam Mafi added that the issue of the FATF will soon be resolved because FATF is the engine of economy and global exchanges and sooner or later Iran will realize it.



He then touched upon the trade ties between Iran and Europe and said that in the current condition the trade between Iran and Europe is in low level, stating that Europeans are waiting for the fate of the JCPOA and observing commitments to have final decision. He went on to say that Iran's grain exchange with Ukraine has not been in a level so that it can have its impact on Iran's grain trade, of course European companies in trade of this product with Iran have had roles but actually Europeans have not been major grain deals because trade of grain is very complicated.

He reiterated that in the last days of the current month the chamber will hold conference on grain in Iran with the presence of all major actors of this trade. He once again reiterated détente and reducing tension will not lead to flood of

Grains Storage Rose 5.9% in 2022

TEHRAN (PressTV) - The Food and Agriculture Organization of the United Nations (FAO) says Iran's grains storage rose by nearly 6% last year despite pressures on the global grains supplies because of the war in Ukraine and in spite of U.S. sanctions that restricts Iran's normal access to global grains markets.

Excerpts of FAO's latest global food outlook report published in local Iranian news agencies on Saturday showed that Iran's grains storage capacity had reached 12.5 million metric tons (mt) last year, up by 5.93% from 2021.

It said Iran was responsible for 1.5% of the total grains supply in the world in 2022, adding that the country had the world's eighth largest grains supplies last year.

That comes as grains storage in Egypt, a country with a population larger than Iran, was around 4.3 million mt last year, according to the findings of the report.

Iran's total grains output in 2022 reached 20.6 million mt of which some 13 million mt was wheat, said FAO as it expected that Iran's wheat production would increase to 13.5 million mt this year.

The UN food agency expected that Iran's rice output would drop by half a million mt to

3 million mt in 2023 while its supply of other grains would remain flat at 4.1 million mt. The figures come as Iran is still under a harsh regime of American sanctions that hamper its access to normal trade of grains in the international markets.

It also comes despite the fact that the ongoing war between Russia and Ukraine has negatively impacted the global supply of grains and left many countries struggling with shortages

Tire Output Crosses 6m in Q1

TEHRAN - Iranian domestic tire manufacturing companies produced 65,353 tons of tires in the first quarter of the current fiscal year (March 21-June 21), IRNA reported.

The figure registered a 4% increase compared with the corresponding period of last year.

Iran Targets \$3b in Annual Trade With Africa by 2025

TEHRAN (IRNA) - The government of Iranian President Ebrahim Raisi aims to reach a minimum of \$3 billion in annual trade with Africa by 2025, says an Iranian official.

Alireza Peyman-Pak, the deputy minister of Agriculture Jihad and former head of the Trade Promotion Organization, made the remarks in an interview with the Iran Economy newspaper, which was published on Saturday.

He discussed President Raisi's recent visits to Kenya, Uganda, and Zimbabwe, and said the visit to Africa-the first of its kind by an Iranian president in 11 years -- will have a positive impact on bilateral relations, especially on economic ties.

Peyman-Pak noted that in previous governments, Iran's trade volume with Africa was less than \$500 million, but the Raisi administration has successfully increased it to \$1.2 billion.

President Raisi's recent visit to Kenya, Uganda, and Zimbabwe marks the beginning of a new phase of economic and trade cooperation between Iran and Africa, the official said.

The potential for collaboration in various sectors -particularly in petrochemicals, construction, healthcare, tourism, raw materials, and agricultural products-presents opportunities for the private sector to benefit from Africa's resources and contribute to Iran's economic growth, he noted.

Regarding President Raisi's visit to Kenya, Peyman-Pak underscored the country's strategic position as the gateway to East Africa and its bustling port of Mombasa, saying efforts have been made to establish regular shipping routes between Iran's southern port city of Bandar Abbas and Mombasa.

Raisi's discussions also focused on enhancing agricultural cooperation and promoting exports of petrochemical products and bitumen from Iran to Kenva, he added.

Peyman-Pak noted that agriculture was a dominant topic during the president's visit to Uganda due to the country's abundant water resources.

By utilizing Uganda's capacity for extra-territorial cultivation, Iran can import agricultural products more efficiently and at better prices, thereby ensuring food

NICICO Planning to Increase Annual Revenues to \$10b

TEHRAN (MNA) - The managing director of National Iranian Copper Industries Company (NICICO) has said the company is following a new program to increase its annual revenues to \$10 billion, IRIB reported.

Ali Rostami made the remarks in a meeting with the newly appointed acting head of the Iranian Mines and Mining Industries Development and Renovation Organization (IMIDRO) Mohammadreza Movasaghi-Nejad. According to Rostami, based on the mentioned program, the country's production capacity is going to increase by threefold and more than 50,000 people will be working in the industry.

Back in March, Rostami said the country's copper production is going to reach one million tons in the next six years

He noted that in case of reaching the above-mentioned output, the country's copper export is also going to hit \$10 billion.

According to Rostami, NICICO managed to export \$1.6 billion worth of copper products in the Iranian calendar year 1400 (ended on March 20, 2022).

Iran saw its copper exports double in that year despite a series of bitter sanctions imposed by the United States aimed at hampering the Islamic Republic's trade of lucrative metals.

Rahul Gandhi Appeals To India's Top Court

NEW DELHI (Dispatches) - Top Indian opposition leader Rahul Gandhi appealed to the country's highest court over his conviction for defamation, one of his lawyers said, days after a lower court refused to intervene.

Gandhi was sentenced to two years' jail for comments he made in 2019 which a court ruled were insulting to Prime Minister Narendra Modi and those sharing his last name.

Azerbaijan, Armenia Hold Brussels Talks



BAKU (Dispatches) - Azerbaijan and Armenia held a fresh round of EU-mediated peace talks, while Russia offered a summit in Moscow in an effort to reassert a lead role in the normalization process.

Azerbaijani President Ilham Aliyev and Armenian Prime Minister Nikol Pashinyan met in Brussels for talks aimed at resolving their decades-long conflict for the control of Armenian-populated Karabakh, the foreign ministry in Baku said in a statement.

European Council President Charles Michel was mediating the discussions, which come amid renewed tensions after Azerbaijan closed temporarily the Lachin corridor, the sole land link between Karabakh and Armenia.

Baku and Yerevan have been seeking to negotiate a peace agreement with the help of the European Union and United States, whose diplomatic engagement in the Caucasus has irked traditional regional power broker Russia. Moscow on Saturday offered to host the two countries' foreign ministers and suggested the future peace treaty could be signed in Moscow.

Russia is ready "to organize a trilateral meeting of the foreign ministers in Moscow in the near future," the country's foreign ministry said in a statement.

It offered to hold later a "Russian-Azerbaijani-Armenian summit in Moscow to sign the relevant (peace) treaty." Adding to the recent standoff with Yerevan, Azerbaijan's defense ministry said Armenian separatist forces in Karabakh "use radio interference against GPS navigation systems of local and foreign airlines' passenger aircraft flying through our country's airspace."

The alleged interference impacted two Azerbaijan Airlines aircraft on Thursday, the ministry said.

"Such incidents pose a serious threat to aviation safety," according to the statement.

Karabakh's rebel authorities denied the claims, calling them an "absolute lie."

On Friday, some 6,000 people rallied in Karabakh to demand the reopening of the Lachin corridor.

Local separatists, warning of a humanitarian crisis, urged Moscow to ensure free movement through the road. Azerbaijan later allowed the Red Cross to resume medical evacuations from Karabakh to Armenia.

Karabakh has been at the center of a decades-long territorial dispute between the two countries, which have fought two wars over the mountainous territory, mainly populated by Armenians. During previous rounds of Western-mediated talks, Baku and Yerevan have made some progress towards preparing the text of a peace agreement, but its signature remains a distant prospect. Yerevan agreed to recognise Karabakh as part of Azerbaijan, but demanded international mechanisms for protecting the rights and security of the region's ethnic-Armenian population.

French Authorities Ban Protest Against Police Violence in Paris

PARIS (Dispatches) - French authorities confirmed that a protest against police violence set to take place in Paris could not go ahead due to police shortages. NGOs say the ban signals a "more and more repressive" approach from authorities. Judges from Paris's administrative court at midday on Saturday rejected an appeal brought by a national organisation against police violence (la Coordination nationale contre les violences policières) to allow Saturday's demonstration to go ahead at Place de la République in the French capital from 3:00pm.

The ruling followed an announcement from Interior Minister Gérald Darmanin on Wednesday banning any demonstrations up to July 15 "directly linked to the riots" that followed the death of 17-year-old Nahel M., who was shot and killed by police on June 27 in the Paris suburb of Nanterre following a police traffic stop. France was wracked by almost a week of violent demonstrations against police violence after the teenager was killed.

Paris Police Chief Laurent Nunez had said on Thursday that Saturday's protest ould not go ahead due to a risk of "disturbance to public order". Nunez cited a lack of police available to ensure security at the event, after security forces were "strongly mobilized" during the riots and France's annual July 14 Bastille Day celebrations. NGOs, unions and left-wing parties reacted to the ban with anger

"The police headquarters supported by judges from Paris's administrative court are blocking all channels for the democratic expression of perfectly egitimate demands," said Lucie Simon, a lawyer representing the organisers of Saturday's protest. Following the court's ruling, the organisers cancelled the

Taiwan, Pena said there are "no constraints" to trade with China, with which Paraguay has "a very broad relationship" -- China is Paraguay's top supplier of goods.

Khartoum's foreign ministry had objected to Kenyan President William Ruto's leadership of the IGAD quartet, accusing Nairobi of siding with the RSF. Before the Jeddah talks were suspended, US mediators had grown increasingly frustrated with both sides' reluctance to work towards a sustained truce.

"They are moving on the village of Robotyne. The enemy is offering resistance to stop our advance southward."

Russia's Defense Ministry, in its daily report, said its forces had repelled 16 Ukrainian attacks on the eastern front, including near the long-contested town of Maryinka and in the strategic village of Klishchiivka, on Bakhmut's southern fringe.

Al Tool Could Aid Diagnosis, **Treatment of Brain Tumors**

NEW YORK (Dispatches) - Scientists have developed an artificial intelligence (AI) tool capable of deciphering a brain tumor's genetic code in real time, during surgery -an advance they say could speed diagnosis and personalize patients' treatment.

The researchers trained the AI tool to recognize the different genetic features of gliomas, a group of tumors that constitute the most common form of brain cancer among adults.

Not all gliomas are the same, however. Most people are diagnosed with one of three subtypes that each have different genetic features -- and, critically, different degrees of aggressiveness and treatment options.

Right now, doctors called pathologists can analyze gliomas for those genetic markers, in what's known as molecular diagnosis. But the process takes days to weeks, said Dr. Kun-Hsing Yu, the senior researcher on the new study.

In contrast, the AI tool his team is developing can enable molecular diagnosis in 10 to 15 minutes. That means it could be done during surgery, according to Yu, an assistant professor of biomedical informatics at Harvard Medical School, in Boston.

The technology, called CHARM, also appears high on the accuracy scale. When Yu's team put it to the test with glioma samples it had never "seen" before, the AI tool was 93% accurate in distinguishing the three different molecular subtypes.

Being able to make such distinctions in the operating room is critical, Yu and other experts said, because it could change how a patient is treated.

Some gliomas are less aggressive, and surgeons can be more conservative in removing brain tissue -- which can minimize side effects.

Other gliomas, such as glioblastoma, are highly aggressive. So surgeons will try to remove as much of the cancer as possible, and sometimes implant "wafers" of slowly released chemotherapy drugs directly into the brain.

"This breakthrough technology has the potential to guide surgical decisions by providing real-time molecular diagnosis during brain tumor surgeries," said Atique Ahmed, an associate professor of neurological surgery at Northwestern University Feinberg School of Medicine in Chicago.

Ahmed, who was not involved in the study, called the tool's 93% accuracy "impressive," but noted that it can be improved.



"It's important to remember that the 7% inaccuracy is not just a number," he said. "It represents patients with very aggressive diseases who could benefit greatly from more precise diagnoses."

Yu agreed that the performance can be further refined, and CHARM is not yet ready for prime time. It has to be tested in real-world settings, he said, and cleared by the U.S. Food and Drug Administration.

The researchers are working with several hospitals in different areas of the world to put CHARM to that real-world test.

Interest in using AI in medical diagnoses has exploded in recent years. The hope is that AI algorithms will assist specialists in analyzing images -- from mammograms or CT scans, for example -- to get a faster, more accurate verdict. No one wants to replace doctors, Yu stressed. "We want to use AI as a tool.'

CHARM is a much more memorable acronym for Cryosection Histopathology Assessment and Review Machine. Yu's team developed the tool using more than 2,300 frozen tumor samples from 1,524 patients treated for glioma at various U.S. hospitals.

The work, described online recently in the journal Med, is not the only effort to improve glioma diagnosis using AI. Other tools are under study, including one called DeepGlioma. Dr. Daniel Orringer, a neurosurgeon at NYU Langone's Perlmutter Cancer Center in New York City, is one of the researchers on that project.

He said that right now, molecular diagnosis of glioma is not only time-consuming and expensive, but not available at all hospitals where patients are treated. AI has the potential to "democratize molecular testing," Orringer said.

CHARM, he said, is "particularly attractive" in that regard, because it could ultimately be used at any hospital that has the capacity to digitize histology slides (microscopic images of patients' tumor samples).

Study Finds Deer Spread COVID-19 Back to Humans

NEW YORK (Dispatches) -A new study has found cases of COVID-19 spreading from deer to humans, and back, multiple times.

The study, published in the scientific journal Nature, revealed samples taken from deer showed mutated variants of COVID-19 spreading to humans, after humans spread the virus to deer.



Of the 8,830 respiratory samples taken from free-ranging white-tailed deer in 26 states and Washington, D.C., between November 2021 and April 2022, researchers found 282 deer were infected with COVID-19.

The scientists, including some from the Centers for Disease Control and Prevention and the Department of Agriculture, found that in at least 109 cases humans had spread the virus to the deer.

Additionally, there were at least 39 cases of deer-to-deer transmission and, more notably, three cases of deer-to-human transmission.

While researchers were able to track down the three people infected with COVID-19, none had reported being near deer prior to getting infected.

White-tailed deer are common in urban and rural areas throughout the country with an estimated population of 30 million, according to the study, which concluded that frequent introductions of new human viruses into white-tailed deer continue to occur.

While COVID-19 variants Alpha, Gamma and Delta were no longer circulating among humans as late as February, the variants continued to spread in white-tailed deer.

Researchers say other viruses can continue to persist in the deer population even after the variants have become rare in humans and are now calling for large-scale surveillance of white-tailed deer to determine whether the animal could be a potential reservoir for COVID-19 and how the mammal may have played a role in the ecology of the virus.

In separate research released Monday, scientists announced an new all-species test to detect the COVID-19 virus in any animal.

SARS-CoV-2, the virus that causes COVID-19, has been detected in cats, dogs, rodents, deer and apes, among others, and can mutate leading to new variants

The new test, supported by research and the U.S. National Institutes of Health, could help scientists keep track of animal populations and prevent future viral outbreaks.

Musk Launches xAI to **Rival OpenAI, Google** ARTIFICIAL INTELLIGENCE

WASHINGTON (Dispatches) - Elon Musk yesterday launched his own artificial intelligence company, xAI, as he seeks to compete with OpenAI, the creator of ChatGPT — a program he accuses of being politically biased and irresponsible.

The xAI website said the Tesla tycoon would run the company separately from his other companies but that the technology developed would benefit those businesses, including Twitter. "The goal of xAI is to understand the true nature of the universe," the website said. Musk on Twitter added that the new company's aim was to "understand reality" and answer life's biggest questions.

Mindfulness Classes Linked To Reduced Stress, Anxiety



NEW YORK (Dispatches) - The centuries-old practice of mindfulness is having a moment in present times, and a new study finds the therapy can improve mental health for at least six months. Analyzing the results of 13 prior studies, U.K. researchers concluded that in-person, teacher-led mindfulness courses were tied to reduced stress and anxiety. Mindfulness "was the seventh step of the Noble Eightfold Path in Buddhism many thousands of years ago. And lots of different cultures have used different variations of this," said Dr. Yvette Sheline, a professor of psychiatry and behavioral research at the University of Pennsylvania, in Philadelphia. There are many cited benefits of mindfulness, which is defined by UC Berkeley's Greater Good Science Center as "maintaining a momentby-moment awareness of our thoughts, feelings, bodily sensations, and surrounding environment, through a gentle, nurturing lens." Mindfulness training is offered in over 600 companies globally, and 79% of U.S. medical schools, according to background notes with the new study. And it's estimated that at least 5% of U.S. adults have practiced mindfulness. "Although there has been previous research on the topic, this is the largest and most reliable study so far confirming that these courses work for the average person," said study co-author Julieta Galante, a postdoctoral fellow at the University of Cambridge, in England. For the study, Cambridge researchers pooled and analyzed data from 2,371 adults who participated in trial mindfulness-based programs. Around half were in programs that lasted for eight weeks, with one session a week. The rest did not participate in the mindfulness programs (the "control" group).

The startup is staffed by former researchers from OpenAI, Google DeepMind, Tesla and the University of Toronto.

The team is to be advised by Dan Hendrycks, who currently leads the Center for AI Safety, a San Francisco-based organization that warns against developing AI too quickly.

Hendrycks also initiated the open letter to global leaders in June that warned AI was a risk to human existence on par with pandemics and nuclear war.

Musk has repeatedly warned about the dangers of AI, having called it "our biggest existential threat," and saying that moving too fast was like 'summoning the demon."

He has claimed to have cofounded OpenAI in 2015 because he regarded the dash by Google to make advances in artificial intelligence as reckless. He left OpenAI in 2018 to focus on Tesla and later said he was also uncomfortable with the profit-driven direction the company was taking under the stewardship of CEO Sam Altman.

nutrition and diet-related health outcomes, evidence continues to build that produce prescriptions are a terrific option," said senior author Dr. Dariush Mozaffarian, a cardiologist and professor of nutrition, who is also launching an initiative dubbed Food is Medicine.

"These innovative treatments are exciting because they cannot only improve health and reduce healthcare spending, but also reduce disparities by reaching those patients who are most in need," he said in a university news release.

The simulation predicted both clinical and financial benefits from making fruits and vegetables more accessible to food-insecure diabetic patients, including a savings of at least \$40 billion in medical bills because of nationwide reductions in heart disease.

Typically, produce prescription programs allow a patient with a diet-related health condition to get vouchers or electronic cards for free or discounted fruits and vegetables that would be delivered to the patient's home or picked up from a grocery store or farmer's market.

The long-term benefits of this idea had not previously been investigated, according to this produce prescription initiative could benefit all Americans, highlighting the potential of Food is Medicine strategies to alleviate health inequities caused by food and nutrition insecurity and diet-related diseases."

The Friedman School team pooled studies of 20 smaller-scale initiatives and nationally representative datasets to run the simulation. It assumed that all American adults ages 40 to 79 who are living with diabetes and food insecurity would increase their fruit and vegetable consumption by an average of 0.8 servings per day. That's about equal to one small apple. It also presumed expected reductions to their blood pressure and body mass index (a measure of body fat based on height and weight).

"A national program could be enacted through inclusion of produce prescriptions as a covered healthcare benefit, already being piloted by several states under Medicaid section 1115 waivers as well as by private healthcare payers," Mozaffarian said. "Our new findings help inform implementation to scale and evaluate these programs across the United States."

EU Ministers Back More Ukraine Aid

BRUSSELS (Dispatches) - European Union finance ministers on Friday unanimously backed extra funds for Ukraine through a top-up of its long-term budget, although differences persisted over other spending that threaten to delay or block proposed aid to Kyiv.

Spanish Finance Minister Nadia Calvino told a news conference that EU finance ministers meeting on Friday had backed continued financial support for Ukraine.

"The Spanish presidency is committed to proceed swiftly to have a stable framework in place by January 2024," she said. Calvino added that more technical work would be needed to support Ukraine, whose economy has been damaged by Russia's invasion.



IMF Sees Pockets of Resilience,

Slowing Momentum in Global Economy

WASHINGTON (Dispatches) - The International Monetary Fund said that first quarter global growth slightly outpaced projections in its April forecasts, but data since then has shown a mixed picture, with "pockets of resilience" alongside signs of slowing momentum. The IMF said in a briefing note for a G20 finance leaders meeting in India next week that manufacturing is showing weakness across G20 economies and global trade remains weak, but the demand for services is strong, particularly where tourism is recovering.

The IMF did not indicate any changes to its April 2023 global GDP growth forecast of 2.8% - down from 3.4% in 2022 - but said that risks were "mostly" tilted to the downside. These include the potential for Russia's war in Ukraine to intensify, stubborn inflation and more financial sector stress that could disrupt markets. But the Fund said that inflation "seems to have peaked" in 2022, and core inflation, while

also easing, remains above targets in most G20 countries.

Reduced supply chain disruptions and lower goods demand means likely disinflationary pressures from goods, the IMF said.

"However, services inflation - which is now the major driver of core inflation - is expected to take longer to decline," the IMF said.

But it said that it was possible for inflation to fall faster than anticipated with resilient output and labor markets, with cooling demand translating into fewer job vacancies rather than higher unemployment.

IMF spokesperson Julie Kozack told reporters that U.S. data showing that June consumer prices registered their smallest annual increase in two years was a "very welcome" reduction in inflation momentum, but core inflation, particularly for services, was not yet on a downward trajectory.

G20 policymakers should continue their fight against inflation, tightening monetary policy in many economies and maintaining real rates above neutral until "tangible signs of inflation returning to target emerge." But the IMF said policymakers will need to be vigilant for signs of financial sector stress, especially those brought about by interest rate risk and property sector stresses, and may need to deploy financial policy tools

to contain them. It called for "granular stress tests" for financial firms. G20 countries also need to tighten fiscal policy to ensure debt sustainability, create fiscal space and to help support disinflation by reducing aggregate demand, the Fund said. IMF Managing Director Kristalina Georgieva said in an accompanying blog post that her "overriding priority" was to complete a review of the IMF's quota resources that would increase their overall size, "with mindfulness of how the global economy has evolved", a signal that major emerging markets like China should see increased shareholding.

The Fund last adjusted its shareholding in 2010, and is working to complete a review by Dec. 15. Georgieva also said IMF members must fully replenish IMF trust funds that provide concessional resources for vulnerable countries.

The IMF also warned G20 countries about the dangers that industrial policy can have in creating distortions in trade and investment, citing China's industrial subsidies and those for green energy investment in the United States and the European Union.

UN Agency Calls for Debt Pause Option as Poverty Rates Rise

GENEVA (Dispatches) - A United Nations agency urged global finance ministers to give poor countries debt repayment breaks, estimating the COVID-19 pandemic and subsequent surge in inflation and borrowing osts had pushed an extra 165 million people into poverty.

The U.N. Development Programme said the jump meant more than 20% of the world's population around 1.65 billion people - were now living on less than \$3.65 a day and struggling to put food on the table. Group of 20 finance ministers meeting in India next week will discuss tackling poverty, along with eforming the world's top multilateral institutions and the international debt architecture. Achim Steiner, UNDP Administrator, called the surge in poverty alarming.

What this means is a government that can no longer pay its teachers; a government that can no longer employ loctors and nurses in hospitals, that cannot provide the medicines for rural health centers," he told journalists. All of the additional 165 million people in poverty were in low or lower-middle income countries, UNDP said. Poverty levels had been gradually dropping until the pandemic but have since risen.

Interest rate rises meant poorer nations now spend twice or three times the share of their revenues on servicing debt compared to wealthier ones, and about 2.3 times more on interest payments than on social assistance.

Steiner said the UNDP was calling for a "Debt-Poverty Pause" so that those countries facing the most acute problems can focus their resources on critical social expenditure.

Russia Sets Plans for Oil Export Cuts in August

MOSCOW (Dispatches) - Russian oil exports from western ports are set to fall by some 100,000-200,000 barrels per day next month from July levels, a sign Moscow is making good on its pledge for fresh supply cuts in tandem with OPEC leader Saudi Arabia, two sources said on Friday, citing export plans.

OPEC and major producers including Russia, together known as OPEC+, have been cutting supply since November to support prices. Moscow this month pledged to cut exports by 500,000 bpd in August, while Saudi Arabia extended its 1 million bpd output cuts.

As Russia did not reveal the baseline for its cut, analysts and traders had said it would be difficult to monitor. But according to trading sources and Refinitiv Eikon data, the August cuts will deepen export redutions between May and July that already total 500,000 barrels per day.

July oil loadings from western ports, such as Primorsk and Ust-Luga in the Baltic Sea and Novorossiisk in the Black Sea, are set to fall to 1.9 million bpd this month compared to 2.3 million bpd in June and 2.4 million bpd in May.

Russia exports oil and products via the Pacific and a direct pipeline to China as well as its European ports. Its export plans via

China Invites Global Investors **For Rare Meeting** As Economy Sputters HONG KONG (Reuters) - China's financial regulators have invited some of the world's biggest investors to a rare

symposium next week, three sources said, seeking to encourage foreigners to keep investing in the world's secondlargest economy despite its recent weakness and rising geopolitical tensions. The meeting in Beijing next Friday will focus on the current conditions of U.S. dollar

denominated investment firms in China and the main challenges facing them, according to the sources who have direct knowledge of the matter and invitation documents reviewed by Reuters.

The gathering comes at a time when global investors and banks are warning that confidence is waning in China's economic outlook. The country's post-pandemic recovery is quickly losing steam and Sino-U.S. relations are at a low over national security issues -- including Taiwan, U.S. export bans on advanced technologies and China's state-led industrial policies. Such a meeting, with a clear agenda to discuss challenges facing global fund managers investing in China, is rare, the three sources said, and reflected Beijing's keenness to shore up confidence among foreign investors.

Large foreign and domestic fund managers such as private equity (PE) firms, known as general partners (GPs), and their investors or limited partners (LPs) including sovereign wealth funds and pension funds are expected to join the meeting, said the sources

They also will be encouraged to provide suggestions to help address challenges facing their businesses in China and share their outlook on the economy, according to the sources and documents. The global funds which will attend will likely send their China-based senior staff, though some senior executives will be flying to China for the talks, the sources added.

One in Four UK Single Parent Households Unable to Afford Food



LONDON (Dispatches) - More than a quarter of Britain's single parent households have recently run out of food and been unable to afford more, according to a survey from the country's statistics agency which highlights the impact of surging inflation.

Out of nearly 15,000 households surveyed between Feb. 8 and May 1, 5% said they had run out of food in the previous two weeks and been unable to buy more, rising to 28% for households with a single parent and at least one child. Consumer price inflation hit a 41-year peak of 11.1% in October 2022, and food price inflation reached its highest since 1977 in March at more than 19%. British supermarkets say prices are now beginning to come down, although figures from the British Retail Consortium trade body showed that prices in June were still nearly 15% greater than a year earlier. The Office for National Statistics will release its June inflation data on Wednesday.

was more than offset by declines elsewhere, the latest indication that inflationary pressures in the economy are abating With the inflation environment improving considerably, Americans are growing more optimistic about the economic outlook. Consumer sentiment vaulted to the highest level in nearly two years in July, other data showed.

The disinflationary trend has raised cautious optimism that the economy could avoid a recession this year. Economists also believe an expected interest rate hike from the Federal Reserve later this month would be the last in the U.S. central bank's fastest monetary policy tightening cycle since the 1980s.

U.S. Inflation Outlook Brightening

WASHINGTON (Dispatches) - U.S. import prices fell for a second straight month in June as an increase in the cost of fuels

The Fed, which has hiked its benchmark overnight interest rate by 500 basis points since March 2022, skipped a rate hike at its policy meeting last month.

"The inflation pipeline is clearing up," said Jeffrey Roach, chief economist at LPL Financial in Charlotte, North Carolina. "Investors should expect the Fed in the upcoming meeting to acknowledge the continued improvement in pricing dynamics across the domestic economy.'

Import prices dropped 0.2% last month. Data for May was revised to show import prices declining 0.4% instead of the previously reported 0.6%. Economists polled by Reuters had forecast import prices, which exclude tariffs, would dip 0.1%. In the 12 months through June, import prices tumbled 6.1%. That was the biggest year-on-year decline since May 2020 and



followed a 5.7% drop in May.

Annual import prices have now decreased for five straight months. The government reported this week that consumer and producer prices rose moderately in June. Though consumer inflation remains above the Fed's 2% target, the pace of increase has slowed sharply since peaking in June 2022, giving consumers some relief. A separate report from the University of Michigan on Friday showed its consumer sentiment index jumped 12.7% to 72.6 this month, the highest reading since September 2021. Economists had forecast a preliminary reading of 65.5.

Joanne Hsu, the director of the University of Michigan's Surveys of Consumers, attributed the surge in sentiment "to the continued slowdown in inflation along with stability in labor markets."

Three sources familiar with the matter told Reuters that Russia had instructed oil companies to reduce supply plans for the next month.

Its energy authorities held a meeting with the companies' top managers earlier this week, asking them to make more efforts to guarantee lower exports in August.

Novak said on Thursday that Russian companies themselves would decide whether to cut oil production in August, but that Russia's task was to reduce supplies to world markets.

Russia's total crude and products exports are estimated at up to 7 million bpd, but data has been secret since the country's actions in Ukraine, which Moscow calls special military operation.

Prior to Russia's announcement of plans to reduce overseas supplies, OPEC+ was only managing oil production, not exports. Igor Sechin, a powerful head of Russia's largest oil producer Rosneft, first hinted at the need to reduce exports as well as output last month.

Britain's main welfare benefits rose by 10.1% in April and the government provided extra support for energy bills.

Despite this, 21% of benefit recipients still reported running out of money for food, the ONS said.

Pressures are greatest for larger families, as support payments since 2017 have been limited to a maximum of two children per household, with limited exceptions.

The ONS survey also showed that people renting their homes were generally under greater financial pressure than homeowners with mortgages. Fortythree percent of renters said it was very or somewhat difficult to afford their rent, compared with 28% of people with mortgages.

Bank of England interest rates have increased to 5% from 0.1% in December 2021 and are expected to rise further, prompting the government to request lenders give mortgage-holders in arrears up to a year before repossessing their homes.

MPs Okay Outline of Bill To Set Up Trade Ministry

TEHRAN (IRNA) - Iranian lawmakers have approved the outline of a two-urgency bill for the establishment of the trade ministry. 129 votes were cast in favor, 101 against, and four abstentions, out of the total of 238 lawmakers present in the Sunday session of the parliament. Prior to the vote, a report by the Social Committee of the parliament in support of the plan was read out, and then the representatives expressed their views for and against the bill.

Mohammad Dehqan, Iran's vice president for legal affairs, also defended the bill on behalf of the administration and emphasized that the Ministry of Industry, Mines and Trade cannot implement the set goals and plans due to the scope of its duties.



French Delivery of SCALP Missiles to Ukraine Marks Shift in Western Strategy

PARIS (Dispatches) - French President Emmanuel Macron caused quite a stir when he announced the delivery of long-range SCALP missiles to Ukraine on Tuesday July 11, upon his arrival at the NATO summit in Vilnius. "This is a strong gesture," said Guillaume Lasconjarias, a professor at the Paris-Sorbonne University, military historian and former NATO researcher. "France is giving the Ukrainian air force the ability to better support the counteroffensive, and further inland."

This air-launched cruise missile was developed jointly by France and the UK, the latter of which has been supplying Ukraine with its own version of the SCALP, the Storm Shadow, since May. With a range of over 250 kilometres, it will enable Kyiv to reach Russian-controlled areas in the eastern part of the country. A French military source told AFP that the SCALPs were already in Ukraine.

Until now, NATO member countries, including France, had felt that long-range weapons could represent a "political risk", according to Swiss military expert Alexandre Vautravers. "This type of weapon raised questions in the sense that the Ukrainians could use them to bomb critical infrastructure on Russian territory," said Vautravers. "The West thought that if the Ukrainians managed to target an air base, then they could target a hydroelectric dam, a nuclear power station or even Moscow's Red Square."

But today, long-range missiles are seen in a different light. Since the SCALP missile has standoff capabilities – meaning that it can be fired from a safe distance away – it won't be dropped directly from the front line. "We should not assume that these weapons will hit civilian infrastructure situated 250 kilometres inside Russian territory," said Vautravers. "Furthermore, Russia's anti-aircraft defence system is so effective that Ukrainian aircraft are forced to drop their weapons from 100 kilometres behind the front line."

This new weapons capacity will help the Ukrainians to continue with their counteroffensive. Such capability is "critical for Ukraine's forces to disrupt Russian logistics as well as command and control", Ivan Klyszcz, a researcher at the International Centre for Defence and Security in Estonia, told AFP. Furthermore, SCALP strikes could help "with Ukraine's current approach, which is to advance slowly so as to protect its forces and reduce losses to the extent possible," said Klyszcz.

SCALP missiles can target bunkers and specific infrastructure behind the Russian front line, as they are extremely accurate. They are also difficult to detect, which means that the probability of the missile hitting its target is very high.

Kyiv has promised Paris not to use these missiles outside of its internationally recognised borders. However, those on France's right and far-right political spectrum feel that this promise is insufficient.

Long criticised for having maintained relations with Russian President Vladimir Putin in hopes of bringing a rapid end to the conflict, Macron has made a notable shift in stance since the end of 2022. Given that the French president continually expresses support for



Kyiv, Vautravers says he is "not at all surprised by Emmanuel Macron's announcement". Nor is the delivery of such long-range cruise missiles a first. The British government supplied Ukraine with Storm Shadow missiles in May, and the Russians have already announced having captured one without destroying it. This means that Russian engineers are now attempting to copy its technology. Vautravers feels that the new missile deliveries are above all a publicity stunt: "France is under pressure, like many other countries. It is in a sort of race to see who can help Ukraine the most."

The aim of sending long-range missiles to Ukraine is to bring Russia to the negotiating table, according to Jean-Pierre Maulny, deputy director of the French Institute for International and Strategic Affairs (IRIS). "The Westerners want to give Zelensky all the means he needs to ensure the success of the Ukrainian counteroffensive," said Maulny in a televised interview with FRANCE 24. "They want to show Putin that this aid will continue over the long term, that they will provide unfailing support, and therefore that Putin cannot win this war."

The French army's SCALP missile stocks are estimated at 400 or fewer, depending on the source. Their unit price is €850,000, according to the French Institute of International Relations (IFRI). The number of missiles delivered to Ukraine has not been specified. The number "is quite significant, but keeps French stocks well above the capabilities we need for the defence of France", said a military source.

Kremlin spokesperson Dmitry Peskov announced in a press conference that France's move was a "mistake" and that Russia would be forced to "take countermeasures" in its war in Ukraine.

Iran and China officially signed the document for 25-year comprehensive cooperation in March 2021.

The document was signed between Iran's former Foreign Minister Mohammad Javad Zarif and Chinese Foreign Minister Wang Yi at the Iranian Foreign Ministry.

Back in December 2022, Iran and China finalized 16 memorandums of understanding (MOU) under the framework of the two countries' strategic 25-year agreement.

"The idea is we are not giving them dollars. Barter is a form of payment, but it's not a payment that's subject to sanctions," Farhad Alaaldin, Sudani's foreign affairs adviser, said. "We don't want to have the repeated Iranian use of the nonpayment as an excuse to cut the gas supply every year." But analysts speculate the deal may nevertheless violate U.S. sanctions on Iran, thus risking U.S. retaliation.

The U.S. reluctance to provide payment waivers has led to accusations Washington is using Iraq as a proxy to squeeze its close neighbor Iran.

How Big Oil Won the Bidding for German Offshore Wind Sites

FRANKFURT (Dispatches) - Energy majors BP and TotalEnergies have won a 7 gigawatt (GW) offshore wind site auction in Germany worth a record 12.6 billion euros (\$14.1 billion), allowing them entry to the central European market without a partnership.

Previous auctions have been won by consortia, as happened in 2021 when British tenders were awarded to BP and EnBW, and Macquarie and TotalEnergies.

The awards for capacity due to come online in 2030 also excluded leading offshore wind developers, such as RWE and Orsted.

Guaranteed rights to grid connection are included in the new leases, but the cost of developing and operating the infrastructure is not included.

Below are details of the auction, which will be followed by one other in August.

The 7 GW electronic auction officially opened in January and bidders had until June 1 to submit offers. The winning bids for the four leases ranged from 1.56 million to 2.07 million euros per megawatt and set a record for Germany.

In previous German lease auctions, companies have made low or negative bids with the expectation of subsidies from the state. This time, some companies pledged to build projects without subsidies, triggering what the regulator Bundesnetzagentur called a "dynamic



The auctions were hourly electronic get-togethers.

Bidders had to offer 30,000 euros minimum per MWh in the first round, with bids rising by that amount for as long as all bidders stayed on board. Once bidders dropped out in successive rounds, the bids rose in steps of 15,000 euros.

As part of a total of 8.8 GW to be auctioned this year - more than doubling Germany's existing 8.2 GW installed at the end of 2022 - the country will also tender 1.8 GW of offshore wind on pre-developed sites in August under different criteria.

Germany has a target to develop 30 GW of offshore capacity by 2030 and will use revenues from the auction to help improve transmission networks and Improving and developing transmission infrastructure to accommodate all the new renewable power on the grid could cost some 128 billion euros by 2025, Germany's grid companies have said.

With the headline cost of the sites equating to \$2 billion per GW, analysts at Bernstein said the cost was high compared with other similar tenders, such as the 2021 auctions for sites off the coast of England.

Wind industry profits have been sapped by supply chain problems, quality issues and competitive pressures. Industry groups have said the high costs of the leases

could drive up the cost of offshore wind projects. "These costs must be passed on. Either to the supply

chain which is already struggling with inflation and surging input costs. Or to the consumers who already face higher electricity prices and costs of living," industry group WindEurope said.

Danish wind developer Orsted said it exited the auction because of the costs involved. Norway's Equinor, which also participated, said it would continue to evaluate opportunities in Germany as part of its strategy of developing profitable growth in renewables.

BP said the projects aligned with its strategy of targeting returns of 6%-8% for its renewable projects and of transitioning to an integrated energy company with the possibility of using the power for its electric

vehicle or hydrogen businesses.

Iraq Takes First Step Towards Becoming The World's Biggest Oil Producer

BAGHDAD (Dispatches) - Iraq's parliamentary oil and gas committee plans to increase the country's oil production to more than five million barrels per day, according to the release of committee minutes last week. As analysed in full in my new book on the new global oil market order, not only could this be done with relative ease by Iraq but it could also easily be the precursor to further oil production increases to 13 million barrels per day (bpd) if handled correctly. This would make Iraq the biggest oil producer in the world.

In broad terms, Iraq remains the greatest relatively underdeveloped oil frontier in the world. Officially, according to the EIA, it holds a very conservatively-estimated 145 billion barrels of proved crude oil reserves (nearly 18 percent of the Middle East's total, and the fifth biggest on the planet). Unofficially, it is extremely likely that it holds much more oil than this. In October 2010, Iraq's Oil Ministry increased its own figure for the country's proven reserves to 143 billion barrels. However, at the same time as producing the official reserves figures, the Oil Ministry stated that Iraq's undiscovered resources amounted to around 215 billion barrels. This was also a figure that had been arrived at in a 1997 detailed study by respected oil and gas firm, Petrolog. Even this figure, though, did not include the parts of northern Iraq in the semi-autonomous region of Kurdistan. This meant, as highlighted by the IEA, that most of them had been drilled during a period before the 1970s began when technical limits and low oil prices gave a narrower definition of what constituted a commercially successful well than would be the case now. Overall, the IEA underlined that the level of ultimately recoverable resources across all of Iraq (including the Kurdistan region) at around 246 billion barrels (crude and natural gas liquids).

Given the true scale of Iraq's oil reserves - and the fact that the average lifting cost per barrel of oil in the country is US\$1-2 pb (the lowest in the world, along with Iran and Saudi Arabia) - what sort of oil output could reasonably be expected? Back in 2013, the Integrated National Energy Strategy (INES) was produced, and this analysed in detail three realistic forward oil production profiles for Iraq and what each would involve. As also analysed in my new book, the INES' best-case scenario was for crude oil production capacity to increase to 13 million bpd (at that point, by 2017), peaking at around that level until 2023, and finally gradually declining to around 10 million bpd for a long-sustained period thereafter. The midrange production scenario was for Iraq to reach 9 million bpd (at that point, by 2020), and the worst-case INES scenario was for production to reach 6 million bpd (at that point, by 2020). Consequently, the 5 million bpd figure announced last week can be regarded as the first easily achievable stepping stone toward those figures. Indeed, according to Iraq's Oil Minister, Hayan Abdel-Ghani, last week, the country's oil production capacity already stands above this level - at 5.4 million bpd – although it is still only producing around 4.3-4.5 million bpd overall.

The question at this point is, with these enormous reserves in place, and specific plans on how to turn these into up to 13 million bpd in the Oil Ministry's files, why is Iraq not already producing a lot more oil than it is? The reason is the ongoing endemic corruption that lies at the heart of Iraq's oil and gas industry. This not only removes enormous amounts of money from Iraq's coffers that could fund much-needed infrastructure investments but also deters Western companies with the required technology, logistical expertise, and personnel from becoming too involved

in the country. Although commissions are standard practice in the Middle East – and indeed across many business around the world – the practice has become something else entirely in Iraq. This has been highlighted repeatedly by OilPrice.com and independently over many years by Transparency International (TI) in various of its 'Corruption Perceptions Index' publications, in which Iraq normally features in the worst 10 out of 180 countries for its scale and scope of corruption. "Massive embezzlement, procurement scams, money laundering, oil smuggling and widespread bureaucratic bribery that have led the country to the bottom of international corruption rankings, fuelled political violence and hampered effective state building and service delivery," TI states. "Political interference in anti-corruption bodies and politicisation of corruption issues, weak civil society, insecurity, lack of resources and incomplete legal provisions severely limit the government's capacity to efficiently curb soaring corruption," it concludes.

The sums of money that Iraq has lost could have funded all the major projects needed to boost oil production up to at least 7 or 8 million bpd to begin with, notably the crucial Common Seawater Supply Project (CSSP), as also analysed in my new book. According to a statement made in 2015 by then-Oil Minister – and later Prime Minister of Iraq – Adil Abdul Mahdi, Iraq "lost US\$14,448,146,000" from the beginning of 2011 up to the end of 2014 as "cash compensation" payments to international oil companies and to other entities. In basic terms, the way in which such a staggering sum was lost relates to the way in which gross remuneration fees, income tax and the share of the State partner was deducted and accounted for in the compensation paid out over reduced oil production levels.

Unseeded Vondrousova Stuns Jabeur To Win Wimbledon

ONDON (Dispatches) - Marketa Vondrousova admitted even she was stunned by her Listoric Wimbledon triumph as the injury-plagued Czech became the first unseeded woman to win the tournament in the Open era.

Vondrousova upset the odds in Saturday's final on Centre Court as she powered to a 6-4, 6-4 victory over Tunisian sixth seed Ons Jabeur.

The 24-year-old clinched an unexpected maiden Grand Slam title at the second attempt after losing to Ash Barty in the 2019 French Open final.

"After everything I have been through, I had a cast last time, it's amazing I can stand here and hold this trophy," said Vondrousova, who was sidelined with a wrist injury in 2022. "I don't know how I've done it. Tennis is crazy."

Vondrousova joins Jana Novotna and Petra Kvitova as the only Czech women to win a Wimbledon title.

She is just the ninth unseeded champion at a Grand Slam tournament.

Vondrousova's triumph completed a remarkable comeback after a rash of injuries stalled her promising career.

Just 12 months ago, she was an injured bystander at Wimbledon, reduced to watching her best friend Miriam Kolodziejova attempt to qualify for the main draw.

Vondrousova's second wrist surgery had ruled the Olympic silver medallist out for six months, although her absence from the tour at least allowed her the space and time to get married.

"The comebacks are not easy. You never know what to expect," she said.

"I was hoping I could come back to this level and now I am here. It's an amazing feeling." At 42 in the world, she was the second-lowest ranked player to reach the Wimbledon final -- only Serena Williams in 2018 was lower at 181.

So unexpected was her run that she told her husband Stepan Simek to stay at home in Prague to look after their cat Frankie until the final, when a pet sitter was found to allow her partner to make the trip to Wimbledon.

Jabeur Vows to End **Grand Slam Misery**

ONDON (Dispatches) - Tearful LONDON (Dispaces) Wimbledon runner-up Ons Jabeur described her third defeat in a Grand Slam final as the "most painful" of her career as she vowed to learn from the tennis greats who were also jinxed at the majors.

World number six Jabeur was beaten 6-4, 6-4 by unseeded Czech Marketa Vondrousova on Saturday, one year after she lost the Wimbledon final to Elena Rybakina.

More pain followed at the US Open later in the year where she was runner-up again, this time to Iga Swiatek.

The 28-year-old is only the eighth woman to lose her first three Grand Slam finals.

However, she can take comfort from knowing that the likes of Chris Evert, Kim Clijsters and Simona Halep also suffered the same fate before going on to capture Grand Slam titles.

Rice Completes Record Transfer to Arsenal

ONDON (Dispatches) - Declan Rice Lobecame the most expensive British player in history on Saturday as Arsenal signed the England midfielder from West Ham for a reported £105 million (\$137.5 million, 122.4 million euros).

Rice's fee surpassed the previous record £100 million that Manchester City paid Aston Villa for Jack Grealish in 2021 as Arsenal continue their spending spree in a bid to challenge for the Premier League title next season.

The sum is just below the British record transfer fee Chelsea paid Benfica in January to bring Enzo Fernandez to Stamford Bridge for £106.8 million.

Neither club officially announced the fee, but West Ham said they would receive a record transfer fee between two British clubs for Rice, 24.

Rice said in a farewell letter to West Ham supporters his desire to play at the "very highest level" lay behind his decision to join Arsenal.

His switch to the Emirates Stadium on a five-year contract comes after he lifted West Ham's first major trophy since 1980 in the Europa Conference League final against Fiorentina.

Kane Auction Possible After Shock Levy U-Turn

ONDON (Dispatches) - There is an increased chance that Harry Kane will leave Spurs this summer after one club pledged to match any Bayern bid and Daniel Levy's stance softened.

Despite the fact he has just one year remaining on his contract and Spurs thus only have two more windows to get a fee for the striker, Kane is expected to stay in north London with Levy resisting offers once more.

But Bayern Munich have been more persistent in their pursuit, having two offers

if he allows his contract to run down'.

The club's transfer committee will meet on Tuesday to plan their approach, feeling that an offer of £80m could be enough.

Kane remains open to all options, including a reported £400,000-a-week deal to extend his Spurs stay, but the north London club insist they will not be 'bullied' either way.

One issue for Bayern could be the renewed interest of Paris Saint-Germain, who The Independent believe are 'are attempting to hijack' the move for Kane.

PSG have received 'renewed encouragement' that Kane would relish the opportunity to play abroad, and 'the tone of the saga has changed'.

'There is now at least more credence given to the idea that Spurs chairman Daniel Levy might sell this summer,' Miguel Delaney adds, also writing that PSG 'are willing to match Bayern in any bid for Kane,' which could prompt something of an auction as Levy begrudgingly accepts 'the logic of a sale' instead of losing Kane for free in 12 months. It would, however, require 'a bid that would make it almost impossible to say no'.

That story also suggests 'Kane's main preference remains Manchester United,' which neatly tallies with the Daily Mail saying Erik ten Hag's side 'would also return for Kane

Inter Furious With AWOL Lukaku Attitude

MILAN (Dispatches) - Inter Milan have been described as 'disappointed' and 'annoyed' after being unable to contact Romelu Lukaku, despite finally agreeing a fee with Chelsea.

Lukaku and his representatives have been trying to engineer a permanent return to Inter after the Belgian's loan spell back at the San Siro during the 2022/23 season, having spent one mutually unsatisfactory campaign at Chelsea.

Chelsea returned to pre-season this week but Lukaku was not present to report for his current employers as efforts are being made to address his future.

While all parties involved want to strike a deal, there had been an impasse over the fee. Chelsea are thought to have valued Lukaku - who they signed for a club-record £97.5m in August 2021 - at £40m, but Inter's opening bids did not reach far beyond £25m.

But reports in Italy have suggested that a deal in excess of £30m has been put on the table by Inter, with Chelsea likely to accept.

There is a spanner in the works, however, as Lukaku has suddenly become unreachable to both clubs.

Gianluca Di Marzio says the 30-year-old 'is not responding either to the managers or to his former teammates' and 'his behavior in recent days has deeply disappointed the Nerazzurri club'.



NEW YORK (Dispatches) - Lionel Messi has officially signed his contract with Inter Miami CF, marking the highly anticipated start of his time playing in Major League Soccer.

The Argentine signed with the Miami franchise on Saturday, three days after arriving in Fort Lauderdale on a private plane from the Bahamas where he was vacationing with his family.



The seven-time Ballon D'Or winner will wear the number 10 jersey for the team. "I am honored to welcome Leo Messi and his family to their new home," said Inter Miami CF Managing Owner, Jorge Mas in statement released by the club. "In 2018, we made a promise to build an ambitious club that would attract the world's elite players. A club that would transform the global view of fútbol in the United States and ensure that wherever fútbol is discussed, your Inter Miami is part of the conversation. A heartfelt thank you to our fans that never stopped believing. Together we will continue to turn dreams into reality."

"I'm very excited to start this next step in my career with Inter Miami and in the United States," said Messi. "This is a fantastic opportunity and together we will continue to build this beautiful project. The idea is to work together to achieve the objectives we set, and I'm very eager to start helping here in my new home." Messi will be unveiled to the fans at 8 p.m. tonight at the DRV PNK Stadium in Fort Lauderdale, Fla. The global star's widely anticipated debut for the club is set for July 21 in a Leagues Cup match against the Mexican club Cruz Azul.
